

## **Church Returns To Rexford**

After a ten year wait and \$5 million dollars, the First Church of Christ, Scientist opens its doors

After 70 years at 142 S. Rexford the First Church of Christ, Scientist has re-opened at its new facility at 141 S. Rexford— right across the street from its former home.

The church was forced to move, selling the structure at 142 S. Rexford after the 1994 earthquake caused extensive damage to the ceilings. Built in 1937, the facility at 142 S. Rexford was the original home of the First Church of Christ, Scientist.

"There was some damage done to the ceilings in the main auditorium which resulted in some asbestos being loosened and at that time there was a big fear about asbestos," treasurer and chairman of the building community Chris Brix said. "We didn't have sufficient capital to do the required repairs in the auditorium at the facility so we decided to sell it."

The First Church of Christ, Scientist occupied a temporary facility on little Santa Monica while re-building their facility on Rexford. 142 S. Rexford is now home to the Nessah Synagogue.

The decision to sell the property was made in 1997. Real estate developer Richard

Weintraub bought the property in 2000, intending to build a new structure but the city would not approve his plans for senior housing, a mixed use facility, or condominiums.

Weintraub then sold the property to Nessah Synagogue who moved to Beverly Hills from Santa Monica in March of 2002. The Nessah facility is 60,000 square feet.

The First Church of Christ, Scientist used the money from selling the facility at 142 S. Rexford to build a new structure across the street at 141 S. Rexford on a vacant parking lot that the church has owned since the 1950s.

This is the first new church built in Beverly Hills in over 40 years.

"It was a membership decision to stay in Beverly Hills. We have a presence in Beverly Hills. We owned the lots and they were zoned for it," Brix said. "We could build a structure that was necessary for our needs at a cost we could afford. If you put all of those things together it seemed like a very logical solution."



#### NOTICE OF COMPLETION AND NOTICE OF AVAILABILITY DRAFT ENVIRONEMTAL IMPACT REPORT

A Draft Environmental Impact Report (EIR) has been

prepared for a proposed mixed-use, commercial/residential project ("Project") to be located at 9588 Wilshire Boulevard, 120 Peck Drive, 125 S. Camden Drive, & 133 S. Camden Drive.

The Planning Commission will hold a public hearing on the Draft EIR and the Project on July 27, 2006, at 7:00 p.m. in Commission Room A, Beverly Hills City Hall, 455 North Rexford Drive, Beverly Hills, California 90210. This hearing will focus on the Draft EIR. There will be future hearings at which the public will be invited to speak to the Project's merits and a separate notice will be mailed regarding such future hearings.

#### PROJECT DESCRIPTION

The SCCA, LLC (applicant), a Virginia Limited Liability Company is considering development of a public/private project on eight (8) lots. The proposal consists of two separate developments referred to as "Parcel A" and "Parcel B". The project site is bordered by Wilshire Boulevard to the north, Camden Drive to the east, and Peck Drive to the west. The project generally includes the following:

Parcel A - The building proposed for Parcel A includes 12,000 square feet of ground floor commercial space; four levels of subterranean parking; and six stories of condominiums and townhouses, for a total of seven floors above grade. The 20 condominium units range in size from 2,650 sq.ft. to 5,320 sq.ft. The maximum height of this building would be 85 feet. A lobby area and resident fitness center would be located on the first level of subterranean parking, with an additional resident-only lobby located on the ground floor. While a total of 97 parking spaces are required for the proposed mix of commercial and residential uses in this building (62 spaces for the residential portion and 35 spaces for the commercial portion), the 70 parking stalls proposed within this structure will all be dedicated for the residential component. The 35 spaces required for the commercial component would be housed in the adjacent project (Parcel B), with valet service provided for commercial customers.

Parcel B – Parcel B would include 40 condominium and townhouse units ranging in size from 1,840 to 4,250 sq. ft. Building height would vary from 45 to 55 feet in four and five stories, respectively. A total of 327 parking spaces are proposed in five (5) levels of ground floor and subterranean parking. The total required parking includes 170 replacement parking spaces currently covenanted for use by Saks Fifth Avenue; 35 spaces for the commercial project on Parcel A, and the remaining spaces for the residential component of the project.

The project also includes the vacation of the north/south alley situated within parcel "B"

The following applications have been filed:

A Zoning Code Amendment to allow residential uses within the C-3 commercial zone (Mixed Use); allow a portion of the required parking to be located on an adjacent parcel; allow an increase in the allowable floor area ratio from 2:1 to 5.63:1 for parcel A; and allow an increase in height from 45 to 85 feet.

The application also includes a Code Amendment to modify the height limit for the two middle lots on Parcel "B" from 45 feet to 55 feet. The project includes several requests to re-align and vacate alleys on the overall project site.

Copies of the Draft EIR will be available for public review beginning **Friday**, **June 30**, **2006**, in the Community Development Department at City Hall, 455 North Rexford Drive, Room G-40; the Office of the City Clerk (Room 190, also in City Hall); and at the Beverly Hills Public Library at 444 North Rexford Drive. One copy (per person or organization) of the Draft EIR may be obtained from the Community Development Department without charge. (Reproduction costs may be charged for additional copies.)

The **45-day public comment period** will be from **Friday, June 30, 2006, through Monday, August 14, 2006.** Comments on the EIR will be accepted prior to the end of the public comment period.

Copies of all relevant material, including the project specifications and the environmental initial study are available for review in the offices of the Community Development Department of the City of Beverly Hills.

# **ASB President Branches Out To State Student Council**

Beverly High senior Josh Tucker will spend summer traveling the state as a member of the California Student Council.

Just last week, Beverly High senior Josh Tucker was in Oakland for a two-day executive board meeting. As a member of the California Association of Student Councils, Tucker's summer will be filled with a range of meetings to discuss topics spanning from education policy to building stronger leadership skills.

"My job this year is to really establish each region [a total of 12] and bring them back to life, which means having each region president position filled and making sure each president puts on a fall and spring conference."

Tucker's responsibilities this year as a member of CASC are somewhat daunting considering that is a total of 24 conferences he must oversee as well as filling four vacant, region president positions. These tasks are mixed with his regular responsibilities as an incoming senior and the Associated Student Body President.

"Josh is a very energetic and charismatic individual," said CASC President Tess Lerner-Byars. "He's very hard-working. It was always our plan to work together. It didn't look like he was going to run last year, and I was really devastated because he brings out the best in me."

Tucker did eventually end up running for the vice president of CASC. The non-profit organization pools students from across the state to brainstorm on problems or issues within the education system to present to the state Board of Education.

The students currently holding positions on the student council come from a variety of cities throughout the state, including Murrieta, Fortuna and Rancho Cucamonga.

"Last year, he was our middle school director," said Jacy Leduc, last year's CASC President. "He put on all of the conferences for our organization, and he did a phenomenal job. He needed very little guidance,

because he was extremely competent in his position. He was usually on the supporting side rather than the one needing support."

In the past, the group has been responsible for helping implement codes that allowed student cell phone use on campus as well as establishing a student bill of rights.

"We play a big role in deciding who will be on the student Board of Education next year," explained Lerner-Byars, "and [we give] students the opportunity to express their voice and give them that channel [to do that]."

Lerner-Byars has known Tucker for the past two years. The two met at a student advisory board on education attending the conference as delegates. The following year, Tucker oversaw many of those conferences as the middle school director. Tucker concurrently held the position of student council president at his middle school in Santa Monica.

As vice president of the state student council, Tucker meets with 24 other high school students from around the country for bimonthly meetings. His next council meeting will be at the end of this month.

He will also be in Sonoma this month taking part in a middle school program helping to oversee the 80 junior high students involved in the program.

"We put on conferences to better student leadership across the state," Tucker said. "We teach them leadership skills, presentation skills, respect acceptance of everyone and encourage youth that they can be the change and make the change themselves." Tucker's interest in politics, education and promoting change through CASC is also something he takes part in at the high school level as the ASB President. He served as president this past semester and was re-elected for the fall semester.

"I love making change," Tucker said. "I love being the person trying to plan the best events to leave a legacy. I've always believed in the power of the individual and that anyone can make change."

Oftentimes, Tucker gets called out of class or goes out on interviews. He usually stays up late at night answering e-mails. In the ASB class itself, during sixth period, he runs the meetings.

"It's wonderful to work with him," said ASB co-advisor Daniel Zadeh. "He's very organized and well-motivated. He generally cares about the school and wants to make the high school a better place. It was my first semester running the student council so it was really nice to work with someone who's really on top of everything. He's a nice kid and very respectful."

Over the past three years, Tucker served as the Class of 2007 President, Commisioner of Fundraising and treasurer on ASB. He became involved in student council the second semester of his freshman year and said he spent his first semester mostly quiet, intimidated by the room full of junior and senior leaders of Beverly High.

Tucker also played football for three years and is on the volleyball team. In the fall, he will be in cross-country.

## **Conflicts And Candidates**

And Beverly Hills loses a great one By Rudy Cole

An interesting issue involving conflicts of interest came up recently when a member of the city's Planning Commission was required, under state law, to excuse and disqualify (recuse) himself on an agenda matter, but then, acting as a private citizen, spoke from the podium.

Commissioner **Shahram Melamed** had a very strong opinion from City Attorney **Larry Wiener** supporting his testifying. He also said that he earlier questioned legal experts at a state meeting of planning commissioners who also said he had a right to speak, even though he was precluded from voting.

The issue before the commission was the mixed-use condo project at 9200 Wilshire (Legacy Partners). The commission voted three to one to deny approval of a project that has been in the pipeline for many months.

Melamed could not vote because he owns property near the site. What makes this different from most conflicts of inter-

est is that Melamed actually spoke in opposition. His appearance was, according to the city attorney, appropriate because city officials are permitted to testify if a matter directly impacts their own home and there is no direct financial benefit involved – even when they are barred from voting. (Wiener's opinion is supported by guidelines of the state Fair Political Practices Commission.)

However, in a very similar problem, when Councilmember **Frank Fenton** could not vote on a proposed plan to combine two lots for a mammoth home near his own house, he not only disqualified himself from the vote, but left the council chamber

So, Melamed did his homework, was armed with a supportive legal opinion, a matter of record, but was it really appropriate? Was there even a taint of unfairness because Melamed was, according to our sources, given the right to speak last?

process is the likely influence a member of a commission has on his or her colleagues, even when leaving the dais and speaking as a private citizen. A strong, very popular commissioner would, inevitably, carry more weight than either applicants or opponents of a project – and that is simply not good government.

Melamed, now a candidate for city council, as we said, did not violate the law, but the council should consider adopting its own rules that would create a fairer playing field.

Some years back, while attending an Architectural Commission meeting, we were somewhat surprised to find a member of the commission recuse himself because he was the architect for the appellant, but then go the podium to plead for approval of the design!

Actually, when a public official recuses himself there is a certain amount of displeasure because the public feels cheated in not having a full, deliberative body involved in decision making. However, most conflicts would not be known and those publicly disclosing a conflict are acting in good faith.

As for the project, the property has had a long and conflicted history. Most of the neighbors, although not Melamed, opposed approval of a hotel. After many

years of hearings and appeals, the hotel – the Bel Jardin – was approved. But it was not able to obtain financing and eventually sold. Unlike the proposed hotel, this condo and retail project had very strong backing among the neighbors. It might not have been the best political strategy to make them the most important backers since they made so many insulting comments about city government when they fought the Bel Jardin.

What is distressing is the lengthy and costly process the proponents had to endure before they learned that the commission did not want mixed-use on this portion of Wilshire Boulevard. While the planning process can encourage, by granting of entitlements, to uses that are deemed beneficial to the city, that should have been clear much earlier. Some planning commissioners may indeed have felt the site could become a home for an entertainment industry entity, but no agency had, according to our sources, expressed any real interest.

What put this issue in the minds of some commissioners was the loss of CAA and the likely move of ICM to Century City, plus plans William Morris, one of our oldest businesses, has to either find a new and larger space or also seek offices outside Beverly Hills. On the other hand, there were other spaces available within the city the entertainment giants did not seek. Now, many entertainment groups, with less fanfare, have found homes in offices within the Industrial area. We lost some, gained others.







# COVERSTORY THE BIG-LITTLE GRAFFITI PROBLEM

Police say graffiti isn't a major problem, but the mayor says it is. Residents just want it gone. By Kari Hamanaka

Last Wednesday is when Reeves Drive resident Peter Bernard walked out to the alley behind his apartment building and saw the graffiti- marks of an ongoing source of irritation for both him and his neighbors.

Over the past few weeks, Bernard reported two incidents of graffiti to the

Beverly Hills Police Department. According to police, four incidents of graffiti around Reeves Drive and Charleville Boulevard were reported June 28, but police say this is not indicative of an overall graffiti problem in the city.

"We have been pretty fortunate where we've done a pretty good job in the past where [graffiti] has been sporadic and rare," said Lieutenant Mitch McCann. "I don't know of a time when it's not been some local teenagers or some teenagers from out of the area just spray-painting [as opposed to gang-related graffiti]."

However, residents, property owners and some on the city council see the tagging as a problem because of the burden private property owners have in paying for the clean-up of graffiti.

"We saw the tagging, [the property owner painted] it out," Bernard said. "Then the tagging came back. It's an impact on the property owner because to [re]paint these things, you've got to pay for a painter to come out and the city doesn't take it seriously."

The graffiti includes the initials ging crew: "F.T.D." spray-painted in purple and blue from the alley between Reeves and South Beverly Drive and along the alley of 221 and 235 Reeves Drive.

"I would doubt that it's a gang," McCann said. "It's probably kids that might consider themselves a tagging crew or something of that nature. It's not what people would hear and think like 18th Street or Crips or Bloods. This would more likely be a tagging crew."

The city currently offers a graffiti abatement program to residents through the Public Works Department. Residents may call in to report graffiti. However, removal of graffiti on private property is left up to the property owner, and some, including the mayor, think this is unfair.

"The problem is that our ordinances place the burden and responsibility for the cleanup of graffiti on what I refer to as the innocent landowner," said Mayor Steve Webb. "I felt that the city charges a fair amount for the services that we provide such as garbage, water, electric and that we ought to be able to give back something to the community and so proposed to put into effect a plan that would have the city clean up the graffiti at

At about this same time two years ago, the police department dealt with another series of graffiti incidents involving black crosses and X's found spray-painted throughout the business triangle area.

At its informal meeting June 27, the city council discussed a proposed ordinance that would address the graffiti issue in Beverly

Hills. Despite what McCann said about graffiti being a minor problem, the city council found that graffiti on private property has

increased over the 2005/2006 fiscal year.

Historically, the city encountered problems with graffiti mostly during the holidays, according to the staff report to the city council. In August 2003, former BHUSD superintendent Jeff Hubbard reported to the Human Relations Commission about the higher fence built at Beverly High to lessen

Although Beverly Hills law enforcement do not deal with graffiti in the same volume as other Los Angeles County cities, Webb and other elected officials still feel that

> Beverly Hills needs to be cleaned up.

"The third prong [among Webb's list staff report to the nature. It's not what people would hear and think of priorities to clean up the city] related to cleaning up the graffiti that we find

> throughout the city," Webb said, "which has become an increasing problem. I think in a city such as Beverly Hills, we shouldn't see any graffiti at all."

> The possible ordinance would allow city employees to enter private property and clean-up the graffiti. The new ordinance would eliminate the current system that

requires Community Development's Code Enforcement to send a letter requesting the property owner remove the graffiti.

"We inform [residents] about it, and most people get it fixed," said Environmental Utilities Manager Shana Epstein. "Some

> [residents] are unable to or as council states, feel they are victims of a crime, so why should they clean [the graffiti] up?"

The graffiti abatement process can sometimes end up being lengthy. If an owner does not comply with the written request for removal, it goes up through various levels of code enforcement according to Epstein.

Public Works Director David Gustavson was on vacation and unavailable for comment.

The financial ramifications if the city council approved the ordinance would be the cost of Environmental Utilities employees' time and the equipment needed to complete the job. An estimated annual cost of this proposal was discussed as being between \$10,000 and \$20,000 to the city.

Back on Reeves Drive however, residents already took a proactive stance against the taggers the second time the graffiti appeared, which they funded themselves.

"We saw beer cans and what looked like marijuana, and that's why we put up the fence - to protect the building and protect the tenants from whoever's doing it," Bernard said.

According to McCann as of press time, police had no suspects or leads on the inci-

"The city prides itself on how it deploys its [police officers]," Bernard said. "If there are not patrols going up and down the alley along Reeves and South Beverly, then people know that [police] never come down the alley, and it gives them the greater opportunity to try and do something."

The city council is now waiting for the proposed ordinance's plan to come back from city staff. However, no set time frame on implementation of this ordinance has been made, but Webb said ultimately the goal is, "Eradication of graffiti. It's as simple as that. It's part of cleaning up this city."

# Football Normans Continue Summer Success

After playing the Lions, the Normans faced Granada Hills, scoring five touch-

downs to the Highlanders' three in a game a score was not kept.

Defensive back Daniel Kim and safetywide receiver Darrian Richardson drew praise from Paysinger for their play for Beverly Hills during the tournament.






