City Council approves outdoor smoking test ban ordinance

Residents and business owners voice support and concern as the city approves the open air smoking restriction

Tuesday night, the Beverly Hills City Council unanimously approved an ordinance for a test ban against smoking in all outdoor dining areas to be enacted October 1.

"I am thrilled City Council unanimously supported the smoking

prohibition for outdoor dining," said Vice Mayor Barry Brucker. "It is a statement we care about the health of our citizens, tourists and employees in the city."

The approved smoking test- ban ordinance will ban smoking in open air dining areas located on private or public property, including public-right of way. Smoking is restricted within five-feet of an open air dining area. The ordi-

nance will affect restaurants in hotels, and will limit pool areas to only be allowed 25 percent continuous deck space for smoking. Smoking clubs, like The Havana Club, are exempt from the ordinance.

Twenty year resident Joyce Levine said because of her asthma and the previous open air dining policy she was limited to where she could dine in the city. It only takes one smoker to affect me, Levine said. Now, she can go anywhere, she said.

Brucker proposed the original ordinance to the City Council in September 2006. At the time, Former Mayor Steve Webb assigned Brucker and Councilmember Linda Briskman to an Ad-Hoc committee to research the proposal, said Brucker. After meeting with the Beverly Hills Restaurant Association and the Chamber of Commerce, the Ad Hoc committee proposed the final revision of the ordinance that included the delay of the ban from the original enactment date of July to the current date of October.

"We are pleased the City Council did not rush into the test ban, and will wait to conduct the ban in October," said President of the Beverly Hills Restaurant Association Vicki Mense.

The Chamber of Commerce Board of Directors voted Tuesday 10-6 in support of the ban.

There was uncertainty about the test ban from local business people. Beverly Hills restaurant owners and their employees came in full force to voice concerns and hesitations.

"As for Crustacean, over 30 percent of our business comes from tourism, largely European and Japanese, who smoke," said Crustacean CEO Elizabeth An. "If these tourists can no longer find a comfortable dining experience for themselves or for their guests, they will choose to travel, dine, and shop in other destinations that will permit them this choice."

Randall Courtland, a 10 year employee at Crustacean, is convinced the ban will affect his business; most of his repeat clientele are European smokers he said.

"I live in Santa Monica but I work in Beverly Hills because there was no ban on open air dining," said Courtland.

The economic impact of the smoking ban on affected hotels and restaurants will be measured during an evaluation period during the 4th quarter of the fiscal year, October, November and December. The report findings of the evaluation period are to be made no later than May 31, 2008. If the City Council cannot meet the dead-

line to establish the findings, the ordinance will be retracted.

If the test ban does result in an impact for restaurants, An said she would probably considering not opening another restaurant in the community; instead she might look to cities that cater to her clientele by allowing smoking.

"I probably would not open another restaurant in Beverly Hills because of the ban," said An.

Other restaurant owners voiced their concerns about having to "police" their patrons as a result of the ban.

"I am busy running my restaurant, I cannot worry about policing my customers because of the ban," said Eurocafe owner Varvarten Kemanjian. About 40 to 50 percent of Kemanjian's clients are tourists, he said.

The City Council is making an effort to make the public aware of the test ban by creating an outreach program. The city will produce "no smoking" signs and table tent cards at no charge to the restaurants or hotels.

Also during the evaluation period, a hotline number and e-mail account will be created for residents to voice their reactions to the test ban.

The neighboring cities of Santa Monica, Calabasas and Burbank have also passed similar band against outdoor dining. At the City Council meeting, Santa Monica Mayor Richard Bloom said the restaurant industry in his city was not affected by the open-air smoking ban the city passed.

"Travelers do not come to California to come to Santa Monica or Calabasas, they come to California to come to Beverly Hills," said An.

BHHS Alumnus elected to Takoma Park City Council

Forty years after leaving the 90210 zip code, Reuben Snipper lives across the country in virtually the same zip code just rearranged: 20912-Takoma Park.

Maryland. The recently elected Takoma Park City Council official says he can still remember sitting on the grass in front of Beverly High.

"Sitting on the lawn in front of Beverly High is just as fun as it used to be," Snipper says about his return to the school for his 1963 class reunion in 2003. It is located in Montgomery County Maryland, adjacent to Washington D.C. The city is an official "Tree City, USA" and has an award winning recycle program.


Prince's credits include executive producing the NBC drama "American Dreams" which ran from 2002-2005.



A Tribute to Beverly Hills

City honors Betty and Fred Hayman By Rudy Cole

Recently, a visitor from Europe asked me to describe Beverly Hills. "Thirty - Three Thousand Generals in search of a private," was my somewhat flippant response.

We do have an inordinate number of leaders, successful people who are active and dedicated, but that is really a good thing: Because it also means taking very seriously responsibilities to the community, to giving something back

A good example of this dedication to giving was inherent in the three people honored last week at two separate events: **Lili and Jon Bosse** by the Beverly Hills Education Foundation and **Fred Hayman** by the Beverly Hills City Council.

The Bosse's generosity to charities, and especially our public schools, has reached almost legendary heights. But it is not just money, it is the commitment and involvement that make what they do so important to Beverly Hills.

For the record, and because it was in their honor, the annual Beverly Hills Education

Foundation dinner surpassed all the Foundation's previous events in attendance and probably even more in donations and auction sales.

The food and service by the Beverly Hilton, was, as always, excellent and the entertainment very creative. The participation of the teachers, who were also recognized, made for a very special evening. However, and this should be a note of advise for all event planners, the awards and recognition should be made early, not late in the evening. Unfortunately, too many people headed for the exits before that part of the ceremony even began.

At the **Mahboubi** table, we broke bread with **Bahador** and his significant other, **Ashlie Hightower**, former mayor **Dr. Charles Aronberg and Dr. Sandy Aronberg**, former assembly member and West Hollywood Mayor **Paul Koretz** and **Suzanne and Marty Geimer**.

All five councilmembers and five school board members, a large delegation of teachers, administrators and community leaders were also at the Hilton, not only to support the schools, but to join in recognizing the Bosses

Congratulations and appreciation to the event co-chairs **Susan Forman**, **Jodi Galen** and **Susan Weisbarth**. If there was an award for best program, this year's Apple Ball tribute book would easily win thanks to **Don Creamer's** graphic skills.

Monday night, when Hayman was honored by the city, it was different. This was not a fundraiser, Fred and Betty have had more than their share of being recognized for lending their names to worthy causes – this was a celebration of the history of a person who reshaped our city. Incidentally, Fred now has an alley named for him and the street sign was unveiled at the dinner.

Fred will be the first to tell you, he didn't do it alone, but his vision and his leadership played a major role in bringing us Rodeo Drive. Hayman, the Mahboubi's, **Don Tronstein, Jerry Magnin** and others reinvented the street that has become a world tourist attraction, it was not much different from many of others in our business district triangle. But, Hayman was the first among the visionaries and the first chair of the Rodeo Drive Association.

Before Hayman has his allies changed Rodeo, two restaurants were the major appeals: The Luau and the Swiss Café. There were retailers, a few with long histories, but mostly there were office buildings for lawyers, doctors and a few stockbrokers. Nothing too spectacular.

The growth was not always smooth. At one point, the Rodeo Drive Association decided to sue a business for supposedly infringing on their trademark: Rodeo Drive. They lost and actually had to change their own name from Rodeo Drive Association to Rodeo Drive Committee.

Hayman's Giorgio's was not only an innovative retail shop with clothing and fragrances, it became the go to place on the street. His later store made his logo shopping bags a collector's item.

The Rodeo Collection, the Mahboubi contribution to the street, marked an important milestone in redefining Rodeo. In time, many of the successful retailers in Rodeo moved to larger venues on the street, but it has reinvented itself, now it has a successful anchor restaurant, Prime Grill, and a new, diverse assemblage of tenants.

The Four Seasons hoped to anchor the street with a world-class hotel at Wilshire, but the voters rejected the project in a very lopsided referendum. Instead, that corner is now Two Rodeo, with much of the Rodeo Collection concept, but added a twist: Two surface streets, one on Rodeo and one at the entrances. Thanks to **Max Salter**, the project also had to guarantee two hour free parking as part of their entitlement process.

Fred has had and continues to have a remarkable career. He has gone from handling food and beverages for the Hilton to owner of Giorgio's to his own fragrance business with successful stops in between. Betty and he are

major donors to a wide assortment of charities and cultural resources.

But there is a very special Hayman quality I wished he could market: The ability to work with people with very diverse views and opinions and do so without the slightest negativism. Fred does have strong opinions on everything from politics to plans for our city's future, but he is able to process this without making it personal. I can't remember his ever having said a bad word about anyone unless they were total idiots, and only a few of these.

A good example of this special Fred talent is his personal friendship with the Peninsula general manager **Ali Kasikci**. Kasikci and the Peninsula owners did not take kindly to the arrival of the Montage in Beverly Hills. They had reasons: Their own hotel had height and public assembly limitations that inhibited full use of their property. They have had enormous success, but they chafed at the entitlements given the Montage

Back to Kasikci and Fred. During the Montage drive for approval that included City Council action and finally a very emotionally draining city referendum vote, Fred was one of the Montage's most important supporters. For Fred, it was never personal and it never changed his affection for Kasikci or the Peninsula. In a sense, the same could be said for Kasikci.

Who was one of the co-chairs of the tribute to Fred and Betty: Ali Kasikci. The others were **Katy Sweet**, probably our city's most effective public relations person and former Mayor **Vicki Reynolds**, the person most responsible for starting the process that will finally bring us a cultural center.

The guest list was as diverse and as representative of the city's many interests as seen in any recent event. All five members of the City Council, entertainment, cultural and business leaders and Fred's kids, **Nicola, Robert and Charles,** who came from Israel for the tribute, were involved. The outstanding food and service were jointly provided by the Peninsula's Belvedere, Spago's and The Grille. **Wolf Puck** was there, of course, and it was good to see the Grill's **Leslie and Bob Spivak** – Bob told me he is semi-retired and that's hard to believe.

We sat with a group of former mayors including Janet and Max Salter and Lynn and Mark Egerman and Robert Anderson, still working on his history of Beverly Hills. Donna Ellman was there as was MeraLee Goldman, Merv Griffin, Laugh In's George Schlatter and Hal David and a guest list that would have made George Bush envious, and we know he loves to party.

Now, do you really want to properly use the special Hayman talents? Take Fred into a city hall room with all members of the city council and planning commission and top staff managers and listen to his ideas of what Beverly Hills might and should become in the future This might all begin with Canon Drive, Fred's new home base. By all means, record the conversation and let future city leaders listen to what might have been.

Beverly Hills restaurants had a small victory Tuesday when the city council decided not to rush into a ban on outdoor smoking and put off a test ban until this fall (see page 3). There

were many people with very good intentions who attended the hearing and supported the ban, including local residents and leaders. But there were also professional organization types who have never ordered a cup of coffee at a Beverly Hills eatery and who saw this battle as one more way to advance a special cause by brining it to a city that receives media attention.

David Heyler Jr. died last week and he may well be one of the last of the great lawyers that made the Beverly Hills Bar Association a national leader. David's father was the final owner of the Beverly Hills Citizen, our last daily newspaper. The Heyler's were also major land owners and developers, but David Jr. had little or no interest in newspapering or real estate, focusing on the law. He was a long-timeassociate of Guy Ward, another bar association leader.

With a school board race about to begin and at least one major candidate challenging the incumbents, there were rumors that one or more of the latter might decide not to run. We reconfirmed, all three will be on the ballot including **John Millan**, **Alissa Roston** and **Myra Lurie**.

BHHS Boys' Tennis Team Upset In Semifinals

Norman runner sets school record.

Losses in two sets they had leads and in a tiebreaker in a third set ended the Beverly High boys' tennis team's hopes of advancing to a third consecutive Southern Section final.

The top-seeded Normans lost to Santa Monica Crossroads, 11-7, in a Division III semifinal May 23 at Beverly High.

Daniel Ho, Beverly Hills' No. 1 singles player, lost to Reese Milner, the Roadrunners' No. 1 player, 7-5, after holding a 5-4, 30-0 lead in a first-round match. Igor Fedonenko and Peter Yoon, the Normans' No. 2 doubles team, lost to Crossroads' No. 1 doubles team, 7-5, after leading 4-1 in a second-round match.

"It wasn't a choke," Beverly Hills coach Mike Margolin said. "It was just a situation where it would have been nice to say we come up with the good shot at the right time. Credit them — they obviously got the balls back in play to give us the opportunity to miss them and they also made some plays."

In the only set decided by a tiebreaker, Gary Parizher, the Normans' No. 2 singles player, lost to Clay Thompson, playing No. 3 singles for the Roadrunners, 7-6 (2), in the third

round.

The highlight of the match for Beverly High (19-6) was the sweep by its No. 1 doubles team of Ethan Bond and Uday Singh, who won, 6-2, 6-0, 6-1.

The Normans trailed 4-2 after the first round, getting victories from the Bond-Singh and Fedonenko-Yoon doubles teams.

Both Beverly High and Crossroads (14-5) won three sets in the second round, making the score 7-5. The Norman victories came from the Bond-Singh, Fedonenko-Yoon and Benjamin Gabbay-Daniel Levy doubles teams.

Beverly Highs' third-round victories came from Ho, a 6-3 winner, and the Bond-Singh doubles team.

Margolin said he wasn't surprised by the

Simmons was timed in 1 minute, 52.73 seconds, breaking the previous record of 1:52.9 set by Simon Langer in 1970. Langer's time was set in an 880-yard run and his time converted to the metric equivalent.

Cory Primm, a Westlake Village Westlake senior won in 1:50.9, while Torion Bailey of Lakewood Mayfair was second in 1:52.38.

Simmons' time was the fourth fastest among all four divisions, qualifying him for the Masters Meet.

The other Norman competitor, junior Dominque Sandifer, was sixth in the 300 intermediate hurdles and eighth in the 110 high hurdles.


The Saints, who tied for third in the Tri-Valley League, lost to Golden League champion Quartz Hill, 2-1, in a first-round game May 18.




