#2...During the whole time of this recent



# **City Council Approves Increased JPA**

# City will pay over \$45 million to use BHUSD facilities over next four years

Beverly Hills schools can look forward to a record \$13 million next year in support from the Beverly Hills City Council, who unanimous approved an historic Joint Powers Agreement on Tuesday night at an open City Council meeting.

Based on the new four-year Joint Powers Agreement (JPA), the City of Beverly Hills will pay over the term more than \$45 million, the highest amount they've ever paid, to the Beverly Hills Unified School District for the use of the 16 acres of land and facilities owned by BHUSD when the spaces are unused by students.

"Given the cuts in the state, we felt that it

was the right time to really give a boost to School District to cover anv short falls and to make certain that Beverly Hills school facilities continue to stay in good shape," said Mayor Barry Brucker, who was on the JPA negotiating committee alongside Vice

Mayor Frank Fenton, Board of Education President Myra Demeter and Board member Myra Lurie.

The four-year term spans from 2008 to 2012, and includes ongoing yearly payments of \$10 million which include a 3 percent cost of living increase each year. The \$13 million total proposed for the 2008-2009 year's JPA is a 20 percent increase from the last year's total of \$8.4 million. It includes a \$10 million ongoing payment and three one-time payments of \$1 million each. One of those \$1 million payments is unrestricted and allows the School District to use the money however necessary. But the other two of those \$1 million payments are restricted for uses specified in the agreement, including allotting \$600,000 to replace the turf at the schools, installing CCTV security cameras on the perimeters of all the campus and assisting in the demolition of the condemned annex building on the Horace Mann campus to provide "more green space," Brucker explained.

The money will also be used to build an anticipated new grass field at Beverly High School, where the old science and business education buildings were located.

"Our high school has less field space than any public high school in the state so we are in desperate need of additional field space. Another benefit will be that after school and on weekends AYSO Soccer or little league can have more field space, its like more park space, it's a win-win sit for school district and city," Brucker said.

But Councilmember Linda Briskman sounded some words of caution about the money from the new JPA at the Council meeting

"Generosity without accountability is not gift,"

ment" and not as base funding.

"You can't look to the city when the state cuts funding. ... it's not our job," Briskman

said. She then urged the school parents to be as "diligent in following up on these funds as they were in lobbying to obtain it from us."

With that, all councilmembers voted to pass the new JPA, with great thanks from the parents and Board of Education members in attendance.

"We're delighted by the support the City Council has provided to BHUSD and our students. The JPA recognizes the important role that schools play in the overall health of a community, and the value in investing in the future of a city. In a time of unstable state funding, we appreciate the consistency and predictability of this commitment, which allows us to focus on academic achievement," Board of Education President Myra Demeter told the Council.

The JPA will now be sent to the City Attorney to be finalized and will be adopted by the City Council at the July 8, meeting.



The Draft EIR will be released on Friday, June 13, 2008 for public review and comment. The City of Beverly Hills, the lead agency, encourages public comment on the Draft EIR.

The Planning Commission of the City of Beverly Hills will hold a public hearing on the Draft EIR and the Project on Thursday, June 26, 2008 at 7:00 p.m. in City Council Chambers, Beverly Hills City Hall, 455 North Rexford Drive, Beverly Hills, California 90210.

The rehabilitation and reuse of the City's former main Post Office into Wallis Annenberg Center for the Performing Arts at 470 North Canon Drive. The Center would include:

- A 500-seat auditorium
- A studio/rehearsal hall for up to 150 occupants
- Three classrooms (up to 60 occupants altogether)
- A functional 3,400 square-foot entry hall
- Administrative offices
- Incidental food concession (750 square-feet) (plus outdoor seating) Sculpture gardens, landscaped walkways, and open space

The performing arts center would involve the rehabilitation and reuse of the City's former main

Post Office to house the classrooms, studio, ancillary activity space, administrative offices, and theater support areas. The Project also involves the construction of a new 43 foot, nine inch (43'-9") high theater and sculpture gardens on the southern portion of the Post Office site. The performing arts center is subject to the approval of a lease amendment for the Post Office site by the City Council.

A City subterranean parking structure proposed at 455 North Crescent Drive, under Crescent Drive between the former Post Office and City Hall. The parking facility is proposed with options as either a two-level garage or a three-level garage. The two-level option is proposed to provide between 270 and 300 parking spaces with points of access at Santa Monica Boulevard South and through the parking lot along the north side of the former Post Office (proposed as a motor court). It is addressed in the main impact discussion of the Draft Environmental Impact Report. The three-level option would provide between 400 and 430 parking spaces. As it has much in common with the two-level option, most of its environmental issues are covered in discussion of the two-level option. Specific discussion of the three-level option is included in the Alternatives section of the EIR, which focuses are areas where the three-level option differs from the two-level option. The Project may be approved with either option by the City Council.

Copies of the Draft EIR will be available for public review beginning Friday, June 13, 2008, in the Community Development Department at 9357 Third Street, Beverly Hills, California 90210. A copy of the Draft EIR will also be available for review at the Beverly Hills Public Library at 444 North Rexford Drive. One copy (per person or organization) of the Draft EIR may be obtained from the Community Development Department without charge. (Reproduction costs may be charged for additional copies.) The Draft EIR will also be posted on the City's Website at www.BeverlyHills.org on Tuesday, June 17, 2008.

After evaluating the Project's potential effects on the environment, the Draft EIR has identified the following significant impacts: temporary traffic impacts during Project construction, The Project alternative (three-level parking facility) was found to have potentially significant traffic impacts at certain intersections along Santa Monica Boulevard South ("Little" Santa Monica). In conjunction with other development in the region, the Project was found to contribute to cumulative environmental impacts.

The 45-day public comment period will be from Monday, June 16, 2008, through Thursday, July 31, 2008. Comments on the EIR will be accepted at the June 26, 2008 public hearing and in writing prior to the end of the public comment period.

Copies of all relevant material, including the Project specifications and the environmental initial study are available for review in the offices of the Community Development Department of the City of Beverly Hills.

Kudos: Although we support the JPA funding the city provides for our schools and agree totally with the increase the council approved Tuesday, Councilmember **Linda Briskman** sounded a very important cautionary note:

Future increases may not be available, the city can not always come to the rescue when the state cuts education funding and the district needs to carefully manage JPA money.

The JPA is not a "grant" but payments for school services, the only legal means allowable, and Beverly Hills probably provides more money through the JPA than all the other schools in the state combined – and we were probably the first to initiate the concept when **Dr. Charles Aronberg** was mayor and **Vicki Reynolds** school board president.

We have great confidence in our schools, especially under the leadership of Supt. **Kari Mc Veigh**, arguably the best super since the days of **Ken Peters** and **Sol Levine**. But a city's ultimate responsibility is making sure the city is safe and well protected by an adequately supported police and fire department, the streets maintained and all the other municipal services for which the city receives tax dollars. That was never intended to include money for schools – a separate governmental agency, but one we support because of its importance to all of us, even those without school age children.

Final Note: As frequent readers know, I hate to pick on Rite Aid, but this one is too tempting. According to a resident, he recently called the Canon Drive Rite Aid to find out if they still carried books on tourism, which they once did. This brilliant response from a staff member: "No, but you can find those in a book store." Duh.

For the last eight years, Diane Olson and Robin Tyler (see photo, page 2) have trekked to the Beverly Hills courthouse on Valentine's Day to ask the city to marry them. And every time for the last eight years, they were denied their request. But that changed on Monday evening at 5:01 p.m. when they returned to the courthouse to become the first same-sex couple to be legally married in California.

Mayor Barry Brucker presented a certificate of congratulations to the newly-weds on behalf of himself and the city. He then toasted the couple, congratulating them on their marriage and thanked them for "their perseverance and tenacity in leading the ways to the California Supreme Court which will benefit all those same sex marriages that may come henceforward."

Reform Rabbi Denise Eger performed their ceremony, in front of their friends and family. Local Coldwell Banker realtor Michael Libow, who helped organize the event, sang "Someone to Watch Over Me" a cappella at the cake-and-champagne-filled ceremony as "a way to give back to them," Libow said. It was one of the brides' favorite songs.

After the ceremony, the couple thanked the city of Beverly Hills for helping out in providing safety and securing the space so they could have their ceremony.

The Beverly Hills Police Department was on hand to ensure the safety of everyone at the ceremony. The "protesters were pretty tame and it was hard not to be when there were hundreds of people there, cheering on the married couple. It was so joyous," Brucker said.

"It was an important milestone for the city of Beverly Hills because our city is known for our tolerance and unconditional accepting of all people of all faiths, colors, ethnicities, gender preferences. That's something that makes Beverly Hills so strong," Brucker said.



# Steven Fenton Named 'Democratic Man of the Year'



# E-waste Not, Want Not

Students in Sarah Utley's AP Environmental Science (APES) class at Beverly High School teamed up with ASL Recycling to host a successful electronic-waste collection event at the back of the school last week.

"Electronics have lead in them, so basically we're recycling so it doesn't get into our landfills," said APES student Jade Rosenberg, who helped to run the event with fellow student Doreen Tivon.

Over 60 people showed up to drop off their old electronics for recycling, free of charge.

"We took in 2,200 pounds of e-waste," said Matt Strud of ASL Recycling, the third largest recycling company in the country. They collected 27 CRT monitors [televisions], five lap-tops, 11 CPU towers [computer towers], 111 cellphones and 1,000 pounds of breakage, which are things like printers, fax machines and copiers.

Since passing the Recycling Act of 2003, California has implemented the most aggressive recycling regulations and recovery plan nationwide, Strud explained. Now in California, when a consumer buys, for instance, a television, that consumer pays a \$14 to \$16 recovery fee at the time of purchase. When that television is recycled that fee is paid to the recycler, providing an incentive to recycle. Strud likened the process to the way bottles and cans are recycled.

ASL Recycling breaks down the e-waste into its respective components and properly recycles or disposes of the waste, preventing the mercury and lead in the electronics from infiltrating the city's water system.

"I am humbled and honored to work with such a fabulous organization and with such amazing individuals who want a better education not only for their own children in our schools but for all children who deserve excellence in public education," Rosenblatt said.

Before this installation, Rosenblatt was serving as chairperson for the foundation and has previously served as president. She replaces current two-year president Devorah Hankin, whose term expires on June 30 at which point she will become the foundation's CEO. Don Creamer will take up Rosenblatt's previous position as chairperson.


