"Horowitz could take job with the same company he was monitoring for BHUSD" [Issue 491]

I was surprised to read that former Measure K Citizen's Oversight Committee ("COC") president Bruce Horowitz was negotiating a consulting agreement with Strategic Concepts, the company that the COC was chosen to objectively monitor and the company whose positions he consistently supported. For the record, I served for the first 2 years on the COC along side Mr. Horowitz and want to be clear that I am not aware of him ever taking any positions during my tenure that would be less than sincere or of a questionable nature. That said, those who serve the public, as do members of such oversight committees, must be held to the highest possible standard and certainly to a higher standard than might be expected in the private sector. That means the mere appearance of impropriety or conflict of interest, even absent any actual impropriety

or conflict, is a breach of the public trust and must be avoided. Mr. Horowitz's potential business arrangement with Strategic Concepts casts an unfortunate and unnecessary shadow over his own objectivity and independence, as well as that of the COC and that of the entire process. This issue is only magnified by the potential involvement of Strategic Concepts in our latest school bond. Given that the BHUSD is now in the process of forming a new COC which will be tasked with overseeing the expenditure of as much as \$334 million, it is imperative that steps be taken to guarantee that the process going forward is objective, both in perception and practice.



Brucker, Brien, Mirisch win **Council race**

Measure P loses By Jacquelyn Ryan

Current Mayor Barry Brucker along with newcomers Dr. Willie Brien and John Mirisch won the three Beverly Hills City Council seats while business tax initiative Measure P was defeated by almost 80 percent in Tuesday's election, according to initial returns reported by the Beverly Hills City Clerk's Office. Official results will not be certified until later this month.

Nine-hundred-three provisional and late absentee ballots remain to be counted. The City Clerk's Office will release another count Friday.

Brucker will be re-elected for his second term on the five-member City Council after garnering the most votes of all the 11 candidates with 2,566 on election night Tuesday.

"I feel grateful the community felt confi-

dent in me to re-elect me. I'm humbled. I had an incredible team of 60 volunteers. I couldn't have done it myself," said Brucker.

A first time candidate for City Council, Brien, chief of staff at Cedars-Sinai hospital, placed a close second place with 2,476 votes

"It was a lot of fun to watch the numbers come in, especially when you're getting a lot of them," said Brien. "I'm just thrilled [and] humbled. It was a great night and great campaign. I commend and compliment all 10 other candidates who ran. I'm thankful for all the support, from teachers, fire [department] and police [department]."

Brucker and Brien served on the BHUSD Board of Education together earlier in the decade. Both say they are looking forward

> "It was very exciting following the results because I wasn't an incumbent and it took me longer and I had to work harder to connect with residents," said Mirisch. "It showed that it paid off."


> Assuming Briskman's totals aren't reversed, Councilmember Nancy Krasne will become the next mayor of Beverly Hills.

The seven other candidates for Beverly Hills City Council made up only 34.9 percent of the vote total on election night. They received a combined total of 4,831 votes, with former Board of Education member Virginia Maas receiving the majority of votes with 1330; former Mayor Richard Stone received 1,311.

Milt Rowen, longtime Hawthorne principal, passes

Former Hawthorne School principal (1965-83) Milton Rowen passed away on Monday after battling an unspecified illness. He was 91.

A North Dakota native, Rowen was profiled in a 2005 "Where are they now?" Weekly interview in Issue #309.

Before coming to Beverly Hills, Rowen served in the military during World War II. Over the following years, he held teaching and administrative positions in Manhattan Beach, East Whittier, Idyllwild and Glen Ranch. He ran schools for the US Air Force in Europe, where he taught in Germany as well as London and Spangealen, two cities in which he was also principal.

In his 2005 interview, Rowen said Hawthorne was "a dream assignment as far as I was concerned because the teachers were all very professional, very proficient and very likeable."


After retiring, Rowen helped organize an after-school class for gifted eighth-grade students to learn from NASA professors. He later taught at the Beverly Hills Adult School as well.

"He was full of creative ideas about how to improve the program. He quickly fit in with the PTA and alumni support organizations and the Beverly Hills Education Foundation," said Walt Puffer, who served as Rowen's assistant principal from 1966 to 1972, at which point Puffer became principal of Beverly Vista.

Puffer called Rowen a "kind and bright fellow" who was "tall man with a deep voice. He liked to move quickly and took big strides. The kids were in awe of him. But he had a heart as big as gold."

Puffer credited Rowen for helping him achieve the role of principal at Beverly Vista.

"It was a pleasure to work with him. A lot of my administrative experience as an assistant principal helped me with the interview

Beverly Hills home prices dropped by almost 40 percent from Dec. '07

Beverly Hills home prices fell by 38.8 percent in December 2008, compared to prices listed in December 2007, according to DQ News.

Of the 11 homes sold in Beverly Hills, the average price was \$1.050 million in December 2008. In the same month in 2007, homes sold for \$1.7 million.

Condominium prices fell 53.4 percent from January 2008 in the 90210 Zip Code. Of the two condos sold in January, the median price was \$710,000. The seven homes in 90210 sold for \$2.6 million sfr, a 16.1 percent drop from the same month last year.

In 90212, one condo sold in January for \$850,000, a 26.1 percent decline from 2008, according to DQ News.

No information was available for the 90211 Zip code.

Beverly High's academic decathlon team will compete against 59 other teams at the 30th annual state competition in Sacramento next month for the chance to represent California at the national championship.

Beverly Hills came in eighth place in the LA County competition but earned one of the 21 available "wild card" positions given to the next highest teams to create a 60 team state competition, according to coach and Beverly High teacher Stewart Horowitz.

The top schools in 39 California counties automatically win a spot in the statewide competition.

Horowitz says that teams like El Camino have incredibly established academic decathlon programs that could rival college courses. Those teams typically win each year.

"But it's an added bonus for the [BHHS] kids to get to go to Sacramento," said Horowitz.

Normans scored 40,298.70 points recently in Round 2 competition, placing them 36th out of 60 teams participating in the state championship.

Several other Southern California school teams, like Venice and Palisades Charter high schools, will face off against the Normans in Sacramento.

The highest scoring team will go on to represent that state of California at the national competition in Memphis, Tenn., on April 22.

All decathlon teams are comprised of nine members from the high school: three students with an "A" grade point average, three "B" students and three "C or below" students.

There are 500 teams in California from 42 different counties.

Board to assess impact of state budget deficit on BHUSD

The Board of Education will receive a report outlining how the state of California's current budget will impact Basic Aid status for public school districts, a status which the BHUSD is increasingly close to becoming.

In the EDC at Beverly High tomorrow at 11 a.m., the Board will hear from Bob Blattner,

the director for school facilities leadership academy and head of Sacramento-based Blattner & Associates, about basic aid and the BHUSD.

The budget cuts will translate into a cease of cost of living adjustment provided to revenuelimit school district as well as reductions of \$944 million in the current year and \$265 in the budget year.

According to documents obtained by the Weekly, these cuts will equate to a "deficit factor" of 13.1 percent below the funding levels that would be necessary just to keep up with the increased cost of doing school business.

BHUSD assistant superintendent of business services Cheryl Plotkin did not return calls by press time.

Board member, BHEF CEO to discuss new college counselor position

Board of Education member Brian Goldberg and Beverly Hills Education Foundation (BHEF), an independent nonprofit fundraising group for the BHUSD, CEO Dev Hankin met to discuss a potential new volunteer position dedicated to bettering Beverly High's relationship and reputation with the country's top 30 universities last week.

The position, which would be managed by BHEF, would be aimed at "developing a relationship with alumni in our community and the top 30 universities," said Goldberg.

The Beverly High college counseling program currently provides a variety of resources for college-bound high school students, beginning with meetings in the eighth grade.

However, this position would ideally help put BHUSD high schoolers in touch with nearby alumni and help to establish a clearer understanding of Beverly High's curriculum with the universities' admissions offices, according to Goldberg.

Hankin was receptive to the idea and will soon make a presentation to the BHEF Board of Directors.

Why Did They Win or Lose

A look at the election results By Rudy Cole

As an event, it was a bust. Eleven candidates spoke at forums, knocked on almost every door of the city, placed signs on more lawns than Coldwell Banker, published countless ads in newspapers and gave the post office enough mail to qualify as a stimulus package.

Once again, a city council election bombed at the box office – polling place.

Think of it this way, there are 32,000 residents and 21,000 registered voters. Some winners in this and recent elections won with about 10 percent of the population's support. Not a magnificent mandate.

It isn't as if we haven't made it easy, almost too simple to vote. Request and return an absentee ballot and you can help pick your elected officials. No need to actually spend a half- hour to visit a polling place.

Why don't people vote in city elections? This time there are all kinds of reasonable explanations: We are election weary, the long presidential trials exhausted the electorate, including our own. Fears about the economy distract our interest in less pressing issues.

Or, the two most often cited, if contradictory, explanations: "We have a good city government, no matter who is elected," or, the more negative, "nothing is going to change whoever we select."

Every election has surprises, varying degrees of nastiness, smears and inexplicable contradictions, including Tuesday's exercise in democracy.

Considering the highly divisive battle fought over the Hilton, Measure H, issue which was on the presidential ballot and produced a record voter turn out only last November, it would not have been too shocking if that battle carried over to this election.

Not quite, considering the mixed messages sent by the voters. **John Mirisch**, a vocal opponent of Measure H, has apparently defeated Councilmember **Linda** **Briskman**, who voted for the Hilton Revitalization plan.

Mirisch had the backing of the two most vocal anti-Hilton organizations in the city: The North Beverly Hills Homeowner Association and the Beverly Hills Municipal League. But so did **Richard Stone** who trailed Briskman by almost 500 votes! Mayor **Barry Brucker**, who also opposed Measure H and who was not backed by the NHOA led Mirisch by nearly 600 votes.

Its hard to find a real pattern here or pin point exactly what issues dominated the election, but there are some other factors, including some incredible last minute events, that could offer some clues on the mood of the voters.

Many voters received calls supposedly backing John Mirisch that were, at best, bizarre. Our sophisticated electorate almost universally assumed these phone messages, many coming very late in the evening, were dirty tricks aimed at hurting Mirisch. But were they? I am not suggesting Mirisch or his supporters engineered the dumb trick to actually help John, but someone did. What were their motives? Probably not just to elect Mirisch, but help defeat or lower the vote of one of the other candidates. Best guess, and only that, some fairly sophisticated operative wanted to hurt Mayor Brucker and not just Linda Briskman.

As for another newspaper's attack on Linda Briskman, that was even more confusing to the voters. Here she was being faulted for voting for projects, including Measure H, that the same newspaper had even more vigorously backed. Did the hit pieces hurt Briskman? Probably a wash: Galvanized her backers, turned off opponents of recent developments.

In every recent election, one incumbent becomes the main target of anti-council sentiments. Two years ago, that honor went to then Mayor **Steve Webb**, this year Councilmember Briskman. There were other issues too:

The confused posture on two hour free parking, pledging not to run for a third term and then responding to a very credible draft, but mostly it was finding the one candidate who most exemplified voter perception of being too supportive of development issues.

Those who voted were not quite ready for a city hall revolution. Dr. **Willie Brien** came in under the radar on issues and Mayor Brucker easily won despite frenetic earlier battles with some homeowner associations.

What about Richard Stone and **Virginia Maas**? Stone had won and even come in first in countless elections for city council and school board, but fell badly this time. Maas ran a very vigorous, credible campaign, backed by many of the city's "establishment." Both opposed, in different degrees, Measure H, and yet their

votes collapsed.

Challengers face this in every election, with a multitude of anti-incumbent choices. One candidate emerges as having the best chance of winning and the "no" vote coalesces for them. It's the not wanting to waste a vote syndrome.

Mirisch had other advantages: Strong family ties to the community, a very recognizable name in the film industry, attractive, youthful appearance and enthusiasm, and the endorsement of this newspaper, giving him another tool in separating himself from the other contenders. That support also probably landed second and third votes for Mirisch from the other candidates The Weekly endorsed.

First, a cautionary note: There are about 900 plus votes yet to be counted and Briskman could still edge Mirisch, but that is simply not mathematically likely. What is not even remotely acceptable is the allegation made by one of Mirisch's supporters at his victory party that the election could be "stolen." Again, not John's fault, but this kind of political paranoia has no place in our city. There are few more competent and trustworthy civil servants than those in City Clerk **Byron Pope**'s office.

Side notes: Best literature in the election? **Sue Brucker**'s mailings for Barry.

This election is also a study in what tools not to use. Aside from the convoluted and unauthorized Mirisch telephone calls, those made for and by **Michael Hakim** totally backfired. He actually lost more than half the vote he received the first time he ran. Make a call, lose a vote.

As for the Persian vote, it is not going automatically to a member of that community. Iranian voters are just as discerning and issue oriented as the rest of the electorate. There is NO block voting. **Fran Cohen** a likeable chair of a city commission and Hakim, a popular graduate of our schools, did not convince the voters, both Persian and non-Persian, that they were yet ready for prime time.

As for our city employee associations, the Teachers lost one, won two (Brien and Mirisch) and the police and fire guys won two (Brien and Brucker).

What does this all mean for city government? There will be serious impacts. One of the strongest arguments for Briskman was her experience, much needed in these very challenging times. She would have been mayor. Now, first term councilmember **Nancy Krasne** will take the gavel.

Krasne, although not openly supporting Mirisch, does see him as an ally.

They had and have many of the same supporters, although their styles are quite different.

Brucker will step down as mayor but could actually be a swing vote, if sides are indeed prematurely formed. Brien has always been a moderate, consensus builder, and those talents will be needed in what could be an overly heated council five. There should be no rush to make changes in staffing at any and all levels of city government, but more on this next week.

With the possible loss of Briskman,

what will now surely happen is splitting of the Visitor's and Conference bureau from the Chamber of Commerce and the resulting dislocation of staff that will bring.

One change a Mayor Krasne is likely to make is the plethora of ad hoc committees the council now has. There are simply too many and too time consuming to be effective and they are often used to impact commission decisions before they reach the council. Sometimes this is good goal setting, but too often they deter a more open governmental process.

It is important, no critical, for new and old councilmembers to fully understand the rules of a city manager form of government. Mayors and councilmembers are not permitted to give direct orders to department heads with the exception of the city attorney and city clerk. They make their positions known at public meetings or through the city manager. Not playing by the rules, harms both staff morale and the orderly, democratic process.

district policy that no implied promise was made to anyone. My colleagues who support "grandfathering" in all opportunity permits have created a convenient argument after the fact to try and pass a new policy and practice. This policy would mean it is more advantageous to be a permit student than a resident student. At the Tuesday, March 10th board meeting the Board of Education will decide whether or not to guarantee permit students enrollment through 12th grade. If the Board majority votes to create this new policy they will be creating a two tiered system where residents have fewer rights because no resident is guaranteed matriculation through 12th grade.

These discussions are taking place because our district is close to becoming a basic aid district (this is not something the Board will ever vote on, this is a designation the State of California will make). We only enter basic aid status if and when we would receive more funds from our local property tax then we would receive from the state on a per pupil had been returned to the City Clerk's Office.

"This is a great process because at the end of the day, it's the people who decide," said Brien.

Measure P, the business tax initiative, went down in flames Tuesday night.

The initial vote tally showed that No votes totaled 3,972 (or 79.1 percent) to the Yes' 1,047 votes (or 20.8 percent).

Measure P would modify some professional business taxes to a gross-receipt model, enact a 10 percent tax on private parking structures and create a gross-receipt tax on oil extraction in the city.

BHWeekly:Tell us about your role at Beverly High.

Calvin Berman: I've been in ASB [student government] since freshman year. I have been elected seven consecutive semesters to a position, ranging from class treasurer all the way to ASB president. Right now, I am the senior class president because my term as

ASB president was up [in late January]. ASB [is a class that] meets the period before lunch. It will plan events for the student body to come and attend, anything from a hip hop concert to the yacht dance [last month] in Marina Del Ray. Not only does ASB plan events, but it oversees the student body budget. All monies going into and out of the school regarding student body pass thru ASB – like athletic entry fees, buying new printer for Highlights, which is the school newspaper, parking permits, agenda books— there are just so many things.

What's the difference in responsibilities between ASB president and class president?

The ASB president is symbol of student body. During ASB meetings, he or she would stand in front of the class run the meetings, pretty much like the Speaker of the House. The senior class president is just any regular class president, in charge of the class' budget and events.

How is Beverly High different from the way it's portrayed in media and entertainment?

The media portrays Beverly as seemingly filled with uncaring student who really are indifferent to academics. Frankly, that's not true for most of the students at Beverly. If you look at the statistics of where kids go to college, it's a pretty impressive resume.

The media also portrays it as an entirely materialistic the school and that's not true either. The school that "90210" is filmed in isn't even Beverly High; it's Torrance. It's made to look like a hotel and Beverly looks like any normal high school.

What's it like being a student at Beverly High today?

Being a student is very interesting. Recently, our test scores have been dropping but I don't see any difference in the students, per se, than when I started three and half years ago. But never the less, it seems like the students are doing a good job as far as scoring on AP tests and getting into [colleges]. Beverly still has so many things to offer as far as sports, academics, all the different extracurricular activities. From the outside, it looks like the same school and in a lot of ways, it still is. But obviously, the school has been growing in population and academics but mainly academics, but as statistics show, test scores are a problem.

I think the administration is doing a really good job in trying to turn around the downward sloping curve of test scores.

Would you say there is still a Persian/American divide at the school?

It seemed like at the beginning of high school, kids tend to group with other kids they feel more comfortable. It seems like it would be by nationality in a lot of ways. I've seen as I've grown older and high school is coming to an end that more kids are interacting with each other. You'll see a European kid, a Latino kid, a Black kid and Persian kid sitting together. With my grade, I've seen a lot more integration.

Would you say there is a divide between the four-year college bound kids and the two-year college bound kids?

Yeah, I still see that. Well, I take that back. There are very strong students who I know who already know they are going to two-year college. And then there are students who work very hard who just end up going to a two-year college because they couldn't get into the school of their choice. I don't necessarily see it as a two-track school but it seems the positive aspect is an overwhelming majority of the kids end up going to college.

Give us an example of something that all the students do at Beverly High?

Text messaging! I don't know anyone who doesn't text message [before school, during school and after school]. In class, not as much but it does go on a little bit. What I would be texting my friends at nutrition would be like, 'Let's do something after school.'

What have been the differences between your experience at Beverly High and your older sister Liz's experience about 10 years ago?

I don't know if it's the high school aspect, but academically speaking, getting into college. It seems like you need to be involved and maintain a higher GPA than what was expected before to get into the schools.

As social aspects go, we always talk about our different experiences. It seems like it's the same. We compare where we go to eat. Some of the places are the same restaurants like Bay Cities in Santa Monica and on Beverly Drive there was Baja Fresh and what used to be Johnny Rockets, now Beverly Hills Diner.

What are you doing more of to get in college?

I don't think I would have done anything different had I gone to school 10 years ago. But I do see a lot of my peers trying to overextend themselves with trying to get into college in the back of their mind, like joining the football team and still trying to maintain a GPA over 4.0. Sometimes students won't take into consideration the various time commitments that come with being involved with so many extracurricular activities. [There are] pressures that comes along with the pressure to be all you can be and exceed limitations.

I was on wrestling team last year. Well, my grades aren't necessarily the highest in the school. But basically I felt like I did what I wanted to do to have fun and at the same time made myself look good for the colleges.

How did you balance it all?

It was pretty tough but at the same

time I felt like I did a pretty job. There were times I should have been studying for a test and getting a better grade but I didn't have time. There was defiantly some overlap. I didn't go very long without thinking about a wrestling match. I never do my homework during a meeting [but] that's not to say I wasn't thinking about my schoolwork.

What are the issues or challenges that are happening at Beverly High?

I feel like peer pressure has been an age-old thing but I definitely do see that students and kids in general feel the pressures of teenage society that often include drinking and doing drugs, but I feel like kids at Beverly do a really good job avoiding those pressures.

How do you fight those pressures?

For me, it was finding a good group of friends, sharing common interests for extracurricular [activities]. My two best friends both were on the wrestling team and both have strong ambitions in terms of what they want to do in the future. You can also spend your time doing so many more productive things. One of my friends is really into making movies and another is into archictecture. The more things you do that you have fun doing, the easy it is to avoid falling into somewhere you don't want to be.

What are some of the issues students think about now?

Definitely right now and since end of junior year, it's been the college hunt. [Many students] are trying to assemble everything like a personal portfolio to make yourself look the best in front of colleges. In every single one of my classes, it's rare to go a whole class without hearing something about college from students, [such as] everything from finding SAT tutor to filling out 12 applications at a time.

What colleges are you and your friends applying to?

Most kids have already applied. I'm really gunning for USC; that's my number one. I'm also looking at UC Berkeley, NYU, Emory University in Atlanta, University of Texas at Austin. [Other students have applied to] UCLA, USC, NYU, UC Berkeley. There are a lot of hot schools. Among my friends, some are relatively obscure, like Tulane in New Orleans.

How often did you interact with Board of Education student member Daniel Yosef?

Daniel and I are great friends. We sat on Head Row [like a governing board] together at ASB. He has done a terrific job of attending every school board meeting. In most ways his responsibilities are heavier [than those of the ASB president] because he is the voice of the students to the highest board in the school district, which is the school board. That in itself is more responsibility than the ASB president under taking a semester. [A student Board member] has a whole year term.

[Daniel] would come to class and give reports on what was happening at Board meetings. Just recently, we talked with the class about permits. I know that's a recent topic that's being talked about at the meeting.

What did you discuss about the permit issue?

Amongst the students, we discussed all the positive things that permit students contribute to the school and some of the negative aspects as well.

A positive [aspect] would be one of the girls, [who is a permit student], is the ASB secretary. She is a great student in AP classes and is in ASB. She contributes so much to the class.

A negative example would be a student who started out becoming a permit student in middle school and kept the permit through high school. It might be he was once a strong student but may have lost the ambition to achieve academically.





Hard Work Gives BHHS Girls' Basketball Team First Finals Appearance

Normans to face Mater Dei for title Friday. By Steven Herbert

The Beverly High girls' basketball team earned its first Southern Section finals berth by taking early control of Saturday's Division II-A semifinal against Fontana Summit, building a lead as big as 11 points and withstanding several runs in a 73-67 victory at Fontana High.

"We never stopped playing with intensity," Norman senior guard Sophie Payson said. "We just had all the heart in the world."

Beverly Hills trailed only once, 4-2, and led 15-11 at the end of the first quarter and 30-23 at halftime. The third-seeded Normans took their biggest lead, 42-31, with three minutes, 57 seconds left in the third quarter on Miranda Abdul-Monsour's basket.

The second-seeded Skyhawks, who defeated Beverly Hills, 63-50, in a championship semifinal game of the Best of the West Tournament Dec. 30, scored the next eight points.

The Normans (24-8) closed the quarter with a basket by Chelsea Austin and two free throws by Morgan Mason, and led 46-39 entering the fourth quarter.

Beverly Hills senior center Javonna Young scored the first basket of the fourth quarter, but Summit (26-5) then went on another 8-0 run, on a 3-point basket by Arielle George, a 2-point basket by George and Adrianne Thomas' 3-point play, pulling to within one, 48-47, with 5:48 remaining.

The Normans scored the next six points as Young made the second of two free throws,

Abdul-Monsour made a 3-point basket and Mason made a lay-up, giving Beverly Hills a 54-47 lead.

The Skyhawks cut the lead to three points three times, 54-51, 57-54, 59-56, and two three times, 60-58, 62-60 and 64-62.

Alyssa Domingo's 3-point basket with 37.8 seconds left pulled Summit within one, 66-65, but she missed the potentially tying free throw.

The Normans got some breathing room as Austin made the first of two free throws and Mason made both free throws when she was fouled getting the rebound of Austin's miss, for a 69-65 lead.

The Skyhawks shot an airball on a 3-point shot with 20 seconds left and Payson iced the victory by making four free throws in the final 18.3 seconds.

"I'm so proud of my kids," said Beverly Hills coach John Braddell, who guides a team that hadn't won a playoff game from 1979 until last season. "They played so hard. No matter what they threw at us, we just worked our way through it."

Braddell called it "one of the best games I've ever part of."

"It had everything," Braddell said. "You had adversity, you had fouls, girls going to the basket, getting hit, making free throws. The intensity was tremendous."

Summit was called for 26 fouls, the Normans 25. Beverly Hills made 27 of 36 free throws, the Skyhawks 18 of 33.

Abdul-Monsour scored a game-high 21 points, including two 3-point baskets. Mason added 18, making 10 of 12 free throws, including six of eight in the fourth quarter. Payson added 14, with 3-point baskets in the first and second quarters and making six of six free throws. Austin added 10, Young six, Jie Ren three and Didi Younesi one.

Austin had 10 rebounds and six blocked shots.

Summit coach Alexis Barile said her team "didn't play the best basketball it could have."

Barile said atmosphere and intensity was the difference from the first time her team played the Normans.

Beverly Hills 66, Newbury Park 48

Young scored 17, Abdul-Monsour and Mason 15 each and Payson 14 in a quarterfinal game last Thursday at the Swim-Gym.

Beverly Hills led 44-32 entering the fourth quarter and ended any chance of a comeback by the sixth-seeded Panthers (22-6), outscoring Newbury Park, 22-16, with Mason scoring nine points.

The Normans led 18-13 at the end of the first quarter, as Abdul-Monsour scored seven

points and Payson five, with both making 3-point baskets.

Beverly Hills increased its lead to 32-23 at halftime by outscoring the Panthers 14-10 in the second quarter as Young scored six points and Abdul-Monsour four.

The Normans outscored Newbury Park 12-9 in the third quarter, as Payson and Young both scored five points, with Payson making a 3-point basket.

"I thought we played extremely well," Braddell said. "Everybody showed up to play and played extremely hard. We did a nice job against their point guard (Sidney Dobner) and center (Doris Park-Sherman)."

Dobner was held to five points, eight below her season average, while Park-Sherman scored 12, three below her average

Braddell said he was surprised by the margin.

"Before the game, I was very leery of this game," Braddell said. "I watched them on tape and they look very good."

Austin and Ren each scored two points and Natalie Moy one.

Braddell praised Moy for playing great defense and said Young played well defen-

sively, offensively and in rebounding. Young had 13 rebounds and Mason 15.

What's Next?

Beverly Hills will play top-seeded Santa Ana Mater Dei (29-0) in the Division II-A final Friday at 8:30 p.m. at Colony High School in Ontario. The Monarchs are ranked second in the nation by USA Today and have won their playoff games, 80-18, 77-39 and 74-25.

The Normans and Mater Dei have two common opponents. Beverly Hills defeated El Segundo, 54-27, and West Hollywood Pacific Hills, 71-67, while the Monarchs defeated El Segundo, 64-22, and Pacific Hills, 81-59.

Friday's game will mark the fourth time a Norman team sport team has played in a Southern Section, and first since 1991, when the boys' soccer team lost to Santa Ana, 5-1, in the 4-A Division final. The boys' basketball team lost to Inglewood Morningside, 64-62, in overtime, and defeated Santa Maria, 74-62, in the 1969 3-A Division final.

The semifinal victory qualified Beverly Hills for the state tournament, which begins Tuesday. Pairings will be announced Sunday.






