

City Treasurer responds to Rudy Cole [Issue #672]

I am writing to correct misinformation contained in the first section of Rudy Cole's August 16th column in *Beverly Hills Weekly*. Mr. Cole stated:

"According to city rules, the Treasurer is responsible for monitoring and advising on investment policies. However, Finkel has created financial advisory committees that have gone far beyond investments, becoming engaged in budgetary matters that are the final responsibility of the council.

"On the plus side, his efforts have supposedly been welcomed by both the council and city financial officers, but this has created questions on possible usurping of authority."

Mr. Cole is incorrect in his assertion that acts of the City Treasurer have "created questions on possible usurpation of authority." The primary duty of the City Treasurer is set forth at the City website www.beverlyhills.org: "The primary responsibility of the City Treasurer, as assigned by the City Council in 1959, is to invest surplus funds (the General Portfolio) of the City in accordance with the California Government Code and the City's Investment Policy." As an elected official, the City Treasurer is technically responsible to the voters of the City, but the Treasurer performs his or her duties at the direction of the City Council. The City Treasurer also typically advises the City Council and City Manager, or their equivalents, on matters relating to municipal finance.

In the spring of 2009, City Manager Rod Wood asked me to create the Citizen's Budget Review Committee. The stated purpose of the committee, which was formed in the midst of the worst recession since the 1930s, is "to critically evaluate the budget process and provide ideas for creating additional revenue or spending cuts." Before forming the committee, I spoke with each member of the City Council to obtain his or her consent and to solicit candidates for the committee. All of the members of the committee were chosen from the council's candidate list.

In the spring of 2011, in a discussion with Mayor Barry Brucker, he asked if I could help clarify the extent of our City's safety (police and fire) employee pension obligations. He requested that I form the Pension Task Force, which I did at the request of the Mayor and with the consent of the Council. The Pension Task Force publicly reported its findings to the Council in August 2011.

Webster's Dictionary defines usurp as: "to seize and hold (an office, place, or powers) in possession by force or without right." As can be seen from the chronology of events set forth above, both the Citizen's Budget Review Committee and the Pension Task Force were formed at the express request of the City Manager and City Council. Mr. Cole owes the members of the Citizen's Budget Review Committee and the Pension Task Force an apology. Pro bono volunteer public service at the request of our elected officials should be





Board of Education set to break promise not to raise tax rate for Measure E



2008 Measure E campaign mailing

Despite a promise from the Board of Education in 2008 that the tax rate would not be raised as a result of passing the Measure E construction bond, the Board of Education agreed in a 3-2 consensus Tuesday evening to move forward with developing an accelerated bond project schedule, which involves raising the tax rate to the maximum allowed by law without holding a referendum.

Vice President Jake Manaster and Board members Lisa Korbatov and Noah Margo supported raising the tax rate. President Brian Goldberg and Board member Lewis Hall did not support the bond schedule acceleration.

Goldberg, who is the only board member who was on the board at the time the bond measure passed, abstained when his colleagues voted in favor of going out for the bond in 2008, but he participated in “selling” the bond to the community.

“While I think that it’s the right thing to do and the prudent thing for this board to accelerate the tax rate, I cannot support that as a board member who was part of selling that tax rate, even though it was predicated on complete misinformation that was provided to the board,” Goldberg said Tuesday evening.

The community was promised in campaign literature and in the ballot statement that taxes would not exceed the \$49.71 rate residents were already paying for existing bonds. Over the last few years, that rate has crept up to a little more than \$50 per \$100,000 of assessed value.

Under the accelerated bond schedule, the tax rate would increase by \$60 per \$100,000 of assessed value, the maximum allowed under Prop. 39 without holding a referendum.

According to Managing Director Tony Hsieh of Keygent, BHUSD’s financial advisors, if the board raises the tax rate, the initial rate would be \$114 per \$100,000 of assessed value—more than double the promised tax rate—but by 2034 the rate would level off to approximately \$60 per \$100,000 of assessed value until the bonds are paid off.

The bond schedule is lagging behind ambitious projections made in 2008. If

the board does not raise the tax rate, it will likely not be able to access the total \$334 million until 2037.

Hall opposed raising the tax rate without first having a clear plan for construction to present to the community.

Goldberg assigned Margo to spearhead an effort to inform the community of its decision to accelerate the bond schedule,

and to also develop a cohesive plan that will address all five campuses. At a previous formal board meeting, the board allocated up to \$10,000 for the purpose of “educating” the community about its possible plans to increase the tax rate.

Manaster suggested planning construction in a way to provide the option of phasing, so the district can plan for constructing items such as gymnasiums or parking structures at a future date when additional funding becomes available.

“My intention is to have [the cohesive plan] as part of our information campaign to the community so as to not only inform them about the rationale behind the bond acceleration but to also make sure the community understands exactly what and how we plan on spending that money,” Margo said by phone Wednesday morning.

Margo said the goal is for the district to start presenting information to the public within 45 days. He said he would be working with staff to compile a potential plan to share with his colleagues focusing on addressing fire-life-safety and structural issues at all five campuses, since safety was a significant component of promoting the bond.

At the board’s study session in July regarding Measure E construction, the board was told if it continued with its \$62-million plans for Horace Mann, which is now in the construction document phase, and proposed plans for Hawthorne, the BHUSD would run out of bond funds in the middle of construction at Beverly High, even if it accelerated the bond schedule.

On Tuesday, Korbatov initially said she opposed implementing the tax increase without first reaching out to the community, but she changed her position after learning from Keygent Advisors that the district has already lost \$12 million in tax revenue in the year that it has delayed accelerating the bond schedule.

Hsieh said the total cost of the \$334-million bond to taxpayers under the accelerated schedule would be approximately \$1 billion, versus approximately \$3 billion without a tax increase. He said leaving the

Crescent Hotel remodel moving forward

After a second review by the City’s Architectural Commission earlier this month, the Crescent Hotel has been cleared to move forward with remodel plans that will involve relocating its entrance and reconfiguring its outdoor dining patio.

The commission approved the plans presented last week, but requested minor revisions to proposed signage.

When the Crescent Hotel first presented its proposed designs to the commission in July, the commission assigned a subcommittee—Vice Chair James Blakeley and Commissioner Andrea Gardner Apatow—to work with the applicant to revise the project in order to gain approval.

Chair Zale Richard Rubins told the *Weekly* in Issue #669 that the commission did not believe the designs that were presented last month established separate identities of the hotel and restaurant, or created a “sense of arrival” for each. The commission also requested changes to proposed signage.

On Monday, Rubins said the applicant presented substantive changes to the designs at the commission’s most recent meeting on Aug. 15.

“We liked the way they revised the plans,” Rubins said. “It was more fitting to what everybody had talked about. They had met with a subcommittee, had gotten clear direction and therefore they were more prepared for a lot of the questions the commission had the second time around.”

The hotel plans to relocate its entrance from Crescent Drive to Brighton Way, and reconfigure its outdoor dining area. Currently, guests enter the hotel through the center of the restaurant’s outdoor patio.

Under the revised plans presented to the commission earlier this month, the restaurant’s oval-shaped sign will be placed on a wall in front of the patio near the restaurant’s Crescent Drive entrance on the right side of the building, instead of in the center.

The hotel’s main entrance, which was previously proposed as a single door with an overhang above and a small plaque identification sign to the left of it, will feature double doors below a sandblasted glass awning and a larger oval sign identifying the hotel and its restaurant. The windows on the Brighton Way side will feature awnings.

In June, the Planning Commission approved the Crescent Hotel’s application to relocate its entrance, but it did not approve installation of an outdoor bar on the patio facing Crescent Drive. Although the hotel’s conditional use permit previously prohibited awnings, the Planning Commission decided to permit awnings at the hotel, with the condition that the Architectural Commission has the opportunity to review them.

Crescent Hotel General Manager Susan Cronin was out of town and was not immediately available for comment.

Scott Jones, project manager for the hotel renovation, said the intent is to create a separation between the hotel and the restaurant, by establishing a fully dedicated restaurant dining area. He said it was not ideal having guests pass through the center of the patio to access the hotel lobby.

“We will always be a hotel first and foremost,” Jones said. “We felt it was important to have a nice restaurant for our guests but we did want to have a nice restaurant that Beverly Hills residents and people from all over Los Angeles can come and utilize as well.”

tax rate alone would cost the district more in the long run because it would have to issue capital appreciation bonds (CAB), which defer interest to a later date, to continue its bond program.

If the district sticks to the original issuance schedule, taxpayers would continue paying off the bonds until 2075, because the last installment would not be issued

until 2037. Under the accelerated bond schedule, the bond is projected to be paid off in 2054, with the last installment of bond funds issued in 2019.

“I support accelerating the bond schedule because the idea of having a bond that is to be used for fire-life-safety and post-

poning that work for 20–30 years does not make any sense to me,” Margo said Wednesday morning. “The second most important thing is the fact that every day we don’t go out for this bond money, we tack on millions on the back end through the bond.”

As Tuesday’s meeting was a study session, the decision to raise the tax rate is not yet final. The board’s consensus Tuesday directed staff to start preparing an accelerated bond schedule and new tax rates, which will require the board’s approval at a formal meeting.

Pressman named Public Works Commission chair in split vote; Foldvary looks back on leading the commission

voted in favor, while current Vice Chair Joe Shooshani and Commissioner Steven Weinglass dissented.

Foldvary explained Pressman and Shalowitz had not been nominated as candidates for chair and vice chair a year ago because they were only a few months into their terms when the last rotation occurred. Last summer, the commission voted to appoint Foldvary chair for the second time and Shooshani vice chair.

Shooshani and Weinglass, who have served longer than Pressman and Shalowitz, had also previously served as chair.

“Now that the two more recent commissioners have a year under their belt, clearly it’s appropriate to resume the normal assignment of the chairship,” Foldvary said.

Deputy City Clerk Lourdes Sy-Rodriguez said there is no policy in the municipal code that dictates how chairs of commissions should rotate, but she said typically commissions nominate candidates based on seniority.

“We advise all commission liaison staff that it’s by seniority, but they can actually do what they want because there’s no written rule or policy on that,” Sy-Rodriguez said. “They can nominate and vote for whoever they want to be chair and vice chair.”

Shooshani said he assumed he would become chair having served the past year as vice chair.

“Since the timing of getting the new members [on the commission] was such, I assumed that as vice chair, after [that] I would be chair one more time,” Shooshani said.

Despite his dissenting vote, Shooshani

said he supported the commission’s choice of Pressman, who he said is well qualified.

“I welcome it; it’s democracy,” Shooshani said. “It’s a pleasure working with such high-caliber people. This is a fantastic opportunity to serve. I really cherish it.”

Pressman is chair of the S. Mark Taper Foundation Imaging Center and Department at Cedars-Sinai Medical Center.

“We’re very fortunate to have him on the commission, because not only is he a clever guy, [but] he [also] has extensive managerial and committee experience,” Foldvary said.

Reflecting on his second term as chair, Foldvary said highlights included seeing the commission become more involved in fiscal aspects of capital improvement projects.

“I think in some ways the commission has taken on new directions for being stewards of the people’s money and a lot of the credit for this direction does go to Joe Shooshani for bringing up and pursuing various items,” Foldvary said.

Shooshani and Pressman sit on a subcommittee that developed recommendations for how the commission could help the Public Works Department save money, especially related to large capital improvement projects.

“Staff has been doing a very good job; the commission has just expressed an interest in being kept in the loop and apprised of the larger expenditures and projects and preferably with a lead time at the conceptualization phase so that it can be discussed by the commission if appropriate,” Foldvary said.

In his remaining year on the commission, Foldvary said his goal is to see the commission continue to be involved in cost-saving efforts by “fine tuning [it], mak[ing] it more relevant and more appropriate for what we should be doing, as opposed to aspects which run very well without our involvement.”

Foldvary said he looks forward to another productive year for the commission.

“I think it’s been a great year for the commission and also personally for me,” Foldvary said. “We really do feel that we are making a contribution to the city in our capacity as advisors to council, now that we feel we are able to provide some well considered and well researched and well thought-out advice.”

Ordinance review prompts possible extension of Fine Art commissioner’s term

Fine Art Commissioner Curt Shepard’s six-year term is set to conclude in November, but the commission has proposed extending his term through February 2013 to facilitate his

continued involvement with the commission’s ongoing review of the fine art ordinance.

Commission Chair Terri Smooke said the commission presented the proposal on Aug. 15 to the commission’s City Council liaisons Lili Bosse and Barry Brucker, who supported it. Shepard’s extension still requires approval by the full City Council, which will consider the proposal at an upcoming meeting.

For months, the commission has been reviewing the fine art ordinance line by line with the goal of clarifying the language to make it user-friendly.

The ordinance requires building developers to install fine art of a designated value at their properties, or contribute to the public fine art fund in lieu of installing art on site.

“It’s going to benefit the city because it’s going to make it easier for developers to satisfy and understand what they need to do from the very beginning,” Smooke said of the commission’s review process.

Since the commission has been directed by the city council to decrease from seven to five members as commissioners conclude their terms, the commission will be reduced to five members when Shepard’s term concludes.

“We are working very, very hard on the fine art ordinance and it has been incredibly time consuming,” Smooke said. “Our thought is this is such complicated and significant work, it would benefit the commission to be able to have Curt’s participation for another couple of months.”

Smooke said she was hopeful the commission would be done with its review by February.

“I’m really happy to finish an important piece of work for the commission and for the City,” Shepard said Wednesday morning. “I’m familiar with the ordinance, but it wasn’t until we started really digging into it that we saw places where if [the language] was tightened up, it would make the process a lot easier for developers and commercial building owners in



Rodeo Drive Walk of Style announces Vreeland as posthumous honoree

Next month, the Rodeo Drive Committee and the City of Beverly Hills will induct legendary editor and fashion icon Diana Vreeland into the Rodeo Drive Walk of Style® on Sept. 10 at Two Rodeo Drive.

Vreeland, who died in 1989, was influential in the fashion world from the 1930s through the 1980s. She was a columnist and fashion editor of *Harper’s Bazaar*, where she worked for 25 years before she started working at *Vogue* as editor-in-chief. She also worked at the Met’s Costume Institute in New York where she helped popularize its historical collections.

Vreeland will be the nineteenth recipient of the award, which involves dedicating a bronze plaque featuring Vreeland’s signature and a famous quote permanently on Rodeo Drive. The ongoing award, inaugurated in 2003, honors style legends for their contributions to the worlds of fashion and entertainment.

Vreeland’s plaque will be unveiled by her son Tim Vreeland and Lisa Immordino Vreeland, producer and director of the film *DIANA VREELAND: THE EYE HAS TO TRAVEL*. The film will be released by Samuel Goldwyn Films and EPIX on Sept. 21 and is a portrait and celebration of an enduring icon whose influence impacted the worlds of fashion, beauty, art, publishing and culture.

Being The Tokens

Phil and Mitch Margo on tonight's free concert at Beverly Gardens Park

So, two guys from Abraham Lincoln High in Brooklyn made it big, huh?

Mitch: I went to Abraham Lincoln High for a couple of years. We were busy producing records in Manhattan so I wound up going to a high school for young professionals in Manhattan for a couple years in the mornings and then spent the day in the office. It was an interesting young life, I must say.

Phil: High school was very important to this whole thing because I was not a great student, and my music teacher in my junior year kind of uncovered the fact that I had a talent for music. There's such a downside now to education where it's being minimized and teachers are being let go, not necessarily here in Beverly Hills, but the fact of the matter is if you look at most people and the turn of their life, it's a teacher as well as their parents. It's a shame that there's such a de-emphasis on things like that now, but that's another matter.

Tell us about how The Tokens was first formed.

Mitch: I was always interested in music. I was picking out songs on the keyboard, on pianos when I could find them, when I was toddler. I was given some piano lessons early in life and encouraged to compose music. Phil and I discovered we could harmonize together. Phil started playing piano in the mountains in the Catskills.

These things happened at the same time. [The late] Hank [Medress] comes into our lives and he's interested in producing us. This is before I was aware of his entire history. He wanted to produce Phil and I and we did an instrumental recording of a rock-and-roll "Chopsticks." It wasn't great but it was ok. He came over one day and we started writing together, and then we started trying harmony together. "Teenager in Love" was a popular song at the time so we started singing it and we realized we had a nice tight harmony sound, and that's when Hank's earlier background came into play. Originally he was in a group with Jay [Siegel] with Neil Sedaka that was called Neil Sedaka and the Tokens and then they became a group called Darrell & the Oxfords, with a record called "Picture in My Wallet." When Hank started singing with us, he thought it sounded good and he liked the songs we were coming up with, so he called on Jay to join in with us and we had written "Tonight I Fell in Love." Jay came in and added his falsetto and we recorded demos and then there was a strange quirk of fate where Hank met a woman on a train who happened to be interested in producing records. Am I getting this right?

Phil: Let me just fill in a couple of blanks. When I got back from the mountains, from

the Catskills after I played there in the summer of 1959, my drummer in the group, his father won the New York state lottery twice in a row so he left the group and went to college. To show you how fate works, we got a replacement for him. The replacement knew Hank Medress. He introduced us to Hank. I'll always be thankful for this. [Hank] saw something in us. He said, "Let's write together." And that's really how it started. On Dec. 7, 1959 we sang "Teenager in Love" just the three of us, just the background part. That's the blank.

Before we did "Tonight I Fell in Love," we did some other demos and Hank was on the train coming back from Manhattan trying to pitch them. He had the demos in an envelope and there was this woman who said, "Are those demos?" That woman and her son wound up financing our first recording session, where we did "Tonight I Fell in Love." She saw demos and knew what they were. They're made out of acetate and they happen to have a certain smell as well.

Mitch: A smell we'll never forget.

So Mitch, you were only 13 when you joined the Tokens?

Mitch: Yeah I was a little bitty, bitty one when we started.

Phil: I was 19 and Mitch was 14 when "The Lion Sleeps Tonight" came out.

Speaking of which, 50 years later, are you surprised "The Lion Sleeps Tonight" is still as popular as it was when it came out?

Mitch: Stunned and delighted. The whole history of that song is amazing and it seems to grow ever and ever more popular throughout the world and it's amazing how many other people have covered it. I'm very fortunate to be a part of it.

Phil: We had done a demo of it and kind of laid out the record but it didn't have the

lyrics. When we auditioned for RCA, the producers said, "We want to do lyrics for it." The day of the session they gave us the lyrics, and they wanted us to sing the same melody [as] the opening chant. When we did it, it was boring because it was the same melody over and over and over again so we [went] over to the piano and we created a new melody that went with the lyric. Of course we didn't get credit for it, we didn't get paid for it, but it made the record what it became. It wasn't "The Lion Sleeps Tonight" until that day of July 27, 1961.

Mitch: And I always say it's like the whole world made that record the way it came to be. A song that originated in South Africa in the '30s, and then recorded to some success by The Weavers in the '50s, kind of a big band arrangement. Then we got a hold of it and put our own thing to it. And that recording session, it's an amazing picture to me when I think about it: an African American arranger, Sammy Lowe; a couple Italian producers, Hugo and Luigi; four Jewish kids from Brooklyn; a studio full of musicians of all kinds including a female soprano vocalist. It was quite a thing the way that came together, and what a delight.

Phil: Back then, when you had a hit record it was 10 weeks and out. Whoever would have imagined that here 51 years later, we would be singing it in places like Beverly Hills or performing it all over the country and all over the world? It still retains a great deal of its popularity and although not everybody might associate us with it because of "The Lion King," everyone knows "The Lion Sleeps Tonight." If you were to ask me at the age of 70 would I be singing this song, the answer is I don't even know if I'll get to the age of 70.

Mitch: It's a great experience still. We've sung billions and billions of "wimowehs" and I still enjoy performing it.

Around 1978 you both moved to Beverly Hills with your young families and your first stop was South Palm Drive. Tell us about that.

Phil: I had an opportunity to work with Robert Guillaume. He was on *Soap* at the time and later on *Benson*. Because of that I got involved in television. I got to write and produce movies. It was pretty exciting. We moved to Palm Drive to see what would develop. Who knew? Every time for years after that as I drove down Wilshire

Boulevard from my office, I kept thinking I'm on a business trip. It took 15 years before I felt like I was actually a resident of California.

Mitch: We initially moved out to produce an album with Kristy McNichol and her brother Jimmy for RCA. She was a popular TV star and actress.

So your kids grew up in Beverly Hills. What are they doing now?

Phil: Noah is a contractor and school board member. He was a teacher for 10 years. My daughter [Neely] just created a fashion item [that she showed off at] this big show in New York and she got a lot of excitement. She's in the fashion industry. She also has two children and her husband is an Emmy-winning sound editor. Noah is married to Laura Hornwood Margo, [who] is a PhD. My other son Joshua, who is Noah's twin brother, works for SAP. He's also studying to be a rabbi. They just moved back to Southern California from Akron, Ohio because his wife is a judge in Social Security Administration. She's an administrative judge. Plus some political notes

Presumptive Republican presidential nominee **Mitt Romney** deserves praise for his clear and unequivocal criticism of Missouri Congressman **Todd Akin's** unfortunate comments on women's reproductive rights.

Clearly, the Romney response will not help Republican chances to capture a senate seat in the "show me" state, but it was the right thing to do. The same should be said of Republican senate minority leader **Mitch McConnell** who suggested Akin drop out of the race. They put country first.

The same cannot be said of the Democratic nominee, **Claire McCaskill**, who allegedly unleashed negative ads against Akin in the primary simply because she knew this would help him win his party's nomination and, she felt, would help her win in the final. A good campaign tactic could backfire and give the state's senate seat to a real Neanderthal.

A new state law may create very serious issues for our school board's real-estate investment plans, not to mention sale of non-education land such as the oil well's parcel.

Apparently, a bill the governor just signed mandates giving charter schools first options on public-school owned land before it is sold. The other kicker: the charter schools cannot be charged more than the original sale price. For the Beverly Vista parking lot, a charter school could conceivably obtain the land for \$500,000, a fraction of its current value.

Is the school board seriously considering going to the voters with a parcel tax? Considering all the questions on how Measure E bond money has been spent, a two-thirds approval of a tax seems very unlikely.

One of the primary advantages of a parcel tax is the few restrictions it places on spending. Bond money, as one example, cannot be used to pay teachers or administrators, but parcel tax revenues can.

Before the board even considers a ballot offering, it must do a far better job of explaining how Measure E bonds have been used. Was it really appropriate or even legal to use those revenues to pay lawyers and consultants for costs not directly related to construction? Supposedly, board lawyers said it was, but serious doubts remain.

But it is not just non-construction costs, it is the whole question of delays and lack of accountability for building plans the board must make very public. Just how

many consultants did we need to know that high school bathrooms are in terrible condition, and have yet to be fixed?

Also, the rush to demolish without concern for historical values has not been in the public interest—at least it seems Hawthorne will be preserved while renovated.

A parcel tax is, inevitably, a vote of confidence in the board—and that body does have some able members. What is lacking is a more sophisticated public relations program that keeps the community better informed and yes, a full review of Measure E expenditures, before even considering an election vote on a parcel tax. If that fails, and it well might, the public perception of our historic support of public education will be diminished. The ultimate victims are future generations of students.

This afternoon the council will give consideration to rules on campaign spending and contribution limits. The time has come to remove all limits and conditions, except the stringent state laws requiring reporting and disclosure.

Why? Because the recent, and in my view very unfortunate, U.S. Supreme Court ruling removing restrictions on controls of so-called independent committees, has made our own rules redundant.

If independent committees can indeed spend what and how they want, and if that is applicable to state and local elections, there will be no public accountability. A candidate can simply wait for some so-called independent group to finance mailings and ads and we will never know who funded the costs or designed the material.

Without limits, we are far more likely to have honest filings and full disclosure by real campaign committees and not anonymous private interests.

When a past council first adopted mandatory limits on spending, it was assumed, probably correctly, that this was an advantage to incumbents, even though officeholders probably had more opportunities to raise campaign funds.

True, few candidates, even in our politically sophisticated community, can win without significant financial resources, but spending alone has never guaranteed success. The losing candidate in the last school board election far outdistanced spending by a winner.

We have several recent losses by incumbents who outspent the winners, and in

our most expensive election ever some 25 years ago, an incumbent mayor ran fourth for one of two seats even though she raised and spent well over \$100,000 in the campaign.

Also, by limiting the amounts one person or family can donate, we are putting too much pressure on candidates to raise funds and devoting more time to campaign donation efforts than in actually campaigning.

There needs to be more realistic campaign reforms and some rational means of public funding of elections—eliminating totally private donations. But until that happens, we should be far more concerned about the lack of voter interest than limits on spending and contributions. The supreme court ruling has changed the rules of the game, and not in the public interest.

Speaking of information availability, the city might just consider improving data available on its web site. For some strange reason, if you check past election results, the only names you will find are those of winners. Results should translate into full data and votes received by all candidates. Political historians and campaign junkies have a right to know.

There is one more vacancy on the planning commission and next March there could be another when **Brian Rosenstein**, currently vice chair of the commission, probably wins election to the city council.

Although this should not be the only criteria, the council would be well-advised to fill these vacancies from among members of other commissions.

Possible candidates for appointment will have had a body of work that can be evaluated, and not just on how they voted, but their willingness to study and be informed on key city issues.

Many of our best planning commissioners first served on architectural, design review, traffic and parking or public works.

Obviously, there could and should be exceptions. Professional training and land-use skills, deep roots in the community that help balance decision making, and an ability to actually spend the time demand this commission makes, are also important tests.

Speaking of planning changes, had lunch this week with a retired former *Los Angeles Times* editor and reporter, **John Mitchell**, who has been living out of the country for a number of years.

John, who began his career with *The Times* as editor of the now defunct Westside section, said he was amazed by the changes he found in our village and by the bustle of activity in the business district, despite supposed economic problems.

When Mitchell first began reporting

on Beverly Hills, then-Mayor **Donna Ellman Garber** gave him a very comprehensive tour of our city. It seemed that each city corner had some history of a past battle, he learned.

We had lunch poolside at the Hilton, still one of my favorites. The best recommendation I can give for their Circa 55 is that the hotel owner, the genial **Beny Alagem**, also dines there.

We had a new treat for dessert, and the hotel does have a first-rate pastry chef, but try the peach cobbler with vanilla ice cream—John agreed it was the best he ever experienced.

Other restaurant news: Spago reports it hopes to reopen mid-September. You can get updates by calling them and they will inform you on exact dates and take some advance reservations.

Where have Spago regulars dined since the remodeling began? Our legendary trend-setter **Fred Hayman** is a regular at Bouchon, just across the street from his office, or The Grill.

And talk of eating and working togetherness, the **Les Golds** not only work together every day at Mitchell, Silberberg and Knupp, but have breakfast at some local eatery. They tell me they rotate between Il Fornaio and Nate'n Al.

Josette and I had dinner with them last week at Caffe Roma, and marveled at the enjoyment they obviously find in each other's work and social time spent.

Probably, my wife welcomes her daily escapes to her school duties.

Les does spend considerable time in China, where he has a large number of business clients, hopefully seeking investments in Beverly Hills.

Soon, we hope to list your favorite dining choices—so send me an email on your preferences and we will publish soon. But let me know if we can use your name. (rudy@bhweekly.com.)

Very briefly, my other picks for different reasons, are the large garden tea room at the Montage, a charming venue for afternoon cocktails, the sophisticated Belvedere at the Peninsula and any Drago-owned restaurants in Beverly Hills.

RUDY COLE RESPONDS:

Hopefully, our city treasurer reads balance sheets more carefully than he does city ordinances or newspaper columns.

We have clear separation of powers, and blurring those lines is never, ever in the public interest, no matter the justification. It might be interesting to allow the city manager to vote with the council, or for the council to directly give administrative orders to all city staff, but that would be destructive of the democratic process, the city manager form of government, and lines of responsibility.

Treasurer Finkel may be well intentioned, but it is the responsibility of our highly competent professional staff to prepare the budget and our elected city council to adopt, amend and approve. There is not one word in our ordinances that transfers that power to the elected city treasurer.

As to how his committees were created, we hope he is mistaken. Finkel writes that he spoke to each member of the council "to obtain his or her consent and to solicit candidates for the committee." The council cannot approve committees or even suggest membership except at noticed public meetings. To do otherwise is a clear violation of the open government, Brown Act. No citizen, member of staff or even elected official can obtain approval from the council except in a totally transparent manner.

There is a simple solution: If the council feels the need to seek citizen advice on financial matters, it can create whatever committees it wants. Most of our commissions are advisory. However, the accountability will rest with the council, as it should, and not the treasurer. The rule of

law may not always be efficient, but is how democracy works.

Finally, it is a bit of a stretch to even suggest I was being critical of the members of his committees. They did fine work and they are not responsible for how or why their committees were established. Nor did I even imply that Finkel benefited in some manner from the enlargement of his duties. Yes, he did protest too much. The rules are very clear.

"BHUSD Elm Drive property"

I am very concerned by Dr. [Brian] Goldberg's proposal (Brian Goldberg's Newsletter Aug. 14, 2012) for BHUSD to use the Elm Dr. property adjacent to Beverly Vista to generate funding or worse—to sell the property. Clearly, more is better, but not at the expense of our children. To give up this land forever would be unthinkable. Find another solution to raising more funding for the district.

Here are some reasons to maximize the Elm Dr. property for the direct benefit of students and staff:

- Beverly Vista does NOT have a gym or an adequate multipurpose room. Let's build one on the Elm Dr. lot.
- Given Dr. Woods' current idea to have team sports amongst the four K-8 school begs for a site like the Elm lot for this very purpose! This is a central location for each of the middle schools to meet for various sports activities—basketball, volleyball, indoor field hockey, among other type of events.
- Build underground parking on this site which would be isolated from the school site (think security) and would provide parking for staff and a place to park for district staff in-service events among other uses.
- A shelter—just in case...
- In addition to a gymnasium, the new building could include a pre-school, classrooms, and administrative offices.
- Off-site data center for the City.

Excerpts from Brian Goldberg's newsletter (Aug. 14, 2012) Elm Drive Property—with included comments:

"...hope we can all agree that it is an underutilized property..." Yes, we can.

"...needs to be discussed in the context of a master facilities plan..." Yes, it does!

"...reality is that this is a unique situation for the District." Yes, it is! Let's not squander it.

"...utilizing funds the City of Beverly Hills has... affordable housing..." Tell that to the neighbors! This is BHUSD property and should be used exclusively for our students and staff (and aligned with the JPA).

"Or we could declare the property surplus property and sell it..." You've got to be kidding!

And the cost? Eliminate the underground parking and gymnasium from the Hawthorne modernization plan. There's a few extra millions of dollars put to good

use.



IN THE WORKS

The Weekly's exclusive interview with incoming Public Works Commission Chair Dr. Barry Pressman

You're one of the commission's two newest members. After 16 months, do you feel ready to be chair?

Yes. At first [there was] a pretty steep learning curve, but that's leveled off. I feel that I have now gotten my feet more than wet and become involved. I've been able to make some suggestions for changes in the commission that the commission has been very responsive to. Something I feel I can now take responsibility for, [outgoing Chair] Peter Foldvary has done a wonderful job in helping move along a major change in the involvement of the commission in the development of CIP (capital improvement projects). In the past, we've basically heard about them late in the process and had little or no input. Now we are going to be reviewing projects that are appropriate well in advance of deadlines, so that we can involve ourselves in the process of determining the appropriateness [and] necessity, making recommendations about the budget and helping staff develop some of these projects.

One of the areas that Dr. Foldvary was really interested in was being sure that on rate setting, for instance for the water rates and solid waste, that we involve ourselves well in advance of deadlines so that if we don't agree with what staff is doing, we can advise them, and they can go back to the drawing board. Staff does a wonderful job in doing that, but they can't do it if they don't have time. I was the one who really got excited about the idea of doing the same thing with CIPs and Peter was very supportive, as was the rest of the commission including Vice Chair [Joe] Shooshani, who was on the subcommittee with me to move this along. Staff was very responsive, so we have now developed a process, which we now have to implement. I'm very excited about being able to bring to fruition something that was a pet project of mine.

I would say that the first 16 months, first under [then-Chair Steven] Weinglass and under Chair Foldvary, have been chock-full of all sorts of issues, including the water rates, the sewer rates, the discussion of new manhole covers, all of these new CIP issues. We've had a lot of discussion about replacement of all the trash bins. We've put

that in the parking lot to think about it rather than to let it move through quickly. It's been a very educational year. Would I have liked to be vice chair? I would have loved to have that opportunity but I don't think that would be necessary for me to do this. I don't think the commissioners would have voted for me had they not felt I was ready. I feel pretty comfortable personally and their support was also reassuring. Then of course it was important to maintain the appropriate cycle of seniority. It was peculiar in the way two [commissioners, Ron Shalowitz and myself] came on. Three had been on a long time; they had all been chairs already. In fact, using the seniority system that the council uses, one would have expected me to have been chairman 12 months ago but that would have been totally inappropriate.

As you mentioned, you and Shooshani were on the subcommittee focused on fiscal responsibility. Tell us how you plan to implement the subcommittee's recommendations.

We discussed that at the last meeting

and we have already assigned individuals to specific projects that we decided are appropriate for us to start reviewing, like the trash bin replacement. One or two [commissioners] will be meeting with city staff. We're hoping to have a timetable laid out on each of these and then each of these subcommittees will report back to the entire commission. This process is supposed to get going hopefully this month.

So trash bin replacement is the next priority?

It's very interesting to us because we hadn't been involved in the discussion. It's not an insignificant amount of money. It's over a million dollars, so that's real money. We think that we should first decide on necessity and second the scope and then the budget, rather than the other way around. There have been a lot of discussions on the commission about educating our public about the recycling issue. A lot of people still think they have to separate, and so we have designed a decal to go on all the trash bins as well as on our trash trucks saying basically, "We recycle. You don't have to [separate]." We're hoping to get together a public education campaign. What we don't want to do is put all these decals on trash bins and then have them trashed, so we need to delay our process until we clarify, so that's one of the reasons trash bins [are] a little higher on the list.

The water rates are very important to us every year and they're a very contentious issue citywide. It was somewhat contentious on the commission as well. The majority supported the decision that the council took.

Tell us why you supported the recommendation to increase the water rates.

I felt it was exceptionally important to keep up with our infrastructure requirements. The MWD [Metropolitan Water District] is literally millions of dollars behind in

their infrastructure replacement. We can't afford that in Beverly Hills. We don't want any sinkholes; we don't want any service interruptions. Our citizens and businesspeople expect to be able to come to work, turn on the sink, have a little water, be able to flush their toilets and we need to provide that. We can't do that if we start trying to save a percent here and a percent there on rates when our rates are going up, the cost of water is going up to us, the cost of infrastructure development never stops going up. We have got to stay up with it. I felt this was a totally reasonable increase in order to be able to continue to provide. We're going to watch it carefully. If we wind up with excesses, we're going to [recommend that the city council] stop it.

The solid waste rates [recently] came up [for discussion]. [Approximately three months ago] the recommendation of the outside consultant was to raise the rate. We discussed the fact that we had in the past been making loans to the fund and we no longer had to make that loan, but it was still carrying our budget and without that in the budget, we didn't need to raise the rates. The commission questioned, clarified and rejected the recommendation of the consultant and [recommended the city council not approve an increase to] solid waste rates. We're serious about our recommendations.

One of the things Dr. Foldvary did as chair and I'm going to continue and hopefully expand is interaction with our liaisons from the council [John Mirisch and Julian Gold] so we get from them things they might be anxious for us to do and we keep them actively apprised of what we're doing.

How do you feel about Vice Mayor John Mirisch's suggestion that the money to cover MWD's water rate increase should come from another budget source?

I have no problem with Vice Mayor Mirisch's thought. If you can find the money somewhere else and that means that money wasn't needed somewhere else, [then that's] great. On the commission level, that's not our province; our province is to say, we need the money to maintain the infrastructure and to provide the water. Then the politics come in. We're not political. We are strictly advisory on the necessity. I don't think he was necessarily voting against what we said; he said [to] get the money somewhere else.

Your wife Sandy Pressman is a Fine Art commissioner. Who got involved in City government first?

She did. She did Team Beverly Hills first. She became a commissioner and I got excited by all the things we would talk about at dinner so then I did Team Beverly Hills. I found that when the Public Works Commission came and made their presentation and we heard all about the things they did and I got to see our water plants, I really got interested and excited about the potential. A position came up; I applied and fortunately was chosen. I'm very excited about and enjoying tremendously the opportunity to be involved in my community, and to offer what I can to

improve it and to see how it works. It's fun to go to the council meetings on occasion, to know many of the council people, to know the staff, to know what's going on, to know their problems, to understand their budgetary constraints. All of these things have really enriched my life. I've gotten to know some wonderful people and learned a lot about the political process as well as things I never really gave much thought to: water, sewage, solid waste, recycling. All those things sort of touched me but didn't touch me very strongly. They're interesting, they're important and somebody has got to be watching over them.

Tell us about your family.

[Sandy and I have] been married 20 years now. We each had previous marriages. I have two daughters [Lauren Greenfield and Kimberly Pressman]. My wife has a daughter [Nathalie Kunin, who is on the BHEF board and runs the Team Tutors program] and a son [Ron Frankel]. Among us we have seven grandsons [Asher, Asa, and Ari Greenfield, Ethan and Louie Kunin, and Eli and Leo Frankel], ranging from 17 [years] to seven months. We're each very involved with our grandchildren. My wife is fortunate that all her grandchildren live in town. Mine all live in San Francisco. I also have a daughter who lives in New York City, so I do a lot of traveling. My wife gets to see her grandchildren several times a week. Two of them live in Beverly Hills and two live in Hancock Park. The oldest boy [Ethan Kunin] goes to Beverly High, where he is a star tennis player.

[Sandy] started the Grandparents [Council] of BHEF. She has a lot of other involvement in charities. She's on the foundation board of National Public Radio and is past president of L.A. Planned Parenthood. She's very active in Beverly Hills Rotary and she's just come off six years on the board [at Hillcrest Country Club] where she was the last two years vice president and chair of the admissions committee.

Now, more about you. You're chair of Cedars-Sinai's S. Mark Taper Foundation Imaging Center and Department, a past president and current member of the California Radiological Society and American College of Radiology, a current member and past officer of the American Society of Neuroradiology and current member of the American Society of Pediatric Neuroradiology. Tell us how you got into medicine.

I was pre-law at Dartmouth College [but] I had a conversation one day with a student who had just been accepted to medical school. I was talking to him and asking him why, and he said "Just think about how many people you can help and feel good about." It kind of got me, and so that's what got me to re-think it. I rushed through pre-med in a year and went to medical school after three years of college. So I was a government major in college, did pre-med on the side, which was fun because I came out at least somewhat liberally educated.

You ended up at Harvard Medical School. Tell us about that.

It's such a great place. The students who surround you are brilliant, so you're constantly fighting to prove that you belong there. The faculty is so remarkably focused, accomplished, that they are daunting. You never want to be caught unprepared in a situation like that, and therefore the teaching was great. The hospitals were Peter Bent Brigham, now known as Brigham and Women's Hospital, Mass General, Boston City Hospital and the Beth Israel Hospital, [which] are all among the finest hospitals in the world and that was our playground. That was an experience of a lifetime. It was hard to leave Boston, but it's awfully cold there. I stayed and did my internship [before moving on to do my residency at Columbia-Presbyterian Medical Center]. I was fortunate to get in there, and then I did a fellowship in neuroradiology with a gentleman I really wanted to work with at

George Washington [University Hospital]. Then I wound up coming to practice here in Los Angeles, where I've been practicing ever since.

At Cedars-Sinai?

I came to Cedars-Sinai in '81. My first six years were at Brotman Hospital in Culver City. I came in '75. I saw Cedars was becoming the dominant institution and was lucky enough to be able to land a job here. In 1992, I became chairman of the department and have been doing that ever since. I still practice neuroradiology every day. That's a very important aspect of what I do, because to manage a department, you've got to know what's going on and you've got to know it from the workers' side.

I'm [also] on the board of 1st Century Bank. We're over in Century City looking to open an office in Beverly Hills. I'm on the board of the LA Philharmonic and Sandy and I [co-chair] an organization called the Board of Overseers, which is a primary support group of over 100 supporters. I'm also very active on the Hollywood Bowl Committee. Hollywood Bowl is my absolute favorite venue or event in town. We attend 15-17 concerts a summer, as well as being avid Disney Hall visitors.

Where are you from originally?

I grew up in Brooklyn. I saw the Rose Parade on television at around age 4 while the heat was out in our apartment and we were freezing to death. I saw these young people in marching bands in short pants. I asked my father about that. He told me that was California and that was why, and that's why I'm here. It became a lifelong passion [to move out to California]. Hard work and school was what I found was my way out and I wanted out of Brooklyn.

How does your medical background relate to your service on the commission?

My medical background gives me a scientific approach to looking at issues, so

I think I can take the general and make it more specific and get deeper into the weeds, [but] not too deep because then it gets beyond me. In addition, my involvement as a chairman but more importantly, my involvement in all those societies and running all those meetings. I think that was one of the things that caught the eye of my fellow commissioners, that I really do know process.

One more thing, I work in a very big hospital. We're about 10,000 employees here. It runs very well, but it runs as a bureaucracy. [After] 20 years as a chairman and manager, I know how to work inside of a bureaucracy. The City is another bureaucracy and understanding that if you come without any experience, you fight it rather than trying to work with it. If you understand it, you understand the seams in it and how to work into them. I have found that experience to be very helpful in understanding our responsibility to council, our responsibility to staff, and the involvement with the city attorney's office. That's a learning curve I didn't have to experience in my first 16 months. I'm totally comfortable with that, so I think that my medical experience and my medical political experience have been particularly helpful.

Two M.D.s currently serve on the City Council. Could you become the third?

It's crossed my mind. I'm not sure I'm up to the fundraising aspect of it. I love the political side. I love the policy side. There is the process which I have come to learn because I was involved in helping Willie Brien to some extent [and] Julian Gold, so I learned the process and it's daunting. It's a major commitment. It's crossed my mind—you never know—but that would be what would hold me back. It's not easy. I give them credit. It takes a lot of effort. But the accomplishment and then the work that comes afterwards would be great fun.


