Scranton, Andrews address Courier article regarding retirement medical plan

The City Council will soon be discussing in open session whether or not to modify the executive compensation plan, so that the City would provide a lifetime retiree medical health plan for the deputy fire chief and fire chief.

"Without any length of time commitment from the people who are promoting into the management position, each time they promote in, if they're only in the job for a year, the City is then on the hook for lifetime medical costs -- let's wait for what the actuarial says but -- probably for \$10,000 a month per life and multiply that by the number of times that there's turnover," said Mayor John Mirisch. "It's not an insignificant expense."

An actuarial is an analysis of the benefit's fiscal impact to the city which is done by an independent accountant, as required by state law.

Chinese artist presents CVB with tapestry

Well-known Chinese hand embroidery artist Zhu Souzhen presented the Beverly Hills Conference and Visitor Bureau with one of her hand-embroidered pieces, titled "Picasso 1932 Famme Avec Une Fleur" on May 2.

The tapestry features four layers of various shades of silk embroidery and took approximately 10 months to create. Souzhen, a national senior arts and crafts master and member of the Chinese Association of Arts and Crafts, has had many of her embroidery works win domestic and overseas prizes.

Up until 2010, executive positions, which include the fire chief and deputy fire chief, as covered by the executive compensation plan, would receive a two party lifetime medical provision after retirement paid for by the City.

The City Council changed the compensation plan to a defined contribution plan in which that employees would receive \$1,375 per month for every month that a senior manager held the position. For example, if new CFO Don Rhoads works for five years, he would receive 60 times \$1,375 once he retired to buy his own medical insurance. This is the case for employees that are new to the City of Beverly Hills.

Ralph Mundell, who has been offered the position of deputy fire chief, has been with the City of Beverly Hills for 27 years and would be promoted to the senior management position internally. Because he is not a new employee to the City, he is not eligible for the new compensation plan.

Employees who are being promoted internally are subject to the same benefit they would have received in their previous position.

The City does not provide a retiree medical plan for firefighters. The Beverly Hills Firefighter's Association provides union members past the age of 65 with funds to cover a medical plan.

BHFA union members receive a medical two party rate paid for by the City until the age of 65. When a BHFA member turns 65, the City stops paying and members pay for their own medical plan but then are reimbursed by the union's trust fund.

The BHFA holds an annual Backdraft Ball, the proceeds of which go into a trust fund created to cover retiree's medical costs.

BHFA President Dennis Andrews said the Courier's May 3 article, "Beverly Hills Could Foot Huge Retirement Bill" was misconstrued and biased. Andrews said that firefighters do not receive full lifetime medical coverage.

"It's important for people to know that we are not able to pick up 100 percent of the retiree medical costs. All we do is provide a small portion of what medical retirement may cost a retiree," said BHFA President Dennis Andrews. "We basically do this through donations through our retiree medical fund. Those donations go into that fund and after our retirees get to 65, we actually have an actuarial that tells us how much we can take and give those folks."

Andrews said the union's board of directors meets every three years and decides what the retirees will receive each month.

All firefighters who are BHFA members past the age of 65 receive the same monthly amount. Andrews would not comment on the amount currently received by retired firefighters from the association.

Mundell has been offered the deputy fire chief position, but because the City does not provide firefighters with a retiree medical plan, he would not be eligible for a retiree medical plan upon his promotion. Because the promotion would cause Mundell to lose his BHFA membership, he would not be covered by the BHFA either, according to Scranton.

Scranton said this would eliminate the reason for firefighters within the department to promote internally.

"If you don't provide this benefit and you stick with the current language of the executive compensation plan, then [Mundell] will decline the position because he has no financial incentive to take it," said Scranton. "When I retire, you're going to have to go outside, which will be cheaper because you'll pay \$1,375 for every month [the new employee is] there, but your two top administrators in one of your most critical departments are going to be revolving doors of people who come in, spike their retirement and leave."

"You may or may not get qualified people but you're certainly not going to get people who are passionate, who believe in the com-

Columnist Rudy Cole honored by City Council

The Beverly Hills City Council presented Josette Videau Cole, wife of the late-Weekly columnist Rudy Cole with a proclamation on Tuesday night honoring Rudy Cole for his contributions to the City.

"I think I speak for many when I say, Thursday is not the same when you open the paper and you don't see Rudy's column," said Councilmember Julian Gold. "You never exactly knew where he was coming from and you never knew what he was going to say but you always knew that he had a deep sense of the City's history and a deep commitment to the residents of this community and to the City and it's a profound loss for us."

Cole passed away on Feb. 10, 2013. Cole was active in the Recreation and Parks Commission, Greystone Foundation, wrote a weekly column for Beverly Hills Weekly, and hosted the City cable public affairs show, Inside Beverly Hills.

Marty Geimer, who created Friends of Greystone with Cole, spoke before the council and said he had been raising money to plant a tree at Greystone in Rudy's memory. The tree roughly costs \$700 and would be installed with a plaque. Geimer asked the council for their support to help memorialize the tree and Rudy Cole.

Mayor John Mirisch said it would be something the council would consider and he said it was a good idea.

munity," said Scranton.

Mirisch said these are only two positions and pointed to Police Chief David Snowden, who he called "as good a police chief as we've ever had," who came from outside the City.

"If they're saying it doesn't make sense for them because even though they're going to be getting a higher salary, then you know that's a choice that they make, but it does show there are systemic problems. There should never be a situation where you're going to be promoted and it doesn't make financial sense to get promoted," said Mirisch, who said the entire system needed to be addressed.

City Manager Jeff Kolin approached the BHFA to see if they would help cover the costs for the deputy chief's retiree medical plan. Mirisch said the BHFA should step up and help the City with the costs and not "stick it to the tax payers."

"I completely understand that you want to

promote people from within but here's the thing, if Ralph Mundell retired today, he'd be covered by the fireman's association. Because he gets promoted, they're going to drop him like a hot potato?" said Mayor John Mirisch.

"I spoke out against that," said Scranton. "We're the final decision makers for the department and if you do something that the union doesn't like, you're beholden to them because they hold the key to your medical when you retire."

Andrews said the union was not consulted when changes to the executive compensation plan were discussed by the City.

"They're referencing us as the solution to something that we didn't really have any decision making power in so we would have liked to at least been talked to about those things and those changes to discuss some of the issues, the changes that we felt would

have impacted people moving up into those spots and how that might be avoided," said Andrews.

In the Courier article, Mayor John Mirisch said he believed a major issue was the loss of overtime pay executive positions are not eligible for.

Scranton said the issue had "nothing to do with overtime," but with the retiree medical benefits. Scranton said 100 percent of the overtime fees came from outside vendors and were not paid for by the City.

Scranton said that those with equivalent positions in the Police Department, if promoted internally, would receive lifetime medical coverage.

Mirisch said the departments struck different deals and they are not the same.

"[The Fire Department] is providing a service that's extremely valuable to the City and very much appreciated, but it has to be paid for at a level that's reasonable and that makes sense. The attitude just indicates that we almost have been a bottomless pit when it came to that before and that's just something that's just not sustainable," said Mirisch.

The item was going to be discussed in open session at the May 7 meeting, but a state employee reform law requires that if an executive benefit package will be enhanced, an actuarial must be completed and posted for two weeks for public comment or awareness before the council takes action.

BHUSD Relay for Life raises \$80,000

The Beverly Hills Unified School District held its third annual Relay for Life on May 4, raising \$80,000 for the American Cancer Society.

"We brought about awareness and we brought about support to everyone in this community who has been touched by cancer and my goal of this is that Beverly Hills is not just a community, Beverly Hills is a family and we don't let anyone suffer alone," said Dr. Michele Kalt, a cardiologist who brought Relay to Life to the district when her daughter Beverly Vista student Sienna Wolfe was diagnosed with cancer at age 6.

Kalt, the event chair, said that thousands were in attendance over the weekend at the El Rodeo track. Relay for Life is a national 24-hour fundraising event hosted by the American Cancer Society. Typically, the event is hosted around a track and members of teams walk the track for 24 hours.

The district put on the event with a kid and family spin. Kalt said all five schools participated as well as many Beverly Hills restaurants. She credited Pickles on Beverly Drive, Jersey Mike's, and Factor's Famous Deli as being especially helpful. The night was filled with

magicians, balloons, pilates, Zumba, cancer education booths and movie screenings.

Every team from each school had its own booth. Kalt called the event a "fun party with a higher purpose."

Kalt said that when her daughter was diagnosed, she did not want to leave Beverly Vista because she did not want her friends to know she had been diagnosed with fibro myxoid sarcoma.

"Somehow I needed to let all of Beverly Vista know that my daughter had cancer and I had to make it fun and I had to make it positive, so I heard about Relay and I turned Relay into a 24 hour kid party," said Kalt.

Kalt said the American Cancer Society has funded 47 scientists who have won the Nobel Prize in cancer research. The society also helps fund treatments for cancer patients.

City Council denies reduced in-lieu parking fees for proposed jazz club; agree to work with applicants

Four members of the Beverly Hills City

Council did not support a zone text amendment reducing in-lieu parking fees for Spaghetini, a jazz club proposed for 184 North Canon Drive. The council decided to form an ad hoc committee to work with the applicants. The committee has not yet been formed.

"You're a little too early. I think these policy decisions around in-lieu are really something I'd like to have a clear understanding of before we kind of give one and then try to figure out how we fit everybody else into this program," said Councilmember Julian Gold.

BHEF needs an extreme makeover

Anemic fundraising, chaotic events plague what was once a top organization

Life's Little Instruction Book reminds us "never tell a man he's balding; he already knows." Likewise, you should never tell a charitable organization they are failing; they already know.

What has happened to our beloved Beverly Hills Education Foundation? What was once one of the top charitable organizations in the city

is but a shadow of its former self. Anemic fundraising, and a chaotic apple ball--probably the most unruly event we have attended in 20 years--have shown us how far this organization has fallen.

We previously covered BHEF's poor performance relative to other educa-

tion foundations in 2011 in issue #592. Manhattan Beach and Palos Verdes, as an example, outperform BHEF year after year, despite having lower median incomes. The attached chart helps tell the story.

Recently BHEF launched their annual fundraiser, which under normal circumstances should have been a success. After all, this is Beverly Hills -- where top public schools have long been the impetus for families to move here. Imagine our surprise when only 13 percent of district families made a contribution, according to a presentation at the April 23 board meeting. Thirteen percent participation? Is

"I don't like this deal. I like the concept. I don't think we can negotiate this from dais. I would hold that perhaps we can revisit this from a business perspective."

Spghettini, a jazz club and restaurant based in Seal Beach for the last 25 years, has a tentative lease agreement at 184 North Canon. The proposed restaurant would be open for lunch and dinner as well as jazz nighttime entertainment.

The restaurant went before the planning commission on March 28 where it requested an extended hour's permit to remain open until 1 a.m. as well as reduced fees for participation in an in-lieu parking program.

The zone text amendment would have allowed Spghettini to pay a reduced fee of \$45,135 paid annually in perpetuity for 59 in-lieu parking spaces. Under current code, the restaurant would be required to pay \$139,063 annually over a period of 10 years. Under the proposed agreement, the restaurant would not own the parking spaces and the spaces would not travel with the property. The City would retain ownership of the in-lieu parking spaces. Additionally, the applicant requested to lease 70 parking spaces in the City's 221 North Crescent Drive parking structure for an annual rate of \$64,260 for 10 years.

Spghettini offered a series of public benefits as justification for reduced parking rates and in-lieu parking fees. The proposed public benefits included a charitable even in conjunction with the Beverly Hills Centennial Celebration, annual jazz genre musical entertainment for "Concerts in the Gardens" series, and annual charitable concerts at Greystone Mansion.

Councilmember Willie Brien, who sat on the liaison, supported the agreement and said the agreement provided financial benefits and

noted that the leased parking spaces would be most used by Spghettini customers from 7 p.m. to 9 p.m. when the parking structure had ample parking.

The program would have sunset on November 1, 2013.


"I was very excited about the possibility of expanding our night life in our city," said Vice Mayor Lili Bosse, who sat on the liaison for this project. "To me, there's an issue about balance and looking at the bigger picture."

Bosse said the project could not be looked at in a "vacuum" and policy issues the project brought forward needed to be discussed

"To me that is, what is the priority of the night life in the business triangle and does that mean only music?" said Bosse, who also said maintenance of the parking facilities, funded by in-lieu parking fees, was a clear priority of the community.

Councilmember Nancy Krasne said she felt the jazz club should look into a location where there was already ample parking and the need for reduced fees would not be necessary.

up to certain members of the community, Zarcufsky hoped to get large donations, but thus far this has failed to happen. The numbers don't lie, and the numbers speak for themselves.

Beverly Hills public schools are too important to have these keystone cops in charge of fundraising. BHEF needs an extreme makeover, and it needs it now.

very good run. 35 years is a long time," said Strimple.

Strimple, who is also a faculty member in the Thornton School of Music at the University of Southern California, works seven days a week. He said will retire to spend his weekends with his wife, Beverly High Assistant Principal Toni Staser.

Strimple will also retire from his role as music director of the Choral Society of Southern California.

"I think primarily the music we've done at the church is just whatever seemed appropriate for a given Sunday," said Strimple. "I've always worked very closely with the pastors of the church just to make everything match up."

Strimple said there has been variety in the music played every Sunday including music he's written for the church.

Prior to working at USC, he worked in the music industry as an arranger/composer.

Strimple worked at USC from 1976 to 1978 and went back to teaching at USC in 1996. He is the head of the sacred music program at USC.

"This is also a reason why I'm retiring from the church... [USC has] one of the best programs in the country and we get very good students and they keep us busy and we keep them busy and I really enjoy the teaching," said Strimple. "We just put in a new curriculum for our master's and doctoral programs so that students can focus in either Jewish music or Christian music. I wanted to be able to devote my time to that."

Pastor James Morrison was the pastor when Strimple was hired until Morrison retired in 2003 after suffering a heart attack. Strimple also worked with Pastor Vahe Simonian, the church's interim pastor for three years, and

associate pastor Andrew Eagles and Pastor David Worth, who currently work at Beverly Hills Presbyterian Church.

Strimple brought the christmas concert to Beverly Hills, which began in December of 1978. Strimple asked Hollywood actor Jimmy Stewart to read *A Christmas Story* at the concert.

"That became a big tradition, it went on for over 30 years," said Strimple, who named other actors who participated such as Danny Aykroyd, Mel Gibson, and Sally Struthers.

Strimple said around 1985, he became very involved in music that was related to the Holocaust.

"That over the years opened up an interest in Jewish music in general so we've done a lot of interfaith projects at the church, cooperating with the Jewish Music Commission of Los Angeles and the Roman Catholic Archdiocese," said Strimple, who said the most recent interfaith program was held in March.

The 11 a.m. morning worship on June 23 will feature music Strimple has composed for the church over the years and will be followed by a noon luncheon and a 4 p.m. concert.

The concert will include a new work by Strimple and a piece by Mozart. The performers are Lauren Buckley, Emily May, Calista Hoffman Campbell, Marc Lowenstein, Timothy Campbell and Cale Olson, BHPC Chancel Choir, the Choral Society of Southern California, and the BHPC Chamber Orchestra.

City Council unanimously decides to take on ESL adult program

Due to budget constraints facing the Beverly Hills Unified School District, the City Council unanimously voted in favor of establishing a new English-as-a-Second-Language program for adults as part of the Beverly Hills recreation division.

"Since language is the bond that unites us and you can't communicate with people if you can't talk to them, so you need this skill and right now we're about to spend \$2.5 million for the second phase of the library," said Councilmember Nancy Krasne. "So that means we're going to build a monument and have a nice structure, but if the people can't read the books inside and communicate with one another, what good does that do?"

Krasne said the city needed educated voters and needed this program.

Staff recommended offering three levels of ESL curriculum including introductory courses. Staff also recommended initiating conversation courses with a possible overlap into the Library's literacy program and initiating a citizenship preparation course.

Staff will return with a fee structure and will look into applying for a federal Workforce Investment Act, which the school district received in the past, to fund the ESL program.

Assistant Director of Community Services

Nancy Hunt-Coffey said most recreation classes are self funded and staff still must work out the fiscal impact.

Councilmember Julian Gold suggested staff look into the maximum costs of the program and that he hoped the program would affect the most amount of people in the most efficient way.

"I think what has to happen next is we collectively have to design what this program looks like," said Gold.

Vice Mayor Lili Bosse said her parents were immigrants and she recalled moments when her own parents were embarrassed to speak English or write letters. Bosse called it one of her "proudest votes."



CHANGING LIVES

Beverly Hills surgeon Gary H. Hoffman discusses his week-long medical mission trip to Guatemala

How did you get involved in humanitarian work abroad?

This started out as something that I wanted to do for me. I wanted to do something with one of my sons, Jordan, who is a second year surgical resident in Atlanta. I wanted to watch him operate. I wanted to teach him things that my father taught me. My father Norman is also a surgeon. It took a very left turn and ended up somewhere so different. It ended up to be nothing about me and nothing about bonding with my son and everything about using what I've done in 30 years of practicing surgery to help other people in a totally different way than we're used to doing in the United States.

And you participated through HELPS International?

There is a Los Angeles team that works under the auspices of a nonprofit organization called HELPS international. HELPS International started many, many years ago by a philanthropist who saw the need for medical care in Guatemala. There are 10 teams from all over the country and I went down as a member of the Los Angeles team and I in no way was responsible for the logistics and the planning. I was just a passive participant and it's not really about me, it's about Guatemala and helping people who have no access to medical care who in a blink are returned to something closer to normal.

What type of work did you do in Guatemala?

There were [five] different groups of specialists. There were general surgeons, gynecologists, facial plastic surgeons, ENT head and neck surgeons, and dentists. Traditionally, it's easy to see a picture of a child with a cleft lip, before and after. But you don't see pictures of people with bad gallbladders who are suffering miserably every time they eat. You don't see pictures of people with fibroid tumors that you take out and they're cured. You don't see kids with swollen tonsils that are gone. One woman we did a double mastectomy and reconstruction and changed her life. It was amazing.

What type of surgeon are you?

I am a general surgeon and a colon and rectal surgeon. There was no colon rectal surgery needed down there, [so] it was all general surgery.

You mentioned that it was a totally different way then how you would practice medicine in the United States.

How is it different?

There was absolutely nothing between me and the patient. I stood in front of a patient and examined him or her. There were no lab tests. There were no x-rays. There were no second, third and fourth opinions. There was no paperwork. There was no insurance company. There was no money. There was just me and 10 minutes later, a patient on the operating table and two hours later, a cured patient. It was the most amazing thing and it's something that's so easy to forget in the way we practice medicine here, which is not to say we practice it wrong, but it's just evolved into something that puts great distance between the doctor and the patient and it's a struggle everyday to maintain that connection.

How many people went on the mission?

There were about 90, of which probably 16 of them doctors, either practicing physicians or residents in training. Then there were local translators who were totally fluent in English – and these were young men and women from the high school in Guatemala City. There were also anesthesiologists; we can't forget them because these patients couldn't be operated on without that. There were pharmacists. There were support personnel – we called them our MacGyvers. Our three MacGyvers could fix anything at all that we needed. There were internists and there were internal medicine doctors to see the patients. There were pediatricians. There were helpers and runners.

Where in Guatemala was this?

Well, we were in Joyabaj. This is very

funny. We were 60 miles north of Guatemala City. It took us six hours to get there. It was mountainous, winding roads and not being familiar with the topography, I thought we were hundreds of miles away. We were no further than from here to Irvine. It was amazing.

What was a typical day like?

We began at 7 a.m. and on the first day/night we ended at 2:30 a.m. the next day, then it was just nonstop after that. I do want to give credit to really the people who ran this thing, Olivia Marroquin and her daughter Jessica were responsible for the entire logistics operation and Babak Larian, who is a local nose and throat doctor, was responsible for the medical aspect of the entire mission and has been doing this for 10 years.

You went with your son. Tell us about him.

Jordan [a Beverly High 2002 graduate] is an interesting character. He started out on scholarship at Rice in music. Halfway through, he said he wanted to become a doctor, studied hard, graduated from Rice, went to Tulane University Medical School, was accepted at Emory University Department of Surgery, and is in his second year of surgical training now. He and I are already extremely close.

If my son Jordan and the resident who was also with him, her name is Alex Gangi, are any indication of the doctors of the future of this country. We're actually in pretty good hands. I watched these kids operate and take care of these patients and I'd be happy to be taken care of by them.

How many procedures were done during that period?

I'm guessing we did about 100 to 120 procedures over that period of time plus we saw untold numbers of kids and adults for check-ups and medical problems and the lines just kept coming until the last day and the army just cut them off.

In issue #409, Dr. Anthony Sokol, who's been on several similar missions, mentioned that when you go to a country, "the country must have certain basic facilities and resources. These countries must have adequate hospital facilities." Was there a hospital

or a facility there that was available to you? What were some of the challenges you faced?

They have something they call a hospital. It's not by our standards. They had basic rooms and square footage and we made it come alive as a medical facility. Their medical facility is pretty basic and a little frightening but our challenges were bringing our own water, our own food, staying healthy, taking care of each other. A lot of people ended up developing different things that we treated on each other -- cuts, stitches, illness. We couldn't leave the compound. They felt that it wasn't in our best interest as far as safety, so we were in a small building and we couldn't leave except to go outside and sit in a chair. The challenge was mental, but we had each other and the physical challenges were those of any deprived area, but we never felt danger.

This was your first mission. What would you say you took away from it?

Basically, I remembered my humanity. I remembered how wonderful it is to take care of people and I owe the Guatemalan people a debt of thanks for that. It's going around like a song in my head and far from forgetting it, it's driving me forward. People worry, "am I going to forget about this?" I don't think so. A surgical career can be divided in thirds: 20, 20, and 20. I've done the first two: the learning, the practicing and now I'm in the giving back and it has totally energized me.

You are now trying to form a second Los Angeles area team. What do you think two groups can do that one can't?

You simply double the amount of operations and there's no shortage of people needing help. I plan on going to Dallas at the end of May for a big HELPS convention where a lot of this can be planned and hopefully, I can get help, advice and suggestions in an effort to start L.A. number two. A bigger point is, this could have been El Salvador; it could have been Namibia; it could have been Afghanistan. It happened to be Guatemala. I happen to know a lot of people from Guatemala. My son was available. I was available and the next thing you know, I'm off on another dream. Of all of this, that's the takeaway. I'm off on another dream and I hope I can make it real.

What would you say if you met a physician or anyone who was interested in going on a mission?

If they wanted to get involved, join me or go on the Internet and find any number of international helping missions because they are around. It's not an easy thing to do to say, "I think I'm going to close up shop and go away." It's very difficult. It almost has to be luck that you fall into it, but anybody who wants to help, I'd say look in your heart, see what you want to give back and see if you can afford one less Lakers game and one less trip to New York, and one more week somewhere watching people get well.





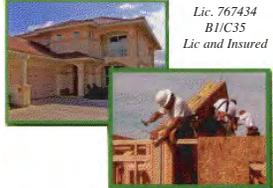
