"Planning Commission mitigates driest year on record" [Issue #742]

No commission can really mitigate a drought. Eventually the water will run out, if not this year, then next year or the year after

We who live in Beverly Hills need to begin conserving water now, in the third year of a major drought, before the taps run dry.

Low flow shower heads and faucets, low flow toilets, and water-saving dishwashers and washing machines are only a small part of the solution.

Half to 70% of residential water use in Southern California is for landscape purposes, i.e., to keep our lawns green.

We must change this. Beverly Hills is lagging behind Santa Monica and Los Angeles in encouraging xeriscaping.

But in addition to concerns about water, we must worry about endangered bird and pollinator species.

Taking out the lawns and planting waterwise, environmentally friendly California native plants- not Mediterranean or South African or Australian plants- in our homes and in the City's parks will not only save water but will nurture endangered species like the monarch butterfly and the many bird species which are also declining in number.

Mayorkas confirmed **Homeland Security Deputy** Secretary

Alejandro Mayorkas, a 1977 Beverly High graduate. was confirmed Friday deputy secretary of the Department of Homeland Security, the department's No. 2 official,

by a 54-41 vote of the U.S. Senate.

No Republican voted for Mayorkas' confirmation. No Democrat voted against

Mayorkas remains the subject of an internal investigation into accusations he overruled career officers to approve visa applications as director of U.S. Citizenship and Immigration Services.

In his confirmation hearing in July, Mayorkas said that he has "never, ever in my career exercised undue influence to influence the outcome of a case."

The Mayorkas vote Friday marks the second Department of Homeland Security

confirmation this week. Jeh Johnson was confirmed earlier this week as Secretary of the department, replacing Janet Napolitano, who left in September.

Mayorkas' approval came two days after his nomination was cleared by the Senate Homeland Security and Governmental Affairs Committee.

Five applicants considered for Planning Commission

An interviewing committee consisting of Mayor John Mirisch, Vice Mayor Lili Bosse, and Planning Commission Vice Chair Howard Fisher, will recommend one of five applicants, Marilyn Gallup, Marty Halfon, Jake Manaster, Sandra Pressman, and Farshid Joe Shooshani, to be appointed to the Planning Commission.

Planning Commission Chair Brian Rosenstein was absent at the interviews.

"We have made a decision, and we have an internal recommendation that will be presented to the full City Council on Jan. 3," said Fisher. "At the moment most of the [Planning] Commissioners don't know who it is. It's hush-hush until the City Council has it. Then the Council has to affirm the recommendation."

The applicant selected by the interviewing committee will be made public on Jan. 3, when the packet for the Jan. 7 City Council Study Session is released, according to City Clerk Byron Pope. Each Council member will receive a copy of all five applications. If the Council approves the committee's recommendation, an email will be sent to all Planning Commission applicants announcing the selection.

City awaits Kobor decision at Jan. 7 de novo hearing

After the issue was discussed at a City Council meeting on Tuesday, Dec. 17 and a Residents Council meeting on Thursday, Dec. 19, residents and the Kobor family await the City Council's decision regarding a medical overlay zone request for 8767 Wilshire Boulevard at Robertson.

At Councilmember Nancy Krasne's request during the City Council meeting on Tues., Dec. 17, the City Council arranged the Jan. 7 de novo hearing to re-hear the Kobor developers' request for an overlay zone. The Council voted 4-1 to arrange the hearing, with Mayor John Mirisch as the only abstention.

"We are a City Council task force

[established in Aug. 2011 by then Vice Mayor John Mirisch], not a homeowners association. We were asked [by the Council] to look at the Southeast and make some recommendations about what we thought would revitalize the climate in the Southeast and respect the residents. Our recommendations do not include medical [facilities]. All through our deliberation we were unanimous that we thought more medical would not be good for the Southeast," said Southeast Task Force member and former Board of Education member AJ Willmer.

In order to construct medical facilities in the Southeast neighborhood, developers must obtain zoning overlay permits proving that the "pros outweigh the cons," according to Willmer.

"We either have to say what we mean or mean what we say in our government. If they don't want medical, that's it. There's no medical. But this area of town has a lot of medical," said Isabel Hacker, Southeast Task Force member and coordinator of Thursday's residents meeting regarding the project. "The city doesn't really benefit from medical facilities."

The Planning Commission finalized their resolution to deny the Kobor permit on Thursday, Dec. 12. The developers had 14 days after the Planning Commission decision to appeal the resolution.

"The real question is why did the City Council feel the need to have a de novo hearing? Why didn't they just wait for the developer to appeal the Planning Commission's decision?" said Willmer.

In attendance at the residents meeting on Thursday were Planning Commissioner Alan Block, who informed the residents about his findings regarding the impact of medical facilities in the Southeast, attorney Larry Larson, who gave a history of the project and the lawsuit, and Thomas Javor, son-in-law of late George Kobor, who asked to address the group with his side of the story.

"We were open to that, and he made a statement. He basically said there was a lot of misinformation around the community, said Hacker." He also said his family had done a lot of great things for the city. Somebody asked him, 'Do you think it's nice that you're going to sue us for \$40 million?" said Hacker.

Javor declined to comment extensively on the case. "I really went into the lion's mouth [on Thursday]," he said. "But it was good. We have our own opinion, and nobody ever asks us about that."

Hacker welcomed his comments.

"I think it was good that he came. I can't speak for everybody, but I think the majority of the people at the meeting were opposed to the [medical overlay permit]," she said.

The Kobor family first requested a medical overlay permit in 2009. The Planning Commission denied the permit, and the City Council denied the developers' appeal. In 2010 they once again requested a medical overlay permit, and were once again denied by both the Planning Commission and the City Council.

"After that, we didn't hear anything about this until the City Council came out of closed session several weeks ago and said they had made some sort of agreement with the owners, and I'll be frank with you. I don't understand it. I've never seen that happen before," said Willmer.

The closed session, which involved matters pertaining to the developers' lawsuit against the city, took place on Oct. 18.

"There was a lot of confusion among the residents as people were coming into the room. People thought this was over when it was struck down by the Planning Commission. They don't realize that it came back to the Council last week [at briefs cont. on page 4

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AUTHORIZING A ZONING AMENDMENT THAT WOULD APPLY THE CITY'S MEDICAL USE OVERLAY ZONE TO THE PROPERTY LOCATED AT 8767 WILSHIRE BOULEVARD;

Planned Development Permit: A request to allow up to 33,802 square feet of medical office space to be located within the building located at 8767 Wilshire Boulevard. This would be equal to approximately 45% of the building's floor area;

Development Plan Review: A request to amend the previously approved Development Plan Review for the subject property. The amendments would modify the project's existing conditions of approval, and would eliminate prohibitions on medical office space, automobile sales uses, and pharmacies. The amendments would also allow for increased restaurant space within the building, and would establish a fee structure for providing public parking on weekdays and weekends at the subject property; and

Conditional Use Permit: A request for a Conditional Use Permit to allow the establishment of a luxury automobile showroom within the building's ground floor. The proposal includes a showroom only, and no service operations would occur on-site.

The ordinance and related entitlements outlined above were previously reviewed by the Planning Commission on November 21 and December 12, 2013. The Planning Commission unanimously voted to deny the ordinance and related entitlements, and the matter will now be considered by the City Council during the public hearing described in this notice.

The ordinance and related entitlements have been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. A Mitigated Negative Declaration (MND) was previously adopted by the City Council on January 30, 2007 for the existing commercial building on the subject site. Therefore, an addendum to the original MND has been prepared to evaluate the project changes outlined above, and will be presented to the City Council for consideration.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

Please note that if you challenge the Council's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

AYSO Sportsmanship Cup features VIP game for special needs children

AYSO's 17th annual Beverly Hills Sportsmanship Cup, founded by Michael Karlin to promote an enjoyable soccer experience with less "screaming and yelling" and more on sportsmanship, included a VIP game for children with disabilities.

"The VIP game is a wonderful addition to what is already a wonderful tournament. It's just a natural fit to bring the VIP program to our tournament, which is based on the concepts of friendship and fun," said Karlin "People don't come to win games—of course all the players all try their best—but you don't win the tournament by winning games. You win because your players, coaches, and spec-

tators get the highest sportsmanship score by the judges."

Two years ago, AYSO Region 76 started the Beverly Hills region's VIP program to create a place for children of all different ranges of disabilities to have the experience of playing sports on a team. This year's Sportsmanship Cup was the first that included a VIP game on the tournament schedule. City Council members were invited to watch the VIP teams practice and play their game.

Each VIP player has a 'buddy' from Beverly Hills Unified and Los Angeles Unified school districts who works with the VIP player each week.

The tournament hosts anywhere from 80 – 100 teams from all over California for a weekend on Beverly Hills Park fields, Beverly Hills Unified fields, and fields at Fairfax High and Kenneth Hahn Park in Culver City. Beverly Hills AYSO Region 76 works with Regions 78 (Hollywood-Wilshire) and 1031 (South Los Angeles) for the event.

"It's become a very highly regarded tournament," said Cindy Dubin, who took over as director of the tournament three years ago with her husband Mark Dubin.

The Sportsmanship Cup also sponsors many teams from neighboring communities whose regions lack have funds.

"It's amazing, and some people question every year, 'Oh we should make it more competitive!'" said Cindy Dubin. "But we get so many emails and compliments from referees and coaches. Everyone is so happy to come to soccer games where the emphasis is on playing soccer and having a good time. It's a very relaxing and lovely two days."

Next year's tournament will also collaborate with the VIP program.

"I think the next step is that we'll be able to get not just a VIP game of Beverly Hills players, but we'll get teams from other regions to play us as well," said Karlin.

Jessica Melamed scored 14 of her 16 points over the final three quarters and Natasha Allen added 15 as Beverly High defeated AGBU, 51-41, in the third-place game of the Milken Classic girls' basketball tournament Dec. 12.

The Normans trailed, 11-10, at the end of the first quarter, then outscored the Titans, 16-10, in the second quarter to take a 26-21 halftime lead as Natasha Kashani and Melamed both scored six points.

Beverly Hills (4-5) increased its lead to 39-27 entering the fourth quarter, outscoring AGBU, 13-6, in the third quarter with Allen and Melamed both scoring five points.

"We played really, really well in the first half and we struggled a little bit in the third quarter," said Norman coach John Braddell, who said his team didn't make enough shots and committed too many turnovers.

"It was a game we thought we should win from the beginning. Sometimes we play down a little bit to our competition. That's something we've been working on - trying to put teams away early."

Kashani added 12. Arianna Mazzarini and Lauren Moghavem three each and Robin Ashkenazi two.

Melamed made both of the Normans 3-point baskets.

The Normans led at halftime 26-20 after being outscored, 13-6, in the second quarter as Allen and Melamed sat out most of the quarter because of foul trouble, Braddell said.

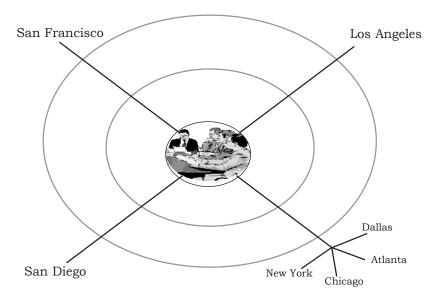

The Weekly's interview with incoming Maple **Counseling Center President Jeff Lapin** By Nicole Battaglia

What can you tell us about the Maple **Counseling Center (TMCC)?**

The Maple Center has been around for a lot of years. I grew up in Beverly Hills, and I went to Beverly High—in fact, I went all through grammar school in Beverly Hills-and TMCC started when I was in high school, many, many years ago. Back then it was a facility to help people with substance abuse, and everyone my age

It evolved into something much bigger over the years. Now it's one of the largest no-pay, or very low-pay, psychological counseling centers in the city of Los Angeles, and certainly the only one in Beverly Hills. It continues to help lots of people. Through the recession, and through the post-recession time that we're in now, the Maple Center has seen waiting lists at times. We can't even serve everybody we would like to serve. We continue to thrive and grow and help people, and hopefully the next couple years, when I'm president, we'll continue to grow activities and help more people

Is most of TMCC's clientele from **Beverly Hills?**

No, actually. Approximately 20-25% of the Center's clientele live or work in Beverly Hills. The other 75 - 80% is outside Beverly Hills in a variety of different areas throughout greater Los Angeles.

What might you do differently than outgoing board president Gail Millan?

Well, I've been involved in many corporations. I'm what you call a 'corporate guy' I suppose. I've been involved in many charity boards, and I like when things grow. I will be pushing for growth at TMCC both in terms of funding and in its programs.

We have many programs at TMCC. The clinical staff is excellent. It's one of the largest teaching facilities in Los Angeles, and I want to continue to expand what we do. I want to help more people and offer services to more people, whether it's the elderly program, family program, general program, or various school programs.

Could you elaborate on how you hope to expand these programs?

For example, currently we provide services to Beverly Hills and one or two schools outside Beverly Hills—peer groups and counseling groups. I would like to expand those services to other schools, to Jacob, Michael, Desiree, and Jeff Lapin

help kids who need help early on, so problems don't develop later. The more kids we can give an outlet to, who need some help, the better off everybody's going to be.

Are you still planning to move to a new building?

We're in discussions with our current landlord, and we are also in discussions with other buildings, so it's unclear as of right now what we're going to do.

We're in the basement of a very nice building, but it is a basement. Windows would probably provide a more cheerful environment for everybody. On the other hand, we've been in this location for many years, and everybody's comfortable with it. We are a charity, and we can only afford so much.

You said your background is corporate. How long has it been since you started working in mental health?

I'm not a mental health person. It's a passion of mine. It's become a passion of mine. The president of the Board before Gail Millan was Mason Sommers [interviewed in issue #667], who also went through the Beverly Hills school system with me, as did several other people on the board actually.

Mason and I were friends in high school and grammar school, and we lost touch. Mason got very seriously ill several years ago and I visited him in the hospital. In a conversation in the hospital he said, "Why don't you get involved in the Maple

to be very active in that organization.

I of course remembered it from my time

at Beverly high, and I got involved. As I got

involved, I got more and more passionate.

That was three years ago. I've been very active. When I'm in an organization I tend

Center?"

A learning experience. I spent a lot of time learning about what TMCC does and how it helps people, and I've learned about the opportunities that TMCC has. I've worked very closely with the staff. We have an excellent staff, particularly our CEO Marcy Kaplan and our Director of Development Jamie Powell.

As a 'corporate guy,' what's your outlook on TMCC's funding?

With any charity there's always a challenge and an opportunity. TMCC had a difficult time in the early part of the recession, and Mason Sommers, who I just mentioned, drove TMCC back to financial prosperity. We're in fairly good shape right now, although fundraising will always be an issue, and we'll continue to do our events. I'm going to call on my own personal rolodex and push people on the board to do the same, to see if we can even better our financial position. As head of a charity you're always thinking about fundraising.

What have you learned about the way mental health is viewed in Beverly Hills?

Mental health causes have been a harder sell to fundraise than other causes that people can identify with. However in the past 20 years, I think that has changed dramatically as mental health issues have touched almost every family I know. It's losing its stigma, and that is coupled with what has been happening in the U.S. with all the shooting events and various disasters. Mental health is discussed rather openly, in the press and otherwise.

So I think although historically there has been a stigma associated with fundraising for mental health, it's becoming more mainstream. I think people understand that

it's a very important place in helping both individuals and our society as a whole.

One of the things I've learned over the past three years is that the number of facilities that provide low or no-cost psychological services have declined dramatically over the years, in the same way that the amount of psychological hospitals have declined. It's really interesting that as problems increase, the available places for people to go have decreased. That's an interesting dynamic that's happening in our society. I do believe, although I'm not an expert, that early intervention, just like a physical problem, is important for the long term outcome of a patient. I'm a big advocate of "get it early and get it right."

I've started thinking about mental health the same way I'm thinking about physical

Why staff the maple center with both interns and professionals?

Most of our clientele sees interns. The interns are supervised by the professionals. The interns are required to intern at a place like TMCC for 3000 hours, giving psychological care under the supervision of a professional, before they can hang up their shilling. TMCC is one of the most prestigious places to meet that interning requirement.

We have always been a teaching facility; that is part of our reason for being. Not only are we helping people for low or no cost but we are helping many up-and-coming psychologists get a start on their career. We have an amazing professional staff that supervises the interns, who in turn help our clientele.

An intern typically stays one to four years. Our professional staff has been there for a long time. The turn-over at TMCC is very low. It's a very good place to work, and people do very good things there.

Tell us about your family.

My wife Desiree and I have been married for 15 years and we have two sons, Jacob who is 12 and Michael who is 10.

How would you say your switch to mental health 3 years ago has impacted your personal/family life?

That's interesting. I think about mental health differently than I've always thought about it, and I give it more importance in my own personal life. It became very important to me to help people, because I have seen a lot of issues with family and friends that mental health professionals have helped greatly. I think getting involved in TMCC has made me approach mental health in a more robust and meaningful way.

It's a really good cause, and it's rare when you can be involved in a charity and know that so many people are actually being helped every day. TMCC does 16,000 hours a year in therapeutic sessions. Lots of people are being helped, and that's very gratifying. I want to continue to expand those numbers so we can help even more people.

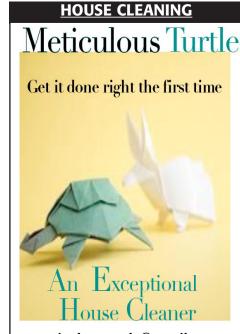

ORDINANCE NO. 13-0-2651

AN ORDINANCE OF THE CITY OF BEVERLY HILLS ADDING ARTICLE 5 TO CHAPTER 5 OF TITLE 2 OF THE MUNICIPAL CODE REGARDING THE PROCEDURE FOR ADOPTING OR AMENDING A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY AND AN EXCLUSIVELY RECOGNIZED EMPLOYEE ORGANIZATION

THE COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1 The City Council hereby adds Article 5 to Chapter 5 of Title 2 of the Beverly Hills Municipal Code as follows:

"Article 5 LABOR NEGOTIATIONS

2-5-501: Applicability 2-5-502: Definition

2-5-503: Adoption of a Memorandum of Understanding

2-5-504: City Representative

2-5-505: Economic Analysis

2-5-501: Applicability:

This Article shall apply when the City Council considers adopting or amending a memorandum of understanding.

2-5-502: Definition:

For the purposes of this Article, the following words and phrases shall be defined as follows: MEMORANDUM OF UNDERSTANDING shall mean a formal signed agreement between the City and an exclusively recognized employee organization.

2-5-503: Adoption of a Memorandum of Understanding: A. The City Council may adopt or amend a

- A. The City Council may adopt or amend a memorandum of understanding only after the memorandum or amendment has been placed on an agenda at a minimum of two (2) City Council meetings that are held at least two (2) weeks apart.
 B. A proposed memorandum of understanding
- B. A proposed memorandum of understanding or amendment to a memorandum of understanding, as well as any fiscal impacts analysis prepared pursuant to Section 2-5-505 of this Article, shall be posted on the City's of-

- ficial website at least seventy-two (72) hours before the first City Council meeting at which the proposed memorandum of understanding or amendment is considered.
- C. The adoption or amendment of a proposed memorandum of understanding shall not be placed on the City Council's consent calendar.

2-5-504: City Representative:

Unless reported as provided below, the lead negotiator on behalf of the City during the negotiation of a memorandum of understanding or amendment to a memorandum of understanding shall not be an employee of the City and shall have demonstrated expertise in negotiating labor and employment agreements on behalf of municipalities.

If the principal representative of the City does not meet the requirements of this Section, then this fact must be reported at the meetings of the City Council at which the memorandum of understanding or amendment is considered.

2-5-505: Economic Analysis:

Unless reported as provided below, the City Council shall obtain from a consultant who is not an employee, a fiscal impact analysis of the proposed memorandum of understanding or amendment to a memorandum of understanding. If a statement of actuarial impact is required by California Government Code Section 7507 or its successor for any change to retirement or other post employment benefits, then the fiscal analysis required by this Section need not address the benefit changes analyzed in the statement of actuarial impact

If a fiscal impact analysis is not obtained as required by this Section, then this fact must be reported orally at the meetings of the City Council at which the memorandum of understanding or amendment is considered."

Section 2. If any provision or clause of this ordinance or the application thereof to any person or circumstances is held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such invalidity shall not affect other provisions or clauses or applications of this ordinance which can be implemented without the invalid provisions, clause, or application; and to this end, the provisions of this ordinance are declared to be severable.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and this certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 4. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
