

#### “Armenian Genocide in California school curriculum”

I join Turkish Americans, members of the Pax Turcica Institute, to express a strong disappointment over the recently amended Assembly Bill 659 by Assemblyman Adrin Nazarian. The amended bill is a veiled attempt to impose the spurious “Armenian genocide” narrative in the public school curriculum.

All recognized genocides, such as the Holocaust, Srebrenica, and Rwanda, have been determined by a tribunal in accordance with the 1948 United Nations Convention on Prevention and Punishment of Genocide. In contrast, the atrocities in the Ottoman Empire were never tried in a competent court and the intent to exterminate Armenians was never established.

Last month, in its landmark *Perincek vs. Switzerland* decision, the European Court of Human Rights ruled that genocide is ‘a very narrowly defined legal notion which is difficult to prove’ in the Armenian case. ECHR also doubted that there could be a general consensus on the alleged, “Armenian genocide,” as it remains a matter of historical debate. In 2012, then Secretary of State Hillary Clinton expressed the same posi-

## Gallup speaks about City Councilmembers' decision to cancel Planning Commissioner nomination

Marilyn Gallup addressed concerns at the Planning Commission meeting on Jan. 9 about the City Councilmembers' intervention on the nomination of Gallup as Planning Commissioner.

"I am here today to thank the commission for the very warm welcome you extended to me at the time when I received the unanimous nomination of the liaison committee to become a member of your commission," Gallup said.

When Gallup's nomination was announced at the City Council Study Session on Jan. 7, Councilmembers Julian Gold, Nancy Krasne and Willie Brien objected to the selection. Another candidate is now being selected for Planning Commissioner by the Planning Commission interview panel, consisting of Mayor John Mirisch, Vice Mayor Lili Bosse, and Planning Commission Chair Howard Fisher.

According to Gallup, her nomination was blocked because she was 'vindictive toward the Kobors.' She also said that the interview process should be uninterrupted, and that 'doubts had been cast upon' the Planning Commission interview panel due to councilmembers' judgment.

At the Study Session meeting when Gallup's unanimous nomination was announced, Krasne said, "As far as I'm concerned, the Planning Commission is dysfunctional."

"I just want to tell you that I don't share her views, that I think you are a diligent, thoughtful group, and accredit to our community," Gallup said. "I'm sorry I won't have the opportunity to work with you to know you better, but I wish you well."

## "Endowment Fund" name changed at BHUSD Finance Committee meeting

The BHUSD Finance Committee voted to change the "endowment fund" title to accurately reflect the account at the Finance Committee meeting on Jan. 13.

At a BHUSD Finance Committee held in Aug. 2013, the Board of Education approved the establishment of an endowment fund account. According to the resolutions, funds from the Basic Aid Reserve Fund, District's Fund 17, combined with the amount from District's Fund 1, will amount in the total of \$10 million in balances for the endowment fund. The purpose of the endowment was to 'provide for the District's future financial stability.'

The resolutions were updated in Oct. 2013 to further define the purposes of the fund, which includes providing additional sources for internal borrowing and providing a reliable source of funds to the General Fund from investment earnings.

Additional resolutions for the endowment fund was added at a Nov. 2013 Finance

Committee meeting by adding a sub-fund, "Reserve Fund for Economic Uncertainties," as well as defining the Basic Aid Threshold. The balance in the Reserve Fund amounts to \$1,676,743, and the amount of the Basic Aid Threshold, which is three times the amount of the difference between the District's community revenue and the State's allocation to the District from the current year, is estimate at \$13,910,292.00. The Basic Aid Threshold estimation would be included to the endowment fund, in order to increase the amount of funds allocated to the endowment fund.

At the Finance Committee meeting held on Jan. 13, Finance Committee Vice Chair Herb Young brought up the definitions of what constitutes as an endowment fund.

"We acknowledged that there was no board of trustees, there is no management of the funds other than the [Los Angeles] County Office of Education, [and] there is no treasurer," Young said. "I want to ask the superintendent, have I said anything that is not factually correct?"

Superintendent Gary Woods said, "It's hard to talk outside of closed session."

The only items that can be discussed in closed session are personnel, litigation and property negotiation.

"The resolution language spells it out," Woods said. "We debated on that language [and] we had an attorney advise upon that language. The way [the Finance Committee defined an endowment fund], it has a board of trustees, there's dividends [and] there's maybe investments that are made to grow the fund. You can't do that with public money so we have many restrictions on what can put together. What we've put together was the best we could do for the restrictions that we don't have."

Other Finance Committee members expressed their concerns with the name "endowment fund" as the definition of the \$10 million fund.

"I don't think anybody's done anything wrong in the financial statements," Finance Committee member Terry White said. "It is a little concerning that there is this loose terminology floating around in the community with regard to this matter."

"I just think they need to call it what it is, and be consistent," Finance Committee Chair Bob Sternsheim said.

The Finance Committee unanimously voted to change the title of the "endowment fund" to properly reflect the definition of the fund.

Their recommendation will be forwarded to the Board of Education.

## BHUSD General Counsel position still open, still in search of candidate

The BHUSD General Counsel position is still open and was further discussed at the BHUSD Financial Committee meeting on Jan. 14.

According to BHUSD Superintendent Gary Woods, the item was pulled from the agenda due to personal discussions in closed sessions and contractual budgetary matters.

The potential General Counsel will manage all BHUSD legal entities, including management of district billing and will hold attorneys accountable for the product they

charge for.

The BHUSD currently has engagement letters with law firms and connections with attorneys with different expertise, but the process may take up to five days before an attorney can create a product for the district to see.

"That's three or four or five days that sometimes we don't have on the issues we deal with," Woods said.

According to Woods, having a General Counsel will lower the legal fees for the district once the position is filled.

"We want to be certain that the direction we'll go in will in fact save money," Woods said.

## Mirisch reacts to Kelly Thomas trial verdict

After two former Fullerton police officers were acquitted Monday of charges in the beating of Kelly Thomas, Mayor John Mirisch expressed his disagreement with the "not guilty" verdict made on Jan. 13.

"The [video] tape speaks for itself and its nothing that can justify the treatment that the police gave to Kelley Thomas," Mirisch said.

In July 2011, Fullerton police officers beat Thomas, a mentally ill homeless man, unconscious. Thomas later died from the

injuries, and the recordings show him begging for his life saying, "Dad, help me."

"This would never happen [in Beverly Hills]," Mirisch said.

"We have the right people and the right training. Clearly, in Fullerton, they do not."

According to Mirisch, a local government in Fullerton needs to be elected that will take charge, and the Fullerton community needs to say the incident is unacceptable in order for a similar event to not happen again.

"I think the whole situation is not only tragic, but shameful as well," Mirisch said. "The police are supposed to be protecting all of us, including the most vulnerable. Instead of protecting them, they murdered instead. That cannot happen in any civilized society."


Any interested person may attend the meeting and be heard or present written comments to the City.

## Steve Tisch's private art collection structure approved by planning commission

Film producer Steve Tisch's request for construction on his Tower Road property was approved at the Planning Commission meeting on Jan. 9.

According to a planning commission report on Jan. 9, the intended structure will display Tisch's private art collection, and, on occasion, hold private parties.

The single-family residence, garage and pool house were designed by Master Architect Paul Revere Williams and considered to be historic. The proposed structure will replace the current tennis court and pavilion which were constructed in 1976 and not designed by a Master Architect, maintaining the architectural structures.

## McGilvray House and North building of Beverly Wilshire Hotel nominated for historical landmark distinction

The Cultural Heritage Committee unanimously agreed on Jan. 9 on the nominations of the McGilvray House and the North building of the Beverly Wilshire Hotel for landmark inclusion to the Local Registrar of Historic Properties.

The McGilvray house, located on Alpine Drive off of Sunset Blvd., was designed by Master Architect Wallace Neff and was constructed in 1927. Neff's hallmark elements are featured by a circular bay topped with a conical turret at the intersection of two wings, and a steeply-pitched, hopped and gabled roof with shallow eaves, which are also elements of the French Revival style. A two story extension to the rear of the house was added in 1984, which is not visible from the street, and was designed by architect Edward Grenzbach.

The owners of the house made sure to retain as much of its original, architectural structure during renovations.


"[The McGilvray house is] a model for future buildings where people are looking to preserve," Cultural Heritage Commissioner Lisa Greer said.

The North building of the Beverly Wilshire Hotel was designed by Los Angeles-based architects Walker and Eisen and constructed in 1927, the Beverly Wilshire Hotel is a nine-story building with two basements, and takes on a Second Renaissance Revival style due to its E-shape. The structure is steel-reinforced with concrete, and is finished with brick and terra cotta.

The hotel is also associated with the early social history and commercial development of the community.

"It is very important to the community of Beverly Hills to include this on their landmark," Vice Chair Maralee Beck said. "It is iconic, it's the one that you see when anybody takes a picture of Rodeo Drive, [and] and it means such a great deal to the history of this particular city."

Initiated nominations also began for eight other architecturally significant structures, including the Regina Fine Arts Theatre

designed by Master Architect B. Marcus Priteca and the Rogers - Cohn House designed by Master Architect Robert Farquhar.

addressed concerns if the retaining wall is strong enough to handle the weight of the proposed building, which will be heavier than the tennis court alone.

An engineering and stability study to verify if the land is stable and if the wall will be sup-

ported still needs to be conducted.

A 12-foot concrete wall will also be constructed from the San Ysidro Drive street view, and Corman requested to have a "green screen," such as vines, to 'soften the look of the wall.'

Construction management plans detailing parking and hauling conditions will also be worked out with the director of community development.

tion.

### "Bicycle lanes"

I'm fortunate to have been appointed to our city's Santa Monica Boulevard Blue-Ribbon Committee, tasked with making design recommendations to City Council. Mobility is the Westside's Achilles heel, of course, and the committee is committed to ensuring that traffic continues to flow on tomorrow's corridor.

We've got to focus on moving people if we're to keep the Westside flowing, and that could include prioritizing transit. But it should include making our streets safe to use outside of a car. One way to do that is to facilitate 'active' mobility.

Though many of us are too long out of the bike saddle to give it more than a passing thought for an errand, say, still others among us care passionately. Our committee received more than 40 members of the public and bicycle lane support ran three-to-one among them. More than 150 more have written to the committee and 90% of them have favored bicycle lanes.

Why do people care so much? Bicycle lanes work to make us feel safe. And for those of us who would bike, that simple 5-foot separate lane could make all the difference. This one design option has received more attention in the Santa Monica redesign discussion than all others. That anyone could be opposed to a bicycle lane is a mystery. Indeed North Santa Monica Boulevard presents a best-case for including a lane: there is no narrow street to retrofit, no curbside parking to displace, and no driveway to impede.

While my fellow committee members have focused on the presumed negative effect of lanes on flow and safety, to transportation engineers it's a settled issue. The bicycle lane like other pavement markings is included in our state's traffic device manual because it's proven to work as a road safety device (just like a crosswalk).

The sooner we can move on from second-guessing traffic engineers to viewing the bicycle lane as a traffic safety measure, the sooner we can begin to discuss our vision for tomorrow's corridor. It will telegraph the kind of city we want to be in our second 100 years.

### Opinions mixed on Evidence-Based Inc. security program on BHUSD campuses

Evidence-Based Inc. began its security program on all BHUSD campuses on Jan. 6. Joe Chirillo, retired Beverly Hills Police Department sergeant and vice president of Campus Safety for Evidence-Based Inc., began the Irvine—based security program in early 2013 after the Sandy Hook Elementary School incident in order to prevent another tragedy from happening. According to Chirillo, there have been 20 school shootings since Sandy Hook.

“This can’t happen anymore,” Chirillo said. “We’re going to try to do something to make sure that doesn’t happen.”

According to Chirillo, all campus safety officers have worked in the police force for 20-30 years, and are honorably retired police officers. These retired officers have a security guard card and an exposed firearm permit issued by the state of California which allows them to carry a weapon. Campus safety officers cannot work in Evidence-Based Inc. without the guard card and permit.

Beverly High’s campus safety officers, Carlos Pinho and Mike Burges, are working in conjunction with the existing six security officers, and there is one campus safety officer on each of the elementary and middle school campuses. Evidence-Based Inc. officers are armed and eventually, at each campus, there will be a security car parked in front of the school to be visual deterrents from serious threats.

If students have concerns for their friend’s safety, bullying, violent threats, or find anything suspicious, they can approach a campus safety officer.

“One of the things that we’re really trying to communicate with the kids is that there’s a difference between tattling, being an adult, and being a good citizen,” Chirillo said.

Traffic and Parking Commission Chair Andy Licht said the visual deterrents of the armed officers will not be as effective. Licht refers to Columbine High School where an on-site armed security guard was present, but was not able to prevent the 1999 shooting.

“Why bring in guns where there are no guns?” Licht said. “Now you have a crazy person who wasn’t able to get a gun, who can now overpower the person with a gun, and now has access to the gun.”

Evidence-Based Inc. will be paid \$1.4 million, according to their contract from Jan. 1, 2013 until June 30, 2015

Licht said he would prefer the money to directly benefit students and educational improvements rather than having it go towards a security program.

According to BHUSD Board of Education President Noah Margo, parents have been pleased that the board has taken action. There have also been concerns about budget and the effectiveness of the program at the high school.

“I want the campuses to be safe,” Margo said. “The program consists of experience[d] [former] Beverly Hills officers [and] that knowledge is priceless to have as opposed to just any security firm.”

mote the senior training travel program. The club’s purpose is to encourage public transportation use by seniors. Seniors familiar with riding the transit system, “Travel Buddies,” teach inexperienced seniors how to use the transportation system. Currently, there is a representative from West Hollywood, Culver City, and Santa Monica.



**You helped edit your dad's posthumous memoir, "Moose," which is available on Amazon. What made your dad want to write the book?**

He had been a short story writer, and a poet, and long before he was ever in a play write, long before he ever became a songwriter, and certainly long before he became a famous songwriter. Of course it's the songs that he's known for, but he's most definitely known for being these other things as well. Probably least for his short stories because he's never really published them. A few of these stories actually go back to the 1940s, but mostly they were done in the intervening years. I'd say the majority of them were done in the 1990s, 2000s, this idea of making this book. But he loved the idea of a short story, he loved o henry and other story writers, and the thing is, what people want to know and some things that have some moral value at the end of the story oftentimes do come in a short story format. It's like [how] we tell anecdotal stories in life. So my presumption would be that he wanted to write this autobiography in the shape of short stories that tell you about his life.

We actually turned down publishers who were interested in the idea of a Robert B. Sherman autobiography because they wanted him to write it chronologically with much more of a bend on his Hollywood story, and when you get into the book you'll see that maybe a quarter of it is about his Hollywood stuff.

I think at one point, probably about five years ago, he probably realized that this book would be his last great testament, a statement of the way things were. I think he really wanted to set the record straight.

The reason that this wasn't published before he passed away was because it was very important to him that there be a lot of photos in this book and he really wanted it.

And I said to him when he was in the hospital, "Dad, should we get the book out." And he said, "Have you finished the picture section?" And so I said, "Not yet." And he said, "We'll wait until the picture sections are done." And that's the reason why it's published now.

**Your dad and your uncle, Richard, wrote some of the most famous songs in the Disney catalogue, including Mary Poppins, The Jungle Book and others. You currently run the business end of Musicworld. Tells us some of your day to day duties running Musicworld.**

Musicworld is my father's publishing company that he established in 1958. [It's] more of the music publishing end of things but it has a wide description. We're dealing with the archival aspects of my father's estate now. Actually, we were doing it before my father passed away because there are a number of things that are currently very pressing for the estate.

We manage[d] [Moose], we edited [it], we published it. As you know running a newspaper, it's not an easy thing to edit any type of written document. We have to do fact checking, [and] we had well over 10,000, probably close to the 15,000 photographs to go through.

There's also my grandfather's, [songwriter Al Sherman's], estate. My grandfather was a well-known and esteemed songwriter in his own right back in the tin-tin alley days. We manage our half of that estate [and] my uncle manages the estate too.

For example, for me, when we went into the archives I had to catalogue everything, and I had a crew with me of people who were helping me catalogue things. Thousands and thousands of items and one of the things we came upon was my grandfather's estate, and all of this has just been sort of packed away by my father when my grandfather passed away 40 years ago, and my grandmother had passed away around the same time. So you have a choice. You can either throw the stuff away or do what we're doing, which is perpetuating it, keeping it around. You know my grandfather was no slacker. He wrote songs for Frank Sinatra, Billie Holiday, Eddie Cantor, and Al Jolson, Maurice Chevalier. He was a first-class, high-rated songwriter.

You can either let that stuff slide into oblivion or you can make a conscious effort to preserve it. But that's a big effort. That's team work, that's building a website, that's doing all these things, and hopefully by 2015 or 2016 that would be accessible by the public.

One of the things that we're doing that's very exciting is we're doing this show called "A Spoonful of Sherman." What "A Spoonful of Sherman" is, it's obviously a

take on "A Spoonful of Sugar" which was [one of] the Sherman brothers song[s] in Mary Poppins, one of the things that we're going to do, is basically we're covering 90 years of music, including my grandfather's music, and my father's music, and also mine because I'm also a songwriter. When I'm not busing administrating I'm also a songwriter. So it runs in the family.

**It seems like that's what you're meant to do.**

I don't know what else I can do [laughs] What that is, is that's what we're doing on a public face to promote the book. It's going to be a tour. We have two dates right now, as of tomorrow we should have confirmed one or two probably then three more dates because we sold out so quickly for these shows.

We're doing songs for my new show, "Bumblescratch," which is a musical about the plague of London told from the point of view from a plague rat. It's sort of a dark comedy.

**Much of the book takes place in Beverly Hills, since your dad lived in Beverly Hills for many years, and your uncle still lives in Beverly Hills too. What made your dad want to move to London in 2002 towards the end of his life?**

Well after my mother passed away in 2001, my father need[ed] a change. It was good fortune for him that he had the opening for "Chitty Chitty Bang Bang" in London on the West End at the biggest theatre in London, which is the London Palladium. That show was like a new lease of life for him. Then of course two years later he had the new opening of "Mary Poppins."

A lot of people questioned my father as to why he would do something like that. The truth is, a lot of people here thought my uncle should have moved to London [too] because this is where the action was in the musical world. With "Mary Poppins," we had a number of workshops with my dad here.

He didn't come here because his life was ending. If you look at my dad's book in the section called "My Time Part Four," you'll see that he really led quite an active life in those last 10 years. It wasn't like he just sat in a room and read a book. He did a lot of that too, but no, he was constantly on the move and really, it marked the resurgence for the Sherman brothers that they're enjoying until this day. I can tell you 15 years ago, the Sherman brothers weren't really that present on the map. But now there's a lot of excite[ment] and exuberance for the future.

**After your dad's passing, you decided to stay in London, tell us about that.**

Well over the last ten years, I've planted roots here, and for

the moment I see myself living in London. That said, I'm not really tied to the place. I could move anywhere. If something was happening in New York or Hollywood I can move there. I've thought about moving to Switzerland. But it would be very straightforward for me to make a move if I wanted to as well.

**The movie, "Saving Mr. Banks," includes a portrayal of your father and uncle. Do you feel the movie is accurate?**


Not really. I think that the movie is a lot of fun, obviously it has to work in broad strokes and in doing so, aspects of historical accuracy are inevitably difficult to portray.

**"It's A Small World After All" is the most played song in the world. Is that correct?**

Yes. But if you were to ask some people they would say, "No," because they are basing it on radio play. The reason why "It's a Small World After All" is the most played song in the world is that for the last 31 years it hasn't stopped playing somewhere in the world that every hour of the day probably in two or three or four different locations because it plays at all the different Disney theme parks, over and over on a loop on the ride. So if it's playing somewhere every minute of the day, it's the most performed song in the world, and there's no other song that's really like that.

**Your dad mentions in the book that he was not entirely satisfied with his portrayal in the documentary, "The Boys," about his songwriting career. Why is that?**

It's very difficult to deal with the nuance of family matters and relationships in something as brief as a motion picture, and the problem with "The Boys," Sherman Brothers' story, was that it painted in primary colors what needed a lot more nuance, and so his portrayal



was as sort of a loner, a recluse.

For example, it talks about when they came to film him in sort of this “day in the life” scene. They didn’t have any lights on in the room, and they were showing him because one of his hobbies was painting and he was a very good painter. He always painted with a lot of music in the room you know, Dixieland music was going, and friends would be coming in and out.

I think it was on December 31st, which in London, the place is empty. There is nobody here, so nobody was at work because we have a home office, and my apartment was next to his. My dad points out, it’s kind of funny that they photographed him without any light on in the room, and he says, “Who paints in the dark?” If you’re a painter you need a lot of light in the room. He didn’t even have lighting in the room and the cameraman says, “No, I’m supposed to show this light.” My dad said that he found that very suspicious.

They wanted to show my uncle as very vivacious, and my dad as sort of a glum figure, and my dad really wasn’t that way at

all. He was such a gentle sweet man who was actually a very happy individual and very content with his life.

#### **Tell us about your family and siblings, what are they up to?**

My brother Jeff, is a writer, he lives in Studio City. My sister Laurie lives in Ecuador. My sister Tracy lives in New Mexico. Tracy is an artist, Laurie is retired.

#### **What are your future plans, do you plan to stay in London or come back to Beverly Hills?**

I have some property in Beverly Hills and I come back from time [to time]. Show business is based out in L.A., still, to a large degree. I[’d] come back, but would I live there again? Only the future will know.

It’s hard for me to imagine myself [moving] right now because what I do, writing musicals, [and] songs for that kind of thing, that’s really more of a [move to] New York or London

#### **What’s one thing readers will take away**

#### **from the book about your dad that they didn’t know?**

I think the thing that was fascinating to me was when I was going through the archives, I found this one letter that my father had written when he was only 18 years old. It’s on the very front of the book.

*[The sealed letter was written by Robert Sherman on September 1944 when he was 18 years old before embarking on dangerous military operations. It was addressed to his parents, and would only be opened from ‘his demise’]*

#### **The reason I point out this letter is because you can see two things.**

One, it shows how principled he was. That he volunteered at 17 years old to be part of this cause that was greater than in itself. Number two, the other thing that was so powerful he knew he wanted to be a writer. He knew what he wanted to do with his writing. If Bob Sherman had wanted to have been an architect, it would have been the “Sherman Brothers Architects Incorporated.” My father would have made beautiful, taste-

ful buildings and my uncle would have showed them off.

He was very focused and very, very clear. And the other thing you’ll find about my father is his integrity.

When you read the book, you realize this is a guy who held truth sacred. Not just in the last thing he ever wrote, but throughout his life. And there are times in this book you read about him and he has done something that is not necessarily the most beautiful thing in the world. He’s not necessarily the nicest guy in the world, so you know he’s telling it as he saw it. It’s not about self-aggrandizement. When you finally do get to the Hollywood chapters at the end of the book, about Disney, about the making of Mary Poppins, readers will find if they really want to know how Mary Poppins was really created, read the book because this book will tell you something. If you read it from the beginning of the book, you will believe the writer. And that’s special.

## WHERE WERE YOU DURING THE NORTHRIDGE EARTHQUAKE?

20 years later, The Weekly looks back

I was living in Santa Clarita with my wife Patty and our two young daughters, Elyse and Cherie. I was working for the City of Santa Clarita as their Deputy City

Manager/Public Services with responsibilities for roadway maintenance, public transportation, and solid waste. We were shaken awake early in the darkness of the early morning and after quickly making sure that my family was safe, our home secure and no threats from gas leaks or structural problems I grabbed my emergency to go kit, kissed my wife and told her I was not sure when I would be home next but I needed to report to work and the City's Emergency Operations Center.

I drove down Bouquet Canyon and quickly determined that it was going to be a very long and challenging series of days ahead. Later that day after helping to activate our EOC and make sure our field operations were staffed and conducting their initial assessments and responses I was able to go up in a Sheriff's Department helicopter to help assess the damage in our community which was major, two collapsed freeways, a leaking aqueduct supplying water to Los Angeles, major damage to local water storage reservoirs and more. This was the beginning of one of the most challenging and yet rewarding experiences in my public service career.

The community of Santa Clarita and its local government worked together to respond to the many emergency response and recovery needs created by the Northridge earthquake. It was a great experience for me professionally to see how well our staff and community volunteers responded over the next several months to the many challenges we faced.

My wife and I were in bed at home on South Oakhurst. We quickly discovered that the kitchen was a mess, tiles and stucco walls were cracked and that we would need


a new chimney. Surprisingly we did not lose a single bottle of wine.

We had minimal damage at home, nothing like the people in the [San Fernando] Valley did. But when I look back at it, this is all I can remember: All these guests that we had standing on the sidewalk in their pajamas.






