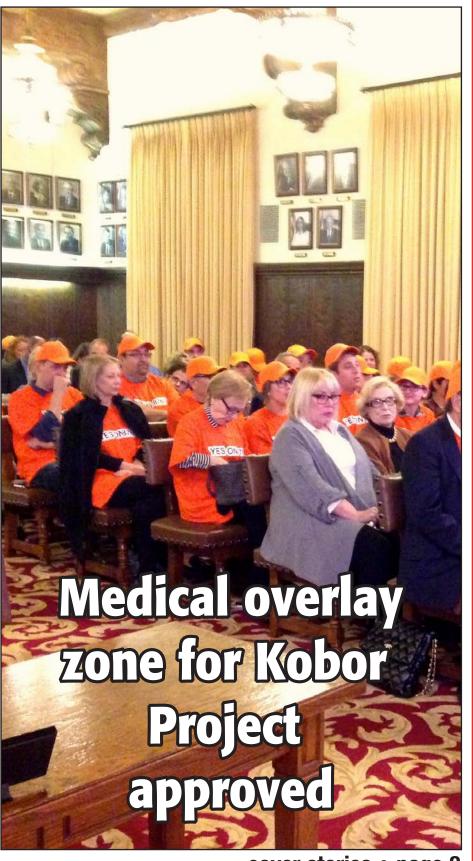

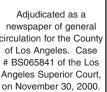

BHUSD to defend former superintendent Gross in Christiansen civil case

Best Best & Krieger has been retained to represent former BHUSD superintendent (2008 – 2010) Jerry Gross in Former Director of planning and facilities Karen Christiansen's lawsuit.

According to Christiansen's attorney Hillel Chodos, Christiansen is suing the school district in two cases. One was filed in 2009 for the termination of her employment in 2005, and was put on hold in pending the outcome of the criminal case. The lawsuit is now resuming seeking \$7 million in damages. The second lawsuit is against various BHUSD board members for pursuing the criminal case. Christiansen was convicted of four conflict of interest charges, which were reversed on appeal in June 2013.

Christiansen named other defendants who were members on the BHUSD Board of Education, including Brian Goldberg, Lisa Korbatov, Myra Demeter and Myra Lurie. However, board members Jake Manaster, Nooshin Meshkaty and Steven Fenton who were also members during the 2008 to 2010 term years, were not named.

"We may add [other board members] but we know those people were actively involved in pressing the criminal case," Chodos said. "We are waiting to see what happens with the motions coming up on Feb. 14. Another half a dozen board members may get added later."

Best Best & Krieger Riverside office partner Piero Dallarda and Associate Trenton Packer will be representing Gross. Dallarda's working rate will be \$384 an hour and Packer will be charging \$288 an hour for their services.

Hill Farrer & Burril, LLP represents the district in the CEQA case against Metro and opposition to the Purple Line extension route. Best Best & Krieger is retained to handle general counsel affairs, such as bond funds and bond projects. Haight, Brown & Bonesteel is retained for oil relations. Hawkins Delafield & Wood LLP is retained for fiscal information. Atkinson, Andelson, Loya, Ruud and Romo is retained for human resource matters. Lozano Smith, LLP is retained for assorted Board projects.

"Remember Black January"

Twenty-four years ago, on the night of January 19-20, 1990, Soviet authorities staged the falling empire's last brutal crime against own citizens. Amidst a popular uprising in Baku, Azerbaijan, 26,000 regular and special Soviet troops with support of tanks, helicopters and navy stormed the city indiscriminately killing unarmed inhabitants. Black January - as it came to be called - was the most violent crackdown on dissent during the Gorbachev's glasnost era. According to the official counts, 137 civilians were killed that night alone, with up to 170 dead and 714 wounded by February 1990. An investigation team led by Human Rights Watch (HRW) found compelling evidence that Soviet troops used unjustified and excessive force resulting in unnecessary civilian casualties. HRW reported that on the night, 1990, heavily armed Soviet troops assaulted the city of Baku as an enemy position intended for military destruction; fired on clearly marked ambulances; used armored vehicles and weapons appropriate

for sophisticated warfare to crush civilians.

Despite the scale of brutality, Black January reinforced Azerbaijanis' determination for freedom. On the third day of the massacre, over 2 million people rallied at the mass funerals of the victims, defying the Soviet military curfew. Within less than two years, in October 1991, Azerbaijan restored its independence. On the 24th anniversary of Black January, I join members of Azerbaijani-American Council (AAC) in requesting a proper recognition of the sacrifices made by Azerbaijani people in their struggle for freedom. Disagreement between Fine Art and Recreation and Parks commissions

Recreational and Park Commissioner Howard Rosoff expressed concerns on Fine Art Commission procedures for selecting art to be placed in parks at the Jan. 16 Fine Art Commission meeting.

"The process should be that if you find a piece that you like and would like to place in a park, before you commit to acquiring it you come to us if whether or not we agree it's an appropriate piece of art for the park," Rosoff said.

Rosoff said this process would prevent a situation where if a fine art piece is approved by the City Council but then rejected by the Recreational and Park Commission later, the Fine Arts Commission would avoid from 'acquiring or committing to acquire' a fine art piece.

Fine Art Commission Vice Chair Sandy Pressman said that the paperwork defining commissioner duties for the recreational and park commission does not entail determining if a fine art piece is 'an appropriate work for the park.'

According to administrative regulations, the Fine Art Commission's duties include recommending public art with its specific location within a city park and advising the Recreation and Parks Commission of the selection 'prior to City Council consideration of the recommendation.' The Recreation and Parks Commission's respon-

sibilities include 'recommending locations within approved city parks for the installation of public art.'

"At some point, there has to be respect and there has to be trust," Fine Arts Commissioner Terri Smooke said. "I have to trust that what's going on in public works is going on in my best interest, [and] I believe that members of other commissions would also have to have respect and trust in the very careful, considered decisions that this commission makes. This is becoming a source of undermining the authority and the position of the Fine Art Commission."

City Councilmember Julian Gold said that if the Fine Arts Commission selected an art piece but the Recreation and Park Commission doesn't think it belongs in the park, the Fine Arts Commission can still acquire the art and place it at a different location other than a park, according to emails exchanged between Rosoff and Gold.

Rosoff said that the Recreation and Parks Commission are concerned that they won't know if the Fine Arts Commission goes to City Council with an art piece to place in the park.

"You received the packet and you've received the pictures," Pressman said. "The piece has not been created. Do your homework before you come."

The Fine Arts Commission can pick whatever art piece they want to pick, but whether or not they place the art in the park is under the jurisdiction of the Recreation and Parks Commission, according to Rossoff.

"We don't need another commission to make sure that it isn't doing something wrong," Smooke said.

Mirisch approves Architectural Commission request to write letters for signage violations

At the Mayor's Cabinet Meeting on Jan. 6, Mayor John Mirisch gave the 'go ahead' for the Architectural Commission to write letters for signage violations.

"Signage to us is a big problem," Architectural Commission James Blakely said. "It negates all the work that we do and all the work that the previous commissioners have done."

Blakely said that the Architectural Commission continues to have problems with signs that have not been approved by the commission. Examples of some signage approvals would be for brightness, placement and size of signs, such as the cases that were presented for approval at the Architectural Commission meeting on Jan. 15 by Rolex, Rite Aid and three other businesses.

"The idea would be if we wrote some letters from the [Architectural Commission] to these violations, then maybe half of them would disappear and enforcement wouldn't have to go out," Blakely said.

Blakely said that he is happy that Mirisch approved the request, who felt that the Architectural Commission did not need formal approval by City Council to write the letters.

"That's honoring the other chairs who've been trying to get something done with signs through three years," Blakely said. "Hopefully we'll work something out and we'll take it one step at a time, see if that helps [or] if it doesn't help. Something had to be done."

Governor Brown's \$10 billion budget in education funding; will it benefit BHUSD?

California Governor Jerry Brown proposed a budget increase in education, providing \$10 billion in funds for K-12 education in his budget proposal on Jan. 9.

Due to a Local Control Funding Formula, local education agencies will receive funding based on the demographic profile of the students they serve. The funds will go towards students who need the most support, specifically English language learners, low income students and foster youth.

"In this district we just don't have a lot of English language learners [and] foster children," BHUSD board member Howard Goldstein said at the Beverly High PTSA meeting on Jan 10.

According to the Legislative Aid Office report released in Dec. 2013, basic aid districts have more funding per pupil, and will continue to receive the same amount of briefs cont. on page 5



Inverted barrier around Kusama's Hymn of Life put on hold at Jan. 21 City Council meeting

The City Council suggested an alternative barrier than the proposed inverted barrier to be installed around Yayoi Kusama's Hymn of Life piece at the Jan 21 study session.

Hymn of Life was selected by the Fine Art Commission and approved by the City Council and was installed in Beverly Gardens Park in 2007. Kusama designed the structural steel and fiberglass tulip sculpture which was created by Ironwood, a Glendale-based company that specializes in purchase displays, museum exhibitions, public artwork and other areas. The cost to create Hymn of Life was \$332,520, and the current estimated value is \$750,000 to \$1 million.

Visitors to the Beverly Gardens Park physically interacted with Kusama's piece by standing on the base and touching and sitting on the leaves of the piece which caused fading, chipping and wear. Cracks appeared at the base of the leaves, which makes it vulnerable from water and would cause rust stains and further cracking.

The Fine Art and Recreation and Parks commissions recommended having an inverted barrier five feet in width, and 30 inches in depth placed around Kusama's Hymn of Life piece on Santa Monica Boulevard in Beverly Gardens Park to protect the artwork from visitor interaction.

The inverted barrier will prevent park patrons from physical contact with the piece, while still maintaining visibility of the entire piece, including its tile base. The construction of the new barrier will be contained within the art piece's borders and will not take up more park space. The cost for the inverted barrier is estimated to be \$75,000 to \$100,000.

Recreational and Parks Chair Robert Anderson suggested a bungee cord and pole barrier that would be placed around the Kusama piece without having an inverted barrier. Fine Arts Commission Chair Fiona Chalom said that an original barrier was suggested that had poles and five wire cords one foot apart to keep individuals from passing through the barrier. Having wire cords would prevent more tresspassers because they would not be able to pull apart the wire. The cost for this barrier would be about \$15,000.

Councilmember Nancy Krasne suggested to have the original barrier, with low plant coverage, instead of the inverted barrier, that would deter visitors from interacting with the art. If this barrier does not work, then the inverted barrier should be placed instead.

The Fine Art Commission and Recreation and Parks Commission will come up with another proposal with the suggestions given by the city councilmembers, that would also maintain the aesthtics of Kusama's piece.

Currently, a temporary post and net barrier is in place which blocks park visitors from coming into physical contact with the piece.

"We are the only basic aid district in L.A. County, [and] our funding stream is significantly different," BHUSD Superintendent Gary Woods, "We have people in our same position, and they are gathering information trying to figure out what it does mean to us and we do not have that answer yet."

According to Goldstein, BHUSD will know what additional revenues will be coming in within the next six weeks to two months.

"I think we're all going to be pleased with what we see and [we'll have] a little bit more flexibility in our budget, which will be a good thing because that would [be] allocated towards our programs," Goldstein said.

Victoria Horton, author of The One You Feed, will visit to The Maple Counseling Center at 12:15 p.m. on Jan. 28.

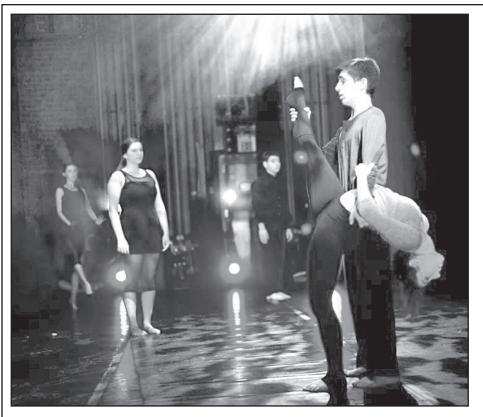

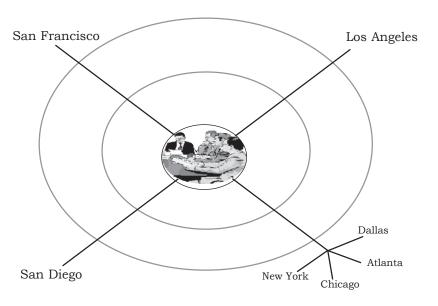
Horace Mann Science Olympiad champs at Muscatel Science Olympiad Competition on Jan. 18

Incoming BHEA (teacher's union) President



Why did you decide to run for BHEA president?

I was encouraged a lot by the current president, Stewart Horowitz, as well as by the former leaders [Mark Frenn and Christopher Bushee], and they were really encouraging in terms of me stepping up [and] leading the organization for the next couple years. Having their encouragement was very helpful.

The other reason includes wanting to build a stronger association in which the representatives from each school feel empowered to represent their school sites [and] to be able to work with me and come up with a consistent way of handling things across the district, in terms of our organization.

It seems like you have a good connection with the other schools.

Yeah, and I think one reason for that is just having been involved in certain aspects of the district, such as the Beginning Teacher Support and Assessment, which gave me an opportunity to work with teachers from the other schools, [and] organizations such as the Extra Pay Committee [and] the Peer Assistance and Review Committee. All of those organizations that I've signed up to do allowed me to work with teachers from other schools and [gave] me the opportunity to work with them so that when I did run, they knew who I was and what I was about.

What are some of your goals for the Beverly Hills Education Association and what will you be doing?

In addition [to] continuing to work for teachers in term of their total compensation and health benefits and just making sure their rights are met, some of the things I will be working on is building a stronger network of said representatives. One thing that this election showed was sometimes the schools have a difficult time getting enough representation. [What] I want to do is make sure that by the time the school year begins, each site has their maximum number of said representatives. In addition to that, making sure they have the training to do their job, making sure they feel empowered to do their job so that when something happens at a school site people know they can go to their said representatives and get assistance from them.

Another goal that I have is making sure that the communication between the schools is stronger. We have a publication that goes out to the entire district that the president is in charge of. I want to make sure that the information [is] relevant and I would share things such as when one teacher is doing something great at one school that we can share that good news with the other schools. [I want to make]

How many members are in the BHEA and who do you represent?

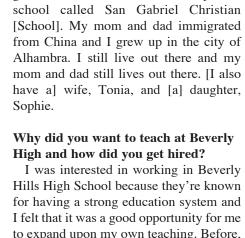
[There are] approximately 350 [members] and I represent the certificated staff, including the teachers and counselors as well as other certificated staff.

coverstory MEDICAL OVERLAY ZONE FOR KOBOR PROJECT APPROVED

After another five hour discussion in front of a packed audience, The City Council narrowly approved the medical overlay zone for the Kobor project at 8767 Wilshire Blvd. at its Jan. 21 formal meeting with a 3-2 vote.

Councilmembers Julian Gold, Nancy Krasne and Willie Brien voted for the project, with Mayor John Mirisch and Vice Mayor Lili Bosse against.

"I don't think the [public concerns] can be addressed," Mirisch said. "[Staff studies] didn't even consider the school children at Horace Mann. They didn't even give us information about the ratio of accidents there. They did nothing there. They were only concerned with their agenda of falling in line with an ex-mayor lobbyist. If something does happen the city should be liable because the city should have responsibility."

Mirisch said he was not able to support any of the findings required for the medical overlay zone.

"Unlike everybody else sitting at this desk, I have no history with this project," Gold said. "I have not touched this building before, so I've had the opportunity to come to it with no prejudice and no emotion, and I've tried to stay that way."

Gold, long seen as the swing vote on the project, included in his comments that two traffic engineers said the traffic would be manageable and he is 'comfortable with the fact that the traffic is manageable.'

With the City Council's majority approv-

al of the medical overlay zone, the pending litigation against the city by the developers will be dropped.

Planning Commission Chair Brian Rosenstein and Vice Chair Howard Fisher spoke at the meeting to answer questions from Bosse regarding a unanimous agreement made at a Nov. 21 Planning Commission meeting that the Kobor project failed to meet the required objectives for the medical zoning overlay.

Former Mayor Tom Levyn, who repreobjected to having Rosenstein and Fisher speak because public testimony was closed at the Jan. 7 meeting and no further public comments could be made. Levyn said that

"I believe that council still has the authority to ask questions to any individuals that they wish to," City Attorney Larry Wiener said. "Depending on whether there is new evidence, then there may be other procedures that may be necessary."

Rosenstein said that according to the Planning Commission's conclusions at the Nov. 21 meeting, the Kobor project "would result in substantial increase in traffic generated by the proposed intensification of land uses, increased handicapped placard parking and on street parking spaces" and "increased traffic on commercial and residential streets related to vehicles circling in search of on street parking."

Recent staff analysis made after the Jan. 7 meeting included daily vehicle trips and peak traffic hours on Robertson Boulevard and studies on the lefthand turn lane going southbound on Robinson into the 8767

> Wilshire property that may create adverse traffic impacts.

According to the agenda report on traffic flow, staff's analysis concluded that the a.m. peak hour would be between 8:00 a.m. and 9:00 a.m., midday peak hour between 2:00 p.m. and 3:00 p.m., and p.m. peak hour between 5:00 p.m. and 6:00 p.m.. At all peak hours of the day, southbound vehicles 'should not have difficulty accessing the project site, nor should they result in Robertson Boulevard or the

medical use would not cause detrimental impacts to existing or anticipated residential or commercial development around the building. Other amendments that needed to be met were that the proposed use will not create an adverse traffic impact or traffic safety hazard to pedestrians and vehicles, including an adverse impact on traffic circulation or parking.

Mirisch said that Horace Mann School was not in session during the dates when the traffic analysis were conducted, and that traffic was possibly less congested compared to when school is in session. Mirisch also said that because an accidental and safety analysis were not included in the report, proper traffic and pedestrian safety considerations could not be made with the traffic studies.

According to the staff agenda report, if the project is occupied to the proposed use at maximum level, an additional 1,280 daily vehicle trips will be made, 620 of those trips coming from medical and general office use. For the 'worst-case scenario' to occur, an auto showroom would occupy the first floor of the building, with a restaurant occupying the second floor, and the medical and general office use on all other available spaces to maximize usage.

Gold asked City Planner Ryan Gohlich if there were any restaurants on the second floor of any building in the city. Gohlich said the staff is not aware of any restaurants that operate on the second floor of any building with the exception of Bouchon Bistro, Fleming's and Mastro's which are split on two levels. Gold, Brien and Krasne agreed that a restaurant on the second floor of a building is highly unlikely and the worst-case scenario is also less likely to

"The biggest positive was supposed to be the restaurant and now we're told that it's uncertain as to whether or not there will be a restaurant," Project opponent and Southeast resident Isabel Hacker said. "There are many unanswered questions and I don't think the council made it clear as to how this project is good for the longevity and for the blossoming of the Wilshire and Robertson

A distraught woman jumped to her death from the Camden Medical Arts building on 414 North Camden Drive Wednesday

At approximately 7:30 a.m., a Beverly Hills Fire Department rescue engine and dispatch went to the location to assist the Beverly Hills Police Department at the scene, according to Fire Chief Ralph

After confirming there was a woman who was possibly attempting to jump, the fire department sent a battalion chief, an engine company and another rescue. Paramedics were in the stairwell to the roof and on the street level in the case the woman fell or jumped.

The incident commander decided to contact the LA City Fire Department to deploy two low pressure airbags that would absorb the impact of the woman. One safety airbag was deployed and they were in the process of deploying the other one when the woman jumped or fell, missing the airbag.

Negotiations with the woman on the rooftop were with the police department, according to Mundell.

She was transported to Cedars-Sinai Hospital at approximately 9:55 a.m. and died at approximately 10:00 a.m..

The woman's name was not available at press time.

For the second time in three years, Beverly High will be represented at the Super Bowl.

Caylin Hauptmann, a 2009 graduate, will be joining his Seattle Seahawks teammates in Super Bowl XLVIII Feb. 2 following their 23-17 victory over the San Francisco 49ers Sunday in the NFC Championship Game.

"SUPER BOWL BOUND!!!"
Hauptmann tweeted Sunday night.
"Today was epic. This win doesn't mean anything without the next though."

The Seahawks signed the 6-foot-3, 300-pound rookie offensive tackle from the Cleveland Browns practice squad Sept. 23 after they placed offensive tackle Russell Okung on the injured reserve/designated to return list because of an injured toe.

Hauptmann has yet to play for Seattle. He was on the active roster for his first two games with the team, but only for the Nov. 10 game at Atlanta since then.

Hauptmann was signed by Cleveland April 30 after being bypassed in the NFL draft following a collegiate career at Florida International.

Hauptmann had survived the cut to the 53-player regular-season limit Aug. 31, but was among four players waived the following day as the Browns reduced their roster by six to make room for six players they had been awarded to on waivers.

Cleveland signed Hauptmann to its practice squad Sept. 2 after he cleared waivers.

Spencer Paysinger became the first alumnus to play in a Super Bowl when he made one tackle on special teams and assisted on a second in the New York Giants 21-17 victory over the New England Patriots in Super Bowl XLVI in 2012.

At least one alumnus played in an NFL Championship Game, the league's title game before the Super Bowl was created in conjunction with the 1966 merger agreement between the NFL and American Football League, Al Barry, a guard in the Giants' losses in 1958 and 1959 games.

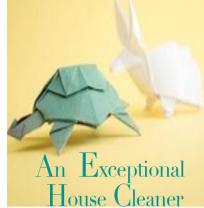

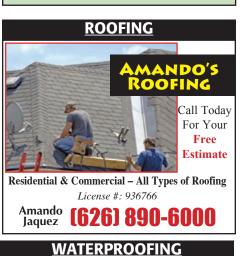
