

Citizens' Oversight Committee: Bond is running out of money

The Citizens' Oversight Committee meeting last Thursday had a contentious start, with COC Chair Woody Clark quieting COC member Mary Weiss during the public comment period. Clark, who set a two-minute time limit for comments at the February 19th meeting, later silenced COC member Craig Davis, repeating "I'm going to ask you to be quiet."

PrimeSource Consulting president and BHUSD Interim Director of Facilities Tim Buresh delivered a presentation which had been shared at a Board of Education Study Session days before outlining the future of the Measure E bond.

The presentation focused on whether the Board of Education should impose a Measure E tax assessment on top of the tax assessment for previous bond measures S (1993) and K (2002), or whether it should first hold a referendum.

"I am very concerned," said COC member Shirley Zaragoza at the untelevised meeting. "The numbers definitely point to the fact that the financing is very weak. We have so much dependence on this referendum passing and we have to be very strong and proactive to understand that the contingency plan really has to be in place because so much effort has been towards creating the wish list, the dream of developing more, with not enough energy on understanding what has been the infrastructure of this bond."

If the Board were to move forward with combined assessment, the pace of work on the construction projects would continue, matching funds would be maximized and the total scope would be maximized, enabling a five-campus program.

Conversely, if the Board waits to hold an election, the pace of work would slow down and the Board would likely lose State Seismic Mitigation Program (SSMP) matching funds, funding a two-campus program.

If the Board chooses not to use a combined assessment, or if the issue fails in the 2016 election, the remaining funds would not be enough to complete much else outside of the Horace Mann construction projects.

The Measure E bond was approved for \$334 million in 2008, supported unanimously by the Board of Education with a 5-0 vote. Current Board of Education President Brian Goldberg was the only Board member serving at the time. In 2013, the Board of Education decided to sell \$45 million bonds. Since then, there has been no action to organize a new bond measure or campaign for acceleration.

Cash flow statements reviewed by the COC depict a \$1.8 million balance outside of the \$78 million set aside to complete Horace Mann. However, the presentation made to the COC by Buresh stipulated that there is a \$13 million shortfall for complet-

ing Horace Mann. Members of the COC asked for clarification.


Buresh and Board of Education Vice President Howard Goldstein explained that the Board had given direction to put \$18 million more into building B, but they did not expect to make use of all the funds. Therefore, they had some flexibility within the scope of the project's budget.

The presentation also mentioned that the current bond could not afford to address seismic and asbestos issues identified originally at Hawthorne.

Later in the meeting, Weiss asked Clark to clarify statements he had made to the Board of Education in November. Clark had claimed that Weiss' letter to the press—in which she voiced her concerns about the use of Measure E funds on MTA litigation—was false and misleading. Weiss reminded Clark that she, too, had addressed the Board and made it clear that she had written the letter independently as a concerned citizen; the letter was not meant to reflect the COC's opinions. Clark later apologized to Weiss for making inaccurate statements, and said he would have his lawyer call her.

Waxman accepts position at K Street firm

Recently retired Congressman Henry Waxman (D-Los Angeles) has accepted a position with Waxman Strategies, a consulting firm owned by Waxman's son Michael. The firm, which focuses on grassroots and communications work, announced the news on Tuesday.

"I'm thrilled at the opportunity to partner with my father and continue his work advancing positive legislative change," the Michael Waxman said in a statement. "His decades of Congressional experience will provide our clients with unique insights and strategies to advance real change in Washington."

Waxman will focus on clients in the environment, energy, technology, health-care and telecommunications sectors.

"I wouldn't want a firm to represent something I didn't agree with," Waxman told The National Law Journal. "There are many special interest groups that I often found myself opposed to in my congressional career."

Waxman told the Weekly in issue #749's cover story: "I will not be a lobbyist, but I am a lawyer, so I might go back to that."

According to the Waxman Strategies website, the firm will "embrace your cause, legislative agenda and policy goals as [their] own."

Port dispute affects Beverly Hills, despite agreement

Although a tentative agreement between employers and dockworkers was reached

last Friday on a new five-year contract that will cover 20,000 workers at 29 ports, the long-running labor dispute, which halted dozens of ships off the ports of Los Angeles and Long Beach, leaving countless containers unopened, continues to impact a large slice of the workforce.

Along with his brothers John and Leon, Beverly Hills resident Yoel Neman runs Neman Brothers & Associates, a prominent textile importer and converter founded in 1981 and based in Downtown LA's Garment District. Neman imports fashion fabrics from China.

"We have been impacted—I must say terribly impacted—for the past

four to five months," Neman said. "We import around 50 to 60 containers each month and some of our containers have been stuck for more than a month." Neman, who had contacted Senators Barbara Boxer and Dianne Feinstein and Governor Jerry Brown about the port dispute, says the monetary loss suffered by his business exceeds \$1 million. Retailers and customers have cancelled orders; demurrage charges are piling up.

"The [International Longshore and Warehouse] Union has held us hostage," Neman said. "I am very disappointed at the federal government for not stepping up."

Around 20,000 dockworkers are represented by the International Longshore and Warehouse Union. Their current contracts pay \$26 to \$41 an hour; members get free healthcare.

"I am furious and I can't do anything," Neman said. "Nobody can do anything."

"I've been connected to Temple Emanuel since 1978 when I

walked in as a precocious 2nd grader to the Temple Emanuel Day School and so my association with the synagogue is 35-something years," Kliger said. "I've been honored to serve as the cantor here for 19 years, since 1996, and this synagogue and its school have provided me with my Jewish foundation and have nurtured me spiritually, personally and professionally."

Kliger, a 1989 Beverly High graduate, will join the clergy team at Temple Judea on July 1.

"I've had a lot of soul searching this past year," Kliger said. "I have to follow the example of the biblical Abraham, who receives a call from God. I'm not saying that I necessarily received a call from God, but I am following Abraham's example when God says to him, "You need to go to this new land that I'm going to show you," and Abraham sort of just follows, not knowing exactly where that is going to take him. I think it's a lesson that we can all learn from."

Temple Emanuel will hold a farewell tribute for Kliger on May 30.

Beverly High counter-protestors

Beverly High counter-protestors outnumber anti-gay Westboro Baptist Church

Six members of Westboro Baptist Church, who picketed Beverly High around 2:30 pm on Monday, were met with dozens of student counter-protestors chanting "We are all gay. We are one race" and waving signs that read "All you need is love" and "God loves you!"

Members of All Saints Church on North Camden Drive also joined the counter-protest.

Beverly High seniors Matthew Sater and Jackson Prince created a sign that read "Welcome WBC: For every 60 seconds you are here, we will donate \$50 to the LGBT charities of our choice...in your name. Stay as long as you like!"

Church members stayed for 30 minutes, bringing the donation total to \$1,500.

According to BHPD Sergeant Max Subin, the police department was in contact with the BHUSD about the picketing in the days leading up to the event. Several BHPD officers, including Chief Dave Snowden and School Liaison Officer Jesse Perez, monitored the protest.

Church members explain their motivation behind the picketing on the Westboro Baptist Church website: "Westboro Baptist Church will picket the sad and rotten, truly good-for-nothing children that matriculate to Beverly Hills High School. Silly rebels think they are children of privilege, but they are children of the filth mongers and pervert pushers, the inventors of evil things."

According to their online picket schedule, the Westboro Baptist Church also picketed the Los Angeles Times, LA Weekly, Hollywood Reporter, KTTV Fox 11 and TMZ on Monday.

"These children at these high schools in this nation go from these classrooms straight to the killing fields of Iraq and Afghanistan or the killing streets of America," said Westboro Baptist Church member and picketer Rachel Hockenbarger. "Their moral compasses have been broken to smithereens by their parents who have taught that God's standards are on the table for them to dispose of as they wish and that you can fornicate, do all manner of sin, and if you happen to get pregnant in that fornication you can kill that baby with impunity. We are here today to tell you that there are standards of God and if you do not obey them that you will face an eternity in hell."

LA candidates oppose Harvard-Westlake parking expansion

Seven out of the nine candidates for Los Angeles City Council, District 4, oppose the building of the Harvard-Westlake parking structure, according to data compiled by the Sherman Oaks Homeowner's Association. The remaining two candidates did not respond.

Incumbent Councilmember Paul Krekorian has not yet taken a position on the project.

"This is obviously a challenging issue for the community," Krekorian said in a statement. "Right now, the project is still in the information gathering phase. Harvard-Westlake is reviewing public comment on the Draft Environmental Impact Report and will have to respond to every comment

submitted."

The LA Council election will take place on March 3.

State Senators Allen, Pan and Asm. Gonzalez introduce Senate Bill 277

State Senators Ben Allen (D-Santa Monica) and Richard Pan (D-Sacramento), and Assemblymember Lorena Gonzalez, who represents San Diego, introduced Senate Bill 277 on February 19 to overturn the personal belief exemption that currently permits parents to opt their child out of vaccines.

"It is easy to forget what it was like before we had broad-based vaccinations and there was a lot of suffering and even death from serious infectious diseases,"

said Allen in a statement. "We cannot risk returning to those days. Parents should not have to live in fear of their child

contracting a potentially fatal disease at school or in the grocery store because of another parent's choice not to vaccinate their child."

SB 277 will require that only children that have been immunized for various diseases, including measles and Pertussis (whooping cough), be admitted to a school

in California. The bill will also require schools to notify parents of immunization rates at their child's school.



A DAY IN THE LIFE OF A BLACK 'N' WHITE

The *Weekly* tags along with Officer Josh Cudworth

FRIDAY, FEBRUARY 20, 2015

5:50 pm

I arrive at the Beverly Hills Police Department a few minutes before the 6:00 pm roll call on a moderately cool Friday night. Pressing the outdoor buzzer, I state my name and the reason behind my visit; the voice on the other end directs me to the third floor and the door opens with a resounding click.

5:55 pm

Lieutenant David Hamel greets me with a smile. Formerly with the Costa Mesa Police Department, Hamel has been with the BHPD for 10 years, starting out as a patrol officer in November 2005. He calls the BHPD a “destination” agency and mentions that very few officers leave the department once they have been admitted. There are around 12 women officers in the department.

6:00 pm

Roll call marks the start of the night shift, which begins at 6:00 pm and ends at 6:30 am. Many of the officers live a long distance away and therefore rely on the on-campus sleeping quarters to recharge before a shift. Lieutenant Hamel takes the stage in a room filled with rows of tables and chairs. Several officers occupy the sparsely decorated space, including Officer Josh Cudworth, the officer who I will be accompanying during the ride-along. A 2009 UC Santa Barbara graduate, Cudworth has been with the department for a year and a half.

6:05 pm

The room darkens as Lieutenant Hamel plays a video depicting a real-life situation where a BHPD officer pulled over a car and decided to approach the suspect from the passenger side of the vehicle as opposed to the driver's side, which is normally practiced. The driver brandished a gun and fired a few shots but failed to injure the officer.

6:10 pm

Lieutenant Hamel takes me on a tour of the premises, beginning with a break room stockpiled with snacks and bottled drinks.

The next stop on the tour is considerably more exciting: a garage that contains SWAT and rescue vehicles. Hamel mentions that the rescue vehicle, which is completely armored, is used to rescue people who are in immediate danger.

6:15 pm

Equipped with several flat-panel computer screens, the dispatch center is next on the tour. I meet dispatcher Erica Maitland, who graduated from the dispatch academy in 2012. Hamel informs me that all 9-1-1 calls come into the dispatch center, which is always staffed. The information is then dispatched to either the police officers or the firefighters; sometimes a circumstance will warrant the involvement of both departments.

6:20 pm

Lieutenant Hamel then walks me through the gym, which is filled with equipment supplied by the Beverly Hills Police Officer's Association. The BHPD provided the space for the gym. Hamel mentions that the officers are encouraged to work out before or after going on duty to help maintain their physical health.

6:25 pm



We arrive at a panel depicting past and recent winners of the “Officer of the Year” and “Officer of the Quarter” awards. I notice a familiar face: Cudworth was named the 2014 Patrol Officer of the Year by the Beverly Hills Police Officer's Association in December. Hamel then provides a quick outline of the rank structure. The highest-ranking officer in the police department is the Chief of Police, followed by the Captain, Lieutenants, Field Training Officers and Officers.

6:30 pm

I meet School Liaison Officer Jesse Perez in the report room, which is equipped with a few computers. “They come in here and they can fill out a complete report,” Hamel says. “We're trying to get to a paperless system, we're not completely there, but we're getting better.” Although the report writing can all be done on the computer, there are still some forms that require signatures for legal purposes; this complicates the route to a completely paperless system.

6:35 pm

The Field Training Office, where new officers are tested before being admitted to the department, sits several feet away. The incoming officers must successfully complete the field training program before being employed by the agency. We talk briefly about the oral exam portion of the interview process, which is notoriously competitive, with an 87% failure rate. Hamel mentions that the thorough screening process prevents future problems.

6:40 pm

Officer Cudworth continues the second half of the tour and our first stop is a large room filled with rows and rows of computers. According to Cudworth, during a significant emergency, employees from the fire, police, public works and traffic control departments occupy the room and broadcast details of the crisis—whether it be a burning building or a fallen tree—to police officers.

6:45 pm

We arrive next at the evidence room, a

compact space fitted with tiny cubicles and drawers. Everything from drugs to weapons is locked away in this room, including blood vials, which are stored in a separate compartment. We then reach the detective station, an expansive room that accommodates around 30 detectives.

6:50 pm

I meet Senior Records Specialist Sonya Bryant and Records Specialist Tiffany Harris, who work in the records bureau. “Their job is to bring in all the reports, as far as tying them all together,” Cudworth says. After signing the ride-along waiver form, I slip off my jean jacket and get into a boxy bulletproof vest.

6:55 pm

Well-lit and expansive, the jail is next on our stop. We walk past a padded cell, which is completely padded so that inmates cannot hurt themselves. The normal cells contain a toilet and a basic bed. The jail is always staffed, Cudworth tells me, and there is always a minimum of two jail officers in the jail.

7:00 pm

Back in the roll-call room, Cudworth explains the logic behind the numbers that officers are assigned before going on duty. (Cudworth has been assigned to 4 Lincoln 92). The first number is either a two, which signifies a day watch, or a four, which stands for a night watch. The City is divided into different beats: beats 4, 5, 6, 7 and 9. The second number represents the beat that the officer has been assigned to. Cudworth's beat partner for the night is Officer Alex Duncan, who recently received the Allen H. Karlin Memorial Award.

7:05 pm

On our way to the garage, Cudworth informs me that the patrol vehicles are parked on level A and the undercover and detective cars are parked on level B. Level C houses a shooting range. Cudworth's patrol vehicle for the night is a Lincoln. Bicycles, which are used by the bicycle cops during the day, and motorcycles, which are utilized by the traffic division, are parked nearby. The sergeants drive Tahoes.

7:10 pm

The Lincoln is outfitted with a radio, computer, cameras and spotlights. Cudworth mentions that the cameras are constantly recording and activation of the spotlights initiates the storing process. A separate camera keeps watch over the back seat passenger, in case the arrested individual begins acting belligerent. Cudworth informs me that the backseat is made of hard plastic to prevent suspects from hiding incriminating evidence between or underneath the seats.

7:20 pm

As the Lincoln pulls into the street, Cudworth points out the Automatic License Plate Reader, or ALPR. Three cameras installed at the top of the car read license

plates and inform the officer if there is a warrant on the car or if the car is a stolen vehicle.

7:50 pm

We turn left on Gregory Way and pass La Cienega Park. Cudworth tells me that later in the night he will walk through the park and patrol the area.

8:20 pm

Cudworth decides to join his beat partner, Officer Alex Duncan, who has identified a traffic violation. We reach a parking lot behind a tanning salon, where the vehicle in question is parked; Duncan is speaking with the owner. We soon learn that the car has not been registered in over three years.

Cudworth tells me that if a car's registration has been expired for more than six months in California, it can be towed. The vehicle owner also gets ticketed because his car is expired.

8:30 pm

Cudworth and I leave the scene soon after the tow truck arrives.

8:40 pm

Dispatch notifies Cudworth of a call made about a parked black van with a scrolling marquee advertising liquor. We circle the area for around five minutes but are unable to find the vehicle. The incident is labeled GOA, or "Gone On Arrival."

8:50 pm

I learn that Cudworth's father works as a training coordinator for the LAPD, which oversees around 10,000 officers. Comparatively, the BHPD represents around 120 sworn officers.

9:10 pm


Cudworth spots a transient breaking a municipal code by drinking an alcoholic beverage from a brown paper bag. He is standing near the newly opened Crème de le Crepe on West Olympic Boulevard. Seconds before being approached by Cudworth, the individual tosses the alcoholic beverage into a nearby planter and then denies that he had been drinking. Cudworth issues a citation.

9:40 pm

Cudworth responds to a call made by a resident on Clifton Way who believes her Amazon Prime package was stolen from her doorstep. The package contained \$75 of merchandise. Duncan arrives on the scene, and together the two officers survey the area. Cudworth files a report.

10:40 pm

We arrive back at the police station and I thank Cudworth for letting me tag along with him on his shift. He resumes the rest of his shift accompanied by Duncan. For me, the evening was notably eventful. But for the BHPD, it was just another night on the beat.

measure that can sustain all long-term construction goals.

"After several quite laborious study sessions it has been made quite clear that no matter what direction this Board takes in relation to accessing our total available capacity of our taxes, the [BHUSD] will not have enough funds to complete all of the planned projects for all of our sites," Margo said. "What we were also told is that there will not be enough funds to complete the current high school in its entirety; all of this making a new bond measure necessary regardless of the case."

The work planned for El Rodeo has proven more costly than originally expected due to a large quantity of inspections and tests of samples from concrete walls, concrete footings, steel framing, metal decking, wood framing and masonry walls.



ORDINANCE NO. 15-O-2674

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO ESTABLISH A WATER CAPACITY CHARGE

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES ORDAIN AS FOLLOWS:

Section 1. The City Council of the City of Beverly Hills hereby finds as follows:

(a) Each new connection to the City's water system creates a demand for additional water and additional capacity in the water system.

(c) The City Council wishes to establish a charge for the cost of water facilities in existence and for new water facilities to be acquired or constructed that are of proportional benefit to the person being charged.

(d) The City Council commissioned a study (the "Study") by Raffelis Financial Consultants, Inc., dated December 22, 2014, to calculate such charge in an amount that reflects the proportional costs to serve a new or expanded connection to the water system.

(e) On this date, the City Council conducted a public hearing on the proposed water capacity charge.

Section 2. The City Council hereby amends the Municipal Code of the City of Beverly Hills by adding Article 2.5 to Chapter 1 (City Utility Services) of Title 6 (Utilities and Franchises) to read as follows:

"Article 2.5. Water Capacity Charge

6-1-250: Purpose:

The purpose of this article is to establish a water capacity charge for the cost of water facilities in existence and for new water facilities to be acquired or constructed that are of proportional benefit to the person being charged, including supply or capacity contracts for rights or entitlements, real property interests, and entitlements and other rights of the City involving capital expense relating to its use of existing or new water facilities.

6-1-251: Establishment of a Water Capacity Charge:

The user of city water service shall pay a water capacity charge in an amount established by resolution of the city council. The water capacity charge is due upon the occurrence of one of the following events, as deemed appropriate by the Director of Public Works Services, or his or her designee: (1) installation of a new water meter, (2) change in the size of a water meter, or (3) the final inspection of a project.

6-1-252: Project and Floor Area Defined:

(a) For the purposes of this Article, "project" means the construction or addition of "floor area" which requires a building permit. "Project" also shall mean any change of use of property, which requires a larger water meter and a building permit.

(b) For the purposes of this Article, "floor area" shall mean the following:
A. Nonresidential and multi-family residential zones: "Floor area" shall mean the area of all

floors or levels included within the surrounding walls of a building or structure. Space devoted only to the following shall not be considered in determining the total floor area within a building or structure:

1. Stair shafts;
2. Elevator and escalator shafts and elevator lobbies located in parking areas or on rooftops. The area of each elevator lobby at each floor shall not exceed one hundred (100) square feet per elevator cab; provided, however, that any elevator lobby area in excess of one hundred (100) square feet per elevator cab shall be considered in determining the total floor area within a building or structure;
3. Courts;
4. Parking spaces below the first floor and access thereto, including void spaces in parking areas below the first floor used exclusively for storage related to operation of the building. Such void spaces may be enclosed and shall not exceed two thousand (2,000) square feet on each parking floor or five percent (5%) of the floor area of the entire building, whichever is less;
5. Rooms exclusively housing building operating equipment or machinery;
6. Parking spaces at or above the first story and access thereto provided that in commercial zones:
 - a. Not less than the front forty feet (40') of the ground floor shall be devoted to retail sales, offices, or financial uses; notwithstanding such restriction, the director of planning and community development may reduce the amount of floor area required under this provision by up to ten percent (10%) pursuant to the provisions of article 36 of this chapter regarding minor accommodations if the director finds that the dimensions of the site do not pro-

vide adequate space for internal circulation for parking and such accommodation would not substantially compromise pedestrian activity in the area; and

- b. At least one full level of parking below grade is provided;
7. Mall areas; and
8. Space used or provided within a building or structure for publicly owned off street parking facilities.

B. Single-family residential zone: "Floor area" shall mean the area of all portions of floors and levels, including basements, which have a roof or floor level above and are enclosed by exterior walls by more than fifty percent (50%). Further, "floor area" shall include the area of that portion of an upper level not separated from a lower level by a floor/ceiling assembly, but shall not include crawl spaces and up to four hundred (400) square feet of garage area.

6-1-253: Collection of Water Capacity Charge: The city may collect the water capacity charge from the water user with a bill for water service charges, or by delivering a separate bill for the water capacity charge. The City may collect the water capacity charge in two or more installments. The city council may provide, by resolution, for an alternative procedure for collection of the water capacity charge.

6-1-254: Establishment of Special Fund for Charge:

Pursuant to Government Code section 66013, there is hereby established a special fund entitled the "water capital facilities fund." The city shall place the revenues from the water capacity charge into the water capital facilities fund to be used solely for the purposes established by this article.

6-1-255: Annual Report:

The city shall annually provide the information required by Government Code section 66013, as such law may be amended from time to time, in the manner provided by such law.

6-1-256: Adjustments:

A person may apply to the Director of Public Works Services or his/her designee for an adjustment to the water capacity charge for a project based upon facts that show the person previously paid a water capacity charge in an amount that reflects the proportional costs to serve the new or expanded connection to the water system for the property."

Section 3. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage, in accordance with Section 36933 of the Government Code; shall certify to the adoption of this Ordinance and shall cause this ordinance and her certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.
