## Council condemns anonymous hit piece; considers adopting local election regulations

In light of the anonymous hit piece delivered as a door hanger October 8, the City Council gave direction to adopt local election regulations for campaign advertising at Tuesday's study session.

### A Proposition 65 Public Notice

The California Safe Drinking Water and Toxic Enforcement Act requires California businesses to advise employees and neighbors of any potential exposure to chemicals considered by the state to cause cancer, birth defects, or other reproductive harm.

Veolia Energy Los Angeles, Inc. wants you to know that detectable amounts of some of these substances may be found in and around its facility located at 2052 Century Park East, Los Angeles, CA. Potential sources of these substances can include common products such as gasoline, oil, natural gas, paint.

Vice Mayor John Mirisch, who has filed a police report against the unknown perpetrator, said that penalties "should have teeth."

"I think the max we can do is six months in jail and [a] \$1,000 [fine]," Mirisch said.

According to the October 20th staff report, under the state's Political Reform Act (PRA), the City, as a local government agency, is permitted to adopt local regulations as long as those regulations do not conflict with those set forth in the PRA.

"At the end of the day, we've got to have some rules," Councilmember Willie Brien said. "When people are sending things out with no attachment to any name, that's just fundamentally wrong. I think it violates the FPPC rules."

As a result of Tuesday's discussion, the City Attorney's office will now complete additional analysis and draft an ordinance for the Council's consideration.

"It's the worst of the worst," said Mayor Julian Gold of the hit piece. "And to not sign your name to it is an act of cowardice."

The Council would have jurisdiction over municipal elections, but not Board of Education elections, which are run by the County.

### "Superintendent house" still on market after five months

The BHUSD-owned residence located at 220 North Doheny Drive has sat vacant since former Superintendent Gary Woods moved out in May.

In August, Board of Education member Lisa Korbатов reported that the house is being listed for "a touch under \$9,000 [per month]." The rental amount has been lowered to \$7,500 per month.

Coldwell Banker realtor Michael Libow, who represented the district in the \$1.5-million purchase of the property, is also representing the district in the lease.

### Measure E bond issuance costs exceed \$6 million

Minutes from the BHUSD Finance Committee's August 27th meeting indicate that the district may not have been entirely transparent about the second Measure E bond sale.

Committee members asked Chief Administrative Officer La Tanya Kirk-Carter why a \$76 million cap was referenced when the district "really sold \$82.6 million worth of bonds?"

The Finance Committee later mentioned that they "do not believe that the amounts of the bond were communicated and presented clearly to the community."

But according to Kirk-Carter, the additional \$6.6 million covered the costs of issuing the bond.

"It has to do with all the costs of financing," Kirk-Carter said. "You [have to] pay the underwriter, the loan people, the title company, the insurance; so all the costs of selling the bond were paid out of the bond."

The Board of Education accelerated the Measure E bond with a 3-2 vote at their June 18th meeting.

### Hit piece ignites discussion on anonymous political speech laws

The anonymous hit piece delivered as a door hanger October 8, which attacked Board of Education candidates Isabel Hacker and Mel Spitz, spotlights the state's anonymous political speech laws.

In an October 16th article about the door hanger, the *Beverly Hills Courier* referenced *McIntyre v. Ohio Elections Commission*, a 1995 Supreme Court case in which the Court maintained that an Ohio statute prohibiting anonymous political or campaign literature is unconstitutional.

But McIntyre represented a narrow exception to the idea that disclosure laws are constitutional and do not violate the First Amendment, says UCI Law Professor Rick Hasen.

"In narrow circumstances, as where a person faces the risk of harassment, they might get an exemption from disclosure," Hasen wrote in an email. "But otherwise, generally applicable campaign finance disclosure rules are constitutional."

In the 20 years since McIntyre, the Supreme Court has repeatedly upheld disclosure rules against challenge; examples include *Doe v. Reed* and *McConnell v. FEC*.

"Since McIntyre, the Supreme Court has continually reaffirmed the ability of governments to require disclosure of campaign finance information and repeatedly turned back attempts to rely on McIntyre for a right to anonymity," Hasen wrote.

## BHUSD experiences security breach

Jupiter Ed, the web-based grade book used by BHUSD students and parents, experienced a security breach on October 8, causing passwords and usernames to be posted online for a few hours.

In an email the next day, Chief Academic Officer Jennifer Tedford and Technology Director Bernadette Lucas advised parents and students to reset their passwords, calling it a “data security measure.”

Unauthorized users may have accessed email addresses, telephone numbers and student grades by logging in with a username, password and school.

According to the email, the breach affected other districts as well, not just the BHUSD.

## Cultural Heritage considers landmark proceedings for former Kate Mantilini building

Kate Mantilini’s iconic Beverly Hills location has been vacant since the restaurant shuttered in June 2014.

At their meeting October 14, Cultural Heritage commissioners deliberated landmark proceedings for the building known as Gibraltar Square/Kate Mantilini, continuing a process that dates back more than a year.

After completing a full review of the property, the City’s historic consultant, Jan Ostashay of Ostashay & Associates Consulting,

had concluded that the building is eligible for landmark status.

The review found the building eligible under “significant” criterion: it was designed by William Pereira and Charles Luckman, both who appear on the City’s list of Master Architects.

But the Commission tabled decision making to a later date, following a rather contentious exchange with property owner Arman Gabbay and his representative Stacey Brenner.

Brenner was supposed to have reviewed the building’s list of “character-defining features” with staff, which she did not do.

“For whatever reason, what we’ve asked for the last two times that we’ve continued this hasn’t happened,” said Commissioner Noah Furie. “I recognize the concerns that

## Hawthorne edges BHHS football team

The Beverly High football team had its first fourth-quarter lead of the season Friday night, but fell victim to Hawthorne's comeback in a 42-35 loss in an Ocean League game at Hawthorne.

Michael Revah returned a blocked field goal attempt 75 yards for a touchdown in the fourth quarter, increasing the Normans' lead to 35-27. The Cougars (2-5, 2-0 in league play) took a 42-35 lead with about three minutes to play.

Beverly Hills had a fourth-and-six play on Hawthorne's 25-yard line when Solomon Nwankwo caught a pass from Jake Wolken and was stopped "two chain lengths" short of a first down, Norman coach Charlie Stansbury said.

"It was one of the more heartbreaking things to see," Stansbury said.

The loss matched the narrowest among the 26 defeats Beverly Hills has had in Stansbury's 27 games as coach and the 35 points matched the highest scoring total.

"I told the team.... that I don't know if I've ever been more proud of them and more heartbroken for them at the same time," Stansbury said.

"Some of the kids, win or lose, that was probably the most fun they've had playing football because it was extremely competitive. We made plays when we had the chance to make plays and that's what we were all most proud of, but at the same time its heartbreaking and frustrating when little, tiny mistakes become big mistakes and you come up short two chain lengths with a chance to go in and score."

The Normans (0-7, 0-2) trailed 21-7. They cut the deficit to 27-21 when Luc Mendez recovered a center snap in the end zone that had gone off the hand of the Cougar quarterback as time expired at the end of the first half.

Rashad Ysaguirre ran 17 yards for a touchdown in the third quarter that gave Beverly Hills a 28-27 lead.

"For us to be down by 14 and come back and take the lead, there's not a lot of teams in our situation that are able to keep preserving and get to that point," Stansbury said.

With Ysaguirre's action limited because of an ankle injury sustained a week earlier, Joe Kolko got the bulk of the carries for the Normans, rushing for 193 yards and two touchdowns on 24 carries.

Wolken completed six of 16 passes for 93 yards, with Nwankwo making five catches for 88 yards.

Stansbury praised his team's offensive line for enabling Kolko to rush for 193 yards.

The Normans are scheduled to play at Lawndale Friday. The opening kickoff is set for 7 p.m.

The Cardinals (6-1, 2-0) have won six consecutive games since a 33-21 loss to South Torrance to open the season.

Lawndale has scored at least 48 points in each of its last four games and recorded shutouts in three of its past four games, including a 62-0 victory over Santa Monica on Friday.

"We want to start fast" on offense, Stansbury said. "They have some explosive players on both sides of the ball. They have a lot of options to go to on offense."

The Cardinals were ranked sixth in the Southern Section Western Division poll released on Monday.

The high school football website Calpreps projects a 52-6 Lawndale victory. It had projected Hawthorne would defeat Beverly Hills 24-22.

# people & profiles

## Katherine Spillar

Feminist Majority Executive Director

### Tell us about your career leading up to the Feminist Majority.

I helped found the Feminist Majority and this summer we turned 28 years old. We wanted to be able to organize differently; instead of by chapters, we wanted to organize around projects and we wanted to help grow the movement. That was at the beginning of the backlash against the progress that we had made. Ronald Reagan was president during the 1980's, followed by the first Bush, and the progress for women's rights had slowed. There was a tremendous backlash and we felt that by starting the Feminist Majority we could help grow the movement and help focus on certain aspects of the work that needed to be done. That was the beginning of the organization. We're a national organization: we have offices here [in Beverly Hills] and the Washington D.C. area. The Feminist Majority is our political and action arm and we also have the Feminist Majority Foundation, which is our educational arm. The Feminist Majority Foundation publishes *Ms.* magazine.

Before that, I was the president of Los Angeles NOW—the National Organization for Women. I had been working for a statewide trade association doing housing policy research and analysis.

### What does your role as Executive Director entail?

I help lead our programs overall, but I'm responsible for our programs in our West Coast office. We have programs for girls and boys in high schools [so that they can] learn about girl's human rights all over the world and to learn to be activists. We also have a nationwide program in colleges. We have a lot of programs based out of here and my job is to keep making them stronger and reaching more people.

### Tell us about the Feminist Majority's event on Thursday (see page 2).

It was to introduce our donors and supporters in the Greater Los Angeles area to some of the key Congressional and Senate races. We'll have a series of these. We work to support feminists running for federal office for the House and for the Senate and we want to introduce our supporters here, in Southern California, to some of these great candidates. Of course, looking forward to next year, [we want] to support efforts to make sure that the Senate



has a majority of members that support women's rights issues. We would like to see Democratic women elected to the U.S. Senate, as well as Democratic men who support women's rights.

### You are also Executive Editor of *Ms.* magazine, which has increased its investigative reporting under your oversight. What has been the most groundbreaking story of the year so far?

One of the biggest stories of this period is how outspoken prominent women in the entertainment industry have become for women's rights. Outspoken on issues of pay inequality, the need for finally ratifying the Equal Rights Amendment in the Constitution so that women are in the Constitution and proudly proclaiming that they are feminists—it's really just unprecedented. We took the name Feminist Majority 28 years ago because a *Newsweek* poll at the time asked women who responded to the poll if they considered themselves to be feminist. Counter to what the popular understanding was at the time, 56 percent of American women self identified as feminists. It was counter to what everyone thought, because feminists had been painted with such a negative image. If you ask about equal pay, reproductive rights, full equality, the numbers are off the charts. There's really hardly anybody who says they're not for equality for women and girls. But the popular understanding at the time when we started the organization was that feminists are very unpopular. Well, look what's happened today: despite the backlash, despite the efforts by Congress and the state legislatures to cut back on abortion access, on access to birth control, to make fun of feminists, here you have some of the biggest women in entertainment in the country talking about how they are feminists. You've got Taylor Swift

[and] Beyonce; you have Meryl Streep, who proudly said she's a feminist. I think it's a big, big story. I think it's a breakthrough, but we still need breakthroughs in workplace policies for women. There isn't paid family medical leave, so many women find it very difficult to hold a job and have a family—

they struggle because we don't have paid family medical leave. We don't have full legal equality, so there are many instances when women are still discriminated against and don't have full recourse. Violence against women is still a big problem: one in five college students, mostly young women, will be sexually assaulted while at school, and domestic violence is still very high. So there are still many ways that women are not treated equally, and yet we've hit, I think, a real period where you're going to see more and more women say they just can't take it anymore. They want full equality in political representation, too. We're only at 20 percent of the United States Congress—we're nowhere near the 50 percent that we represent of the American population.

### How long has the Feminist Majority been based in Beverly Hills?

Thirteen or fourteen years. Before, it was on 3rd street at Crescent Heights, so it was in West L.A. We moved here because the Chair of our Board decided to buy the building and to renovate it so that we would have a place for feminists in Los Angeles to gather and have meetings, events and conferences, and [so we could have] a work place for the Feminist Majority and its programs. It really is a community center for progressive organizations that are working for women's rights and civil rights and human rights.

### Tell us about your organization's upcoming events.

The Feminist Majority has an event in Los Angeles scheduled for December 3rd that is called "Vote Feminist 2016." It's going to feature Feminist Majority president Eleanor Smeal, former CNN White House correspondent Jessica

Yellin and Dolores Huerta, who was the co-founder of the United Farm Workers. There are others that will be announced soon. It's an event to mobilize the feminist vote and stop the war on women.

We're always looking for people to volunteer. The women's rights movement needs the ideas and the energy of its many, many supporters. There are all kinds of ways that people can become involved with us as volunteers and as supporters, so we're always anxious to talk to people who want to learn more about what we do and become involved.

### What is the greatest challenge of helping a feminist organization?

We have an incredible amount of support among the public, but we run into such roadblocks in the Congress and in some of the courts where women are still very under-represented. And our issues, especially issues of abortion rights and birth control, have become the focus of our opposition.

They've become politicized, and these are issues that should never be politicized. But because they've been politicized, we're constantly having to fight for our most fundamental rights, even though the vast majority of people—women and men—support fundamental human rights for women. And people are overwhelmingly opposed to violence against women. Our issues have such popular support but we have such a backlash right now in Congress and in some of the state legislatures—not California, but Texas, Virginia and much of the South. It's where anti-women's rights and Republican leaders dominate. We are losing ground on women's and girl's rights and we need more people to step forward and help us make this fight. That's the hardest thing, but the good news is that we have such support.

## DOG PARK STILL NOT RESOLVED

Five-hour meeting ends without a vote

In recent months, the dog park proposed for the industrial area has received widespread community attention, inspiring both supporters and opponents to air their opinions through many different forums.

Tuesday's City Council meeting continued until 12:25 a.m., fueled by a public comment period that featured more than 50 speakers.

Rabbi Pini Dunner outlined his opposition to a park at the proposed location, saying the "[pro-dog] campaign has

perhaps overwhelmed by the countless unanswered questions that the public comment period seemed to have generated.

The park's hours of operation is one of many details the Council has yet to finalize.

"I'm okay with dawn to dusk, but why anybody would want to be at a dog park at 9 o'clock at night, I don't know," Gold said.

The Council has already approved \$400,000 for the park's construction,

staff report, a "basic" dog park involves retaining the existing walls at the site and providing one to two benches, a drinking fountain and a doggie-bag dispenser in both the large and small dog areas.

The Recreation & Parks Commission unanimously voted to recommend decomposed granite as the surface material. Two double-gated entrances—one for each area—are also included in the plans.

Once the Council carries out a vote, staff will begin the process of securing an architect to design the park in accordance with the direction given by Council.

"Should the bids come in beyond what funds exist, which can happen, staff can typically scale back in certain areas to bring it within the allocated funds," Zoet said.

The Recreation & Parks Commission recommended that the park be restricted

At their next meeting, the Council is expected to vote on the Recreation & Parks Commission's recommendation for a park capacity of 20 large dogs and 20 small dogs. The Commission had also proposed that no more than three dogs be permitted per person. Santa Monica currently allows four dogs per person.

Community members who oppose the dog park often cite safety issues, expressing fear that their children will run into the street if they cross paths with a dog. The estimated cost of carving out a walking path to separate dogs and their owners from other residents ranges from \$40,000 to \$50,000.

A landscape plan that involves adding 12-14 new trees will cost around \$25,000, the staff report says. Additional costs stem from installing CCTV cameras (\$17,000-\$20,000);

resulted, in this room tonight, in open anti-Semitism."

Planning Commission Chair Alan Robert Block, who expressed his support for the park, said he believes the synagogues' concerns are unfounded.

"I've never seen 20 dogs at a dog park at the same time, much less 40," Block said.

By the time Mayor Julian Gold adjourned the meeting, Councilmembers Willie Brien and Nancy Krasne had left,

which City staff believes is sufficient to fund a "functional park" at the proposed location, Community Services Director Steve Zoet said at a Council meeting in August.

"Based on some very preliminary assessments it is believed that the City can design and build a basic, functional dog park within the funds that have been allocated," Zoet wrote in an email earlier this week.

As outlined in the October 20th Council

to Beverly Hills residents, provided that park users show a current license and obtain a permit and tag.

The City of Santa Monica's Herb Katz, Memorial Park and Pacific Street dog parks are restricted to residents. Non-resident use of the city's Airport dog park requires an annual permit.

Beverly Hills currently utilizes controlled access technologies within many buildings. Cost estimates for the keycard system being considered for the dog park range from \$15,000 to \$20,000.

LED lamps and poles (\$10,000-\$15,000); shade structures (\$50,000 to \$75,000) and replacing a chain-link fence with a cinder-block wall (\$16,000 to \$22,000).

The process of bringing a dog park to the City dates back to February 2010, when then-Councilmember John Mirisch requested that the Recreation & Parks Commission explore the possibility.

The Council will revisit the dog park at their next regularly scheduled meeting on November 3.

### Planning Commission orders "major overhaul" of North Oakhurst project

The 31-unit condominium building proposed for 332-336 North Oakhurst Drive was not met favorably by the Planning Commission at their meeting October 8. The Commission voted unanimously to table the project to a later date.

The project is split between Beverly Hills and Los Angeles, with 28 percent of the property located in Beverly Hills and 72 percent of the property located in Los Angeles.

"It's not an appropriate project for the area—the scale, the massing," said Commissioner Lori Green Gordon. "And the traffic and parking are two things that concern me greatly."

Reading from the City's General Plan, Commissioner Craig Corman pointed out that "the importance of scale must be underscored."

Corman mentioned that the four-story condominium project would clash with the "predominately two-story buildings elsewhere on the block."

Spanning three lots, the proposed building would also be much longer than neigh-

boring properties, which typically occupy one lot.

Corman and Vice Chair Joe Shooshani were assigned to an ad-hoc committee so that they can work with the applicant on a revised project design.

The development was originally proposed in 2011 as a 37-unit building.


