Water Rates and the penalty charges

On a bill of \$1,900.24, the penalties associated with that bill were as follows: \$8,830.56 the second penalty surcharge, level 2, was \$13,796.16, which we as citizens of the great City of Beverly Hills found to be an extremely high. Over a six-day period of research, I discovered that a home of 2,000 to 2,500 square feet is allowed 48 units of water. Our building has condos that are all the same size—3,000 square feet—we are 24 units. If you were to take 48 times 24, the amount of units of water to be allotted is 1,152 units. We then reduce that by one third, it then comes to the amount of 806.40 units of water. If you look at the actual usage of 758 units of water, we are well under the allotted amount.

If I used what the City says for the billing period—352 units of water—and I divided that by the 24 units in our building, that means we only get 14.67 units [of water] per a two-month period of time. If I then did that by the gallons we

were to receive for the two months, which comes to 10,973.16, and divided that by 60 days, it comes out to 182.89 gallons per day. If you do one load of laundry in your home for that day you are done for the day in water—there is no way you can live like that in this lifetime, the numbers just seem to me to be wrong from the city point of view. This then becomes a quality of life issue.

I don't want live this way where every time I turn around we are getting out of this world fines and the allotment of water seems to be too small for the size of the homes—and make no mistake, these are homes. Although you may call them condos, we pay property taxes, just like a home, and we pay all the other utility bills, just like a home. The only general bills get paid out of a general fund, such as water and common-area electric bills and gas and other maintenance contract bills that belong to the building as a whole. The biggest problem is there is no way to place a separate meter on each condo. When the building was made in the 1970s and 80s, the cost is quite larger in the millions because it requires a redo of the plumbing and how it was designed. I discovered this because I looked into this with several plumbing companies—this has become a big problem for older buildings.

Council to review Planning's CUP determination

The Planning Commission's decision last month to grant Jim Falk Lexus access to a vehicle service facility on Olympic Boulevard currently being used by Infiniti was called up by Vice Mayor John Mirisch at the City Council meeting Tuesday.

"This is not about a concentration of auto activity in the area," Mirisch said. "I've asked this to be brought up for two specific reasons: one, before any CUP [conditional use permit] is granted, I feel that there needs to be made clear what the penalties will be if the CUP conditions are violated."

Mirisch, the only councilmember who lives in the southeast part of the city, said his second concern was that Lexus may move its sales division "out of town."

"How can we ensure, before we're granting CUPs, that in fact, the sales will remain in Beverly Hills?" Mirisch said.

Jim Falk Lexus plans on taking over the property located at 9031 Olympic Boulevard, in addition to two other Infiniti-owned parcels along the major thoroughfare.

"In my mind, the question is: Would you want another 17 years—because that's how long the lease is—of Infiniti, or do you want Lexus?" said attorney and former Mayor Tom Levyn, who represents Lexus.

Infiniti has 17 years left on a 20-year lease.

Late last year, a group of southeast residents filed numerous declarations under penalty of perjury against the dealership following several violations, from speeding cars to noise disturbances to allegations of harassment by Infiniti employees.

The Commission greenlit the undertaking through its unanimous approval of an amendment to an existing conditional use permit (CUP). With Councilmember Willie Brien dissenting, the Council voted 4-1 to review the Commission's determination of the CUP.

The Council must order a review within 30 days of the Planning Commission's approval, which occurred on December 10. As a review was requested, the Commission's action will be suspended until the Council's assessment is final.

Councils OKs preparation of EIR for condo project

A multi-family condominium project being proposed for 9908 South Santa Monica Boulevard received push-back from Vice Mayor John Mirisch at Tuesday's City Council meeting.

The site is zoned for commercial use, meaning the new development would not conform to current zone requirements and standards.

Additionally, the proposed project, which contains 27 units and stands five stories tall, would require the Council

to authorize circumvention of the city's three-story height requirement for residential properties.

"There is a reason why we have a three-story height requirement," Mirisch said.

Councilmember Lili Bosse mentioned that the city cannot make predetermined assessments on the project without completion of an environmental impact report, or EIR.

But Bosse later clarified that support for the EIR does not equate to support for the development.

With a 4-1 vote, the Council approved an agreement between the city and environmental firm Rincon Consultants for preparation of the environmental report, a \$87,290 contract that will be paid for by the project applicant.

"Converting business space into residential space is a hard sell, but nonetheless, it's the landowner who wants to spend their money doing the EIR," said Councilmember Willie Brien.

On their website, GPI Companies, a real estate investment and development firm based in Los Angeles, describes the site as a "36,000-square-foot parcel along Beverly Hills' emerging Billionaires' Row."

Passed into law in 1970, the California Environmental Quality Act (CEQA) requires state and local agencies to provide information about a project's environmental effect through completion of an EIR.

"Next Gen Leaders" converted into formal Council committee

Mayor Julian Gold fashioned the Committee of Next Generation Leaders last spring, in an effort "to move Beverly Hills forward into the future," according to Marketing and Economic Sustainability Manager Megan Roach.

Since its inception, the group, comprised of 21 residents aged 25 to 45, has identified

eight areas of focus "to make Beverly Hills more exciting and appealing to the next generation." The committee's priorities include community engagement, homelessness and panhandling, family-friendly activities and "Next Gen" housing.

"My only concern is that [we're putting]

a chronological, mandatory age—I think that's discriminatory," Councilmember Lili Bosse said of the age requirement.

Bosse pointed out that the age restriction shuts out residents who fall outside the numbers.

At Tuesday's meeting, the Council agreed to remove the age requirement and make Next Gen an open group.

The Council later gave direction to convert Next Gen Leaders into a formal Council committee, meaning two councilmembers will be assigned to the group as liaisons. Additionally, the committee will have to comply with all Brown Act requirements.

Next Gen is expected to return to the Council with a new proposed work plan once they achieve their first set of goals.

In September, the Council considered allocating \$105,000 for a block party hosted by Next Gen.

"I do think the budget was a surprise," Gold said at the study session.

Discussion of the "street experience event" has yet to resurface at a Council meeting.

Geimer, Goldberg propose mayors forum

Ira Goldberg and realtor Marty Geimer attended Tuesday's City Council study session to request use of the Roxbury Park

Community Center for a mayors' forum, the first in over 15 years.

"We've had so many new [councilmembers] and mayors that now is an appropriate

time to have another one," Geimer said.

Geimer and Goldberg organized the 1998 event, which was held at Beverly High's Salter Theater.

At the forum, the former mayors will discuss the decisions and accomplish-

ments that defined their terms, Geimer said.

The Council agreed to waive the fees associated with renting the community center for three hours, a \$600 cost. The forum, being slated for February 8, will be free and open to the public.

BHUSD legal fees for second quarter fiscal year: almost \$1 million

In a sharp increase from the amount spent the previous quarter, BHUSD legal

expenditures totaled \$927,260 for the second quarter fiscal year. About \$315K was charged to the general fund and \$611K to the Measure E fund.

In comparison, first-quarter legal fees stood at \$119,177.

The \$315K was paid to four different law firms: Alvarez-Glasman & Colvin; Atkinson, Andelson, Loya, Ruud & Romo; Greenberg Glusker Fields Claman & Machtinger; and Horvitz & Levy.

Attorney Fred Fenster from Greenberg Glusker represents the district in the litigation involving former BHUSD Facilities Director Karen Christiansen. The total judgment against the district exceeds \$20 million.

As of October 2014, Horvitz & Levy represented the district in the CEQA appeal involving Metro's proposed Purple Line extension project, which the district lost. Murphy & Evertz represented the district in the CEQA case against Metro in opposition to the Purple Line extension route.

According to research conducted by Board of Education Vice President Mel Spitz, comparative school districts spend \$65 per student on legal fees, whereas the BHUSD spends \$478.

"There is a natural tension between responding promptly to the press and the public and the need to ensure that the information that is provided is completely accurate," said North Homeowners Association member and former Mayor Robert K. Tanenbaum at Tuesday's City Council meeting, quoting a report drafted by City staff. "Natural tension? Is this *Pravda* that we're dealing with that we're demanding information?"

Relevant parties are expected to participate in the town hall meeting, which will take place inside the City Council Chambers, located at 455 N. Rexford Drive.

The North Homeowners Association's objective is to then make recommendations to the City Council.

Incoming Traffic & Parking Commission Chair Jake Manaster

You're a former Board of Education member. How does serving on a commission compare to serving on the Board?

I think an elected official has certain obligations that relate to finances of, for example, the school district. Commissions don't control finances and are primarily there as an advisory body to help our residents conduct their business.

An elected official at the school-board level is a trustee, or a governing person, along with their colleagues, and a commissioner is neither.

What sparked your interest in local politics?

I enjoy being a part of the community I live in and if I wasn't a part of that, I would feel that life would be less interesting. I enjoy trying to build upon the

hard work of other volunteers before me.



At a recent Commission meeting you said, "There's been a change in behavior and use that makes the [Electric Vehicle] network much less, we'll just say, usable for its intended purpose." Explain the change of behavior you've detected.

My colleagues and I are hopefully going to

look at a report that will show how electric vehicle charging had initially been used to spur people [to purchase] plug-in hybrid vehicles and electric-only vehicles. That was meant to allow people to not have what's known as "range anxiety;" in other words, they'd be able to go places and charge up and have enough charge to go home. Now, what appears to be happening, is the

spaces are being used either as reserved parking spaces for people who do not charge, or for vehicles that don't need to charge—and that means it's becoming more of a utility. As a utility, it's a public resource, and we need to recover our costs on that. I'm sure that my colleagues and I will get into a good discussion about what the mission of the charging network should be.

How do you suggest the city combat this issue?

There's no such thing as "free." Everything that we do in this city, whether it's for businesses or our residents, costs something. I'm in favor of seeing some of that cost recovered, but you have to decide on what the mission is first. Specifically on that matter, if the mission were to be that we just want to provide charging stations, I would suggest one mode, and if it was more about wanting to allow people to feel safe that they won't be without a charge by shopping and visiting Beverly Hills, that's a different mission. That's what we call transient use. At the moment, there aren't enough chargers for everybody and there aren't enough parking spaces for everybody. I think the mission should be used as an attraction for transient use, meaning [it will be] used to [make people] feel comfortable shopping and spending leisure time in Beverly Hills, not necessarily to support

somebody's need to have free energy—in essence, fuel—for their commute. That's not what I believe the network was originally intended for. As far as a fee structure goes, that relates to cost recovery, so whatever the costs are of maintaining the network and providing electricity, I don't believe the residents of Beverly Hills should be paying for other people's free fuel.

Recently, preferential parking permit zones have been a recurring topic of discussion at Commission meetings. In August, you said "it's really unnerving to have these keep coming up over and over again." What kind of solution do you envision?

I envision an improvement on the process that consolidates the numbers and types of permits that currently exist. I think anybody can see that there are over 70 different permit zones and restrictions and that that is a very unmanageable path going forward. It can be improved both for cost attainment measures as well as for ease of use for our residents.

What is your number one priority as incoming Chair?

To help facilitate my fellow commissioners—who are also my neighbors—ability to help other residents get traffic and parking problems solved for that year.

Water Enterprise revenues for fiscal year 2015-16 are estimated to total \$32.6 million, while the projected costs are approximately \$35.9 million, resulting in a \$3.3-million revenue shortfall.

According to Public Works Assistant Director Trish Rhay, the projection is based on anticipated reductions of 19.4 percent. The revenue loss to date is \$4.5 million, Rhay said.

We needed to make sure that it was revenue neutral," Rhay said. "We are not a profit-driven agency, so we need to make

sure that we do not charge more than what we need to operate our business."

The Council continued the matter to a future meeting.

Lieu outlines opposition to GOP health law repeal in House Floor statement

In light of House consideration of the Senate-passed GOP Reconciliation Bill, Congressman Ted Lieu (D-Torrance), who represents Beverly Hills, took to the House Floor Wednesday to express his opposition.

"Today the House Republican Caucus unveiled their 'new' ideas for America: a 62nd repeal of the Affordable Care Act (ACA) and 11th attack on women's healthcare, both of which are guaranteed to be vetoed by President Obama," Lieu said. "One definition of insanity is repeating the same thing over and over again expecting a different result. Repeal of the ACA would result in 22 million Americans losing their health insurance, including approximately 3.5 million Californians."

In his critique, Lieu asserted that Republicans have no plan to cover the millions of Americans "they would plunge into healthcare crisis through an actual repeal."

The Congressional Budget Office estimates that the bill would result in 22 million Americans losing their health coverage after 2017.

Passage of the bill by the House Wednesday will send the bill to President Obama's desk. Obama has already promised to

veto the legislation.

"If you want hyper-partisan bills that waste time, squander taxpayer resources and are destined to go nowhere, look at the GOP Agenda," Lieu said. "If you want ideas that will move our nation forward—such as investing in education, reducing carbon pollution and creating jobs—take a look at the Democratic Agenda. At least we're not insane."

Council postpones vote on water rate increases to future meeting

Following a two-hour discussion that featured several impassioned residents and business owners, the City Council agreed to postpone voting on increase water service rates and charges Tuesday night.

"I think we're going to have to be deliberate and look at every element of the entire [Water Enterprise] plan and make a decision where we don't want to spend money," said Mayor Julian Gold.

Operational costs are climbing and revenues are sinking as a result of water conservation during the drought, so the current water rates structure is no longer revenue-neutral, according to the January

BHHS boys' basketball team defeats Loyola

The Beverly High boys' basketball team held a 13-point lead with six minutes to play, then withstood Loyola's comeback attempt in a 49-44 victory in the third annual Take Flight Challenge Saturday at Redondo Union High School.

Maddox Daniels' second 3-point basket of the fourth quarter – and fourth of the game – gave the Normans a 42-29 lead with six minutes to play.

The Cubs responded with a 9-0 run, with senior forward Josh Lavergne scoring the final five points, cutting the lead to 42-38 with 4:08 left.

Loyola twice pulled within three, the last time at 45-42 with 2:05 remaining.

A basket by Denzel Holt and Matt Reskin's two free throws put Beverly Hills ahead, 49-42, with 1:13 to play and it led by at least five for the rest of the game.

Daniels and Reskin both scored a game-high-equaling 14 points. Holt added eight, Fidel Quiralte six, Amir Hajirsooli four, Kevin Cho two and Mason Daniels, Maddox Daniels' twin brother, one, for the Normans (7-6).

Beverly Hills coach Jarvis Turner credited the victory to his team's defense.

"Amir played real well for us," Turner said of the Normans' 6-foot-7 starting center. "He battled inside, rebounded. He was a real presence."

Beverly Hills broke an 8-8 tie and took the lead for good by scoring the final four points of the first quarter and first five of the second.

Reskin's third 3-point basket of the first half gave the Normans a 22-12 lead 4:01 before halftime. The Cubs scored the next six points, but Beverly Hills closed the half by outscoring Loyola, 6-2 for a 28-20 halftime lead.

The Normans outscored the Cubs, 8-3, in the third quarter to lead 36-23 entering the fourth quarter.

Loyola coach Jamal Adams said his team "didn't play very well" in its fourth consecutive loss.

"Beverly did a great job at getting the game at their tempo," Adams said. "They got their shots and we didn't get the shots we wanted to get. They defended us well."

Lavergne led the Cubs (7-6) with 14 while their 6-foot-10 senior center Henry Welsh added seven.

Welsh has made a non-binding verbal commitment to play for Harvard, Adams said. He is the younger brother of UCLA starting center Thomas Welsh.

Loyola was ranked second in the most recent Southern Section Division 2AA poll, which was released Dec. 14. Beverly

Hills was ranked third in Division 3A.

The Normans lost to the Cubs, 47-42, in a fifth-place semifinal of 75th annual Sax Elliot Invitational Dec. 11, in a game Turner said his team "missed some easy shots, had some crucial turnovers down the stretch."

To Adams, a difference between the two games was that senior Josh Curls, who Adams described as "our best guard," was sidelined Saturday because of an ankle injury.

"He sets the pace for us," Adams said.

Curls had nine points, seven rebounds, three steals and two assists when the teams first met.

Beverly Hills is scheduled to open Ocean League play Wednesday by playing host to El Segundo at the Swim-Gym. The opening tipoff is scheduled for 7:30 p.m.

Michele Gold on being married to the Mayor

Both you and your husband, Mayor Julian Gold, work in the medical field. Did that play a part in how you met?

Yes, very much so. We met in the hospital in New York at NYU. Julian was an attending anesthesiologist in the NYU Department of Anesthesia and I became their first chief nurse anesthetist. We met in the operating room. He was never my official boss, because I don't want to think there was any impropriety, but we were colleagues. Not only was he nice to me in my new role, but because I had just moved to New York, he also showed me what it was like to be a New Yorker and not a tourist—he really showed me the city.

You are an associate professor of clinical anesthesiology at USC's Program of Nurse Anesthesia. You're also the program director. Tell us about that.

I have been at USC for 20 years. I started as the associate director and became the program director in 2000. This began after my career took a change and I finished a PhD in pharmacology, and started my professional life doing research in pharmacology and anesthesiology. I finished my PhD in 1990 and started at USC in 1996. For my doctoral work, I worked with a scientist, [Dr. Louis Ignarro], who went on to win the Nobel Prize in physiology and medicine in 1998. I had a background as a bench researcher but chose to continue my clinical work in the hospital and that directed me into the education of nurse anesthetists, which I began in 1996. So I was a clinician, researcher and now an educator. My role now is focused on education. I teach pharmacology and I also mentor students and faculty within the department.

Is it difficult to manage your time between your roles at USC and attending events with the mayor?

We are busy, there is no question about that. Julian is much busier than I am. I get to pick and choose, as I can, to get to things or not, so it is definitely easier for me than him. It's not hard—we make things happen because when he assumed the role as City councilmember, and of course now as mayor, it has been our honor and our privilege and we feel an obligation to the city. Because of that, he does many events and I try to do as much as I can.

In the rare chance you have free time, what do you enjoy doing?

I'm a knitter, and along with former [Fine Art] commissioner Sandy Pressman, I was able to knit some hats for our soldiers in Afghanistan. I helped with the Special Olympics this summer and found that to be a very heartwarming experience. Two dear friends and I will be walking the L.A. Marathon on February 14. We have been training for awhile. My two friends have already walked the L.A. Marathon last year, but I'll be doing my first and I am very excited.

Were you surprised when Julian pursued elected office?

Yes, I was, and that's not to minimize any of his accomplishments, but we were very new to campaigns and new to politics in general. We mounted a campaign that we had certainly hoped to be successful, but having never done this before—being accomplished in other things, but not this—lends itself a certain amount of anxiety. But it was exhilarating when he was elected. We knew that it would be work, but we also recognized that it would open a new chapter in our lives.

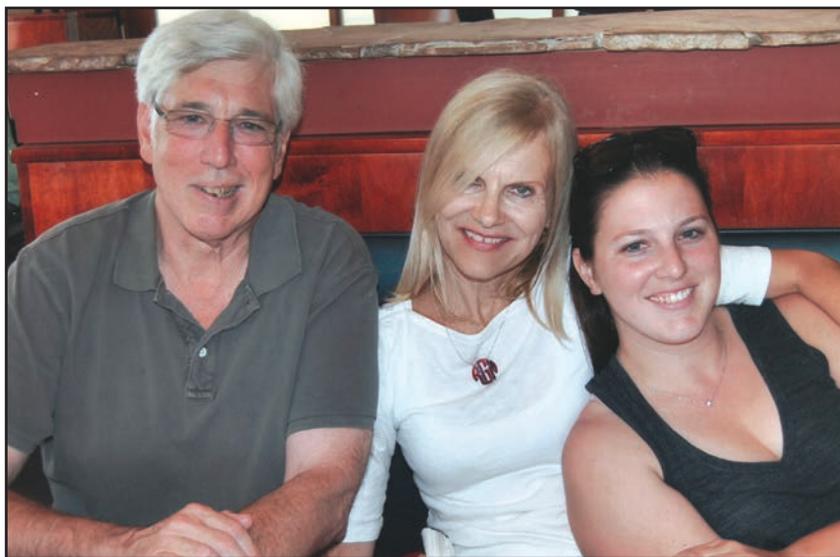
Tell us about that new chapter.

One of the things that Julian says often about being on the City Council, and of course now being mayor, in a small town [is that] you meet up with your constituents, so there has to be a responsibility and accountability at all times. That was apparent from the beginning when we'd walk down Beverly Drive and people would stop him. So we began to understand the magnitude of what it meant for people. Another part has been places we have been to represent the city. Julian talked about it in some of his work, but we went to China in

May [2015], where he represented Beverly Hills to the Chinese government. Several Southern California mayors were in attendance, and again, that was different for us and exciting. One of the highlights, for sure, was attending the U.S. Conference of Mayors in San Francisco. President Obama and Secretary of State Hillary Clinton spoke and many other mayors and business people were in attendance. It was different for me and Julian because being in the medical field, we get used to that sort of conference, but this was eye-opening and special for us.

In a 2008 follow-up with your alma mater, Rush University, you said, "I am proud of each student I have had the chance to teach and support throughout their educational paths." What's most rewarding about teaching?

I enjoy watching the students grow. I teach graduate students, so obviously they're adults. I'm not so certain I'd be a good kindergarten teacher—in fact, I know I would n

ot be a good kindergarten teacher. But I love watching adults learn. They begin knowing very little and the faculty role is to guide their understanding. The most rewarding time is when I see they can open their eyes to the information, grasp concepts and get a better understanding. That is the most special thing. And by now I have hundreds of students across the United States and it is always heartwarming when I see them at conferences and know how well they're doing.

Do you think you'll ever get into politics?

No. I don't think I am that interested in it. I love hearing Julian's discussions, but I don't think I would be able to be as strong as he is. I like to think I might, but I'm not certain. It takes strength and I would likely be too emotional. Coming down to the most critical decision, I may not be able to be as objective as he always can be.

Tell us more about your family.

We have a daughter, Rebecca, who of course is everything to us. She is currently living in Orange County and sometimes I worry we won't get her back from Orange County. She really likes it down there, mainly because the streets are wider; she says there's less traffic and there's very

little need to have to pay for parking. She is working on a post baccalaureate at Chapman University. [Rebecca] was a product of the Beverly Hills schools: she graduated Hawthorne in 2005 and Beverly High in 2009. She was a four-year soccer varsity goalkeeper, as well as a four-year varsity softball player; she was a catcher in softball. She's much more of a natural athlete than her father and me. She went to Carnegie Mellon University in Pittsburgh, Pennsylvania and graduated in 2013 with a degree in psychology. In addition to her studies, she played soccer for Carnegie Mellon. Her future goal is to be a physical therapist and she's working hard toward that goal right now.

I'm from Chicago, I'm a Midwesterner. My family still all live back in the Chicago suburbs, and I must say I don't think I ever dreamed of living in Beverly Hills. From Chicago, I went to New York for the job I mentioned—chief nurse anesthetist at NYU. Then I met Julian, came to California, but originally we lived in Cheviot Hills. We moved to Beverly Hills in 1994, mainly for the schools, as do so many people. Our daughter was three at the time.

Julian is nearing the end of his term as mayor. How do you think he's done?

I think he has done very, very well. I'm always amazed and proud of how he handles things. He has a very nurturing background—that's his medical training—and I see it in every decision he makes, as well as his strategic abilities. He can listen to people and analyze and process and always come out with what I consider a good decision. When [Julian] started [his term as mayor], a few

days later, [there was a] large announcement [about] the impact of the drought and the need to conserve water. I thought that this would be somewhat challenging for him, but he loves challenges and he rises to the occasion. He enjoys working with city staff and appreciates their hard work. He's very, very lucky that way and he knows it. The other accomplishment he led the City Council in was choosing a new City Manager, Mahdi Aluzri. The City Council is also very close to announcing a new Chief of Police. [Julian] has taken on all of those tasks with the same thoughtful analysis and making a good decision.

What do you love about Beverly Hills?

The best, of course, is the sense of community that we have. Our daughter went to school here. Raising a child here makes you an immediate member of this community and we have many dear friends. I love being able to take long walks in the streets, it is of course safe and the weather is perfect. It is a very sophisticated town and finding wonderful restaurants is always easy and we don't like to leave our neighborhood. Of course, nobody would've ever thought, between Julian and me, we would be living in Beverly Hills, he would be the mayor, and now his term of mayor is almost over.

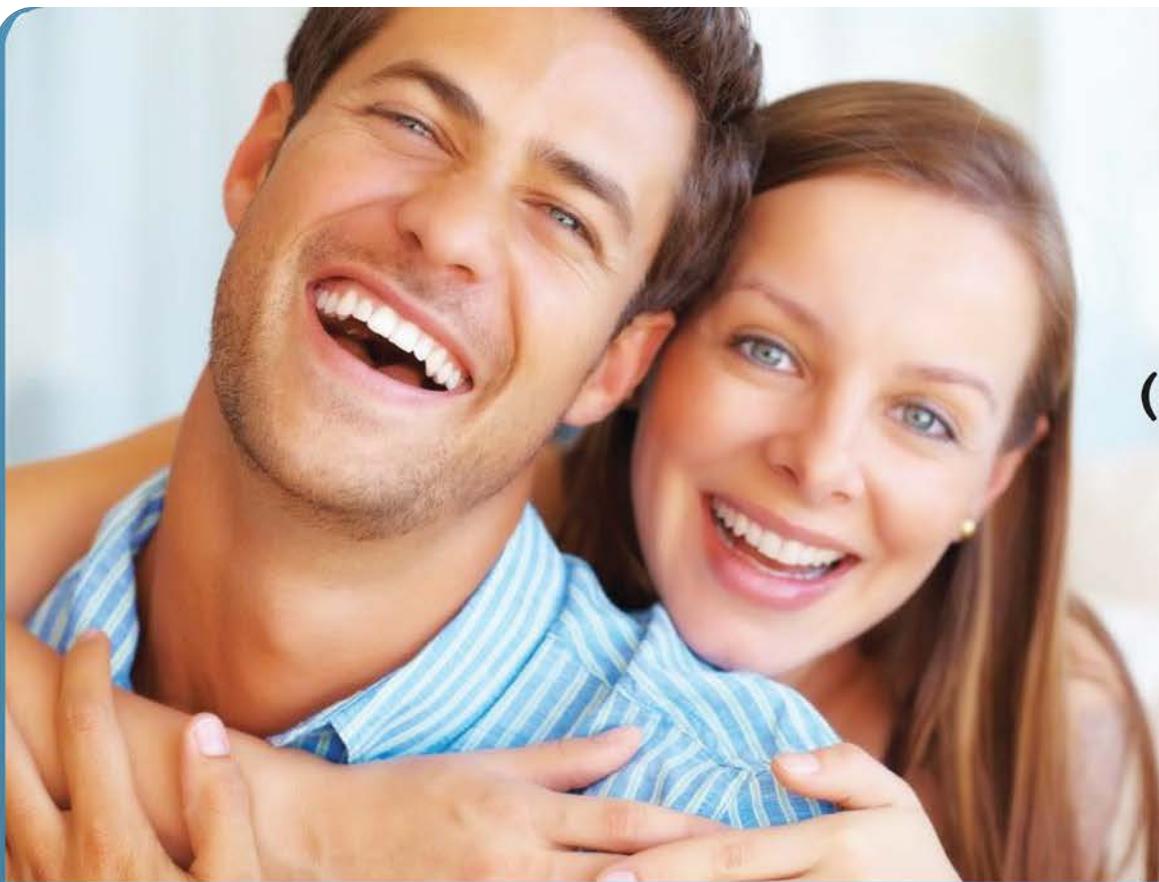
