Council supports implementing stricter election regulations

Soon after an anonymous hit piece attacking two Board of Education candidates arrived as a door hanger at 15,000 homes last October, the City Council directed the city attorney's office to draft an ordinance amending local election regulations.

"At the end of the day, we've got to have some rules," Councilmember Willie Brien said at the October 22nd meeting.

The draft ordinance, spearheaded by City Attorney Dave Snow, contemplates several revisions to Chapter 8 of Title 1 of the municipal code.

Under the ordinance, the door-to-door distribution of more than 200 pieces of "substantially similar" campaign literature would be prohibited, unless the materials contain identifying information.

"This is really geared towards campaign activity, campaign literature [and] campaign literature as defined," Snow said.

The new regulations prevent vendors from receiving cash payments that total \$100 or more from any candidate or com-

mittee, which is already forbidden under the Political Reform Act (PRA).

Last year's anonymous door hanger was allegedly paid for in cash.

At the October meeting, Vice Mayor John Mirisch, who filed a police report against the unknown perpetrator, said the penalties "should have teeth."

Snow's ordinance proposes a maximum fine of \$1,000 or no more than six months in the County jail.

"I want to know that here's something more than a misdemeanor if we can prove it," said Councilmember Nancy Krasne.

The Council supported exploring ways to broaden the ordinance, which would apply to Council and City Treasurer elections, as Board of Education elections are run by the County.

More than three months later, the perpetrator behind the October hit piece remains unknown.

Peck Drive gets new trees

Parks and Urban Forest Manager Ken Pfalzgraf said he is happy with the way things are turning out on Peck Drive, where two thirds of the street's 120 Idaho locust trees were recently replaced with Chinese elm "Drake" trees, signaling the final phase of a process that dates back five years.

Resident concerns about the Idaho locusts began surfacing in 2011.

Since then, city staff members have met annually with a group of Peck Drive residents to discuss the trees' lagging performance.

"As long as there's heavy soil, they just don't do well," Pfalzgraf said of the trees, which were planted on the street over a 15-year period.

More than 10 years in, the Idaho locusts were still not performing in a manner that complements goals outlined in the Street Tree Master Plan. The City Council approved phase one of the plan in 1996.

At a Recreation & Parks Commission meeting last March, Peck Drive resident Eric Schwartz presented a petition calling for the replacement of the large deciduous trees.

"We don't feel we have a canopy that's representative of the city or the neighborhood," Schwartz said.

Schwartz mentioned the Idaho locusts lowered property values and disrupted the cohesiveness of the city's streets.

More than 50 percent of the property owners on Peck Drive supported the petition, and the initiative received backing from the Recreation & Parks Commission, and later, the Council.

Earlier this week, Schwartz said the process has been an open and transparent one.

"I think it was a classical way in which government should work," Schwartz said.

Removing the trees costs around \$23,000 and planting the replacements totals \$75,000.

Pfalzgraf expects that the remaining 40 Idaho locusts will be replaced by next week. The 80 trees that were already removed have been sent to a recycling yard.

"I can't really salvage them knowing the condition they were in," Pfalzgraf said.

Sharon Persovski appointed to Architectural Commission

The City Council appointed Smiles Through Art Executive Director Sharon Persovski to the Architectural Commission at their meeting Tuesday.

A graduate of Universidad Iberoamericana in Mexico City, Persovski

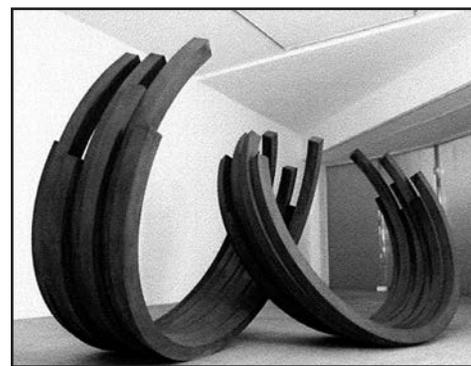
has extensive experience creating and developing environmental graphics solutions for clients around the globe.

Persovski was one of four candidates considered for the opening. The interview panel included Councilmembers Willie Brien and Nancy Krasne and Architectural Commission Chair Andrea Gardner Apatow.

Persovski will fill the position of Commissioner James Blakely III, whose term ends June 20.

Fine Art Commission decides not to proceed with Bernar Venet sculpture

Following a proposal by Commissioner Michael Smooke, the Fine Art Commission considered acquiring a sculpture by French conceptual artist Bernar Venet at their meeting last week, but decided not to proceed with the purchase.

According to the staff report, the Corten steel construction was being offered at a "reasonable" price of \$300,000.

"I don't think it's a good deal," said Commission Chair Brenda Potter.

A Venet sculpture is currently installed in front of South Beverly Grill.

Though tasked with acquiring art, the Fine Art Commission often spends a substantial portion of its monthly meetings deliberating maintenance procedures for the city's public art.

In fact, late last year, Smooke himself noted that the Commission's primary goal is to acquire art for the city, "although maintenance is certainly important."

If Smooke reintroduces the proposal, the Commission will revisit the possibility of acquiring the piece at their priority-setting session in August 2016.

The sculpture, currently installed at Ace Gallery, features two intersecting arcs and stands seven feet tall.

NOTICE IS HEREBY GIVEN that the Council of the City of Beverly Hills, at its meeting to be held on **Tuesday, February 2, 2016**, at 7:00 p.m., in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, California, 90210, will hold a public hearing to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING BEVERLY HILLS MUNICIPAL CODE SECTIONS 10-3-2804(B) AND 10-3-2850 REGARDING THE HEIGHT LIMITS FOR ADDITIONS TO LEGALLY NONCONFORMING BUILDINGS IN MULTIPLE-FAMILY RESIDENTIAL ZONES.

The proposed Ordinance would amend sections of Chapter 3 of Title 10 of the Beverly Hills Municipal code regarding the height limits for additions to multi-family residential buildings with legally nonconforming building heights. The proposed Ordinance would establish provisions for a request to be granted, through the issuance of an R-4 Permit, for additions to multi-family residential buildings to match the legally nonconforming heights of those buildings.

A resolution recommending City Council adoption of the Ordinance was previously reviewed and adopted by the Planning Commission on December 10, 2015.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City Council will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations, as well as Sections 15305 because adoption of this ordinance results in minor changes to land use limitations pertaining to building heights, and applies to properties with an average slope not exceeding 20%. In addition, the Planning Commission of the City of Beverly Hills adopted a Class 1 Categorical Exemption for the multi-family residential project associated with the amendment.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

Please note that if you challenge the Council's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

Where were you when the space shuttle Challenger exploded? JANUARY 28, 1986 – 30 YEARS AGO

PAUL BERNSTEIN RETIRED ENGINEER

“I was in my sixth-floor conference room in the Hughes Aircraft building on Imperial Blvd., just east of Sepulveda. My boss came in and said there was a shuttle failure. We all rushed out to the nearest TV to see the event. Speechless was not enough. Not much work was done for the remaining hours that day.



A day or two after, one of my project managers came to see me. As his program was to be a shuttle launch he was concerned about a cancellation. I stuck my neck out and told him the project was still needed and it would be reconfigured to a standard launch vehicle. With no schedule changes I said that we would be busier than ever. It turned out that I was right.”

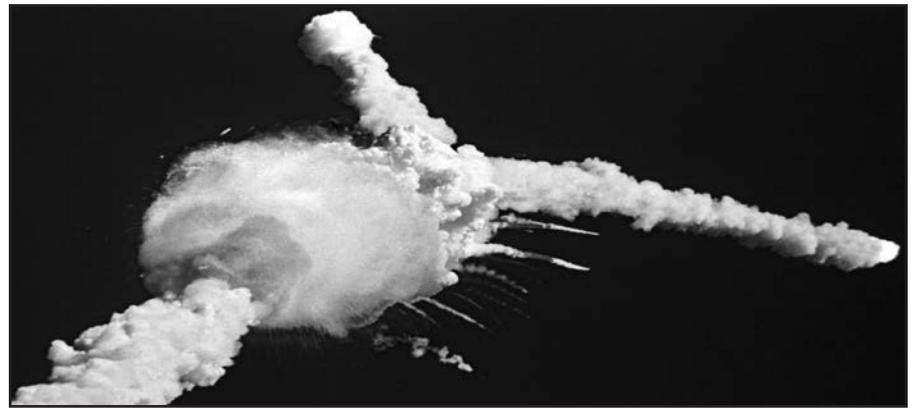
ROSE KAISERMAN PTA COUNCIL CO-PRESIDENT

“I vividly remember being in my 8th grade Social Studies class at Hawthorne School when we heard about the shuttle explosion. However, the gravity of the event did not register until I stepped into Mrs. Eaton’s Science class. She had the custodian wheel in a television set into the classroom where we watched live coverage. The combination of watching the grave reporters speak of the horrific explosion and our teacher’s look of devastation hit home for me because I had learned that one of the casualties was a high school teacher. It was then when I realized that not all aboard were astronauts, trained to expect the possibility of the worst. Some of these passengers were everyday civilians like you and me.”



HOWARD GOLDSTEIN BOARD OF EDUCATION PRESIDENT

“The Challenger explosion was the first time I witnessed a space flight catastrophe unfold on live TV. My wife, Juliet, and I were college students watching the launch together. At that time she was studying to become a teacher and wanted to watch the launch of the first schoolteacher bound for space, [New Hampshire teacher] Christa McAuliffe. Shortly after the launch I recall seeing the TV screen light up in a horrific flash, then the crew compartment shot out of the explosion and began to plummet back down to Earth. Julie and I continued to watch in bewilderment as the two booster rockets ascended and attempted to return to their original trajectory. The camera feed cut back and forth to the faces of Christa McAuliffe’s family and the teachers and students from her school in New Hampshire as they gasped in shock and tears as debris fell from the sky. I remember looking at Juliet in disbelief as her eyes swelled up with tears. That morning, our hopes and dreams were not only riding with McAuliffe, but with the future of space travel itself. While seven brave astronauts lost their lives that day, it took only 73 seconds for the hopes and dreams of students around the world to evaporate.”



CHRIS BUSHEE BEVERLY HIGH CHEMISTRY TEACHER

“I was playing at my best friend’s house. Somehow we got word of the tragedy and we turned on the TV in the living room. They replayed the footage of the explosion over and over and I recall being glued to the screen in disbelief. It was especially impactful because I was still in high school (my senior year) and I felt a connection to Christa McAuliffe, a teacher.”



JULIAN GOLD, MD MAYOR

“I was at Cedars in the preoperative area getting ready to see my patient. Someone ran into the room in tears yelling ‘It exploded!! The Challenger exploded!!’ We all ran into the staff lounge which had a TV set in it and watched as they replayed what happened. I remember that sense of disbelief and the sick feeling you get in your stomach when something like that happens. Many of the staff were in tears. It was a really difficult day to get through. I have the same sense for the day Kennedy was shot and for the Twin Tower attack of 9/11.”



LINDA BRISKMAN FORMER MAYOR

“What I remember first about this day was the incredible shock and disbelief watching the explosion. I really identified with Christa McAuliffe. We were the same age and I thought that somehow she represented me and all of the young women who looked to “compete” in a world previously reserved for men. I foolishly thought at first there would be survivors. I just couldn’t imagine the complete devastation and quite frankly it changed forever my feelings about manned space flight.”



LILLIAN RAFFEL BEVERLY HILLS DEMOCRATIC CLUB PRESIDENT

“I was having a surgical procedure at the old Century City Hospital when it occurred. I was waking up from the anesthesia and the first thing my husband Stuart said to me was that the Challenger exploded. I thought I was having an anesthesia dream (nightmare) and didn’t believe it was true. I cried, heartbroken. I prayed for the families of those on board.”

Architectural Commission orders restudy of condominium development

A seven-unit, multi-family residential building approved by the Architectural Commission in March 2008 was sent back for restudy last week, following an elaborate discussion about the project's revised aesthetic.

"It sounds like there's a little bit of massaging that needs to be done before we can approve this," said Commission Chair Andrea Gardner Apatow.

The original construction, characterized as a Tuscan architectural style, under-

went substantial modifications since the Commission gave the green light nearly eight years ago.

"A different owner acquired the building, came to us and said, 'Look, we want something contemporary,'" said Antonio Simos of the Code Solution, an architectural and planning firm.

Concrete block walls, clear-glass window and door openings, burnished white concrete paving and smoked glass at the upper-level canopy characterized the revised design.

"One of my concerns is [that] the polished marble, in conjunction with the stucco wall, feels like a little bit of a jarring change," said Commissioner Sheri Hirschfeld.

The Architectural Commission expects to revisit the development at their February 17th meeting, after the project designers have had a chance to consider the committee's recommendations.



Board OKs expansion of Beverly Vista playfield

At Tuesday's meeting, the Board of Education voted 5-0 to begin the bid process for the expansion of the Beverly Vista playfield, a \$750,000 project expected to break ground this summer and take six weeks to complete.

Architectural firm SVA Group has already prepared design documents for

the field. In order to ensure that construction begins during the summer break, the Board decided it was best to begin soliciting bids early.

As the project timeline does not allow a separate pre-qualification process, the bid package will include a contractor qualification process.

AYSO has agreed to cover a portion of the costs associated with the project.

Council to discuss additional public review process for mixed-use development

At their study session next week, the City Council will consider initiating an informal public outreach process to gather community feedback on a proposed project by Townscape Partners and Gehry Partners, Frank Gehry's architecture firm.

The City Council will discuss a public review process, through which the project proposal would be presented to the

community at a series of informal public meetings.

The purpose of the outreach meetings would be to gauge community reaction before making a decision on whether to pursue formal city review of the project.

The concept for the project is a mixed-use development on city-owned property in the Entertainment Business District, bounded by Foothill Road, Maple Drive, Alden Drive and the alley north of Burton Way. The developers have called for a request for proposal (RPF) process to select a ground-lease development tenant.

Current uses of the property include the future site of the dog park, the shallow ground water wells under construction and property leased to Lakeshore Entertainment and the City Employee Credit Union.

DR. GOLD GOES TO WASHINGTON

Mayor Julian Gold on last week's 84th Conference of Mayors

What were the highlights of last week's U.S. Conference of Mayors?

Mrs. [Michelle] Obama addressed the mayors on the issue of veteran homelessness. She highlighted initiatives all over the country that are finding ways to create affordable housing for veterans. She encouraged the group to continue working to end this tragedy. It was a very impressive speech.

The next day, we met with the President [Barack Obama]. CNN covered the first part of it and then [Obama] kicked the press out of the room and took questions from the mayors about various elements of his policy and the manner in which the federal government can help local government. [Obama] was—and has always been—very supportive of mayors and

local government and said frequently that he recognizes that it's the local level that gets things done. He said, "Whether you're a Democrat or a Republican, the trash still has to get picked up." It was a very good meeting. former Los Angeles Mayor [Antonio] Villaraigosa. The mayor of Dallas, Mike Rawlings was there, [as well as] the mayor of Chicago, Rahm Emanuel. The mayor of Washington, D.C., Muriel Bowser, and the mayor of Baltimore, Stephanie Rawlings-Blake, were all there.

How is what you learned applicable to Beverly Hills?

We had a big conversation on Wednesday morning about water. What's very interesting about water is that the entire country is dealing with the issue of water but dealing with it differently. Some parts of the country, like us, are dealing with the issue of drought and how do we get more water. There are parts of the country dealing with too much water and floods and having to get rid of water;

and there are parts of the country that have the right amount of water but can't get it where it is needed in an efficient manner. And of course, there is the recent disaster in Flint, Michigan, where the drinking water is contaminated with lead. Almost every region of the country has issues surrounding water, which I thought was pretty fascinating.

How did the Washington, D.C. conference compare to the one you attended in San Francisco last June?

Both conferences were similar in that they focused on very real local government issues: water, transportation, community-based policing, gun violence [and] infrastructure. This was different because of the visit to the White House and the mayors' meeting with the President. That was very exciting and special.

Why do you think it's important to participate?

The conference offers mayors from cities [of all sizes] the opportunity to share their experiences with local government issues. It is an opportunity to learn from others and, at the same time, it offers us an opportunity to discuss issues that are important to Beverly Hills.

Any chance Beverly Hills might one day host the conference?

I think it would be wonderful if we could. I suspect there is a lot of competition for that role and larger cities have an advantage, but I think it is a great idea.

LIBOW SECURES NAMING OPPORTUNITY OF HORACE MANN AUDITORIUM STAGE

But some question whether the move is a boondoggle

The Horace Mann auditorium stage will be named the "Michael J. Libow Performance Space," following a \$35,000 donation from Coldwell Banker realtor Michael Libow to the BHEF.

"With this last naming, Mr. Libow will have completed a naming opportunity at all of our schools," said BHEF President Monique Gibbons at Tuesday's Board of Education meeting.

Libow has been at the center of a long-standing controversy over whether the

donation amounts are congruous with the properties' values and whether one individual should be allowed to secure multiple naming opportunities.

"It seems as though the school board has forgotten their promise and commitment to the community to properly market and expose naming opportunities," El Rodeo parent Martin Halfon said Wednesday. "It's wonderful that Michael Libow has stepped up to the plate again, but what marketing mate-

rials can they provide that show that they appropriately reached out to the community to let them know other than posting it on a website that nobody visits?"

In late 2014, the El Rodeo courtyard was named the "Michael Libow Courtyard" after the realtor made a \$30,000 donation, *Beverly Hills Weekly* reported in issue #788.

"Why is it that the school board stated that they had learned from their last mistake at El Rodeo when this landed on the cover of the *Los Angeles Times*?" Halfon said.

The price list for naming opportunities is approved by the Board.

"Could it be that somebody would have come up with \$50,000 or \$100,000?" said Board Vice President Mel Spitz at Tuesday's meeting.

Gibbons said she is not prepared to "haggle" with prospective donors.

"It just seems to me that we see one name all over the place," Spitz said.

The Horace Mann auditorium is named after beloved eighth-grade Social Studies teacher Ron Brown, who taught

alongside now-Superintendent Steve Kessler for many years and passed away unexpectedly in 1994. No dollar amount was specified for that naming.

BHHS boys' basketball team loses to Santa Monica

A slow start led to the Beverly High boys' basketball team's 68-51 loss to Santa Monica Friday night at the Swim-Gym, its first loss of the season in Ocean League play after three victories, according to coach Jarvis Turner.

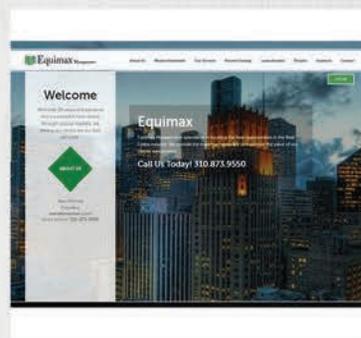
