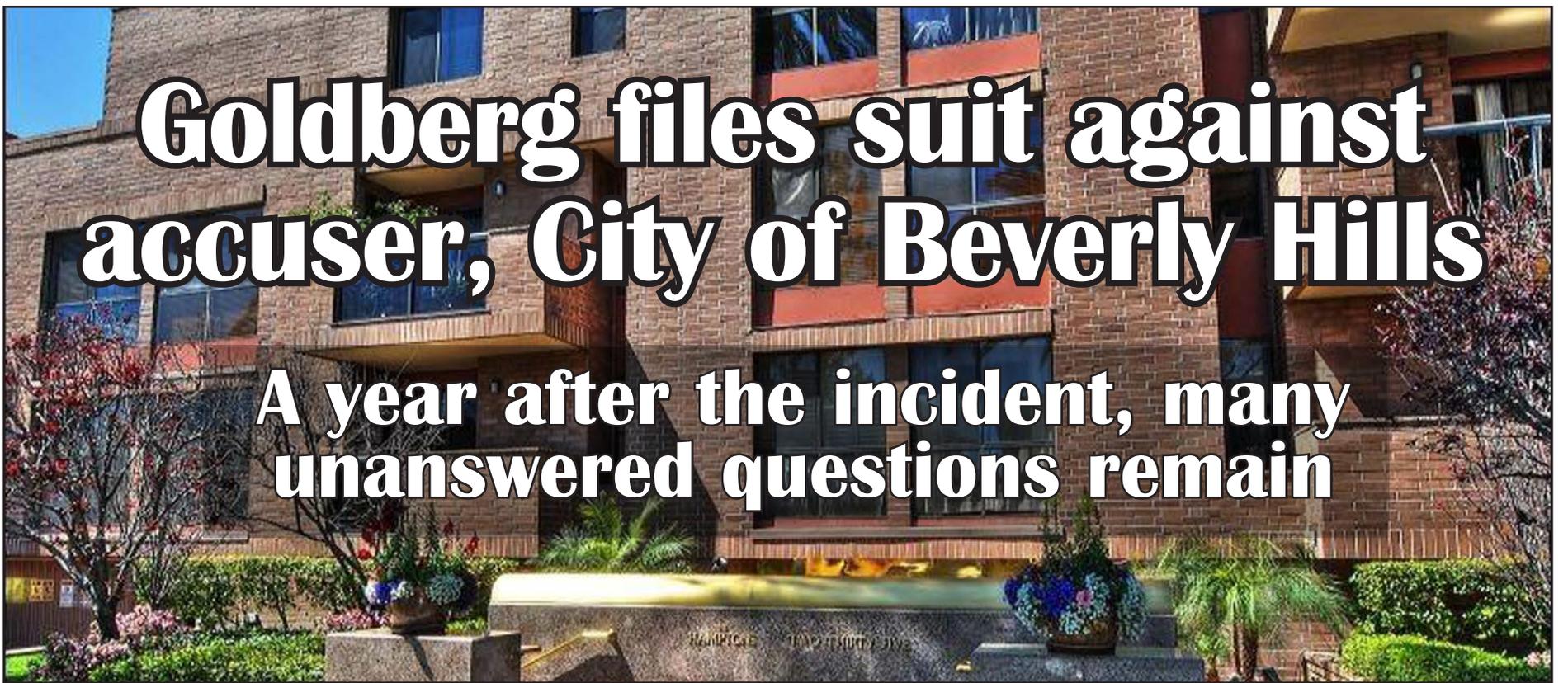

**Brien slams *The Courier*, does not indicate resignation date**

Councilmember Willie Brien did not announce his resignation date at last week's installation ceremony, despite the city playing a four-minute "farewell" video recognizing the former mayor and Board of Education president.

Instead, when Brien took the podium at the Samuel Goldwyn Theater March 16, he began by thanking city staff members, his past and present colleagues, and his family.

"Truly, we are blessed with our problems as

well as our opportunities, which often turn out to be one and the same," Brien said.

Though Brien was expected to step down March 16, he did not address the matter. The councilmember did, however, share his thoughts on the *Beverly Hills Courier*, after invoking the spirit of his grandfather, former U.S. Chief Justice Earl Warren.

"[Earl Warren] said, 'Everything I did in my life that was worthwhile, I caught hell for,'" Brien said. "So here goes: Beverly Hills deserves better than the *Beverly Hills Courier*. Beverly Hills deserves a real newspaper that reports without editorializing, distorting or walking up to the edge of defamation and libel. Beverly Hills deserves a *Courier* so many of us grew up with: a paper that served the best interest of the residents by delivering

the news as news. *The Courier* operates with the presumption of power, intimidating public servants and ultimately discouraging good, decent people from running for public office; bullying our city employees simply because they can, knowing that our good and decent employees—real people with families—cannot fight back. This, my friends, is just plain wrong.”

Brien then assured City Manager Mahdi Aluzri, who has been attacked by *The Courier* in recent months, that he “has the support of many, including me.”

## Venoco files for bankruptcy

Petroleum firm Venoco filed for bankruptcy on March 18. The independent oil and natural gas company has operated in Beverly Hills since acquiring the West Field from Wainoco in 1995.

Under the Venoco oil lease, the BHUSD has been receiving approximately \$600,000 a year in royalties from the private corporation. Annual payments used to total \$1 million.

In 2011, the City Council voted to cease oil drilling no later than December 2016, which marks the end of the lease.

“The determination was that we did not want oil drilling in the City of Beverly Hills,” Councilmember Julian Gold said at a Southwest Homeowners Association meeting last April.

Venoco did not return a call from the *Weekly* by press time.

## Fine Art Commission rejects two artwork loan requests

At their meeting last Thursday, the Fine Art Commission turned down two proposals for loaned artwork.

UNIX Gallery had requested the city host LA-based artist Desire Obtain Cherish’s *Cherry Meltdown* for one year.

“I think it’s great fun and I’d love to see this somewhere,” said Commissioner Carolyn Hiller.

Commissioner Michael Smooke had different thoughts on the sculpture.

“This is not my favorite,” Smooke said. “I don’t know that it meets the same criteria as the other work that we’ve been dealing with.”

Later, the Commission unanimously rejected artist Stuart Kusher’s proposal that the city host his piece *Contessa* for five years.

## WeHo Mayor denounces Trump

In an email announcement Tuesday, West Hollywood Mayor Lindsey Horvath denounced Republican presidential candidate Donald Trump.

“I am compelled to state for the record how deeply disturbed I am by the Trump presidential campaign,” Horvath wrote. “It has gone beyond their right to express a political point of view or policy differences, which we all have to greater or lesser degrees. The hate speech and implicit calls to violence coming from Trump and his campaign are beyond the pale and have no place in any community in our country.”

Horvath, who was elected to the West Hollywood City Council last March, addressed the letter to her colleagues throughout L.A. County.

“With the primary making its way to California, as West Hollywood’s Mayor, I have stated for the record that his campaign of violence and intimidation is not welcome in our City,” Horvath wrote.

Mayor Pro Tempore Lauren Meister will succeed Horvath.

## Lauren Meister to become next West Hollywood mayor

Lauren Meister will be installed as West Hollywood mayor April 18.

“Lauren Meister is a very pro-resident councilmember who I think understands that local government is meant to serve the residents, and not special interests,” said Beverly Hills Mayor John Mirisch.

Prior to her election last March, Meister served on several commissions and committees, including the Planning Commission, the Campaign Finance Reform Committee and the District 1 Parking Committee. She worked on mitigating traffic and parking impacts of new and proposed city projects.

“It’s great for West Hollywood that they are going to have a truly pro-resident mayor, and I’m very happy for her,” Mirisch said. “I look forward to working with her to address the concerns of the residents from both of our cities.”

In 2013, Meister chaired the “Yes on Measure C” Term Limits for West Hollywood committee, which limited all councilmembers elected on or after March 2013 to no more than three full or partial terms.

A 25-year West Hollywood resident, Meister formed marketing research firm Meister & Associates in 1991. She earned a Bachelor of Arts degree in Sociology from the University of California, Santa Barbara.

**Public Works urges Council to prioritize recharging Cabrillo Reservoir**

The Cabrillo Reservoir was taken out of service in 1986 due to groundwater seepage, as profiled in issue #856 of the *Weekly*.

Recently, the city began capturing the non-potable groundwater and storing it inside a



portable water tank adjacent to the aquifer. Up to 4,000 gallons of the water is used on a daily basis for municipal services, including power washing the Business Triangle and maintaining wastewater lines.

“I’d like to move that the Public Works Commission create a resolution urging the City Council to adopt the \$3 million request for funds out of unallocated resources for the purposes of relining and re-plumbing the Cabrillo aquifer,” said Commissioner Jerrold Felsenthal at the Public Works Commission meeting March 10.

The Commission unanimously supported the initiative.

City staff has received bids for the Cabrillo Reservoir Lining Project—estimated to cost around \$400,000—and will make a selection late next month.

The preliminary estimate for the entire project, which encompasses the water treatment process and a conveyance system, is \$3.3 million.

“The issue before the city has to do with the unallocated funds at the moment,” Felsenthal said.

According to Public Works Services Director/Assistant City Manager George Chavez, the 2016-17 fiscal year budget is

expected to include funding for additional pipelines for the Cabrillo Reservoir, so that the water can eventually irrigate city parks and medians.

The capacity of the reservoir is approximately one million gallons.

A conversation with Orlowsky at 7 p.m. will lead up to the 8 p.m. performance.

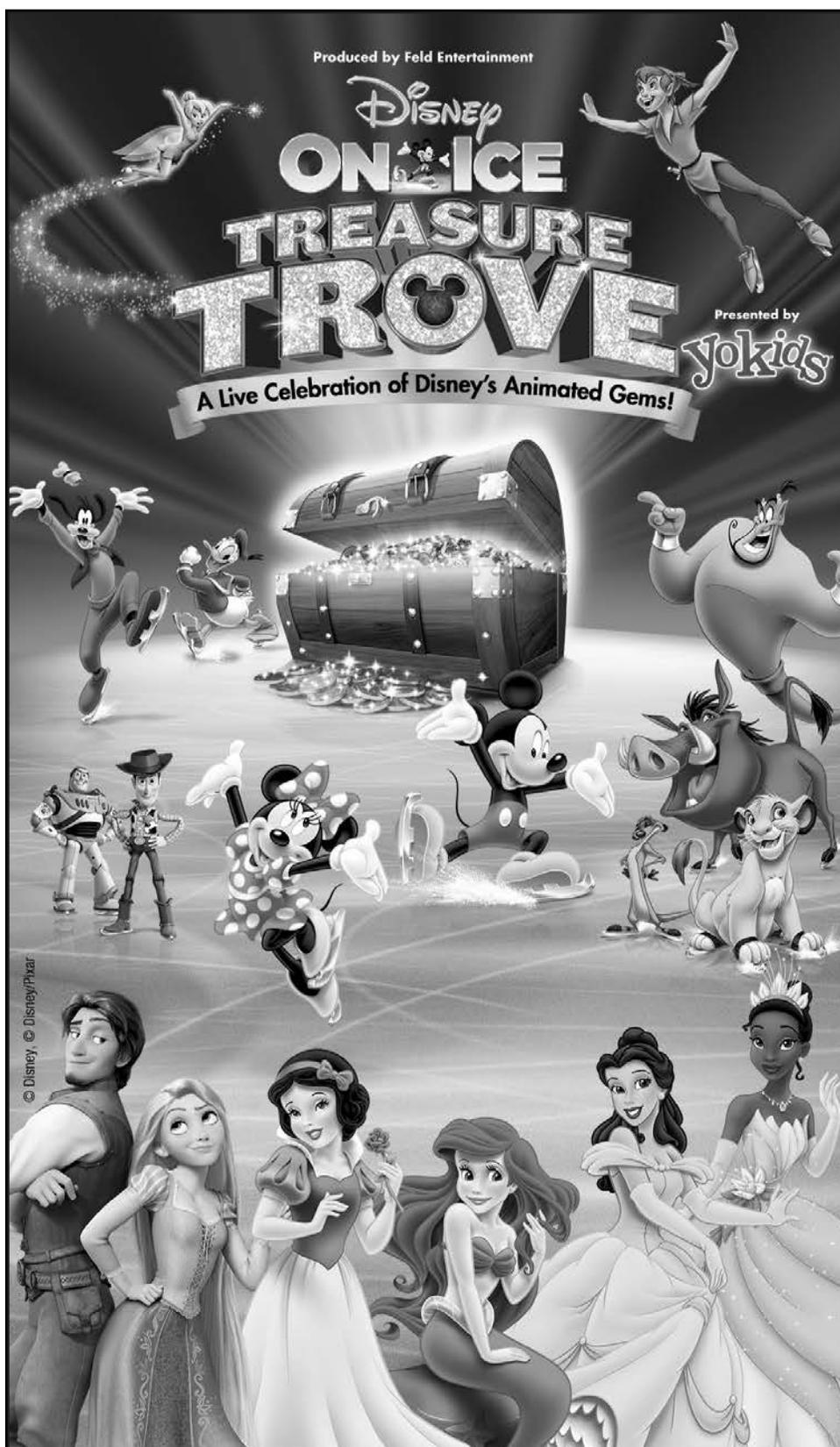

## BHHS boys' track team defeats El Segundo Norman girls' lacrosse team tops Marlborough

The Normans tied the score in the sixth as Stavroula Kyriazis, the No. 9 hitter in their lineup, led off with a double, moved to third on Carruth's single and scored on Lena Shapiro's ground out.

Carruth went four-for-four, while Elitzer, Kyriazis, Lindsay and Aleks Recupero each had two hits as the Normans out-hit the Pandas, 15-7.

Shapiro was credited with victory, limiting Immaculate Heart to two hits in 6 2/3 innings. Shapiro allowed four runs (three earned), struck out two and walked one.

Beverly Hills also scored three runs in the second and one in the fourth.

The Pandas scored once in the first and four times in the second.

#### What's Next?

The Normans are scheduled to play host to Environmental Charter Tuesday at 3:15 p.m. in a nonleague game.

## GOLDBERG FILES SUIT AGAINST ACCUSER, CITY OF BEVERLY HILLS

A year after the incident, many unanswered questions remain

Former Board of Education member Brian Goldberg has filed a lawsuit against the City of Beverly Hills and Nahal Yashar, Danny Yashar and Fariba Lavian alleging wrongful arrest, intentional infliction of emotional distress and negligence.

Goldberg was arrested by the BHPD last March on battery charges. The then-Board president had allegedly shoved 18-year-old Nahal Yashar, knocking her to the ground inside the Tower Drive condominium building where they both are residents.

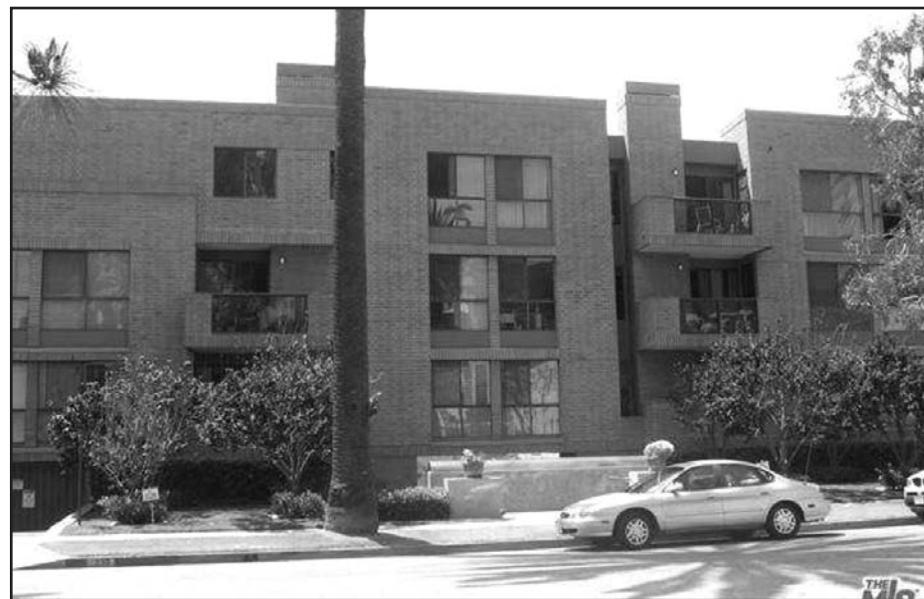
“The complaint is written in very general terms, but from what we can tell, our

officers acted appropriately,” said City Attorney Larry Wiener.

Attorney Ronald Richards, who is not involved with the case, thinks the complaint is defective on two grounds.

“It intentionally misrepresents that this was a citizen’s arrest, and it also doesn’t allege that a proper claim was filed first against the City of Beverly Hills,” Richards said. “This looks like a rush job on the eve of the statute expiring. Furthermore, it ignores the fact that the city has immunity under Penal Code 847(b)(1) for a citizen’s arrest.”

In the 17-page complaint filed by attorney Gregory W. Smith earlier this

month, Goldberg seeks judgment against the defendants on each cause of action, including physical, mental and emotional injuries, pain, distress, suffering, anguish, fright and nervousness.

“Mr. Goldberg has now opened up his entire mental history,” Richards said.

In the days following his arrest,

Goldberg stepped down as Board president, but was reinstated about a month later.

Smith’s office refused to release a copy of the complaint, despite it being a public document.

## A TREE GROWS IN L.A.

Newly appointed TreePeople CEO Cindy Montañez on creating a climate-resilient Los Angeles

**You served in the California State Assembly from 2002 to 2006. How did that experience prepare you for this role?**

When I was a member of the state legislature, one of my biggest passions was issues of the environment and natural resources, particularly environmental justice. My policy work was very much about urban sustainability and protecting California's beautiful environment, as well as looking at the urban environment. Having the opportunity to be CEO of TreePeople allows me to connect big policy issues like climate change and how cities adapt to becoming more climate resilient. [The position also allows me to] work with local neighborhoods all over the Greater Los Angeles Area to actually create models of sustainability that, from my perspective, have to be available so that we can take what we're doing in neighborhoods throughout Los Angeles and scale it county-wide, California-wide, country-wide and, even at some point, export these ideas to developing countries all over the world.

**Most recently, you were Assistant General Manager of the Department of Water and Power. You're now helming an environmental organization that promotes sustainable local water supplies. How are the two interrelated?**

When I was brought into the Los Angeles Department of Water and Power, it was specifically to be part of the team that was looking at how the largest municipal utility in the country, which is LADWP, could become cleaner in its energy and more sustainable with its water supply and delivery. Now we're discussing the Stormwater Capture Master Plan, groundwater contamination cleanup in the San Fernando Valley, increased recycling efforts and conservation. Being at TreePeople, I have the ability to work with one of our main partners in what we have called the Multi-Agency Collaborative, or MAC. The Multi-Agency Collaborative is a unique, one-of-a-kind concept that has actually brought together pub-

lic agencies like the Los Angeles Department of Power, L.A. Sanitation and L.A. County Public Works. So we brought everybody together to start coordinating and start having the discussion about how we as a region can start increasing our local water supply by turning to ancient, old concepts of storm-water capture. The relationships that I established as an Assistant General Manager of LADWP are relationships and partnerships that will allow us—along with TreePeople, LADWP, LA Sanitation and LA County Department of Public Works—to make these projects with storm-water capture a reality in neighborhoods throughout LA. So there couldn't have been a more perfect training.

**Why were you drawn to this opportunity with TreePeople?**

I want to make a difference in issues of environmental sustainability and I want to be a leader in the City of Los Angeles with TreePeople to make L.A. a model for climate resiliency—a model that can be scalable and taken to communities throughout the region, throughout the state and throughout

the world. There is no better place to show how a city can adapt to climate, address issues of the drought, deal with increasing air and water temperatures, look at sea-level rise; I mean, LA really is the perfect laboratory to develop the science, to develop public policy, to develop projects and programs that can be implemented to fundamentally transform and improve and prepare communities to become more climate resilient. When the opportunity came up to work with TreePeople and

work with a legend like [TreePeople Founder] Andy Lipkis, it just could not have been more perfect.

**Tell us more about TreePeople.**

I came across TreePeople when I was in my late 20s, a member of the legislature and working for very poor, underserved communities, like the northeast part of the San Fernando Valley. I came across this brilliant mind and man named Andy Lipkis, who was talking about storm-water capture and connecting the importance of the work that TreePeople is doing with my reality of being a state legislature for a very poor, underserved environmental justice community. [Andy] spoke to the work that we were doing and I saw the work that was done. In one of the poorest parts in the entire city of

Los Angeles, they did a storm-water capture project where they tore up a concrete asphalt playground and put in a storm-water system that allowed for water to be cleaned and recycled back onto the property. Where there was once an asphalt jungle, it became a beautiful running track with grass and trees and a playground for kids to actually be able to play in. I saw the work that TreePeople was doing—I saw a visual, tangible transformation of communities. I believed in the mission and the vision that they had because I was

seeing how the implementation of their mission and vision was transforming communities. TreePeople continues to be that. We have a mission and a vision that's about preparing communities, especially [in] L.A., to become more climate resilient by increasing the local water supply and the tree canopy.

**What are some of your responsibilities as CEO?**

My responsibility as CEO of TreePeople is going to be to make sure that this great vision of making LA the most climate resilient city in the world gets implemented; my job is to continue to encourage our team here to dream about what it is that we can do to make LA and the greater region the most climate resilient and sustainable city that we can, and ultimately implement that dream. I will do everything from getting my hands dirty and planting trees to meeting with major investors, donors and believers of TreePeople to bring us all together on a mission and a vision that most Californians share. Two out of three Californians will say that climate change is a real issue that needs to be addressed.

**TreePeople works with different levels of government to create policies that facilitate a greener L.A. infrastructure. Tell us about some of those policies.**

The overall Stormwater Capture Master Plan—the first of its kind—says that we are going to move towards getting at least 50 percent of our water from local water supply. The number one energy user in California is all the energy that goes into bringing water imported from the Sacramento-San Joaquin Delta. By increasing local water supply, we save energy, we make it more sustainable, we create a greener environment—and all of that leads towards job creation, healthier communities and preparing us for climates. It's a mission and a vision that benefits everyone and anyone, regardless of where you live and what your background might be. TreePeople is about investing in all of us.

**What is your top priority?**

My top priority is to be a champion all over Los Angeles, the State of California and the country in pushing these ideas that are practical and can be implemented that are coming out of this beautiful village that is TreePeople. [I want to] create those partnerships and find additional supporters to make Los Angeles the most climate resilient and sustainable city in the country, and take that model all over the world. My job is to be the champion and make sure that happens every day.
