

## Hilton project qualifies for ballot, Council supports Nov. 8 election

After hearing from a group that included former mayors Linda Briskman and Robert K. Tanenbaum, the City Council supported placing the Beverly Hills Garden & Open Space Initiative on the November 8th ballot Tuesday, sidestepping the possibility of a special election in September.

More than 10 members of the public spoke against a special election, arguing it would not have the same draw as the general election. Some speakers also noted that conducting a standalone election is estimated to cost \$130,000, whereas consolidating the measure with November's presidential election will cost \$42,000.

Collecting 3,980 valid signatures, the Beverly Hills Garden & Open Space Initiative qualified for ballot placement earlier this month.

The proposed project would result in the city's first-ever skyscraper, a 345-foot, 26-story residential tower designed by Robert A.M. Stern and planned for Santa Monica Boulevard and Merv Griffin Way.

"It's not a matter of whether it's illegal or not—it's clearly legal—but it does represent a very traumatic change and the first

time that we are looking to do business this way," said Councilmember Julian Gold.

By opting for the initiative route, the Beverly Hills Garden & Open Space Initiative has skirted the standard planning process undergone by other developments.

"This is precedent setting; it sets a potential pathway; it really does allow for a developer with money and a desire to do this same thing to move forward and do this yet again; it potentially creates a class system that developers with large campaign funds will be able to go through this process and everybody else who can't afford that will go through the traditional system," Gold said.

Agreeing that many unanswered questions remain, the Council ordered a 30-day report on the impacts of the measure. They are expected to review the materials at their

The initiative submitted more than 7,000 petition signatures last month (see chart below) to City Clerk Byron Pope. Roughly 3,200 valid signatures, or 15 percent of the approximately 21,000 registered voters in Beverly Hills, were needed to qualify the project.

### CA Supreme Court over- turns 2013 ruling that threw out Hubbard's conviction

The California Supreme Court on June 16 overturned a 2013 state appellate court ruling that reversed two convictions against Jeffrey Hubbard, who was BHUSD Superintendent from 2003 to 2006.

In January 2012, while superintendent of the Newport Mesa Unified School District,

Hubbard was found guilty of misappropriating public funds; namely, allocating funds for a \$350 increase in his car allowance in 2005 and for a \$20,000 stipend to former BHUSD Facilities Director Karen Christiansen in 2006.

Hubbard was terminated as superintendent of Newport Mesa following his con-

viction.

After being sentenced in February 2012, Hubbard served four of his 60 days in jail, the *Los Angeles Times* reported. He was also sentenced to 280 hours of community service, three years' probation, \$23,500 in restitution to the school district and a \$6,000 fine. The appellate court annulled all of his penalties.

Christiansen filed a suit for fraud against former BHUSD Superintendent Jerry Gross, construction firm Telacu Industries, Board of Education member Lisa Korbatov and several others in November 2013. The total judgment against the district exceeds \$20 million.

Hubbard's attorney Sal Ciulla did not return a call to the *Weekly* by press time.

The Planning Commission of the City of Beverly Hills, at a special meeting on **Thursday, June 30, 2016**, will hold a public hearing beginning at **7:00 PM**, or as soon thereafter as the matter may be heard to consider an ordinance to amend the development standards for the Hillside Area of the City (If you have received this notice, you either own or occupy property in the Hillside Area of the City). The proposed ordinance includes the following measures, which would apply to Hillside development projects until such time that permanent hillside development regulations, which will be studied by the City over the next several months, are adopted:

- No more than one thousand five hundred (1,500) cubic yards of earth material may be imported or exported from a site in the Hillside Area that is immediately adjacent to a street that is less than twenty four (24) feet wide, unless a Hillside R-1 permit is issued pursuant to Section 10-3-2550.A. of the Beverly Hills Municipal Code. The current limit of export/import before an R-1 permit is required is 3,000 cubic yards per 5 year period. The current regulation does not include provisions regarding the width of adjacent streets (BHMC § 10-3-2521).
- A level pad area must contain a level square-shaped area with minimum dimensions of twenty (20) feet per side for the level pad to be used to calculate the maximum permitted cumulative floor area of buildings and structures in the Hillside Area pursuant to Section 10-3-2502.B. of the Beverly Hills Municipal Code. The current BHMC standards do not include a minimum level pad size to qualify for use in maximum floor area calculations.
- The maximum cumulative floor area of the portion of any buildings and structures located off the existing level pad of any lot in the Hillside Area of the City shall be one thousand (1,000) square feet, unless a Hillside R-1 permit is issued pursuant to Section 10-3-2550 of the Beverly Hills Municipal Code. For purposes of this Interim Ordinance, "level pad" shall have the meaning set forth in Beverly Hills Municipal Code Section 10-3-100, and "existing level pad" shall mean the level pad in existence on the date this Ordinance takes effect. There is currently no limit to floor area developed off the level pad before an R-1 permit is required.

This Ordinance has been preliminarily assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The Planning Commission will consider the adoption and implementation of the Ordinance to be exempt from CEQA pursuant to Section 15061(b)(3) as there is no possibility that adoption and implementation of the Ordinance may have a significant effect on the environment because the Ordinance does not authorize construction and it would impose greater restrictions on certain development in order to protect the public health, safety and general welfare. Additionally the Planning Commission will consider if adoption and implementation of the Ordinance is eligible for a Class 8 categorical exemption pursuant to Section 15308 of Title 14 of the California Code of Regulations for actions taken to assure the maintenance and protection of the environment.

Any interested person may attend the meeting and be heard or present written comments to the Commission. Any comments submitted will be considered as part of the public record.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

corner of the Beverly Drive block of Beverly Gardens Park and the southwest corner of the Rodeo Block were among the sites discussed for the Tom Friedman sculpture.

"I think more people will see it and talk about it near Rodeo [Drive]—I think it also adds to the aura of Rodeo Drive," Commission Vice Chair Alan Kaye said in May.

The Commission supported the location at their May 19th meeting. According to Kaye, Recreation & Parks Commissioners Frances Bilak and Susan Gersh have indicated they have "no issue" with the spot.

"I think it's important to note the funds that we have for art is paid for by business owners in the city who have completed developments and—instead of putting art on their properties—given the funds to the city for us to purchase fine art in the city," Kaye said.

Though Recreation & Parks Commission liaisons are permitted to discuss potential locations for the city's public art pieces, they cannot deliberate the prices.

Born in St. Louis, Friedman is a conceptual sculptor known for his mixed-media pieces.

### Council OKs two new bike-share locations

The City Council supported the addition of two new bike racks to the Beverly Hills bike-share pilot program at Tuesday's study session. Twelve racks will be installed at

the northeast corner of South Santa Monica Boulevard and Wilshire Boulevard and nine will be brought to the La Cienega Tennis Center.

The Traffic & Parking Commission had also recommended stations at Will Rogers Park and Roxbury Park, pending additional review of equipment placement.

As of June 2, the program, launched May 10, had 30 bicycles in circulation and seven founding, eight monthly and 107 pay-as-you-go users. Founding members pay \$99 annually, monthly users pay \$25 and pay-as-you-go users are charged \$6 per hour.

The Council previously approved \$327,000 for capital equipment and year-one operating services. Ongoing contractual operating costs of approximately \$110,000 annually are budgeted with Measure-R transportation grant funds.

### Council supports one-year JPA extension

The City Council approved a one-year

extension of the Joint Powers Agreement (JPA) between the city and the BHUSD at their formal meeting Tuesday. The current four-year contract was set to expire June 30.

"We've appreciated greatly the collaborative efforts shared between the school district and the City of Beverly Hills," said BHUSD Superintendent Steve Kessler. "Our meetings with city and district staff, as well as Council, commission and school board liaisons for the past few months on the terms of the agreement have been cordial and productive."

Through the JPA, the city averages around 90 hours per day of district field and facility use, which amounts to more than 32,000 hours annually. In return, the district receives approximately \$9.8 million.

Pursuant to the agreement, a new JPA must be completed by the end of the year, no additional school facilities used for city programs can be taken off line and the Horace Mann multipurpose room and parking facilities must be made available for use by the public and city as soon as they open.

Earlier this year, the Board endorsed a nearly \$1-million contract with Asphalt, Fabric and Engineering Inc. for the addition of two U-10 soccer fields to the Beverly Vista play-field.

The COC was established to oversee bond proceeds, expenditures and audits associated with Measure E.




The production focuses on Dame Beatrice and her friends and lodgers, a tight-knit bunch who concoct an operation to return a stolen fur before its

“I think that he not only is someone who himself deserves to be honored for what he did for the country, but for what he did for our city.”

Rogers was an American cowboy, vaudeville performer, humorist, philosopher and actor. Though never mayor of Beverly Hills, he was deeply involved in city government and helped mobilize voters to

oppose annexation of Beverly Hills by the City of Los Angeles.

In the mid 1920’s, the president of the Beverly Hills Board of Trustees named Rogers “Honorary Mayor,” but the California Secretary of State later declared the title illegal and invalid.

The Beverly Hills Will Rogers Memorial Park is located at Sunset Boulevard and Beverly Drive.





### Ben Allen honored as 2016 Legislator of the Year

In a gathering Tuesday of over 200 Alzheimer's advocates representing the entire state of California, Senator Ben Allen (D-Santa Monica) was presented with the 2016 Legislator of the Year award by his constituent in the 26th Senate District, Elizabeth Gelfand Stearns, a former

local and national board member of the Alzheimer's Association.

As a freshman state senator, Allen distinguished himself immediately as a champion for the 610,000 Californians living with Alzheimer's disease and the 1.5 million family members and friends who provide care and support to a loved one battling a fatal condition with no known cause, cure or prevention.

Allen introduced Senate Bill 613, a measure signed into law by Governor Jerry Brown in 2015, requiring an update to California's outdated physician guideline for Alzheimer's disease management. According to the Alzheimer's Association's state policy director, Susan DeMarois, "an astonishing 55% of all patients affected by Alzheimer's or a related dementia have not been informed of their diagnosis by a doctor."

Formed in 1980, the Alzheimer's Association advances research to end Alzheimer's and dementia while enhancing care and support for those living with the disease. The organization provides a toll-free, 24/7 helpline (1-800-272-3900) with local offices in Los Angeles and throughout the nation.

### May BHHS Graduate to Swim in Olympic Trials

May Beverly High graduate Amy Okada will swim in the women's 100-meter butterfly in the U.S. Olympic Trials Sunday in Omaha, Nebraska.

Okada met the one minute, 1.19 seconds qualifying standard for the race by recording that time at the 2014 Summer Junior Nationals. The qualifying period began on July 30, 2014 and ended on Monday.

The fastest 16 swimmers in the preliminaries will advance to Sunday night's semifinals. The eight fastest swimmers in the semifinals will advance to the Monday's final. The top two finishers will qualify for the Olympic team.

### 1967 BHHS Graduate Makes \$1.5 Million Donation to CSUN

Irv Zakheim, a 1967 Beverly High graduate, made a \$1.5 million donation to fund renovations to Matador Field, home to California State University, Northridge's

baseball team, the university announced Monday.

Zakheim's donation will help fund a renovated entryway to the stadium, the first of multiple projects that will modernize a complex that is more than 50 years old, Director of Intercollegiate Athletics Brandon Martin said.

Zakheim was the starting second baseman for CSUN's 1970 Division II national championship baseball team. He played two seasons in the Chicago White Sox minor league system.

Zakheim is the chairman and CEO of Zak Designs, a company he founded in 1976 while importing puka shell necklaces from the Philippines. Zak Designs has grown significantly in the years since and today the global company is one of the leading distributors of licensed mealtime products and active lifestyle beverageware.

## David Haimovitz Incoming Chair of the Chamber of Commerce Board of Directors

### How did you become involved with the Chamber of Commerce?

In 1996, I became manager at the Bank of America in Beverly Hills at the Beverly/Wilshire office. And that branch and that bank had a long history with the Chamber: one of the former managers, Solly Laub, had been president of the Chamber years before and [was] very involved in the community. He was one of the people that invited me, being new to Beverly Hills, to get involved with



the community, with the Chamber and [to] do whatever else we could do to be civically involved. I followed his advice and started going to evening mixers and Chamber events whenever I could. Bank of America was a member of the Economic Development Council (EDC) and I started going to those meetings and started getting involved in that way; I started meeting people and getting familiar with the community. When OneWest [Bank] recruited me, one of the things they said was that their vision was to be very involved in the community and [to be] known as a community-based, Southern California

bank, and that was what attracted me to come here. Part of my plan with them was that I would get very involved with the community—even more than I was able to at Bank of America—and that helped me decide, after 30 years, to leave Bank of America and come here. Six years ago, we started this new OneWest branch, and the first week that I started with this company, I joined the Chamber and the EDC.

[OneWest] was still in the process of trying to build this office and they really didn't know how to navigate the city, and through that first week of me going to the Chamber and getting introduced to the people in the City of Beverly Hills, I was able to really help that process.

### Do you have a strategy for attracting new businesses and retaining existing ones in Beverly Hills?

I've been heading the Membership Committee for the last three years, and I think that's one of the reasons why they asked me to be Chair. As Chair, I'd like to focus on trying

to expand membership and look at the different business industries in Beverly Hills and look a little deeper to see what the Chamber can do for each different segment of business. A couple of years [ago], we established a Health and Wellness Committee. We're now looking at some focus groups on high-end luxury businesses and seeing what their needs are, and that's going to be the approach—looking at all the different segments of our businesses here and their needs and how the Chamber can help them. We're looking to continue our partnership and continue to have really good communication with the city and the residents. I'm also going to be looking for more ways to get a more involved membership, because it makes for a stronger Chamber. We're looking at using social media and marketing to help the communication here in the city, [because] social media is one of the ways we can reach a more diverse business community.

### How will your professional background shape your approach as Board Chair?

Some of the work on the Board of Directors is to keep an eye on the finances and operations of the Chamber, and so my background in banking and management is helpful in the day-to-day oversight that the Board needs to do. Also, leading people goes hand in hand. In my professional business, I'm leading a staff to try and grow our bank, and with the Chamber, we're trying to grow our membership and grow our usefulness to the community. So I think that's really similar.

### How has the Chamber evolved over the past 20 years?

The caliber of events has really improved and changed with the times. When I first joined, they had an old-fashioned, annual ball—things that really spoke to a different generation. And I've seen the Chamber be a lot more responsive in the type of events. I've seen more emphasis on networking and helping people's businesses in the last 15 years.

**In our interview with outgoing Board Chair Kelly Scott in issue #818, he said, "I have the feeling that for some [Chamber] members, a membership is like not knowing you have a Lamborghini in the garage, and you're not going to use what you don't know." What metaphor would you**

### use to describe a Chamber membership?

I would call it one of the best marketing tools available to our businesses that is so underutilized yet one of the most powerful tools that we have for marketing and growing our businesses.

### What are some things you've learned from Kelly Scott?

One thing the Chamber does really well is [create] a gradual process, so what Kelly has done over the last six months is get me more and more involved—it's not like all of a sudden I take over and I'm brand new. One thing that Kelly said to me was that we're not going to reinvent the wheel every year, but we're going to focus on doing a better job of what we're already doing.

### Tell us about your family.

I was born in Los Angeles and grew up right around Beverly Hills my entire life: I was bar mitzvahed at Temple Mogen David, which is right on the edge of Beverly Hills, and I went to Temple Isaiah as a teenager.

I'm married and have twin 18-year-olds; we live in Sherman Oaks. My daughter just finished her freshman year at UC Santa Cruz and she's currently on a birthright trip to Israel. My son is at Diane S. Leichman High School, he has some special needs, he's autistic, and we've been very involved over the years with that community. My wife and I—especially my wife—very actively belong to Temple Beth Hillel in Studio City and our whole family is very involved there. Our immediate family is very involved with extended family and community—those are two values that we all share.

### What are you most excited about?

I'm most excited about getting to know even more people in this community and being able to bring some more excitement and attention to the Chamber. I hope that we have a really successful year with our members and make it a fun place to do business.

## BY DESIGN

### One Beverly Hills architect Michael Palladino on how the project both fits in and stands out

*Proposed for the former Robinsons-May site, One Beverly Hills will feature a 134-room luxury boutique hotel and 193 residences. The Weekly spoke to Michael Palladino, who is the principal designer and one of six partners at Richard Meier & Partners Architects.*

#### What drew you to One Beverly Hills?

Quite frankly, it's an extraordinary property when you think about it from an architect's perspective: the property is between high-rise Century City, mid-rise Beverly Hills and residential space. Any time that you have an opportunity to make an architecture that really can mediate between low rise and high rise, there's always potential there. And for this site, the [Los Angeles] Country Club adds a whole other dimension. Most of the time, architecture that's in an urban fabric is related to the real order of streets and other buildings, but being backed up to the Country Club is like having one of the most beautiful gardens in Los Angeles in your backyard, so it was the site for one reason. But also, it's the location in Southern California—the opportunity to build at the gateway to Beverly Hills is an extraordinary opportunity. Beyond that, at least 12 years ago, the program was for all residences, all condominiums, and we [Richard Meier & Partners Architects] design houses, we design larger buildings—museums and city halls and court houses—but we design houses. And building homes is an important part of what we do.

#### In a video on One Beverly Hills, you said the project is an “extraordinary opportunity to revitalize the west gateway to Beverly Hills.” How will it achieve this?

You create a moment. Wilshire Boulevard is Wilshire Boulevard. Coming from Westwood, it's suburban and urban, and then you come along the country club, but because of the landscape, you don't really see into the country club. Just as you get past the country club, it opens up again, and the question is: What does it open up to? It could either open up to 10 more buildings with nice scale, but all the same, or something exceptional. Here, we were looking for what would create the exceptional. On one hand, it's an urban

architecture, so it's got a definite reference to the street, but the shapes of the building are also designed to be organic and they really draw from the landscape of the country club. As you approach this building, it won't be like the other buildings in Beverly Hills, partly because they're not backed up to the country club. [One Beverly Hills] is an approach to the city, but it's an approach that's a soft approach with an architecture that's curvilinear, that has a shape to it; it's a site-specific building, so it will be different, and the gateway will have a slightly different architecture than the rest of the city.

#### How has One Beverly Hills evolved since you first surveyed the project site 12 years ago?

When it comes to creating the right design, it needs to be “site specific”—all that means is that it could only work right on this site, at this location. [One Beverly Hills] is a little higher on the south end as it comes towards Century City, but then it terraces down to the scale of the community. The design process isn't about the solution, it's about the process; it's not about the destination, it's about the journey. And the journey in architecture is the design process, the design evolution. You can't just start and make the final solution, it would never happen. This was a long process, but remember, it involved architects, engineers, the city, the planning department, the Planning Commission, the City Council, the building department—all of these are stakeholders—and the community, the community was part of all the public hearings. You put all of this together and the building will really evolve. It's a collaborative effort with a lot of engineers and architects, but also, other stakeholders in the community. Therefore, just the architect by himself can't imagine it—it's got to have that process and that influence to become an architecture that's of this place. In this case, [One Beverly Hills] is of this place today, but it's also timeless.

#### Describe the architectural style.

The style is driven by the site, it's driven by the place—it's not driven by trying to be contemporary or to be of today or to be of yesterday. The style comes direct-

ly from the problem, from the program and from the place. In [the case of One Beverly Hills], the place includes community. There are other places where you can build where there is no community—it's out in the mountains. But when you're building in an urban setting, you have to engage the community and the urban context that you're building in. Style has many different dimensions, but for us, we don't start with trying to design in a style, we start with the program, the problem and the place. If the architecture evolves in that way, it has a better chance of being there for a long time.

#### How have technological advancements allowed you to realize the full scope of your creative vision?

There has been a lot of technological evolution in the 35 years I've been practicing architecture.

Probably one of the most profound, for me, is the sizes and the quality of glass that we can buy today that you couldn't get just 15 years ago. First of all, the glass today is designed with high performance codings that let us design very energy efficiently with glass. The glass facades for One Beverly Hills are designed so that they're getting sun at the time of the day that we want the sun and they are not getting the sun at the time when we want to keep the sun out, because it's a hotter time of day. For years and years, glass had a tint to it. Glass technology has gotten to the point where we can use clear, clear glass—water-white glass. It's glass with no iron in it, so it's like crystal. If you make dark glass, it means the light can't come in, and if the light can't come in, then you need to turn the lights on. By making clear glass, but managing the direct sun, we can make buildings like One Beverly Hills that don't need a light on all day. You don't need to turn the lights on because we can bring quantities of daylight to the interior space.

#### Daylight plays a major role in One Beverly Hills. Why?

Any project built in Southern California that doesn't take advantage of the extraordinary daylight is a missed opportunity. The daylight here is about as good as it gets. It's a Mediterranean quality of light: the quality of the light is there, but it's also got a little bit of softness to it that comes with moisture in the air from being by the ocean. And that light is so predictable that we can design around it—we know

exactly where the light is coming from, the angles in the summer, the angles in the winter; we know when it will set, meaning the architecture can work on engaging that light. In Southern California, the most valuable resource we have is the quality and quantity of the light.



**Tell us about some of the other projects you've worked on, like the Getty Center and the Broad Center at UCLA.**

I moved from New York to Los Angeles in 1986 to open this office when we started working on the Getty Center.

At the time, I said that'll be about three or four years, and then I'll go back to New York. It took about 10 years to build the Getty Center. The Getty Center experience was exhilarating and it was frustrating, it was exhausting, and in the end,

it was worth it, because it makes a real contribution to the City of Los Angeles. As a visitor to the Getty Center, it gives you not just the experience of the Getty—the art, the restaurant and the collection of books—it gives you a chance to see Los Angeles in a way that only you can see it from an elevated location. The Getty Center has become a civic center that people gravitate to, to participate in the buildings, but it's also a place to meet, a place to spend a Saturday or Sunday afternoon.

The Broad Art Center was a wonderful opportunity, and we love designing on university campuses because there's so much to manage—from vehicle traffic, pedestrian traffic, obviously lots of different buildings with different functions. It's one of those really interesting problems of how you overlap all of those things and create an architecture that's engaging, and yet responsive, to the program.

#### What do you find most satisfying about being an architect?

It's wonderful to see, after the building is done, how it ends up being used. [When you] design based on a program, you're designing for very specific functions in order to make it efficient. It's not unusual that after a building gets done, that it gets used in lots of different ways. The Broad Art Center is a good example. The space we designed became part of a performance art with artists making installations on the façade—nobody could have predicted that, nobody said, *make the building so that it can become a canvas for art*. But it became one.
