A RESPONSE TO ROBERT K. TANENBAUM'S COURIER LETTER

In an op-ed in support of the Hilton's skyscraper initiative, former Beverly Hills Mayor Robert K. Tanenbaum writes, "Knowledge Will Forever Govern Ignorance."

However, as former Senator Daniel Patrick Moynihan liked to say, "Everyone is entitled to their own opinions, but not their own facts." To support Tanenbaum's opinion, he has created his own new facts.

In listing a "massive regulatory scheme" in dealing with some of the technical details of the project, Tanenbaum tries to suggest that the vetting eight years ago by the Planning Commission and City Council of the original approved project automatically should transfer to the new proposed skyscraper, which the developer would have the residents believe is really a public park.

Of course, technical building and safety standards imposed by state law can never be circumvented. But arguing that vetted environmental issues remain in place is the reddest of herrings. The adverse environmental impacts, including shade

and shadow and traffic, which were studied more than eight years ago, are not necessarily the same as for a 375-foot skyscraper. The suggestion that it would be kosher for a developer to "reconfigure" a property by stacking buildings on top of each other without going through a full review process is absurd. How would Tanenbaum like it if a neighbor – in order to add "open space" – built a four-story home next door, while not adding any square footage, without going through the full city review, including public input?

Tanenbaum writes that "the initiative process allows the City Council to exercise its right to obtain a study of impacts, in any, which may occur as a result of the proposed project." Another half-truth.

To compare a 30-day study with a full review process, which includes public input and extensive studies and CEQA scrutiny, is just as deceptive as the Hilton's multi-million-dollar propaganda campaign, which hides the true height of its proposed skyscraper.

Tanenbaum writes: "There are no new impacts. The daily construction oversight, monitoring and compliance will remain in full effect." Again, here he tries to conflate technical safety standards with the larger question of lasting impacts on our quality of life in the City of Beverly Hills. Neither he nor anybody else is able to factually ascertain "there are no new impacts." And a 30-day review is no substitute for the full review that a project

of this magnitude requires. A 375-foot skyscraper is simply unprecedented in the history of Beverly Hills. It is more than double the height of the current highest building in Beverly Hills and more than 7.5 times higher than our General Plan allows for a standard commercial building. Tellingly, Tanenbaum doesn't ask the question: If this is such a bagatelle, why doesn't the developer simply go through the process – like every other Beverly Hills developer in the last 100 years?

Tellingly, Tanenbaum doesn't ask the questions: What kind of City do we want to be? Do we want to be the Wilshire Corridor? Do we want to be Century City? Do we want to be a City that allows a single developer with his deceptive advertising to buy an entitlement that violates our city codes and quality of life?

Finally, through ignoring facts, Tanenbaum attempts to trivialize the possible domino effect that setting a precedent could create. He attempts to paint the project as “sui generis,” or one-of-a-kind. He provides no evidence as to why a different developer, emboldened by Beny Alagem's chutzpah with the Hilton, would not try the same tactics in the name of profits. Every developer believes their project is one-of-a-kind and could use the initiative process to overstate a questionable benefit while hiding a major impact. Beny Alagem, the Hilton's co-owner, is trying to sell a skyscraper by advertising that the new project is a public park. In reality, the Hilton initiative would only add .65 acres of private green space. The proposed park is not public—it's private and controlled by the Hilton. But, the new building, a skyscraper, is 70 feet higher than the Stature of Liberty, including the base.

And if the Hilton is allowed to build a 375-foot skyscraper, what's to stop One Beverly Hills next door (former Robinsons-May) from making the same argument? Why should they not be allowed to build a 375-foot skyscraper? Or maybe a 500-foot skyscraper? They, too, received entitlements eight years ago by the Planning Commission and the City Council. They also are subject to “extensive, comprehensive construction oversight and monitoring... and mitigation measures.”

Tanenbaum suggests that because the Hilton has passed on taxes in the amount of \$70 million over the past 10 years

(in reality, taxes which are mostly paid by hotel guests, not the developer), they should somehow get special treatment. This is perhaps the biggest fallacy of them all.

First of all, the Hilton can base its own success largely on its prime location and the incredible amenities and cachet that the City of Beverly Hills provides. But secondly – and most importantly – it is critical for government at all levels not to play favorites, not to judge development projects on developer propaganda and pretty pictures, but rather on objective thoroughly vetted standards. Tanenbaum would do well to heed the words of Benjamin Franklin, who once said: “I am a mortal enemy to arbitrary government.”

“Lawn Bowling Green presidents criticize Rec & Parks for May comments” [Issue 875]

PLEASE TAKE NOTICE that a public hearing notice was published on July 8, 2016 in the Beverly Hills Courier identifying that on July 19, 2016 at 7 p.m. the Council of the City of Beverly Hills will consider adopting an ordinance entitled “An Ordinance of the City of Beverly Hills regulating Landform Alterations, Expansions of Level Pad Areas of Lots, and Development off the Level Pad of Lots in the Hillside Area of the City”. This item has been rescheduled to the City Council's August 16, 2016 meeting at 7 p.m.

PLEASE TAKE NOTICE that on Tuesday, August 16, 2016 at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, the Council of the City of Beverly Hills will consider adopting an ordinance entitled:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS REGULATING LANDFORM ALTERATIONS, EXPANSIONS OF LEVEL PAD AREAS OF LOTS, AND DEVELOPMENT OFF THE LEVEL PAD OF LOTS IN THE HILLSIDE AREA OF THE CITY

The proposed ordinance includes the following measures, which would apply to Hillside development projects until such time that permanent hillside development regulations, which will be studied by the City over the next several months, are adopted:

- No more than two thousand (2,000) cubic yards of earth material may be imported or exported from a site in the Hillside Area that is immediately adjacent to a street that is less than twenty four (24) feet wide, unless a Hillside R-1 permit is issued pursuant to Section 10-3-2550.A. of the Beverly Hills Municipal Code. The current limit of export/import before an R-1 permit is required is 3,000 cubic yards per 5 year period. The current regulation does not include provisions regarding the width of adjacent streets (BHMC § 10-3-2521).
- A level pad area must contain a level square-shaped area with minimum dimensions of twenty (20) feet per side for the level pad to be used to calculate the maximum permitted cumulative floor area of buildings and structures in the Hillside Area pursuant to Section 10-3-2502.B. of the Beverly Hills Municipal Code. The current BHMC standards do not include a minimum level pad size to qualify for use in maximum floor area calculations.
- The maximum cumulative floor area of the portion of any buildings and structures located off the existing level pad of any lot in the Hillside Area of the City shall be one thousand (1,000) square feet, unless a Hillside R-1 permit is issued pursuant to Section 10-3-2550 of the Beverly Hills Municipal Code. For purposes of this Ordinance, “level pad” shall have the meaning set forth in Beverly Hills Municipal Code Section 10-3-100, and “existing level pad” shall mean the level pad in existence on the date this Ordinance takes effect. There is currently no limit to floor area developed off the level pad before an R-1 permit is required.

This Ordinance has been preliminarily assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City Council will consider the adoption and implementation of the Ordinance to be exempt from CEQA pursuant to Section 15061(b)(3) as there is no possibility that adoption and implementation of the Ordinance may have a significant effect on the environment because the Ordinance does not authorize construction and it would impose greater restrictions on certain development in order to protect the public health, safety and general welfare. Additionally the City Council will consider if adoption and implementation of the Ordinance is eligible for a Class 8 categorical exemption pursuant to Section 15308 of Title 14 of the California Code of Regulations for actions taken to assure the maintenance and protection of the environment.

Any interested person may attend the meeting and be heard or present written comments to the City Council.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

Please note that if you challenge the City's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing or in written correspondence delivered to the City, either at or prior to the end of the public hearing.

Council: No consensus for public “rebuttal” period

Though the City Council agreed at their July 5th study session that community input plays an important role during meetings, they also acknowledged the practical challenges of expanding public comment

Council discussion. The City of Beverly Hills currently allows members of the public three minutes to speak. Conversely, the City of West Hollywood gives one minute.

“The public is deliberately, from my standpoint, and unnecessarily excluded from even knowing about things even after the fact, when the confidentiality aspects of it have long since expired,” said Municipal League Chair Thomas White.

Vice Mayor Nancy Krasne firmly opposed the proposal, and said it sets a “very bad tone in the chamber.” Mirisch, who said he thinks both Krasne and White are right, indicated the Council may revisit the discussion if there is a way to avoid “[dragging] out the meetings.”

The Brown Act, adopted by the State of California in 1953, assures that local government agencies conduct the public’s business openly and publicly.

“Everything would be a debate, and then I don’t think we could ever move anything forward,” Reims said. “I think public input is essential, I get that, but being mindful of the fact that you have to move the meeting along and make decisions.”

Councilmember Lili Bosse was out of the country and absent from the meeting.

Lieu applauds Court’s sentencing of “swatting” perpetrator

Congressmember Ted Lieu (D-Torrance), who represents Beverly Hills, issued a statement Tuesday about the sentencing of “swatting” perpetrator Mir Islam by the Department of Justice to 24 months in prison. In April 2013, Islam,

posing as Lieu, had reported to police that he had shot his wife at their home in Torrance.

“I want to thank the Court today for rendering

the appropriate sentence for the perpetrator who caused so many people much

distress,” Lieu said. “I believe ‘swatting’ is a serious crime that can result in injuries or death. It causes significant disruptions to first responders and is a wasteful allocation of critical resources that should otherwise be used for real emergencies.”

The Department of Justice sentenced Islam on three federal charges for conspiracy to commit various crimes, including “swatting” and “doxing” numerous victims, as well as making bomb threats and engaging in online cyber-stalking.

As State Senator, Lieu had authored California State Senate Bill 333, which increased the fines an individual would have to pay for making false 9-1-1 calls.

“Elected officials should never be criminally targeted or become victims of crime because of legislation we choose to author,” Lieu said. “It is my hope that this sentencing will deter others from committing similar criminal acts.”

Traffic & Parking supports phasing out several valet spaces

The Traffic & Parking Commission supported an initiative June 7th to remove several spaces from valet operations in the city’s business triangle in order to increase the number of parking meters available for on-street public parking.

Through the issuance of permits, Beverly Hills operates valet parking services which operate within the public right-of-way. A valet permit

costs \$1,700 annually.

“It is my opinion that we have a matrix of standards for setting up valet spaces,” said Commissioner Lester Friedman. “If there were some sort of standards that we set in terms of how many uses there are there, how big the facilities are, I think it would be a lot easier to come up with recommendations.”

Eight of the current 48 valet operations are conducted in private lots or alleys with no assigned on-street parking spaces; ten of the 48 are shared valet operations,

funded and used by more than one business.

“We had talked with the Chair and Vice Chair about potentially making them customer loading zones in the evening—that has the advantages that people could use them for take out,” said Deputy Director of Transportation Aaron Kunz.

Kunz said the operators have agreed to reduce the Ruth’s Chris Steakhouses spaces from four to three; Xian and Café Roma from four to three; and Il Pastaio from five to four.

Sugarfish, located at 212 North Canon Drive, recently requested a third valet space and an additional operational hour, but the city turned down the meter request due to slow vehicle turnaround.

“I think that [staff is] going to have to be fluid on this with the reconstruction on Santa Monica Boulevard, also, because we want to make sure that the businesses are able to survive during that reconstruction period,” Friedman said.

In the past year, the modifications made to valet services in the city include the Kiyono-Urth Café valet zone signs on South Beverly Drive being changed from “6 p.m. – 12 a.m. Daily” to “6 p.m. – 12 a.m. Monday through Saturday.”

Nathan returns as Design Review Commission chair

The routine rotation of Design Review Commissioners took place last Thursday, resulting in the appointment of Vice Chair Ilene Nathan to the position of chair and Commissioner Mahnaz Sharifi Ardani to vice chair.

“What I’m hoping to achieve this time around is we’re trying to get the Planning Commission to give us oversight in the hillside, and I think they’re amenable to that,” Nathan said. “We believe that the entire city should have equal oversight. If you live north of Sunset [Blvd.] right now, you really, and for the most part, don’t come to us for approval—that’s usually approved by the city staff and the Planning Commission—and we would

Project proposed for 527 North Palm Drive

Design Review sends North Palm Dr. project back for restudy

At their July 7th meeting, the Design Review Commission sent back for restudy a two-story, single-family residence planned for 527 North Palm Drive.

The Commission was generally accepting of the Contemporary-style project, helmed by design firm Tag Front, but agreed the landscape was in need of enhancements.

“More large trees in the front, but particularly more deciduous trees,” said Commission Chair Ilene Nathan, who also had an issue with the front fence.

Commissioner Arline Pepp applauded the variety of materials used in the project, but said the building was a “little massive for the residential area.” Pepp called for a “softening” of the structure.

“I just think the front—although I know you have 40 percent glazing—kind of gives me the impression of this being a medical or dental office—it’s kind of got that static look to it,” said Commissioner John Wyka.

The revised design is expected to come before the Commission at their August 4th meeting.

“We will make those changes that you’re asking for, of course, but I think the reasoning behind it was because I think the house should tell you what it’s about,” said Tag Front co-founder Mandi Rafaty.

like to have oversight in that area.”

Nathan will round out her seven-year term on the commission as chair, a position she previously held in 2013.

“We don’t want the City of Beverly Hills to look like a track of new homes, we want each home to fit into the neighborhood, and we want the applicant to be happy with their project, so we try to accommodate the applicant, the neighbors, our criteria, and I think we’re achieving that,” Nathan said.

A real estate agent with Keller Williams, Ardani joined the Commission in January 2015.

Commission in May, a resolution to establish a new preferential parking permit zone on the 500 block of North Canon Drive was approved by the City Council at their July 5th meeting.

“I certainly want more enforcement,” said Vice Mayor Nancy Krasne. “I think a lot of these problems would evaporate if people were getting citations on the street for parking.”

On May 5, the Traffic & Parking Commission considered a resident-initiated petition to implement a “No Parking Anytime” regulation on the block. Though commissioners Jake Manaster and Nooshin Meshkaty supported the proposal, Commissioners Lester Friedman, David Siedel and Andy Licht stood behind an evening parking restriction recommended by city staff.

The resolution will establish permit zone “BT” on the 500 block of North Canon Avenue between Park Way and

Carmelita Avenue, including the adjacent sections of Carmelita. The regulation permits two hours of parking 8 a.m. to 8 p.m. Mondays through Saturdays. Parking is prohibited from 8 p.m. to 2:30 a.m. daily, unless residents have a valid “BT” permit hangtag.

Alan Levine, who has lived on the southwest corner of North Canon Drive and Carmelita Avenue

for 32 years, urged the Council to “look at this on a much grander scale” and “take a big step.”

“I think it was one of our police chiefs that said the community wants more citations, but when it’s up to them, fewer tickets,” said Councilmember Julian Gold.

The Council agreed that increased parking enforcement is part of the long-term solution.

Beverly Hills experiences growth in tourism, visitor revenue

The Conference & Visitors Bureau announced Wednesday that the City of Beverly Hills has continued to grow in tourism and visitor revenue since its record results from Fiscal Year 2014-2015. The Average Daily Rate (ADR) for the city’s hotels is up 5.3 percent and Revenue Per Available Room (REVPAR) is up two percent from the year prior.

The organization also experienced major growth in the interactive and social media spaces, including a 46-percent YOY growth in organic searches to the Love Beverly Hills website, a 47-percent increase on its Chinese website, as well as a 132-percent increase in Instagram and a 43-percent increase in Facebook followers.

In addition to hosting its fifth annual Chinese New Year event, which was another sold-out show at the Saban Theatre, Beverly Hills launched two major initiatives within the first half of 2016 to emphasize the city’s position as a leader in the luxury sector: *The Future of Luxury* global trends report and *The Definition of Luxury* multi-channel marketing campaign.

Looking ahead, the Conference & Visitors Bureau has increased its travel trade and public relations representation to produce strategic opportunities for Beverly Hills in key feeder markets, including

expanded representation in the United States and in Europe.

Tell us about your role as assistant director of Ace Gallery.

I work under Sam Leslie, the plan agent appointed to run Ace Gallery. We work as a team to curate exhibitions, make sales, run the gallery operations and focus on the direction that the gallery is going.

How did you get involved in the art world?

I grew up painting and went to [Pomona College] to study art, art history and media studies, so it's been a part of my life since I was a child.

Tell us about the artwork currently on exhibition.

At our Beverly Hills location we have Natalie Arnoldi on exhibition and Matt Hope, as well as a selection of other artists in the back gallery. Natalie Arnoldi is a painter, and her current exhibition, *Below Sea Level*, is a collection of paint-

THE SENATOR FROM SANTA MONICA

Ben Allen on bills, lobbyists and getting things done in Sacramento

In November, it'll be two years since you were elected. Tell us about the experience so far.

It's been a fascinating experience. [The 26th district, which includes Beverly Hills] is a diverse district with a lot of different kinds of people and a lot of industries and a lot of needs and interests. Every day I try to come up with thoughtful and creative solutions to some of these very pressing policy challenges that we have as a state and as a community. I love the mixture of substance and theatricality, and the fact that everything we do is meaningful and really does impact people's lives. My job is to listen to everybody and try to understand broad challenges that we have and try to come up with creative, thoughtful solutions. The other thing I do, of course, is I have to cast judgment on other people's bills. That's also a really interesting process because sometimes [the bills] may have been written in ways that I may not have written them, and I have to cast a "yes" or "no" vote, and sometimes there's the challenge of, well, you may love 70 percent of the bill and hate 20 percent, and what do you do in a situation like that? You typically would vote yes on a bill like that, but then there are oftentimes parts of the bill that you really don't like. And part of the challenge is coming up with a thoughtful approach to casting votes.

Why did you choose to tackle the controversial issue of mandatory child vaccinations right after you were elected?

We were seeing that vaccination rates were lowering in our area and we had parents coming to me saying "What are you going to do to help protect our kids?" There were mothers who wanted to be able to take their babies to the store without [the] fear of contracting a dangerous communicable disease. I quickly learned that school districts' hands are tied when it comes to requiring tighter rules, and that's what ultimately led us to SB 277, which was done in conjunction with Dr. Richard Pan, who's a pediatrician and senator from Sacramento. From a personal perspective, my father had

polio; it's a debilitating disease and I had the chance to learn quite a bit about it. People in [my father's] generation can't believe that we've allowed these dangerous communicable diseases back into American society, and I believe ultimately, the government has a role in protecting our public health and protecting our broad-based society. But there's a heartfelt opposition and I've spent time talking to them and working with them. We've tried to moderate the bill to allow for some limited exemptions while also making sure that our eyes were on the prize with regards to boosting overall vaccination rates.

A recent bill you sponsored resolved a loophole in the law with regards to HIV patients donating organs to each other. Tell us about that.

It was a story of a stigma that needed to be addressed of a problem in the law—the idea that if you're HIV positive, you can't donate an organ to an HIV-positive person, even though it's proven to be perfectly safe—was a real problem and it needed to be addressed. So I caught wind of this loophole—but it's not really a loophole, it was a law passed during a day and age when we knew much less about HIV, and it was related to certain stigmas that we must now address. I had the bill moving through the legislative process, and then, all of a sudden, it turns out there was a case in San Francisco that needed addressing immediately, where someone needed to have a transplant within three weeks or they would die. Twenty-two Americans die every single day waiting for an organ transplantation—this is life-and-death stuff, and if we can do what

we need to do to take at least some of the organ transplants off the market by providing a new pool of people who can safely donate, we're going to be saving lives. In this case, there's a life that's going to be saved as a result of this bill.

What's a typical week like as Senator?

Every week is different, but when I'm in session, I'm up in Sacramento a lot of the time. I fly up either Sunday night or Monday morning and I'm up there through Thursday afternoon or Friday. When I'm in Sacramento, it's a ton of hearings and going over bills; I'm presenting bills, I'm voting on bills, we also have floor session, where you're voting on bills and you're also giving speeches. A lot of it is considering voting on, dealing with, drafting [and] amending bills. There's also the budget process. I serve

on the budget committee, and so that's another big part of my job. I serve on the subcommittee that oversees the education budget—I'm one of three senators serving on that subcommittee, which is about half the state budget, so it's a big portion. We have regular hearings [with] various stakeholders and agencies who manage the budget; we'll hear from the University of California, the K-12 system, the county offices of edu-

cation and the community colleges and the Cal States, and we'll ask them questions and we'll make modifications and we'll increase budget here and decrease it there. Then, of course, there's a fascinating negotiating dance that takes places between the senate, the assembly and the governor, and I play a small part. It's a fascinating mix of legislation and budgeting. Then you come down to the district and you're going to events and meetings and taking tours of various facilities.

You're one of the youngest state senators. Tell us about that.

I'm in my late 30s, I served for six years on the [Santa Monica-Malibu] school board, I was on the [UC] Board of Regents for two years, so it's not like I'm a spring chicken. The campaign and this job have certainly taken a physi-

cal toll on me, but I do think it's very valuable to have some younger voices around the table and provide a new generational perspective. Part of it is that I'm closer to the education experience. For example, something like half of our budget is in education, and for some of my colleagues who are significantly older than me, their time spent in the education system was so long ago that it's hard for them to fully grasp all the trends that are happening culturally, societally and pedagogically. That's not to say we don't have some extraordinarily talented, smart, experienced members of the legislature who I have learned a lot from, but it's good to have a few members who are [closer] to the younger generation, who ultimately have the most to lose or gain from the decisions that we make.

What aspect of the job is most different than you thought?

Fundraising is a big aspect of the job—I guess I knew that coming in, but it's a little relentless. The logistics are difficult: going from serving on a local school board in Santa Monica and Malibu, it was easier, it was a smaller universe. I think that part of what's interesting about the job is the way that people's feelings about an issue or their interests associated with an issue get distilled up to interest groups and lobbyists in Sacramento. There's a voice for nearly every interest out there; every organization under the sun has an interest group that's out there in Sacramento weighing in on bills. We really rely on them to some extent to understand all the implications of the bill, so it's been interesting to get a better understanding of the role of lobbyists. Sometimes it can be a corrosive role, but sometimes it's a very helpful role, in the sense that we don't have the time to vet every bill. Good lobbyists are actually really helpful to the process in the way that a good lawyer can and should be. There are bad lawyers, and lawyers can often cause a lot of damage in a situation, but a good lobbyist ideally plays the role of a good lawyer in advocating for their client and putting forward the best possible argument. It's our job as legislators to impartially and ethically cast judgment on those arguments—that's of course where some of my colleagues fall into trouble. So that's been interesting to get to know.

What's the most rewarding part of your job?

I really like the diversity of the work; you get to work on so many different issues, it's incredibly meaningful, you get to help people and change people's lives every day.

ORDINANCE NO. 16-O-2705

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING MINIMUM NUMBER OF OPERATING TAXICABS PER FRANCHISEE

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The city council hereby amends and restates paragraph F of Section 7-4-102 ("FRANCHISE REQUIREMENTS") of Article 1 ("Taxicab Franchises") of Chapter 4 ("PUBLIC TRANSPORTATION VEHICLES") of Title 7 ("TRAFFIC, PARKING, AND PUBLIC TRANSPORTATION") of the Beverly Hills Municipal Code to read as follows:

7-4-102: FRANCHISE REQUIREMENTS:

F. Each taxicab franchisee shall maintain in operation in the city at all times a minimum number of properly permitted taxicabs as determined by the transportation official or such higher number as specified in its franchise agreement.

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the city within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the city Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this city.

Section 4. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
