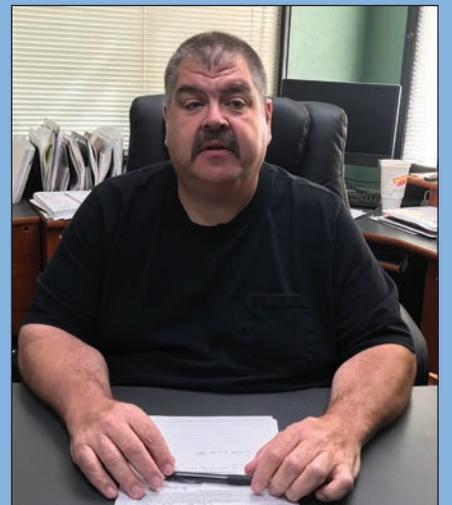

## “Lago Vista Showdown” [Issue #906]

My wife Anne and I have owned our home at 1271 Lago Vista Place for 15 years. We love the City of Beverly Hills but vehemently oppose the 1260 Lago Vista Drive project. Everyone has a right to build a home, but nobody has a right to circumvent an ordinance for their personal benefit.

1. There is no topographical hardship that prevents them from building a 6,000 square foot house as of right. The neighborhood would be fine with that. It is the extra hauling they request so they can build a bigger house than as of right that we are objecting to.

2. Our house is on a 50,000 square foot lot and we are approached all the time to sell to a developer for our unobstructed view from the tip of our promontory. They all envision building two or perhaps three mega mansions on our site. Frankly we have a big financial incentive for you to approve the R-1 permit for 1260 Lago Vista Drive. Yet, we oppose. We bought our home in Beverly Hills for the quality of life, not to make money.

3. For the staff of [the Planning] Commission to find this development would

have limited impact on our neighborhood is, frankly, absurd. I encourage [the commissioners] each to visit the hairpin -steep-blind curve where the house sits. I suspect it is the most dangerous in the whole city. In fact the rest of the street is no piece of cake either. The danger of this street with heavy trucks is Trousdale on steroids. Have we not had enough tragic accidents? If it occurs is the staff going to say it happened during the “as of right phase” and not the additional work allowed by our granting an exception to the ordinance and therefore not feel responsible? We do not care how many flagmen the developer offers to pay for - we will not feel comfortable walking in our own little area.

4. Their proposal is for the trucks to make a left turn on Coldwater. That means traffic will be stopped in both directions while the trucks turn left and then lumber up the hill. Instead of the “Coldwater Crawl” extending back to Sunset, as it sometimes does, it will extend down to Santa Monica and perhaps beyond.

5. We understand that an as of right project will have some of the same concerns described above. But to allow a 50 percent bigger project just because a developer wants to make more money is not what our community is about. It means a 50 percent increase in risk of injury and disturbance to quality of life to the neighborhood.

6. [Planning Commission] staff keeps saying the “scam” aspects of basement plan is not within their purview as currently there

## City Council approves new rent stabilization ordinance; reduces relocation amounts

At the first meeting of the new City Council on Tuesday night, a new rent stabilization ordinance was unanimously approved.

The new ordinance repeals the urgency ordinance approved by the former Council at the end of January. The Council's decision to pass the urgency ordinance created an ongoing dispute between landlords and tenants.

A majority of renters were in favor of the ordinance because it capped annual rent increases at three percent. Prior to the urgency ordinance, a tenant's rent could be increased at a maximum of 10 percent

annually. In addition, the ordinance established relocation fees payable to tenants for "no just cause" evictions.

Many landlords felt they were under-represented throughout the creation of the urgency ordinance. The relocation fees and the rent increase cap leave them with limited options for evicting "problem tenants."

The new ordinance changes little from the original urgency ordinance, except relocation fees payable to tenants were decreased.

Councilmember Robert Wunderlich called the ordinance "interim." Many of the councilmembers agreed their approval of the ordinance was contingent upon plans to continue public outreach and create a law that fairly represents the interests of both parties.

Wunderlich also suggested the City hire an independent real estate professional to help mediate future conversations about rent stabilization.

"We [should] consider hiring a consultant, a real estate expert, perhaps a university professor to help sort through these issues, since these are issues people around the country have had to deal with before," Wunderlich said.

Councilmember Les Friedman attempted to make a friendly amendment to the ordinance by suggesting the inclusion of a sunset clause.

"The reason I'm asking for [a sunset provision in this ordinance] is so we make sure this process moves along quickly," Friedman said. "I don't think it's fair to the tenants or the landlords if this drags on too long."

Mayor Lili Bosse disagreed with

is no rule against calling a living room with windows a basement - even though I understand such a new rule is being contemplated. Yet why do they enable this scam by encouraging an exception to the hillside ordinance. Is the developer and his expediter more important than us?

7. Finally I ask [the Planning Commission] a simple question: If this project - which is

exactly on a street specifically designated by the ordinance and does not have a topographical impediment to building an as of right house - is approved, then what good is the ordinance at all. [The Commission] will be hard pressed to ever turn down any proposal in the future.

Friedman's suggestion.

"I do not believe we need a sunset because that would be random, I don't know what number we would pick or when we would pick it. I think it's clear that this is a priority for all of us."

A sunset clause was not included in the new ordinance.

The Council plans to discuss this issue at its next meeting on April 20.

Fred Sutton, Apartment Association of Greater Los Angeles Director of Government Affairs, told the *Weekly*, "Housing providers in Beverly Hills are very excited to welcome the new Council. We are hopeful the legislative body will bring a more fair, balanced and nuanced approach to these ongoing discussions. Independent Rental Owners need financial flexibility to not only operate their buildings but to be able to continue to offer top notch services."

## Lago Vista neighbors continue the fight

Lago Vista neighbors have returned with an online petition to boycott the proposed construction of a 10,228 square foot single-family residence at 1260 Lago Vista Dr.

The online petition, created on Monday

by neighbor Debbie Weiss, asks the Planning Commission to deny the developer's application for a Hillside R-1 permit.

The Commission was expected to review the permit request back in February, but was advised by the City to postpone the hearing after a movement of over 20 neighbors reached out to the City Council with grievances about the noticing process.

Since then, neighbors have sat down for a meeting with the developer's representatives to discuss reducing the scale of the project. However, the developer was unwilling to mitigate the scope of the project "because the developer then would not achieve his profit aspirations," according to the description written in the change.org petition.

The developer is Robert H. Shapiro of Woodbridge Investments. Shapiro, not to be confused with the prominent defense attorney of the same name, is represented by Crest Real Estate.

The petition outlines several reasons why the project will have "substantial adverse impact on the surrounding neighborhood."

Residents in support of the petition argue that "granting an R-1 permit in this instance will undermine the purpose of the Hillside ordinance."

In August, the Council adopted the Hillside Ordinance modifying the previ-

ously existing regulations regarding the earth material export threshold for properties located on streets less than 24 feet wide.

It was determined that the proposed project, which involves a request to export 2,498 cubic yards of earth material, will require a Hillside R-1 permit because the total import and export of earth material from the site will exceed 1,500 cubic yards and Lago Vista Drive has a street width of 22 feet.

Attorney and project neighbor Ronald Richards is one of the leaders of the opposition movement. He told the Weekly that project proposals are not well vetted before they appear in front of the Commission.

“The [city] staff does not [do] independent verifications of any of the devel-

opers’ submissions,” Richards said. “Unless there’s opposition, these things just get rubber stamped all the time.”

He also explained that there is a new ordinance in the works to keep developers from being able to tack on additional square footage by disguising it as basements.

“Council indicated to the Planning

Commission that they want a new basement ordinance to eliminate the fraud of calling [a new addition] a basement when [it is above ground],” Richards said. “[The ordinance will] basically eliminate this loophole where [developers] pretend they’re building a basement to avoid the maximum allowable structure [on] the hillside.”

Over half of the square footage for the proposed 1260 Lago Vista Dr. project is dedicated to a basement. 3,038 square feet of the total 5,085 square feet making up the basement is considered “exempt” because it will be under the designated first floor.

Another one of the main concerns expressed by neighbors is the extra traffic from construction. Lago Vista Drive is a narrow, steep street. The project is

located directly on a hairpin turn, which will potentially be dangerous to anyone using the street.

A special Planning Commission meeting to discuss the proposed construction is scheduled for Wednesday, April 19 at 7:00 p.m.

## Jergens bows out of Beverly Vista PTA presidential race

Incumbent Vice President April Jergens announced last Sunday she will no longer be running for president of the Beverly Vista PTA.

In an email sent from Beverly Vista Green Tree News, Jergens wrote a letter explaining why she decided to drop out of the race.

“Tuesday’s election was marred by irregularities and extremely close,” Jergens

wrote. “Most importantly to me, the voting showed a divided school. We should be role models for our children, and a divided school and the associated social media vitriol isn’t good for them, the PTA, or Beverly Vista, all of which I hold dear

after so many years of involvement.” She added backlash from the contested election resulted in unwanted press attention for the school.

“Our school should be getting press for academic excellence, success in the Science Olympiad, our choir going to Carnegie Hall, our band and orchestra BOTH getting gold at the Forum Music Festival, and our students’ strength of character, not because we parents are squabbling over the PTA and its bylaws.”

The disputed PTA election was invalidated by the 33rd District on Tuesday, March 28. Prior to the election, 33rd District also voided the executive board slate because the PTA’s creation of the nomination committee did not follow the governing body’s bylaws.

Jergens and Beverly Vista parent Cynthia Park both nominated themselves from the floor on the day of the election. After the votes were totaled, Park appeared to be the winner by a close margin.

However, current PTA Historian Don Rosen, who is also Jergens’ partner, told the Weekly a recount of the votes revealed 95 ballots were cast; although, only 84

individuals were registered and eligible to vote [Issue #913].

Park remained the only announced candidate, as of press time.

A reelection is expected to be scheduled before the end of the month.

## BHPD names Marc Coopwood new assistant chief

Sacramento Police Captain Marc Coopwood, a 22-year law enforcement veteran, has been named the Beverly Hills Police Department Assistant Chief of Police.

Coopwood will be sworn in at a public ceremony April 24 at 3:00 p.m. at the Wallis

Annenberg Center for the Performing Arts.

As second-in-command to Police Chief Sandra Spagnoli, Coopwood will assist the chief in overseeing day-to-day operations as a key member of the department’s senior policy team.

“I am honored to become a member of the [BHPD],” Coopwood said in a statement. “This is a top-notch organization that proudly serves a world class community. I look forward to working closely with Chief Spagnoli and members of the [BHPD], to continue in moving the department forward. Through partnership with city leaders, employees and the community, we can accomplish great things.”

Coopwood began his career with the Sacramento police Department in 1994 and was promoted to Sergeant in 2004, Lieutenant in 2011 and Captain in 2015. He has managed a variety of assignments including patrol, narcotics, special operations, internal affairs and investigations.

He is the current president of the California Peace Officers’ Association. Coopwood holds a Master’s Degree in Emergency Services Administration and a Bachelor’s Degree in Criminal Justice. He attended the FBI National Academy, POST Command College and the PERF Senior Management Institute for Police.

“[Coopwood] has had a solid track record in enhancing police services, mentoring and statewide leadership,” Spagnoli said in a statement. “He exemplifies the department’s core values of Respect, Integrity, Courage, Commitment and Honor.”

## Local coin dealer Kevin Lipton pays \$3.29 million for rare 1804 silver dollar

One of the world’s most famous rare coins, an 1804-dated U.S. silver dollar that was actually struck in the 1830s for a diplomatic mission on behalf of President Andrew Jackson, was purchased for \$3,290,000 last Friday, March 31 by

Beverly Hills coin dealer Kevin Lipton.

Offers to buy the 1804 silver dollar started coming in after word that Lipton jointly purchased the coin with long-time friend John Albanese of Bedminster, New Jersey for \$3.29 million.

“We bought this coin on spec and were real-

ly quite shocked that our bid was successful,” Lipton said in a statement. “[Albanese] and I both thought it would sell for \$4 million or more on Friday night. By Sunday, we had six interested parties who were calling, sending emails and texts wanting to buy the coin from us.” After considering the offers, Lipton and Albanese subsequently sold the coin to Laura Sperber of Legend Numismatics in Lincroft, New Jersey for an undisclosed price. She purchased it on behalf of Bruce Morelan of Spokane, Washington who she describes as a “Super Collector.” Morelan reportedly owns the finest known collection of early American silver dollars.

“We didn’t have any customers for it Friday night; we just thought at \$3.3 million that it was the best buy of a high value rare coin in the last 20-plus years,” Lipton

U p o n Friday’s purchase, it was the second time Lipton had owned the historic 1804 dollar. He and Los Angeles dealer Hugh Sconyers paid a then-record price of \$990,000 in 1989, and a few years later privately resold the coin for a profit at an undisclosed price.

Only fifteen 1804-date silver dollars are known today. No silver dollars dated 1804 were actually struck that year. Researchers believe eight of the surviving examples, including the coin Lipton recently sold, were made by the United States Mint in the 1830s to be given as diplomatic gifts for a State Department mission to the Far East and Asia.

Decades later, Mint employees made a handful of other, similar examples of 1804-dated dollars for collectors.

In January 2015, Lipton set a record for the highest price ever paid for a penny, \$2,585,000 for an experimental one-cent copper coin produced in 1792 during the early days of the U.S. Mint.

## Freshman wants Beverly Hills residents to save big

Beverly Hills resident and real estate syndicator Samuel Freshman recently authored a new book, *The Smartest Way to Save Big*. The book is the third in the series offering tips on how to spend less and save more.

Freshman told the Weekly he was inspired to start the series after counseling an individual who made \$6 million annually, but “was always broke.”

“The bottom line is, it doesn’t matter how much you make,” Freshman said. “It’s how much you spend, not how much you make. People who may have modest incomes [can] become very wealthy because they save and invest.”

He noted that many of the residents in Beverly Hills can afford to save or have used savings as a way of developing their wealth.

“Particularly anyone who lives in Beverly Hills, if they can afford to live there, should be able to save,” Freshman said. “Most people in Beverly Hills, [especially] if they live north of Wilshire [Boulevard], make more than they need. It’s not what you want, it’s what you really need. A lot of [those people] don’t even have a college education and yet they’re multi-millionaires. Most of them started at very modest jobs through small businesses.”

Freshman also indicated that he believes the biggest over spending in Beverly Hills is on weddings. There is a chapter in the book with information on how to budget for weddings.

“Most parents of daughters who are about to get married should definitely get a copy of the book. This is where I see a lot of unnecessary spending.”

Freshman is the founder of Standard Management Company. He has been responsible for the acquisition, development and management of approximately \$500 million of real property in 11 states and more than 25 cities.

## Beverly Hills and WeHo join forces to find senior transit services provider

Beverly Hills, in conjunction with the City of West Hollywood, plans to release a joint request for proposal in May or June for the management, operation and maintenance of the cities’ senior transit services.

Beverly Hills Transportation staff is currently working with West Hollywood staff to create a request for proposal from local and national transportation companies offering transit/ dial-a-ride and taxi subsidy programs.

An informational item in Tuesday’s City Council staff report indicated the purpose of a joint request is “to attract a larger pool of qualified transit operators.”

The transit and taxi subsidy program for resident seniors and disabled persons are fully funded with transportation grant funds such as Proposition-A, Proposition C and future Measure-M funds, according to the staff report. Special charters requested by City departments are charged

directly to the department and are included in contract costs. The transit service programs contractual costs are approximately \$750,000 for the senior Dial-A-Ride and Trolley, and \$277,000 for the senior taxi subsidy program.

The senior transit programs are available residents 62 years of age and older and disabled residents of any age. The senior taxi program subsidizes \$18 of taxi fare value for the discounted cost of \$6 per month, for a total of \$24 taxi fare value, per participant.

The senior transit services include free curb-to-curb shared dial-a-ride transportation for medical and personal appointments; dedicated Roxbury Park and super-market shuttles; narrated trolley tours of the City; on-demand special charters for City department needs and private charters for Beverly Hills civic organizations.

In the report, staff proposed enhancements such as door-to-door service with an on-board ambassador to assist participants that require extra help, repurposing the trolley vehicles to address current tourism needs, and replacing the eight year old paratransit shuttles.

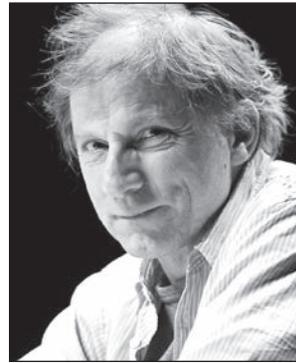

## AN APPLE FOR THE TEACHER

A look at this year's Apple Award recipients

**KALIA SCHEINER**  
Beverly High Hebrew Teacher

Kalia Scheiner came to Beverly High in the fall of 1988. Her initial assignment included two small, multi-level Hebrew classes.

Throughout her time at the high school, the demand for Hebrew has increased tremendously. Shortly after her arrival to Beverly High, Scheiner was teaching five to six large classes. She also rewrote the Hebrew curriculum and selected new textbooks adopted by the administration.

She is the sole Hebrew teacher at the only public high school, west of Chicago, offering Hebrew language courses. She encourages all students who show interest in Hebrew by sponsoring the Jewish Student Union/ Jewish Culture Club, where weekly meetings are held in her classroom during lunch.

"I was overwhelmed when [Principal] Dave Jackson told me that I would be this year's recipient of the Apple Award," Scheiner said. "I truly feel honored. It is so nice to be recognized and appreciated for all that I do for our students in the district."



**ELIZABETH SCHWAB**  
Beverly High Special Education Teacher

Elizabeth Schwab has been teaching special education at Beverly High for five years. When Schwab started at the high school, she took over a brand new Moderate/ Severe Special Education program.

Over the past five years, Schwab has worked to establish the PrIME curriculum and structure. In conjunction with this, she has spent the past two years developing a PrIME Transition program servicing students ages 18 to 22. The program helps integrate students with intellectual disabilities into the community.

During the short time the transition program has existed, Schwab has helped get three students onto company payroll.

"This award is such an honor to receive," Schwab said. "I don't feel like it should be just for me, but [it] should be shared with all the instructional assistants and students in my classroom. They also contribute in large part to making the PrIME Special Education program what it is today at Beverly Hills High School."

Carly Versteegen began her teaching career at the Milwaukee public schools. Before moving west with her husband Justin, Carly was offered a Special Education teaching position with the BHUSD. She says she "jumped at the chance to work for a high-profile district."

She then moved back into an elementary teaching position at Beverly Vista and has been teaching the second grade for six years.

Beverly High Principal

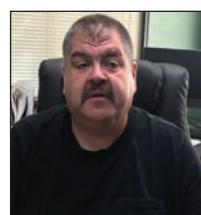
Dave Jackson has worked in many different areas of education, but says he is particularly fond of the high school level "mainly because of the kids."
