### “Town Hall Meeting”

Four issues were brought forth at the March 13 Town Hall Meeting, two of which deserve greater exposure.

The first was brought by Councilmember John Mirisch who informed the attendees last night of a possible existential threat to our city. California Senate Bill 827, introduced by Senator Scott Wiener (D-San Francisco).

This bill, if passed, would require a local government to grant developers the right to build multi-family, multi-story buildings all over our R-1 residential blocks.

Think about the effect of this proposed state bill. It would force local governments, specifically our beautiful 6 square mile city, to allow the building of multi-story condos and apartment buildings deep into the blocks of residential single family homes, significantly transforming Beverly Hills, its landmarks, balanced residential and commercial landscape and way of life, into an over-developed mega-metropolis.

This measure would compel blocks and blocks of our beautiful and some landmark single family homes, from Olympic

Blvd to north of Sunset Blvd., to be overrun by 5, 6, 10 story condominium buildings! Imagine multi-story condos and apartment buildings between Santa Monica Bl. and north of Sunset Bl. engulfing small patches of single family homes. Now imagine all homes from Wilshire Blvd to Olympic Blvd overshadowed the same way!

The very nature and character of what we know as Beverly Hills would be lost and along with it our way of life and our attraction and admiration from the entire world.

Moreover, property ownership rights and the local control of cities to plan and regulate development would be supplanted by state law in favor of (greedy) developers who don't care what havoc they wreak after extracting their profits from one after another development project.

This is a direct attack on property ownership rights and the rights of local governments, who answer to the voice of its residents, to plan and design the life and livability of their own city.

However well intentioned SB 827 may appear, its results in short order, could completely destroy Beverly Hills forever, decimating property values and our way of life. Do not be fooled.

If we, the residents of Beverly Hills, sit back and allow Sacramento to dictate to us how we will live, the life we know will be adversely changed forever.

your neighbors on SB 827. Oppose this bill from ever seeing light out of committee by organizing and contacting our State Senator, Ben Allen!

Which brings me to the second issue. Steve Weinglass made an appeal at the Town Hall meeting which bears repeating. We must pay much more serious attention to elections-local, state and national.

The right to vote and the responsibility to know what we are voting for will only be of benefit if we read and become educated on what's written on the ballot.

Elections include referenda, measures and propositions that require majority votes for passage. California is renowned for its production of voter passed initiatives, many of which have titles that sound

so benevolent and civically minded which are, in reality, deceitful and misleading.

Beware of the title of proposed legislative measures! More often than not they are written to mislead and mean to make you want to vote for measures, had you read the language of the proposal, you would never, ever be in favor of.

We should be a society of educated, civically engaged and responsible citizens. Instead, we are distracted by our smartphones, Facebook feeds, daily obligations and careers. But if we delegate all of our civic decisions to political action committees and deceptive, misleading electoral and initiative campaigns, we will end up living in a world we will deeply regret.

Read the text of every proposed ballot measure. If its confusing-and often it is deliberately written to be so-ask your city council, local bar association, council

member, etc. to organize a debate so that both sides can elaborate and explain the meaning behind the proposition. Insist on transparency from the proponents as to who is funding the campaign and why. Seek out organizations like the League of Women voters whose raison d'être is the parse through the camouflage and help us understand the essence of what we are being asked to support.

Above all, take a lesson from the brave high school students across the country this week. They are not only speaking out and up to our elected officials and representatives, they can't wait to cast their first of many ballots and have their voices heard.

Over 200 years ago, this country was founded on a grand experiment: democracy. Every other nation on earth was lead by monarchy, emperor or dictator. Our

nation was founded on the principle that each citizen's vote was equally weighted to decide the course of our government and future of our country.

The experiment only survives if we exercise our constitutional right to vote. Inspire your children to cherish their right to vote by demonstrating how much you value it yourself. Engage your children to learn about the issues (and educate yourself in the process). Do not allow the grand experiment to fail by atrophy.

We are admired the world over for our freedoms. They will only be enforced and survive if we are vigilant to keep them alive.

## Gold Installed as Mayor

On Tuesday evening Julian Gold was installed as the new mayor of Beverly Hills during the annual ceremony at the Academy of Motion Picture Arts and Sciences.



Councilmember John Mirisch was sworn in as vice mayor.

Both were formally elected by the rest of the Council in a unanimous vote.

Sworn in by his wife Michele and daughter Becca, Gold's acceptance speech focused on how to achieve a "strategic vision" for the commercial areas of Beverly Hills.

Gold traveled back in time, reminiscing on the early beginnings of Beverly Hills when Georgio was first created and Rodeo Drive was a mere idea.

Gold emphasized the importance of Beverly Hills' pioneering steps in offering its citizens a "true experience," which ultimately transformed the City into an international tourist destination.

But he also pointed out that neighboring cities like Santa Monica and West Hollywood have followed the City's footsteps in providing "experiences" like restaurants, shopping malls, and less expensive housing for their residents..

In order to compete, Gold says, the Council will assemble a steering committee

to discuss the City's vision for the future. These conversations will dive deep into identifying the commercial areas of town and determining the most appropriate use for them.

"As wonderful as our commercial district is, as much as we love the look and feel of Beverly Hills, we must look to the future," said Gold. "How can we improve what we have, being mindful of our heritage but aware of our competition? We must find a way to compete where, perhaps, we have not had to compete before."

Newly sworn-in Vice Mayor John Mirisch also made a lengthy speech, where he addressed the rumors swirling around the potential closure of "Nate'n Al" Delicatessen, a Beverly Hills institution for several decades.

Mirisch emphasized the integral effect of the deli, stating that it is part of the DNA that makes the City "home" to so many people. He said that losing "Nate'n Al" would be "the City's version of a national disaster."

The event also featured several video packages, a musical performance headed by Temple Emanuel Cantor Lizzie Weiss, and a subsequent reception replete with sushi and desserts.

## Only 76 Percent of Beverly Hills Children in Public School, Study Says

On March 13 the Board of Education heard presentation about the 2017-2018 BHUSD demographics, as the district has experienced declining enrollment in recent years.

Davis Demographics found that only 76 percent of school-aged children in the area are enrolled in public school. A reported 5,427 school-aged kids reside in the district.

Comparably, a Las Virgenes Unified School District study found that 96 percent of school-aged children in their district are enrolled in public school.

"The district embarked on getting updated information for the Future Focused Schools Team and just for the future of our school district," said Superintendent Michael Bregy on the purpose of the report.

Davis Demographics Technology Director Scott Torlucci said that projections are based on the resident student population under the belief that "facilities should be located where students live."

Torlucci said that Davis used area demographics instead of school enrollment because area demographics don't change as often or as easily as school enrollment changes.

The process included collecting data relevant to BHUSD's current and future student population, creating short to mid-term student population forecast, analyzing and reporting on the findings, and analyzing student capture rate and transfers.

Davis used a GIS (Geographic Information System) to find street database of the area and the student attendance areas, which were broken down into "study areas" based on main streets and have anywhere between 10-75 students.

They subsequently took the student data files and geocoded them to the given address.

Davis found that births in the area have declined over the last 15 years. 2007-2008 averaged around 389 births, while the last year has averaged around 369.

"It's not a direct one to one correlation, but we do see that the kindergarten class does mimic what's happening in the births," said Torluccio, noting that kindergarten classes have declined as well. "It's the best indicator that we have."

Torluccio said that kindergarten classes are projected to decline a little bit more over the next few years and then stabilize out. The entire district is expected to stabilize at 3,700 enrolled students.

In the 1990's and 2000's, total BHUSD enrollment exceeded 5,000.

The decline is most prevalent between 6th and 7th grade, where as low as 89 percent of students are attending secondary school elsewhere.

Torluccio also noted that 52 percent of Hawthorne students live outside the designated Hawthorne zone.

"Overall, your TK-12 enrollment has declined over the last few years," said Torlucci. "We're showing a slight decline still over the next couple years but not at the same rate."

fulfill their duties and responsibilities," said K-12 School Facilities Consultant Bill Savidge.

Roles of the COC are to inform the public concerning the expenditure of

bond revenues, actively review and report on proper expenditure of taxpayers' money for school construction, and advise the public on whether or not the district has met California Constitutional requirements.

These requirements include ensuring bond revenues are expended only for con-

struction/replacement of school facilities and ensuring that no funds are used for other school operating expenses like administrative salaries.

Savidge said that staff continuity—i.e. leadership and team changes—delays in construction and false starts have hampered efforts to build a strong capital program.

He pointed out that the COC can do their part by engaging in discussion and consideration. This means providing "clear, understandable" financial reporting, capital program procedures updates, updated schedules, audit responses and staff support areas.

COC member Jason Lund said it was not clearly communicated at the last meeting that the Board opted to use new construction funds (approved from a previous bond) to restart the seismic mitigation program.

"It's unfortunate that if we're looking to increase transparency and communication, that Mr. [Don] Blake is not here today," said Lund. "This committee only meets once every two months."

The program, according to Savidge, will cost between \$6-8 million.

"I'm a strong advocate for building the internal capacity of the school district, so having an internal role long term—that should be a goal."

Superintendent Michael Bregy indicated that staff will add a full-time Director of Facilities that reports directly to him.

### What Will Happen with Art During Construction?

On March 15, the Fine Art Commission voted 4-0, with Chair Michael Smooke absent, to allow a piece at 9390 Wilshire Boulevard/160 North Canon Drive to move to storage during Metro construction.

Since the building will be demolished and the entire site will be used for construction staging of the Rodeo Station of the Metro Purple Line Extension Project, the piece—called From the Belgium Suite by Ewerdt Hilgemann—would have otherwise not had a home.

The decision follows developer Arnold Rosenstein's request that staff store the piece, as the art piece satisfied the art requirement when the building was last under construction.

But, according to Community Services Director Nancy Hunt-Coffey, the Fine Art Ordinance is "fairly silent" in respect to the status of existing art while demolition and construction is occurring on the property.

"Obviously you don't want

to leave the art there during demolition or while there are substantial comings and goings of materials," said Hunt-Coffey, adding that storage of the piece is the best option for the duration of construction.

In order to track the piece that has been placed in storage and ensure it will be put back after the multi-year project, Hunt-Coffey said that staff will keep an inventory of developer-owned art and make a notation of where it is stored and why.

Staff will also execute an official agreement with the owner allowing him to put the piece in storage and put a notification in the online business center.

Commissioner Zale Richard Rubins said to make sure the piece is both "secured" and "insured" before storing it. He also suggested specifying the ordinance in case a similar situation arises in the future.

"That might be a good thing for you guys to think about when there are changes like this so that we don't have to keep reinventing this and you know what the process is going to be," said Rubins. "There are renovations all the time and pieces of art will have to change and if this is the first one out, it might be a good time to get that covenant."

### Fine Art Commission Discusses Kusama Issues with City Attorney

On March 15 the Fine Art Commission discussed a recent meeting between Chair Michael Smooke, Vice Chair Zale Richard Rubins and City Attorney Larry Wiener regarding Yayoi Kusama's "Hymn of Life: Tulips," which is current-

ly facing potential re-fabrication.

At the meeting they recounted a letter from Rosa Lowinger & Associates Consultants on the state of the piece and suggestions

on how to move forward.

“We concluded there is a fundamental flaw in the design and fabrication of the work,” read the letter, pointing out that the piece was made of maquette and required a thick pipe that created a high metal to fiberglass ratio. “This statement is not to assign blame; they are simply facts.”

Community Service Director Nancy Hunt-Coffey said that although staff spent the past month exchanging correspondence with the Kusama studio, the conversations left them with “more questions than answers.”

Both Rosa Lowinger & Associates and Wiener agreed that refabricating the piece and painting it either bronze or stainless steel are “viable” options.

The idea for re-fabrication originally stemmed from cracks that had appeared in the piece. Both the studio and commissioners first thought they were caused by people climbing atop of the Kusama, but later discovered the culprit was that the fiberglass and steel beneath were expanding and contracting differently.

The commission recently extended their warranty in order to fix these issues.

### BHPD to Form Police Chief’s Advisory Panel

In support of the 20-year Police and Community Together (PACT) initiative, Police Chief Sandra Spagnoli has announced the formation of a community panel, designed to expand the BHPD community outreach.

The Chief’s Advisory Panel will be established under the direction of the Chief of Police and created to act as a community resource for the Chief in the formation of strategies, development of community policing concepts and increasing public awareness.

The panel is intended to provide a forum for discussions concerning community concerns and the goal is to have a broad spectrum of viewpoints represented.

The rotating membership of the panel will be comprised of up to 20 citizens from throughout the community who represent a range of interests and experience. Members are from diverse backgrounds, including business, education, non-profits, public relations, faith-based community and more.

The role of the panel members includes, but is not limited to acting as a sounding board for the Chief of Police regarding community needs and concerns, as well as providing community feedback to current and proposed police programs and priorities, apprising the Chief of Po-

lice directly of the community’s need for police services, and assisting in educating the community at large about the function and role of the Beverly Hills Police Department.

Panel members also must be a Beverly Hills resident, business owner or active in the community and attend monthly meetings.

Members are selected by the Chief. Members are chosen to serve for a minimum of one year to a maximum of two years on the advisory panel and be selected for their commitment to the community. The Chief’s Advisory Panel will be led by the Chief and chairperson.

Public safety is a partnership, and this panel works to enhance public safety, foster community relationships, build trust and keep the community safe.

### BHPD Appoints Second School Resource Officer

On March 12 the Beverly Hills Police Department (BHPD) appointed another School Resource Officer (SRO) to the Youth Services Division.

Officer Anne Marie Lunsman, a former SRO, joins Officer Stephanie Frias, Juvenile Detective Ubaldo Mendoza and a cadre of Adopt-a-School Officers to work in partnership with the BHUSD, parents and the community served.

“School safety continues to be a priority for the BHPD and the addition of a second SRO is another step in the right direction,” said a press release.

### Health & Safety Commission Applies For Prop 56 Grant Funding

At their meeting on March 19, the Health and Safety Commission opted to submit a grant application for a Tobacco Law Enforcement Grant Program, for which the California Department of Justice (DOJ) has just issued a Request for Proposal.

They discussed at the meeting different

program ideas that would meet the grand application criteria related to reducing illegal sales and marketing of tobacco

products to minors/youth and performing investigative activities and compliance checks.

The DOJ has included sample goals to help guide applicants and provide ideas upon which to build. Some goals include identifying target problematic retailers of tobacco products, conducting tobacco-related

enforcement operations targeting licensed retailers, and conducting at least local tobacco retail license inspection operations.

In their Request for Proposals, the DOJ states that the patterns of use of tobacco products in California are “increasingly uneven,” meaning that smoking rates vary widely depending on race, age, education.

## GOING GOLD

### Mayor Julian Gold on his vision for the future of Beverly Hills

**So, what's different about being mayor the second time around?**

Being mayor the second time around is in some ways easier and in some ways more difficult. I don't think that until you're mayor, you understand what it really takes to be the mayor. Although each of the councilmembers is equal in terms of their voting ability and the way the government runs, the world seats the mayor differently and so the demands on the mayor's time are much more intense than they are most councilmembers. It takes some adjusting to

get your life in sync with those kinds of demands and if you haven't done it before, the first couple weeks can be overwhelming. And I think sitting in the [mayoral] seat to speak last and whose obligation it is to keep the meetings running smoothly and hopefully end at a reasonable time—is a different pressure than sitting in a councilmember's chair. So, unless you've done that before it takes a little getting used to. Having done it, I'm comfortable with it.

The other piece, though, is that there's also some pressure—because [I] don't have to have that learning curve—to try and do more and to push as much into your mayoral year as you can in order to accomplish as much as you possibly can.

**Tell us some of your specific goals as mayor.**

The primary goal is [a] strategic vision for the commercial areas of the city. There is no common vision, there's no plan for how [to] compete in the current world. Way back when Georgio was starting and ultimately Rodeo Drive, Beverly Hills was unique [in that] it really was an experience. We didn't know what the word “experience” was; today we use it a lot. That experience ultimately translated into [turning] Beverly Hills into an international tourist destination. But now we have competition. Others

around us have latched onto this notion of “experience,”—Westfield both in the Beverly Center and in the Century City mall are trying to create experience, and certainly Culver City, Santa Monica and West Hollywood. They've begun to understand that if

you create these experiential places, people will come. So where we were the leaders in creating experience, we have not really spent any time talking about what we want our more modern experience to be. We have a great history, a spectacular history [that's] probably unrivaled, and yet we need to be mindful of

the fact that there are others who surround us that would like to compete. So, the question is how to we compete?

It's going to take some really smart people and a little bit of give and take. We're going to have to put everybody in a room and talk about what our vision is for the future. That will include landowners, merchants, residents—young and old—people who live here and people who work here. We have to come together and understand where we want to be. And it's going to be different. The triangle will always be different from any part of town, and we're not going to be able to do it all at once. This is going to be, I think, the beginning of a process that will take four or five years as we look at each commercial part of town and try to decide what we collectively think should happen there. What happens in the area that surrounds the subway and La Cienega and Wilshire will be very different than what happens at the triangle. But nonetheless, we have to have a conversation about both. We have to begin to address the large, empty stores on Wilshire Boulevard where NikeTown used to be. What do we want to put there? And this is not just what the residents want; it [also] has to make sense for the landowners. So I'm going to ask the Council to participate in the creation of a steering committee to start

this discussion.

I'm also going to go back to having Town Hall meetings on a monthly basis in different parts of town so that we can meet with the community that lives in that area and address their specific concerns in a casual environment. If people want to talk about the broader issues that's okay too, but really the goal of this will be to allow people who live in a particular area to aggregate people who cannot perhaps get to City Hall—people who live nearby who want to stop and talk and say “These are my issues.” And so, I wanted to restart these community Town Hall [meetings] at least on a monthly basis.

**You have a full-time job as an anesthesiologist at Cedars-Sinai. Is it a challenge to make time for your mayoral duties?**

I'm fortunate at this time in my life that most of my work is managerial. I have two wonderful assistants—one here at Cedars-Sinai and one in the City—and they manage to keep my calendar in a way that gets me where I need to get. I manage to get it done. I'm pretty good at managing my time. The reality, too, is that it's just [my wife] Michele and I. Michele has been a wonderful partner in this, and so the truth is that the extra time comes out of what would have been “our” time. So, the fact that she's such a great partner allows us to spend some of “our” time doing this collective work. That's made it that much easier.

**When we last talked to you in 2015 in Issue #808, you said, “The hardest part was narrowing down [my installation speech] because there are 150,000 things I wanted to do and I knew that I only had a year. There are two elements to it: one is to narrow it to something that's doable, and take the ones that are most important.” What themes did your speech cover this year?**

My view has turned a little bit. Previously I really thought that I wanted to do something I could accomplish in a year. I still have some of that, but I've also come to understand that things that are really important will take longer than a year. So, I've made a decision that this year my goal is to make sure we have the right people in place to begin the conversation and hopefully, in the years that follow, we will begin to see the benefits of having done that. I recognize that I will not complete a strategic visioning for the entire City over the course of this one year. So, my thinking has changed a little bit. I think that the goal will be to

create a robust system that will continue to move us forward in the future.

**Do you think the meetings have gotten out of control in terms of length and number of speakers?**

These are public meetings, so the public has the absolute right to speak. And not only that; we encourage it. I would much rather have a room full of people who tell us what they think than to have a discussion amongst ourselves with nobody in the audience. Our job is to represent the public, and if there is no public then the best we can do is guess. I do like having people in the chamber telling us what they think, and I believe the public has an absolute right to speak. [But I also] think that we need to manage the agendas and we need to manage the meeting so that everybody gets an equal chance to speak and yet, we manage our meetings so that they end at a reasonable hour. So, that will be my goal: to ensure that everybody gets treated fairly and has the same opportunities to tell us what's

on their mind, but that the meetings are managed tightly and hopefully we can cut down some of the time it takes to get through the meetings.

**Tell us about your family.**

My wife Michele has been my partner in this now [for eight] years. She's been a great partner. She loves doing this stuff [and] when she has stuff of her own that she needs

to do, she has no problem saying “I'm busy.” But for the most part, Michele has shown up for most of what I have done, and I really appreciate the fact that she's always been there. My daughter [Becca] is in her second year of physical therapy school at USC. She is a product of the Beverly Hills school system, and although she lives in Whittier she stays close. She watches what [the Council does, but] I don't think she has any interest in ever doing this. But I didn't either at her age. I'm fortunate that both have been really supportive and helpful.

**One year from now, what do you hope to have accomplished as mayor?**

I hope that we create this committee which will be responsible for the visioning and strategic planning for the commercial areas of the City. I hope that it's a well-functioning committee, that we set the rules for how it's works and that the landowners and residents will come together to collectively participate in decision-making about what we're going to do. If we're really successful in a year, we will have completed the visioning for one area and are preparing to move onto the second—that would exceed expectations for this next year.



## BHHS football coach resigns Normans boys' tennis team loses to Loyola

Steve Geanakos said last week he resigned as Beverly High's football coach after two seasons "over a difference of opinion" with Beverly Hills Unified School District Superintendent Michael Bregy and principal Mark Mead.

After explaining the relative low amount of players expected to return to the team for the 2018 season, Geanakos told Beverly Hills Weekly he shared three ideas with Bregy and Mead "about how to improve the team or even be able to field a team."

"There was one of those three solutions (that) had me remaining and they didn't want to go with that solution so they chose other ways to go through," Geanakos said.

Geanakos declined to share what those proposals were, instead suggesting that Bregy or Mead be asked that. There was no response by the Weekly's deadline to a request Wednesday for interviews with Bregy or Mead.

The district's schools are in the midst of spring vacation.

Geanakos said he has offered his help to assist in the hiring process, including serving on a selection committee.

Geanakos said that if an applicant asked him for advice on whether to take the job he would tell them to contact the principal, athletic director or superintendent, but said he would meet with the person chosen to be his successor "to tell him the ins and outs and how they could try to be as successful as they can here."

"It's a tough road for sure," Geanakos said.

Geanakos cited the school's declining enrollment and the growing number of parents, including fathers who played football, who will not allow their sons to play football out of concerns of being injured, as the reason for the team's recent poor record.

The Normans were 0-20 in Geanakos two seasons as coach, but were more competitive in 2017 than 2016.

Beverly Hills was outscored, 400-62, after being outscored 496-28. They were

shut out five times, one less than in 2016, and lost by 40 or more points four times, three less than in 2016.

The Normans are 2-48 over the past five seasons, and 6-64 over the past seven. They have not won more than two games in a season since 2010, the last time they qualified for the Southern Section playoffs.

Geanakos said he "enjoyed my time" as football coach, praising the players remaining in the program and the parents "after they bit their tongue and let their kids play and found the greatness of this sport."

Geanakos will remain at the school as a science teacher and boys' tennis coach.
