

City Council Begins Development Agreement Negotiations for Friars' Club Project

On Tuesday, the Beverly Hills City Council voted unanimously to enter into development agreement negotiations with the applicant attempting to construct a



9908 South Santa Monica Boulevard

four-story, mixed-use building consisting of 25 residential condominium units and more than 13,000 square feet of retail at the former site of the Friars' Club, located at 9908 South Santa Monica Boulevard. They also voted 4-1, with Vice Mayor John Mirisch dissenting, to consider the zone change and general plan amendment for the project.

An appeal of the project filed by Robert Zarnegin and The Belvedere Hotel Partnership, which owns The Peninsula Beverly Hills, was denied.

The appeal, filed on September 24, questioned whether a 3-2 decision of the Planning Commission to conditionally approve a development plan review and tentative tract map for the project as well as to recommend approval of a general plan amendment, zoning map amendment, and zone text amendment to create a mixed use planned development overlay zone for the project was the right one.

In the appeal, it is argued that the vote

was "poor planning that will negatively impact the City of Beverly Hills, its residents and The Peninsula for years to come." It also identified several key factors it felt made the

project a negative one, including significant changes to the project (a 50 percent increase to the size of the rooftop garden and the increased size of the rooftop amenity room) and the overall height of the project, which it claimed would be more than two levels higher than what is

allowed under the City's current zoning code.

Other grievances outlined in the appeal include a claim that rezoning for this project would not benefit the public, an assertion that it is located in a transitional zone and should therefore be limited in size, and concerns about privacy for guests of The Peninsula.

The Peninsula Beverly Hills' Managing Director Offer Nissenbaum reiterated the issue of guest privacy at Tuesday night's meeting, stating: "Even if the developer has no intent of using the roof, the residents will. They will use it for parties, dining, or whatever use they feel is appropriate. It has been talked about that from The Peninsula we will look down on this building. It can't look down when this is higher. I don't know what that implies. I don't know if you'll be able to see into our guests' rooms. That's a big concern for me. Our guests like discretion and privacy."

The Council attempted to go through each of the above objections individually to find solutions that would allow the project to move forward with the support of Zarnegin and The Belvedere Hotel Partnership. Councilmember Lili Bosse seemed particularly concerned with this, stating multiple times that she felt the two businesses could work well together in the future.

"We all love The Peninsula. I live at The Peninsula practically. It's my home away from home. I have a salad named after me! We'll see if I still do after this is finished," Bosse joked. "My point is: If we as the Council and the Planning Commission address all the concerns you have and get to a point where we think this project is okay, how can we make two businesses work well together? ... I believe the residents who call this spot home will also view The Peninsula as a home away from home. I see this as a benefit for both The Peninsula and for the residents living next door in those homes. When they have guests, I feel that they'll stay at The Peninsula."

In addressing the hotel's privacy concerns, Bosse asserted that residents care about privacy "just as much, if not more" than hotel guests. She also questioned the objections to the height of the project, noting that structures for amenities on roofs

can be as tall as 15 feet above the allowed 45 feet in height.

"You're pointing out something that you as The Peninsula and other businesses take advantage of," Bosse said. "So, why are you pointing it out when it's allowed in code and it's something that you and others take advantage of?"

One of the owners of the 9908 South Santa Monica Boulevard property, Cliff Goldstein, was also questioned about the appeal on Tuesday and made several concessions at the request of the Council, including more landscaping on the roof deck to lessen the amount of potential "event space" in the location and changing the hours for use of the rooftop to 8 a.m. to 10 p.m.

Goldstein also addressed the appeal's assertion that the pool had been expanded in size. The singular pool was increased as the appellant claimed, but Goldstein explained the expansion happened because he'd gotten rid of two pools (the project previously had three) and didn't want the roof to appear "barren."

"We're trying to build a first class project here. We want the luxury pool to reflect that. If we didn't have it for that extra few feet, we'd just be looking at rooftop," Goldstein said. "So, our objective here if you look at our design is to put in a lot of detail. The rooftop will be no different."

Goldstein offered a similar answer in regard to the increase in the size of the rooftop amenity room: "We could leave it as a barren roof or we could use the space effectively and offer something that I believe will be very luxury."

Mayor Julian Gold asked Goldstein about a separate issue, one that has become increasingly important in Beverly Hills over the last several months: Airbnb. He wanted to know what measures would be taken to prevent residents from renting their condominiums to Airbnb users.

"If the law will allow it, we will prohibit it and make it a condition of the CC&Rs," Goldstein said.

After more than four hours of back-and-forth over the project's merits and potential problems, the Council determined the project could move forward into development agreement negotiations.

"I think this is absolutely the right scale with what we have before us. It's the right use. It's the right aesthetic," Bosse said. "I feel this is an opportunity to have vision. It's an opportunity to plan. We are

planning the future of Beverly Hills. We have the chance to plan a revitalized and beautiful gateway to the City."

Vice Mayor John Mirisch disagreed, taking a stand against the project.

"I actually don't think this is planning. I think this is reacting to what an applicant wants to do, understandably, for profit. I also think to an extent it's planning by attrition," Mirisch said. "There needs to be a compelling reason to change zoning. It's not immoral, it's not illegal, but as Councilmember Wunderlich said, for exceptions there should be exceptional projects. I just don't see this as an exceptional project."

Potential benefits of any development agreement negotiations include a one-time financial contribution, EMS fees applicable to the sale of each condominium unit, and the provision of publicly accessible parking spaces.

Mirisch was particularly interested in the discussion of EMS fees, noting that he felt they should be comparable to those imposed on the One Beverly Hills project.

"Even though there's no hotel, the relevant elements of the One Beverly Hills project should be the ones that we're looking to. Those are benchmarks that Councilmember Bosse and myself negotiated and I'm not sure why we would ask for something that's a third or fourth of what we were able to get from a subsequent negotiation, just in terms of what's good for the City," Mirisch said.

He was also concerned with affordable housing, which he said had long been an issue in the City, and urged the Council to include an affordable housing nexus analysis study as a requirement of the development agreement. The Council approved this request unanimously.

Development agreement negotiations will proceed with the nexus analysis study, the appointment of an ad hoc subcommittee, consisting of Mayor Gold and Councilmember Robert Wunderlich, and the retention of an outside economic consultant and/or negotiator.

Levine to Fill Traffic and Parking Commission Vacancy Following Hendry Resignation

As of January 15, retired former Traffic and Parking Commissioner Jeffrey Levine will return to the commission to replace Commissioner Pamela Hendry, who ten-

dered her resignation on December 10 after accepting a job offer elsewhere.

The decision to reinstate Levine in Hendry's absence was approved unanimously by the City Council during their study session on Tuesday. He will remain on the commission for the full length of Hendry's term, which was her first and is set to expire on June 30.

"Jeff, for his part, has become a really strong on-going advocate for reform of the disabled placard ordinances and hopefully this will give him a bigger platform to continue that," Mayor Gold said of Levine.

Because Hendry was set to become the commission's Vice Chair on January 1, the Council also was also tasked with selecting a commissioner to fill that position.

Commissioner Jake Manaster would have been an obvious first choice as he is the next most senior Traffic and Parking Commissioner and was scheduled to become the Vice Chair after Hendry, however, Beverly Hills Municipal Code states that those who fill the position of Chair cannot do so "if such Commissioner's term will end before such Commissioner is able to serve one complete year as Chairperson." As Manaster's term will expire on June 30, 2020, he would be able to complete one year as Vice Chair, but would be unable to complete a full year as chair and is, therefore, ineligible for the position.

Manaster requested that the Council consider allowing him to do so anyway, but the Council declined the request.

"I'm not seeing a reason to change things that have been working," Councilmember Lili Bosse said. "I haven't heard anything that convinces me because this is a rule we'd be changing for all the commissions."

Councilmember Robert Wunderlich agreed, stating: "Given that it would also change the regular order of the Chair of

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, January 24, 2019, will hold a public hearing beginning at 1:30 PM, or as soon thereafter as the matter may be heard to consider the following:

Zone Text Amendment. A request for a Zone Text Amendment to amend the Beverly Hills Municipal Code (BHMC) to clarify whether a legally, nonconforming structure that exceeds the maximum allowable floor area permitted in BHMC §10-3-2502(B) is eligible to apply for a Hillside R-1 Permit to exceed 15,000 square feet of cumulative floor area. Currently, the Municipal Code requires that a structure be code-compliant as it relates to maximum allowable floor area in order to be eligible for a Hillside R-1 Permit to exceed 15,000 square feet of cumulative floor area.

Hillside R-1 Permit. A request for a Hillside R-1 Permit to allow more than 1,500 cubic yards of earth material to be imported or exported from a site in the Hillside Area that is immediately adjacent to a street that is less than twenty-four feet (24') wide; a Hillside R-1 Permit to allow for cumulative floor area greater than 15,000 square feet, and; a Hillside R-1 Permit to allow an accessory structure to be located within 100' of the front property line on an estate lot located in the Hillside Area of the City at 1115 Calle Vista Drive.

Variance. A request for a Variance for the abovementioned project at 1115 Calle Vista Drive to deviate from the existing requirement that a legally, nonconforming structure be code-compliant as it relates to maximum allowable floor area in order to be eligible for a Hillside R-1 Permit to exceed 15,000 square feet of cumulative floor area.

Project Description

The proposed project involves the remodel of an existing two-story single-family residence, the addition of a partially subterranean basement underneath the existing residence, and the relocation of an accessory swimming pool. The cumulative floor area for the proposed project, which includes the first, second, and basement levels, is proposed at approximately 21,788 square feet. Approximately 3,954 cubic yards of compacted earth material is proposed to be exported from the project site (reduced from the previously approved 4,618 cubic yards).

Project Background

The Planning Commission, at its regular meeting on September 13, 2018, voted to approve the requested Hillside R-1 Permits. On October 8, 2018, the City Council voted to set a public hearing regarding the project for the December 11, 2018 City Council Meeting. Subsequently, the applicant submitted revised plans that included removal of the subterranean garage and a reduction in the amount of export. Accordingly, the City Council considered the project and remanded it back to the Planning Commission for further review along with direction to prepare a zone text amendment clarifying whether legally, nonconforming structures that exceed the maximum allowable floor area permitted in BHMC §10-3-2502(B) are eligible to apply for a Hillside R-1 Permit to exceed 15,000 square feet of cumulative floor area.

Environmental Review

Zone Text Amendment. The zone text amendment has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, there is no possibility that the proposed code amendment may have a significant effect on the environment because the modification does not authorize any physical changes in the environment and requires discretionary review whenever a specific development project is proposed. Therefore the Planning Commission will consider finding that the amendment is exempt from CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations because it can be seen with certainty that there is no possibility that the activity in question would have a significant effect on the environment.

Hillside R-1 Permits and Variance. This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, the project appears to qualify for a Class 1 Categorical Exemption (Existing Facilities) in accordance with the requirements of Section 15301 of the state CEQA Guidelines. This exemption is applicable to the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use. Accordingly, the Planning Commission will consider a recommendation to find the project exempt from the environmental review requirements of CEQA pursuant to Section 15301 (Existing Facilities).

City Council Discusses Framework for Newly Established Office of City Auditor

The Beverly Hills City Council approved a proposed framework for building the Office of the Auditor, a new department within the City that will fall under the leadership of City Auditor Eduardo Luna, at its meeting on January 8. The framework, outlined by Luna, consists

of three main components and eighteen other elements and recommendations including the development of a staffing plan, the implementation of a fraud hotline, and plans to develop a budget proposal for fiscal year (FY) 2019-20.

A mission statement was also outlined for the new office. It states that the purpose of the Office of the Auditor would be "to advance accountable, efficient, and effective government through independent and objective audits that ensure the community receives the highest quality services, and ensure that public funds are expended in a transparent and appropriate manner."

Staffing of the new office was not discussed on Tuesday, but was included in the staff report related to the framework.

According to the report, Luna will return to the City Council at its next available meeting with an appropriation request in the amount of \$236,234.41. These funds would be used to hire two performance auditors and an executive assistant and would include funding for salaries and benefits, training, memberships for professional audit organizations, and furniture and equipment. Those positions would be hired during FY 2018-19.

City Dedicates Tom Friedman Sculpture at Beverly Gardens Park

Last Thursday the City of Beverly Hills dedicated its newest public art installation, a 14-foot tall sculpture by artist Tom Friedman entitled Takeaway, at Beverly Gardens Park.

The Fine Art Commission commissioned the stainless steel sculpture in 2015 and debated about whether its permanent placement should be at the corner of Canon Drive and Santa Monica Boulevard at Beverly Gardens Park, the park's southwest corner (Rodeo Drive and Santa Monica Boulevard) or on the north side of City Hall, along Santa Monica Boulevard, throughout much of 2016. It has now found a permanent home at the corner of Rodeo Drive and Santa Monica

Boulevard.

Course Map, Source: BHEF


celebrities such as trainer Dion Jackson, his All Seasons Fitness Media Team, and Olympic Gold Medalist Bob Seagren's Run Racing team.

Twelve-Time Grammy Nominee Ledisi to Star in Witness Uganda at the Wallis

forming Arts will host the west coast premier of *Witness Uganda*, a groundbreaking documentary musical by Matt Gould and Griffin Matthews starring twelve-time Grammy nominee Ledisi, Jamar Williams (*Wild Goose Dreams*), Amber Iman (*Hamilton*), and Emma Hunton (*Wicked*), from Tuesday, February 5 to Sunday, February 24 in the Lovelace Studio Theater.

After a successful off-Broadway run, the new and revised production of the musical shares the true story of a man named Griffin, a New York City-based American volunteer, who arrives in Uganda to help build a village school and escape his church's condemnation of his sexuality. When he falls into a complicated relationship with a group of destitute, orphaned teenagers, he finds himself driven by a mission that will change his and their lives forever. From a joyous celebration of African youth to a terrifying abduction 8,000 miles away, *Witness Uganda* explores whether or not changing the world is possible.

According to CBS, *Witness Uganda* is "an awesomely powerful musical that will thrill you to the bones." The Associated Press called it "a vibrant, pulsating musical," and TimeOut NY described it as "exuberant and soulful." The show has received the Richard Rodgers Award, Harold Adamson Award and Dean Kay Award.

Witness Uganda has helped to raise over \$275,000 for UgandaProject, an organization founded by Matthews and co-directed

by Gould that sponsors the education of a group of students living in Kampala, Uganda. Both Matthews and Gould have spent time living and working in Africa. Gould was a Peace Corps volunteer in The Islamic Republic of Mauritania from 2001 to 2003, and Griffin first went to Uganda in 2005 on an aid trip. The two created *Witness Uganda* based on interviews with UgandaProject staff and students, weaving music through the words of the people.

"This production gets back to the roots of *Witness Uganda*," said Gould. Matthews added: "We're excited to share this raw, real story about the complexity of

SGLA Removes 25 Pound Tumor, One of the Largest in Cedars-Sinai History

The Surgery Group of Los Angeles' Joshua Ellenhorn, assisted by Moshe Barnajian, removed a 25 pound tumor, measuring almost two feet in size, from a 61 year old patient last week. The tumor was one of the largest ever removed in Cedars Sinai history.

The patient, a Spanish-speaker maintenance worker, had previously been told the mass was inoperable and experienced difficulty eating, a loss of weight, related weakness and an inability to perform at work. A large academic medical center in Los Angeles told the patient his suffering was caused by a large retroperitoneal sarcoma, a type of cancer of the bodies connective tissue, in his abdomen. He was also told that his tumor would not respond to chemotherapy or radiation.

It was until the patient was referred to the offices of the Surgery Group of Los Angeles (SGLA) that he found hope for a cure.

On the Future of Water and Self-Reliability in Beverly Hills

What made you want to apply for the Public Works Commission?

Beverly Hills has been my home for over 40 years and I've tried to be involved with the City in various ways during that time. I participated in the first team Beverly Hills program, which opened my eyes to some of the complexities involved with having a safe and livable city. As a physician and professor at UCLA's School of Public Health, I try to use my background where I will be most helpful in the city. Before I joined the commission there were a couple of incidents, not involving any of our current staff, where the City didn't file the appropriate water tests and things like that so when a spot opened up it seemed like a good time to apply. We all expect clean water when we turn on our faucets at home and I thought I could be a resident voice leading the charge on that. I've joked before that the Public Works Department is like a doctor to the City and it really is. I was amazed when I first joined the commission by how important what we do is, from dealing with water and sewage to streets to park and tree main-

tenance and so much more. We are usually only noticeable to the public when there are problems, but we have recently won several awards including some for the Santa Monica project.

You previously served on the Health and Safety Commission. What did being a commissioner teach you?

It taught me that things can move a little slowly in city government, but you have to keep trying to move forward. There are lots of opportunities. You can't be limited by some of the stumbling blocks. You have to keep moving forward. I think it works that way on every commission. If you believe you have a good idea that you believe in, my suggestion is always to keep trying with it. There are lots of ways to get things done.

A water leak in Metropolitan Water District's Santa Monica Feeder, which serves treated water to Beverly Hills and several other cities, had to be repaired in late December. How is the City working to make sure that doesn't happen in the future?

That recent rupture on Sunset was an eye-opener. It really was. I should also say that the pipe that burst wasn't one of ours, but it does supply water to five cities including Beverly Hills. When it was off, we were totally reliant on our reservoirs. In terms of how we're working to make sure it doesn't happen again, the City is trying to determine what ways it can pick up early leaks. But

again, that wasn't one of the City pipes, so that makes things more difficult. We have to work with our neighbors to clean up and fix older pipes, which many of these pipes are, but locally I do know that there's an effort to find ways to catch leaks before they become major, like this one was. It was a real reminder that we're one hundred percent reliant

on MWD water.

Outgoing Public Works Commission Chair Jerry Felsenthal told the Weekly in Issue #953, “the question of self-reliability and self-production of water is imperative.” Why is self-reliability and self-production of water so important?

I agree with that, and trying to move forward with our master water plan is a big challenge and major goal for us. We have some current wells and a water plant, but that plant is presently offline while it goes through improvements. A big part of the master water plan is to get new wells set up so that we get about

twenty-five percent of our water from our own wells and the rest from MWD. The City has considered becoming more sustainable and I think that's something that will be very important going forward.

Tell us how the proposed water rate increases will affect the City.

I think I will leave it up to the Director of Public Works Shana Epstein to go into the details because I wouldn't want to misspeak or get any of the details wrong. But, essentially, in order to pay for the services that need to be done in order to keep our system running and to develop an insurance policy with the wells we were just talking about, we need to raise our rates. In the last year and half or so several members of the subcommittee worked so hard to come up with fair rates and charges.

On November 20, the City Council approved moving forward with design and preparation of construction documents for seismic strengthening, Tower shell infrastructure and interior improvements to support re-occupancy of the historic City Hall Tower. What plans are in place for moving forward with that rehabilitation project?

We have talked about it. We're mostly going to be getting information about

it. We're not involved with the decision-making.

How is practicing medicine different from government?

I think with medicine you can have more objective information at hand to make some of the decisions that need to be made. With government, some of it is using the best information you have, but you don't necessarily have all the answers when you try to move forward.

In medicine, you usually have a 1:1 relationship with your patient and that patient is your main focus while in government, you are planning for populations. It's one of the reasons I teach in the UCLA School of Public Health.

Tell us about your family.

I've been married to a very good man [Former Mayor Chuck Aronberg] who cares deeply about the City and has done much on behalf of the City over the years. He is glued to Channel 10 and catches most of the City Council and commission meetings, Mayor's Cabinet meetings, and anything else that happens to be on. My daughter Cindy was instrumental in stopping the oil drilling off of Santa Barbara. I also have two terrific grandchildren who live in Santa Monica and being around them now is the closest I'll ever get to knowing what being a rock star feels like.

What are your top three goals as Chair?

Moving forward with our master water plan is definitely up there. I'd love to see the water plant up, running, and producing usable water while I'm on the commission. We want to develop Burton Way in a way that will be attractive and also meet the City's goals. I'd also like to do what we can to be proactive and reactive with maintenance and planning, so trying to avoid disasters but also being prepared if they do happen.

BHHS boys' basketball team wins three of four in tournament

Squad to play host to Santa Monica Friday

Beverly High boys' basketball coach Jarvis Turner called winning three of four games in the Rancho Mirage Holiday Invitational a "good accomplishment."

"Taking a loss at the buzzer was definitely a tough one," Turner said, referring to a 53-52 loss to Anaheim Fairmont Prep Dec. 27 in a pool play game at Rancho Mirage High. "The good thing is that the team that beat us at the buzzer ended up winning the championship."

"Our guys got to see that we were right there with those pretty good teams. A few plays here and there it's actually a different outcome."

The Normans had a one-and-one free throw opportunity with 10 seconds to play against Fairmont Prep, ranked third in the Southern Section Division 4AA poll released Monday, but missed the first shot.

Turner said his team played "extremely well" and "felt good" about accomplishing the goal for the tournament, which was to "bond as a group."

"We had early games ... so our kids pretty much got to spend the entire late afternoon and evening with each other and they got the opportunity to bond," Turner said.

"I think that was the most valuable experience that we can get from there because if the chemistry for this particular group becomes a little better, that will equate to a little more success later on."

After being critical of the team after back-to-back losses Dec. 7-8 dropped its record to 5-2, saying it "showed a lack of focus, a lack of toughness," Turner said the team is improving.

"The kids are getting more comfortable playing with each other," Turner said. "Out of the 17 guys we have on the roster, three of them played valuable minutes and the fourth guy rarely played at all last year on the varsity," Turner said. "We have a lot of new guys who came from our junior varsity program who are still trying to get acclimated to the intensity level and the understanding of what it takes to be successful ... at a varsity level."

"That growth from our other guys has been good for us and I think that's the reason why we're starting to get better as a group. We have a little more guys we can depend on."

Beverly Hills opened the tournament with a 69-63 victory over Seattle Ingraham Dec. 26 at College of the Desert. The

Normans defeated El Cajon Christian, 82-65, in their final International Division pool play game Dec. 28 at College of the Desert.

Beverly Hills defeated Mercer Island (Washington) 46-38 in the division's fifth-place game Dec. 29 at Rancho Mirage High to improve to 10-4 on the season.

The Normans played all but the Fairmont Prep game at College of the Desert. The Fairmont Prep game was played at Rancho Mirage High.

In their final game before the tournament, Beverly Hills lost at Harvard-Westlake, 58-53, in a nonleague game Dec. 21 that was tied 48-48 with two minutes, 27 seconds to play.

"We had an opportunity to win the game," Turner said. "Unfortunately, it was a familiar story -- we don't capitalize at the free throw line when we have the opportunity to do so. I was happy with the way they played."

The Normans devote what Turner called "a good amount of time" to free throws in practice and "try to put them in different situations ... making sure their mindset is correct when they go to the free throw line, they're comfortable and they're relaxed."

Turner said his players "are trying a little bit too hard" at the free throw line.

"They (need) to get up there, relax and be confident in themselves and just knock it down," Turner said.

The Wolverines are ranked 12th in Division 1.

Beverly Hills is scheduled to play host to Santa Monica, ranked 13th in Division 2AA, Friday at the Swim-Gym and play at Culver City Wednesday in Ocean League games beginning at 7:30 p.m.
