# **Council permits Cosmetic** Spas in C-3 Zone under conditional use ordinance

At Tuesday's joint meeting of the City Council and the Parking Authority, council approved an ordinance amending the Beverly Hills Municipal Code (BHMC) to conditionally permit cosmetic spas in the city's C-3 commercial zone.

The Applicant, Alchemy 43, requested a Zone Text Agreement (ZTA) and a Conditional Use Permit (CUP) to allow the continued operation of an existing cosmetic spa located at 440 North Canon Drive.

The ZTA amends the BHMC to establish a "cosmetic spa" as a new conditionally permitted use in the C-3 Commercial Zone. The Planning Commission first discussed the proposal at a study session on in March.

In April, they recommended approval of the ZTA as amended to the City Council, and approved the CUP contingent upon the City Council's approval of the ZTA.

The BHMC outlines permitted, conditionally permitted, and prohibited uses in each zone in the City. Due to concerns regarding the proliferation of medical uses in commercial zones, the City adopted specific standards that regulate medical uses in 2011

These standards have allowed existing legal medical uses to continue operating as legal nonconforming uses, but new or converted medical uses would no longer be considered by-right permitted uses in the majority of commercial zones of the City. This ordinance also established definitions for the types of activities that are considered to be medical uses.

The proposed changes to the code

would include a new definition for a "cosmetic spa," create regulatory standards for cosmetic spas with a CUP process for approval and clarify the relation of cosmetic spa uses to the Medical Use Ordinance.

"We've separated the interpretation as medical and proceeded through the process because we really want to stay in the city of Beverly Hills and attract new business to the area," Nicci Levy, owner of Alchemy 43 said.

Alchemy 43 combines their cosmetic spa medical procedure with selling retail products to customers.

"Retail is increasingly becoming an important part of our brand and we want to update the [Beverly Hills] store to look more like the others and have more of a retail look and feel to it," Levy said.

Most councilmembers were in support of the project and agreed that Alchemy 43 and other cosmetic spas would promote retail reslievance and vibrancy in the com-

munity and enhance the city's effort to be more diverse in the services that are available.

Mayor John Mirisch had some difficulty with accounting for the three separate levels of taxes that the business is responsible for. He was in favor of also changing to tax code to reflect this issue.

"This is a subset of medical, and it's medical/retail, we should solve this at the same time. I don't see why we wouldn't change the tax code

simultaneously to reflect that. If we are treating it like retail it should be taxed like retail," Mirisch said.

Other councilmembers did not agree that updating the tax code was related to the cosmetic spa conditional use permit. And according to Levy, Alchemy 43 currently does pay taxes on all three bracket levels.

Mirisch agendized a tax code change for the council's next meeting to reflect

## **Planning Commission denies** rooftop music use at 9800 Wilshire

At Thursday's Planning Commission meeting Spring Place, an office building at 9800 Wilshire and 121 Spalding Boulevard. requested a Zone Text Amendment (ZTA) and an amendment to a previously approved Development Plan Review (DPR).

According to the staff report, Spring Place is a co-working office that operates on a membership basis in which members receive access to common or dedicated work spaces and amenities, including cultural, social and professional events.

The building utilizes the first two levels of office space in the 9800 Wilshire Boulevard building, the first and fourth office levels of the 121 Spalding Drive building, and the rooftop facilities of each building.

The ZTA request was made in order to allow additional operations on the rooftop facilities of an existing private coworking club The amendment to the DPR would allow club members to bring up to 10 guests each with them to the rooftop for social events.

Opposition and support of the issue was not only represented by the public comment at the meeting-- the differing views were also expressed by planning commissioners.

Residents in the area were very warv of the noise level that would come with the use of live and pre-recorded music on the rooftop. Club members and some other residents and entrepreneurs expressed sentiments that Spring Place was bringing valuable people and business into Beverly

The majority of commissioners believed that social aspect of the space was not a part of the explanation, as it was originally presented as a co-working space.

Commissioner Peter Ostroff said that he could not make any of the findings to approve the application, and that the commissioners were mislead greatly by the application-- believing that the social aspect of the club was not represented accurately.

"The concept is fabulous. I don't think

this city is a sanitarium, the city has to have life. In the city there is some noise you can't help it, Other than that we will have a dead city and I don't want this city to die," Commissioner Joe Shooshani

Commissioner Lori Greene Gordon and Vice Chair Alan Robert Block also said that she could not make any of the findings to approve the application. "When you neighbor residences I think the value comes first to the people that live in the community first," Gordon said.

The Planning Commission requested that city staff adopt the resolution made by the majority of the commissioner in denying the request with a vote of 3 to 1.

The commission requested that staff bring the issue back at a future study session to discuss parking and traffic in the area with participation from Spring Place and residents within the next 90 days.

# BHPD receives lowest-ranking on statewide 'Police Scorecard'

The Beverly Hills Police Department receives the lowest rating out of 100 California states, according to a recent study. The same scorecard failed 78 out of 100 of California's largest police departments.

The Police Scorecard is a project initiated by Campaign Zero, which focuses on

police reform. The organization used data from California's Open Justice database, public record requests, national databases and media reports to conduct the nation's first statewide "Police Scorecard."

The campaign used this formula when evaluating California police departments: 'A police department received a higher grade if it made fewer arrests for low level offenses, used less force during arrest, had fewer homicides unsolved, did not have racial disparities in arrests and use

> of force, and upheld civilian complaints of police misconduct more often than other police departments in the state."

> The city of Beverly Hills earned an overall grade of F. According to the campaign, the BHPD has received 45 complaints of police misconduct, made 1,345 arrests in 2018 and has used deadly force in two incidents.

Carlsbad Police Department receives the highest score of the 100 states, earning an A-.

Some of the major findings on a state level from the report revealed that most

people arrested in California are arrested for low level offenses. Of 1,354,769 reported arrests made in 2016, 70% were for misdemeanor offenses.

Other major findings include evidence of racial bias in police use of force and failure by police departments to take reports of police misconduct seriously.

The campaign recommended that, "These findings should prompt further investigations and interventions targeting low-performing police departments within the state, not only from local policymakers but also potentially from the California Attorney General, who has the power to initiate pattern and practice investigations into local police agencies."

# 10-year extension approved for Cedars Sinai's use of space in Wilshire property

The Planning Commission approved a Conditional Use Permit Amendment, allowing Cedars Sinai to extend their contracted occupation of the ground floor in the property at 8536 Wilshire for its medical uses.

The proposed project is a request to amend a condition of a previously ap-

proved CUP that allowed the medical office uses to occupy the ground floor of the subject property until September 13, 2022.

The requested amendment would modify the condition that allows 5,870 square feet of ground floor area to be used for medical uses to allow for an additional 10 years of ground-floor medical uses, until September 13, 2032.

After hearing testimony from the property co-owner, Recreation and Parks commissioner Julian Javor, the commission disregarded staff's initial recommen-

dation to permit the contract extension for only five years. Javor's mother is the other co-owner of the building.

# **Planning Commission denies** multiple requests made by Warbler Way property

At Thursday's Planning Commission meeting, requests for a lot line adjustment, an accessory dwelling use permit, a Trousdale R-1 permit and variances were made by the current property owner at 9304 Warbler Way.

The staff report recommended that the commission adopt resolutions denying the requests.

A similar request was submitted in June of 2018 allowing for the adjustment of lot lines to combine four existing adjacent parcels into one parcel and to construct an accessory dwelling unit on a portion of the project site located in Beverly Hills.

At its meeting on May 2019, the Planning Commission conducted a public hearing on the project, and ultimately cast a unanimous vote (4-0, Commissioner

Shooshani recused), directing staff to prepare resolutions denial because they could not make findings to approve the request.

The project request for a lot line adjustment would combine three existing Beverly Hills properties with an existing parcel located in Los Angeles (9304 Warbler Way) to create one lot, resulting in a dual-jurisdictional property located partially in Beverly Hills and partially in Los Angeles.

Commissioner Peter Ostroff said he thought that the lots on the property were knowingly illegally subdivided, and that the owner's request presented several dif-

Murray Fischer, the attorney representing the owner of the property in question, said that his client has no reason to believe the property was illegally subdivided when he purchased it.

During public comment, community members spoke in favor of the city staff's recommendation that the commission approve resolutions to deny the requests, including members from the Doheny/ Sunset Neighborhood Association and the Trousdale Homeowners Association. Some called the situation dangerous to neighbors.

Meg Greenfield, a planning deputy from the Los Angeles Council District #4 council also spoke during public comment.

"Our office strongly encourages the approval of the resolutions [to deny] and agrees that the alternate proposal is a separate matter," Greenfield said.

"I'm not in support of the develop-

ment of the accessory structure. I agree with what everyone else has said about the modification, but I think we're asking for problems if we don't approve the minimum of the lot line adjustment," Vice Chair Alan Robert Block said.

Commissioners voted 4-1, with Vice Chair Block voting no, to adopt the resolutions put forward by city staff denying the requests regarding the lot line adjust-

Commissioners then voted again to adopt the resolutions denying the request for an accessory dwelling use permit, a Trousdale R-1 permit and several variances by the current property owner at 9304 Warbler Way.

# **New Learning Management** System to be Implemented **Across District**

BHUSD Director of Technology Bernadette Lucas presented the results of Schoology, a new learning management system, to the Board of Education at their

meeting last Tuesday night.

Students currently use Jupiter Ed learning management system. Students can access their grades and assignments through Jupiter Ed. BHU-SD's contract with Jupiter Ed will end in December, and the district is looking to adopt a new system.

The pilot was designed to get survey feedback from teachers about how the technology was working well or needed improvement. Al-

though the pilot was not intended to be completely rolled out, Lucas said that there were no requirements for how the teachers implemented the pilot use of

The program was evaluated based on various criteria including how often students used Schoology, how they rate its functionality of navigating through coursework and the efficiency of communication tools

About 146-149 fourth through eighth grade students from Horace Mann and El Rodeo were polled.

Of the students polled, Lucas said, "the trend is consistent, about a third to a quarter of students said that it Schoology needs improvement."

In Lucas' findings, she said that students need a bootcamp on how to use Schoology, parents need training on how to use it, and BHUSD needs to collaborate with Schoology to refine the technology's functionality wherever possible.

According to Lucas' timeline Schoology is set to launch districtwide in January.

"It really concerns me looking at the survey results is that less than five percent of our student population was polled and those numbers were taken from classes where teachers were really engaged in using Schoology." Board Vice President Isabel Hacker said.

Hacker pointed out that no students from Beverly High or Hawthorne were included in the Schoology pilot survey.

"How are you going to get around the pilot part to incorporate and include the high school students and Hawthorne," Hacker said, "have you thought about how you're going to do that before January?"

Lucas said that there will be another survey in the fall, after students have had more experience using the program. All students will also receive training on how to use Schoology through bootcamps that will be differentiated by grade level.

# **Board Appoints BHUSD Assistant Superintendent of Business Services**

At last Tuesday's Board meeting, the BHUSD approved the appointment of J. Wade Roach as Assistant Superintendent of Business Services.

Roach served 16 years as the Chief Business Official and Assistant Superintendent of several school districts in the wine country of Sonoma and Napa counties, most recently for eight years as Assistant Superintendent of Business Services at the Napa Valley Unified School District.

Roach returns to the Beverly Hills area where previously served more than twelve years in several business services roles for the Santa Monica-Malibu Unified School District.

Superintendent Michael Bregy said "Roach brings exceptional experience from the education sector as well as significant corporate fiscal management skills to our District.

His financial focus paired with a communicative-based leadership style are critical assets BHUSD. for We are eager to welcome Roach to our community." Before

# **BHUSD Special Education Program Changes**

Changes being made to BHUSD's Special Education Program for 2019-2020 were presented at last Tuesday nights Board of Education meeting. Assistant Superintendent of Student Services Laura Chism described the proposed upcoming changes to the Board.

At both Horace Mann and Hawthorne, five classes have been added to each campus' Special Education Program. The programs would include intervention classes for all students, special day classes, a restructuring of their RSP program, reading and math comprehension classes and a Counseling Enrichment Program (CEC).

The Prime program-- which serves moderate to severe students-- which was previously only offered at Hawthorne, will be extended to all schools within the district.

Chism said, "students don't have to travel if they live in one school district they don't need to move to another school to get the programs they need."

The CEC program currently exists at Beverly Vista, but will be implemented across all BHUSD campuses. The program is used to address students' unique needs so that they can stay at school in the district.

Although the Board was generally supportive of the plans, some Board members expressed frustration over not being informed about the proposed program changes earlier.

According to Chism, informational meetings about the special education program updates were held in March after the transitional meetings.

"It's always easier for the board to get behind something before we get phone calls from people, but I'm incredibly appreciative for the change you are bringing forward," Board member Tristen Walker Shuman said.

"The program as you've described it is an intent for us to have a complete continuum so we can address all students that need special education. We will not need to use outside services which is really commendable and I'm hoping that it will alleviate a lot of what we get into with legalities," Board member Rachelle Marcus said.

Board President Noah Margo agreed.

"A while ago the Board asked if we could move towards a model of being more in-house with our Special Education program because we had so much use of private programs. This really encompasses a lot of work and a long-time vision," Margo said.

Margo asked Chism provide enrollment numbers to the Board so that they could evaluate the justification of administration roles and ensure that it's balanced across the district.

# BHUSD approves updated employment of relatives policy

At Tuesday night's BHUSD meeting, board members unanimously approved the second reading of an updated Employment of Relatives Policy. Changes to the policy outline clear reasoning for the BHUSD's attempts to eliminate conflicts of interest in their hiring process.

New wording in the policy states: "the Board of Education desires to maximize staff and community confidence in district hiring, promotion, and other employment decisions by promoting practices that are free of conflicts of interest or the appearance of impropriety."

Selection of applicants to BHUSD are outlined in the policy as strictly mer-

it-based and without regard to familial relationships. Although, no relative of any Superintendent or Board member may be considered for new employment in the district.

In the case of this policy, the term relative is defined as the applicant's spouse, domestic partner, parents, in-laws, grandparents, great-grandparents, children, grandchildren, great-grandchildren, brothers, sisters, aunts, uncles, cousins, nieces, nephews, and the similar family of the individual's spouse or domestic partner.

According to the policy, all applicants must fully disclose names of any relatives currently employed by the district.

The Board also prohibits the employment of any person for a position in which his or her relative holds a direct management or supervisory position.

Additionally, the Superintendent or designee may determine, on a case-by-case basis, whether to appoint a person to a position in the same department or facility as an employee with whom he or she has a personal relationship.

This applies when the relationship has the potential to create an adverse impact on supervision, safety, security, or morale of other district employees. Or when a conflict of interest for the individuals involved is greater because of their relationship than it would be for another person.

# Complete Streets Plan Accepted by Traffic and Parking Commission

Next steps for the city's Complete Streets Plan was presented at Last Thursday's Traffic and Parking Commission meeting. The draft plan was released for public review in early April, city staff are currently in the process of reviewing in

community feedback.

The vision of the complete streets plan is to create a framework for programs, policies and infrastructure projects that will make navigating the city easier for pedestrians, bicyclists, drivers and public transit riders.

The plan has been developing for about a year, incorporating community-based planning efforts.

Some of the issues that the complete streets plan aims to address are:

•Upgrading the city to best-practice

mobility standards across all modes

- Enhancing safety for all
- •Improving traffic flow
- •Positioning the city for competitive implementation funding
  - Preparing for the Metro Purple Line
- •Considering ways to prepare the city for connected and autonomous vehicles and providing flexibility for new innovations on the horizon

Specific projects that are proposed for the city are organized by importance into three different groups or tiers.

Residents' comments will be considered and the plan will be re-introduced to City Council at their July 16 meeting.

## Waverly Mansion named Historic Landmark No. 9

On April 15, the Cultural Heritage Commission presented fellow commissioner Jill Tavelman Collins with the historic landmark plaque for the Waverly Mansion. Collins owns and preserves the Waverly Mansion, also known as the Christie Estate.

In 2013 the Waverly Mansion, located on Sunset Boulevard, was named historic landmark number nine.

The two-story Tudor style Waverly Mansion was erected in 1926 on five acres. Architect Charles Gibbs Adams initially designed the formal landscaping throughout the site.

The frame of the building is made of wood, and covered with half-timbered stucco on the second story. Several tall brick chimney stacks emerge through the roof. Small-paned casement windows, framed in stone were installed under the eaves of the second floor.

The interior space of the second floor includes seven master bedrooms and baths each with sitting rooms and a guest gallery. The house also has a clubhouse, swimming pool with dressing rooms, ser-

vants' quarters and garages.

Landscape features include brick perimeter walls, fountains and ponds with bridges, low-profile concrete steps, decorative iron gates and formal paved driveway.

"It's a splendid example of Tudor-style architecture Commissioner Chair Richard Waldow said.

Collins has worked on the restoration of

# **Board of Education discuss**es cell phone restrictions at special meeting

At the May 29 special Board of Education meeting, the board reviewed regulations about students' possession of cell phones and other personal electronic devices. Rules and restrictions on cell phone usage varied from the elementary to high school levels.

The regulations are intended to create a learning environment free of distraction that otherwise may result from unrestrict-

Regulations at all school levels include:

•Students may possess electronic signaling devices on campus, including but not limited to cellular/digital telephones.

•During school hours, cellular phones and other electronic signaling devices must be powered off or placed in "Do Not Disturb" mode and stored out of sight at all times while school is in session.

•No student shall be prohibited from possessing or using an electronic signaling device that is determined by a licensed physician or surgeon to be essential for the student's health and the use of which is limited to health-related purposes.

•Other exceptions to the policy will be determined on a case-by-case basis by the site administrator or his/her designee.

•If a student is found to be in possession of an electronic signaling device without proper authorization, a district employee will use best judgment and determine which of the following options to exer-

1)Confiscate the device until the end of the school day or activity; or confiscate the device and turn it over to the site administration before the end of the school day

•If a device is confiscated and turned over to the site administration, the site administrator or designee will determine when and how the device will be returned.

•A student who violates this policy is subject to discipline in accordance with Board policy, administrative regulation, and site rules.

•Students bring electronic signaling devices on campus at their own risk. The school is not responsible for lost, stolen, or damaged electronic signaling devices.

This was the board's first read-through of the proposed cell phone restrictions in schools. The board members decided to revisit the topic after proposing changes to the policy.

# BHPD DISCRIMINATION **LAWSUIT CONTINUES**

# **Employees Testify Spagnoli Made Racially Insensitive Comments**

Last Friday, four BHPD employees testified in opening statements during a Los Angeles Superior Court trial alleging that they've witnessed or been subjected to discrimination and harrassment under the leadership of Police Chief Sandra Spagnoli.

The plaintiffs are Lieutenants Renato Moreno, Michael Foxen and Shan Davis, and civilian employee Dona Norris, who is the BHPD's public safety communications and evidence manager.

According to mynewsla.com, Gelfman testified that during a management meeting before the 2016 Jewish holidays, Spagnoli asked about the "funny hats" Jewish men wear when referring to the varmulke.

"I was very surprised she would say something like that. It was very insensitive," Gelfman said.

Moreno alleged that he's experienced "pervasive" anti-Latino and anti-Catholic discrimination under Spagnoli. According to Moreno, the situation only worsened after he testified on behalf of former Captain Mark Rosen, who sued the city for discrimination and retaliation and received a settlement of \$2.3 million in 2018.

After testifying, Moreno alleges that he was given fewer choice assignments, lost job benefits and pay and was subjected to improper internal investigation.

Gelfman testified that when Spagnoli was invited to a party at Moreno's home, she asked if she needed to "dress Mexi-

Foxen said that he was treated unjustly after notifying management that Officer Lisa Weller, a gay woman, was paid less than a straight male for doing the same

According to the complaint, when Spagnoli found out that Weller is gay she did not provide her with the necessary support staff and eliminated her promotional opportunities.

Davis, who is Norris' supervisor, testified that Spagnoli told him to lower

Norris' performance evaluation because of her sexual orientation. Norris said that he refused to complete Sapagnoli's alleged order and was subsequently passed over for promotions and demoted, according to the complaint.

Gelfman testified that Spagnoli spoke with Norris and Davis in a "dismissive" tone, which was inconsistent with how she treated other employees.

Gelfman said that she didn't report Spagnoli's alleged insensitive remarks in the past because she didn't believe that the city would offer her protection against retaliation.

Forensic specialist Clark Fogg, said he was 55 years old when he met Spagnoli shortly after she was hired in 2016. Fogg alleges that she made several ageist remarks and suggested he retire. She eventually removed him as supervisor of the crime lab without a drop in salary and replaced him with a less experienced sergeant, he said.

Fogg, now 57, testified that some

women who worked for him complained Gelfman testified that about being called "girls" and other demeaning names. Fogg said that he has sued the city alleging harassment and discrimination, and that his trial is scheduled for July 17.

Before her employment by the BHPD, Spangnoli worked as police chief in the northern California cities of Benicia and San Leandro.

City Public Information Manager Keith Sterling said that the City will not comment on specific testimony but looks forward to presenting its case. The trial is expected to continue through the week.
