

The chance to impact students and teachers in another district is something that Stepenosky says he looks forward to accomplishing in the Las Virgenes Unified School District.

"It's exciting to meet new people and to build those new relationships and that's a big part of it and it's daunting,"

Stepenosky said. "It's the direction I wanted to go."

At LVUSD Stepenosky will be working under Dr. Sandra Smyser who has served as Superintendent for the past year. Prior to coming to LVUSD Smyser served as Superintendent of the Carpinteria Unified School District on the Ventura/Santa Barbara County border for five years.

Carpinteria Unified School District's (CUSD) demographics differ from the LVUSD. CUSD has a 31 percent Caucasian population compared to 80 percent in Las Virgenes. With 2,800 students, CUSD is less than one third the size of LVUSD, which serves over 9,000 students. CUSD scored 727 on the API test, significantly lower than LVUSD which scored 860.

Like Beverly Hills, the LVUSD has dealt with school construction issues. LVUSD's \$128 million bond measure passed with 64 percent of the vote.

Stepenosky enters a district with a similar socioeconomic background as BHUSD. The percentage of socioeconomically disadvantaged students at LVUSD is comparable to BHUSD. The California Department of Education defines socioeconomic disadvantage as either having parents who both did not graduate from high school or are participating in the federally funded lunch program.

The bond measure will provide funding for district-wide improvements including classroom upgrades, replacing deteriorating temporary classrooms, restroom renovation, and remodeling outdated science and computer labs.

Before Smyser, BHUSD interim Superintendent John Fitzpatrick served for nine years as LVUSD Superintendent. He retired in 2005.

During his time as Superintendent at LVUSD conflict arose between Fitzpatrick and the teachers union. Teachers voted noconfidence in Fitzpatrick.

"[Fitzpatrick] was not the right management style for our district anymore," Las Virgenes Board of Education President Cindy Iser told the *Weekly* in issue 348.

Stepenosky first came to the BHUSD in 1995 as a physics and astronomy teacher. He became assistant principal of Beverly High in 2001, and principal in 2003.

Before coming to Beverly High, Stepenosky was in the Navy. He graduated from Villanova University in Pennsylvania and received his doctorate in education from UCLA.

"I love being principal. I'm crazy about it," Stepenosky said, "but this position came open so I threw my hat in the ring."

According to Assistant Superintendent of Human Resources Sal Gumina, Beverly High Assistant Principals Toni Staser and Amy Golden will serve in different capacities as interim principal until a permanent principal is found.

"The district will remain strong and growing. The staff at the high school and at the other schools is a tremendous staff," said Stepenosky. "At the high school, there

is a great mixture of veteran and new leadership and energy and good things coming in. The parents and teachers and students are terrific."

Board of Education President Myra Lurie said the board is currently searching for the new principal.

"Our panel interviewed the candidates for the high school principal position early last week," Lurie said in an e-mail, "and the results of their search process have not been formally brought to the Board as of yet."

On June 19, a panel of various members from the community and school administration met to interview potential candidates.

"I loved working with Dan Stepenosky. He is a wonderfully collaborative, studentcentered, and dynamic educator whose educational leadership was exemplary," Lurie said, "I'm grateful for all that he has done on behalf of our students and district. I will miss him greatly, and wish him much happiness and success in his new district."

In addition to searching for a new principal, the BHUSD is also conducting a search for a permanent superintendent.

"The high school in some ways was my baby. You always worry about it when you hand the keys over to someone else," Stepenosky said, "The person who replaces me will have a fresh perspective, fresh ideas and energy and will bring about more positive change. So all good stuff. I think they are finalizing their selection, but I don't know who it is."







BHUSD Comes Up Short For Turf Funds

The school district comes up \$300,000 short of the estimated \$1.2 million cost to install the high school's turf field.

The city council will lend a hand to the Board of Education after a tally of funds from various sources left the district \$300,000 short of paying for the installation of a turf field at Beverly Hills High School.

"It was the view of the council, that putting artificial turf on the high school field was of overall importance to the community not just to the high school programs such as football, but to Recreation and Parks [Department] and other community programs such as soccer, little league and lacrosse," said Mayor Steve Webb.

AYSO is only one organization that uses the high school's field. Yet, it is the only organization, that will help with funding the new field.

A number of other organizationzations in the community also use it on a regular basis making maintenance of the grass a major issue for the high school. This was the main reason the school wanted the

artifical turf installed.

The high school will be the last school in the school district to install the artificial grass field.

The city and Board of Education also hope the new field will lessen the amount of field usage at La Cienega Park thereby decreasing the amount of damages to that park's field.

The estimated cost of the high school field installation is currently at \$1.2 million. However, a final cost estimate will not be available until the landscape architect conducts a study of the drainage system.

In an effort to answer the funding question, that has carried out now for more than two months, the city council decided to fund the remaining \$300,000 to the Board of Education on a no interest loan. The idea was discussed and agreed upon during the city council's informal meeting Tuesday

The ideas had already been discussed weeks ealier at the City Council BHUSD Liaison Committee Meeting June 6.

"Because the school district didn't have the funds currently to meet its financial commitment, we felt it was important to advance those funds, so that [the turf] could be accomplished by this summer," Webb said. It was also asked that City Attorney Larry Wiener look into why money from the Recreation and Park Maintenance fund could not be used for the additional turf installation funds. Wiener could not be reached for comment in time for the *Weekly's* deadline.

According to Webb the high school football team has already scheduled away-

games for the first half of the season in anticipation of the field being completed before the season comes to an end.

Under the new agreement, the school board would have a maximum of five years to pay the loan back after the council decided it would be willing to wait anywhere from two to five years for the payback.

It was also recommended that any additional costs for the field would be paid for by the city. However, the school district would be required to save money in a fund used for the maintenance and repair of the field in the future.

When the initial idea to replace the high school's current grass field came up more than two months ago, the Board of Education was under the impression the city would finance the turf project without using funds from the 2002 Measure-K bond.

As reported in the *Weekly* [issue #345], that assumption resulted from a written miscommunication between the city council and school board.

The city intended to help fund the turf using the Measure-K bond money. As part of this agreement, the \$5 million bond money would be used to reimburse the district on any improvements made.

"There had been a lot of dialogue about this project in an informal manner that didn't come to the board in any formalized fashion," Lurie told the *Weekly* [in issue #345]. "There were times when we were talking about this, I wanted to make certain that we understood that if the city

were to be generous enough to finance this, they should not expect that grant money to be part of that funding. There had been some miscommunication at the staff level, perhaps, about this."

During the city council vote to fund the original \$600,000 for the turf, the recommendation passed 4 to 1 with Councilmember Linda Briskman dissenting

"I was unwilling to allocate any money for the turf project until I go through the budget exercise next week and find out what can/cannot be funded," Briskman told the *Weekly* [in issue #345]. "In concept, I enthusiastically support coverting the high school field to artificial turf, but I have a fiduciary responsibility to first make sure that the needs and not the wants of this community receive priority funding."

Currently, money for the turf is coming from three sources: the city (\$600,000 not including the additional \$300,000), the Board of Education (\$200,000) and community organization AYSO (\$100,000).

Several other large projects are also occurring simultaneously in the distrct including construction of the Science and Technology Center and the BV-B building project (at Beverly Vista). In addition, the the three other K-8 schools in the school district will receive renovations for the restrooms and auditoriums.

Installation of the high school's turf is expected to be complete some time in the fall. Lurie was in Germany as of press time and was unavailable for comment.



The Gov Takes MySpace

Notes on people, places and ideas. By Rudy Cole

The power of the press, not. Friday lunch at Caffe Roma is mostly a gathering of the usual suspects at their regular tables.

The smoking impaired inside, and the tobacco users or tolerant, outside. With new owners and smaller tables, there has been a reshuffling of seating and, back I went to my old station.

In the **Gray-Davis** era, when Arnold was just another actor making millions in film classics about a terminator or the telling of true lies, we were dining neighbors. His luncheon companions were most often his bodyguards, his hair stylist and an occasional film colleague. We exchanged pleasantries. How was I to know he would one day try to dismantle state government with failed ballot measures? But I did have this good table next to his.

When he was elected, I was moved some distance away. The governor needed two tables. Mine was taken without even the

process of eminent domain. It's understandable that having a Democrat that close could spoil your pasta. His guests are now more political, and his bodyguards were state cops, positioned strategically nearby.

So, when I was restored to my former place of honor, I assumed it meant **Schwarzenegger** was not part of the purchase by the new team, or that we would once again share servers.

Friday was a reality check in restaurant priorities, in case I had any doubts. The governor and his new entourage returned, and I was shuffled safely away. I survived.

In any case, I'm sure my guest was more interesting, even if the gov failed to recognize former Los Angeles County Supervisor Ed Edelman who is now working on homeless issues from an office in Santa Monica's city hall. Edelman had a remarkably successful career not only as a county supervisor, but as a Los Angeles councilmember representing the fifth district, which surrounds Beverly

Hills. Santa Monica and Los Angeles County are very lucky to have Ed using his talents to address one of our most important social issues, the homeless. More on his work later.

It is most kind of Edelman not to bring up a conversation we had over 40 years ago when we were both bright eyed, innocent enough Democratic activists. Ed, who had been working in Washington as a staff member of a congressional committee, one of his earliest jobs, visited me with some news: He intended to run for city council against incumbent Roz Wyman and wanted me to manage his campaign. First, I couldn't do the work because I was managing Marvin Braude in another district and second, I thought he didn't have even a small chance of winning! "Run anyway," I advised. "It will be a great experience, but you aren't known well enough and even if Roz is vulnerable, there are at least four challengers who are well funded and with greater name recognition."

The 1965 primary was a tight race with Edelman edging his opponents, but he clobbered incumbent Wyman in the final. One of the many candidates was Beverly Vista's then principal **John French**. See, that school does have political history. The election also marked my one and only entry into Los Angeles city service. Braude also won and as Edelman was sworn in as an elected official, I

became Braude's chief deputy.

And speaking of restaurants, check out the recently opened and creatively designed "Colors" on North Bedford. Recently seen dining, although not all at the same table, were Marian De Witt, one of the most charming and always cheerful women in our community and four stalwarts of community service, Monty and Marilyn Hall and Charles and Betty Wilson.

Some thoughts on Beverly Hills governance: The city council had, only a few years back, their own deputy. This was a one person position assigned to handle such matters as information gathering, citizen concerns and scheduling, among other chores. That job was eliminated some years back. But should it have been? In West Hollywood, each councilmember has his or her own deputy and the system works very well. Having at least one staff member, independent of the city manager, should be reconsidered by the council.

The recent flap over "managing" council relations with the media might have been avoided if the city had an experienced press aide, who would also expedite information flow. Robin Chancellor, the director of community relations, is very good, but the job is not designated as press secretary, and that's what the city needs. One person who coordinates and assures that important news gets out there and who is the media contact for all departments. Even Spartanberg, who acquired our former city manager Mark Scott, has one. Fred Cunningham, who served for years as deputy city manager and who is still serving our city, although

"retired," knew the press relations technique extremely well. He could train a public relations person and explain the realities of our city's civic history.

Admittedly, the city has an incredibly able staff. Almost every department is "citizen friendly" and service oriented. You seldom encounter the us versus them attitude, endemic in other government offices, when you approach a city counter.

But it would be community helpful if we could encourage more young people who actually live here to enter city service.

Suggestion: Why not use the Team Beverly Hills concept, which has given so many residents a learning experience on how city government really works, for a staff intern program? Bring some of our bright high school grads or college students interested in government into city service – everything from police and fire to recreation and parks, planning and building and safety and more. This experience might lead them into serving in their own community. Mayor Webb and City Manager Wood, give it some thought.

Political rumblings: It seems there will now be two planning commissioners running for city council next year. Nancy Krasne has reconsidered and has told friends she will be a candidate. Before serving on planning, Mrs. Krasne was a member and chair of the Architectural Commission and also an officer of Friends of Greystone. She has an early and impressive list of backers.

Incidentally, in spite of some not too interesting rumors, this columnist is out of the campaign managing business. Nor will I be a

candidate unless I can be guaranteed to lose. I would love to run. It's serving that bothers me. With my luck, I just might win.

The city council may well take the Sports Center proposal to a vote, even before a threatened initiative by opponents.

It would clarify community attitudes, determine if a need exists and it might well stimulate the youth of our city to actually use the constitutional amendment that lowered the voting age to 18. Referenda and initiatives too often demean the democratic process of representative government, but on this issue a voter plebiscite may be the only way to find out if a sports center is needed.

Good to hear that **Gloria Jennings** has mended well from her too frequent hospital stays and is lunching with the ladies at the Beverly Hills' Polo Lounge. **Lya Cordova Latta** and hubby **Harrison** are off on another trip – that means half of the time in Beverly Hills and the other half on cruises or at Theatre Forty plays.

There's a condo going up south of Wilshire that has totally intruded on neighbors. What great early Beverly Hills planners decided that our narrowest streets should be where we are going to place our heaviest concentration of housing? Unlike Wilshire, a more recent choice for mixed use, construction on the narrow by -ways is very intrusive.

City Continues With EIR Plans For Robinson's-May Site

An agreement for an environmental impact report for property at 9900 Wilshire Boulevard was finalized at Tuesday's city council meeting. Fees for the EIR amount to \$408,063, which will be placed in escrow and later reimbursed to the city.

The contract with Impact Sciences will include an extra \$50,000, which will cover any unanticipated costs that might arise during the study's process.

The city also reviewed a proposal from Jones & Stokes Associates to conduct the EIR. However, the city ultimately chose Impact Sciences in favor of the consulting firm's internal organization, which calls for one project director and one project manager to oversee the EIR process. Fees to have the firm Jones & Stokes conduct the EIR would have amounted to \$390,048.

Impact Sciences is expected to also create a report for the Hilton Hotel once the city receives an application for the hotel's redevelopment.

Hoffman To Leave High School

Beverly High Assistant Principal David Hoffman accepted a position as Principal of Madison Elementary School in Redondo Beach. He is now the seventh administrator to leave the BHUSD this year.

Hoffman will replace Dr. Patricia F. Kinnan, the Madison Interim Principal. The school serves the northern portion of Redondo Beach and offers classes for kindergarten through fifth grade. This past year, 450 students were enrolled at Madison.

"I look forward to going back [to an elementary school] and working with elementary school kids," Hoffman said. "I loved the people here [in Beverly Hills] and feel I'm a better rounded individual."

His transition from high school to an elementary school should be smooth considering Hoffman worked at an elementary school before Beverly High though not in the same job capacity. He was the Categorical Programs Coordinator Advisor for Third Street Elementary School in LAUSD before coming to Beverly Hills in 2003

Former Beverly High Principal Ben Bushman currently serves as the assistant superintendent of Student Support Services in the Redondo Beach Unified School District. Incoming Beverly Vista Principal Erik Waren also worked in the Redondo Schools prior to coming to Beverly Hills.





coverstory COMPLEX IRRITATING NEIGHBORS

Although Century City land, the plans for a high-rise next to the high school, is cause for concern in Beverly Hills. By Kari Hamanaka

A Los Angeles project to build a highrise has some in Beverly Hills concerned over the site's close proximity to Beverly High. Sitting at the intersection of Moreno Drive and South Santa Monica Boulevard, the proposed project raises issues over the building's potential height and appropriateness as it sits adjacent to the high school.

"As soon as I learned of the potential development, I sent a letter to both

SunCal and [L.A. Councilmember] Jack Weiss," said Mayor Steve Webb, "expressing my concern as the mayor of Beverly Hills of the potential impacts that such a development could have especially adjacent to the high school and indicated that the city would vigorously oppose any project that posed a threat to the safety and welfare of the students at Beverly Hills High School."

At its informal meeting held Tuesday, the Beverly Hills City Council asked City Attorney Larry Wiener to look into the city's boundary line after Irvine-based SunCal Companies purchased the land last month. The developer has plans to convert the empty lot into a high-rise building with luxury condos.

"This property is one of the jewels of Southern California," said Frank Faye, SunCal Companies Los Angeles/Central California Region President, in an e-mail. "It is perfectly positioned to take advantage of all that Los tial hope is that it will provide an A construction sign posted at the Moreno Drive construction entrance. extraordinary place to live, work and play – all in one location."

A representative for the company said specific details such as the building height and number of condos to be built are unknown because the plans are in the early phase of development. Despite that, construction has already begun where a covered fence surrounds the land's perimeter.

According to Moreno Drive resident David Murphy, the construction noise, dust and parking problems are a nuisance to residents near the SunCal land.

"The noise and the parking impact [from construction] have really been creating serious quality of life issues," Murphy said. "We would prefer that the developer take steps to, if possible, monitor the air quality resulting from the dust coming out of the area."

The existing boundary lines between Century City and Beverly Hills dictate who has a say in the development process making this a purely Century City development issue. It is the project's proximity to Beverly Hills that has made it a Beverly

cally, Beverly Hills has no official role in the project.

Both Hansen and a SunCal representative said they would be willing to work with Beverly Hills to incorporate the city's concerns and ideas into the overall plan.

"We must first engage local officials and our neighbors to discuss how we can collaborate to develop a plan that will benefit the entire area," Faye said, "and

The 2.25 acre piece of property, located at 10000 Santa Monica Boulevard, was the object of interest several months ago after the Weekly reported on the auction of the land [issue #343].

Several developers were interested in purchasing the property, including Donald Trump. However, SunCal outbid the other companies in a deal worth over \$110 million.

> The former site tenant, Fox Sports, vacated the lot last year. However, the land owners, 10000 Millennium Plaza, LLC faced several lawsuits that began during exit negotiations between Millennium and Fox, beginning in 2001.

Millennium owners said there was a clause in the lease that not only required Fox Sports West to pay a termination fee, but also restore the building to what it had been before Fox became the tenant. Fox disputed the restoration fees (amounting to \$5 million) by filing a lawsuit, which resulted in a settlement for Fox.

Another lawsuit followed after Millennium negotiated with the owner of Jimmy's Restaurant, Jimmy Murphy, to purchase Murphy's lease. Murphy left the building, but did not receive the money from Millennium for the lease purchase.

In 2005, Millennium filed for Chapter 11 bankruptcy and the courts ordered an auction to be held in May of that year for the building. Several developers bid on the property.

One developer, Grand Avenue LA, was interested in building towers that would house luxury condos, an idea similar to what SunCal has proposed for their newly purchased land.

"The city of Beverly Hills has the legal ability - if it feels that it is necessary - to challenge any process that violates the law, and in particular, if the EIR (that ultimately would be required) is legally deficient," Webb said. "We will represent the city in making sure that the developer and the city [of Los Angeles] proceed as legally required."



Hills issue in a city where development projects' heights and mixed-use nature have been the source of past and recent debates.

"The councilmember [Jack Weiss] is waiting to see what the final proposal includes and he will ensure a full public process that gives all stakeholders the opportunity to be heard," said Lisa Hansen, Deputy Chief of Staff for Los Angeles City Councilmember Jack Weiss

According to Hansen, the city of Beverly Hills has been in touch with the Los Angeles City Council over some concerns with the project and said that techniwe are eager to begin this comprehensive planning process.'

According to Webb, an arrangement between himself and Jack Weiss is in the process of being planned. Webb said he made arrangements to meet with SunCal representatives, but they cancelled the meeting.

"I felt [the cancellation] showed a clear lack of concern and sensitivity on their part," Webb said. "They have not called back [to reschedule]. They've basically given the city of Beverly Hills the message that they don't care and do not consider our issues or concerns important to

Norman senior guard Cosmo Morabbi scored 40 points against Hamilton and 38 against Leuzinger.

"We played well," Beverly Hills coach Luis Turcios said. "I think it was a good tournament for the kids. We kind of relied too much on Cosmo to do a lot of the stuff."

The Normans played without starting point guard Julian Wheeler, who is sidelined with a broken left ankle.

What's Next?

The Normans were scheduled to play perennial Los Angeles City Section power Los Angeles Fairfax Wednesday in a Nike 20th annual Fairfax Summer Basketball Tournament first-round game yesterday that was to begin after the Beverly Hills Weekly's deadline.

If the Normans won, they would face the Orange Lutheran-West Torrance winner Friday at 6:50 p.m. in a championship quarterfinal. If Beverly Hills lost, it would face the Orange Lutheran-West Torrance loser Friday at 5:30 p.m. in a consolation quarterfinal.


