



BHUSD Starts off School Year with Influx of Teachers

Each school in the district hired new staff members.

The BHUSD hired a large amount of new teachers and counselors for the 2006-2007 school year. According to Beverly Hills Human Resources' records, 44 new teachers and three new counselors assumed positions this fall, some of whom are recent college graduates.

"I had the best experience as a student [at Beverly High] which is why I'm back," Halimi said. "I was really involved in ASB and I played basketball as well and I love the school. I want to give back in any way I can which is why I'm here teaching."

Halimi is currently in an internship program at California State University Northridge which is allowing her to earn her teaching credential while teaching at Beverly High.

She said one of the greatest things about teaching in the BHUSD is the community support.

"The parents care about the well-being of their students. 99% of the school is college bound. Everyone wants to do well and wants to learn," Halimi said. "The faculty and administration are all great too. It's just a wonderful community to be a part of."

For Halimi, it is comforting to know that her colleagues are starting out fresh along with her.

"It's just nice to be on the same page as a lot of other people who understand what you are going through, being in a new environment," she said.

Alyssa Para, a new El Rodeo Physical Education teacher, knows what it's like to move from one environment to another.

Para, who graduated from college in 2001 and previously taught for a private school in San Marino compared the public school system with that of the private school system.

"The private [school] I was at was also a K-8 school so that's similar and the students are very similar," Para said. "What I appreciate here is that I'm not the only teacher. In the physical education department there [are] two of us who teach cooperatively. That's really the biggest difference and the biggest blessing."

Making the change to public school was not that difficult for Para, who said she discovered the job opening at El Rodeo on the web.

"I'd heard about the reputation of the school district and how outstanding it was," Para said. "I went online and looked at the web site and was just very impressed and have been impressed with the whole process. I'm very happy to be here."

Each of the five schools in the BHUSD hired new teachers and counselors. According to Beverly Hills Human Resources' records, Beverly High hired 24 teachers and one counselor, Horace Mann, 10 teachers and one counselor, El Rodeo, five teachers and one counselor, Beverly Vista, four teachers, and Hawthorne, three teachers.

BHEA President Chris Bushee said there is no overarching reason for why the BHUSD lost so many teachers after the 2005-2006 school year and that it is a confluence of a number of different factors.

"I think that the reasons were varied. We had quite a few retirements. People made changes in their profession," Bushee said. "Looking over the personnel records that I received from Human Resources, I've noticed that we have quite a number of teachers who are on leave. I would imagine that many of those would be maternity leave. Maybe others [left] for professional development or something else. [Also] quite a few of the new teachers have a temporary status; they're temporarily replacing teachers who are on leave."

The change in faculty left the doors open

a guy named Walt Puffer and later he became a [principal] at [Beverly Vista]. Walt and I were LA County beach lifeguards together in the summer. We worked together on the beach, so we had a personal relationship, but when he needed [someone for the job] he thought of me. I went up and interviewed and got the job. I also coached wrestling and they also needed a wrestling coach so I [took] both of those jobs. About three years later I think, Walt Puffer [became assistant principal at] Hawthorne School, I believe, and that opened up the athletic director's job and so I applied for that and was appointed athletic director. I was athletic director, head football coach and wrestling coach. It was probably too much for one guy to handle but I couldn't

Tell us how you got to Beverly Hills

I was with a very successful program at Long Beach Poly. We just won everything. We had great athletes. Beverly's coach, a guy names Joe Sabol, was promoted [to another job] and felt that he wanted to step out of full time coaching. They had an opening and the athletic director at that time was

step back. It was so exciting to watch those programs turn around and watch these kids take responsibility for establishing a really sound program and we had such good coaches too. I don't think anybody realized including myself what an incredible coaching staff Beverly had. I had a guy that I hired from Long Beach State, Jack Riley. Ben Bushman became coach when I left and then eventually he became principal of the high school. I've met a lot of good people. I have a lot of good friends, but Ben Bushman is right at the top. Then we had a guy named Jack Riley, who I hired from Long Beach State and he ended up coaching in the NFL and he's been coaching in the NFL for about 15 years. We had some real-

ly great coaches.

You are responsible for hiring and/or working with some legendary coaches, many of whom later became administrators. Tell us a little about some of them:

Walt Puffer

Walt was of course the water polo and swimming coach and they had a great water polo program before he left. He wisely selected Ron Crawford who I went to school with, at Long Beach State and we were LA County lifeguards too. In fact there were several LA County lifeguards who were coaches. always had [an] extremely good [reputation] with the students athletes. He knew the sports very, very well and he selected good people to when he moved into administrator and started hiring people.

Ben Bushman

Ben is a rare bird. He combines I think the finest of elements of a professional. He's got a lot of innate wisdom. He is very competitive in a positive sense and leads by example. I don't think there was ever a harder working guy. He commuted every day from Long Beach to Beverly Hills. [He is] a great parent [and has] awesome kids and I think he had the ability because of his coaching background to relate to kids on a level that the kids respected and yet they knew he meant business. He was a no-nonsense kind of guy. He was a hands-on, eyeball to eyeball, get the faculty moving, get the team moving [guy]. He was a real leader. He is an incredible human being. My frame of reference is pretty high. I worked in the White House for a long time, and I've worked in major corporate companies and really have had a wonderful experience. I put Ben right up there at the top four of five capable, confident professionals I've ever worked with.

Dick Douglas

He was hired when I was the athletic director and Walt Puffer was the guy that called the shots on that because he was the aquatic specialist. He was a classroom teacher and coach. Most of the coaches who taught P.E. coached but he did have some people who were inside the classroom. I think he taught Social Studies. I've lost track of both he and Ronny but they were a great team. [They had] a good sense of humor; never crushed if they lost or over the top if they won. [Dick] was a pretty even guy but really did well with the kids. That water polo and swimming program was great. I don't think anybody realized the quality of coaches that school had while I was there.

Ron Crawford

Ron was of course a two-time, maybe three-time, Olympic water polo player himself. He grew up in Orange County. I knew him before he came on board because of the LA County lifeguard relationship. As an athlete is was just incredible. He was very rugged, very tough, and very physical in the water and as a coach; he coached pretty much that way. He had a lot of energy. He wasn't beyond yelling at people and getting them to do things but he also, like Dick, had a great sense of humor. He was great and the water polo teams were great.

Chuck Kloes

Chuck was a history teacher. [He was] very bright and verbal. I always thought somebody would have discovered him and got him on television or movies because of his stunning good looks. He had great personality and this smile that was charming. He really knew how to teach. [He] could

take a kid that had very little skills and help them develop their confidence and of course their skills. [He was] exceptionally gifted in working with high school boys, because [he had] a great sense of humor. Chuck's fabulous. I'm not surprised that he's still coaching there at Beverly. I really would like to see him again. It sounds like I'm just white-washing it. The records speak for itself. You do not have that kind of consistency across the board success, and I'm not saying that success was championships. Certainly if you looked at the scoreboard, we had that but the number of kids we had come out for the teams. We were suiting up 50 kids on the varsity. We had a junior varsity and a B team so that was probably 120 kids that came out and stayed out and they suited up every week. A good coach works with the whole person and athlete. Not just when he's on the field or in a uniform but he sees him up on the campus or he gets to meet his parents after the game.

Tell us about some of the students you remember at Beverly Hills

I still talk to those guys all the time. I get calls, not every week, but at least once a month I'll get some emails or somebody will call me. Several of them come to town. [One was] Bill Hussey who was a football player and a wrestler for me. When I was married about seven years ago, I asked Bill if he would stand up for me at the altar and it was just awesome. There were about four other guys who came. They showed up and they were laughing and giggling and having a great time. One was George Kimball. It was just so much fun. Bill and I had worked together on several health related policies here in Washington. He became very much involved in the environmental movement and was a lobbyist and worked for a number of non-profit organizations in trying to persuade congress to pass legislation for a cleaner environment. Since I left Beverly [I've been] a health promotion fitness person and have just been torn up by the failures we've had in this country over the last 20 years. So Bill Hussey and I worked together on Capitol Hill, working shoulder to shoulder. You can imagine the football analogies that we'd throw across to one another because we didn't coach; it was the same kind of mindset. We had a moral stance that we really believed in. If I was in a jam, if I thought I needed a back up I'd call a lot of people. But I'd call those players. There's just a huge amount of loyalty. The kids that I see from time to time, I hear them saying the same things to me that we said to them and it's been 33 years or more for the younger players. They got it. I got a kick out of calling Tony Rubin. One of the things we did, almost every kid on the team had a handle, a nickname like "Ben the Bear", "Bill the Bull." Tony Rubin is a super guy. He was one of the early guys and I called him and he didn't think he'd ever talk to me again I suppose, and he came on the phone and he said, "Hello," and I said, "Rat" and he said, "Coach Keelor." I said, "Tony, how [are] you doing." He said,

"Coach, you'd be proud of me, I just finished working out." I said, "What did you do?" and he gave me his routine. It was just like when we were standing there in that weight room, 35 years before.

Tell us the famous "heart attack" story

I don't know who came up with the heart attack story, but that is not at all accurate. It was probably Bushman or George Kimball - maybe Coach Jerry Carpenter. However, it is true I became quite ill at a Morningside game held at Sentinel Field in Inglewood.

Here are the facts: While the team was going through their pre-game warm-up, I foolishly wolfed down a hot dog loaded with mustard and relish. Not too smart anytime, but especially before a game. By the second quarter, I thought I was going to have to leave the field but it was a super big game and I hung in there.

As we went into the locker room at the half, I was sweating and dizzy. I stepped into the restroom and players had all the facilities completely occupied. As I started for the door, one of the coaches wanted to insert a new offensive set and called me into the discussion. That was bad. No bathroom, no outdoors, no time left. The half was winding down; the team eager to hit the field and time for my usual fire and brimstone pep-talk. The team and coaches were all looking at me with great anticipation knowing they were about to get their adrenal glands tweaked and all of a sudden it was coming up with a rush. Bushman could see something was wrong and asked me if I was alright. I moaned, "No, take over," and headed for the door onto the field. I was standing behind a tree all bent over and heard Bushman and the staff yelling as they all charged out to field. I was stuck in the now empty locker room for most of the third quarter. I managed to stagger out on the field just as some jerk from Morningside threw a punch at Lindsey Wellman (Pioneer League Player of the Year) and his brother, Mike decked the dude. Before I could make it to the sideline both benches emptied onto the field and it took about 15 minutes to regain order. I have heard the "heart attack" tale before so as famed radio commentator Paul Harvey is fond of saying, "Now you have the rest of the story."

When did you leave Beverly?

I was athletic director and [won an] award [which] involved a trip to Washington D.C. for an interview with this panel of politicians and great athletes. While I was there, there was a guy from Sacramento Department of Education who had just been hired to run the President's Council on Physical Fitness and Sports and he asked me to come by his office. I was there for a week and he wanted to talk to me and introduce me to the chairman of the council. At the time [it was] Jim Lovell (Apollo 13). I met Jim [and he] said that they had an opening position and they were looking for someone who had background in public school teaching and coaching. I'd

done a lot of work in Sacramento in maintaining the physical education requirement for K-12 in schools. So I felt comfortable arguing, persuading and cajoling legislators to see things our way. They said "Would you be interested?" I was really flattered but I was just about to finish my Ph.D. at USC and had to do an internship and write my thesis. I loved coaching. What I wanted to do was be the head coach of the [USC]. That was my goal. He said "Well, I really want you to think about it and then let's talk tomorrow." So I saw him the next day and he gave me a little more of a sales job and then they had the award banquet. Jim said, "Listen, we're going over to talk to the President tomorrow. Would you like to come with us?" So I said, "The President of the United States I assume you're talking about?" And [he] said "Yeah." I said, "Are you kidding?" So [there I was] sitting in the Oval Office. I sat in the back. [When] the meeting was over, Jim said to [Richard] Nixon, "Mr. President, I want to introduce you to Dick Keelor from Beverly Hills, California and he was just awarded athletic director of the year." The president said, "Oh yes, he's the one you've been telling me about. They tell me you're going to join us." It was a set up. I didn't know what to say, I just said, "Yes sir" and shook his hand. So we go back to the office and I said "What went on there?" and they said, "You just joined the staff." I said, "But I told you, that's not something I can do. I've got these kids at Beverly. I have this program going. We're getting things going and I'm a beach bum. I couldn't live in this environment." And he said, "Well, think about it." I sat down with my family and we talked about it [and] that's how I ended up back here. There's no person in the world that has been more blessed than I have in meeting people. I've traveled around the world and I've met some awesome people. I hope I've made an impact. I'm not through yet. I'm still plugging away.

Tell us about Health Designs International.

Health Designs is a company I started in about 1990 in Raleigh, North Carolina. Our principal focus then was to go into corporations and do a healthcare cost analysis and develop an intervention wherein we would incorporate a physical fitness facility by HDI personnel who would work with employees, particular moderate to high risk employees, and help them make incremental changes in their personal choices to be more healthy and productive and everybody wins. The company wins; healthcare costs go down and the employee wins because they are going to live a happier, healthier life. Now we're trying to revitalize that whole company, at first at the employee health fitness level. We're going to also look at schools. I'm hoping, I believe and I'm trying to convince some major national sponsors to challenge school districts to put in a sound facility and to employ well trained professionals. There are learning systems we can put into place. We call it

Bicyclist Fatally Injured in Hit and Run on Wilshire

Peter Kim, the 39 year-old of Los Angeles, who is a suspect in the felony "Hit and Run" surrendered to Police Officers on Tuesday, and was booked at the Beverly Hills Police Department Jail after a bicyclist was fatally injured after a hit and run traffic collision occurred at Wilshire Boulevard and Santa Monica Boulevard at approximately 7:30 p.m. on Monday.

When Officers responded to the call they found that a male bicyclist had been struck by a full size sport utility vehicle which had fled the scene. Officers recovered a black 4-door 2002 Cadillac Escalade at the 800 block of Lucerne Boulevard Tuesday and believe it to be the vehicle involved.

The bicyclist was transported by Beverly Hills Fire Department paramedics to UCLA Medical Center and was pronounced dead.

The victim has been identified as Ilia Panikin of Los Angeles.

Kim is expected to appear in court on charges of vehicular manslaughter gross negligence and felony hit and run on Oct. 18, and is being held on \$50,000 bail.

Wilshire Boulevard was closed for nearly four hours, between Whittier Drive and Santa Monica Boulevard while the initial investigation was conducted and was reopened at approximately 11:30 p.m.

Blaze Breaks out at Beverly Hills Home

A 4,000-square-foot, two-story home in the 700 block of Foothill Drive in Beverly Hills, caught on fire on Monday, Sept. 16 and caused at least \$150,000 in structural damage.

According to Beverly Hills Battalion Chief John Karns, the fire broke out around 6:30 a.m.

Although the cause of the fire is still under investigation, Karns said that "some remodeling was taking place."

He said arson is not suspected.

No one was home when the fire broke out. The blaze cause heat and smoke damage to the second floor as well as the attic. There was also some smoke damage to the first floor.

Flames were extinguished by Beverly Hills firefighters and Los Angeles crews just after 7 a.m.

A discussion led by Little Rock Nine member Dr. Terrence Roberts, and Emmy award-winning producer Sandra Robbie, is scheduled for Tuesday, Oct. 3 at 7 p.m. at Beverly High.

The Little Rock Nine is a group who faced threats of angry mobs in a landmark desegregation of Central High School in Little Rock

Panelists will discuss the motivations behind the people who were involved in the civil rights movement as well as other topics including the role the alliances have in helping different racial, religious and ethnic groups make strides toward justice and equalities.

"The Beverly Hills Unified School District is

Of The Super, Council, Pope and Times

Give new super a chance, council lineups, the Pope battles Arabs and Times Fights Owner.

A new school superintendent is introduced, the likely candidates for city council are emerging and some are bowing out, the Los Angeles Times is engaged in an internecine struggle with its owners and the Pope has enraged the Islamic world. Where to begin in this fascinating news week.

Last first. The comments by the Pope in, of all places, Germany certainly did not contribute to a calming of religious conflicts in the Middle East, or the world. It was hoped that the Holy See could be a force for bringing the moral persuasion of all religions together to end the growing conflicts which are triggered largely by religious fanaticism. Yes, there is oil, there are territorial issues and many more reasons for the world's ills, but the differences in religious beliefs dominate the minds and hearts of even impoverished masses.

The reaction does remind of an old story told in the Italian community. A motherly type calls a television station to complain about the portrayal of Italians on the tube: "We are not all

members of the Mafia, we are not gangsters or murderers and you must stop showing us this way. If you don't, I'm coming down there to blow up your station."

The new school superintendent, **Kari McVeigh**, was introduced to the community last week, and I owe her an apology. What I said was "Welcome to Beverly Hills." What I should have said, was "thank you for accepting the job."

Some of the reaction to her first appearance and speech at the school board meeting was not very generous. Her words were too general, too boilerplate education generalities to stir excitement. Also, she was plainly nervous, which was understandable. Even her very conservative attire drew comments.

However, McVeigh has an incredible resume and has given up a job in a district, San Diego, which held her in high regard and where she could have continued to expect advancement. She took a chance, and so should we.

I have a great deal of respect for the search

team that recommended her and to a unanimous school board that made the final choice. They did not opt for the super who might have been more photogenic, more akin to what we would have found if we called central casting. We have an educator, one willing to really help us find new and better tools of improving the quality of our educational services. Are we as good as we think? McVeigh needs the time and support to help us enter a whole new experience in teaching – one that makes education a collaborative effort. We have a really outstanding teaching staff, but there is a need to bring to the process a reexamination of teaching methods, of curriculum changes that will make us willing to think about change and progress as exhilarating opportunities, not attacks on our history. We often forget how our schools depend, not just on continued support, on well trained and highly motivated teachers, but on the quality of the children who enter the system.

McVeigh follows two superb communicators. **Gwen Gross** knew that when she was on television, red was the right color. McVeigh wore grey. **Jeff Hubbard** was able to mix humor with insight, and he had four years learning about the district before assuming the top job. They are gone and we have someone very different, and that might well be what we need. She took a chance on us, we now need to give her the support she needs. Incidentally, although the reception for her drew mixed

reviews, her next day visit to the schools and meetings with teachers were very well received.

Different styles? Our longest running school boss, **Ken Peters**, who ruled with a very firm hand, would have been shocked by the changes in protocol made by more recent school superintendents – seating the super among the board members and next to the board president. He sat at a staff table as does our city manager and city attorney at council meetings. Also, who decided it was legal to call for voice votes instead of a roll call on board votes? All implemented before this board took office.

Are they running, walking or bidding their time for the March, 2007 city council elections? Two of the stronger possible contenders have told friends that they will not enter the contest. **Dr. Willie Brien**, a former school board president and current board head **Myra Lurie** both gave serious consideration to running for council, but have decided, for many reasons, that the time was not right.

Dr. Brien is very busy in handling new leadership roles at Cedars-Sinai and Lurie is committed to helping lead the changes taking place in our schools. Lurie is a bright new face in city politics and is clearly a strong possible future candidate. School boards have given us many excellent councilmembers, and Lurie would be no exception, however her decision to wait makes good sense. As for Dr. Brien, he has been far too aloof from city issues in recent months and will have to reinvent himself if he has any plans for future office, once his stated life goal. Talented, bright and people oriented,



Brien has wasted too much time if he really wants to enter public service. Also, he has frustrated friends and supporters by not returning calls seeking updates on his plans.

As for former **Mayor Robert K. Tanenbaum**, who was being urged to run by some vocal anti-council leaders, the lawyer turned author has told some likely supporters that he has no desire to again serve and wants time to work on his books and family. He does spend considerable time outside the city and his entry into local politics would have meant a very confrontational battle with his former adversaries.

The two incumbents, **Mayor Steve Webb** and **Vice Mayor Jimmy Delshad** will be hard to beat, but they are hardly guaranteed an easy ride to a second term. On most major issues, this council has had few differences – the exception being an ethics ordinance and the need for a Community/Sports Center.

There are three very strong challengers, each with a very different constituency. The one with the most impressive resume is **Nancy Krasne** – she served on both the architectural and planning commissions. **Shahram Melamed** is a new member of planning and also served on Recreation and Parks. They both have a problem, however. Their votes on issues before the planning commission are almost entirely the same as Webb and Delshad.

How do they differ? Krasne made it clear she did not support the sports center in the Industrial Area and Melamed, although he recused himself, strongly opposed the Legacy condo-mixed use project. The council unani-

mously reversed the Planning Commission on proper use of the site.

The third contender, **Maggie Soleimani** may well be the surprise in the election. What is one of her strengths? She did not have to vote on any development issue. What is her weakness? She did not have to vote on any development issue. (She has not served on the planning commission.)

Friends in the Iranian community have told us she has more support among Persian voters than either Delahad or Melamed, and is highly regarded. She has earned points too outside the Iranian community by her work with the BHEF, PTA and as an attorney. She is a very able public speaker and has delivered welcoming addresses at school openings.

Early endorsements, which sometimes matter and often do not – consider all the support **Bernie Hecht** had when he lost to then unknown **Thomas Levyn**, have gone to the incumbents and to Krasne and Melamed. Both have good name lists.

Much too early to even draw conclusions, but the challengers will have a fairly tough campaign road to travel to beat either Webb or Delshad.

The turmoil at the *Los Angeles Times* is sad, especially for the staff. The Chicago owners have ordered personnel cuts and local bosses have mounted a very public campaign of resistance.

The *Times* is one of America's great newspapers and it was not a good day for our city when the Chandler family decided to sell the paper to *The Chicago Tribune*. No matter their

resources, local ownership is always preferable and more responsive.

Some of the less important changes at the *Times* did upset many readers, including the diminished size and coverage of the TV *Times*. That Sunday supplement no longer carries capsule reviews of movies, channel line ups and other features. Its shrunken size testifies to all that is wrong with the paper itself.

Now, the final blow: In order to keep receiving even this poor imitation of the TV *Times*, subscribers had to either call the paper or mail in a card. That is a very dangerous journalistic experiment.

Suppose readers of the *Weekly* demanded that **Josh** cut my column? Or suppose all the hard core Democrats and Republican moderates who receive the *Courier* wanted publisher Smith's editorials trashed? The logistics would be challenging.

As for the *Times*, if they want some thought on savings, I would offer the following: "Mallard Fillmore," "Prickly City," "Lio" and "Pearls Before Swine" in the comics will not be missed, at least by this reader. Don't touch "Blondie," "Drabble" or the best, "For Better or Worse". As for the other comics, you can keep **T.J. Simers**, although barely, but lose **Joel Stein**, at least in my delivery. In any case, don't send him back to Beverly Hills, please.

This would never have happened if **Col. Robert R. Mc Cormick** still owned *Da Trib*. Once, when Rhode Island did something that drew his ire, he had a copy boy go down to the *Trib* building lobby and cut out one star from the flag. You can imagine what he would have done to the *Times* rebels.

for Hayley Denenberg who graduated from college in 2002 and accepted a Spanish teaching position at Hawthorne this year.

Denenberg said she'd tutored Spanish for a couple years but had never taught in the public school system.

She said that everything is basically going smooth except for a few minute challenges.

"My biggest challenge [was] just being overwhelmed in the beginning," Denenberg said. "I had to learn the technology and I had to learn how to work the copy machine; all those little tiny things. It was just a little overwhelming. But as far as being in the classroom, I feel very comfortable. My problems have been mostly getting adjusted to a new job and a new school and learning all the policies of the school and the rules."

Overall Denenberg feels confident in her new position and is excited about working in the BHUSD.

"There [are] so many good things about [the BHUSD]. One is I think that it's a community where everyone cares so much about the education; the teachers, the parents and the students, and that's a really nice environment to be in," Denenberg said. "I've observed classrooms in other districts and it seems to be more the teacher trying to get the students to want to learn. In my classroom all the kids came with a big appetite for learning and it's just nice to be in that kind of environment."



Normans Record Victories From Coast To Coast

BHHS football team wins in Massachusetts, boys' water polo team wins tournament, cross country runner wins race in Orange County.

Running back Ramon Judkins and receivers Darrian Richardson and Dominique Sandifier helped Beverly High run past Marshfield Saturday.

Judkins ran for two touchdowns and was stopped one yard short of a third in the Normans' 31-20 victory in an intersectional game in Marshfield, Mass.

"I think we had more speed than they did and we were able to get ball to the ball outside to Dominique and Darrian Richardson," Beverly Hills coach Carter Paysinger said after the victory which enabled the Normans to start a season 3-0 for the first time since 2000.

Judkins' first touchdown came on a one-yard run 15 seconds before halftime that tied the score, 14-14.

On the first play of the second half, Judkins ran 60 yards for another score, giving Beverly High a 20-14 lead it never relinquished.

"It was his speed that allowed him to outrun the angles and get into the end zone," Paysinger said.

The Normans increased their lead to 28-14 later in the quarter on Darrian Scoggins' five-yard touchdown run and Meyer Linter's two-point conversion pass to Jon Skura.

The Rams (1-1) cut the deficit to 28-21 early in the fourth quarter, but Trevor Charlston's late 39-yard field goal sealed the victory.

Marshfield scored a touchdown on its first drive. Beverly High tied the score, 7-7,

early in the second quarter on Linter's one-yard run, one play after Judkins' 11-yard gain.

The Rams regained the lead later in the quarter.

The Normans "played very well," as they had to adjust to playing in a different time zone and under college rules allowing for blocking below the waist, Paysinger said.

Fullback Gerald McGee, Judkins, Linter, Richardson, Sandifier and the Beverly High offensive line of Brent Brien, Jon Jun, Brandon Kim, Mike Rostovtsev and Nick Urteaga all drew praise from Paysinger.

Defensively, linebackers Nathan Forrest, Michael Kerman, Sae Bin Park and Benji Rosen, defensive tackle Shayad Meshkaty "all played very, very well," Paysinger said.

The victory extended the Normans' regular-season undefeated streak to 13 games, their longest streak since a 16-game winning streak from 1995-97. The current streak began at the start of the 2005 season.

The victory also moved Beverly High up two spots, to fifth, in the Southern Section Western Conference poll released Monday.

What's Next?

The Normans have a rare bye week as the result of the difficulty of avoiding conflicts when scheduling a game near Rosh Hashanah, which begins at sundown Friday, Paysinger said.

Beverly High is scheduled to resume play Sept. 29 at Manhattan Beach Mira Costa.

THE BATTLE ON NORTH BEDFORD DRIVE

With her employer deceased and the house for sale, the maid of the estate says she has nowhere to go.

Rosa Hernandez, the maid for a local estate, claims provisions which had been made for her and her daughter, Jessica, before her employer's death aren't being carried out.

Hernandez's claims her employer Marian Seabury, the lifelong companion of famous classical pianist Jose Iturbi had promised her that she would always have a job as a live-in housekeeper at Seabury's 915 N. Bedford Drive home. The home is now for sale and at 55, Hernandez claim is that she is too old to get another housekeeping job.

Seabury, who died on January 16 of this year, had no living relatives and had drawn up a living trust which left her estate and its belongings to the Jose Iturbi Foundation, which was set up to help support young classical musicians.

The estate originally belonged to the famous classical pianist and conductor Jose Iturbi. Iturbi, who died in 1980, left everything to his lifelong companion Seabury. Iturbi made his American debut in 1929 and from 1936-1944, he was the conductor for the Rochester, N.Y. Philharmonic Orchestra. Iturbi also appeared in several MGM movies in the 1940's, including *Anchor's Away*, starring Gene Kelly and Frank Sinatra.

The three people who Seabury appointed as trustees are now in charge of Seabury's home, where Hernandez and her daughter currently reside. Since the home is now an asset to the foundation, George Braunstein, who was Seabury's lawyer and is now representing one of the trustees, Donnelle Dadigan said the trustees had decided to go forward with selling the house as it would be the most beneficial option to the foundation.

"They're trying to create a controversy where one doesn't exist."

The eight bedroom, eight bath home is currently listed on the market for \$13.95 million. According to Braunstein, the proceeds from the sale would go back into the trust, which would provide further funding for the Jose Iturbi foundation. Braunstein said the foundation will also be using the proceeds from the sale of any contents of the house, including clothing, jewelry and artwork.

This would considerably raise the assets of the foundation, which were reported at \$44,858 in December of 2004.

Larry Larson, who is representing Hernandez's 16 year-old daughter has filed a petition on behalf of the minor to put a notice on the house, warning potential buyers that the sale of the property is being contested.

Larson is contesting this sale on behalf of the younger Hernandez, because Seabury had

made arrangements for Hernandez and her daughter to live in the home for life and be employed by the foundation. Larson said that in the original Living Trust, it was stipulated

this trust."

Larson is also filing a Trust Contest to knock out the two amendments to the living trust, to ensure that the house remains with the founda-



The home for sale at 915 N. Bedford Dr. is listed at \$3,950,000. All proceeds are scheduled to go to the Jose Iturbi Foundation.


that upon Seabury's death, the house would be used as a place of residents for classical musicians in the area and that Hernandez would be able to remain as the caretaker as long as she was able.

Also at one point, there was a version of

Seabury's living trust that allocated \$200,000 to Hernandez if she was still in Seabury's employment at the time of her death. In that version of the living will, it was also stipulated that on Hernandez's death, her daughter would be provided with "as much of the net income of the Trust" that would be "necessary for her proper education," and, upon the completion her bachelor's degree, would receive \$40,000 from the trust.

All of this, but the \$200,000 was amended though on October 26, 2003 by Seabury. George Braunstein who was Seabury's lawyer and is now representing Dadigan said no one knows why Seabury would have removed those parts of the trust, but stressed that it was Seabury's wishes.

"Mrs. Seabury was a very private person," Braunstein said, "It was her wishes to set up



tion and the Hernandezs remain in it.

Larson said his major reasons for doing so are that he feels Seabury may have been under the influence of Dadigan when she made the amendments.

"There's too much evidence of wrongdoing," Larson said.

As part of the arrangements that were made for her, Hernandez is able to live in the house until it is sold. She is also currently collecting her usual salary, which Braunstein described as quite generous and was given the \$200,000 that

was provided for her in the trust. This said Braunstein, was Seabury's way of providing for her.

Since the rest of the provisions were removed by Seabury nearly three years ago, Braunstein said the Hernandezs really have no case.

"They're asking for things that Marian Seabury changed herself," Braunstein said.

Larson also filed a request for an accounting from Dadigan naming all of the items that Hernandez said she saw removed from the house. Braunstein said there would be no need for the accounting, as the items were part of the trust and had been removed for safekeeping before being sold to benefit the foundation.

According to Braunstein, this was the exact reason Seabury set up a living trust, so that the items would not have to go through probate and would all go directly to the charity.

"They're trying to create a controversy where one doesn't exist," Braunstein said. "These were trusted confidants; it's not like [the trustees] are getting it."

But on September 19, Larson's request was approved and a judge required that Dadigan turn over an inventory of the missing items. A hearing on that portion of the case is also set for November 28.

Where the story really gets ugly is the dispute over the last few hours of Seabury's life. According to Braunstein, when she was taken to the hospital, Seabury told Dadigan that she had been lying on the floor for several hours before Hernandez found her. Speaking on behalf of Hernandez, Larson said that she had been instructed by Dadigan to call her instead of 911 if anything happened, so when she fell, she first contacted Dadigan instead of the paramedics. Seabury also had hired caregivers who were present at the time.

Although not related to Iturbi or Seabury, Dadigan was their goddaughter and was appointed as a trustee in December 2005. Larson said he has concentrated his case around Dadigan because she is also the current head of the Iturbi Foundation.

Braunstein, who knew Seabury for most of her life, said that she was as passionate about classical music as Iturbi and had specifically appointed the three trustees to the foundation to carry out her wishes.

"She wanted the Jose Iturbi Foundation to be a real mover [in the classical music community]," Braunstein said.

The foundation currently sponsors six concert series in Cerritos, and according to Braunstein, they are in talks regarding making major donations to a California University.

ETHICS UPDATE

Still No Vote From City Council on the Increasingly Controversial Ethics Ordinance.

Call it Ethics, call it Revolving Door, even call it the Barry Brucker Ordinance. No matter what name it has, the City Council still has made no set decision on the Ethics Ordinance, mostly arguing over the wording and the proposal to add an extra year to council that councilmembers would have to abstain from lobbying or representing issues they have voted on.

On Tuesday night, the council went past midnight discussing the proposed amendments to the ordinance and what that would mean to them, Planning Commissioners and other city employees once they leave office.

Mayor Steve Webb said that ultimately the ordinance will pass once the details and wording are worked out to what will be acceptable to the community. On Tuesday night though, Webb said a vote would have been superfluous and instead opted to send it back to the City Attorney for redrafting.

Although all council members were in agreement that a code of ethics is a good idea for the city, they were split 3-2 on an amendment that would increase the plan's requirement that City Council members wait one year after leaving office before they can lobby for or represent any issue that came before them while they were in City Council. Both Councilmembers Barry Brucker and Vice Mayor Jimmy Delshad strongly supported the amendment, but were opposed by Webb and Councilmembers Linda Briskman and Frank Fenton who all supported the proposal's current requirements.

Brucker, who introduced the ordinance earlier this year and has strongly supported lengthening the rule to two years, expressed his disappointment that the majority of the council opposed it. Brucker pointed out that

the proposed ordinance as it applies to city council members is really no different than the state's current requirements.

"We're refusing to go beyond the state minimum requirements. It's a lot of noise and hot air for not changing it for city council members," Brucker said. "We felt it's more a matter of sending a message to the community that we as council members do not seek office for any financial gain upon leaving office."

Another change is that Planning Commissioners will now fall under the one year rule as well, where they have previously been at two.

Instead of supporting the increase to two years, Webb suggested putting into the ordinance a clause that would require councilmembers to wait three years from the time an issue was presented before them until they could support it.

This provided another reason for the ordinance to be reworded as it caused confusion of which issues that come before the city would be applicable. Both Delshad and Briskman expressed strong concern that the ordinance's current wording would technically cover every issue that is presented to the city while they are in office. Most of which will never even come before the council. Brucker was in agreement about the need for clarification.

"There's so many things that come before the city that don't come before the city council, how could we know them all?" Brucker said. "We would be accused of violating this prohibition everyday without even knowing."

Webb clarified that this would only be for issues that came before the council, and not just the city.

One thing that all councilmembers did

seem to agree on though is that they aren't in it for the money.

"I really believe that we serve the city because we want to," Delshad said.

When Webb said that "nobody in their right mind" would sit on City Council for several years and take an overall pay cut due to the hours they put into it just for the possibility of making money down the road lobbying, it elicited a strong response from the small crowd still left.

"I would be glad to show the doubters and the people laughing in this room my time sheets over the past year," Webb responded. "Nobody does this for the money."

This concern is one of the reasons Brucker said he is so supportive of increasing the time limit.

"There's no downside to having a robust ethics ordinance," Brucker said. "It is good for the community, it builds trust and faith that elected officials are doing their job for the right reasons."

Many members of the audience were critical of the Council's decision to keep the one year rule.

"They wasted my time and everybody's in the audience," said attorney Larry Larson who also attended the meeting. "They're going to basically say we have to abide by State law. They didn't need to spend tens of thousands of dollars doing that."

Other audience member suggestions ranged from requesting councilmembers not to vote on projects that involved people they knew personally.

Webb pointed out that one of the problems with abstaining from voting on project where a councilmember might have a personal relationship with those presenting it is that most of the projects that come before

the council have people involved who are close to them.

"(If that happened) nobody could vote on anything," Webb said. "This is a small town."

One of the main reasons for this ordinance Brucker noted is that there are issues especially in Beverly Hills with the handling of lobbying once an official leaves office.

"The irony is that there are probably eight former city council members who were mayors who are land use lobbyists now," Brucker said.

Although former Mayor Mark Egerman's name was mentioned at the meeting, Brucker said that he could think of several other former mayors including Les Bronte, Tom Levyn and Allan Alexander who now regularly lobby before the council.

"These are all former elected officials who to some extent are now representing developers," Brucker said. "Some of these were doing so before they ran. This was their job. Some are doing so after they ran. Some were never even lawyers."

Brucker stressed that even though he has spearheaded this project, this is something that the community and not just he and the other councilmembers support.

"This is a community ordinance, not a Barry Brucker Ordinance. My goal is that we pass it and whoever wants to lay claim to it, go for it," Brucker said. "It's frustrating, but on a positive note, we did put in some ethics wording which I'm very pleased about," Brucker said.

The Council is scheduled to review this issue and vote on it at their next meeting on Oct. 3.

health entertainment, not health education. These learning systems approach the subject of physical activity and obesity at the core level which is not with the muscles or the heart or sweat. The core level is self esteem and self responsibility. HDI is experimenting with some cutting-edge methodology in helping moderate to high risk groups, change. We want to be able to get in the schools because the schools aren't able to do the jobs themselves or they would and they need help.

How does running a company compare to coaching?

All I do is coach. The truth is, when I left Beverly it wasn't football. But it's all about coaching. It's about helping people achieve their goals; helping them to break the task down into its parts and teaching those parts. Then allowing them to fail a few times and

then watch them make progress and when they get discouraged give them the positive feedback that they need. If they get a little bit lazy, then you start kicking them in the butt. But it's all about love. I mean I always knew that about coaching. I do miss coaching. Every once in a while I'll get into a situation where do a lot of consulting. For me it's like if I were a painter maybe or a sculptor doing a work of art. It's just so passionate. I'm tired of losing. I want to get this country back on its feet. This old coach is still plugging away. It's just a different game.

Tell us about your wife.

Today Carolyn is in Serbia on assignment with U.S. Customs & Border Protection. Last month she was in the jungles of the Peruvian Amazon and a couple of months before that in Kuwait and on the Iraqi border. Her job is to develop training programs and provide technical assistance to

our men and women on the ground in high risk drug intervention programs and anti-terrorism operations. Obviously I am very proud of her and her cohorts. When people find out what Carolyn does they frequently ask her how she became engaged in anti-terrorism training, she often responds "Living seven years with Dick Keelor." I'm sure any of my former Beverly High athletes will understand her meaning.

Do you miss California?

I miss Redondo. I'd go back to Beverly in a second and coach. I just thought that was the greatest place to be. I had the best of everything. I lived in Redondo and worked at Beverly. It's great back here. I love it. I hate the traffic but it's as bad as it is there as it is here. I miss the beach a lot and I miss my friends. I'm always interested in how Beverly is doing and when I talk to one of my former athletes out there I always ask them how they are doing. They always keep

me up to date on what's going on.

What advice would you give to a young coach who is just starting out in the profession?

First of all, I'd tell them they are really, really lucky to be in a position where you can really make a difference in a kid's life. You can make a huge difference. It's not about winning. It's about doing your best. It's about teamwork and the winning always takes care of itself. Coaching is fun if you don't take yourself too seriously. You've got to get serious for the game, but have fun, laugh, snap towels, goof around a little bit and love one another. There's no greater teacher than a coach. None.
