# **Beverly Hills Reacts to Tuesday's Election Results**

Local officials weigh in on passage of statewide bonds

# By Ryan Vaillancourt

With all five state bond measures passing yesterday, and Democrats taking a majority in the US House of Representatives, Beverly Hills looks poised to capture more funding for trans-

> portation schools.




Proposition which 1A, restricts state sales tax on gasoline for motor vehicles to transportation needs, passed with 76%

approval. Proposition 1B, which passed with approximately 61% approval, will allocate roughly \$19 billion dollars for statewide transportation needs.

Among future local projects that could

benefit from the transportation bonds is the proposed Westside subway extension.

"If we have any hope obtaining federal funds for a subway system to the Westside

through Democratic congress," Steve Webb said. "With the democrats hopefully in control of the senate and the house it will enhance the ability for us to obtain that funding."

Also passing was proposition 1D, which allocates \$10.4 billion to schools statewide. Of the five bond measures, 1D had the lowest support with 56% of the vote.

The measure is intended to provide relief to overcrowded public schools and improve earthquake safety. Bond funds will also go toward general facility improvements throughout the state.

absolutely Superintendent Kari McVeigh said. "1D is going to allow us to continue modernization efforts in a district that has five schools that are very old. We have plans already submitted to the state and we're hoping with this money that we'll be able to get some of those plans going."

Board of Education President Myra Lurie said Proposition 1D will help BHUSD to fund ongoing modernization efforts.

"Clearly, the public understands the need to provide updated, adequate, and safe school facilities in order to educate our children," Lurie said.

As of Wednesday morning, Democrats had captured a majority in the house, winning 34 seats. Nancy Pelosi (D-San Francisco) is expected to become the new Speaker of the House.

"I am excited about the possibility of Nancy Pelosi becoming the first woman Speaker of the House," Lurie said. "As a Californian, she understands the unique concerns and issues that our state faces in the area of education."

Having a more local effect might have been Proposition 90, which would have restricted the eminent domain powers of all state governments. Proposition 90 failed to pass with roughly 52% of voters voting against it.

Critics of Proposition 90, including City Manager Rod Wood, warned that the legislation would have effectively eliminating practical zoning restrictions and cost tax pavers excessively.

"The defeat of Proposition 90 takes away the threat of unrestricted building in our city," Mayor Webb said.

Democrat Debra Bowen defeated appointed Republican Secretary of State Bruce McPherson with nearly 59% of the





# BHHS Football Team To Play At Culver City Tonight

Winner will be crowned Ocean League champion.

The Beverly High football team bounced back quickly from being shut out for the first time since 1991 a week earlier by scoring 20 second-quarter points in a 20-7 victory over Inglewood Morningside Friday night at Nickoll Field, keeping alive its chances of successfully defending its Ocean League championship.

Dex Lucci, who had sprained the index finger on his right (throwing) on the third play of a 20-0 loss to Inglewood Oct. 27, threw 50- and 46-yard touchdown passes to Dominique Sandifer and Ramon Judkins, sandwiched around Gerald McGee's two-yard touchdown run as the Normans improved to 7-2, 3-1 in league play.

The Monarchs (5-4, 2-2) scored their lone touchdown on Travis Harvey's 36-yard pass to Shawnta Husband in the third quarter on what Beverly Hills coach Carter Paysinger described as a breakdown in its secondary.

"I thought we played well offensively in the first half," Paysinger said. "In the second half, they made an adjustment and started blitzing more. It took us a while to adjust to it, but we adjusted to it and we played very well in the fourth quarter."

The Norman defense "played well the entire game," Paysinger said, holding an opponent to eight points or less for the fourth time this sea-

Defensive lineman Danny Berkowitz, and linebackers Sae Bin Park, Michael Kerman and Benji Rosen drew praise for their play for Beverly Hills from Paysinger.

The Normans out-gained Morningside 393 vards to 319.

Judkins ran for 101 yards on 22 carries and caught two passes for 60 yards; McGee "played very well," running for 68 yards on 13 carries; Lucci "did a great job coming back from his injury," "threw the ball well and ran the team efficiently," completing seven of 13 passes for 156 yards; offensive lineman Mike Rostovtsev "did a real good job, particularly in the second half of recognizing and picking up their blitzes," and Sandifer "had a real big game for us," catching three passes for 87 yards and rushing for 68 on his only carry, Paysinger said.

The victory moved Beverly Hills up two places to seventh in the Southern Section Western Division poll released Monday.

#### What's Next

The Normans are scheduled to play at Culver City (8-1, 3-1) tonight at 7 p.m. in a game where the winner will capture the Ocean League championship.

The Centaurs rose two spots to fifth in the Western Division poll following their 68-6 victory over Hawthorne, which lost to Beverly Hills, 49-8, Oct. 13.

Culver City quarterback Darius Banks, a junior, leads the state in passing yards with 3,071, according to statistics complied by Maxpreps.com.

"Containing him is going to be tough because they throw to so many different receivers," Paysinger said. "All those receivers are real good. In some games, we try to take away the top players and the strengths of the opponents. In this case, there are so many of them, it will be difficult to try to stop them. You're going to be able to slow them down by taking away a couple of their options, but they seem to feel comfortable going to other options. We just have to try to figure out want they want to do most and take that away."

# What Does The Election Really Mean

Will The Real Arnold Now Step Forward? By Rudy Cole

California is truly the Great Exception that Carey Mc Williams described in his monumental study of our state's politics.

Here we are, a true blue state in the sea of red giving an overwhelming reelection vote to Republican **Arnold Schwarzenegger** while delivering an equally wide margin to Democratic senator, **Dianne Feinstein.** 

If Los Angeles County represented the majority, **Phil Angelides** would have been elected. So much for carrying your own hometown

What McWilliams wrote was that California has a political history unlike others because we never produced and lived through the political machines that dominated many states and most eastern metropolitan areas. Or put another way, our own **Will Rogers** once said "I do not belong to any organized political party, I'm a Democrat."

However our political parties are structured, it was the Democratic leadership of California that fostered the primary campaign of Angelides over state controller **Steve Westly.** 

Angelides had the backing of Feinstein, Sen. **Barbara Boxer** and most of the rest of the party's leadership, including most local activists.

It was, by any standards, a terrible campaign. True, the primary victory over Westly exhausted Angelides, was enormously costly and very divisive. They were not nice to each other and, in fact, Arnold managed to replay many of Westly's worst attacks on Angelides. Hard to survive that kind of primary for a final election win

Angelides, a really nice guy with a good record as state treasurer, missed the most important issue of the election until the very end: The voter rejection of the governor's state ballot measures. Here was a newly elected governor trying to demolish the traditional balance of power in state government by very radical proposals that managed to alienate nurses, law enforcement, fire fighters and the education community. His il1

ratings were lower than **George W. Bush's.** True, the governor handled his debacle very

well. He moved quickly to patch up differences with the Democratic controlled legislature, explained that he knew the people wanted a more collegial state leadership and made any number of comprises that produced a state budget without all the turmoil of the past. He reinvented himself as a moderate, and it worked

What Angelides had a right to ask is which governor would we have after the election. And, what Democratic leaders need to explain was how they hoped to win with Angelides. Was he really the best the Democrats could produce?

Nationally, the campaign was not just about the war although the Bush administration's handling of the occupation was an important factor. The scandals involving House members and the rush of sexual misconduct turned off much of the Republican base and voters simply tired of being pushed by social issues such as gay marriages and gun control. Even though gay marriage bans won in some states, Democrats still ran ahead in some of the districts that voted their "family values" issues.

What historians and social psychologists will study and explain in years ahead is the incredible link among gay bashers and hidden gay predators. How much impact on the election was the disclosure that a fundamentalist, antigay church leader was supposedly having sex with a male prostitute. Could make even far right types wonder.

Back in California, the GOP must also view Arnold's big win with some displeasure. The coat tails did not bring into office many other Republicans, certainly not the most conservative such as **Tom McClintock**, the nominee for Lt. Governor. Arnold hardly spent many political chips for McClintock or the rest of the slate. The Republicans who won at the state level did so on their own. The secretary of state had good marks for improving the state's voting procedures and **Cruz Bustamante's** lame effort to win votes because he had lost weight did not overcome the attacks on his campaign funding.

It also didn't help Bustamante's try to move from Lt. Governor to Insurance Commissioner when he took one of the early daggers thrust at **Gray Davis** in the recall election.

Interesting, how difficult it was to pass education bond measures both locally and in the state. Probably the answer lies, in part, to the decline in parents with school age children who actually vote. Our aging population impacts support for schools in the state and it also effects support in our own community.

It will be interesting to study the absentee vote on the oil measure. Bill Clinton put much of his prestige on the line for Prop. 87, but it was late in the election. Did the absentees provide the largest plurality of votes? Voters were obviously fearful of higher gas prices.



# COVERSTORY SUBWAY UPDATE: CAN YOU DIG IT?

# Plans for a subway through Beverly Hills move forward.

The Beverly Hills Mass Transit Committee is inching its way toward a recommendation to the City Council regarding a subway in Beverly Hills.

Though a final recommendation is not slated until January 9th, the committee announced on Thursday at a Town Hall meeting that it has decided on a specific route alignment for the proposed subway and determined two ideal station locations.

The "subway to the sea," if it does get built, will be an extension of the existing Metro Red Line subway which currently runs along Wilshire Boulevard between Union Station in downtown Los Angeles and Western Avenue. The red line also branches northeast from Vermont Avenue to North Hollywood.

"The reality is that there's a very extensive rapid transit rail system that already exists in Los Angeles and what we're talking about is a way to extend it in a way that will serve the city of Beverly Hills," transit and planning consultant Dick Kaku said. Kaku is a transit expert and has been hired by the city to advise the transit committee on technical issues.

One of two potential alignments considered by Kaku and the mass transit committee was along Santa Monica Boulevard. The other was along Wilshire Blvd.

The Santa Monica Boulevard alignment would have started at the Red Line station at Hollywood and Highland and continued on to Century City. The other alignment, along Wilshire Boulevard, was considered more ideal because it is denser in population and employment.


"What we discovered was Santa Monica Boulevard, as busy as it is, through that portion of Santa Monica from West Hollywood through the city of Beverly Hills to Century City, until it gets to Century City, doesn't have the density of development that we're looking for," Kaku said.

The committee also considered extending the existing red line from Western only to San Vincente Boulevard and then going around the Beverly Hills triangle via San Vincente and Santa Monica Boulevards. Another route would have taken San Vincente only as far north as Beverly Boulevard, and cut west along Beverly Boulevard to Santa Monica Boulevard. These alignments however, all fell short of the criteria used by Kaku and the committee for choosing an ideal route.

Besides employment and population density, Kaku looked into the availability of stations along each potential route that could be approximately one mile apart, and within walking distance to as many riders as possi-

ble. Also considered was the existing transit activity on the proposed routes. Based on these criteria it was determined that an alignment along Wilshire Boulevard, with stops at La Cienega and Beverly Drive would be ideal.

"The entire Wilshire Boulevard alignment all the way from Wilshire and Western, all the way through Beverly Hills does contain relatively high density development, relatively high public transit usage, [and] lots of public transit service," Kaku said.

Dan Walsh, CEO of the Beverly Hills Chamber of Commerce, said the Chamber is very attracted to the notion of a subway station at Beverly Drive.

"The Wilshire and Beverly station would deliver visitors as well as employees and workers to essentially the heart of the city," Walsh said. "It's very close to the shopping center that is currently world-renowned in the triangle, the emerging growth of a fabulous restaurant street of Canon, and then South Beverly, which is emerging as our newest gem in terms of its shopping appeal, so it's just ideal."

Some community members, however, are not convinced that a subway anywhere in Beverly Hills is a good idea.

A subway along Wilshire Boulevard would run along the northern border of a significant residential neighborhood, represented by the Beverly Hills Southwest Homeowners Association. President Ken Goldman said the group has not reached an official position on the subway, but he expects that safety and security to be concerns among members.

"Right now the crime rate in Los Angeles on the Metro is very very low because security and security staff are very well funded," Goldman, who is also on the mass transit committee, said. "One concern is what if the funding is greatly reduced in the future?"

Goldman also addressed the concern that construction of the subway stations could suspend business activity in nearby areas.

"[The MTA] tells us that the intersections at those two locations [at Beverly/Rodeo Drive and La Cienega] would not be closed during the week and would be under construction for 8 to 10 weekends, so that should minimize the inconvenience and loss of business," Goldman said.

Other concerns include the feasibility of tunneling underground through Beverly Hills and especially the mid-Wilshire region to the east. In 1985 there was an explosion in the basement of a Ross Dress For Less store due to underground pockets of methane gas. Representative Henry Waxman (D-Los Angeles), whose district includes Beverly Hills, orchestrated a federal ban on future tunneling in the Fairfax area.

The tunneling ban may soon be lifted though. After the release of a 2005 study by the American Publican Transportation Authority, which found that the risk in tunneling along Wilshire "would be no greater than other subway systems in the US," Waxman introduced legislation to repeal the ban. The bill was passed by the House but waits to be heard by the Senate.

With the ban removal at least under way and with strong support for the Westside subway extension from Los Angeles Mayor Antonio Villaraigosa, who also chairs the Los Angeles County MTA Board of Directors, a subway in Beverly Hills looks likely. It's just not clear when.

"We're talking anywhere from 10 to 20 years before it would be in place," Alexander said. "It's so hard to predict."

But even if shovels don't break ground for twenty years, it is essential that the City of Beverly Hills starts planning now, Mayor Steve Webb said.

"In order for us to effectively lobby the federal, the state and the local government, the city needs to take a formal position on this matter," Webb said. "Because this is something that's happening today in other communities we need to be out in front."

Once the mass transit committee, which was appointed by Webb in April of 2006, makes its final recommendation, the city will start to lobby for route alignments and ideal station locations. Other communities are likely to lobby for different alignments.

"I fervently believe that we need a subway system that goes from downtown to the Westside," Webb said. "Where the alignment is and where the stations are is not my primary concern; my primary concern is for the city to take an official position so we can get out there and make sure that when money is allocated, money is allocated for the Westside."


