

Candidates File Initial Campaign Spending Reports

Delshad and Webb top the list of contributions received; Krasne raises most among challengers

Vice Mayor Jimmy Delshad has raised the most money among the six candidates in the March 6 City Council election, narrowly leading Mayor Steve Webb, according to reports filed last week with the City Clerk's Office.

Delshad received \$50,763 in contributions through Jan. 25, all but \$1,865 being raised between July 1 and Dec. 31. Webb was next with \$46,818, including \$2,276 since January 1.

Nancy Krasne topped the four challengers in contributions received with \$27,193. Fellow planning commissioner Shahram Melamed raised \$8,089, followed by Maggie Soleimani with \$3,104. Lizza Monet Morales did not report any contributions.

The reports show that Krasne - who in addition to her individual contributions has loaned her own committee \$28,000 - has outspent the other candidates, reporting \$32,489.80 in total expenditures. Delshad loaned his own committee \$30,000 and has spent \$28,635.35; Webb has spent \$23,418 and reported no loans; Melamed loaned his committee \$20,000 and has spent \$20,701; Soleimani loaned her committee \$10,000 and has spent

The first report, which was required to be filed Jan. 25, covers the period Jan. 1-25. Semi-annual expenditure reports, which were due on Tuesday and cover all of 2006, were also submitted.

"All candidates submitted both reports on time or early," City Clerk Byron Pope said.

All six candidates accepted the voluntary

campaign expenditure limit, increased by the council to \$60,000 in a vote last year, which limits contributions to no more than \$250 per individual or \$500 per married couple.

Delshad's contributors include a host of former and current elected officials: He received \$250 donations from former mayors Allan Alexander, Les Bronte and Max Salter and city & schools cont. on page 4

The City of Beverly Hills announces the availability of its draft "Statement of Community Development Objectives and Projected Use of Funds" for review in connection with the City's annual application to Los Angeles County for federal Community Development Block Grant (CDBG) funds.

CDBG funds must be used for activities considered to primarily benefit persons of low and moderate income. The City's allocation of 2007-2008 CDBG funds from the County is expected to be \$267,804. The City Council will review the application at the regular February 6, 2007, City Council meeting.

It is proposed that the 2007-2008 CDBG funding continue to support the City's ongoing programs in approximately the same amounts as the current 2006-2008 year. The proposed funding for 2007-2008 is as follows: Handyworker Services (\$190,000), public service programs for senior citizens (\$40,167), partial funding of planning activities and program management (\$26,780), and a contingency (\$10,857).

The City is further expected to fund at least one new program this year using CDBG funds from previous years. Any new programs will be reviewed at a future City Council meeting.

Manslaughter, DUI Charges Sought in Garrison Fatal Accident

Lane Garrison, the actor behind the wheel of the Dec. 2 crash that killed Beverly High student Vahagn Setian, had a blood alcohol level twice the legal limit and was under the influence of cocaine on the night of the incident, according to an investigation by the Beverly Hills Police Department.

The investigation revealed that Garrison was allegedly driving between 47 and 51 mph and no mechanical problems were detected in the vehicle, Beverly Hills Police Chief Dave Snowden said.

According to a BHPD press release, Beverly Hills traffic investigators presented the collision investigation to the Los Angeles County District Attorney's Office and recommended that Garrison be charged with Gross Vehicular Manslaughter "with an enhancement for causing bodily injury or death to more than one victim," Driving Under the Influence of alcohol and drugs and contributing to the delinquency of a minor.

If convicted, Garrison could face up to ten years in prison, Snowden said.

Delshad notched contributions from former Board of Education members Ernestch, Art Malin, Virginia Maas, Lillian Raffel, and Betty Wilson. And fellow councilmember and former Board of Education member Barry Brucker and wife Sue contributed \$250 each.

Bronte and Salter also contributed to

Webb's campaign, as did Maas, Raffel, and Wilson. Fellow councilmember Frank Fenton and Judie Fenton contributed to Webb. Judie Fenton also donated to Delshad.

Webb refunded four contributions from real-estate developers Craig Wald, Lance Walter, Alan Goodman and Maynard Brittan.

"I discovered after I had received the contributions that these were partners in a devel-

opment project that had come before the city that I voted on and I didn't know who they were," Webb said. "When I found out that they were partners I immediately refunded the money."

Also reporting a contribution from a recently active developer in the city was Melamed, who received \$250 from George Kobar. As a planning commissioner, Melamed voted in favor of Kobar's Wilshire Boulevard and Robertson Boulevard project last year.

Despite having personally signed the Campaign Statement Cover Page, Melamed said that his treasurer had handled the expenditure report and that as of Wednesday afternoon he was not personally aware of the Kobar contribution.

"Might it have the appearance of favoritism, exactly because of that we will refund the check," Melamed said. "It's not that anything is wrong, it's the appearance."

As incumbents, Delshad and Webb have maintained their election committees since being elected in 2003, giving them a predictable head-start in front of this year's four challengers.

"The core of my supporters are friends that I've had relationships with over a long period of time," Webb said. "I have people that have been close friends of mine that don't even live in the city that have sent me money."

Lasting community ties and name recognition, which increases while in office, tends to favor any incumbent in small city elections.

Dlshad, who defeated former Mayor MeraLee Goldman in 2003, said it was difficult to raise funds as a challenger because he had no track record at City Hall. Now, as an incumbent candidate, Delshad has out-raised the competition.

"It is easier to raise funds as an incumbent, but only if you've done your job," he said

But to some residents, the track records of both incumbents are poor.

The Beverly Hills North Homeowners' Association has asserted itself as the most vocal anti-incumbent group in Beverly Hills

and their dual endorsement of challengers Nancy Krasne and Maggie Soleimani proposes to "change the culture at City Hall."

"The incumbents, Webb and Delshad, must go," the group said in their official statement of endorsement. But with a membership of about 500 in a city where turnout has recently numbered around 5,200, the BHNHA cannot elect a challenger on their own.

"The anti-incumbent bloc is always there," said political consultant and Beverly Hills resident Harvey Englander. "The question is: does it cross over to people who haven't made a decision?"

Krasne's landed contributions from various BHNHA members – including Victor Bardack, Betty Harris and Larry Larson – and she is also the only candidate to get a contribution from Anthony Shipp, who owns the North Foothill Drive property that has been threatened by eminent domain. But her long list of contributors indicates a diverse support

According to Englander, Krasne's fundraising, "certainly shows that she is not afraid to ask people for money and that she's got a level of sophisticated support in this city."

"Certainly, it puts her lightning paces ahead of the other challengers," he said.

The bulk of expenditures for all candidates thus far has been in campaign materials, mailers and printed advertisements.

As of the reporting deadline, Melamed spent the most in advertising, reporting \$16,940 spent with Beverly Hills Courier and \$0 with Beverly Hills Weekly. Krasne reported \$5,000 spent at the Weekly, \$7,360 at the Courier and \$3,500 at the Westside Chronicle; Soleimani reported \$1,800 spent at the Weekly and \$3,280 at the Courier; Webb reported \$1,600 spent at the Weekly and \$2,800 spent at the Courier; and Delshad reported \$3,200 spent at the Weekly and \$0 at the Courier.

The next campaign expenditure reports are due to the City Clerk on February 22 and cover the period between January 21 and February 17.

For City Clerk Byron Pope, the city clerk's job is all about the details



Clerk Byron Pope. Between planning for regular scheduled city council meetings and

City Clerk Byron Pope preparing for the March 6 election, Pope took some time to explain his day to day duties and how the first election of his tenure is starting to take shape in this exclusive interview with the Weekly.

When former city clerk Nina Webster left the position over a year ago, you became the acting city clerk before ascending to the official position. Where did you work previously?

Previous to the city clerks office I was in the public works department here in the city. I was the commercial services manager, which was in charge of the commercial refuse.

With the city council When I first joined the city in 2000, we had many accounts in the city, they could choose any vendor they wanted to to pick up their commercial trash and recycling. When I came on board I did the RFP to hire one exclusive contractor to do the entire commercial area. That was American Waste

What led you to the City Clerk's office?

It's probably my management skills and wanting to utilize them more for the city. I came from a background with my church, from being the church administrator, [and] at Warner Brothers being in charge of commercial services for the studio lot. So I had more to offer than what that [previous] opportunity

What does the City Clerk's job entail on a day to day basis?

Lots of detail and that's another one of my strong points. I'm a stickler, meticulous. Not only do I try to do it in attire, but also ethics in life, [and my] home is immaculate. Dotting

i's crossing t's, that's just what I like to do so there's a lot of that in my day. The first half hour of my day is loading up 30 to 50 e-mails and responding to different requests for resolutions, ordinances, research questions, [and] staff members' or members of the public asking questions about some history or city council actions. Then I go into follow up work or preparations for the next city council meeting, which includes the agenda packets, the synopsis, the minutes, the follow ups.

The upcoming election means a busier schedule for you; what are you doing in the name of preparation for the election?

My schedule changed last summer when the election season actually started. We had to get our prep work in place before the nomination period started in November. So it entailed going to the seminar for my election supplier, to hiring [an] election consultant, to going over how we have done the elections in the past just so I knew what to expect this year and getting everything in place for the nomination with the candidates that filed. We have a timeline of events that all city clerks have to file according to the election schedule. Every day there is something due. There's "e" minus 122 [days], we have something to do, e minus 99 there's something to do.

Roughly half of Beverly Hills voters do so by way of absentee ballot. Take us through the process that begins when someone submits an absentee ballot request form.

First it's very important top know that people that are registered with LA County as a permanent absentee ballot voter don't even need to fill out an absentee request. They're automatically in every city's system, so if you're a permanent absentee voter, for every election, you're automatically going to receive a ballot. That's caused some confusion in the past because they know they're a permanent absentee voter but then they get campaign materials from candidates with an absentee application, then our sample ballot shows up with an absentee application and sometimes they send them in anyway. We have about 2800 voters in Beverly Hills that are [permanent] absentee voters. When [permanent absentee voters] send in a request form for an absentee ballot, we send them what we call a snag letter letting them know that they are a permanent absentee voter. For non-permanent absentee voters, when they submit an absentee ballot request form, we keep the requests in an alphabetical file and until the absentee period starts on February 5, that's all we do. Once the absentee period starts, we update what we call the 54 day file from the county, which is a list of all voters eligible to vote in our city 54 days prior to the election. We scan in by the bar code the voters, each one that's requested one, and we mail them out starting on February 5.

How many absentee ballot requests have been submitted so far?

Probably about 250 to 300.

How does that compare with previous elec-

Inside Some Campaigns

Outside the box thoughts By Rudy Cole

How much is your vote worth? In terms of dollars, not very much. Before the current city council election has come to an end the candidates will have spent about fifteen dollars per voter.

Are they skinflints, these six who hope to earn their \$654.84 per month salary and such benefits as attending every possible brist and Starbucks opening, and if that conjunction doesn't cure your coffee addiction, nothing can? No, they are or are supposed to follow the rules limiting total expenses to \$60,000 per candidate.

With the advent of campaign spending limits, something the United States Supreme Court once ruled illegal in national elections citing a limitation of freedom of speech, but still enforceable in state and municipal campaigns, the numbers of actual voters has declined. One way to view that, of course, is that with campaign reforms come less democracy.

Two years ago, with some very deep

pockets on both sides of the issue, the hotel referendum posted an historic \$600.00 per elector.

Considering the actual numbers of people who vote, this campaign spending is not a model of marketing success. It has been many decades since even half of the registered voters of Beverly Hills made the effort to either mail in their ballot or march to the polls. (In Beverly Hills approximately 2,700 are permanent absentee voters.) How many people around the world would love an opportunity to vote in such exotic venues as the Beverly Hills Hotel?

In 35 days we will choose our city fathers and mothers. Even that designation for local elected officials has some deeper meaning. We never call our congressmen or senators national mothers and fathers, although a part of that designation is sometimes used. We look to our local officials to provide us with safety and comfort and, even yet, we are far more

likely to spend voting energy on national and state elections even in Beverly Hills.

The likely number of voters is about 5,000 to 6,000 or less than 30 percent of those eligible. One possible answer for the minority of population vote is that residents really aren't very concerned. No matter who is elected, the mechanics of government will continue providing first rate city services under the guidance of the professional staff.

The validity of the "government will go on much the same no matter who we elect" theory, is clearly not true this year. Why? Because for the first time in this generation, the city council will adopt a new general plan and that will impact our quality of life for another 30 years.

Changes in height limits, new uses in the Industrial Area and, incidentally, that misnomer could soon change, and much more are all on the agenda for soon to be elected councilmembers. It has been many years since any real industry loaded freight trains in the section of Beverly Hills east of city hall and south of Santa Monica Boulevard still called the Industrial Area, now home to new apartment buildings, some condos, city facilities and a growing number of entertainment industry enterprises. Oh yes, a vet office and hospital and the Amanda Foundation. It will fasci-

nate future urbanists to discover that we had a hospital for animals, but none for humans.

In any case, the next council will decide, unless it goes to a referendum or initiative, how we view future growth and development. Some change is inevitable. There are deteriorating, neglected areas, yes, right here in the hub of high property values and historic demand for space. There will be development, but what kind, how high the structures and how much density will all be decided by a block by block determination incorporated in the next general plan.


This council also has other big decisions on the agenda plate. Installing improved technology for our police and fire services, necessity of a sports center, widening of Santa Monica Boulevard, repairs of streets and alleys, improvements in utility services ranging from cable television to electricity and water and responding to a very public demand for stronger ethics ordinances. And, oh yes, there is that hole in the ground some zealots want to dig under Wilshire Boulevard in attempt to reduce surface traffic, which, of course, is a continuing elephant size issue in every election.

It is a required slogan for all candidates since **Will Rogers** had an honorary civic tile, honorary mayor, to proclaim that we must preserve the residential quality of life in Beverly Hills. Of course, we must and in most of the residential land, nothing could be done to provide change. What that should really mean is limiting growth



too close to residential or change that has little benefit and only increases existing environmental problems. It is also obvious that our grid lock issues are not just local, but regional.

It is also axiomatic for challengers to be more anti-growth than incumbents, and even those worthies would seldom hold you by the ears and proclaim a wish to build high rises on every city lot. They know, given a choice, that most residents would deny Mrs. Shapiro the right to add a new shower in the master bedroom.

Knowing all this, why such ennui? Maybe it's the candidates that create disinterest. This entry of six does not lack diversity of choices. Five are well funded, have very viable campaigns and supportive backers, including their families. The sixth, **Lizza Monet Morales**, needs some separation from the others. She has raised no money and spent zero. She said, at one forum, "I don't have the deep pockets like the rest of you," and that should never preclude candidacy. But it also indicates a certain lack of support. No friends willing to contribute? No fund raisers to pay for some mailings?

At least for this filing period, zilch. Monet Morales is attractive and very articulate and comes across well in the forums, however it is our sad duty, after listening carefully to her words, that almost half of her opinions are unrelated to the issues being discussed. She needs to do some homework, but the other candidates could learn much from her performances. Unfortunately for Monet Morales, this was

not a casting call. O.K, one foot note, on a few issues she really understood, she was good and said the right words.

Now, about the five that have paid their dues and their printers. These are not world class thespians. If performance alone counted, none would win, with the possible exception of **Nancy Krasne** who is just loose enough and candid as to come out ahead in the two forums I monitored. Nancy has some impressive credentials too. She has served on two commissions and is never loathe to express her opinions.

Shahram Melamed also has two commissions on his resume, but sometimes appears not to fathom the process of which he is very much a part. What he has going for him is a very loyal family with an impressive record of community service. An example of his lack of experience, surprising considering his service on commissions, was a comment at the press forum in response to a renter issue, one governed by state law. Melamed argued that we did not need to follow state law. "Since when do we do that?" he said. Well, actually, always. We are a general law city and we are very restricted by state law. As an example, I wish we could, as a city, permit pipe smoking anywhere and everywhere, but state law makes that impossible. We are preempted, as the lawyers would say.

Jimmy Delshad and Steve Webb are not running as a team and they have some serious differences both in style and substance. However, they are very unlikely to again air any disputes as they did when Delshad was credited with suggesting Rodeo Drive be closed to automobiles and Webb lost it. But they are apart on many issues and maybe of those could emerge. We writers love controversy, of course.

They are also different in interests and abilities. Webb is the pragmatist who understands government mechanics as well as anyone and is a fairly good communicator even though his press forum was stiff and rushed. Delshad is weak on civics, strong on technology. He has very good people skills, handles himself very well in public and is the hardest campaigner in the election. Even though he is presenting a somewhat changed view on issues, not unusual for candidates, he and Webb have almost identical votes on development proposals, a history that has led to opposition from the more militant anti-growth groups.

Conventional wisdom; Incumbents have the best chance of winning, but there is considerable discontent out there and, again depending on the size of the vote, this could be a year of surprises.

So, speaking of surprises, we have one. Maggie Soleimani. She didn't exactly come out of nowhere – her resume is an impressive list of civic involvements, but she was a relative unknown outside education, a host of charities and among the soccer moms. She is not a spell binder, but there is something about her sincerity that is coming across. A lawyer, she scored some big points when she said she would never return to the council after leaving office to represent any developers.

Soleimani and Krasne have the strong

support of the Beverly Hills North Homeowners' Association, much to the surprise of Melamed who lobbied hard for their backing and who, for his efforts, was treated very poorly at their forum.

It is never surprising to see incumbents with the longest list of insider endorsements, it goes with the office. But here to, there are changes. Krasne has snared many of the usual opponents of the council, but also some well known more neutral activists. Soleimani, with Krasne, has the largest homeowner group, and with Delshad, has garnered the backing of the city's renter organization, CTR. Soleimani and Krasne won the support of the National Women's Political Caucus.

Actually, we should be grateful that in this era of distrust of anything political, six people are even willing to serve. Although personally I like both Steve and Jimmy, this may not be the year of the incumbent.

Side note: If you want to win the hearts of the voters, go green. Although every other proposed development has issues with these candidates, not one has voiced opposition to 9900 Wilshire (Robinsons-May.)

Most important observation of the year: GO BEARS.

enormous density and height. Preservation of our City's Industrial Area for Municipal Services

(that area directly south of Santa Monica Blvd., east of Foothill, and between Alden and Third Street)

As part of the excessive development scheme in play by our incumbent council members, Webb and Delshad, it is City Hall's intention to commercially develop our City's Industrial Area in joint ventures with private developers. In two previous elections, in 1979 and 1980, the residents of our City voted and made clear their mandate that the Industrial Area must be retained for the development and maintenance of municipal services only, e.g., a waste water treatment facility that would not only conserve our water supply but also reduce its cost to us.

Let's not forget that Steve Webb and Jim Delshad endorsed a 26% rate hike in our water bill over a nine month period just last year without any requirement to do so by the Metropolitan Water District and without providing a public forum for residents to debate the rate increase.

Presently, in the Industrial Area, Councilmembers Webb and Delshad have started the process for the development of a mega sports facility estimated by Steve Webb to cost somewhere between 60 million and 80 million dollars! The development provides for condos/commercial development with a cut-through street onto Santa Monica Blvd. To jump start its plan, City Hall is utilizing its powers of Eminent Domain to acquire the property presently occupied by the Amanda Foundation. The cut-through street from the Industrial Area onto the south side of Santa Monica Blvd. in conjunction with the encroachment into the Beverly Gardens Park, to widen Santa Monica Blvd., will increase traffic not only on Santa Monica Blvd. but also onto the residential streets in and around the 500 blocks of our City.

Beverly Gardens Park Encroachment

On December 19, 2006, Steve Webb and Jim Delshad, along with their council colleagues, voted for a Council resolution (item eight on the Council Agenda) approving Memorandum of Understanding between the City of Beverly Hills and the Los Angeles County Metropolitan Transportation Authority for funding the <u>design and construction</u> for the widening of North Santa Monica Blvd. between Doheny Drive and Wilshire Blvd. As part of this agreement, our City plans to expend \$941,000 in order to receive \$1,751,000 from L.A. County Metro Transportation Authority for the design and construction of the Santa Monica Blvd. widening. Significantly, both Steve Webb and Jim Delshad approved this resolution without directly notifying the residents living in the 500 blocks adjacent to the parkland. That type of dismissive disregard of our residents by not dealing directly with them and on their behalf, sadly characterizes the misbegotten efforts of the two incumbents, Webb and Delshad.

the Montage referendum issue on the ballot so that was a unique situation, this is more of a normal election of just city council candidates. This is a two seat election versus a three seat election, which will be in 2009. So with two seats, this is pretty normal for a two seat election for this time. As opposed to last time with the Montage referendum item and three city council seats, we had probably twice the number of absentee requests at that time than we have now.

When is the last day that voters can request an absentee ballot and when is the deadline for registering?

The absentee period is from February 5 and 27, so up through the 27th. The deadline for registering to vote is February 19, which is 15 days before the election.

The city considered using a touch-screen voting system for this year's election. Why isn't this technology being used?

The touch screen voting would have been out of my control. It would have been under the guidance to run the machines of [Los Angeles County Registrar-Recorder] Connie McCormack who's the registrar recorder county clerk. That would have been out of my control, so I didn't want any part of this election out of my control. I wanted to be able to control and oversee and insure the entire election process this time. The county even offered to support it and to totally run it for me, but then again, I can't control that.

Will the ballots be printed in Farsi?

The main ballot is English and Farsi and the additional one we do is in English and Spanish, which voters have to request. We normally get about 100 requests for Spanish

Who translates the ballots?

We submit the English version to our election supplier. They have court certified translators, a company called CTS. They do the official translation of our English version. We do proofs of it on staff and with the candidates for their candidate statements. They get to review their own candidate statements, we do the rest of the ballot. We send back and changes or suggestions to them. The only stipulation is if we have changes to their translations, we must support that with court certified verification that these are correctable changes or they won't even consider them.

Sometimes, voters make errors when filling out a ballot and their ballot is thrown out. What kinds of errors automatically disqualify a ballot?

First of all, if a voter knowingly makes a mistake on their ballot, they can send it in and we can spoil it and issue them a new ballot so that they can mark it correctly. unknowingly make a mistake, there's nothing they can do about it, it disqualifies itself. For instance, there are two seats open on the ballot and if they circle in all the bubbles, that ballot automatically gets disqualified. If they

circle in more than two, there's no way for the machine or our staff to know which two bubbles they filled in first.

How many absentee ballots on average get disqualified?

It's typically very few. We err on the side of the voter as much as we can.

What is the unacceptable margin of difference between someone's signature on record and the one on the ballot?

It has to be really, really different. We give the voter the benefit of the doubt.

When a person's ballot is disqualified, are they notified that their vote was not tallied?

No, but all absent voters have the right to call [the city clerk's office] to find out if their vote was tabulated after the election.

What are some of the lessons you learned from the past election that you expect to help make this election go smoothly?

We have our debriefing notes from the last election, so we've done our best to ensure that all of the things mentioned in that debriefing are in place for this election. For example, we've had an issue with our ballot counter [machine] for the last two elections, so when it came time to count the ballots there was a problem with the machine and it was the way the ballots were lining up. So, we've made contact with our election supplier to make sure that they send us a good working ballot counter and also to have a warm spare in the

car in case there's anything wrong [with the first one]. We do the accuracy test the afternoon before the election where we test a set of ballots to make sure it's working properly. We'll probably do more than one accuracy test this year.


How did those past problems complicate the process?

They were just very nerve-racking because it delayed us getting the results. When everything else was ready, the ballot counter wasn't ready, so it just made for a very nerve racking evening, not only for us but for the candidates and their committees and the community as a

What do you foresee will be the biggest challenge leading up to March 6?

The biggest challenge is educating our foreign American voters on the American voting process. They come from other countries where voting was done differently. They have a different concept of how voting happens, so it's a constant education. We cant segment one population, we have do do a general outreach with our education. We cant reach out to one population because it looks like we're favoring them. Every person has to be registered to vote; if the head of the household is registered, it doesn't mean the whole house is registered. We've had those kinds of questions in the past.
