

Translated Sample Ballots Spark Community Backlash

Some residents say they are alarmed by the use of English, Farsi and Spanish in this year's election materials.

The City Clerk's office was clogged with complaint calls last week after residents got their first look at this year's sample ballot.

The callers, City Clerk Byron Pope said, were alarmed by the inclusion of Farsi translations throughout this year's election materials.

As of Monday afternoon, 300 complaints had been fielded and more calls likely never got past a busy signal, Pope said.

"We are taking the phone calls the best we can, but it is slowing down our process of getting the absentee ballots out," Pope said.

This is not the first year that the sample ballot has included Farsi. With urging from the human relations commission in 2004, the city council directed former City Clerk Nina Webster to include Farsi in the ballot for the 2005 election.

So in 2005, the voting instructions, candidate bios and precinct information found inside the sample ballot were translated into Farsi and for the first time in city history, voters could obtain, upon request, a translated ballot card at the polls or by mail.

This year however, the sample ballot is translated entirely into Farsi, and on election-day, one universal ballot printed in English, Farsi and Spanish will be presented to all voters.

Because most voters were still presented with an English-only ballot in 2005 – as in every prior election in city history - the policy may have initially snuck beneath

David Reyes Senior Planner the radar of those who have voiced concern this year.

"The languages have all been combined on one ballot so there's no cause for discrepancy or concern of knowing whether the translations were correct, whether the names were correct, [or] how you know who's voting on what ballot. Everyone gets the exact same ballot and has the opportunity to vote on the same ballot on the same issues," Pope said.

Critics of the policy say that it is unnecessary and even offensive. Voters in this country, they say, should be required to cast their ballot in English.

"We got the ballot in the mail and there were all kinds of languages splattered all over the front page and I got offended by it, it's really inappropriate" said Pete Sayegh, a South Maple Drive resident.

Sayegh, a first generation Israeli immigrant himself, likens the multi-lingual ballot to multi-lingual materials issued by the Department of Motor Vehicles. "The street signs are all in English," Sayegh said. "I think by providing official government information with foreign languages, you are preventing assimilation."

Though some residents complained about the policy when it was first implemented in 2005, this year's reaction has been twice as strong, Pope said, and it has prompted an inquiry into the city's legal responsibilities to offer translated election materials at all.

Section 203 of the federal Voting Rights Act stipulates that a state or "political subdivision" must "provide language assistance to voters if more than 5 percent of the voting age citizens are members of a single-language minority group who do not speak or understand English adequately enough to participate in the electoral process."

The US Census does not identify Persians as a minority, so the exact number of Persians in Beverly Hills is uncertain, *city and schools cont. on page 5*

ing me to vote for Mr. Delshad. In addition Councilman Frank Fenton has endorsed both Webb and Delshad, and Brucker has endorsed Webb as well.

What troubles me is that these endorsements diminish to some extent the independence of the five council members, one from the other. Moreover, as is their obvious intent, they diminish chances of independent-thinking-non-incumbents, thus promulgating control over city management by the incumbents and their chosen successors whom they will endorse. In a similar vein, I was offended last year when the president of the school board approached me to introduce, and urge me to vote for, "her candidate" to serve with her following that school board election.

Long-time Beverly Hills residents will recall that prior to the mid-1980s no sitting councilman or school board member would publicly endorse a candidate for either body. The prevailing attitude was "you elected me as one of five, and I will do my utmost to deliberate independently and harmoniously with whomever you elect to the other seats in either body". I believe the city and school district were better served in that bygone era.

As individuals, I do not question the honesty or integrity of any of the five city council members, and I know that they may take differing positions (on rare occasions). I will not, however, by my vote, support their efforts to maintain ironclad control over the management and future of this city.

ries

For the Love of the Game Bruce & Toni Corwin

Sports and politics are similar in that they're both cyclical. Every year, college basketball enthusiasts hunker down for three plus weeks of March Madness. It's tough to predict the champions, but that's why we watch. Politics - very much a game itself - is the same. Every year, at every level, candidates strategize, garner fans and hope for a slam dunk. Win or lose, there is always something to talk about.

Jerry and Marilyn Phillips, the couple that introduced Bruce Corwin and Toni Cooper at a Los Angeles Blades hockey game, would have agreed.

For Bruce and Toni, both sports buffs and budding campaign activists of the same political persuasion, a chilly ice arena should have been the ideal setting for a first date. Their shared excitement expressed with cheers and howls during the game would translate into excitement about each other. Between periods they would analyze the defense and make friendly bets about the outcome.

It couldn't have been any different.

Maybe it was butterflies, maybe not, but Bruce and Toni didn't share a word.

"I sat with Marilyn all night and we got home and I said 'That's it, I don't ever want to see him again," Toni said. "I spoke to her all night and Bruce spoke to Jerry all night and it was cold in there and I didn't like hockey, thank you very much."

Should have gone with basketball.

But a few months later, in the summer of 1963, Jerry and Marilyn tied the knot and Bruce and Toni would see each other again, this time in a warmer setting.

"They sat us at the same table," Toni said. Jerry and Marilyn wanted to match Bruce and

Toni and they were not giving up. This time, it wouldn't take much prodding to

get them talking. As Bruce recalls, Toni didn't necessarily have a choice.

"I took one look at her and said I'm taking her home." Bruce said.

On the dance floor, Bruce hogged the young, blonde beauty to himself all night and Toni met a new man.

"I had arranged to get a ride from someone else that night," Toni said. "But I went home with someone else."

It would be five years until Bruce and Toni would get married, with both dating other people in and around Beverly Hills along the way. What sealed the deal?

"Well, I just made up my mind one day that this is what I wanted, and my mother had definitely made up her mind, she was in love with Bruce," Toni said.

Ask Bruce and Toni what made them perfect for each other and they'll recite a laundry list of common interests, a shared affection for family is only one item.

"We both really enjoy sports, we both right now really enjoy travel, we're both incredibly nuts about politics," Toni says. "And dogs," Bruce interjects, "they sleep on our bed!"

"Well values are really important and if you see in your spouse the same kind of values that you have, it's something special," Bruce said.

Not many couples, sports nuts included, would be so compelled by a particular sports team to let it dictate their wedding date.

But in the months leading up to March 22, 1968, when Bruce and Toni were scheduled to wed, something was brewing in the air over UCLA. Toni's alma matter team had sustained a heartbreaking loss to Houston earlier that season, and to make matters worse, their star center Lou Alcindor (now remembered as the great Los Angeles Laker, Kareem Abdul Jabbar) got

poked in the eye and had to exit the game. Houston's upset victory snapped a 47-game winning streak for UCLA - and as the first primetime televised college basketball game in history - Bruin fans had nowhere to hide.

But UCLA battled its way through the rest of the reason, returning to form with Alcindor back on the court. Houston too kept winning and it the world of sports fans knew that there would be a rematch, in the NCAA championships, schedule for March 22, 1968.

"Can you imagine, everybody walking down the aisle with radio antennae sticking up and earplugs?" Bruce said

More importantly, Bruce and Toni might have to miss the game themselves, so Toni went to her mother - aloof to her daughter's passion for sports – to explain the need to reschedule.

"She just had no idea what I was talking about, but I told her that I didn't want her to spend all this money on a wedding that nobody was going to pay any attention to," Toni said. "The invitations hadn't been sent out yet and so we pushed the wedding back a week."

Good thing. The Bruins, recharged, shined in the spotlight and beat Houston decisively. The timing couldn't have been better.

"It was great, because UCLA won and a week later, Toni and I won," Bruce said.

Soon, Toni and Bruce became parents to sons David and three years later, Danny. These days, the family of four still gets together for the big games - Mom and Dad rubbed off on the boys, who played soccer and baseball as they progressed through Hawthorne School and then Beverly High.

but many estimates say that Persians make up at least 30 percent of the population. A city study conducted among Beverly High families in 2004 showed that about 25% of families spoke Farsi at home, though it's unclear how many families may also be proficient in English.

Either way, according to Professor Rick Hasen - who specializes in election law at Loyola Law School - Beverly Hills is not mandated to translate election materials into Farsi.

Because the Department of Justice limits the definition of "political subdivision" to counties, Hasen said, Beverly Hills is subject to the requirements and census data of Los Angeles County, where Farsispeakers make up less than 5 percent of eligible voters.

Los Angeles County - and by default, Beverly Hills - is only mandated to provide election materials upon request in Spanish, Chinese, Tagalog, Japanese, Korean and Japanese.

But Beverly Hills is not alone it its efforts to go beyond what's required.

Glendale offers a ballot in Armenian for its largest minority group.

West Hollywood, which is home to a significant Russian-speaking community, prints two versions of their ballot; one in English and Russian and the other in English and Spanish.

"We're not required to do this," said West Hollywood City Clerk Tom West. "But it's in the spirit of the law. It's a good faith effort to enable all of our residents to participate."

According to City Attorney Larry Wiener, Beverly Hills follows the same model.

"In 2004, when the city council requested that ballot materials be translated into Farsi, it did so because the council felt that there was a need in the community and it would encourage more and better informed political participation." Wiener said. "Technically, Beverly Hills is not required by federal law to translate [election materials] into Farsi."

If opposition to the policy stirs the pot to a boil, the next city council could decide to rescind the policy all together. While this year's ballot is set in stone, Pope said the city will consider the residents' concerns for next year's election.

If the debate continues though, critics of the multilingual ballot policy are sure to meet some opposition of their own.


"I just find it amazing that anyone would ever be offended that a ballot was in a language that gave other people the right to vote, it's just sad," said Human Relations Commissioner Julie Auerbach.

"Whoever these people are, this is exactly why we should be doing this. A translation of a language does not hinder their way of voting, it's just their displeasure."

Pope Handles Protests



The city had a new record last week: Protest phone calls. No, not the loss of two hour free parking, widening of Santa Monica Boulevard, or even the closing of Crescent Drive for a private party at city hall.

What enraged over two hundreds denizens who called City Clerk **Byron Pope** was the inclusion of Farsi on the official city ballot.

As one irate voter put it: If they can't understand our native language, they shouldn't be allowed to vote.

That does present a problem. As far as I know, English is a foreign language, so some Native American dialect will have to suffice.

This is not first time Farsi has been used as a second language in city elections. Nor is it even the first experience we have had with alternative languages. Spanish, the language of the early non-Indian settlers in Southern California, has been used in Beverly Hills and most of our neighboring cities for many years.

But two years ago, the city reacted to the growing number of Persian community voters by including Farsi.

Why is this even an issue? The city took a preemptive action based on advice from the ballot consultants and by evaluating federal guidelines.

No, we were not under some court order to insert Farsi, but a section of the Voting Rights Act does instruct cities to meet the language demands of its population. In Los Angeles County, the options range all the way from Spanish to Vietnamese.

Did we really want the feds to come in and file a legal action against Beverly Hills for not accepting standards adopted in other cities? Or, a more drastic but not impossible scenario: Rule that our elections were invalid? Can you imagine anything more divisive?

There is a broader issue involved, and one that is not dependent on the law.

To become a citizen a person must only have a cursory knowledge of English and American history. That fits our national goals of encouraging citizenship. If the new voter needs to fully understand the ballot and it is in a language with which he or she is more familiar, isn't that in the interest of fair, open and democratic elections?

The framers wrote the constitution in English, but made no reference to the language of **Chaucer** and **Shakespeare** in that marvelous body of work. We have a national language, although **Winston Churchill** might have challenged its resemblance to his words, by custom even though a vast majority of our current population has absolutely no family ties to the British Empire.

How quickly we forget. When our families arrived in America, they lived in neighborhoods where English was an unknown tongue. There were newspapers in Polish, German, Yiddish, Italian and Russian, to name a few of the wonderful cultures that made this country great. Immigrants, especially in New York, were rushed through the citizenship process by the political machines, such as Tammany Hall in New York, to assure control of city and state governments. Did these citizens have a clue what the ballot really said? No legal translations were provided.

The Voting Rights Act was adopted to cure many un-Democratic ills of our society. African Americans faced road blocks to voting in the South where regressive challenges, such as the poll tax, or the requirement that in order to vote your grandfather had to be a voter, was the law before the Voting Rights Act. The act also attempted to find more tools to encourage voting everywhere. One section is even called "Make America Vote."


I fully understand the discomfort some people had when they first viewed their ballots, and the Farsi inclusion seemed so very enlarged. It's possible the ballot design could have been more inventive, but the intent was to comply with the spirit and the purpose of federal directives and to really assist our new neighbors in understanding the ballot they were about to mark, a very proud action for new Americans.

There is some political reality here which also comes into the scenario. This is not the first time an Iranian candidate appeared on the ballot; four years ago the city elected its first Persian resident to the council. Others had tried and failed.

Jimmy Delshad won four years ago, but without the support of most of the Iranian leadership of Beverly Hills. Most of those endorsements went to **MeraLee Goldman** who lost because her literature was attacked, at the last minute, for including endorsers she did not actually have. The mistake was clerical, clearly not intentional, but that and some anti-growth issues Jimmy then supported, made him the surprise winner. Since then, he has modified his anti-growth positions.

In the last election, only one Iranian was on the ballot, and he did not do well. The Iranian vote was as splintered as the non-Iranian vote.

This election marks the first time more than one Iranian filed. We have three members of the Persian community running and that too probably contributed to the voter reaction. The three are energetically campaigning throughout the city and are vigor-

ously attempting to corral Iranian and non-Iranian votes.

Yes, there are some few Iranians who will vote only for Iranians, but there are also voters who will only vote for a Democrat, even though the election is non-partisan, and others who will only support candidates who are women or men or people of the same religion. Wrong? Maybe, but understandable.

What is interesting about these three: Delshad, **Maggie Soleimani** and **Shahram Melamed**, is how often they disagree on issues and how different their styles and appeals. To say that Delshad and Melamed dislike each other, is to understate the intensity of the competition. Soleimani, on the other hand, appeals to non-Iranian voters in the education community and also among people active in charities, both Iranian and non-Iranian.

Clearly, this is not an election between Iranians and non-Iranians, something that if it had happened, would be divisive and of concern. As for differences, the non-Iranians are just as distant from each other as the Iranian candidates.

Nancy Krasne is still angered by what she feels was unfair treatment by the city council when she was up for reappointment. Singling her out for questions on her behavior as a commissioner, an unprecedented act by the council, probably triggered her desire to run. She has taken a very strong anticouncil posture.

Mayor **Steve Webb** often disagrees with Delshad, but his two non-Iranian challengers, Krasne and **Lizza Monet Morales** a relative unknown and very long shot - have been his biggest tormenters in the campaign.

Also interesting in pairings is the endorsement of an Iranian, Soleimani, and non-Iranian, Krasne, by the Beverly Hills North Homeowners Association, an organization that has been very critical of Webb, Delshad and the rest of the city council. This is worth repeating: The election is not about three Iranians running against three non-Iranians and it was not the Iranian community that caused the ballot to be translated into Farsi. Most wished it hadn't happened.

Are there cultural issues, clashes in our city? Of course. The differences in history alone made that inevitable, as it does with most first and second American generations. On the plus side, the size of Iranian families probably saved our school system. Since pubic education is now paid by the state and not local property taxes and courts have ruled that the spending must be equal in all school districts, we have benefited enormously from Iranian immigration which came as we were losing school age population.

Also, as the candidates themselves show, the Iranian community is not monolithic. Most are Jewish, some Bahai and a few Muslim, although all three in the council race are Jewish. Adopting to their new world, they are in a wide range of professions and trades with the usual mix of economic success and failure.

Any change in any ethnic, religious and racial mix in any community causes some discomfort and even extreme backlashes. The migration of Jewish residents to Beverly Hills was not seamless, not at all. We have also had times of large numbers of Christian Scientists, Mormons and, in case you have any reservations on our religious history, examine the house of worship on our church row: Not one synagogue or temple. We live in harmony and are an enlightened, tolerant people. We just need to remember that diversity and adjustment together will strengthen our city.

As for choosing our councilmembers, I hope the test will always be integrity, ability and a grasp of the problems our city faces. Issues, not ethnicity, should matter. There are Iranian and non-Iranian candidates I

MYTH: The City Council has entered into a Memorandum of Understanding (MOU) with the Beverly Hilton to build a new Waldorf Astoria Hotel.

FACT: Absolutely Untrue. The Council has no such Memorandum of Understanding or MOU. In fact, the Council has yet to see the Hilton/Waldorf presentation that was first shown to the public several weeks ago.

MYTH: The City Council made a decision to hire a traffic consultant for \$900,000 and is legally obligated to widen Santa Monica Blvd by five feet.

FACT: Not true. The City Council has authorized a traffic consultant (for \$50,000) to analyze the impacts of widening Santa Monica Blvd. No decisions will be made regarding widening Santa Monica Blvd. Endorsements crossing the political body from council to board and back are very common and understandable. Preservation of our City's Industrial Area for **Municipal Services**

(that area directly south of Santa Monica Blvd., east of Foothill, and *between Alden and Third Street*)

As part of the excessive development scheme in play by our incumbent council members, Webb and Delshad, it is City Hall's intention to commercially develop our City's Industrial Area in joint ventures with private developers. Beverly Gardens

On December 19, 2006, Steve Webb and Jim Delshad, along with their council colleagues, voted for a Council resolution (item eight on the Council Agenda) approving a Memorandum of Understanding between the City of Beverly Hills and the Los Angeles County Metropolitan Transportation Authority for funding the design and construction for the widening of North Santa Monica Blvd. between Doheny Drive and Wilshire Blvd. As part of this agreement, our City plans to expend \$941,000 in order to receive \$1,751,000 from L.A. County Metro Transportation Authority for the design and construction of the Santa Monica Blvd. widening. Significantly, both Steve Webb and Jim Delshad approved this resolution without directly notifying the residents living in the 500 blocks adjacent to the parkland. On Kazoos and Romance

Barry Weiss & Janet Roston There are two sides to every story. The love

tale of Barry Weiss and Janet Roston, married for 22 years, is no exception.

To Barry's recollection, it all began when he, a 34 year old hairdresser working on Canon Drive at the time, took a sudden interest in remote video production for television and enrolled in a Beverly High adult school class taught by the school's longtime media director Dave Stiles.

Weeks into the class, Barry had begun to grasp the ropes of camera angles and lighting when a close friend invited him to the taping of a human-interest story for the evening news. The program's unlikely subject, to be interviewed by Channel 2 anchor Kerry Millerick, was the Temple City Kazoo Orchestra.

This rare ensemble of tuxedo-clad kazoo maestros performed treble heavy renditions of tunes like "Theme From 2001: A Space Odyssey" and Led Zeppelin's "Whole Lotta Love." Barry accepted the invitation and arrived early to the taping, clipboard in hand, eager to observe the pros. Instead, he found himself focusing on a spirited young lady member of the ensemble, Janet.

"This cute little, curly haired girl, who I had never met before, happened to be particularly nice to me," Barry said.

Barry, still just a novice in remote production had been jotting notes from the back of the room when Janet went out of her way to introduce herself. "I just think she's interested in me," he said.

Not quite, Janet said.

"At the time, I had gotten my undergraduate degree in dance at UCLA and I was in my graduate program there; I wanted to do choreography," she said.

As a 22 year old graduate student, Janet saw the Temple City Kazoo Orchestra open for a popular punk band on campus.

"I thought well these guys are pretty funny, but you know what? They'd be a lot funnier if they had choreography," Janet said. "They need and act, they need a show."

A few phone calls later and Janet was at a rehearsal. But despite her best effort to coordinate and corral the "unruly" group, they "just weren't interested." Instead, they asked her to join the band.

It was a bittersweet compromise. Janet dreamed of choreography, not symphonic overtures on kazoo - but there was still hope that the group would one day, in a change of heart, embrace her dance ambitions.

Channel 2 taping as a spring board for her choreography career.

"I'm going to show up the day that we shoot and get my name on as the choreographer of this band. That's my mission," she said. "So I show up early, and there's a guy there with a clipboard and I think he's the producer. [He's] there before everyone else, you know, collecting all the information, and he looked really official, so I go up to him and I'm really friendly like, 'Hi, how are you,' because I want my name on TV as the choreographer of this band."

Smitten, Barry has his friend pass along his business card the next day, unaware that he's just demoted himself from producer to hairdresser.

"When I got his card and find out that he's a hairdresser, I realize I've made this huge mistake," Janet said. Yet, in a "what-the-heck" moment, she decided to give the guy a date.

Meanwhile, Barry hit the library to learn every last detail about kazoos.

Janet looked forward to the meeting too, but she had been warned by friends that Barry, a male hairdresser, had to be gay. Friend, yes, boy-friend, probably not.

When they finally met up near Barry's apartment in Westwood, it wasn't long before that topic pops up. In passing, Barry tells Janet that he had been married before. No big deal, Barry thought, it was in the past. But in Janet's mind, at first, that's strike one against Barry. A divorced hairdresser is not who she expects to take home to mom.

"So, you're divorced?" Janet asks.

Barry was prepared with a clever response -

he would reference the famed dancer and actor Fred Astaire. Any ambitious student of choreography would have appreciated the gesture and grasped the humor:

"Yeah, that's me," Barry says. "The Gay Divorcee."

The fourth paragraph of Section 3-2.2.1 "Contract Unit Prices", of the Standard Specifications for Public Works Construction is deleted and replaced by the following: "Should any Contract item be deleted in its entirety, no payment will be made to Contractor for that Bid Item."

The following is in addition to the provisions of Section 2-9.1 of the Greenbook:

The Contractor is required to locate and tie out survey monuments in the project area prior to construction involving street and highways, and to file with the County Surveyor a Corner Record of any such work. Prior to the issuance of a completion certificate, the Contractor is required to file a Corner Record for survey monumentation that is replaced. All such survey work shall be performed under the supervision of a California lincensed Land Surveyor or a Civil Engineer authorized to perform such work.

Section 3-3.2.2 shall be changed as follows:

(a) Labor. The costs of labor will be the actual cost for wages of workers performing the extra work at the time the extra work is done, plus the employer payments of payroll taxes, health and welfare, pension, vacation, apprenticeship funds, and other direct costs, resulting from Federal, State, or local laws, as well as assessments or benefits required by collective bargaining agreements.

An allowance for the Contractor's overhead and profits shall be added to the sum of the Subcontractor's costs and markup and shall constitute the full and complete markup for all overhead and profit for the Contractor on work by the Subcontractor. For Contractor markup of Subcontractor's costs, the allowance shall be 10% on the first \$2,000 or portion thereof, and 5% on costs in excess of \$2,000.

LIQUIDATED DAMAGES - There will be a Five Hundred Dollar (\$500.00) assessment for each calendar day that work remains

PREVAILING WAGES - In accordance with the provisions of Section 1770 et seq., of the Labor Code, the Director of the Industrial Relations of the State of California has determined the general prevailing rate of wages applicable to the work to be done. The Contractor will be required to pay to all workers employed on the project sums not less than the sums set forth in the documents entitled "General Prevailing Wage Determination made by the Director of Industrial Relations pursuant to California Labor Code Part 7, Chapter 1, Article 2, Sections 1770, 1773, 1773, 17".

Attention is directed to the provisions of Sections 1777.5 and 1777.6 of the Labor Code concerning the employment of appren-tices by the Contractor or any subcontractor under him. The Contractor and any subcontractor under him shall comply with the requirements of said sections in the employment of apprentices.

Information relative to apprenticeship standards and administration of the apprenticeship program may be obtained from the Director of Industrial Relations, San Francisco, California, or from the Division of Apprenticeship Standards and its branch offices.
