Junior David Swatt mentors kids with learning disabilities

David Swatt was showered with the limelight yesterday, as a camera and news crew descended on Beverly Vista to name the Beverly High junior the KABC "Cool Kid of the Week."

Swatt is the founding member of "Mentoring for

Success," a student-run group that meets with a dozen or so children from Beverly Vista for an hour-long mentoring session geared toward learning. Like Swatt and most of the other teenage mentors, the participating Beverly Vista children all have learning disabilities.

"Over 20 percent of BHUSD kids have some sort of learning disability," Swatt said. "While I know that learning comes naturally to some people, it's not the case for everyone." Though Swatt is successful student – he sports a 3.94 GPA - it didn't come easy, he said. He credits long-time mentor and special education teacher Kathy Bronte, who worked directly with Swatt at Hawthorne School. Bronte, who has since moved to Beverly Vista, also helps Swatt with "Mentoring Success."

"He's a great kid, he's a success story," Bronte said. "He put this program together and he beams, he loves it and he's good at it, and the young kids love it too."

Swatt said he was motivated to organize the program because it's important for other kids like him to know that they too can be successful.

"I have a 3.94 GPA and here I am," Swatt said. "I want to show the kids that they can succeed, it's just a matter of time and a matter of people believing in them."



UNITED STATES DEPARTMENT OF JUSTICE CIVIL RIGHTS DIVISION, VOTING SECTION MINORITY LANGUAGE REQUIREMENTS

Dear Beverly Hills Voters:

The City is providing the Sample Ballot and Ballot materials for the 2007 General Municipal Election in multiple languages to its voters because the Department of Justice, Civil Rights Division, Voting Section is enforcing Sections 203 and 204 of the Voting Rights Act in municipal elections.

Congress adopted the language minority provisions of the Voting Rights Act in 1975 for a period of ten years, then extended them in 1982 for ten year and in 1992 for fifteen years, and again in 2006 for 30 years.

Sections 203 and 204(f)(4) require that when a covered state or political subdivision provides registration or voting notices, forms, instructions, assistance, or other materials of information relating to the electoral process, including ballots, it shall provide them in the language of the applicable minority groups as well as in the English language. It also provides tools to local election officials to recruit large numbers of new bilingual poll officials.

The requirements of the law are straightforward: <u>all election information</u> that is available in English must also be available in the minority language so that all citizens will have an effective opportunity to register, learn the details of the elections, and cast a free and effective ballot.

A jurisdiction is covered under Section 203 where the number of United States citizens of voting age in a single language group within the jurisdiction:

Is more than 10,000, or

• Is more than five percent of all voting age citizens

Beverly Hills is **not** currently required to translate into any minority languages. The City Council provided policy direction for the 2005 General Municipal Election to translate the candidate statements and voting instructions into Farsi. This year, in an effort to comply with the spirit of the above law, the entire Sample Ballot and Ballot (instead of portions of the materials) are in the languages of minority groups that make up the population of the city based on the survey that was completed in 2004 for the 2005 Election.

Revised Notice of Preparation of Draft Environmental Impact Report - State Clearinghouse #2006081074

Project: Proposed Office/Retail Development 231 – 265 North Beverly Drive / 9461 Wilshire Boulevard

In August 2006, the City of Beverly Hills issued a Notice of Preparation for the project referenced above. The project proposes the construction of a six-story commercial building in the City's central business district.

After the issuance of the Notice of Preparation in August 2006, the project has undergone design modifications, which have resulted in a slight increase (less than 5,000 square feet) in the gross square footage of the building. The change in the proposed project is shown in the table below.

Project Overview

The proposed project is located at 9461 Wilshire Boulevard, which is known as the "Bank of America building," and 231–265 North Beverly Drive, which consist of an area bounded on the south by Wilshire Boulevard, on the east by Beverly Drive, on the north by Dayton Way, and on the west by the alley between Wilshire Boulevard and Rodeo Drive. No substantive changes are proposed for to the Bank of America building, although it will be rezoned as part of the proposed project. The demolition and construction of the office/retail building will take place on 231–265 North Beverly Drive, which is presently developed with one level of commercial space and six levels of parking.

The project proposes changes to the existing zoning and General Plan, which are subject to approval by the Planning Commission and City Council. The proposed development is also subject to Planning Commission approval through the Planned Developed Review.

The project proposes a new six-story office building to be constructed on a 1.1-acre portion of the site.

A copy of the Initial Study is not attached. However, the Initial Study completed in August 2006 concluded that the proposed project may have potentially significant impacts for the following topical areas, which will be studied in the EIR: Aesthetics; Air Quality; Geology; Hazards and Hazardous Materials; Hydrology and Water Quality; Land Use and Planning; Noise; Population and Housing; Public Services; Transportation (Traffic and Parking); and Utilities (Water, Wastewater, Solid Waste).

The Initial Study concluded that the proposed project will not have impacts on the following topical areas, which will not be evaluated in the EIR: Biological Resources; Mineral Resources; Agricultural Resources; Cultural Resources; and Recreation.

As indicated, the project description has changed. If this revision changes any of your previous comments please respond with written comments within the time frame referenced below. Due to the time limits mandated by State law, your response must be sent at the earliest possible date, but not later than 30 days after receipt of this notice.

After the Draft EIR has been prepared, the Planning Commission will hold one or more public hearings on the EIR and on the project. Notices of the availability of the Draft EIR and of the hearings on the project will be provided at a later date.

Politics and Food Do Not Mix

And no, the menu was not in Chinese By Rudy Cole

It was a night to celebrate the Chinese New Year, the annual party The Peninsula throws for civic leaders and the societal chieftains of our village and, as always, General Manager **Ali Kasikci** proves that he is the **Perle Mesta** of the West.

From the Chinese animated dragons and music at the entrance, to the décor of the Veranda room to the food, excellence was achieved. But being an election year, the talk was not Mandarin subject matter.

The conversation Monday night was focused, with some of our most knowledgeable political types asking, not answering, the question of the month: Who do you think will win?

As **Lil' Abner** often said, "It's confusing, but amusing," and if you don't recognize the comic strip of my youth, just another example of our age gap.

This election is confusing because of so many uncertainties, surprises and historical implications.

It has been many, many years that, without a so-called "open seat," meaning at least one spot in the election not being held by an incumbent, more than one strong, well-financed challengers emerged. In this election, Mayor **Steve Webb** and Vice Mayor **Jimmy Delshad**, both seeking a second term, are up against four contenders, three of whom are serious threats.

It is also the first time in our history that more than one member of the Persian community have been on the same ballot and, as mentioned here before, they are as diverse in their

appeals and posture on issues as possible.

This is not a slate of Iranians against non-Iranians, not even close. The main non-Iranians, Commissioner Nancy Krasne and Mayor Webb, are at opposite polls on issues, as are the Iranian contenders. Even the appeals of the Iranian candidates speaks to their differences on issues and personal strengths. Shahram Melamed is the angry young man of the election, confronting Delshad at every turn. Maggie Soleimani, who along with Krasne, has the backing of the largest but most controversial homeowner association, differs from both Melamed and Delshad in style and substance, appealing strongly to younger voters with school age children. Krasne has reached more of the council critics than any of the other candidates.

This city has some major decisions on the council plate, all of them far more serious than how the ballot is designed. But to hear some people who should know better, say they are voting for or against candidates because of their ethnicity is beyond belief. Actually, although the protesters are vocal, when it comes time to actually vote I think the electorate, both Iranian and non-Iranian will vote for leadership that comes closest to representing what they know are the best interests of the city. I am certain that most Iranians and non-Iranians alike will put Beverly Hills first and, hopefully, put an end to an ugly episode in our history.

One more time, is a ballot with Farsi more *rudy cont. on page 7*





"The technology is available right now to help track down the killers who use handguns," said Feuer. "It is time to require this technology to be used so law enforcement can clamp down on hand gun crime.

coverstory COUNCIL CANDIDATES SPRINT TOWARD FINISH LINE Campaign officials hope issues, not multilingual ballot or rumors, will define the election

The city council election is less than two weeks away and campaigns are chugging along at full speed. And with the Monday deadline to request absentee ballots, candidates and their campaign teams are hitting the streets and staffing the phones with absentee voters in mind.

"First we try to reach out to the people who will vote absentee and then closer to electionday, we reach out to voters who vote at the polls," said Samantha Stevens, political consultant to Vice Mayor Jimmy Delshad.

In Beverly Hills, about half of the electorate tends to vote by absentee and the other half goes to the polls on election-day. But because campaigns have access to the names of voters who have requested absentee ballots - and whether or not their ballots have been returned - well-managed campaigns often devote more resources to the absentee voters.

This late in the election season, if a campaign sees that a known supporter has not returned their ballot, that campaign will be sure to contact the voter and urge them to return their ballot on time. Ballots received by the city clerk

after election-day are not counted.

"I think all the campaigns are focused on the absentee voters right now, you've got to," said Mike Meurer, who is consulting the campaign of Nancy Krasne.

As of Tuesday morning, 1,161 absentee ballots have been returned, according to City Clerk Byron Pope. A total of 1,797 ballots were requested this year, in addition to the 2,899 ballots that were sent out to permanent absentee voters. With 129 ballots being returned each day on average, the projected number of absentee votes this year is on par with recent elections.

To reach absentee voters that haven't yet returned their ballot, candidates and campaign representatives say they're walking door to door and calling voters, urging them to vote and pushing their respective platforms.

In addition to walking, Krasne zeroed in on what is perhaps the most important issue this year by sending out a direct mail piece with a detachable survey about traffic, urging people to complete the survey and mail it back.

Maggie Soleimani said she has focused

mostly on walking and made the rounds most recently on and around South Lasky Drive, where she held a coffee reception on Tuesday night.

"People in the Southwest are concerned about gridlock, people on the 500 block [of Santa Monica Boulevard] are concerned about the widening of Santa Monica Boulevard," Soleimani said.

But the widening of Santa Monica Boulevard is one of a few hot button issues that other campaigns, especially those of the two incumbent candidates, say have been misrepresented.

Mayor Steve Webb, running for a second term, sent out a pre-recorded "robo-call" to thousands of residents last week, urging them to call him back and talk about issues such as Santa Monica Boulevard.

"It's Steve's number one, he's always dispelling these rumors," said Judie Fenton, cochair of the Webb campaign.

Though the city has entered into a memorandum of understanding with the Los Angeles County Metropolitan Transportation Authority, committing \$941,000 if the city were to widen Santa Monica Boulevard, the project is being studied and no binding decision has been made.

The Beverly Hills North Homeowners' Association, which has endorsed Krasne and Soleimani, has repeatedly attacked Webb and Delshad, calling their approval of the MOU with the MTA the "misbegotten efforts of the incumbents" in an ad that appeared three weeks ago and again last week in the Weekly.

Webb responded yesterday with a flyer that denounces the group's claims about Santa Monica Boulevard. In response to another floating rumor, the piece also denies that the city council has "entered into an agreement with the Hilton Hotel to build a Waldorf Astoria Hotel." Webb campaign workers were dropping the piece directly, Webb said.

Delshad, who has repeatedly championed his role in the successful takeover of Santa Monica

Boulevard from the State of California, has even committed not to widen the street.

"I led the successful takeover of Santa Monica Boulevard to prevent the State of California from widening it," Delshad said at a candidate forum earlier this month.

"I think the bad publicity that the North Homeowners' Association have brought up have given the wrong impression of the incumbents," Delshad said. "When they go to the point of lying about my voting record, I don't blame anybody for not liking me."

The group's recent ad stated that Delshad, along with Webb, "endorsed a 26% rate hike in our water bill" last year, though Delshad voted against the measure.

The new multilingual universal ballot, which drew over 300 complaints to the city clerk's office last week, is another unexpected - and perhaps widely misunderstood - election agitation.

In an attempt to defend the new ballot, the city clerk published a public notice in last week's Beverly Hills Courier detailing Section 203 of the voting rights act, even though the provision does not mandate Beverly Hills to translate its election materials into Farsi.

The same ad has been edited slightly to reflect that detail and an amended version appears in this week's Weekly on page three.

With confusion about the recently redesigned ballot still lingering, some say it could affect the election. There are three Persian candidates and three non-Persian candidates running, though none are affiliated or estranged because of ethnicity and Persian and non-Persian residents alike were alarmed by the new hallot

It is uncertain how the Farsi ballot, or any other recent controversies, will affect the election outcome.

"Two weeks is a lifetime in a campaign," Meurer said. "It's too early to tell anything."




