

# Mammoth park renovation plans draw support, opposition

Southwest Homeowners turn out to protest Roxbury Park overhaul By Rudy Cole

Residents and beneficiaries of the city's parks will soon come together in an effort to salvage plans for an ambitious renovation of both La Cienega and Roxbury Parks following an often raucous public hearing Monday before the city's Recreation and Parks Commission.

City officials appeared to admit that earlier plans for a Community-Sports Center in the Industrial Area would be abandoned since "ninety percent" of proposed uses for the Center would now be included in the new Roxbury Park.

One member of the audience said this was another example of "pushing on the southwest section anything the North Homeowners don't want." Another speaker said "imagine the opposition if they [the city] tried to put all these new buildings on Beverly Gardens," (the park adjacent to Santa Monica Boulevard.)

A proposal by Southwest Beverly Hills Homeowner Association president Ken Goldman to bring "resident and user groups together" to work out a possible compromise plan won support from the Commission and city staff.

Original plans called for a presentation to the city council in April, but city officials said the project would now be placed on hold pending a meeting of the "residents and stake holders."

Most of the opposition was to plans for massive enlargements of Roxbury Park which would include an aquatic facility, a community center meeting room, enlarged youth sports fields and the abandoning of lawn bowling and croquet. Far less drastic changes at La Cienega Park are planned and these seemed not to face similar problems with park neighbors.

City Consultant Pat Hirsch estimated that renovation costs for both parks would be about \$60 million with \$38 million ear marked for Roxbury. Hirsch, who has helped advise cities such as Glendale and Burbank and also UCLA on recreation facilities, did not give specific sources of funding but a bond issue, which would require voter approval, was mentioned by city staff as one possibility.

Among the dozen or so speakers who opposed expansion was Spalding drive resident Peggy Kaus who said that increased uses would mean loss of privacy and more noise for nearby residents.

Other speakers warned that the park would not be used by residents and would only increase visits by non-residents. Objections were also raised to an underground parking

facility which "would require considerable security to make parking at night safe" another resident warned.

An earlier meeting in February, attended mostly by park users including youth sports associations, generally approved the improvements at both parks which expand fields for soccer and Little League. They will be represented when the various interest groups are brought together by city officials

Lawn bowling, which has been a tradition at Roxbury Park for decades, and croquet are the most likely losers if current plans are approved. Of the 21 remaining members of the lawn bowling group, only two are Beverly Hills residents and only one of 14 croquet club members live here.

On the other hand, of the Active Senior group, major facility users, almost 70 percent are reportedly residents of the city.

Recreation and Parks supervisor Pat Agnitch told the Weekly that "essentially, we will be starting over again" with all options on the table. She welcomed the plans to bring "stakeholders and residents" to a joint meeting.

About sixty people attended the meeting, mostly homeowners in the southwest. Representatives of soccer groups, including Michael Karlin, were present, but did not speak. Sports association representatives made their views known at the February public hearing. Representatives of the school district are also expected to be invited to the meeting of resident and user groups which will be held within the next few weeks.

named Beverly Hills Chamber of Commerce Director of Communications Jacqueline Paynter and chief executive Dan Walsh. Jackie has a rich background in communication and is also a quick learn. Our luncheon was the Friday following the week of the election and there were inevitable campaign discussions around us. Former planning commissioner Mitch Dawson, Mayor Steve Webb and soon to be Mayor Jimmy & Lonnie Delshad all stopped by to meet Jackie.

In Sacramento, the most powerful state leader can make or break a restaurant by his or her patronage. When **Willie Brown** wielded the speaker's gavel he dined at a formerly unpretentious Chinese restaurant which quickly remodeled and expanded as his Assembly and state Senate colleagues and a large entourage of lobbyists rushed to be seen in Brown's neighborhood.

With Webb's departure, it is now up to Delshad if Caffe Roma continues as the local political favorite. Incidentally, the diner covered itself quite well in the election. Facing the patio were two signs supporting Webb and Delshad, but inside, quite discretely, there was another for Nancy Krasne. My favorite Mexican restaurant, Lucy's Adobe, never removed Jerry Brown's picture from their window, even when his convoluted political career took him from Governor of the state to Mayor of Oakland and back to Sacramento as our new Attorney General.

I don't know the quality of your e-mail, but mine is very challenging. Someone must know something because I am, on a daily basis, offered suggestions on how to "increase my manhood" and at the same time given options to meet exciting ladies in "your neighborhood." Is there some possible connection between the two? Note to senders: She who rules reads all my emails.

Newspaper people and public relations folks do have a love-hate relationship and that may be why I often dislike myself, since I have labored in both worthy professions. Newspapers see pr types as important sources and annoying pests, depending on the message.

My e-mails are overloaded with plugs for everything from new books to unheard of motion pictures to products I am not able to understand, see above.

But my favorite flack story involves the late newspaper tycoon, the scion of the Chandler family, Norman, then publisher/owner of the Los Angeles Times. He once showed me a press release, and it did not amuse him.

It was for a play opening at the old Biltmore theatre from a New York publicity firm and the press release described the play, the leading actors, the date and times and some puff notices. At the end of the release, Chandler read this addition: "If you publish this notice we would be pleased to present you with two tickets for a Wednesday matinee. Just bring a tear sheet (copy of story) to the box office as proof and we will be pleased to have you as our guests." As I recall it, that play was never reviewed.

Speaking of the Times and Caffe Roma

luncheons, reminded me that I recently met their op-ed writer Erin Kaplan and cityside reporter John Mitchell who used to cover the Westside when the Times had a Sunday and Thursday regional supplement. One lunch with me and Kaplan gets reassigned. Incidentally, it was wrong of me to complain to them of the Times decimation of their comic pages and the loss of Momma and now Candorville. What happened to the other great strips such as Broom Hilda, the Far Side, Wizard of Id, Garfield all replaced by a pathetic roster of mediocrity - with the exception of For Better or Worse and the ageless Blondie, Crankshaft and the Drabble - the only reason to still turn the pages.

Final note on publicity workers: We are told the city will soon hire a top professional to handle information dissemination, and not too soon, although some recent releases have been helpful. However, a planning commissioner suddenly resigns and not one press notice is prepared. That would not happen in Spartanburg where our former city manager, Mark Scott, inherited a first rate publicity staffer. She could not have been more helpful in keeping us informed on Scott's timed arrival.

When the new gun on pr arrives, possibly the minutes and synopsis of commission meetings could be brought up to date – some are six or more months behind on the city's web site.

OK, one political note: Being mayor may not be the best title to put on your bal-

lot designation when you run for reelection. MeraLee Goldman, Tanenbaum, Annabelle Heiferman all departed office via election while serving as mayor. Nor is having the most lawn signs, the support of almost every "important" community leader and both newspapers and the police and fire associations backing a guarantee of success. The only nod Steve Webb failed to garner was that of the National Women's Political Caucus and that was gender bias for sure.

In case you missed the notice, the induction of Delshad and the looking back speech of Webb has been reset for March 27 under a city hall tent.

It will be Delshad's and Webb's night, but all ears will be tuned to newly elected Nancy Krasne who will certainly bring a new perspective to city government. Nancy and Jim just returned from a recuperative trip to Italy and she is primed to move for an immediate restoration of two hour free parking. She will begin with Frank Fenton's vote and should easily gain a third.

## Final City Council Election results: 166 ballots disqualified

Final, certified election results from the March 6 City Council election indicate a total of 6510 ballots were cast. Votes disqualified include 166 provisional ballots which were disqualified due to voters not being registered or other registration irregularities, and 37 absentee ballots which arrived in the mail after election day, too late to be counted.

### West Hollywood Councilmember Turns Down Mayor's Job

In a move that caught his colleagues by surprise, newly reelected Councilmember Sal Guarriello Tuesday passed up his turn to be mayor of West Hollywood citing "personal reasons" for refusing the office.

On March 6, Guarriello won reelection for a third term along with Councilmembers Abbe Land and John Heilman, but finished third among the three winning incumbents. His closest challenger was former mayor and

councilmember Steve Martin who had 1,867 to Guarriello's 2,200. Land led all candidates with 2,635 votes.

Councilmember John Duran will become Mayor and Jeffrey Prang Mayor pro-tem (vice mayor) at an installation ceremony on May 7.

Although none of the councilmember's would comment on the "surprise" move, city insiders say that Guarriello may not have been able to garner the three votes needed to assure election as mayor.

## **Edwards, Clinton Set For Beverly Hills Fund-Raisers Friday, Saturday**

Former North Carolina Sen. John Edwards and Sen. Hillary Rodham Clinton, D-N.Y., are scheduled to hold fund-raisers for their campaigns for the Democratic presidential nomination in Beverly Hills homes Friday

and Saturday.

The fund-raisers come as a key deadline is approaching — the March 31 end of the quarterly fund-raising period. The candidates' reports, due April 15, could force presidential hopefuls to drop out of the race or propel candidates who were also-rans into the top tier.

With the large and costly-to-campaign-in states of California, New York, Florida, Illinois and New Jersey among as many of 19 states that could hold primaries Feb. 5, the 2008 presidential campaign will be "the longest and most expensive election in American history," Michael Toner, then a member of the Federal Election Commission, said recently.

"We're heading into the first \$1 billion election," Toner said, adding that to be competitive, a candidate will need to raise \$100 million by the end of the year.

Candidates are collecting contributions at a record-setting pace and could collectively report raising nearly \$100 million in the quarterly report, The Washington Post reported.



## BHHS Baseball Team Wins In Return To Nickoll Field

Norman softball team defeats St. Monica, Lawndale By Steven Herbert

The Beverly High baseball team made a triumphant return to Nickoll Field Friday, defeating Los Angeles Marshall, 2-1, in an eight-inning nonleague game, its first game on campus in several years.

Michael Kerman singled in Erik Munzer with the winning run as the Normans (6-1) won their fifth consecutive game. Munzer opened the inning by reaching first on the third error of the game by Oscar Robles, the Barrister third baseman, then stole second.

Matt Ross (2-0) pitched a two-hitter, striking out seven and not walking a batter.

Ross retired 14 of the final 15 batters he faced after Robles led off the fourth with a single. Jose Mendieta was the only Marshall batter to reach base during that span, reaching first on an error by Justin Schwarz, the Beverly Hills shortstop, leading off the seventh.

Both teams had two hits. Kerman had the both Norman hits, tripling leading off

the third and scoring when Charlie Bogart reached first on an error by Robles.

Peter Betancourt homered with one out in the second for the Barristers (2-6).

The installation of artificial turf on Nickoll Field will allow the team to again play there, coach Vonzie Paysinger said.

Beverly Hills had been scheduled to make its return to Nickoll Field March 14 for a game against Pasadena La Salle, which did not show up for the game, whose coach claimed he did not know it was scheduled to play at Beverly Hills, Paysinger said.

The Normans are scheduled to play two more games at Nickoll Field this season, April 17 against Inglewood Morningside and May 10 against Inglewood, both beginning at 3:15 p.m.

#### **Beverly Hills 9, Fillmore 2**

Alex Rosenthal pitched a four-hitter, John Skura drove in three runs and Schwartz went three-for-four as the Normans won a nonleague game at Fillmore March 13.

The Normans scored twice in the first. Joey Axelrod led off with a single and hobbled to second base with an apparent groin injury when Flash right fielder Jason Hurtado overran the ball. Schwartz followed with a triple, driving in pinch-runner Monty Zimmerman. Schwartz scored on a single by Skura, Beverly Hills' No. 3 hitter.

The Normans increased their lead to 3-0 in the third when Schwartz led off with a single, moved to second on Skura's ground out, stole third and scored on Brandon Cohen's ground out.

Beverly Hills scored three times in the fourth, taking a 6-0 lead. Axelrod singled in Munzer, who singled. Skura's single drove in Bogart and Axelrod.

## People's Agenda

To preserve and enhance our quality of life, we put forward our People's Agenda to City Hall for adoption.

- **1.** Restore two hour free parking city wide.
- 2. Rescind the December 19, 2006 City Council Resolution calling for the widening of Santa Monica Boulevard and the accompanying encroachment into Beverly Gardens Park. Declare that the widening of Santa Monica Boulevard and encroachment into Beverly Gardens Park will not occur.

3. Inform developers that the 3 story/45 foot height and density limits are still in effect in our City and that proposals like the Hilton/Waldorf Astoria Towers Project with its planned 170 foot tower and two150 foot towers (The Tri-Towers) in close proximity to residential neighborhoods and the El Rodeo School, are, and will always be, unacceptable.

- **7.** Declare that the proposed mega sports facility at a cost of between 60 million to 80 million dollars planned in the Industrial Area will not be built.
- **8.** Ensure that all of our public schools have state-of-art technology in the classrooms so that our children will receive quality education consistent with the finest private schools in the area.
- **9.** Ethics enact an Ethics ordinance that bars for a period of four years all ex-Councilmembers, Planning Commissioners and their family members from representing clients before the City Council, staff, or Planning Commission.
- **10.** <u>Duttons Bookstore</u> Let's bring back Duttons Bookstore or another one similar in nature. We need a bookstore here in our City!

## **Council Report Card**

As part of our continuing effort to keep you informed as to the goings-on at City Hall, we will keep tabs on the voting and public record of the City Council members and report back to you on such matters. First up, Barry Brucker:

#### • Excessive Development/Gridlock

For the past several years, the City Council has trashed the 3 story/45 foot height and density limits reflected in the Municipal Code and the Beverly Hills General Plan. The result has been spot zoning, massive development and destination gridlock traffic! There are presently more than 15 development projects on hold awaiting post-election decisions. The enormity of this build-out qualifies as a matter of major public concern-yet, you remain silent.

## • Widening of Santa Monica Blvd.

On December 19, 2006 you and your colleagues voted to approve an agreement with the Los Angeles County Metropolitan Transportation Authority for funding for the design and construction for the widening of Santa Monica Boulevard from Wilshire Boulevard to Doheny Drive, with an encroachment into Beverly Gardens Park. Contrary to your campaign promise to keep the residents advised of City Hall activity, you never bothered to inform the residents, especially those most directly affected by the planned design and construction!

## • Two Hour Free Parking

You voted to abolish two hour free parking!

## • 26% Water Rate Hike -Compounded Over A 9 Month Period During 2006

You personally voted in favor of it without any reasonable requirement to do so from the Metropolitan Water District.

## • Montage Hotel Project/Measure A

You personally voted in favor of it and while running for Council never divulged the \$2.5 million in debt service our City is now obligated to pay for the next 20 years. Also, you neglected

to inform our residents that the public parking would be in excess of 86% tandem parking - 4 levels subterranean with cars stacked one in back of another.

#### • Eminent Domain

You and your colleagues endorse the concept of Eminent Domain in the Industrial Area that may result in evicting the Amanda Foundation, its animal protection/welfare facility, from its present location, most likely forcing it out of business in our city!

#### • Forum Control

You and your colleagues, during this election campaign, arbitrarily by fiat, set down rules for the conduct of candidate public forums. Without any public input, you simply decreed that if the forum were not at City Hall and the moderator were not approved by City Hall, then you would not permit the forum to be aired on our City Public Cable Access channel. Accordingly, you denied us residents the opportunity to view in the comfort of our homes the candidates for City Council answer questions asked by their fellow residents. And why, because City Hall couldn't control it.

On January 10, 2007 at Roxbury Park Auditorium, we conducted a Candidate Forum. You refused to air it. Also, your arbitrary and un-democratic edict resulted in the League of Women Voters refusing to participate and comply with your intrusive policy. For the first time in decades, the League withdrew its Candidate Forum. Moreover, cost was never the issue - we offered the tape of our Forum free of charge as a public service to all.

In our judgment, this voting record is so dismal that rather than having us ascribe a grade, we suggest that you grade Councilmember Brucker's record yourself and please notify us of the result.

## City Council Deception du Jour

On February 21, 2007 at 7 P.M. inside the Verandah Room, at the Peninsula Hotel, we invited the public to participate with us in an election Rally to support Nancy Krasne and Maggie Soleimani. Presentations were made by Board members who discussed matters of public concern. Victor Bardack, past President for many years and present Board member, was delivering his prepared remarks regarding the City Council's December 19, 2006 vote to approve the Resolution adopting the Memorandum of Understanding (MOU), the contract between Beverly Hills and the Los Angeles County Metropolitan Transportation Authority to widen the north side of Santa Monica Boulevard. with its encroachment into Beverly Gardens Park, when Council member Barry Brucker disrupted the meeting by shouting at Victor Bardack that he, Brucker, wanted to tell the "truth". Victor Bardack cautioned Barry Brucker that he was interrupting the meeting and that this Rally was not an appropriate time to debate. Brucker continued to interrupt. The Chair, Robert K. Tanenbaum, Board President, advised Brucker that he would be given fair opportunity to present his views after the agenda planned presentations were completed.

At no time did Mr. Brucker ever approach any Board member, including the Chair and/or Victor Bardack, to request an opportunity to be heard. Nevertheless, it has always been our policy and practice at our meetings to permit the public to participate. Needless to say, it is unbecoming for anyone, much less for an elected official, like Mr. Brucker, to disrupt a public meeting by shouting down any individual who is addressing the audience.

Since we believe in an open, free, democratic marketplace of ideas through stimulated discussion, the Chair recognized Mr. Brucker and gave him unlimited time to present his views. Mr. Brucker did so without interruption. substance, he stated that the December 19, 2006 City Council vote approving the contractual agreement between Beverly Hills and the Los Angeles County Metropolitan Transportation Authority to widen the north side of Santa Monica Boulevard, with an encroachment into Beverly Gardens Park, was not binding, was done only to preserve Metropolitan Transportation Authority funds, and if the widening and Park encroachment were to occur, there would be an Environmental Impact Report (EIR) required. Let's analyze each of Mr. Brucker's assertions:

1. The Memorandum of Understanding (MOU) is a binding contractual agreement between the parties, in this case, between the City of Beverly Hills, and the Los Angeles County Metropolitan Transportation Authority (Metro). It was precisely and definitively drafted by lawyers representing the respective parties. In this contractual agreement, the City of Beverly Hills is the grantee and Metro, the grantor. The purpose of the contractual agreement is to provide a grant to the City of Beverly Hills in the amount of \$1.7 million dollars in funding for the "widening" of the north side of Santa Monica Boulevard from Wilshire Boulevard to Doheny Drive. This grant of funds combined with Beverly Hills contributing \$941,000 dollars contemplates the cost for the widening of Monica Boulevard encroachment into Beverly Gardens

Contrary to Mr. Brucker's assertion that this contract is not binding, both parties entered into it expecting each side to honor its contractual commitments. Implicit in all contracts are the covenants of good faith and fair dealing. It would be reprehensible public policy for public officials like Councilmember Brucker and his colleagues to enter into binding contractual agreements with other public agencies and have no intention to engage in good faith performance of their contractual obligations.

We believe that the City Council had every intention of going forward with this agreement. If not, why did the Council hire a consultant in the amount of \$50,000 to assist in the project? Why, also, have there been surveying crews along the edge of Santa Monica Boulevard in the very area where the work is contemplated? Let's face some facts. The City Council went forward with this agreement without ever notifying the residents, particularly those living in close proximity to Beverly Gardens Park. It hired a \$50,000 consultant. It is on-line to comply with the Project Milestones listed in Attachment C of the contract. The seventh Project Milestone calls for "construction" to begin November 2007 through January 2009 (14 months)!

**2.** Mr. Brucker's second point was that the City Council only voted to enter into the contractual agreement to preserve the grant money. But the grant money was only to be used for the widening and could only be obtained if the city

performed its obligations pursuant to the terms of the contract and consistent with the stated <u>Project Milestones</u>. The City is already on-line in a timely fashion to comply with the first two <u>Project Milestones</u>.

**3.** Mr. Brucker's third point was that if the city was going to widen Santa Monica Boulevard it would require an Environmental Impact Report (EIR). No where in the contract is there any provision for an EIR. In fact, the contract contains a detailed timeline (Attachment C - Project Milestones - posted below) with actual construction to begin in November 2007 and to last for 14 months.

Unfortunately, in attempting to defend the indefensible, Mr. Brucker engaged in a painfully pathetic spin about a matter of enormous significance to all of us residents. Had he and his colleagues respected our rights and interests and notified us of their intentions, perhaps the City Council would not have sought the grant from Los Angeles County Metropolitan Transportation Authority and never signed off on a contract with it. In our judgment, the lesson to be learned is that City Hall owes all of us the proper respect of fair notice of its intentions with a meaningful opportunity to be heard.

## **SCOPE OF WORK**

#### BH Weekly: Tell us about BHEF's priori- Who are some new faces on your BHEF **Board of Directors this year?**

Some of the new faces, although not all, include Larry Sternshein who is taking on a greater financial role, Jodi Galen, who has co-chaired the fall Apple Harvest Fair and this year's Apple Ball, Jana Garrotto, who has worked on all of our events, Jonathan Prince, who is creating a television show and merchandising for us, Cynthia Baseman who is a remarkable fundraiser, Fabienne Berman who co-chaired our Bloomingdale's event and Denise Avchen who is working on our Arts 4 All projects as well as Andy Geller, and Karri Steinberg. We also invited all of the PTA presidents at the five schools to sit on our board to enhance our ability to work together effectively. New on the Executive Board this past year are our Secretary Ronna Berlin, Dr. Steve Berlin (not related) co-chairing the car show, Steven Fenton, chairing BHAAA and Teen BHEF and our Treasurer, Julie Steinberg.

We also started Teen BHEF for kids grade 8-12 which has really taken off. It is amazing to see these new faces begin to understand the importance of philanthropy and how necessary private funding is for public education.

## We have a new superintendent in the BHUSD this year. In what ways has BHEF interacted with her?

I worked closely with [former superintendent] Jeff Hubbard last year but even more so with Kari McVeigh. She has a unique understanding of the importance of fundraising for a public school district. She has truly become a partner in the effort. We share the belief that the Beverly Hills public schools can't be just "good enough," that they must set the standards for excellence and be a flagship for other public schools.

#### Tell us a little bit about your professional background, and how did you first get involved in BHEF?

I currently have a strategic partnership with an entertainment manager to produce film and television. I have worked in this industry as creative executive and co-produced movies such as Patch Adams and Catch Me If You Can. My experience with producing movies and putting projects together has well-prepared me for the many aspects of fundraising. I love the development process and the creative elements of running BHEF. So much of it involves sharing the story of how great our schools could be if we all find ways to work together and each play a role. Simultaneous to my professional career, I have always had a "second career" in philan-

thropy so I fell into this role naturally. I initially got involved in BHEF through my cousin Linda Gach Ray, largely because I was working and BHEF met in the evenings. I was very attracted to the community aspect of BHEF. I love that BHEF raises funds for the entire district, for all of the schools, so that we elevate the levels of excellence throughout the district and even the playing field. It's important for all five schools to assure that all five are well-funded, equitably. Eventually, all four elementary schools feed into the high school and we want the kids prepared and achieving at their highest levels to subsequently raise the standards at the high school.

### Why do you think it has become more difficult for educational charities to raise money in recent years?

Part of the problem raising money is that there are so many worthy charities trying to accomplish the same goal. Most people and companies can only give so much to so many. In Beverly Hills, we also have been competing against each other. I feel like this is the first year in a long time that the PTAs and BHEF have really tried to join forces to help everybody in this unified school district.

### To what degree would you say BHEF is a liaison between the schools and the community at large?

This is one of our goals, to be more of a liaison between the schools and the community. We really need to re-establish ourselves as the fundraising arm of the district. At my installation speech last June I commented that the Backdraft Ball or Black and White Ball isn't attended by only the parents of the firefighters or police officers. As a community we all recognize their contributions to our community and support them. The schools are and always have been vital to the welfare and success of Beverly Hills. We must, as a community, assure their excellence and central role in this

### You have two children at El Rodeo, and you also were educated in the BHUSD yourself. In your opinion, is the educational product of the Beverly Hills schools comparable to that of competing private schools?

This is tough for me to answer because I have only been in public schools. I can say that I believe my children are receiving the same level of education as their friends in pri-

vate school and that, at El Rodeo, several families who have moved here from schools such as Center for Early Education and Stephen S. Wise have said that they prefer the Beverly Hills schools. I believe that there are immeasurable advantages to public education to a child's future. To me, making sure that public education works throughout the country is the single most important political action we can take as citizens. I am saddened each time I hear of a Beverly Hills resident choosing private schools because I believe our schools are not only good but offer a level of diversity that is crucial to living in the "real world." I understand though that not every environment is right for every child and that sometimes parents need to make choices that involve private education. If [BHUSD] parents would [donate] a small percentage of what they spend in private school, we would have everything and more than what is available in private schools. I know the schools aren't as good now as when I attended and the only real difference is the amount of money coming in the door post-Proposition 13 in California.

#### What is BHEF doing to reach out to younger parents who are new to the district?

It's hard with new parents who have a kid in kindergarten at BV [for example] to convince them that they should think about the entire district. I can tell you though that time goes quickly and before you know it what didn't affect your kid, does. We send a new parent letter and I go to new parent nights at the school. It's really not enough though and I would love a new parent "event" to welcome them and begin talking about some of the reasons why we need to augment a diminishing state budget for public education in our community. Also, we could offer great insight and knowledge about the schools that could be a great asset to new parents.

#### What one thing would you most like to accomplish this year on behalf of BHEF or the BHUSD?

I would love for the Beverly Hills schools to set the standard for excellence in public education and be a role model for other districts to follow. This sounds trite but this is the


