

I want to address an incorrect impression that may have been left with your readers who saw Mr. Horowitz' letter to the editor last week. He writes: "And, yes, again, unless the Board convinces philanthropists in our city to hand over another \$3,500,000.00 our sparkling new Science and Technology building will be empty."

When the Beverly Hills High School Science & Technology Center (STC) opens this Fall, even if we do not raise the \$3.5 million that Mr. Horowitz is referring to, it will be fully furnished and equipped. It will have all the furniture, lab stations, supplies and computer cable drops that you would expect in a modern high school building.

The effort to raise the additional money is to establish an exciting and new standard in the district for technology infrastructure and equipment, and the training necessary to put it to proper use. It is our plan to ultimately use this building as the showpiece and standard for the balance of the district's facilities. The Beverly Hills Education Foundation (not the Board of Education) is spearheading the fundraising effort to show our community what is envisioned and how everyone can participate. Watch your mail for announcements.

At some point in the near future as we approach completion, we expect to declare a cost underrun on the Beverly Vista and High School STC construction projects. This underrun will be used to augment modernization projects at the other three schools-projects which are in the State approval stage and will get underway this summer. Some have suggested that we use this underrun to finance



# Water rate increase proposed

Residents can expect an increase of about 18 percent in utility costs By Amanda Parsons

Beverly Hills City Council will consider increasing the cost of water for citizens during meeting on May 29, if approved the increase will become effective on July 20.

The cost increase would vary per resident based on consumption rates. On average a 6000 square foot lot will pay \$30 extra per month, business will pay an estimated \$114 per month and six unit apartment buildings will pay an estimated \$85 extra per month.

"No one like increased rates and we do not either as consumers and as representatives as the people we are serving," said Shauna Epstein, Beverly Hills environmental utilities manger. "But we feel they are necessary and we try to keep them as low as possible."

The increased fee will go toward capital expenses in providing the city with water. Beverly Hills currently imports 90 percent of its water pre treated from out side of the city. Only 10 percent is local ground water treated at the public works facility. As the cost of fuel, power, and using water rise, the city must look for new ways to pay. Currently the city absorbs these costs to the tune of almost \$7 million a year.

"We have a great deal of water in the underground in the industrial area that goes into the storm drains," said Betty Harris, former public works commissioner. "This water

is usable. We can take that water and put it to our water treatment center to use it. I brought this up to [former deputy city manager] Dan Webster, four years ago. It was determined to be good water then and it is still flowing into the public drain."

According to Epstein the shallow ground water under the city is currently under study.

"We are determining what would be the best use for the water," Epstein said "Would it be best to treat it or use it for irrigation? We are in the evaluation process. Most cities have never used that or done that so we are treading new territory with the regulatory agencies regarding this matter."

The cost of water has already increased by 26 percent compounded since 2002.

Water rates did not increase at all from 1997 to 2002 but the consumer price index increased annually by 2.4 percent, regardless. In 2004 to 2005 a rate restructuring was implemented in Beverly Hills increasing utilities revenue by six percent. The following year an eight percent and twelve percent increase occurred.

The Public Works Commission is inviting the community to meet on May 10 at 8:30 a.m. in Study Room A at 455 North Rexford to express questions and concerns about the issue.

A Draft Environmental Impact Report (DEIR) was prepared for the project and the DEIR was released on Friday, January 6, 2006 for public review and comment pursuant to a notice published on January 6, 2006. A public hearing on the DEIR was held January 21, 2006 and the 45-day comment period ended February 21, 2006. A final Environmental Impact Report has been prepared in connection with this public hearing.

# **Project Description**

The Applicant, Legacy Partners, has proposed to develop a six-story, approximately 70-foot high (including rooftop uses), mixed-use project on the vacant lot at 9200 Wilshire Boulevard between South Maple Drive and South Palm Drive. The project would include 54 residential condominium units; approximately 14,000 square feet of ground-floor commercial space; and, up to 283 parking spaces located in a multi-level subterranean garage. Access to Project parking would be split between Maple Drive (resident parking) and Palm Drive (visitor and commercial parking). The Project's loading facilities would be located on Palm Drive. Approval of the project would be dependent on approval of an overlay zone for this location as the current C-3 zoning does not allow residential use and the Project would exceed the existing three-story/45-foot height limit and 2:1 FAR (Floor Area Ratio) allowed in the C-3 Zone. In addition, approval of the project requires City Council approval of a planned development and a vesting tentative tract map for this mixed use project.

# Overlay Zone Ordinance and General Plan Amendment

The proposed overlay zone was requested by the project applicant. The proposed overlay zone will create an overlay zone to allow mixed use commercial/residential development on Wilshire Boulevard and apply it to the Project site. A General Plan amendment is also required and will allow additional height and density for this mixed use development.

# Council to vote on proposed smoking ban

The City Council Ad Hoc committee will propose a smoking control ordinance to city council Tuesday to propose a new law that will restrict smoking at restaurants and outdoor dining areas adjacent to public sidewalks and some private restaurant outdoor dining areas near walk ways used by the public.

Hotels and hotel restaurants will be exempt from the ordinance because they act as a "home away from home" according to project manager Daniel Cartagena.

The ordinance was originally proposed by Vice Mayor Barry Brucker in response to his wife's negative experience with the inhalation of second-hand smoke from a within a restaurant she was dining in.

If the council accepts the terms of the ordinance, smoking would be prohibited during the summer months, peak tourism season, from July 15 through September 9.

On September 10, the ban will be suspended and the city will review impacts experienced by restaurants and other businesses.

If the council finds a positive impact from the assessment report, the ban would become permanent after December 31.

California law already prohibits smoking indoors, in parks and in city buildings.

# Garrison to plead guilty to vehicular manslaughter

Former "Prison Break" actor Lane Garrison will plead guilty to vehicular manslaughter for a crash that killed 17-year-old Beverly High student Vahagn Setian who was a passenger in his car, Garrison's attorney said Wednesday.

Garrison was driving a 2001 Land Rover that hit a tree at over 50 mph on Dec. 2. Police reported that Garrison had a blood-alcohol level of .20 percent and cocaine in his system. Two 15-year-old girls in the car were also injured.

Garrison's attorney Harland Braun said the guilty plea will be entered May 21 in Superior Court.

Garrison is accused of felony vehicular manslaughter while intoxicated, felony driving under the influence causing injury to multiple victims, felony driving with a blood-alcohol level above the .08 percent legal limit causing injury, and a misdemeanor count of furnishing alcohol to a minor.

The charges carry up to six years and eight months in prison. Garrison remains free on bail. **Diversity Permit deadline extended** 

Following a meeting with civil rights leaders on April 12, Beverly Hills School District officials agreed to extend the deadline for its diversity permit program an additional 13 days, which is expected to increase the number of black and Latino students submitting applications to attend Beverly High.

The application deadline had been April 13, but was extended until April 26 after concerns were raised from civil rights activists during a press conference held at the BHUSD offices.

# Beverly High student awarded scholarship



the technology upgrades that we want to do at the Science & Technology Center. This is a good idea, but state law and the bond measure authorization limits how we can spend bond money for certain types of equipment and services. Our alternative is to spend General Fund money for these improvements. Surely Mr. Horowitz isn't suggesting that we pay for these improvements out of the same fund that we pay teacher salaries?

Mr. Horowitz also refers to a potential bond election and how can we expect community support? At this time there is no proposal for an additional bond. The district is conducting a study of the district's buildings for a Facilities Master Plan. The plan should be completed by

this Fall. The purpose of this plan is to establish a district standard for facilities reflecting today's much higher expectations—the standard which the new building at Beverly Vista and the Science & Technology Center represent. Any request for community funding through a bond will be accompanied by architect's plans for the project; so if a bond is requested and approved, we will be able to promptly issue contracts and immediately see results. It is my personal desire to see that the District is always proactive in providing state-of-the-art facilities for our students.





# Notes on ideas and people in the news

Delshad does well, Zev floats an idea By Rudy Cole

At least he's putting ideas out there designed to do something about our traffic problems, but Supervisor **Zev Yaroslavsky's** proposal to make Olympic, along with Pico Boulevard, one-way streets could have a very negative impact on the south residential streets of Beverly Hills.

Cars coming to or through the city in the opposite peak traffic hours will inevitably use alternate streets through Beverly Hills, causing more traffic on streets, such as Charleville, already clogged much of the day.

However, this needs very careful study by thebest traffic consultants we can find and soon before the Yaroslavsky proposal, now under review by both the county and the City of Los Angeles, becomes a reality. Fortunately, the city has the final word on what happens to Olympic Boulevard and we should reserve final judgment on Yaroslavsky's plan until impacts are professionally considered.

What is lacking here are comprehensive

solutions: Despite all our misgivings about further impacts from local development, the real traffic growth has and will continue to been largement of commercial areas west and east of the city.

Some solutions, and they are indeed regional, are available, if there would only be some political leadership willing to bite some uncomfortable bullets. Mandatory ride sharing, incentives for use of mass transit, especially for all those people who work in the high rises in Century City, Westwood and the Wilshire corridor, and restrictions on single passenger cars are doable and have worked elsewhere. But none of this will work unless we apply regional traffic control, or calming, as the experts call it, to our congestion woes.

Credit Yaroslavsky for putting an idea on the table. Now let's use our coalition of local governments to finally do more than just bemoan grid lock. While we are at it, a ride sharing program for the high school is something we should make happen all by ourselves. Incidentally, we had heard Zev was not pursuing this one-way idea, but it is going forward.

\*\*\*

There are some cultural gems in our community, one with a long history of theatrical success sand another that will soon make us proud.

Theatre Forty is our on-going gift to play going and the Annenberg Cultural Center will soon be a long-awaited reality.

First, Theatre Forty. Carved out of some very unusual space at the Beverly High School, in a theatre named for the late, great **Reuben Cordova**, a school administrator and community leader and now helped by the ever optimistic **Lya Cordova-Latta**, Theatre Forty has given us many years of stage productions that have not, unfortunately, yet reached the broad community support it merits. Put another way, more of us need to support and attend their productions. It is a pleasure waiting to serve.

Now under the creative leadership of **David Hunt Stafford** and a dedicated volunteer board of community leaders, Theatre Forty actually began in Los Angeles in the mid-1960s and moved to its present space in 1974. 

# COVERSTORY COUNCIL KIDS: PART IV

# How do former city council and board members live on once they're out of the public spotlight?

Two years ago the Weekly began its "Council Kids" series, where we tracked down the children of former city council and Board of Education members from the 1960's through the 1980's. In Part I [issue #279], we profiled those children and grandchildren of former Board of Education members Bernice Hutter and Louis Teitler and former Mayors Ben Stansbury and George Slaff. In Part II [issue #284], former Board members Dana Tomarken, Ruth Bard, Elinor Nathan, Bernie Grenell and Max Factor III. For Part III [issue #335] the Weekly looked at former mayors at Phyllis Seaton, David Tannenbaum and former Board of Education member Florence Thalheimer.

Through their stories we learned the impact their parents' public service had on their adult lives.

Back by popular demand, the weekly continues to track down the children and grand-children of Beverly Hills elected officials from the 1950's and 1960's. This week we profile the children and grandchildren of former City Council member Leonard K. Firestone and former Board of Education member Ernest Ach.



Brooks Firestone Santa Barbara, CA Son of Leonard K. Firestone, Beverly Hills city councilmember, 1953-1957

Working in politics is a family tradition for Brooks Firestone. He is the son of the late Leonard K. Firestone, a Beverly Hills City Councilmember from 1953-1957, and currently holds a seat as the Third District Supervisor for Santa Barbara County.

Firestone grew up in Beverly Hills but went to boarding school in Pomona, graduating from the Webb School in 1954. Because he was away at school during the

majority of his father's stint in public office, he doesn't believe the fact his father was on the city council affected him at all.

"I remember he would rattle me down to vote, which I did when I was 21," said the now 70-year-old Firestone.

Firestone doesn't recall any particularly controversial issues of real merit while his father was office

"People weren't storming City Hall; it was a very benign time," he said.

Firestone remembers his father's relationship with major political influencers at of the time including Eisenhower, Nixon, Bush Sr. and President Ford. In fact, Leonard Firestone's relationship with certain US presidents that helped found the Betty Ford Clinic in Palm Desert with Gerald Ford and celebrated his 75th birthday in the White House with George H.W. Bush.

Firestone left Beverly Hills to attend college on the East coast. He graduated from Columbia University in 1961.

"I guess I was the typical teenage high school graduate," he said. "I wanted to get as far away from home and do my own thing. And New York is a long way from Los Angeles."

Firestone later worked as Director for his grandfather Harvey Firestone's Firestone Tire and Rubber Company in London for 12 years before leaving for the Santa Ynez Valley to join forces with his father in the wine business.

He and his wife Kate moved their young family to the Santa Ynez Valley in 1972 where they established the San Antonio Ranch and the Firestone Vineyard.

"I am the classic executive dropout," Firestone said. "I spent 12 years in the tire business, and I finally decided my soul wasn't there."

For two terms (1994 - 1998) Firestone served as a Republican member of the State Assembly, representing the 35th District. He has four children a teacher, a

lawyer, a wine man and an actor. Andrew Firestone, his son, was "The Bachelor" on ABC's third installment of the hit reality show. Thus far, none of his children have expressed interest in running for office.

Looking back on his father, Brooks mentioned he was never into Beverly Hills' politics before joining the Santa Barbara State Assembly. And his fathers influence on his decision to join local politics he admits is very little.

"I believe in public office I believe that private people should be involved," he said. I suppose that my father's involvement in public affairs had something to do with it but not much. I ran because no one else would in the Assembly."

"I was proud of him for doing it," Firestone said. "I think he was a person of good judgment who had no agenda, but good government."



Peggy Ach Hansen Pacific Grove, CA Daughter of Ernest Ach, Board of Education member, 1957-1969

Peggy Ach Hansen will be visiting Beverly Hills from her home in Pacific Grove, Monterey County this weekend to celebrate a very special occasion, her father, Earnest Ach, is turning 95 on Saturday.

Ernest Ach served on the Beverly Hills Board of Education for twelve years, handing high school diplomas to both of his sons while he served on the board.

Although by the time her father was elected Hansen had already graduated Beverly High, Hansen acknowledges her family's strong ties to public service.

"I don't know if it was his idea or someone talked him into it, but he had always wanted to run for the school board," Hanson said of her father. "That's

because his role model was his grandfather. His grandfather served on the school board in Cincinnati where he grew up. He was such a good community leader that they named a school after him in there."

Indeed the influence fathers have on their children in the Ach family is reflected back by Ach's effect on his daughter. Hanson dedicated her life to public service and believes that her decision was based on the example set by her father.

"He absolutely influenced me in a lot of ways," she said. "I learned the importance of giving back to the community and I think it was during that time that I made the subconscious decision to devote myself to other people."

Hansen is a retired elementary school teacher, administrator for non-profit organizations, and a grandmother of four.

"Both of my careers were definitely deeply influenced by him and turned out to be deeply satisfying careers," Hansen said. "I loved them both. Since retirement I continue to be a community volunteer for the League of Women Voters, the property owners association where she lives and a literacy tutoring organization. But right now my most satisfying job is as a hospice volunteer. I owe all of it, all of it, to my father. He is a great man."

She also attributes her morality to her father based on decisions he made while on the Board.

"He had to make some controversial decisions but he always made the morally correct choice even though it may have been unpopular," she said. "That is when I got to really realize what a morally correct decision was. I was proud and amazed."

Hansen has two brothers, Jim and Larry. Jim Ach is currently a retired computer programmer living in Marina Del Rey who loves to sail and Larry Ach lives in Manhattan where he works in the investment business, just like his father almost 40 years ago.


"Our lives [hers and her brothers'] are really different but we remain close and the one thing that keeps us so close is how much we adore our father," Hansen said. "Just because of who he is and the way he lives his life. With integrity. He always has a smile on his lips and a tune in his heart.

Ernest still lives in the home he purchased with his late wife 60 years ago in Beverly Hills. He volunteers with the Friends of the Beverly Hills Public Library and has recently signed on as a volunteer at Cedars Sinai Hospital in Los Angeles.
