

# Lane Garrison pleads guilty to vehicular manslaughter

Actor to be sentenced for the death of Beverly High Student By Abbey Hood

L a s t
December,
"The Prison
Break" televi-

sion star injured two 15-year-old females and killed 17-year-old Beverly High senior Vahagn Setian, after crashing his Land Rover into a tree in Beverly Hills. Garrison's blood alcohol level was twice the legal limit said prosecutors. He was also under the influence of cocaine.

"[Garrison] said why should I fight something that is true?" said Garrison's attorney Harland Braun.

Criminal defense attorney Ronald Richards, who is not affiliated with the case, said it was too early for Garrison to enter the plea before testing the evidence.

"This will give him good will," said Richards. But "He should have got a 90-day diagnostic."

According to Richards, the plea will not alleviate the sentencing.

"The Court will judge based on the factor set forth by the legislature," said Richards.

Garrison said he is ready to accept the consequences of his sentencing scheduled for August 2, said Braun.

Superior Court Judge Elden Fox will decide if Garrison will spend the maximum time in prison, six years and eight months, for the crime.

"Garrison most likely will not get the max-

imum time," Richards said.

This is because Garrison does not have a prior record and had an early acceptance of responsibility said Richards.

"He might spend a year in county jail, or

three years in state prison, where he will serve half the time," said Richards.

#### **NOTICE OF PUBLIC HEARING**

The City Council of the City of Beverly Hills, at its regular meeting to be held on **Tuesday, May 29, 2007 at 7:30pm**, in the Council Chambers at City Hall 455 N. Rexford Drive, Beverly Hills California, will hold a public hearing to consider adoption of:

AN ORDINANCE OF THE COUNCIL OF THE CITY OF BEVERLY HILLS AMENDING THE COMPREHENSIVE SCHEDULE OF TAXES, FEES AND CHARGES TO ADJUST UTILITY RATES FOR FISCAL YEAR 2007/2008.

The proposed Ordinance will amend the City's current utility rates to increase the rates charged for water service, wastewater (sewer) service, and solid waste (refuse) service to offset additional operating and capital expenditures incurred by the City.

The City of Beverly Hills is proposing to increase utility rates later this year so that it can continue to provide reliable and high quality service in the face of rising costs. The increases include water, sewer, and solid waste utilities, and are necessary to maintain a high level of service, invest in maintenance and replacement of aging infrastructure, and maintain adequate reserves in case of emergency.

The City of Beverly Hills is proposing the increases because of rising construction, power, and fuel costs; to maintain the City's infrastructure; and to be prepared for emergencies such as earthquakes and their aftermath.

Costs continue to rise rapidly, including the amount the City pays for water from the Metropolitan Water District, fuel costs for trash trucks, and improvements in water and sewer lines to keep them safe and reliable

The rate increases are similar to those in nearby cities, and are based on the guidance of utility experts who have thoroughly researched the City's current and long-term needs

Absorbing cost increases and deferring maintenance is not an option; the City is required to ensure that rates keep up with costs and that facilities are well-maintained and reliable

At the public hearing, the City Council will hear and consider all objections or protests to the proposed ordinance and report.

If the Council adopts the proposed ordinance, the new rates will become effective on bills prepared after Friday, July 20, 2007.

Copies of the proposed ordinance are available for review or purchase in the Office of the City Clerk, Room 190 at 455 N. Rexford Drive, Beverly Hills, California. Any interested person may attend the meeting and be heard. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, California, 90210. The comments should be received prior to the hearing date.

Please remember, if you challenge the Council's action in regard to this matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.



## A Wish List for Beverly Hills

We look at some possible improvements By Rudy Cole

What could we do to make our city more livable? Not really bad, as it is, probably one of the safest, best managed, attractive places to live in the world, but not quite perfect.

Since so many wonderful ideas were floated around coffee hours during the recent City Council election, I thought it might be helpful to bring some back and add a few of my own. We know politicians keep their promises.

Some urgent priorities. In one of those major goofs in drawing city maps, a tract feet from our borders and adjacent to our high school, is being primed for some development project. Not yet announced, but we hear the proposal could mean a structure over 16 floors, dwarfing its neighbors to the east, including one of our leading hotels, The Peninsula, and creating major traffic at one of our most congested intersections – think one- student cars going to the high school.

It could even be a hotel, and imagine how that would effect our bed tax revenues. The Four Seasons on Doheny proclaims it is "at" Beverly Hills and pays taxes to Los Angeles. If a hotel sprouts here it will say "on" Beverly Hills without exaggerating.

What to do? A regional planning agency that permits our city to impact zoning on our borders. How crazy is it to prevent revenue producing projects and residential inventory increases in our own city when much larger, more intrusive "improvements" are created all around us? In the meantime, our council needs to be very pro-active in watching any proposal being considered by Los Angeles.

Some not good ideas that need early intervention: Making Olympic and Pico one-way streets could make through traffic easier, but it would also divert cars to our residential streets and limit our own mobility.

Widening Santa Monica. Same theory, a way to make the street more accessible for people going through Beverly Hills. Same reasons to oppose: More inter-area traffic with obvious impacts on residences, parks and churches. Remember, all the candidates, including the winners, promised to prevent widening.

Unfinished promises: Return of two-hour free parking. Somehow, this has again been put deep into the to- do basket. Yes, there are issues including in and out users who are not shoppers, and money to make improvement in the lots, but the loss of two hour free does bug shoppers and nearby merchants. Although our parking structures are monuments to irrational design and dysfunction, we do desperately need more, especially in the South and on Robertson Boulevard.

More traffic ideas: Actually, compared to other cities, ours isn't, and don't jump at your email response button yet, as bad as we proclaim. Peak hour traffic on Wilshire and Olympic, our two most traveled streets, has not, to this unprofessional observer, increased that much, at least cars that leave those streets to enter Beverly Hills. Traffic control officers at a West Olympic intersection also seem to have improved movement.

What can we do? It takes some leader-

ship, imagination and cooperation with our neighbors too, but we can make ride sharing and mass transit use attractive to our own businesses and those surrounding us. Some radical approaches, including permits for single car trips, are used successfully in many countries, but we can begin by giving incentives to ride sharing and mass transit. It's amazing that this has not been tried.

In our own city, we can do ride sharing and mass transit programs, but we can also encourage and facilitate parking at out of business district parking structures by providing improved shuttle services. The La Cienega building could accommodate hundreds of additional vehicles. As for employees parking on our streets or using parking structures, what would we do without these people? How much would our economy suffer? So, create workable alternatives.

Recreation Center: It may have been a good idea, but it was dead before arrival because it was, as too often happens, proclaimed and presented before soundings were made in the community. Silent throughout the studies and meetings were possible users or, if they were heard, it never resonated in the community. Actually, the idea of a center paid by a limited development project was imaginative, just never properly explained.

Do we need expanded recreational facilities? I feel we do and the movement to make major improvements at Roxbury and La Cienega may be a viable alternative to



a Sports Center, which is no longer a reality. While I understand some of the reasons for opposing the Sports Center and some early reactions to a far too ambitious plan for Roxbury, I am ashamed of some of the bigotry this unleashed by a very few in our city. Its one thing to have reasonable concerns about "gangs" and quite another to punish our own community by irrational and prejudicial fears of "outsiders" using our parks.

Have we forgotten our own victimization from this same kind of blind hatred? Most of us, I am sure, have not.

Where to put culture on a priority list? Should be near the top. The plan for a performance art center at the Post Office is progressing and should have a united community's enthusiastic support. At some point, bringing the miraculous Theatre Forty and a revitalized Beverly Hills Symphony into the program need to be explored.

General Plan. We've been at this process, adopting a new plan, for years now, and there have been reviews by both the City Council and the planning commission, separately and at a joint meeting. The council needs to bring the community an update on progress and the city should make every effort to re-involve all the legitimate community groups before a final adoption is voted. Don't look now, but the look and feel of our city could be impacted for many generations.

I've left out our city's involvement in a proposed downtown to the ocean subway plan, because I still have too many mixed feelings and no absolute opinion, just reservations on impacts and a lack of study on future development around us.

The subway, is a project dear to the heart of our resident visionary, Former Mayor Allan Alexander. But Allan has also taken the lead on a project I can support without any hesitancy: A close circuit television system to enhance police services. This is not some "Big Brother" intrusion on our privacy, but it is a technological tool that will make us much safer and more protected

Finally, a trip into Utopia. This one needs a slogan: Mr. and Mrs. School Board Member, "tear down that high school." Hold on, this was not an idea I can claim, it came from a very thoughtful study committee chaired by Southwest Beverly Hills Homeowner President **Ken Goldman**, hardly a friend of commercialization. His committee made a surprising recommendation, some years back: Tear down the historic school, sell the property and use the funds to build a modern, functional school elsewhere, probably in the Industrial Area.

The high school is not a community jewel. The buildings are far too spread out, too aging to even come close to providing a physical facility that matches our educational needs.

Now, indeed, may be the time to give this a serious look. The economy is still in a positive mode, the district has good administrative leadership and the problems of waste and mismanagement and delays that plagued recent improvements can be avoided. It would require a major bond commitment and voter approval, but the time to give this serious thought is now.

A word about priorities. One council member said at a recent council meeting that he and a colleague had spent "hundreds of hours" on the proposed ban on outdoor dining area smoking. Is that really the most important issue facing Western civilization or even Beverly Hills? Maybe a few minutes on two hour free, a new parking facility, closed circuit tv, a traffic management plan and moving along the general plan would also warrant some attention.

Seriously, I don't doubt the sincerity of those who want to send a message by banning smoking in outdoor areas. Its simply not appropriate to try these experiments in Beverly Hills alone. Want to stop smoking everywhere? Do it at the state level. As for the health issues, ask your own physician if second hand smoke in outdoor areas is really a health hazard.

Final thoughts: If resumes count, New Mexico Governor **Bill Richardson** should be a leading candidate for president. More than that, the former congressman, cabinet member and ambassador to the United Nations is a unifier, not a divider. His experience, wit and balanced view on our country's needs will make the primary races more interesting, at least.

### BHHS Boys' Tennis Team Wins Quarterfinal In Rout

Beverly High won all nine singles sets in a 15-3 victory over Long Beach Wilson in a Southern Section Division III boys' tennis quarterfinal May 15 at Long Beach Wilson.

Daniel Ho, the Normans' No. 1 player, won 6-1, 6-0, and then was replaced by Brent Kaplan, a 6-1 winner in his only set.

Gary Parizher, Beverly Hills' No. 2 player, won 6-0, 6-0, 6-2, while David Vayzner won 6-0, 6-3, 6-0 at No. 3 singles.

The Normans' No. 1 doubles team of Ethan Bond and Uday Singh was a 6-1, 6-1 winner before being replaced by substitutes. The Igor Fedonenko-Peter Yoon doubles team won two of three sets for top-seeded Beverly Hills (19-5). The Benjamin Gabbay-Andre Herd team won one of two sets for the Normans, while their replacements, Ben Haber and Daniel Levy, were 6-2 winners in their only set.

#### **Pioneer League Finals**

Ho defeated Parizher, 6-1, 6-2, in the singles final May 2, while the Bond-Singh team defeated Fedonenko and Vayzner, 6-2, 6-2, in the doubles final, May 4, both at Beverly Hills.



# THE MAN WITH THE PLAN

#### The Weekly's exclusive interview with newly appointed Community Development Director Vince Bertoni

Two years Vince ago. Bertoni started in Beverly Hills as city planner. In recent weeks, Northern California native formally appointed to fill Mahdi Aluzri's shoes as the director of community development. The 19year veteran of planning city has worked in Malibu, Rancho Cucamonga, Redlands and Santa Clarita.

### Tell us, how does the planning director interact with the Planning Commission?

The Community Development Director is the lead staff member to the Planning Commission and advises the Commission on matters related to zoning and land use for the city.

#### What do you hope the two newly appointed planning commissioners will bring to the commission?

We have two exceptionally bright and talented new planning commissioners with extensive volunteer experience in the community. My hope is that they bring their unique viewpoints from their community activities to help guide zoning and land use policies for the city that balance the city's needs for a healthy business community with the needs of maintaining a high quality of life in our residential neighborhoods.

#### What is it like following in Mahdi Aluzri's footsteps?

I definitely have big shoes to fill. Mahdi was an exceptional director who understood all aspects of community development and had wonderful relationships with city staff and the community. Those people, who know Mahdi well, will also tell you that he is a hard worker and a lot of fun to work with.

#### How do you differ from Mahdi?

Mahdi had a strong background in the portion of our department that deals with building and safety and is one of the most talented people I know when it comes

to dealing with development projects. My background has focused more on land use policy and long-range planning, such as developing general plans and housing policies for cities.

#### What projects did you work on together?

We worked together on the General Plan, the update of the plan for the Entertainment Business District [formerly known as the Industrial Area], as well as a variety of development projects in the City.

#### What are the biggest projects in the pipeline?

The relocation of the William Morris headquarters to Beverly Dr. and Dayton, redevelopment of 9900 Wilshire Blvd. [the former Robinsons-May Department store site], expansion of the Beverly Hilton Hotel, Residences at Saks Fifth Avenue [next to Barney's Department store], and the Gateway project which are the former railroad right-of-way properties at Wilshire and Santa Monica Blvd.

#### What is the estimated time line for the projects?

These projects all have different timelines. They are all undergoing rigorous environmental review under the California Environmental Quality Act and will have environmental impact reports prepared. The reports will not be released until they have met the city's high standards and I expect these projects to be brought before the City Council over the next year. Also, each of these projects will have extensive public comments.

#### What is the status of the general plan?

The city is currently studying the impacts of potential scenarios for land use in the city to determine their environmental impacts and we anticipate that we will be providing this information to our Planning Commission and City Council later this fall. We expect to have the General Plan completed by next spring.

#### What are your personal goals for the general plan?

I hope that the General Plan is a forward-looking, visionary document that takes into account the needs of the city to be economically healthy over the next 20-30 years and maintains the unique quality of life for our residents. Also, I hope that the General Plan is able to balance the various needs of the community and that we can make sure that everyone's voice is heard throughout the process.


Mahdi had commented in the Weekly [Issue #377], that there has been an "inclusive approach to the general plan" and the external communications need to be improved, have you worked toward this

#### goal? If so how?

We have gone out to each of the neighborhoods in the city and held a series of community meetings to hear from our residents and business owners on issues that matter most to them about the General Plan. We will continue to be proactive to reach out to the various parts of the community and look for ways that we can engage our residents as much as possible.

#### What is the most enjoyable part of the position?

Beverly Hills is a wonderful and unique community to work for and I am excited to be able to play a role in insuring that Beverly Hills maintains its unique qualities and characteristics for future generations to enjoy.



HEREBY ORDAINS AS FOLLOWS:

The City Council finds that the City has seen a rise in juvenile crime and disruptive behavior in public areas during daytime
hours by students who are required to be in school. Creation of
a new offense for daytime loitering by truant students would

a new offense for daytime loitering by truant students would address this issue.

For many years the City of Beverly Hills has had a nighttime curfew for juveniles in order to protect the community from juvenile crime and also to reduce juvenile victimization. The experience of many communities supports the value of such a curfew. The City Council finds that the nighttime curfew ordinance should be updated to reflect the most recent judicial decisions concerning nighttime curfews and to integrate the nighttime curfew with the daytime loitering ordinance.

The title of Article 2 of Chapter 6 of Title 5 of the Beverly Hills Municipal Code is hereby amended to read as follows:


