

At the City Council meeting of September 19, 2006, the City Council of the City of Beverly Hills considered an appeal of the Planning Commission's denial of a general plan amendment to allow a mixed use development project on the vacant lot at 8600 Wilshire Boulevard at the southwest corner of Wilshire Boulevard and Stanley Drive and extending southerly to Charleville Boulevard (the "Project Site"). The City Council approved in concept a mixed use development for the Project Site, and remanded the matter to the Planning Commission for additional input on the specifics of the project. At its meeting on Tuesday, June 19, 2007, the City Council will hold a public hearing beginning at 7:30 p.m., or as soon thereafter as the matter may be heard, to consider the actions set forth in this notice related to the proposed development at 8600 Wilshire Boulevard ("Project"). The discussion on June 19, 2007 will focus on the remaining issues presented by the Project.

A Draft Environmental Impact Report ("DEIR") was prepared for the project and the DEIR was released on April 17, 2006 for a 45-day public review and comment period pursuant to the California Environmental Quality Act. A public hearing on the DEIR was held on April 27, 2006. A final Environmental Impact Report has been prepared in connection with this public hearing.

### Project Description

The Applicant, Wilshire Colonial Partners, LLC, has proposed to develop a five-story, maximum 61foot high (including rooftop uses), mixed-use project on the vacant lot at 8600 Wilshire Boulevard. The project would include a maximum of 25 residential condominium units; 6,383 square feet of ground-floor commercial space; and, up to 97 parking spaces located in a multi-level subterranean garage. Access to Project parking would be from Stanley Drive. The Project's loading facilities would be located on the site off of, and accessed from Stanley Drive. Approval of the project would be dependent on approval of a general plan amendment and an overlay zone for this location because the current C-3 zoning does not allow residential use; the current R-1 portion of the site would not allow multiple dwelling units; and the Project would exceed the existing three-story/45foot height limit and FAR (Floor Area Ratio) allowed in the C-3 and/or R-1 Zone. In addition, approval of the project requires City Council approval of a planned development permit, a vesting tentative tract map, and a development agreement for this mixed use project. The Planning Commission recommended approval of the Project subject to conditions of approval that would require significant modifications to the Project as proposed by the Applicant. The Planning Commission's recommendations will be presented to the City Council at the public hearing.

### **Overlay Zone Ordinance and General Plan Amendment**

The proposed overlay zone was requested by the project applicant. The proposed overlay zone would create an overlay zone to allow mixed use commercial/residential development on this segment of Wilshire Boulevard and apply it to the Project site. A General Plan amendment is also required and would allow additional height and density for this mixed use development.

All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210 and should be received prior to the public hearing.

Please remember, if you challenge the Council's action in court, you may be limited to raising only those issues you or someone else raised at the hearing before the City Council or in written correspondence delivered to the City, either at or prior to the hearing.


"Although he is out of the classroom, we are still using his skills as an educator," said Millan.

### BHHS Alumnus Signs With Major League Team

Norman football team playing host to tournament Saturday. By Steven Herbert

Joe Rocchio, a 2003 Beverly High graduate, is expected to learn Sunday where he will begin his professional baseball career.

A right-handed pitcher, Rocchio was chosen by the Philadelphia Phillies in the 10th round of Major League Baseball's First-Year Player Draft Friday, the 323rd selection overall, signed with the National League team Monday, then reported to its spring training base in Clearwater, Fla. for a minicamp.

Rocchio said he expected to be assigned to either Philadelphia's Class-A South Atlantic League affiliate in Lakewood, N.J. or its Short-Season Class-A New York-Penn League affiliate in Williamsport, Pa.

Rocchio said he was "very excited" to be drafted and did not have a preference about the team selecting him.

Tim Kissner, the Phillies' area scout who recommended that Rocchio be drafted, said he had scouted him since his sophomore season at Cal State Northridge and was

impressed by his arm strength.

"He throws rather hard," Kissner said.

Rocchio played four seasons for the Matadors, and was second in school history in games pitched with 85 and third in career saves with 10.

Rocchio was 2-8 with three saves and a 5.25 earned run average this season. His 60 strikeouts, 13 starts and 85 2/3 innings were all team highs.

Rocchio's 2007 won-loss record is deceiving, Kissner said.

"Wins and losses depend on the team," Kissner said. "His stats weren't the best, but he has ability."

Rocchio was shifted from being Northridge's closer to a starter midway through the season because the struggling team had very few save situations. He will be used as a reliever in the Philadelphia organization, Kissner said.

Returning to a relief role will be beneficial to Rocchio, Kissner said.

Rocchio will also benefit from not having to pitch to players using aluminum bats, as he did in college. Aluminum bats give hitters several advantages, Kissner said.

"Once he starts facing players with wood bats, you'll see very good things from him," said Kissner, who said he was "very optimistic" about Rocchio's chances of reaching the major leagues.

Rocchio said he will have to work hard to become the third Beverly High alumnus to reach the major leagues, following pitcher Ryan Karp and designated hitter Ken Harvey.

"Every day you have to get better," said Rocchio, whose mother Elaine and sister Natalie are both teachers at Beverly Vista School. "If you don't, that's when you fail."

Rocchio said he will return to Northridge during the off-season to complete the final

16 units he needs for his business administration degree.


### Football

But will they return your call? By Rudy Cole

Compared to some of the other projects in the pipe line, the William Morris plan to build a new home office on North Beverly Drive has almost been as mysterious as a Soprano's final episode.

There has been little or no mammoth community outreach, no highly publicized public meetings or receptions and no full page ads in the community press extolling the virtues of a planned development that could bring more traffic and density to the business triangle than the Montage Hotel and Gardens, and we know how much contention that brought to the city.

Of course, we begin with the obvious: We want to keep William Morris and all those going-tolunch, hungry agents in Beverly Hills. We have lost CAA and ICM to Century City and to lose our oldest talent group would be a significant blow to our economy.

Also, William Morris has been a fairly good corporate citizen. In more recent years they have been supportive of community organizations, including the Beverly Hills Education Foundation. (Not quite so civic minded are all those agency workers who constantly ignore jaywalking laws on El Camino as they rush from their west to east office buildings and back. The intersection is only feet away.)

William Morris, in recent times, has had two major expansions during their tenancy in Beverly Hills, one addition on El Camino and the other on Rodeo displacing what was once our most famous restaurant, Romanoff's, and later a supper club. Their entitlements then as now carried the argument that we must keep them in the city.

A side issue, which has nothing really to do with the merits of their proposal, is the role of former Mayor **Mark Egerman**. His taking on William Morris as a client triggered the push for a more encompassing ethics ordinance. Egerman left the Council and it seemed he was back representing development clients within minutes. He became the poster boy for ethics reform ordinances pushed by now Vice Mayor **Barry Brucker**.

Egerman did nothing illegal, the then ordinances did not inhibit his ability to represent William Morris or anyone else, and he is not the only former mayor to rep builders, including some non-lawyers such as, amazingly, Les Bronte. There are even some reasonably valid arguments that former councilmembers help bring more reasonable and rational projects to the table by knowing what is realistic and what is too ambitious or pervasive.

In fact, it was Egerman's squeaky clean image that gave much credibility to the Montage project which he strongly supported as mayor.

That issue aside, there is a far more important consideration involved in the Morris proposal:

What assurance does the city have that the agency will actually stay here and that at some future time the building will not become another office structure, leasing to less economically beneficial tenants? What if they want to convert to medical later, pleading for exemptions of the more demanding parking requirements? How much of the 210,000! square feet will actually be for agency uses?

There is a possible remedy and one the city should very carefully consider: The agency should be required to provide a long-term bond assuring that they will remain at this location and in the city. Failing this, the project should not be approved.

### \*\*\*

Something most of us never considered was that the city itself would become one of the largest owners of commercial property in the community. The inventory includes not only the civic center, large parcels in what was the Industrial Area, but straight commercial properties around the

### Triangle.

Did you know the city leases to a Rite Aid, a newsstand, a food market, our only hardware store and at least one major restaurant? Thanks to the forward looking efforts of past City Councils, this property ownership and management is a major source of city revenues, when the system works.

Under the direction of City Manager **Rod Wood**, the city made a wise decision and hired a highly trained expert on commercial renting and that already seems to have paid off with the leasing of space for a high end restaurant on the former T Lot, next to the Montage.

Being economically productive is and should be the primary concern of the city acting as property owner, but not entirely. The leasing criteria should also encompass demands and needs not easily attained in the private sector.

Example: The loss of Dutton's. Clearly, a private property owner has no obligation to examine community interests when signing a commercial lease – the market determines the rental. The bookstore was brought to the D Lot because high rents made a Dutton's, or any bookstore, unlikely anywhere in the triangle. Acquiring a bookstore was one of the arguments most heard when the city proposed developing the D Lot.

Dutton's left under cloudy and difficult circumstances. Dutton's argues that the city did not even try to understand their problems and the city responds that not paying the rent was not acceptable, even for a bookstore. Whatever the merits of the dispute, and both the city and Dutton's have made their reasons for the loss very clear if conflicting, the broader issue continues: Revenue yes, community needs too, including a bookstore.

We want a neighborhood type market on North Crescent and the city has made "adjustments" so that the Beverly Hills Market can survive. The

rent the city receives for the next door hardware store. Pioneer and Lucerne, may also not be at market value, but it too serves a city demand.

Now the same area has lost one of its few remaining barbers, replaced by a hair stylist. The local barber was a Beverly Hills institution, cutting men's hair without any pretense or costs of "styling" and the customers were loyal and many. Now gone, shall we say scalped by the city?

My father tried to teach me a good rule of life: Never criticize anyone's work unless you are willing to trade places. But my father never shopped at Rite Aid or K-mart.
