




Roxbury Park Master Plan leans towards "Plan B"

Recreation and Parks Commission prefers one out of three proposals By Abbey Hood

The Recreation and Parks Commission preferred one of three plans proposed for the Roxbury Park's Master Plan at the June 26 meeting, but will hold a public hearing August 1 to present changes to the plan, said Recreation and Parks Deputy Director Pat Agnitch.

"Based on the feedback we were getting from the user groups, we are leaning more towards Plan B," said Recreation and Parks Chairperson Michael Blumenfeld. "But, we have absolutely nothing set in stone. We are still in the stages of meeting with people. We had a lot of good feedback, positive and negative at the last meeting. We are a commission put together for the city to listen to the city. If I was a gambling man I would not put money on anything- I would not know where to put the money because there is nothing in concrete."

After a year of meetings with neighbors and stakeholders, sending out surveys and developing master plans A, B and C, the Recreation and Parks Commission have ruled out Plans A and C. Previously, Plan A was presented to the commission last February, but was almost immediately ruled out because it had two different versions of the community center's location. Both locations were opposed by the community. Plan A also included an aquatics facility, that is not listed in Plan B.

Plan C was ruled out because Plan "C" featured the community center at the corner of Olympic and Roxbury Drives. "The commission and those that we heard from in the community preferred the Community Center to remain in approximately the same area as the

existing center," said Agnitch. "Another consideration for placement of recreational elements are two storm drains that dissect the park. Buildings cannot be built over top of the storm drains so the consultant had to work around them."

Plan B was preferred by the commission to be further looked into and will make minor changes to be presented in a public hearing scheduled for August Roxbury Park 1, said Agnitch.

Currently Plan B proposes to the commission for review: a community building of 27,000 sq ft. A picnic table on the concrete slab. Sand volleyball courts. A full basketball court and half court basketball court will be in the community center. Four lit tennis courts above to parking structures will be added as well as a tennis court warm up wall.

The lawn bowling green and croquet green have been eliminated from the conceptual designs due to low use and high maintenance costs. During the recent stakeholder meetings, the issue was raised about retaining one green which could be shared by both clubs. The con-

sultant is adding a scaled-to-size "overlay" on the Roxbury conceptual design to depict possible locations if the Commission decides to retain a green, said Agnitch.

A baseball field and two soccer fields were also included in Plan B. A children's water play area would be included. Various items including a rose garden and fountain were also listed in Plan B.

'The Southwest Beverly Hills Homeowners Association certainly prefers Plan B to the original plan," said Ken Goldman. "The commission and staff have made substantial steps to

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING REGULA-TIONS GOVERNING WOOD ROOF COVERING REQUIREMENTS, AMEND-ING THE BEVERLY HILLS MUNICIPAL CODE

This ordinance amends provisions of the California Building Code as adopted by the City as set forth in Beverly Hills Municipal Code Section 9-1-202. The ordinance prohibits the use of wood as a roof covering material. The ordinance is intended to reduce the risk of homes and other structures from being destroyed in a wildfire.

This project was assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. It has been determined that the proposed ordinance is exempt from CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210 and should be received prior to the public hearing.

Please remember, if you challenge the Council's action in court, you may be limited to raising only those issues you or someone else has raised at the hearing before the City Council or in written correspondence delivered to the City, either at or prior to the hearing.

Two people arrested for April home invasion case

Two people were arrested and charged on June 22 for an April Beverly Hills' home invasion case; the suspects are accused of entering the victim's home as he slept, attacking and threatening him with a weapon and robbing the home.

Jessica Cano, former employee of the victim, and her boyfriend Juan Romero, were arrested and charged for first degree residential robbery, assault with a deadly weapon, false imprisonment and kidnapping.

"During the course of the investigation, our detectives were able to identify the suspects and determine they knew the victim prior to the robbery," said Police Lt. Mitch McCann.

Beverly Hills SWAT officers and detectives searched the home of Cano where they found some of the victim's property.

"Due to the tireless and dedicated work of our detectives, the suspects were later located and ultimately arrested safely thanks to the outstanding tactics and professionalism utilized by our SWAT team," said McCann.



Galer to play for Brown Bears

Allison Galer, a Beverly High 2007 graduate was recruited to play for the Brown University Bears.

Galer, a four-year varsity starter and two-year team cap-

tain, averaged 19.6 points and 7.8 rebounds per game at Beverly. She was her team's most valuable player for four years, and earned Second Team Ocean League in 2003 and 2004. Galer also earned First Team honors in 2005 and 2006. Galer was an All-CIF Selection and a California All-State team nominee.

"Ali has passion to play," said Bears Head Coach Jean Marie Burr. "She is an aggressive guard that has three-point range and also can drive to the basket."

Galer was also featured in the Weekly's Issue 403 as a third- generation Beverly High graduate.

Local voicemail service bureau to provide local phone service

The Telephone Connection (TTC), a telecommunications company based in Beverly Hills, will install a new switch to provide local phone service to Beverly Hills' residents beginning the first quarter in 2008.

Joe Rocchio, a 2003 Beverly High graduate, recorded the first hold of his professional baseball career Saturday, pitching 1 1/3 innings of shutout relief in the Williamsport (Pa.) Crosscutters' 2-0 victory over the Auburn (N.Y.) Doubledays in a Short-Season Class-A New York-Penn League game at Williamsport.

Rocchio, the Philadelphia Phillies' 10th round choice in Major League Baseball's First-Year Player Draft June 8, entered the game against the Toronto Blue Jays' affiliate at the start of the eighth inning and walked the first batter he faced, Luis Sanchez.

Darin Mastroianni followed with a bunt single, but Rocchio pitched out of the jam, getting Adam Calderone to hit into a force out and ending the inning on a double play ball hit by Baron Frost.

Rocchio retired the first batter he faced in the ninth, then walked pinch hitters Paul Franko and Benjamin Zeskind. Matt German relieved Rocchio and got Jonathan Arencibia to ground out and Leance Soto to strike out to end the game.

Rocchio has pitched eight consecutive scoreless innings since allowing two firstinning runs in his professional debut June 21.



keep the park a neighborhood park rather than a regional park." But Goldman expressed hesitations about the

Brian Tash

The Weekly's exclusive interview with newly appointed Director of Curriculum & Instruction Brian Tash



How many times have you heard a student say, "I hate math"? Definitely don't say it around Beverly Hills' Unified School District's new Director of Curriculum and Instruction Brian Tash. Tash, a San Fernando Valley native lived in Oceanside and San Diego before coming full circle to the Valley and taking a job in Beverly Hills five weeks ago.

How did you get to Beverly Hills?

I started as a special education teacher in 1976 in Oceanside. From there, I became a resource specialist for special education. After I taught elementary school I went to junior high and I was a resource specialist for four years. Then I got involved in math and science in the program AIMS, leading to an opportunity to leave the classroom for four years as a math and science consultant for Creative Mathematics. After, I went back to Oceanside to work for the district office as a math and science program specialist for five years and left to be program manager for the San Diego Unified School District.

The opportunity arose to come to Beverly Hills. I needed to challenge myself; working in San Diego became almost mechanical. Beverly Hills gave me the opportunity to take the skills I had in terms of professional development, working with teachers, working with budgets, working with grants and then expanding it beyond mathematics. This is a huge opportunity for me to grow. I have probably learned more in the last few weeks than I have learned in the last few years.

Superintendent Kari McVeigh, is also from San Diego, did you know her at your previous district; if so did she give you any advice?

I knew her, but I did not work directly with Kari. Kari's position was assistant superintendent; she had 21 schools under her. I was a manager in the mathematics department. She was a line person, the direct line from the superintendent to the assistant superintendent to the principal. I was in the curriculum department so I consulted with Kari, but San Diego is so large that different people in the curriculum department worked with different people in the assistant superintendent's office.

Dr. Ilene Straus hired me in Beverly Hills. I knew Kari was here, which really made me want to apply for the job. I knew her philosophy of education, and I like it and I agree with it. It is about the instruction; it focuses on the students and their learning. When you work in the school district you really have to support your superintendent; that is what we do. If I did not think I could support her, I would never have applied for this job.

Kari did give me advice. I saw her after I had been hired. Kari reminded me that Beverly Hills is all about community. The important thing to do is listen; not to come in as a steamroller. We are here to support kids and the teachers-listening to teachers and their needs and to be responsive.

What does your job entail?

A director of curriculum is responsible to: coordinate categorical programs, assess: needs, plans, organize, facilitate, and evaluate district-wide professional development activities of certificated staff. Supervise the following District programs: GATE, Special Reading, and district libraries. Organize, direct, and report on district and State testing program. Supervise the implementation and evaluation of the district technology program.

Coordinate, direct, and facilitate the evaluation, selection, adoption and dissemination of textbooks and other instructional materials. Plan, organize, and direct the district curriculum, and instruction design and development programs, instructional delivery systems, and the strategies and techniques for achieving optimal educational and instructional results. Directs the alignment of the district's curriculum, including standards, curricular objectives, instructional materials, and evaluation.

Directs the articulation of curriculum

between secondary and elementary schools. Serves as a resource person for all curriculum committees by facilitating communications, preparing reports, and compiling research. Develops instructional guides and courses of study outlines, arranges for demonstration of new instructional materials and techniques. Coordinates the district's instructional materials and media program. Works with the district's beginning teacher and support program(s). Serves as an advisor to the assistant superintendent and district personnel regarding the various aspects of building instructional capacity, professional development, and administrator capacity building.

Provide direction, support, and guidance to staff, district personnel, and members of the educational community to effect thorough and complete communication relative to the educational design and delivery process, and to ensure that community advisory groups have had an opportunity to participate in educational assessment and evaluation processes. Plan, organize, and direct the preparation of a variety of district, county, State and Federal reports in order to ensure compliance, secure funding and provide thorough, complete, and effective communication and information systems. Plan, organize, and implement educational services budget planning guidelines and expenditure control strategies. Provide leadership and expertise in forming, guiding, and advising district advisory committees and groups.

You work closely with Dr. Ilene Straus, who comes to the district as a former school principal, how does your background contrast and what will this bring to the table?

It is amazing. In educational services we each have our own strengths. Even though we have very specific job titles, the four of us[Kari McVeigh, Dr. Ilene Straus, Diane Mead] very much complement each other.

For example, Dr. Straus' background is secondary education. She was a renowned middle school principal and high school principal. So she comes with that strong perspective of secondary students. My background has been in elementary and middle school. I have worked with high school students, but not to the extent Dr. Straus has. Together, we can look at the whole system and compliment each other in that way.

In terms of curriculum the three of us have got it covered. We all have a little bit of difference in our background in our areas of strength. What I really like about being here is the collaborative effort; it is remarkable.

A large part of your job is student assessment, what is the single biggest misconception parents' have when analyzing student test scores?

Students are more than test scores. I think we give so much power to the California Standard Test, it is important and it is an indicator of standards. But, what's important to understand is that it is only one indicator. Some kids test better than other kids.

What I truly value is thinking, reasoning and problem solving. I think sometimes the tests don't test all of that. It tests a lot of facts and a lot of knowledge but to really get how a child is learning, how they are thinking and reasoning, I really think a parent needs to sit down with a teacher. They need to look at the body of work that the student is producing. When you look at the California Standard look at it as one piece of the whole pile; it is not the end all.

In the district we look at two kinds of assessments: summative assessment and formative assessment. Summative is assessment of learning, which the California assessment is, it is just a score

Another type of assessment is formative assessment. This assessment is for learning. As a child is progressing through the year, formative assessment looks at what is happening throughout the year. It does not wait until the end of the year to test the child. Formative assessment helps take corrective action, if a child is having difficulties with something we can find that out. Then the teacher and the parents can put their heads together to come up with different solutions to try to correct the difficulties.

Test scores are readably accessible to parents over the internet now; how does this affect education?

I think this is beyond our control. It is a standard based system nationwide. The system of accountability is huge, and I think we all have test scores on our mind. Anyone that says they don't have test scores on their mind is probably not telling you the truth.

My belief is that with good instruction, learning will happen and the test scores will go up. What I hope we don't do is only focus on the tests. If we unpack the standards and ask ourselves what the biggest ideas are under those standards, and how can I teach it to the students so that they understand it in the way that they need, then I am confident that test scores will follow.

Some districts are so worried. They see the standards as a checklist and instead of teaching students they are teaching the tests. I worry about that because again students are more than test scores.

Tell us about working in a small school district like Beverly Hills versus working in a large school district like San Diego?

The number one difference in Beverly Hills is that everybody knows everybody. It is wonderful. Everybody has an opportunity for input. In a large district it is really easy to get lost. I had a pretty important position in San Diego, people knew my name but they did not know who I was. People know you here. People know you on a personal level, that is important. You have heart to heart talks with people about teaching and learning and that rarely happens in a large district.

Also, I get to be at the schools. I got to go to all of the K-8 schools' graduations. You are able to go out and participate in the schools. I feel like a part of the community and a team member to each of the schools. I want to be there, I want to be there with the teachers, if they are having a special night I want to be there. You can't really do this in a large district because there were over 121 elementary schools in San Diego.

In a large district people don't know what you are doing. It is like, "why does that guy even exist?"

What are some of your goals for the district?

The goal in the state of California and the nation is to improve how students do in Algebra. It is a nationwide goal, because nationwide students are not doing as successful in Algebra as we would like them. What we are going to be doing is having mathematics initiatives.

Starting this summer, we are looking at

how we can help students be better prepared for Algebra in eighth and ninth grade. We will start professional development and take a look at each grade, asking what is it kids need to be doing starting in kindergarten that will give children better access to Algebra down the line.

It will start this summer with voluntary professional development for teachers. One of my goals is to offer as much as we can: workshops, professional developments, so if people want it, it is available to them.

Another goal is looking at formative assessment. We want to get better at closely looking at children in mathematics on an ongoing basis. We will look at where is this individual successful, where is this individual struggling, and step in. It is about the interventions that are needed now, rather than waiting till the end of the year. Teachers do this already; we just want to get as strong as we can doing this.

So the big focus is mathematics: engagement in the classroom, student discourse, teachers becoming excellent question askers to be great facilitators in the classroom-it is already happening but we are here to improve it.

On the subject of math, you stated in "Take the fear out of math homework with helpful tools and websites" that parents should not tell their kids they

hate math, that in the US there is a bad stigma about math; why do you believe this and what is the determent to students if their parents say they do not like math?

As a society, I believe we are pretty math phobic. I believe that many of us in school did not have good experiences with mathematics.

I will give you an example, when I was a consultant I traveled in airports quite a bit. I would meet people and tell them I was a consultant for mathematics. People quite readily said, "I hate math" or "I was so bad at math." They would almost wear it like a badge. Let's say you were a poor reader, you would never hear anybody say, "I hate reading" or "I was so bad at reading." For some reason it is socially acceptable to say we are bad at math, but not socially acceptable to say we are bad at reading. This is an issue.

I think as a society, it is as important to be literate as it is to be mathematically literate. The decisions we make on a daily basis are based on quantities and values. We need to change our mindset about mathematics. What I believe for the sake of our children is that we need to value mathematics as much as we value literacy. One way is by not stating things like, "It is okay for you to get a C in math as long as you are trying your hardest" - parents probably wouldn't say this in another subject.

I want parents to help their children

understand how important mathematics is. I want them to play games with their kids with quantities and numbers. I want them to count with their kids and if the parents are really unsure about math or they do not like math, it is okay not to tell their kids they don't like math. You don't have to say that because we want to change that perspective. We want kids to walk away and say, "I love math just as much as I love to read" versus "I hate math"

Your predecessor Nancy Lynch left to take a job as a superintendent in Placerville. Is this something you might want to do in the future?

Not at all. I am living my passion right now. What I love is instruction and curriculum. What I am getting to do is work with students, parents and teachers. I am getting to think about the ways we teach and learn. I am getting to think about curriculum and learning. I don't aspire to be anything more than what I am right now. I feel so fortunate that I was hired. My gosh, it is an honor with all the trust that was put in me with this job.

And there is a lot for me to learn. My intention is to stay here. I like Beverly Hills. I never thought I would be where I am today.

COVERSTORY A TALE OF TWO PROJECTS

Neighboring projects on Wilshire spur development in the previously dormant eastern part of the city By Abbey Hood

Wilshire Boulevard's two development projects across the street from each other, 8600 and 8601, have proposed rezoning an R-1 lot, added residential units to the street, and proposed affordable housing in less than five years.

Some residents have supported the eastern part of the city's past development and continue to support upcoming development.

"I found myself in favor from the beginning [of 8600 Wilshire]," said former Board of Education AJ Willmer. "The mixed use project will cause less traffic and the process the planning commission and the City Council have been going through have made the project better."

Other residents object the projects for Wilshire, going as far as forming the now defunct Save Our Neighborhood's Integrity (SONI) group to bring down Wilshire 8601 in 2003.

"I am against the project [8600 Wilshire]," said Stanley Drive resident Jim Simon. "The problem is, it is not just an R-1 change, we are doing cartwheels to accommodate this developer, it is an overbuild from the word go. I am in favor of developing the site, but not if it does not abide by zoning codes."

City Council, caught in the middle, is urging residents to look at both sides of the argument

"If the neighbors understood Wilshire 8600, the neighbors would really embrace it," said Mayor Jimmy Delshad. "This type of project is really listening to the neighborhood, I wish there was a better way to explain to them. By forcing them [the applicant] to cut down the densities we are forcing them to have extra parking. The neighborhood has been concerned that businesses are parking in their neighborhood; this is the only place that is willing to give extra parking to the neighborhood. Because of extra parking, and mixed use, the traffic will be a lot lower."

When did the division amongst some residents start? 2003 with the arrival of 8601Wilshire.

The project, approved by the council in 2003 as a mixed use site, quickly gained publicity when residents opposed it. After, 8601 Wilshire was supported by former mayor Mera Lee Goldman, residents voted overwhelmingly for her opponent Mayor Jimmy Delshad, in that election, which in part led to her defeat.

Neighborhoods opposed 8601 and formed the group SONI. Headed by the former president Al Omansky, SONI filed a lawsuit against the developer Galaxy Commercial Holdings and the city for not complying the

California Environmental Quality Acts in 2003.

The Weekly reported in issue 258 that a settlement was reached for approximately \$229,000, but the entire settlement went to attorney's fees.

Since the settlement, 8601 Wilshire has continued with its plan and developed Blu, an 11 story high rise with 37 apartments for lease, the first residences ever to be built on Wilshire. The apartments are available for lease now, but are not scheduled to open until the end of summer.

SONI has since disbanded. Al Omansky moved out of Beverly Hills after the settlement, and resigned as president because he did not feel it was right to act as president not living in Beverly Hills, said Omansky.

After, Galaxy said the company and SONI worked together on the project.

"Galaxy Commercial Holding and SONI worked closely to shape the development concept for Blu from the earliest phases," said Vice President of Galaxy Commercial Holdings Lauren Cohen. "Through a collaborative process, Galaxy and SONI came to an agreement in 2003 that met everyone's expectations for a successful development at 8601 Wilshire. When delivered, the new development will meet those agreed upon expectations."

Less than five years later, in June 2006, the city found another development project on the table for Wilshire Boulevard: right across the street

8600 Wilshire, first denied by the planning commission last June, was brought back to the commission in September on appeal by the City Council. The council asked the commission to look into the possibility of the site as a mixed-use site, which was originally ruled out, the commission went back to the 8600 Wilshire team with modifications. The "team" consists of: the applicant Colonial Partners LLC 8600 Wilshire Boulevard, attorney representing the applicant Mitchell Dawson and communications representative Susan Berk.

This June, the project arrived back to the council with modifications made by the planning commission and the developer. Those included the change of ground floor space from 4,774 sq. ft. to an approved 6,383 sq ft. of commercial space. The height of the project started at 61 feet, the planning commission said 55 feet, but the council approved 8600 Wilshire for the 61 feet.

The city also is looking to benefit from the mixed use site, said Donna Jerex, who is the city planner for the project. So the council has requested that the applicant come back with the inclusion of only two units of affordable housing to the project, she said.

But, because there are only two units of affordable housing the project should not be confused for an affordable housing project. It is still a mixed rate project, said Jerex.

The addition of affordable housing has helped gain support for the project from some of the community members.

"BHEA supports any reasonable efforts by the city of Beverly Hills to create affordable housing within the city limits," said Beverly Hills Education Association president Chris Bushee.

Members from the Board of Education spoke on behalf of the project at the June meeting in support of affordable housing, such as John Millan and Alissa Roston. Berk is also Roston's Board of Education campaign manager.

If the council approves the project, and included in the project is the affordable housing, the affordable housing would be written into a covenant in the entitlements "almost assuredly," said Mitchell Dawson, attorney representing the applicant for 8600 Wilshire.

"The city has not yet detailed what they will require," said Dawson. "But, that is very typical and consistent, so that they [City Council] will determine the period of time that remains as such."

Traditionally in the state, city councils can make it affordable housing for five years, 10, years or 20 years, said Dawson.

"We as the developers think that is the city's jurisdiction," said Dawson. "Presumably the city would want to protect it for whatever they deem appropriate. I would hope they would not want to have it turn over in a year or two back to market rate. That is not the concept of affordable housing; the concept is that it is made affordable housing at least for a significant amount of time."

Once the applicant sells it, the developer is out of the picture. If the city said three years it has no impact on the applicant, the applicant is out of the picture at that point, it is the subsequent owner, said Dawson.

If granted, this affordable housing would be the first project on site in Beverly Hills.

City Council has asked the applicant to come back on July 24 with plans showing the options for affordable housing, as well as the different options of two or three housing units for the back parcel of the property.

"The council's primary goal is to make certain we don't have something that is extraordinary, unusual or out of character with the neighborhood and that is to be determined at the next meeting," said Vice Mayor Barry Brucker.




