



Wood roofs ignite a fiery debate at City Council meeting

The Beverly Hills City Council bans wood roofs as a result of the April fires. By Abbey Hood

Beverly Hills' flats residents voiced opposition to the second reading of the prohibition of wood roof coverings at the Beverly Hills' City Council meeting Tuesday; but the City Council unanimously approved the second reading of the ordinance that came heavily supported by the Beverly Hills Fire Department.

The ordinance, first passed as an urgency ordinance by the City Council on June 19, came as a reaction to the April 12 fires in the Los Angles Franklin Canyon area. Winds exceeding 50 miles per hour spread embers in Beverly Hills that led to the ignition of three homes. Two of the homes were located on Beverly Drive and one on Woodland Drive near the fire station. All homes had wood shake

This led to an effort by the fire department and the planning department to change the previously existing ordinance and push to prohibit wood roofs in the city.

"The only structures that were damaged were the three in the city of Beverly Hills," said Fire Captain Gregory Barton. "The reason why we went forward to council to change the ordinance to eliminate wood roofs, is in hopes of limiting the flying embers in the air landing on roofs and igniting the roofs."

The approved second ordinance prohibits wood roof covers in the city of Beverly Hills. Roof repairs of less than 10 percent of the total roof area in one year may be repaired with a roof covering that meets the same fire retardant standard as the existing roof. If more than 10 percent of roof repair is needed, the entire roof will need to be replaced.

This will solve two major issues for fire prevention, said Barton. The embers flying in the air land on the roof and catch the roof on fire. If the roof is non combustible, roof fires can be prevented, said Barton. The second issue this will help solve is once the embers are on the roof, and the roof fires get started, that roof has become more of a fuel load for the fire. It will put the embers out in the air, causing the embers to spread to different parts of the city. Eventually, affecting other roofs that are wood shake roofs, said Barton.

"This was a time the council put aside what our personal preferences were and listened to the professionals," said Mayor Jimmy Delshad. 'We depend and we make sure that the rest of the community is protected by the fire department. We wanted to listen to them more than our own personal views on whether a home should be changed. I think it was a great collaboration of city staff, the fire department and City Council getting together to see what is best for the community."

Less than a handful of residents voiced their concern at the meeting, disagreeing with Mayor Delshad. Residents said not everyone would be affected by the ignition of embers in

"People in the flats have never been affected by a fire," said Trenton Drive resident Ruth Kraft. "My objection is not to Beverly Hills declaring no wood roofs for new homes, but it is that they are going to change the old homes. Some of the people cannot afford to replace their roofs.

Kraft said because the flats have not been affected by fires, it is not fair to go into the old homes and ask them to change the entire roof if there is more than 10 percent repair needed.

"Even though the ordinance could be a little bit troublesome for some homeowners, we need to think for the rest of Beverly Hills," said Delshad. "I cannot worry about a few homes that may be inconvenienced or have additional costs if it dangers the rest of the city. I was thinking more for the entire city. For the homes that will catch fire, it is not the home itself, it is

A Draft Environmental Impact Report (DEIR) has been prepared for the proposed office/retail development at 231-265 North Beverly Drive/9465 Wilshire Boulevard. The DEIR will be released on Tuesday. July 10, 2007 for 45-day public review and comment

period. The City of Beverly Hills encourages public comment on the DEIR during this period.

The Planning Commission will hold a public hearing on the project and the DEIR on Wednesday July 25, 2007 at 6:00 PM in City Council Chambers, Beverly Hills City Hall, 455 North Rexford Drive, Beverly Hills, California 90210.

Project Overview:

The proposed project is located at 9461 Wilshire Boulevard (also known as the "Bank of America building") and 231-265 North Beverly Drive, which consist of an area bounded on the south by Wilshire Boulevard, on the east by Beverly Drive, on the north by Dayton Way, and on the west by the alley between Wilshire Boulevard and Rodeo Drive. No substantive changes are proposed to the Bank of America building, although rezoning of the site is proposed as part of the proposed project. Demolition and construction of the office/retail building are proposed at 231-265 North Beverly Drive, which is presently developed with one story of commercial structure and a six-story parking structure.

The project proposes an overlay zone and general plan amendment, which are subject to approval by the Planning Commission and City Council. The proposed development is also subject to Planning Commission approval through the Planned Developed Review. The project may also require utilizing the City's In-Lieu Parking Program, in which fees are deposited into the City's Parking Enterprise Fund for public parking facilities. The project also proposes a lot line adjustment to address certain existing uses and improvements associated with the existing nine-story Bank of America building.

The project proposes a new six-story, 91 $\frac{1}{2}$ -foot high office building to be constructed on a 1.1-acre portion of the site at 231-265 North Beverly Drive. The project will provide a total of 665 on-site parking spaces, and proposes the following mix of uses:

Shopping, Parking, Politics

Plus some events not to miss. By Rudy Cole

Consumer insights, food shopping. Beverly Hills once had over 12 food shopping choices – everything from Ralph's, Safeway, Smith's Food King, the locally owned Premier Markets and a scattering of medium sized independents.

You could find a wide range of shopping choices at major intersections, including Wilshire and Crescent and Wilshire and La Cienega. The explosion of real estate values and consolidation of competitive chains all contributed to a lessening of options.

As an example, "Premier Markets" was one of our historical landmarks, started by the late **Archie Dickranian** on North Canon, now the "D Lot" parking structure, it had as much delivery as walk in business, AND boasted top quality meats and produce.

The closest store to this model is Beverly Hills Market on North Crescent, and here too delivery is a major source of business. The store is "convenient" in the sense that they always open a second station if there is any significant waiting in line and they have most basic needs.

We really only have one major, full service market: Pavilion's on South Beverly. On the plus side, the people who work there are really among the most friendly and service oriented I have found anywhere in the Los Angeles area. As a full service market, it simply does not have sufficient space to compete with the Ralph's chain stores found on our borders on Pico, Olympic and Beverly Boulevards.

As for Whole Foods, no question they have the best quality meats, fish and produce and a fine salad bar. This socially conscious chain too has a Beverly Hills shop that is much smaller in size than their stores in Brentwood, West Los Angeles and Fairfax. Although they pride themselves on organic, health awareness offerings, they sometimes slip in watching

expiration dates on their products. On July 5, we purchased some milk that expired on July 3. Not the first time I noticed this, after the fact.

Interesting comparison: Although Pavilion's prices on many items, especially frozen foods, are much lower than the same items on competitors outside Beverly Hills, an exact same small milk product at Whole Foods was 10 cents cheaper – I don't think this was because of the expiration lapse. Time and space permitting, we may do some other comparison shopping.

Having said this, what we lack is a Gelson's. Too bad there isn't some place in the former Industrial now Central Beverly Hills area to house them.

Want to start a range war, bring a proposal for permit parking to the city. Instead of sheep farmers and open range combatants of the old west, we have merchants tugging for space rights with residents.

Unfortunately, the issue has never had a citywide policy or plan. Each small section of Beverly Hills has responded to resident demand, often followed by business opposition.

The latest installment of the conflict played out Tuesday at a lengthy City Council hearing on a request for restrictions on parking in the south Willaman and south Carson areas.

The businesses in this area have a very special problem: There are simply no public or commercial parking alternatives available. Without street parking, their businesses could be seriously hurt.

After some crazy quilt and confusing proposals coming from compromises the Parking and Traffic Commission and city staff tried to offer, the council worked through a compromise plan that limits and restricts some parking and provides some alternatives – for a six month test period.

What is certain to happen is a very strict enforcement in the area. While some residents and shoppers in other sections of the city might feel that enforcement is too efficient, merchants and business owners agreed that their area needs more, not less issuance of parking citations. What they ask, they will soon receive.

However, what the city needs is a comprehensive street parking plan and, of course, more public parking availability, including better use of existing, satellite structures, including those at La Cienega.

Speaking of parking, the city needs to bite the bullet and find the means of funding a parking structure adjacent to the Annenberg Cultural Center. This non-profit, working diligently to complete funding needs so that we can actually have a cultural resource we can view with pride, should not have to bare the costs of a facility which will serve needs far beyond their own. City leaders need to stop treating the



Center as if it were some private enterprise instead of a valued addition and community resource.

This parking facility could go a long way in meeting the failures of promises made when the D Lot was created and bring new parking availability to a whole section of the north business area. More on this later, including some distortion by opponents of the project that public funding of the parking building would go back on promises that the Cultural Center would be self-funded. But bottom line: We need the Annenberg.

Mayor **Jimmy Delshad's** effort to support divesture of state retirement fund investment in foreign companies that have holdings in Iran almost, but not quite, erupted into a clash on process and public policy Tuesday evening.

Councilmember **Linda Briskman** was obviously not pleased by the headlines the Delshad proposal had received, complaining that this had not been subjected to the usual process of subcommittee study and city-hired lobbyist review.

Aside from process, Briskman has other concerns, although these were not so apparent and never openly expressed, for obvious reasons. But I think the reasons are her apprehensions about our city becoming too visible on this and related issues – the only way I can write this without making it too obvious.

Interestingly, I think they are both right, in their way. Our city has over \$500 million in the state retirement fund, the target

of Mayor Delshad's concern, but we have no ability to control their investments. What is being considered by the state legislature, and it is very far into the process, too much so to have the usual committee/staff study, is legislation that would bar these investments. The state agency, one of the major funding institutions in the world, has taken almost a cavalier and insensitive approach to the divesture issue. The bill passed by one branch of the legislature has the unanimous support of the Los Angeles City Council and our own should act promptly to join the fight.

Delshad is to be commended for raising the issue and Briskman for wanting to follow process. Now, let's move on and take this out of committee, where it was assigned, and let our voices be heard. Yes, there are risks.



Mayor supports a bill that would withdraw public retirement funds from investors in Iran

Mayor Jimmy
Delshad urged
Beverly Hills City
Council to formally
support a bill that
would withdraw

California's public retirement funds from investors in the Islamic Republic of Iran, following support from the State, on Tuesday.

The mayor's proposal to council asked the city to support Assembly Bill 221 to divest California's public retirement funds from key foreign businesses that invest in the Islamic Republic of Iran.

Mayor Delshad said he believes it is irresponsible for public investment retirement funds to have holdings in companies doing business with terrorist states.

The bill first introduced by Assemblymember Joel Anderson (R-San Diego) is supported by Governor Arnold Schwarzenegger and is now in the Senate Public Employment and Retirement Committee; the California State Assembly passed the bill 75 to zero.

Tuesday power outage affects Rodeo Drive during peak season

A power outage affected 104 Southern California Edison customers in Beverly Hills, including many businesses on Rodeo Drive, last Tuesday afternoon.

The outage affected customers between Brighton Way and Dayton Way and between Camden Way and Beverly Drive, but not all Edison customers in these zones were affected, said Southern California Edison Westside Los Angeles Region Manager Mark Olson.

Both the Luxe Hotel and the 26 stores managed by Two Rodeo said they were without power for about 30 to 35 minutes. The power outage occurred at 1:16 p.m. and was restored to all but two customers by 2:24 p.m., said Olson.

Telephone Connection of Los Angeles Inc. President Marc O'Krent said he is looking to use another electrical provider aside from Southern California Edison because of the continuous outages affecting his telecommunications business

"This is based on my low confidence with Edison," said O' Krent. "When we spoke to the Edison regional manager last year, he said he did not know how long the power would last in Beverly Hills because things are very old."

O' Krent also addressed the Public Works commission last year about the outages that were continuously occurring in Beverly Hills.

"Over the last several years, we have seen an increasing number of power outages in the Southwest portion of the city due to fires at Edison facilities," said O'Krent. "These incidents pose a danger to the public and to the firemen who have responded to these incidents."

Public Works Commissioner Tom Korey said last year Southern California Edison had many outages due to transformer breaks. Usually, the outages first affected South Beverly Drive, he said.

Olson said Southern California Edison has been and is currently undergoing system upgrades in Beverly Hills.

"There was a small section in Beverly Hills not doing well," said Olson. "We have replaced that equipment, it is now up to new. We will be replacing three major pieces of equipment in Beverly Hills this month. In general the power system is doing very well."

Since June 26, there have been three significant power outages in the city of Beverly Hills, one on June 26 that lasted until June 27, said Olson. The second outage occurred July 7; the outages were due to high voltage splices, he said.

Korey said the Public Works Commission is not currently investigating Southern California Edison in any special way at the moment.

Collision closes Wilshire Boulevard for four hours

A vehicle collision at 9900 Wilshire, adjacent to the Unocal 76 station at Whittier Drive, shutdown Wilshire Boulevard from Comstock to Santa Monica for approximately four hours on July 3, said Lt. Michael Hines of the Beverly Hills Police Department.

Beverly Hills police said the vehicle carrying four Los Angeles residents in their early 20s was heading east bound at high speeds. The vehicle lost control trying to change lanes. The car slid sideways and hit a palm tree in between the old Robinson's building and the Unocal station at 10:10 p.m. A Beverly Hills' police officer was at the Unocal station preparing to set up speed enforcement during the time of the accident.

The Whittier and Wilshire intersection is the same site of the vehicle collision that killed Beverly High student Pedram Kashani in 1999.

No alcohol is suspected. The accident is still under investigation.

Proposed Wilshire Corridor expansion meeting in Beverly Hills

Southern California Transit Advocates will host a second meeting discussing the proposed subway expansion for the Wilshire Corridor at 6 p.m. on July 17. The proposed plans would include an extension from Westwood to Santa Monica via Miracle Mile, Beverly Hills, and Century City.

Less fumes as cars move along rather than stall and wait in the curb lane. "A Tale of Two Projects"

This is in response to last week's front page story on the 8600 Wilshire Mixed-Use project. My home is directly adjacent to the R-1 residential lot that this Council wants to rezone to allow some townhouses as part of a forthcoming massive mixed-use project that will tower to 61 feet on Wilshire. This is the first time in Beverly Hills history where a R-1 residential lot is rezoned to allow multi-family with greater height and densi-

My family purchased our home 28 years ago surrounded by R-1 homes and the R-1 lot (same size next to my lot to my east on Charlevile and Stanley) which I considered an R-1 buffer. I questioned if it could be rezoned. The Beverly Hills Planning Commission told me it could not or we would never have bought our home in the first place since there were other homes available to purchase. I am a teacher and my home is my major asset and life savings. I do not want my home's value to decrease due to massive townhomes adjacent to my backyard which will destroy my privacy. I learned in the EIR report that at 8 AM, I will have 69% shade! I also discovered that on an R-1 lot the maximum square footage allowed to be built is 4100 sq.ft. The developer, Wilshire Colonial Partners, wants to build 2 or 3 townhomes - 9,000 sq.ft. That is double the amount permitted on an R-1. Talk about density, you cannot hide bulk and scale with two or three townhomes sitting on a small R-1 lot!

It is obvious to me and many others that this city council, like past city councils, favor massive development even at the cost of homeowners. Mayor Delshad and Councilmembers, how would you like to have one of the R-1 lots next to vour home rezoned to allow some massive townhouses...or do you believe, as long as it's "Not In My Backyard"...it's okay? the embers that will be caused as a result of that fire that will damage other homes or add potential risks to the city."

Councilmember Nancy Krasne suggested the possibility of adding roof sprinkler systems, or fire retardant products. This is so that residents who have existing wood roofs might have other options.

One of the homes that caught fire in Beverly Hills did have a sprinkler system for the roof, said Barton. There are two problems with sprinkler systems, he said.

"The 50 mile per hour winds cause the wind to blow so hard that it pushes all the water off the roof, so the roof is not getting good coverage," said Barton. "And it is normally a hot dry day; the water does not stay in place that long, it evaporates right away due to the tempera-

Fire retardants do not work either, said Barton. The Beverly Hills Fire Department has found the best protection for a wood roof is to pressure impregnate the roof; this is only temporary, said Barton. By putting a spray on the outside the homeowner would have to spray the home constantly because the products usually last for only 24 hours, said Barton.

For homeowners concerned about the aesthetics of their homes, the fire department is creating a public education campaign to help educate homeowners on options available instead of wood products, said Barton.

"This[the ordinance] is helping the city of Beverly Hills become one of the safest cities by eliminating combustible materials in wildland urban interface areas," said Barton

What are your neighbors reading?

Temperatures are supposed to be in the 80s this weekend; so don't stay indoors. Pick up a book and take it outside. The Weekly gives you an in-depth look at how your neighbors stay busy with literature, even without Dutton's.

The Book Club Seekers

Book clubs are not just for Oprah, take Beverly High, for example, or ask English Department Chairperson Jennifer Tedford about the buzz word. Tedford alongside seven other current and retired staff members at Beverly High meet once a month for the Beverly Hills High School Staff Book Group, something Oprah would call an, "old fashioned book club with a twist."

The group has been in existence for eight years under director and English teacher Julie Goler.

"I wanted to give back to the BHHS community and teachers have been most appreciative of having a chance to talk about literature," said Goler.

"The regulars" are seven or eight faculty members from all departments, who meet to discuss the book of the month, said English teacher Michelle Halimi, who has been in the club since last school year. Included in the group are Halimi, Tedford and Alexandra Rhodes.

"The best part of the book club is getting the staff together to discuss a piece of literature," said Halimi. "It's interesting to hear other colleague's perspectives on the book. Many are interested in different types of writing, so even the ones that don't love a book still have a lot to say. In addition, many teachers who have retired still come back for the book club. It's a great way to get everyone together and learn."

Last year's books included, *Under the Banner of Heaven*, *The World to Come*, *Prep*, and *The Tender Bar*.

All the books are thoroughly researched by Goler before going into a meeting. Goler familiarizes herself with the author and the time period so she can lead the discussion groups. Goler said she makes sure during these discussions that the group does not digress too far from the book, she said.

At least once a year, Goler invites authors to participate in the discussions. Author Lisa Pearl Rosenbaum will join the group to speak about her novel, *A Day of Small Beginnings*.

In the last 10 minutes of the meeting, Goler pitches ideas about the next month's readings. The group is out for the summer but will reconvene in September to read *Inheritance of Loss, The Road*, and *A Day of Small Beginnings*.

The City

Employees of the city of Beverly Hills have started their own book club with the same idea but they add a little twist.

Coming out of training strategies for employees, the City Employee Book Club is a voluntary club that began last April. The club meets once a month during the lunch hour and have nicknamed the theme, "Brown Bag Lunch," said Karine Shirinian, training and organizational development coordinator for the city. The "Brown Bag Lunch" crew is led by Librarian Deborah Henderson and Recreation Services Manager Teri Angel.

Since its beginnings, the seven to 15 members in the club have already finished *The Fred Factor* recommended by Sgt. John McKenzy. Now, readers are halfway through *The Starbucks Experience*. Originally the books selected were applicable to training and development strategies, but because the club is voluntary the next books the group will read will be books read for pleasure. Up next is *Harry Potter*. The members purchase their books independently, said Shirinian. Usually the books are purchased through Amazon, Borders, or the library can order the books to be purchased, she said.

The Fiction Fanatic

Love fiction? Love theatre? The Beverly Hills' Public Library is the place for you. The New Short Fiction Series at the library is a fiction lover's perfect activity for a summer night. On the second Friday of every month, actors perform short fiction books for the series.


"The authors featured are new authors, some are published and some have yet to be published," said Madeline Gabriel, library outreach services manager.

New Short Fiction Series is sponsored by the Beverly Hills Public Library, the Community Services Department and Barnes and Noble. Performances are held at the library auditorium at 8 p.m. Seating opens at 7:30 p.m.

the seams with activities for families this summer.

"It is a very busy time for the library," said Children's Librarian Kay Macdonald. "During the school year we are usually busy with students doing their homework, but in the summer we have whole families at the library."

Sponsored by Friends of the Public Library, events include Monday evening musical performances for children. The performances are targeted for ages 3 to 5.

On Wednesday afternoons, there are interactive programs for ages 5 and up. On July 25, the parrot from "Pirates of the Caribbean" will come to the library for the program "Parrot Tales." On August 1, "Cowgirl Christy" comes to the library to show off her trick roping skills and tell her tales of the American West.

The Young Reader

With over 1,000 students in the summer reading programs, it is no wonder the library is busy. The Summer Reading Club is designed for preschool students to junior high school students as a way to keep them interested in literature over the summer.

The Summer Medalist Program is for students in first grade through eighth grade. Beverly Vista PTA co-president Jennifer Schwartz's third grade son Jacob is in his fourth year of program.

"I strongly recommend this program to every school aged child," said Schwartz.

The Summer Medalist Program encourages students to read a book from the school district's website. The student will then complete an activity to correspond with the book. For example, a student can create a bookmark or letter about the book they have read. After five books, a student will submit a form to their teacher in September to receive their medal in assembly line.

Jacob is currently reading his second book, *Jackie and Me*, by Dan Gutman. To go alongside with his book, Jacob will write a letter to one of the characters.

Another program for young readers hosted by the library is the Summer Reading Club. For each book a child reads, the child will do a book report on the book and receive a paper character for each report completed. The character can be colored and designed however the child wishes. After eight books, the eight characters are hung in a mobile at the library. Last year, 594 children completed a mobile.

Macdonald has not seen a trend in what students are reading this summer, particularly because the age range is so wide. But, she says series are always popular.

"They [children] can't wait for the last *Harry Potter*," said Macdonald.

The High Schooler

Thought you would be spending your summer lounging poolside, not if you are in an honors or AP English course at Beverly High.

Students this summer are required to read four books. Some are pieces of traditional literature that most high school graduates can remember reading. Some of which include: *Grapes of Wrath*, *Catcher in the Rye* and *Lord of the Flies*.

Senior Zach Kahn, who is also the student board member on the Board of Education, said he finds most of his books for summer reading on Amazon or at Borders. Most of the time Kahn orders his books online, but he said if he needs a book quickly he will go to Borders.

Upon school's return students like Kahn will be tested on the material. In addition to an objective test, incoming seniors are also required to do a writing piece on their summer readings.

"The English department at the high school has always supported the summer reading program," said English Department Co- Chair Bill Hiatt. "There is a strong correlation between the amount which students read and their development of a wide variety of skills, including writing skills," said Hiatt. "There is also a strong correlation between the amount of reading while in high school and future success in college."

The Traditionalist

Not all libraries have to be big, overwhelming and on the cutting edge of technology. Readers searching for the intimate appeal of a library that uses the old fashioned card catalogs are in luck. These readers can find what they are looking for at the library location at Roxbury Park. Park goers can stop in at the small library, check out a book, take it outside and enjoy the nice weather.

"This is handy for those who already go to Roxbury," said Gabriel.

There is one computer, the books have the card pocket attached to the cover and non electronic card catalogs are used to search for books.

"Some people like the cards in the book," said Gabriel. "This way they can see if they have read the book before, and see who else has read the book."

The ambience is personalized, friendly and slower, said Gabriel. The volunteers are dedicated. Recommending books make them happy and this makes the people who go to the library happy, she said.

Open five days a week from 11 a.m. to 3 p.m., the Roxbury Park location carries about 2,000 books in large print and regular print. Videos are available to be checked out, and there is a paperback exchange at this library.

What are you reading?

Susan Gersh, Fine Art Commission chairperson, is reading about the globalization of individualism in Thomas Friedman's book, *The World is Flat*. Friedman, a New York Times foreign affairs columnist and three times Pulitzer Prize winner, has Gersh on the edge of her seat as she is over halfway done reading the "informative read," she said. A wake-up call, said Gersh, *The World is Flat*, is recommended for parents, educators, leaders and businesses entrepreneurs, she said. "I am learning so much," said Gersh. "It is opening my eyes; the book is a fascinating read."

Ronit Stone, El Rodeo PTA co- president, just finished reading about circus life in the United States in the book *Water for Elephants* by Sarah Gruen. Stone needed a summer read for her long flight to Israel and decided to pick up *Water for Elephants* after a recommendation by a friend. "I enjoyed the book," said Stone. "I would definitely recommend it as a summer beach read."

Susan Rosen, Friends of Greystone chairperson, is currently listening to an audio book, *Kabul Beauty School*. Rosen said once her sons introduced her to her ipod, she enjoys listening to audio books while she travels. "I have been listening to *Kabul Beauty School* because it is about the everyday life of women in a country that we politically support," said Rosen.

Amy Golden, Beverly High assistant principal, can't seem to leave education, even when school is out. "I just read 19 Minutes by Jodi Piccoult. It is about a school shooting, so needless to say I find it fascinating," said Golden. "One of my best friends was reading it and couldn't put it down. She said that Jodi Piccoult was one of her favorite authors, so I thought I would give her a try. I loved the book. It was a page turner, but a little disturbing. I would recommend it and can't wait to get another one of her books." The next book on Golden's list is Notes on a Scandal, a book about a teacher's affair with a student. "I really like books that have to do with schools," said Golden. "I can relate to that."

Adina Melnick, Recreation and Parks Department secretary, said she is learning all the secrets in the world, like what's in a Twinkie, in the book *Big Secrets* by William Poundstone. Melnick said if she goes to someone's home and does not see a collection of books she just doesn't feel right. That is why Melnick always has a book in her hand. "Read, read, read because therein lies wisdom," said Melnick.

Amy Phillips, Horace Mann PTA president, likes a little bit of history and a little bit of romance. For her summer read she is half way through a book with a little bit of history, E.L. Doctorow's *Worlds Fair*. Narrated through the voice of a 9-year-old boy living in the Bronx, the book takes place during the 1930s. Phillips has yet to get to the part where the narrator reaches the Worlds Fair, but Phillips can't wait to read on. If you were to ask her about her absolute favorite, it would definitely be a fictional romance set in World War II, she said.

Patty Ogden, assistant city clerk, is reading about Starbucks, but not what's on the coffee menu. *The Starbucks Experience* by Joseph Michelli is literature that couples sound business strategies with a desire to enrich the human spirit, Ogden said. 


