Beverly Hills Chamber Promotes Business and Tourism in New York

Mayor Jimmy Delshad discusses city partnership with NYC Mayor Michael Bloomberg By Elisa Osegueda

Beverly Hills conducted its annual trade mission to New York. Members from the Beverly Hills Chamber of Commerce, Conference and Visitors Bureau (BHCVB) and City Officials traveled to New York from October 22-25 to promote and advance Beverly Hills' economic landscape.

The trip consisted of trade meetings and business events aimed at promoting Beverly Hills as a world-class destination and location to do business.

New York Mayor Michael Bloomberg and Beverly Hills Mayor Jimmy Delshad met to establish a new city-to-city partnership and high-level information exchange on issues including homeland security, business development and emergency response. "It is critical for governments around the country to learn from each other and share best practices," said Delshad. "If Beverly Hills is to continue its reputation for excellence and remain 'Best of the Best', it must not only share its own experiences, but must establish new city-to-city partnerships."

The delegation also toured New York City's new high-tech 311 customer call center and discussed technology innovations.

The 311 customer call center is a phone number for government information and non-emergency services. It provides the public with quick, easy access to all New York City government services and information. It also offers immediate access to translation services in over 170 languages.

Beverly Hills Chamber of Commerce CEO Dan Walsh said tourism plays an important role in Beverly Hills.

"Beverly Hills has significant business relationships with dozens of companies in New York," said Walsh.

According to City Officials, about 75 percent of the Beverly Hills budget comes from business activity, both local and tourism related. In addition, 25 percent of the City's general fund revenue, the single largest source, comes from the Transient Occupancy Tax that comes from tax on hotel rooms, currently set at 14 percent.

Walsh believes the annual trips have a great potential to be successful.

"Meeting with executives, agencies and media outlets to enhance their understanding of and strengthen their relationship to Beverly Hills adds substantial value and growth to the Beverly Hills economy," said Walsh.

According to City officials the New York trips have been successful in the past. The Luxe Hotel Rodeo Drive claims to have increased in bookings. David Yurman, a high profile retailer, recently leased space in a city owned building. W Steakhouse opened a restaurant in Beverly Hills as a result of relationships made during a New York trip.

"Our willingness to engage in vital information exchanges such as this one with New York City can enhance our ability to provide worldclass services," said Delshad.

Courier Publisher hits back at snub By Rudy Cole

Aside from the usual lawn signs wars and the battle for corner lot sites, the school board election has earned an enormous yawn. When board president John Millan withdrew at the very last minute, the excitement of a strong challenger running against three incumbents left with him.

Aside from questions about administrative changes and permit enrollments, it would be very hard to fault this board on issues that dominated past and more contentious elections. This board does not engage in petty squabbles, has completed construction programs on time and under budget and has been very open and responsive to parents and the whole education community.

Of the four candidates, three are extremely well qualified. They are:

Myra Lurie. During her term as president and now as member, she has been strong, creative and a unifying force on the board. It was

during Lurie's presidency that the district faced the unexpected departure of the very able Jeff Hubbard. She handled the selection process with care and insights and provided a very smooth transition. As a lawyer – the only one now serving on either the school board or the city council – she provides special expertise that has great value to the board. Significantly, Lurie's list of supporters is a model in bringing people together. Many of those backing her have very different views on major problems facing Beverly Hills, but all agree she merits a second term based on her record, experience and dedication to public education.

Alissa Roston. This would be Roston's third term, but that should be a plus not a distraction. Her experience working with many different board members gives her a history of goals and programs and insights into a continuing education process. She has avoided some of the bat-

But it certainly is interesting to see all the arguments being used to support incumbents Lurie and Roston, and interesting to see how a school district that has descended into the upper echelons of mediocrity is magically being portrayed as the best of all possible school districts. tles involving former colleagues – boards in office before the present majority were elected. She is a good team player.

Steven Fenton. Had Millan sought a second term, Fenton's candidacy could have made this a more challenging election and many of the issues Fenton has raised would have become far more significant. Even so, Fenton has made the school community aware of challenges – not the least of which is encouraging parents with school age children to enroll in our public schools. Fenton will bring to the board enthusiasm, a willingness to seek new answers for old problems and he will help create a better understanding with the teacher's union. Fenton will, once elected, continue the spirit of cooperation and civility that has set this board apart from past boards.

He has an impressive record of service to our schools.

The fourth candidate, **Brian David Goldberg**, began as an unknown quantity and has not articulated sufficient reasons to choose him over other candidates who are well known and have strong credentials and identifiable supporters. There have been questions about his resume, his knowledge of our schools and his record of service, meager in part because he is new to the city.

It's also really interesting to see the way challenger Brian Goldberg is being written off like some kind of carpetbagger, despite his impressive credentials and the fact that he is espousing a platform aimed at addressing the District's deficiencies just like the other challenger, Steven Fenton, who is deservedly getting widespread endorsements.

It's also interesting that Cole faults challengers Fenton and Goldberg for having the chutzpah to criticize incumbents, Lurie and Roston. This criticism seems mainly to have consisted in pointing out the serious problems the District is facing, most notably the decline in the standards of educational excellence.

Since Cole is characterizing much criticism of the incumbents and current Board as "specious and distracting," it is not surprising that he tries to put a spin on things while acting as an apologist for the current Board. But trying to rationalize sinking test scores by citing magnet and charter schools in other districts obscures the real point.

Pretty good isn't good enough for our children. The BHUSD's goal should be to provide its students with the finest education possible and to prepare its students for the finest universities. No amount of spin can hide the fact that the district is just not getting the job done, as evidenced by the low ratio of BHHS grads to get into and attend the Ivy League and other top universities.

Cole suggests that this really isn't an issue either; in fact, echoing Myra Lurie, he suggests that a large number of BHHS students actually do get into Ivy League schools but Hopefully, he will stay involved no matter the results of this election, however he simply does not meet the test of well qualified although his entry into the race at least made sure there was an election.

Note: One letter writer seems to think our schools are terrible and blames the incumbents for everything from test scores to changes in school principals. Facts seem uninteresting, but our test scores have NOT declined and there is far greater harmony in our district than there has been for many years. No one questions the great contribution Irene Stern made as principal of Beverly Vista, but that school community is doing extremely well under new leadership as is our whole district. Not distracting from Hubbard's time as superintendent, but the new super, Kari McVeigh may well become of the one best the district ever had. She cares about public education, knows curriculum enhancement, financial management and outreach, often with a real passion.

One failure to include: When I wrote about past board issues in financing construction, I left out one significant problem. The 1994 Northridge quake added needs and costs no board could have predicted.

There was one small, minor omission in last week's Courier blast against the Beverly Hills Chamber of Commerce. In case you missed it, the Courier has questioned funding the city "gives" our local Chamber, even saying it has served a public records act "demand" on the city manager and city clerk.

What the story failed to include was a far

don't attend because they prefer to stay closer to home — as if BHHS students, when applying to Ivy League schools, are actually unaware of where they are located.

The facts tell another story. In 2007, a higher percentage of BHHS grads who got into Ivy League schools actually ended up attending than those who got into either USC or any of the UC schools.

I guess the conclusion is that our grads do want to attend the Ivy League and other top universities: the problem is that not enough of them get in. Seven from the class of 2007 went to Ivy League schools and one went to Stanford. As previously mentioned, relative to the size of the graduating class, Harvard-Westlake sent 28 times more students to the Ivy League than BHHS this year.

Cole's faulting the challengers for not citing specific Board votes in their criticism of the incumbents is also off the mark. It is not a question of the incumbents' votes on specific issues as much as a failure on the part of the Board to even acknowledge and address the larger issues of the educational decline of the district. It's simply impossible for the challengers to point to Board votes that would supposedly deal with such issues when the Board and the incumbents are not even willing to admit that the problems exist.

So it's more than a bit ironic that both incumbents are using the old, hackneyed "Experience counts" cliché. Experience only counts if one learns from that experience and takes the appropriate actions. Much more than experience, it is the results *letters cont. on page 7* more intriguing item: The executive committee of the Chamber refused to immediately name Courier publisher **Ciff Smith**, **Jr**. to its board and also denied his request for inclusion in some of the meetings the board and city will have in New York this week as part of tourist and business promotion junket. Smith also dropped out of the New York program and trip.

For the record: The Chamber simply acted on a recommendation of a nominating committee that made no recommendations for any additions to the board. However, the board did not, according to our sources, react favorably to a letter it received from a member of the city council insisting that Smith be named to the board.

Did the Chamber act wisely? This might shock my readers but Smith should be on the board and, for that matter, so should Weekly Publisher **Josh Gross.**

There is some history here, too. Some years back before **March Schwartz** sold the Courier to Smith, he too had a Chamber problem. Schwartz tried to convince the then Chamber leaders to hire two people Schwartz felt could increase membership. The two, a couple with strong sales and newspaper experience, were not retained and Schwartz launched his own crusade against the Chamber that lasted many years.

When **Marty Barab** became Chamber president in 1997 he worked to heal the breach, inviting Schwartz to join the Chamber board which he did. Schwartz served two years, first under Barab and than with his successor **Richard Rosenzweig**, probably one of the best leaders in the Chamber's history. The peace period ended when **Tom Korey** became Chamber president in

1999. Depending on who relates what happened, apparently Schwartz did not think Korey's invitation to Schwartz to remain on the board was offered with sufficient enthusiasm, and March stopped serving.

Before Schwartz was invited to become a board member, a long line of newspaper publishers were on the Chamber's board. The Beverly Hills Citizen owner and publisher **David Heyler** was a major player on the board as was the Courier's one time rival, **Walter Harris**, co-publisher of the Beverly Hills Post. In fact, Harris also served on the board of the West Hollywood Chamber where the Post had a satellite publication.

Newspaper publishers are very much a part of the business and civic life of the community and most Chamber's welcome their membership. Yes, this sometimes means competing papers are both on the board, but so are businesses that appeal to the same customers.

The Chamber knew what was likely to happen when it denied membership to Smith – and while Smith was less than candid for his reasons for attacking the Chamber, not once mentioning his failure to be nominated, the escalating dispute is not good for the business community or the city.

There are two legally recognized, that means adjudicated, newspapers in Beverly Hills: The Courier and the Weekly. What is difficult to explain is the inclusion of a representative of a magazine, Los Angeles Confidential, on the board and NO community newspaper. Putting aside issues of methods, the Chamber should invite Smith, and Josh if he would accept, to serve. As for Smith's questions about financial support from the city, a Chamber official told this column that the financial reporting and reviews conducted by the Chamber are at the highest and most professional levels in its history.

The Chamber insists that it does not receive money from the Chamber, only funding for economic development and tourist promotion. Yes, but this money does go through the Chamber which controls both the Visitor's Bureau and the EDC

The Chamber argues that in any case the funding is actually from the transit occupancy tax (the bed tax) paid by visitors to our hotels. Of course, visitors also use and depend on other city services, including first rate police and fire protection.

This might, inadvertently, be a good time to consider one reform: Separating the Visitor's Bureau and making it totally independent from the Chamber. Promotion of tourism should be the responsibility of the city's hotels and they should manage an independent agency, funded through the TOT.

On the plus side, this Chamber has some excellent professionals and can point to some solid achievements in tourist promotion and economic enhancement. Smith aside, the Chamber has also brought back into the fold great leaders such as Dick Rosenzweig, **Ali Kasicki** and **Fred Hayman** who left when their Economic Committee was diverted from city funding.

The Chamber focus should be on business promotion and it will be a far more independent organization if it is less dependent on the city, as some recent conflicts has shown. Final thought: Understandably, many board members reacted negatively to what they perceived was "outside" pressure on their board membership selection process. This is not really about Smith, but on the importance of including community publishers on the board. I still will differ totally with Smith on almost every imaginable issue from immigration reform to his attacks on "liberal" Democrats. But he and Gross provide a much needed service to our city and they can and should serve on the Chamber board. Both sides need to chill.

The Maple Counseling Center gala was just that. It was produced smoothly with the honored guests actually being presented before people headed for the exits. **Linda** and **Gary Briskman** received the Center's top award and, a new tradition was established: the public official listened while the spouse accepted the honor. Gary, not Councilmember Linda, gave the responding comments and did so with clarity and warmth. **Sue Brucker, Lonnie Delshad, Judie Fenton** and **Jim Krasne**, warm up.

that count. Explaining away, relativizing and even denying that problems exist is not the kind of experience that counts.

Assuming a Panglossian attitude towards the state of the District is not going to protect our students' psyches either. They're not stupid and acting as if we can "protect" them from reality isn't doing them any favors. They can't help but notice that their schools' test results are no longer the tops in the state, let alone the nation. They can't help but see that their neighbors, including incumbent Lurie's own son, aren't attending public schools because the public schools can't offer them the same quality of education as Harvard-Westlake and other private schools. They can't help but see that their neighbors are going to Yale, Harvard and Stanford and that they aren't.

And herein lies the key to dealing with the issue of declining resident enrollment in the District's schools. Most parents want their children to have the best possible education and to go to the best possible universities. Many residents are prepared to pay huge, non-tax deductible sums of money to send their children to private schools. Does anyone really think that most of these parents would send their children to private schools if the public schools of their own community could achieve the same or better results?

In fact, if the BH schools were able to maintain the same or higher standards of excellence than top private schools like Harvard-Westlake, there would quite naturally be an incentive for parents with school age children to move into BH. And in addition to being a huge factor in strengthening the sense of community, such an influx of families moving into BH for the schools would be good for property values, a matter of concern to many residents who don't have school age children.

Former Board member Melvin Spitz, who led the Board in the salad days of the 1970's, when the BHUSD was recognized as one of the finest districts in the nation, has written and circulated a document entitled "A process for restoring the preeminence of BHUSD." The first point in this plan is:

Establish a Mission Statement including as prime objectives delivery of a scholastic program second to no other school district in California, public or private; educating and guiding the District's students to achieve superior standard test results; and fostering acceptance of BHHS graduates by universities and colleges of their choice.

The current and future Board should take a cue from Spitz and formulate a Mission Statement with the stated goals of excellence, as well as follow the other points of his plan. The fact that the current Board hasn't taken any such initiative to date is only one more reason to give challengers Fenton and Goldberg a chance to give the Board a new, better direction.

Very simply, it is time for the state of denial to end and for action to be taken.

While it is most unfortunate that Spitz himself is not a candidate in the upcoming elections, his process for restoring the District's educational preeminence can and

I have just read John Mirisch's letter to the editor [Issue 420] and would like to take this opportunity to respond to his critique of Beverly High, while at the same time commending him for the passion and concern that prompted him to put so much time and thought into the composition of his letter.

I can't address each and every point, however I would like to make a plea to Mr. Mirisch and the community in general to stop comparing Beverly High to Harvard Westlake; it is nothing short of absurd to do so for many reasons. The most important and obvious of these reasons is that Harvard Westlake is a private school that one has to apply to, one has to be admitted to, and whose students are chosen from a very large group of applicants coming from far flung communities in the greater LA area. These students, many of whom come from affluent and philanthropic families, are chosen because of test scores, because of talent in the arts and sports, because of their families' already existing affiliations with Ivy League and other selective schools and for many other reasons which make them far more

likely to want to attend, to be qualified to attend and to be accepted by those schools. I take exception to the constant compari-

son of our student body as being somehow inferior to the student body of the oft talked about "golden years" at Beverly. As a 1973 Beverly graduate, my educated guess is that the number of students attending Ivy League schools now is comparable to then, even despite the fact that the pool of applicants to these colleges is so much larger. Furthermore, it took a relatively easy 3.1 average and a 1050 SAT score to get into a school like UCLA at that time, and the large amounts of students attending SMC from Beverly now would surely have been accepted to a UC school then. The world has changed....for the better in many respects....with many more students throughout the world now applying to these schools, and thus the bar has been raised for our students and a 4.3 and about a 1400 SAT score is now required for UCLA, for example. It is important to note that we still do send a large number of students to UC schools, despite the fact that acceptance rates to these schools are so much lower now. In fact, we have 81 students from the class of 2007 attending UC schools, and 55 of our students were accepted to UCLA. Those are quite impressive numbers indeed.

Three of my children have graduated Beverly High, and one is now a freshman at Beverly. Over the last twenty years that my children have attended school here, I have been impressed and delighted with the caliber of intellect and quality of their friends and also with the wonderful and caring teachers they have had. I can safely say, knowing so many young people from the private schools in the area, that these Beverly kids have gone on to excel in college and, importantly, graduate school in a comparable way to their counterparts from private school. In the meantime, they have benefited from all the advantages of attending a neighborhood school, and due to the size of the school, have had many young people to choose from as friends and study partners.

I am of the mind set that acceptance numbers to Ivy League schools is not the only way, and certainly not the best way, to gauge the success of a school system. I have been so pleased to see my children exposed to an interesting and multi-faceted student body, coming from different socio-economic and cultural backgrounds. The largeness of the school gives the students opportunities that they wouldn't have had in a private school. A public school such as Beverly High is mandated to address the needs of all kids, not just the high achieving ones, and many of our kids have benefited by being able to, for example, participate in a sport, even though they do not excel in it. This is something that might be harder to do in the more competitive atmosphere of a private school. The ambitious and high achieving student at Beverly will find a myriad of AP and Honors classes to choose from, while the student whose path is not yet clear, or whose ambitions might lie in the arts or other areas will find classes and extracurricular activities

which are offered to help that student find his area of interest and strengthen his skills.

I would be interested in knowing how Mr. Mirisch acquired some of his statistics; I am under the impression that actually attrition to private schools is lessening, not increasing, and I further submit that the skyrocketing real estate prices and lack of affordable housing in the area is not the district's fault, nor can we push back the clock to the days when commutes were short, traffic was light, and teachers commuted more easily from the South Bay, for example, to Beverly Hills. So many things have changed in the last decades: the schools' budgets, the commute time for teachers, the huge amount of standardized testing requirements that the teachers of my time didn't have to deal with and the list goes on and on. Yet our schools are still producing wonderfully accomplished graduates who go on to succeed and excel in the field of their choice. We need to deal with and accept the reality of today instead of looking back to the "good old days," which were far from perfect, in my opinion

One final point that I make directly to readers of this letter who are debating between BHUSD schools or a private school:; the transparency of a public school system allows the readers to know the good and the bad of our schools. Private schools do not have this transparency, do not belong to a community, do not have letters to the editor written about them in a public forum conducive to debate nor do they have week-

BHHS Football Team Edges Santa Monica

Norman boys' water polo team remains undefeated in league play. By Steven Herbert

Ramon Judkins ran for 279 yards and three touchdowns on 26 carries, but one play he made on defense spared the Beverly High football team from disappointment Friday night.

Judkins tackled Santa Monica quarterback Ryan Katz a half-yard short of the goal line on a two-point conversion attempt with 14 seconds to play preserving the Normans' 28-26 victory in an Ocean League game at Nickoll Field.

The tackle and accompanying victory means that if Beverly Hills wins its next two games against Inglewood and Inglewood Morningside, and Santa Monica loses to or ties Culver City Friday, the Normans are assured of at least a second-place finish in the Ocean League and would be spared from playing a league champion on the road to open the Southern Section playoffs.

Beverly Hills (3-3-1, 2-0 in league play) took the lead for good on Dex Lucci's 21-yard touchdown pass to Dominque Sandifer late in the first half, breaking a 14-14 tie. After a scoreless third quarter, a Viking touchdown cut the lead to 21-20, but the extra point kick failed.

Judkins' third touchdown put the Normans up 28-20. Santa Monica (4-3, 1-1) scored again, setting up the potentially tying two-point conversion attempt.

"Ramon was defending the tight end and Ryan Katz had the option to throw to the tight end or run it in himself," Beverly Hills coach Carter Paysinger said. "Ramon took away the tight end as an option. Once he saw that Katz was going to put his head down and was going to take it in, he came off the tight end and made the tackle."

The Normans played "inspired and aggressive" against Santa Monica "in a great high school football game," Paysinger said.

The Beverly Hills defense "played great versus the run," Paysinger said.

The Vikings were ranked seventh in the Southern Section Western Division poll released Oct. 15. The loss knocked them out of the Top 10.

Paysinger praised the play of Judkins, Sandifer (10 catches for 108 yards), the Norman offensive line and defensive back Dewayne Taylor. Linebackers Nathan Forrest and David Saedi and defensive end Michael Kerman "probably had their

best games," Paysinger said.

What's Next?

The Normans are scheduled to play host to Inglewood (3-4, 1-1) Friday at 7 p.m. at Nickoll Field in their homecoming game. The Sentinels defeated Beverly Hills, 20-0, last year, ending a 14-game losing streak to the Normans with their first victory in the series since 1983. Injuries forced Beverly Hills to play its No. 3 quarterback, Erik Munzer, for much of the game. Inglewood also ended the Normans' 169-game streak of avoiding being shut out, which dated back to Oct. 25, 1991.

A homecoming game is always a challenge, Paysinger said.

"The activities leading up to the game can be distracting," Paysinger said. "In any sport, you try to keep every week as normal and routine as possible. This week is anything but routine." The two teams have one common opponent, Palos Verdes, which tied Beverly Hills, 15-15, Sept. 7 and defeated the Sentinels, 44-13, Oct. 5.

coverstory **IS BEVERLY HILLS PREPARED** FOR A BRUSH FIRE?

Potential fire danger remains a possibility By Elisa Osegueda

The Southland fires, weather conditions, and low density have some residents asking how prepared is the city for a wild fire? In January, the Weekly asked "Could the Malibu fires happen here?" [Issue 382] Fire officials at the time said "absolutely." Has anything changed?

Newly appointed Beverly Hills Fire Chief

Timothy Scranton said the fire department continues to closely monitor the fuel density, weather and typography in the city.

Since the neighboring Bel-Air fire in 1961, Beverly Hills has not experienced a major fire close to its borders, but the prolonged Santa Ana winds and low humidity caused the Beverly Hills Fire Department (BHFD) to declare a Tier 2 Red Flag Alert, on Monday, in northern parts of Beverly Hills including the Calle Vista area.

"Because of low humidity, winds and other weather conditions [make can to prevent that," said

Scranton. "That is why we are doing the additional staffing so we can get a quick jump on any fire that may occur as well as patrolling in the north end."

Among the additional fire preventions, the BHFD added an extra battalion chief, staff assistant, incident commander and two paramedics. The City also recalled all offduty personnel to staff additional fire apparatus and provide fire patrols in the high fire hazard zone north of Sunset Boulevard.

According to Scranton, a Red Flag condition is categorized in two tiers.

"Tier 2 is when we staff another complete fire engine and put it in the north end of town at fire station No. 2 staffed with four people," said Scranton. "The mission is to help patrol and assist Fire Engine No. 2 in the North end on any type of a brush response."

North of Sunset Boulevard is considered a high risk zone because of the high steeps, which include the residential hillside areas of Trousdale, Benedict Canyon and Coldwater Canyon.

"Steep canyons can potentially race up in a time of fire," said Scranton. "[That's the reason] why we have an extensive brush clearance program to reduce fuels around peoples homes so that if a fire does happen

tion Scranton said the logistics have been carefully thought out and fire department is ready to implement the tactics.

"We have people predetermined to staff the emergency operation center. We have an incident action plan that we have created with radio frequencies, predetermined positions, and so forth," said Scranton. "We have all of these logistical issues already in place so that the minute we are notified of any type of incident all of this goes into play."

As the City prepared itself for a possible brush fire BHFD Captain David Grate, Engineer Victor Gutierrez, Firefighter Dan Maher, and Firefighter Bradford McHenry were sent out to assist Malibu firefighters early Sunday morning, and by Monday afternoon were on their way to help Orange County.

According to Scranton two fire department personnel needed to return to their homes and evacuate their families this week. The fire department released them and immediately 'back-staffed' their positions.

"I am deeply concerned about what took place this weekend," said Bronte. "Just north of our City are many acres of dried brush making us extremely venerable to the type of fires that occurred this week."

During Bronte's time on the Council in the 1990's, an ordinance was approved requiring all palm trees on private lots to be trimmed regularly, said Bronte.

As of Wednesday, the areas of Schuyler and Calle Vista by Doheny continued to be on a red flag alert due to the brush coming in from Franklin Canyon.

"Due the strong winds, hot embers can travel for miles and can land on roof tops and in the dead dried fronds of these trees. With in seconds they become tiki torches and can ignite a neighborhood," said Bronte.

According to Scranton, keeping the trees trimmed and appropriately maintained is a good fire safety measure.

"There has been an ordinance for many years where you have to have a class one roof assembly," said Scranton. "Mayor [Jimmy] Delshad has made a diligent effort

to make Beverly Hills a more fire safe city by enforcing non-combustible roofs. They are making every effort legislatively to make this a safe city."

As a member of the Community Emergency Response Training (CERT) Bronte says this program teaches residents how to deal with life threatening conditions and is a good way to learn about community safety.

"The purpose is to train residents in self-survival in an event of a man made or natural disaster," said Beverly Hills CERT Coordinator Sonia Berman.

Members receive 28 hours of training, in which they learn about

"preparedness, shutting off gas-electricity, putting out small fires, what to do after disasters, first-air, CPR, and how to extricate bodies," said Berman.

Although the program teaches various safety procedures, Berman says the program doesn't teach resident how to address wild fires.

"There is not much you can do right now but follow the instructions of professionals," said Berman. "We never know when nature or man is going to put us in a position of needing to be prepared."

Scranton assures residents that the fire department and police department are taking ever effort to secure the city.

"The city is safe," said Scranton. "We have taken the proactive approach of becoming self reliant because we know resources are very scarce.

that is why we are taking Bedford Drive, and the untrimmed palm tree pictured is on the 600 block of North Rexford Drive. The Beverly Hills Fire Department recommends that all trees be trimmed every precaution that we

it gives us more of a dispensable space and allows us to save homes."

If a fire similar to what residents in Malibu or Orange County are experiencing were to occur in Beverly Hills, Scranton says the fire department is ready.

"We have taken every precautionary measure that we possibly can. Every piece of equipment that we own is staffed right now. We are doing everything that we can proactively not only to respond but to keep our eyes open with the collaboration of the police department, public works," said Scranton.

If a fire were to occur in Beverly Hills, Scranton says one of the tactics they may use would be to "take each side of the fire and put it out, and ultimately pinch it off on the top," said Scranton.

The BHFD has an incident action plan called Operation Safe Guard. Although, the action plan contains confidential informa-

"Two off-duty Beverly Hills firefighters went to another firefighters' house, [a firefighter who] was on the 'strike team' fighting fires in Malibu, on their own time, and put out spot fires on his property and his neighbors' property. Again, they volunteered their time and expertise and saved structures," said Scranton.

The original strike team that left on Sunday for Malibu is now deployed in south Orange County and is expected to remain there at least through today. Battalion Chief Ralph Mundell joined the strike team last night.

Several Beverly Hills firefighters and police officers live in or in close proximity to the Canyon Country area fires.

But Scranton clarified "no one has had any loss associated with the fire."

Former Mayor Les Bronte believes the community can take a proactive approach in fire prevention.

"Ethics Ordinance Amended by City Council" [Issue 420]

Several years ago, Council Members Brucker, along with Delshad, tried to pass a very tough Ethics Ordinance that would have gone into effect immediately. But, Brucker & Delshad did not have the required third council vote. Therefore, a watered down Ethics Ordinance was passed that for the most part mirrored the minimum requirements of state law. With Webb, Briskman and Fenton not agreeing to the Brucker/Delshad ordinance, Steve Webb was able to feather his nest so that now Webb is eligible to become a for hire real estate lobbyist in March 2008.

Last week, a new Ethics Ordinance was passed, which prohibits Council Members and Planning Commissioners from acting as lobbyists with the City for a term of 30 months after they leave office. The moratorium under current law is only for one year. But, the public should know that Delshad, Briskman, and Fenton all refused to make the new Ethics Ordinance effective immediately. Unfortunately, the effective date of the new ordinance is not until March 2009 after Briskman and Fenton are probably no longer council members.

It is particularly interesting to note that Delshad before the election agreed to make his Ethics Ordinance effective immediately. However, since Delshad was narrowly reelected and is now the mayor, he has flip flopped on his position. Why? Apparently, some council members also want to be developer lobbyists soon after they are off the council so that they too can enjoy substantial monetary rewards of pandering to the City on behalf of developers.

Nonetheless, congratulations to Barry Brucker and Nancy Krasne for pushing forward a new Ethics Ordinance. Also, congratulations to Barry Brucker, Nancy Krasne, and Planning Commissioners Furie, Bosse and Reims, all of whom have agreed to be immediately bound by the new Ethics Ordinance in order to help clean up Beverly Hills politics. Perhaps, the other two Planning Commissioners will now also agree to be bound by the new Ethics Ordinance.

Fenton and Briskman voted for the new Ethics Ordinance attempting to gain favor with voters, but both refused at the council meeting to bind themselves to the new ordinance. This allows them the option of becoming lobbyists one year after they leave the Council in March 2009.
