No substantive changes are proposed to the Bank of America building, although rezoning of the site is proposed as part of the proposed project. Demolition and construction of the office/retail building are proposed at 231-265 North Beverly Drive, which is presently developed with one story of commercial structure and a six-story parking structure.

The development agreement proposed between the City and the applicant would vest the applicant's rights to develop in accord with any approvals of the project that may be granted for a specific period of time, along with other terms.

The Draft EIR was released on July 10, 2007. Garrison sentenced to 40 months in prison for death of Beverly High Student Vahagn Setian

Lane Garrison, ex-"Prison Break" actor was sentenced yesterday to 40 moths in prison for the fatal DUI accident that killed Beverly High student Vahagn Setian. On August 2 Garrison was ordered by Superior Court Judge Elden S. Fox to complete a 90-day psychological evaluation [see Issue 412], which he will receive credit for, reducing his sentence.

Garrison must also pay approximately \$300,000 to the Setian family and the other two victims injured during the accident. Despite a community petition, sent to Judge Fox, with over 3,600 signatures mandating that Garrison be given the maximum sentence, Judge Fox decided not to accept delivery of the petition.

1,750 Ballots Returned So Far

"We are very saddened by Leonard's passing," said Beverly Hills Mayor Jimmy Delshad. "On behalf of the City Council and all City employees I would like to extend my sincere condolences to his family."

Horwin's election is remembered as a turning point in city politics. He ran on a slate for City Council with Frank Clapp beating incumbents Jack Freeman and Lawrence G. McNeil.

According to retired Beverly Hills attorney Julian Isen, who was also a longtime friend and member of Horwin's political campaign, the Chamber of Commerce and developers controlled the city politics in the early 1960s.

"The City Council continued to grant their spot variances and our group [of community members] decided that the only way to stop the City Council was by electing Leonard [Horwin]. It took him two minutes to decide, and then we got the second candidate, Frank Clapp, who we always saw at City Hall trying to stop [the variances]," said Isen.

Horwin won the 1962 election with 4,219 votes along with Clapp who received 3,946 votes, beating Freeman with 3,122 votes and McNeil who obtained 2,761 votes.

As the winning team, they reduced variances that affected building height limits.

"They both worked hard and were integrated in Beverly Hills and had wonderful connections with Washington people," said Horwin family friend Marion Leiser Lipofsky.

During Horwin's term in office Lipofsky said, "People cared more, they got involved more. The city was a smaller community and better to manage," said Lipofsky.

According to Lipofsky, Horwin was trying to make a difference.

"[He was] really trying to make Beverly Hills a wonderful city. Things have changed now, it is just not the same anymore," said Lipofsky. "He was a worldly fellow, spoke many languages and he was one of those people that when he talked to you, you were the only one in the room."

According to Isen, Horwin influenced Beverly Hills for 20 years.

[The current Council] is doing the same thing that the Council was doing back then in the 1960s to the detriment of the City," said Isen. "The only difference is that there is no Leonard Horwin to run against the incumbents."

Horwin also played a pivotal role in acquiring Greystone Mansion, first built by the Doheny family in the late 1920s.

Horwin was a strong supporter of Israel and his previous work with the U.S. government granted him personal relationships with world leaders.

He was a former counsel U.S. Board of Economic Warfare, member U.S. War Production Board Program Adjustment Committee (1942-43), former U.S. diplomat, attaché, legal advisor U.S. Embassy, Madrid, Spain (1943-47), and former U.S. representative Allied Control Council for Germany (1945-47).

In 1931 he established a newsletter "Plain Talk" in 1931 where he discussed national and international issues. He was also the author and publisher of "Insight and Foresight."

"At his funeral his son said Leonard could have been president," said Isen. "And I said to his son, Noel, Leonard was too honest and bright to be president. He could have been a wonderful Attorney General or Secretary of State. Leonard was a giant, an intellect, honest, he was the

brightest man I ever knew.

Horwin is survived by his children Noel and Lee. His wife Ursula predeceased him.

Very few industries or professions are so self-destructive. I doubt, as only one example, that any airline would ever list the number of fatal accidents of a competitor. Does it really serve our city to imply that our schools are falling apart?

Compared to other communities, our political campaigns are usually fairly mild. But even some of our most sophisticated observers were somewhat shocked this week by a mailer hitting hard at all the members of our board of education and, whether or not that was the intent, at our teachers and administrators.

I doubt if any reasonable person will buy into the argument that our schools are in really terrible shape, and certainly not the parents. Although it is the responsibility of the candidates to respond to the overblown charges, our school system continues to be the envy of other districts and people still come here because of our schools.

Of course, there are very legitimate issues that can and are being discussed campaigns do serve an important opportunity to focus on present and future needs of our schools. But candidates need to be careful not to exaggerate or use smear tactics - the ultimate victims of denigrating our schools are the kids.

Test scores are not going down. There was a big jump recently followed by a leveling off that, playing with numbers for political reasons could imply a down slide. That is simply not factual. Successful schools are the result of good education policies, talented administrators, dedicated teachers and parents and children willing and able to use the opportunities we provide. Since nothing happens immediately, if there is any validity to the overblown attacks on our schools it means that every recent administrator or school board member, not just the present team, must have been failing. It also means that our PTAs are indifferent, and, of course, they are hardly disinterested.

Unfortunately there are problems in communicating. Whether or not teachers should give students test score results has led to some very hard feelings. However a reasonable solution should be found.

Injecting this into the election is not really constructive.

Two of the present board members are seeking reelection. Considering the intensity of the hit pieces, you might wonder why they would even want to serve. Myra Lurie and Alissa Roston have given our district a good part of their lives because they care about our schools. They should be reelected, and they will be. Steven Fenton has been an incredible campaigner and has stimulated some discussions on education policies that have been, mostly, constructive. He will be a good addition to

the board. None of these three has resorted to negative campaigning.

Calling the election: A former board member, who is a good election watcher, thinks the two incumbents. Myra Lurie and Alissa Roston, will run first and second and that Steven Fenton will edge out Brian Goldberg for the third seat. Maybe, but Fenton has run a very strong campaign, walked every street in the city and should win comfortably. Lurie ran first in her initial campaign and has put together a very strong coalition of supporters as have Roston and Fenton.

Final election note: I am the last person to find fault with anyone's spelling, syntax or typos, but then I am not a candidate for school board Considering that Goldberg's mailer gave the current board "F" ratings, surprised to see his spelling of "exodus" (for the loss of teachers) came out as "exdous" along with other errors in his campaign piece. Can't give him a passing grade. Last week we gave Lurie, Roston and Fenton our highest well qualified rating.

You do have three votes and your ballot does matter. There have been board elections decided by one vote!

On a more cheerful note, the city has decided to televise planning commission meetings and that does make more informed citizenry. Now, the school board

and the city council should work out their meeting schedules so they don't conflict.

It was, for many years, the practice to have meetings on alternate Tuesday's, and never on the same night. They shouldn't be fighting for ratings.

Josh and I will be doing our usual election night show next Tuesday with results and interviews, but don't expect immediate news on who won and who lost. The election is managed by the county and not the school district or our very able city clerk staff.

The first, early returns will be the absentees. This year the absentees will probably outnumber the walk in vote and once the absentees are reported, there is often a long delay before the balance of the votes are tabulated. Twice in recent elections, the county computers system failed.

Also, although this is very unlikely, if there is a close vote, the so-called provisional ballots will not be counted until later in the week or even longer. The provisionals are mostly absentee ballots that are mailed too late to be verified, ballots challenged for various reasons at the polling place and absentees delivered to polling stations.

Although we will be on KBEV/Channel Six at 7:30 p.m. with some election analysis, no candidates or their supporters will appear until the polls close.

Leonard Horwin died last week (see story on page 3) and with him a part of our history that is unlikely to be repeated. Leonard ran with Frank Clapp, as a dual entry. We have had few such slates in recent years and when it was tried, it most often failed.

Horwin and Clapp – a leader of an early Christian Science community that at one time played a large historic role in civic affairs, won by bringing together residents from every section of the city who had fought developments, and especially the practice of granting zoning variances for above height limit buildings. It wasn't just their opposition to new construction, but the variance practice that concerned residents.

It was also the first city council campaign I managed and the support team was incredible. Sooky Goldman assembled a committee that united almost every segment of the community. These include Phyllis and George Seaton, George Slaff, Leonard Low, the Lipfosky and Isen families, Armin Wittenberg, Edith **Snapp** and dozens of others.

Seaton, a former president of the Motion Picture Academy, was the name we used for our final mailer. The night before the election, the Academy gave him their prestigious humanitarian award. That's not something we could have planned. Horwin received more votes than are usually cast for all candidates in council elections

Horwin spent a life time of involvement in local, state, national and international affairs and he did it with style, class and enormous integrity. He will be missed.

The Sentinels scored the game's final 19 points on Marlon Johnson's 15-yard second-quarter touchdown pass to Keilenn Childs and 18-yard third-quarter touchdown run and David Freeman's five-yard fourth-quarter touchdown run.

Dominique Sandifer and Sae Bin Park drew praise from Paysinger for their play for the Normans.

The loss dropped Beverly Hills into a tie for second with Inglewood in the six-team Ocean League, a game behind league-leading Culver City (8-0, 4-0) and one game ahead of Santa Monica (4-4, 1-2) and Inglewood Morningside (4-4, 1-2).

IS GOLDBERG REALLY A "PROFES-SOR"?

The candidate refers to himself on his resume and on the voting ballot as a "Professor" at the American Jewish University (formerly known as The University of Judaism). The fact is that the University's website specifically does not list Goldberg, as a "Professor", but a "lecturer". This distinction in rank and professional designation is significant and misleading to the public, especially in an election for School Board.

In fact, when I called the school, people in 5 departments did not even recognize his name. Finally, one employee told me that, while she does not know who he is, it is likely that, since his name sounds familiar, he may have lectured there about one or two years ago. The truth is that Goldberg occasionally teaches a class unrelated to education and would not even be lecturing at that school during his political campaign for this high Board of Education position.

IS GOLDBERG REALLY THE CEO of CASA de la FAMILIA?

Again, Goldberg has stated in his credentials that he is the Chief Executive Officer (CEO) of a social service organization called "Casa de la Familia". IRS Form 990 for this non-profit organization which is filed with the California Department of Justice, Attorney General's Charitable Trust Division, shows that Goldberg is not, in fact, listed as its CEO, but its Chief Financial Officer (CFO) who only works two unpaid hours a week for the organization. The organization's true CEO is actually a woman named Ana Nogales who, according to the public record, works 20 hours per week for this small organization whose total assets are listed as minus \$12,000.

Repeating, Mr. Goldberg, according to the public record, worked 2 hours per week, is not the CEO as he stated, received no pay for his position, as well as did NO counseling or clinical work for them. These are major exaggerations and misrepresentations to our voting public that carry potential negative ramifications for our school district and for the welfare of our city.

WHY DID GOLDBERG LEAVE THE MAPLE CENTER AS ITS EXECUTIVE

DIRECTOR IN LESS THAN ONE YEAR?

This has been a question in the minds of many residents, but is not a subject that Maple Center Directors are apparently able to speak about. Without knowing the specific circumstances surrounding his departure, it is clear that he parted company with the organization before completing even his first year of employment.

HOW MANY JOBS HAS GOLDBERG HAD IN RECENT YEARS?

In my opinion, a quick check of public records and Goldberg's actual resume will show that he has bounced from job to job and city to city. Is this the stability of a person who will best represent the interests and understand the institutional history of our residents?

WHY WON'T GOLDBERG STATE WHETHER HE SUPPORTS STUDENTS' **RIGHTS TO HAVE THEIR TESTS RETURNED?**

Goldberg is the only candidate who gave a practiced change-of-subject answer at a recent candidates' forum when asked about the issue of returning-of-students-tests upon which the teachers support him. The other 3 candidates supported the rights of students and their parents to view their test results at home so that they can study and learn from their mistakes. This subject has become a major point of contention between School Board and our increasingly militant teacher's union. Even after their recent pay raises and increases in medical benefits, the union is said to be staunchly opposed to the return of tests, despite the educational value of this practice. Many have concluded that this test return issue forms their true reason for the union's support of Goldberg's candidacy, despite his lack of any actual credentials or experience in our school district. The union will relate to you many reasons for their mailers that attack the two student-friendly and effective incumbents; however, I believe that these attacks are nothing more than union "pay-back" for the incumbent's insistence upon the rights of students and parents. Again, all of the other three candidates stated that the returning of tests to students was warranted as a valuable means for them to learn what they did wrong on their tests. Yet, candidate Goldberg avoided answering this key teacher-related forum question.

This candidate is a newcomer to our city. This, in itself, may not be a problem if his credentials were adequate, his experience in other schools provided the students with expert aide or, at the least, he had a successful administrative background that was worth using in the district. Also, initially, having few core supporters, he is the only candidate who has hired an "outside" professional promotion company to present his case for election to you. Their "Had Enough" mailer was full of inaccuracies and misstatements, and irresponsibly tears down our district. He has misrepresented the achievements of our school district, which has recently seen a very admirable thirty point increase in the API scores district-wide.

It appears that the teachers union does not care about any of these concerns and will continue their politically motivated attacks on two of the most dedicated and effective BH Board of Education Members who ever served, Myra Lurie and Alissa Roston. For

editorial Steven Fenton IS The Man with a plan

On Tuesday Beverly Hills voters will elect a new Board.

As far as the media goes, there is no bigger champion of our Beverly Hills public schools than the Weekly. But as supportive as we are of our schools, we also don't sweep tough issues under the rug. We feel the best way to solve the district's problems is to confront them head-on, with a vigorous community debate, similar to the one we've seen in our letters to the editor over the past few weeks.



Incumbent Board: Good people, but so wrong on the issues

We want to state from the outset that the incumbents Myra Lurie and Alissa Roston are good people and our differences with them are not personal, but entirely on the issues. We like the incumbents personally, but their agenda of the past four years has badly failed.

For reasons which we will explain, we believe under its current leadership, the district is headed in the wrong direction. Only one candidate, Steven Fenton, has the combination of experience and vision that we believe will help put out schools back on track.

I. AN EXCITING-AND LONG OVERDUE- CAMPAIGN

Our schools remain among the top, but it certainly isn't because of anything this Board is doing. What's amazing is that our schools are as good as they are in spite of this Board.

This is our first election in four years, after the 2005 Board election was tragically cancelled when only two candidates filed. One of the reasons why so much anger came to the surface in this campaign is because the voters were denied the opportunity in 2005. Anytime you hear an incumbent make the hollow argument "let's cancel the election and save the school district some money instead", it's always nonsense. So too was this case in 2005.

Thankfully this year, we had a good, old-fashioned election. We applaud candidate Brian Goldberg for running and forcing the issues. While we feel he needs to build a wider base of support before we can endorse him, we'd like to see him run again in two or four years with a better organized campaign, assuming he is not victorious on Tuesday. Admittedly this Board had a handful of successes.

Successful projects of the last four years include the rehabilitated and breathtakingly beautiful Beverly Vista B building and auditorium (remember when the "green ribbon" crowd at BV wanted all of the brick buildings – including the auditorium—to be demolished?), the new turf field at Nickoll field at Beverly High, and the new Science & Tech building.

Yet if this is a district built on collaboration, teamwork, and "respect" (the official BHUSD motto), why is this Board trying to hog all of the credit for these projects?

If you look at the plaque outside the Science and Technology Center, two things come to mind. First, when did Superintendent Kari McVeigh earn her Ph.D.? It's not listed on

her resume, which only indicates she has a Master's degree, nor on the district's website or stationary. We'd be shocked if the Superintendent misrepresented on the plaque having a degree she does not actually hold, especially when misrepresenting credentials is an allegation the incumbents have made against challenger Brian Goldberg. Second, why does this Board list only their own names, completely omitting the four other former Board members (Brien, Brucker, Lunn, Maas) two former principals (Bushman, Stepenosky) and two former Superintendents (Gross, Hubbard) who spearheaded and passed the 2002 school bond, approved the plans, and made the building a reality?

Just as with our former administrators, apparently this Board believes in no continuity.

II. READ OUR LIPS: NO NEW PERMITS

The sharp explosion in the out-of-district permit issue has been covered extensively, starting with our own story over a year ago in issue #370, and again more recently in issue 417. However a few points are worth repeating.

Through their votes and actions, this Board is attempting to turn the BHUSD in to a **regional** school district, not a local one, by over-enrolling certain grade levels.

This Board has made it clear they have no problem with additional permits. In fact, they think they're great. When the subject was discussed at their meeting in March, Board member Nooshin Meshkaty said that additional permit students were desirable because "they help raise our test scores on standardized exams".

We disagree with Meshkaty when she suggests that Beverly Hills students are somehow too stupid to learn, and that we need to rely on outsiders to raise our test scores.

It's also a bald-faced lie when the incumbents argue that "they aren't adding classes to accommodate permit students".

They absolutely are adding, or **at the very least maintaining, surplus classes to accommodate permit students.** Take for example the district's Kindergartens, where we're offering 11 sections at the four elementary schools, despite the fact that we only have enough local children to fill 9 sections (see issue 417).

At Horace Mann, 36% of the three kindergarten sections (totaling 18 students) is on permit – **that amounts to one whole homeroom of kids that don't live here!** And that's only at the kindergarten level alone.

As this Board's reckless permit program continues to spiral out of control, it could even threaten the future of the JPA, because **do you really think future City Councils are going to keep giving \$9 million annually to educate other cities' kids?**

What happens when other grade levels start to approach 40% on permit? Then what are we going to do? This Board's answer is to do nothing.

We agree declining enrollment is a very real problem, but the answer is to confront it head-on with creative solutions (like a BHUSD-run pre-school, see discussion below), not just to open up the gates and let in everyone who wants to come to school here.

Meanwhile, staffing in the district office's educational services department has ballooned from 2 staff members in 2003 to 10 in 2007 (including 4 teachers on special assignment)! Bear in mind that each teacher on special assignment annually costs us \$70,000 or more, when in reality these teachers should be back in the classroom.

So are all these extra permits going to support extra program, or are they really going to pay for more mid-level administrators and outside-the-classroom bureaucrats in the district office?

Rather than absorb sections over time with resignations and retirements, this Board defiantly believes runaway permits are the answer. We disagree. We want Beverly Hills schools for Beverly Hills kids, and we're not backing down.

III. PHANTOM ADMINISTRATORS

Do you recognize the names Liz Hicks, Aviva Ebner, or Joseph Leppert? Probably not, because these are principals or assistant principals that this Board hired **who left the dis-trict after less than one year on the job.**

Perhaps they weren't a good fit for their respective schools? A few bad hires would be excusable, were it not for the fact that **this Board knowingly skips over more qualified internal administrative applicants, in order to bring in outside applicants who tell them what they want to hear.**

Only 4 of the current 16 principals or assistant principals actually taught in the BHUSD (Cherniss, Painter, Schaeffer, Staser). Contrast that with 10 years ago in 1997 when 14 out of 16 principals or administrators had taught in the district!

So is it really any wonder why so many outside administrators are leaving so frequently? It's because they don't feel invested in the BHUSD in the first place, as a district where they want to start (and finish) their careers.

Who are some of these internal applicants this Board is skipping over?

In the summer of 2006, a 29 year BHUSD faculty member was skipped over for an assistant principal position at the high school, despite being recommended by the interview panel comprised of parents, students and teachers. In his place, the Board hired an out-of-district applicant who stayed for less than a year and then resigned.

In the spring of 2007, a popular coach and 25 year BHUSD employee was skipped over for an assistant principal position, also recommended by the interview panel, in favor of another out-of-district applicant who, not coincidentally, had taught another administrator's kids in Ventura County. That's this Board's version of "promoting from within".

Over the course of this campaign, the incumbents have offered the tired excuse that "Beverly Hills has become a stepping stone district for administrators", but what they haven't paused to consider is that maybe these administrators are also leaving because they don't want to work with a micromanaging Board?

This community overwhelmingly wants administrators we know and trust; administrators who know our families and our community. We want respected school principals like we used to have with Ben Bushman, Dick Douglas, Steve Fisher, Chuck Kloes, Tanis Harris, Walt Puffer and Nadine Breuer, to name just a few.

What do all of these former principals have in common? They all started as teachers here and spent a majority, if not all, of their careers here. However these types of administrators would never be hired today under this Board's *fakakta* hiring policy.



IV. MCVEIGH: HER NEXT 6-12 MONTHS ARE MAKE-OR-BREAK

After the departure of Jeff Hubbard in the summer of 2006 (see issue 346, "Will the Last Person to Leave the School District Please Turn Off the Lights?"), the Board hired Kari McVeigh as its new superintendent.

Everyone agrees McVeigh is an expert on curriculum and instruction. But what she needs to prove the community in the next 6 to 12 months is that she can deliver on the many other areas of school operation that need attention besides curriculum.

We haven't been particularly impressed with any of the policies or themes coming from the McVeigh administration after one year. However we understand it might take more time for a superintendent to adjust to our very unique and demanding city.

When she was first selected, we voiced concern that McVeigh's previous experience in three large, urban school districts (Las Vegas, Boston, San Diego) might not translate well to the ultimate-small-town of Beverly Hills.

Over the next 6 to 12 months, we'll evaluate McVeigh on better communication and continuity with retired faculty and administrators, including the former superintendents (currently there is zero continuity); more aggressive marketing and promotion of the district (the BHUSD has produced a fabulous DVD promoting our campuses, which is certainly a step in the right direction); and progress on a pre-school, among many other much-needed changes.

V. "INDEPENDENT STUDY" FIASCO

In issue 403, and again in issue 420, we covered the embarrassing "independent study program", where, among other things, we learned students in Thousand Oaks were earning Beverly diplomas and biology lab courses were being taught out of the living rooms.

After learning the lax manner in which the program is being run, most Boards of Education would have immediately discontinued the program, and possibly even fired the director. But not this Board.

In issue 420, we learned that astoundingly students are still taking all kinds of courses on "independent study" all from one teacher, not even certificated to teach many of the courses in question.

These courses include, among others, ten students taking P.E. on independent study. Another is taking the student government class "leadership". Exactly how do you teach a student government course via independent study? Perhaps he's the ASB president in Czechoslovakia?

While we understand there may be a small handful of legitimate cases, the Independent Study program is being administered in an overly lax manner and is wide open for the potential for fraud or corruption. How can we ensure these courses aren't in reality an "easy A" for Board member's kids and other VIPs? It's a bad idea, being badly run, so we say to the School Board quite simply: show us some leadership. Shut it down.

VI. A BHUSD PRE-SCHOOL IS THE ANSWER

The Weekly first covered the obvious link between a strong pre-school program and primary enrollment in issue #375 ("Why doesn't the BHUSD have its own pre-school?")

Despite the fact that many other neighboring school districts (Santa Monica-Malibu, Las Virgenes) have booming pre-school programs, our Board continues to drop the ball. Needless to say, if the BHUSD were to launch a first-rate pre-school, there would be a feeding frenzy for spots reminiscent of the last helicopter out of Saigon.

Suddenly we'd have booming kindergarten, 1st and 2nd grade sections – not like today where 36% of Horace Mann's kindergarten is on permit (see discussion above).

Currently the City of Beverly Hills runs a pre-school that the BHUSD could, over time, absorb and take over. Currently there is little or no communication between the city and BHUSD on pre-school. The Recreation & Parks department should not be running our city's pre-school; the BHUSD should. That's because pre-school isn't recreation or day care: it's school.

Sadly, at least so far, this board has not actively pursued a pre-school because **their own kids are not of pre-school age.** They would rather rely on additional permits to sustain enrollment (see discussion above), which is absolutely not the answer. Remember, this Board's idea of "vision" is fighting with teachers about handing back tests; they haven't had the courage or leadership to envision starting a pre-school. Thankfully Steven Fenton does.

In the event we don't see start to see some significant changes in these all of these areas, we're going to need to find two new Board members in 2009. As we saw in this year's election, there is no shortage of passion for debating school issues in the community.

Let's recap. The incumbents are good people. But over the past four years, this Board has radically changed: 1) who is being admitted in to our schools; 2) the types of administrators who are being chosen to run our schools; and 3) the priorities and vision of our schools.

These are radical and unneeded departures from the way the BHUSD has been run for the last 70 years and we do not support these changes. For these and other reasons, we are not supporting the incumbents' re-election.



VII. FENTON IS THE MAN WITH A PLAN

Steven Fenton understands how and where this Board went astray.

In a speech at Fenton's kickoff, campaign co-chair Lili Bosse said "when you attend Beverly Hills public schools, it becomes a part of you". We absolutely agree.

Fenton gets it. He negotiated an impressive series of donations to benefit the athletic department from graduates Sam Nazarian and the Konheim family – over \$500,000- even before he was elected on the Board.

Fenton has offered fresh ideas and new solutions. The incumbents have suggested none (unless you consider "greening the district" a critical campaign issue,

while Rome burns). He understands why we need to start a BHUSD pre-school to combat declining enrollment. He's explained the importance of scaling back permits to a reasonable level, and was the first candidate to courageously articulate this.

By profession, Fenton is a talent manager. We know he will use his professional negotiation skills to better the district and its relations with faculty, staff, the City Council, and other interest groups.

Fenton grew up here, graduating from Horace Mann and Beverly High. He understands what makes Beverly Hills great and what could once again make our schools great, too. We not only believe him, we can't wait to see him get started.

The Weekly recommends a vote for Steven Fenton.
