Approved ordinance targets Beverly Hills homeless

Proposed program establishes standards of conduct on public property By Elisa Osegueda



Beverly Hills is not the only city facing homelessness issues. Approximately 80,000 homeless people reside in LA county.

The cause and effects of homelessness have been issues the City of Beverly Hills has tried to amend. After hearing both the residential and business communities the City has decided to move forward with the adoption of an ordinance that would limit the conduct of homeless people in public property. At Tuesday's formal meeting the Council voted unanimously in support of the ordinance that may go into effect as early as January of 2008.

According to Director of Human Services Maria Rychlicki, the Human Relations Commission and staff recommended to the City to support the CLASP: Changing Lives and Sharing Places program that would help address all community concerns regarding homelessness.

"A large number of the homeless people in Beverly Hills have a mental illness or suffer from paranoia, which makes them not want to go into any program. They may have also had a bad experience at a shelter, which at times they magnify into something they can't get over," said Rychlicki. "By having an outreach team that is trained to work with these types of homeless people we have a better chance of getting them into these services."

Vice Mayor Barry Brucker says the ordinance will help "curve criminalization, because what good is it to throw someone in jail and have them released back in the street and be no better off."

The first step according to Rychlicki is to get homeless people to try to engage in the

"The second step is the ordinance, which allows the police department to site homeless people who are exhibiting behaviors that have an impact on others. Such as defecating on the parks, washing themselves in public bathrooms, and sleeping in parking structures. All these things make people who live here or who are visiting nervous," said Rychlicki.

The Human Relations Commission in a staff report expressed that the homeless needed viable alternatives to jail time or fines and recommended to look for ways to build a network of support services for the homeless to complement the ordinance prior to moving forward.

"Our homeless population is extremely small compared to other cities. There are 88,000 homeless people in LA County, there are more than a 1,000 estimated to be in Santa Monica," said Rychlicki.

It is estimated that approximately 30-35 chronically homeless people live in the parks, doorways, parking structures, alleys and shrubbery. This is why the Human Relations Commission recommended a six-month pilot program of alternative sentencing rather than establishing an independent court. During the pilot program the city will work closely with "Step Up on Second."

"Step Up on Second is a very well respected organization that has its roots in Santa Monica so they have vast experience working with homeless people," said Brucker.

The six-month pilot program with "Step Up on Second" will cost the city \$33,400.

"This organization will have professionals come in and make contact with these people and help them get into a rehab/transitional center," said Councilmember Nancy Krasne. "We know who are homeless people are, they are regulars. I think it's appropriate to step up and deal with them."

Another issue brought up to the Human Relations Commission was panhandling.

"There is a constitutional right to panhandle, but it is very intimidating when people are being approached by a panhandler when they are at the ATM machine, or

entering a parking structure and they are taking money out or while they wait for the bus or outdoor dining. The city can't prohibit panhandling but they can limit where and how you panhandle," said Rychlicki.

The ordinance would allow the police department to have a more active role in handling homeless people.

"It is really important that no one walk away thinking we are criminalizing or trying to penalize or shove homeless people out of the community," said Rychlicki.

Brucker believes the ordinance will bring a positive change to the city.

"If we can touch them emotionally through resources, then maybe of the 30 that we have maybe half of them can find an alternative lifestyle. This town has a big heart and I think that is one of our strengths," said Brucker.

Nasty allegations against the Mayor

It is just too nasty out there. A disinterest visitor to our village might well assume that our schools are falling apart and city government is under the thumb of special interests.

Our schools are still among the best in the nation and our city government provides incredibly excellent services including police and fire protection.

Our elected officials deserve more credit and more respect and far less of the smears some have recently faced.

First about the council, and then the board election:

Last week there was a totally unfair report that Mayor Jimmy Delshad had taken a trip with the owner of the Beverly Hilton, Beny Alagem. He was charged with going with Alagem on his private jet and staying supposedly free at an Alagem hotel in Cabo.

Completely false. There was no "pri-

vate jet." Delshad paid for the air fare on American Airlines. I have the American Express receipts for charges of \$919.00 for airfare and \$3,539.34 for Jimmy and wife Lonnie at the hotel.

If those were the payments to a "benefactor" or friend, I would hate to know what an enemy would have had to pay.

Did Beny contribute to a Delshad charity? Of course, but the list of corporate sponsors of our major charities includes not only developers with matters before the city, but every major, civic concerned corporation and individual in our town. That's called giving back and caring. Any developer who didn't should be kept waiting at the planning commission and council hearings. Anyone seriously suggest that BHEF, the Police and Fire Associations and the Maple Counseling Center and others should not solicit grants from any and every entity in our city?

If being generous donors helped politically, the very community minded Peninsula would have been more successful in blocking the Montage.

Incidentally, Alagem, who too is one who gives back, was not even at the Cabo hotel with Jimmy - he was far away in another country. The "guest of and on a junket" allegations were ludicrous and Delshad merits an apology not only for the smear but for the embarrassment of having to go public with personal trip records. Let's be very careful before we call into question our elected officials integrity. If not, only the most masochistic will ever agree to serve. No, I don't always agree with Jimmy on issues, but fair if fair.

Who were the real winners in last

week's school board election? Since the results could well impact education policies for years to come, maybe it would be worthwhile to take another look at what message the voters were really sending, if any.

The Beverly Hills Education Association, our teacher's union, at a recent meeting celebrated their success: two of the candidates they endorsed and strongly supported, Steven Fenton and Brian David Goldberg, won.

So far, justified and deserved. For the first time in years, the union backed their recommendations with solid political action. They spent money and did doorto-door work for "their" candidates.

However, the dynamics of the election are for more complicated and mitigate against any assumption that the "union won" the election and, in the process, sent a message to the board and the returning board majority.

By attacking the board, the union was leveling criticism, not only at the two incumbents seeking reelection, but the entire school board and two returning members, Nooshin Meshkaty and Myra Demeter.

Should that majority "listen to the voters" and make major policy changes? That really depends on what message the voters were sending and what issues truly dominated the election.

First, some reality checks: Although the union did campaign against the two incumbents, the candidate that most need-

ed their backing, Goldberg, ran far behind the board member they opposed – **Myra Lurie**. Had Goldberg run ahead of Lurie and had his vote come close to matching that of Fenton, there would be some justification for demanding drastic changes in board policies: Didn't happen.

Fenton was indeed critical of the present board, but his issues were not precisely that of the teachers. Out of district enrollment did concern voters, but the teachers did not pounce on this major Fenton and Goldberg issue. Why? It could mean job losses and an economic crunch that could jeopardize benefits the teachers now enjoy and never cited as inadequate.

Fenton would have won no matter what the union did. He was active in school programs, he had high name recognition, he had the strong support of both community newspapers—if for different reasons—and he had an impressive list of endorsers. No candidate for board ever worked harder or walked more streets.

Lurie's victory and second place finish was, in many ways, even more remarkable. With no newspaper support and despite being the target of attacks from the union and in newspaper editorials, she easily won a second term.

Remember, in most recent board and council elections, incumbents such as Lurie, lost reelection bids or failed to finish in first or second place. Being an incumbent is not good for your political health, not lately.

Was there a voter revolt? Again, not exactly. Many political scientists argue that most people go to the polls to vote against and not for a candidate. Less than 20 percent of the eligible voters bothered to vote in what was a hotly contested election with loads of issues A community really upset with board policies would have marched to the polls to turn out the incumbents, but 80 percent didn't!

Why did Goldberg barely edge Alissa Roston? This campaign has some historical parallels, although not nearly as profound. When now Vice Mayor Barry Brucker ran his precedent setting write-in campaign for school board in 1997, with heavy criticism of the then board on school construction problems, his campaign led to the election Gerald Lunn Jr. who echoed Brucker's issues in almost the same way Goldberg did with Fenton. One major difference: Lurie's easy victory.

Roston had some other issues: Although it never became a focus during the election, voters were aware this would have been her third term. Although probably unfair, Roston was blamed for the departure of **Irene Stern**, the Beverly Vista principal who endorsed both of her opponents.(In reality, the board backed the decision of the then Superintendent, **Jeff Hubbard**, something it would have been very difficult not to do.) Roston was probably the least controversial member of the board, working well with a very different cast of board members during her two terms. Was the election a mandate for change in school administrators? The changes in school leadership were an issue but no candidate questioned the work of Supt. **Kari McVeigh**.

Back to the teacher's union. Neither of the incumbents counter attacked the union endorsements, at least publicly. At their recent meeting, one teacher said that when they walked, they were welcomed by voters. Yes, as teachers, but not necessarily as reps of the union. On a personal level, I disagreed strongly with their endorsements and questioned whether they were really reflecting their own member's needs, but there is no question about their right to endorse and work for candidates just as voters can decide whether the union should dominate the school board. One issue that did not entirely surface was the question of teacher's not wanting to return tests to parents.

One very positive post election message was delivered by union president **Chris Bushee** who told the teachers "we need to put the election behind us" and work to restore harmony in the whole education community. Good for Bushee – he said that at the meeting and on our election night show.

There were some very nasty elements of the election, including attacks on the Board by the newspapers and by the candidates. (This column called Lurie, Roston and Fenton "well qualified.") The winners should heed Bushee's advice and move on. A dysfunctional, overly divisive Board will really lead to a voter revolt and that would sink any chance of passing a much needed bond election.

As viewers of the KBEV election night show and loyal readers know, Publisher **Josh Gross** and I had very serious differences on issues and even candidates. We both supported Fenton, but for very different reasons and Josh's attack on the incumbents certainly helped Goldberg, who was not endorsed by either paper. I thought Josh was wrong and unfairly critical, but I want my readers to know that at no time did Josh even suggest editing my column or controlling my opinions – I doubt if that could happen at the other paper.

Historical note: Steven Fenton and Councilmember **Frank Fenton** are not the first members of the same family to serve on the board and council. That honor went to **Annabelle Heiferman**, Mayor, and **Dana Tomarken**, Board President. However, Steven did follow father Frank's career. There is even a Fenton connection. The "T" in FTA, mother Judie's firm, is for Tomarken.

BHHS Football Team Qualifies For Playoffs

Team to play at Redondo Friday night. By Steven Herbert

A rare double forfeit involving Inglewood helped put the Beverly High football team into the Southern Section Western Division playoffs despite a 31-21 loss to Culver City in its regular-season finale Friday night at Nickoll Field.

Inglewood was leading Inglewood Morningside, 16-6, with about eight minutes left in the third quarter, when a fight broke out. Every player on both teams became involved in the fight. Southern Section rules call for the ejections — and one-game suspensions — of all players involved in fights. Because neither team had the minimum 11 players eligible, both teams were charged with a forfeit loss, according to Norman coach Carter Paysinger.

The loss dropped Inglewood's record in Ocean League play to 2-3, leaving the Normans and Santa Monica tied for the league's two remaining playoff berths with

3-2 records behind champion Culver City. Beverly Hills was designated as the league's second-place team by virtue of its 28-26 victory over Santa Monica Oct. 19.

"We didn't earn our way into the playoffs the way we would have liked to, but I don't think anyone else in our league did anything to earn a playoff spot above us," Paysinger said. "Had Inglewood won the game, great.

"But for Inglewood to be put into the [playoffs] after all the controversy and having kids kicked out and trying to overturn it, I don't think that's right. I think it would be worse going into the playoffs that way then the way we went."

The Normans entered Friday night's Ocean League game in an unusual position. A victory would have given them a share of the league championship and designation as the league's No. 1 team in the playoffs. However, a loss by four or more points and victories by Inglewood over Morningside and Santa Monica over winless Hawthorne would have kept them from the Southern Section playoffs.

(Under league rules, if no team in a three-team tie for second place has swept the other teams, the next tiebreaker is the result of the game against the league champion. Santa Monica's three-point loss gave it the advantage in that category.

(Inglewood would have then taken the tiebreaker for third place and the league's final playoff berth on the basis of its 25-7 victory over Beverly Hills Oct. 26.)

The Normans (4-5-1, 3-2 in league play) appeared to be headed for a go-ahead score midway through the fourth quarter. Trailing 24-21, Beverly Hills had driven from its own 15-yard line to the Culver City 28, all on running plays, and took four minutes off the clock. A holding call pushed the ball back to 35, when a Centaur defensive tackle stripped the ball from the Norman running back and Culver City recovered.

Beverly Hills appeared to have forced the Centaurs to punt, but a five-yard face mask penalty gave them another thirddown opportunity, which Culver City (10-0, 5-0) capitalized on as Darius Banks threw a screen pass which Jeremi Anderson turned into a 61-yard touchdown, putting the game out of reach.

The Normans were plagued by turnovers. Quarterback Dex Lucci lost a fumble on their first series, which the Centaurs converted to a touchdown. Running back Kenny Bassett had the ball punched away from him on a long kickoff return, which Culver City also recovered.

The Centaurs, ranked first in the Western Division poll released Nov. 5, took a 14-0 first-quarter lead on Lowell Rose's 14-yard touchdown run and Banks' 12-yard touchdown pass to Zach Davis. Beverly Hills tied the score in the second quarter on oneand two-yard touchdown runs by David Saedi. Culver City reclaimed the lead on Banks' one-yard run later in the second quarter.

The Normans re-tied the score on Ramon Judkins' five-yard run in the third quarter. The Centaurs took the lead for good in the fourth quarter on Devin Sylvester's 26-yard field goal.

"I thought we played very well and carried out the game plan to a T," Paysinger said. "The turnovers were the difference in the game. You have to credit Culver for creating a couple of those turnovers."

Judkins, the Beverly Hills offensive line and defensive linemen Marcelus Jones and Keith Richmond drew praise from Paysinger.

The loss left the Normans winless in their last five games against Culver City, including a 13-13 tie in 2005 and a 56-56 tie in 2006. Beverly Hills had defeated the Centaurs seven consecutive times from 1995 to 2001.

What's Next?

The Normans will play at Redondo (6-4), the Bay League co-champion, in a first-



round Western Division playoff game Friday beginning at 7:30 p.m.

The teams have three common opponents - Culver City, Manhattan Beach Mira Costa and Palos Verdes. Beverly Hills was 0-2-1 in those games - losing to Mira Costa 30-14, Sept. 28 and tying Palos Verdes, 15-15, Sept. 7. The Sea Hawks were 1-2, losing to Culver City, 38-28, Oct. 5 and Palos Verdes, 35-16, and defeating Mira Costa, 27-21.

Palos Verdes coach Pat Fresch described the Normans-Redondo game as "a very close matchup."

"It's going to be an interesting game," said Fresch, whose team was 7-2-1, 4-1, share the Bay League championship with the Sea Hawks, but being designated as the league's No. 1 team for the playoffs because of their victory over Redondo.

The Sea Hawks have a "solid defense, with a power running offense," and tailback Hayward Gray "is kind of explosive," Fresch said.

Beverly Hills is 6-7 in first-round playoff games since Paysinger became coach in 1990, including a 1-4 record since 2001.

If the Normans win, they would face the Downey Warren-Palmdale winner in a second-round game Nov. 23. The Normans would play host to Palmdale, the Golden League champion, because of the Southern Section rule giving the next home playoff game to the team with the fewer home games. Warren, the third-place team in the San Gabriel Valley League, won the coin flip to determine the site for a game against

Beverly Hills.

Council reverses stand amidst resident complaints

decision to support 2-hour free parking for everyone after originally being in favor of 2-hour free parking for

residents only. "Of the one-and-a-half billion dollar sales that go on in the golden triangle, \$500 million come from residents, \$400 million from counties outside Beverly Hills, and about \$500 million come from outside California. That means residents contribute to a third of the business, but two-thirds are non-residents," said Delshad.

Delshad felt not providing 2-hour free parking for non-residents would lead them to feel "antagonized and discriminated."

"This time I decided that I wanted to extend [2-hour free parking] to all shoppers. I believe this will send a good [message] and [be] a thank you to all the shoppers," said Delshad.

Although Delshad recognized the overwhelming response the Council received from the community, only two community members appeared before the Council to speak in favor of 2-hour free parking.

Councilmember Frank Fenton was a major advocate for reinstating the 2-hour free parking rate to everyone, not just Beverly Hills residents.

"I [was] holding my breath on it," said Fenton. "I think I was finally able to get them to get it. A lot of merchants came

forward and said look, we get at least 50 percent or more of our business from people outside our community. The sales tax dollars are so important to providing all the services that we offer the residents here."

Fenton believed that by not providing 2-hour free parking to everyone, it would cause a negative impact on the city's sales tax.

"Sales tax dollars are more important in the long run. breath on it," said Fenton. Once people start shopping somewhere else they get used to it, you don't get them back," said Fenton.

Vice Mayor Barry Brucker supported the idea of 2-hour free parking for everyone, but originally lobbied for 2hour free parking for residents only.

"2-hour free parking [for residents] was a compromise proposal that I brought forward and it was not well received by the residents or the merchants," said Brucker.

"Sometimes what

you think may be a good idea just doesn't fly, so that was rejected."

Brucker was surprised his proposal wasn't received well.

"People in the community felt it was not appropriate and the merchants felt it would be discriminatory, so that is off the table," said Brucker.

In the Weekly's issue # 416 "Parking Rates Reconsidered," Brucker said that offering 2-hour free parking to everyone in Beverly Hills would have a tremendous financial hit on the city.

Although he voted to pass the 2-hour free parking for everyone, Brucker says he did so with caution.

"I am cautiously optimistic that we will be able to find the financing to offset the shortfall, so I am [supporting] it with a great deal of caution," said Brucker. "The community is making it crystal clear to their electives that this is what they want. I am willing to go that route and support what the community wants, in the same vain make certain that we find the revenue to fund it."

The 2-hour free parking program will affect the 216 S. Beverly Dr., 345 N.

Beverly Dr., 438 N. Beverly Dr., and 9510 Brighton Way retail parking lot structures.

These parking structures were changed to one-hour free parking in 2006 January of after the city experienced a major loss in sales tax and transient occupancy tax revenues in 2004.

Funds from the Parking Enterprise Fund where transferred to the General Fund to avoid a budget deficit. To date the Parking Enterprise Fund. which finances construction, operations, maintenance and improvements of the City's parking facilities, has not

recovered the \$2 million revenue loss.

The city planned to restore the funds by eliminating free parking. As a result, 2hour free parking was eliminated in four city operated parking structures and converted to one-hour free parking structures.

Tuesday's decision to return parking facilities to 2-hours free parking to all users will result in a \$1.7 million reduction in revenues, a deficit of \$2.7 million in the current fiscal year and a total deficit of \$19.6 million over the next five vears.

Councilmember Nancy Krasne who campaigned on the issue said the parking issue stemmed from a broken promise.

"A previous Council before I was ever elected to the Council had promised [2hour free parking] I felt the Council had broken a promise, but I couldn't get in on the agenda without three votes and Brucker allowed me to get it on the agenda and brought it forward," said Krasne.

Krasne opposed the idea of 2-hour free parking for residents only, an idea originally presented by Brucker.

"Anybody that comes to Beverly Hills should feel welcomed. If they are coming here to shop, eat and spend their money then they should be welcomed as any resident," said Krasne. "As a result, I wanted the 2-hour free parking for everyone returned."

Although the deficit was a topic heavily discussed at Tuesday's meeting both Fenton and Krasne believe 2-hour free parking will have a positive impact on diminishing the deficit.

"I think the tax revenues will go up because the free parking will increase the sales tax revenue base we get," said Krasne.

Councilmember Linda Briskman expressed her opposition to 2-hour free parking, previously commenting in [Issue 416] that there was no data to support changing the one-hour free parking rate.

"I have always supported the staffs recommendation to reduce the free parking to one-hour and I have never promised anything else," said Briskman. "I felt the right thing was to see if our sales tax figures were affected by it and if they were affected by it then to sacrifice the additional few dollars a year that our residents would pay to park, we would stop the abuse, generate a significant revenue source, restore our parking structures and we would be doing the right thing."

Despite adamant opposition for 2-hour free parking, Briskman voted in favor of reinstating 2-hour free parking to the four retail parking lots recommended by staff.

Delshad asked the Ad Hoc committee to reconvene and find solutions on how to generate revenues sources to offset the financial shortfall from reinstating 2-hour free parking and how to eliminate the misuse of the parking facilities.

"Come and join us," said Delshad. "I am asking the political leaders of Beverly Hills to join me to unite this city. Beverly Hills is the best city in the world and we need to be united."
