"High drama at board meeting and a surprise at a fund raiser" [Issue 428]

Let's set the record straight and defend a great country that has taken too many potshots from peashooters like Rudy Cole. When it comes to racism in America, Cole laments, "we are moving forward, but not fast enough." His example of not moving fast enough? "It hasn't been that many years since new arrivals from Ireland found this sign at factories: NINA. No Irish Need Apply." I couldn't resist looking that one up.

As it turns out, Richard Jensen, a retired professor of history at the University of Illinois, wrote a 2002 article entitled, "No Irish Need Apply: A Myth of Victimization" published in the Journal of Social History. Professor Jensen concludes that NINA is an urban legend. He writes, "There is no evidence for any printed NINA signs in America or for their display at places of employment other than private homes [for nannies]." Furthermore, "There are no contemporary or retrospective accounts of a specific sign at a specific location. No particular business enterprise is named as a culprit. No historian, archivist, or museum curator has ever located one; no photograph or drawing exists. ... The business literature, both published and unpublished, never mentions NINA or any policy remotely like it. The newspapers and magazines are silent. The courts are silent."... "The complete absence of evidence suggests that probably zero such signs were seen at commercial establishments, shops, factories, stores, hotels, railroads, union halls, hiring halls, personnel offices, labor recruiters etc. anywhere in America, at any time."

The history and origins of the NINA myth are fascinating. Equally fascinating is how Rudy Cole showcases this whopper as an example of recent racism in America. In fairness, Cole cites other cases of racism (including the Beverly Hills lawn bowling club!), mainly from forty years ago or more. Taken with a thimbleful of common sense, the conclusion is quite the opposite. America today, though far from perfect, is the least racist pluralistic society in human history.

Cole and others who are quick to make charges of racism (or sexism, or homophobia) do a disservice to the civic life of this city. Let's not attempt to shut down debate by lobbing the R bomb. Instead, let's try to win on the merits with facts and reasoned arguments.

Cole Responds

Unfortunately, Spitz' letter, and the one that follows from Susan Mishler, totally misstate what I wrote and what I believe, and seem to want to kill the messenger. Spitz even

questions my patriotism.

Mishler thinks people who make racist comments are exercising their right "to free speech" and asks "would he want us to throw the man out" who made oblique references to "outsiders" benefiting from park expansion.

No, but a very simple statement disassociating themselves from these comments would have been appropriate. All of us, including myself, have too often remained silent when we heard bigotry.

Spitz, a history teacher, decided to focus on only one example I gave on our history - the 'No Irish Need Apply' signs I cited. He quotes historian Richard Jensen as his authority that these signs were a "myth" and never existed and have "never been found." However, that is not precisely what Jensen argued. He wrote, if they existed, they were very few in number. Jensen also questioned President John F. Kennedy's reference to having seen the signs.

Let me cite an even more reliable source, mostly because he was older: Tip O'Neill. In his book "Man of the House" O'Neill, remembering his own experience with discrimination as a youth, writes: "there were businesses in Boston that needed employees but put up signs in windows saying NINA which we all knew meant 'No Irish Need Apply'. Historians questioning documented societal disasters? Sound familiar?

I agonized long and hard before writing the column. No, I do not think we are a racist community and I know our country has made letters cont.on page 5


Got Water?

Drought causes Public Works Commission to promote water conservation

For years, Beverly Hills

Howard S. Fisher According National Weather Service this year is considered the driest rain season ever in Los Angeles and other parts of Southwestern California.

"The city is facing a shortage of water," said Metropolitan Water District (MWD) Representative Robert Wunderlich. "Water is becoming shorter in supply and more expen-

The MWD supplies the city of Beverly Hills with 90 percent of its water.

According to Wunderlich there are a couple of reasons that have caused this shortage in

"Weather conditions, less rain fall and legal decisions have all been contributing factors," said Wunderlich.

The Department of Water and Power has taken an initiative to help alleviate the problem. Through its programs, 1.3 million ultralow flush toilets and showerheads were installed in city homes and buildings. These types of water conservation efforts have saved approximately \$70 million per year. Los Angeles has been able to reduce its waste water by 56 million gallons per day, equivalent to all the wastewater treated daily in Las

"This is more than just a city problem, this is a state problem," said Public Works Commission Chair Howard Fisher.

Fisher said the city is actively pursuing ways for residents to engage in water conservation. Both the Commission and DWP are urging residents to voluntarily cut down 10 percent of their water consumption.

According to Beverly Hills Water Operations Manager Kevin Watson the city has been a long leader of water conservation.

The city saves water at the parks through the installation of "smart" irrigation controllers that regulate the amount of watering needs for landscaping by using climate sensors, said Watson.

According to Planning Commission officials the City's goal is to achieve fiver percent or less of unaccounted for water, which would save the City more than \$200,000 per year.

Some waterless public urinals have been installed at Roxbury and La Cienega parks.

Fisher says there are many water-saving tips residents can implement in their day-today lifestyles that can help prevent experiencing a negative effect from the increasing

By fixing leaky faucets, residents can save 20 gallons per day. By installing water efficient washing machines and toilets over 100 gallons of water can be conserved a month. Even simple tasks like turning off the water while brushing teeth saves three gallons a day and shorter showers can save up to 2.5 gallons per minute.

"You can be amazed at how much water you save," said Fisher.

Public Works Utilities Services Manager Shana Epstein said the city is aiming to work with the BHUSD.



Epstein emphasized the importance of water conservation education especially at a young age.

But the drought has raised concerns among The North Homeowners residents. Associations (NHOA) talked about water rate increases during a formal meeting last month.

NHOA President said increases in water rates are of concerns to residents.

"They have already raised our water rate by 38 percent from 2005 to 2007. They plan in the next four years to raise our water rate an additional 8.5 percent for the next four years adding up to 34 percent or 72 percent in six years," said Tanenbaum, in the Weekly's issue

Former Public Works Chair Betty Harris said there is an alternative and that water rate increases can be prevented.

"I want all the residents to know that Beverly Hills has its own ground water in the industrial area, which is flowing into the storm drain and out to the ocean and they [City officials] have done nothing to capture that water," said Harris. "There are hundreds and hundreds of gallons of water that we can

take and treat because it is only a thousand feet from our water treatment plant. We can treat it and blend it with our own water. If we don't recapture it our rates are gong to go sky high."

Although Harris said she has expressed her views and alternatives to various elected officials none have done anything about it.

"We can capture the water that is simply going in the storm drain. I don't know why they don't pay attention to it. I have written to [Vice Mayor Barry] Brucker and the only one that believes it and knows it is [Councilmember] Nancy Krasne," said Harris. "They don't want to spend a nickel. The problem is they are going to put it on the backs of the residents when we have supplementary water."

Epstein said it's about creating a robust educational program and having everyone work together.

"Education is so important to the city, adult and child education," said Fisher.

Fisher said the Commission will continue to develop water conservation programs.

"If you have water and you don't use it that is a sin," said Harris.

A resolution to amend the Beverly Hills Residential Design Style Catalogue. The Residential Design Style Catalogue ("Style Catalogue") was approved by the City Council and is used by the City as a guide to review single family residential projects. The proposed resolution would correct inconsistencies in the Style Catalogue and remove the Beaux Arts style as a "Principal Subtype" under the category of "Period Revival" style in the Style Catalogue.

The Planning Commission's action regarding this project will result in a recommendation to the City Council for final action. The proposed City Council action would be in the form of a resolution amending the Style Catalogue, pursuant to Section 10-3-4408 of the Beverly Hills Municipal Code.

Staff has determined that it can be seen with certainty that there is no possibility that the contemplated revisions may have a significant effect on the environment, and is therefore exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061 (b)(3).

Any interested person may attend the meeting and be heard or present written comments to the Commission.

If you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

Beverly Hills expanded its global focus by approving outreach to China and Israel to develop new Sister City relationships.


The City Council authorized the Mayor on Tuesday, December 18 at an informal meeting to make formal overtures to the leaders of the Pudong district of Shanghai, China and to Herzliya, Israel with a view to developing a formal Sister City relationship.

"Although Beverly Hills is a small city, we are proud to be known throughout the world. We are a leading destination for fashion, retail, tourism and entertainment business," said Mayor Jimmy Delshad. "The world is smaller today and we want to share knowledge, best practices, cultural experiences and business opportunities with our global partners. Learning from others will only make us better."

China being a major player in the global economy is poised to be a major source of tourism to California. In seeking a Sister City in Israel, the Committee was attracted to Herzliya to provide a cultural and educational exchange as well as business opportunity. In their research Herzliya rose to the forefront as a potentially great Sister City.

The next step for Beverly Hills will be to make formal outreach to the leaders of these cities to invite them to mutually explore a new Sister Cities partnership.

October 2007 home prices rise in 90210; condominium prices dramatically increase in 90211, 90212


For October, sale prices for single-family residences in the 90210 zip code increased by 192 percent for the 12 homes sold in the area. The average median in the 90210 zip code of a single-decreased family residence is \$3.650 million. In the 90211 area, prices for single-family homes decreased by 28.4 percent for the two homes sold.

The average price of a single family home in the 90211 zip code is \$1.79 million according to a report released by (Data Quick Real Estate News http://www.dqnews.com). In the 90212 area, for the four homes sold, there was an increase of 71.8 percent for single family homes. The average price of a home in the 90212 area is \$2.1 million. Condominium prices in the 90210 area decreased by 7.6 per-

great strides in ending both legal and social discrimination, but it is a work in progress.

In Beverly Hills, we need to set even higher standards of tolerance and, yes, it is because of "our" own history.

I was shocked to read the comments of outgoing School Board member John Millan of a few weeks ago. He said that he heard racist remarks during the school board campaign surrounding the student permit issue in our district. His words were strong, "... hate, intolerance and racism..." Who, What, Where, When, Mr. Millan? Once vague accusations are made they can never be withdrawn from the public forum. As a result of Mr. Millan's charge we have Rudy Cole expanding on those comments in the BH Weekly by giving us a lesson in ethical standards. He even gave us the religious backgrounds of Mr. Millan and Councilmember Briskman who he holds in high regard for their outrage about racism in town and admonished "us" to live by a higher standard if "we" had learned from "our" own history of discrimination.

We have Mr. Cole dividing residents by their religion which is most unfortunate. Next, we have Mr. Cole making a moral equivalence between the silence of the German Jews during the Holocaust and the silence of residents at a Recreation and Parks meeting which I attended! Would he have liked us to throw the man out who said expanding Roxbury would bring gangs and outsiders? We may have disagreed with his opinion but the last time I looked this individual was entitled to free

expression at a public forum. We have Mr. Cole telling us that those residents who didn't want the ballots printed in Farsi were prejudiced and racist. A sweeping indictment of some people who believe that voters should be able to read and vote in English. Again, their opinion in the land of the free and the brave. If Mr. Cole wants to report on the fiscal survival of our school district he should report on the work of the school board. What he hears under the radar that he deems racist begs the issue.

The real issue is that voters wanted to know how and why the permit program grew from 526 students 4 years ago to 903 today. Voters wanted to know how the program worked, who administered and implemented it. Voters wanted to know about the fiscal impacts of the whole program in light of the 8 to 10 million dollars that the City Council gives to the school district. Questions by voters are legitimate and Mr. Cole is diverting public discussion of important issues and muddying the waters with false cries of residents being "quietly prejudiced." All of this was piggy backed onto the vague comments of Mr. Millan who started the ball rolling with his innuendo about racism. The residents of this city are interested in how decisions are made by their School Board and by their City Council. Those seeking public office ask for our vote at election time and they are the ones to be held accountable. Hopefully, voters of our city will keep asking questions of their elected officials and not be silenced by false and divisive arguments.

Our Readers React

The lot of a politician

Last week's column evoked some strong emotions from readers (see letters on pg 2), and that's good. Having a community discussion on issues of tolerance, understanding and cultural diversity can only be positive

Most of the calls and emails were, generally, supportive. An underlying discomfort with airing any problems dealing with ethnic, racial or religious bigotry is also understandable and this theme was reflected in many communications. (Note to readers: emails sent to this column are treated as personal. If you don't object to their publication, please note that or send them to the editor.)

I tried very hard not to overstate the issue. No, we are not a racist community. However, some of our neighbors exhibited very intolerant reactions to the Farsi ballot use, and fears, again by only a few, on allowing out of district students to attend

our schools or "outsiders" from enjoying our parks.

We would all benefit from a dialogue, a community symposium on these issues. Yes, it requires confronting cultural differences on every side of our diversity and what every segment of our population can do to bring us closer together. We have a Human Relations Commission and that excellent agency could be the catalyst for a community-wide discussion on tolerance.

On the plus side, an even cursory look at our civic organizations proves how much progress we have made in being inclusive. The Persian community, as one example, is well represented in the PTAs, the city commissions, the service clubs, charities and the professions. There is progress.

This week, I thought it might be appropriate to discuss a far more pervasive problem: Showing some tolerance and understanding of our elected officials. The level

of anger expressed by many of those who speak at city council and school board meetings, and at commission meetings, is incredible. It isn't that those who are in opposition to our elected officials are always wrong. On the contrary, on many issues they bring views that help place matters, including new developments, into focus. We need involvement and dissent, but not when it deteriorates into personal attacks and constant questions of integrity.

Equally important is a lack of understanding of process. At a recent city council meeting one very well intentioned resident asked how a development project came to be approved. "I didn't approve this," she said.

Some months back, another council speaker actually said "it is unconstitutional for this council to approve (a different development) without a vote of the neighbors"

Not how it works. We elect people to make decisions and to balance those decisions by considering all of our needs. We do have the referenda process, but this should be used with great care and not abused. Representative democracy is best when it avoids the passions of the moment.

Sometimes, it's very difficult for elected

officials to actually vote their conscience. An example: The council chamber is filled with people who are against a new development. Their arguments are very persuasive. The traffic impacts are serious and the project wants exceptions from height and density limits. Although those speaking in opposition may not represent a majority view, they are vocal and they are among the most likely to vote in the next city council election.

This is all hypothetical, but the councilmember wrestling with his or her vote has another problem: The city may soon experience a short fall in revenues. This proposed development will bring considerable revenue, including major fees to city coffers. Without that money, the city could have to cut funding for our schools through the Joint Powers Agreement or even cut appropriations for police and fire protection.

So, the councilmember can respond to the outcry against the development and win friends among the vocal opponents, but later may have to face community reaction to cutting support for schools or public safety. Our elected officials constantly face precisely that kind of quandary on many matters they decide.

Even the two hour free parking in city lots had a down side. Returning two hour free was probably the right decision because it meant keeping campaign promises and because both merchants and shoppers insisted. But it also meant finding

other sources of revenue needed to improve the city lots, and they need renovations.

Part of the problem is the cry wolf syndrome. When the massive property tax ballot measure (Prop. 13) was before California voters, opponents warned that passage would "destroy" local government and bankrupt our schools. It did shift control of funding from local to state government for education, but somehow cities and school districts survived.

In local decision making, the problem is also one of credibility and choices. Robinson's-May, 9900 Wilshire, is a good example. When supporters argue that the alternatives to a condominium development could mean a far more intense, commercial use, opponents show very little concern. But they are very wrong. Under current codes, this property could be used for a huge discount store such as a Best Buy and imagine how that would change the gateway to our city. A mammoth retailer would not need any exceptions on height and there would be few discretionary actions required by the city.

The councilmember's voting on the project understand this fully, but opponents mostly don't care – not their responsibility.

More positive notes: Despite some carping, the holiday decorations have been very well received. For most of our history, the South Beverly Drive business section was simply ignored. This Chamber of Commerce, working with area merchants,

has brought the spirit of the season to that vital section of our economy. For those who think past decorations were superior and more in keeping with the spirit of the season, they seem not to know that for many years the season was one religion, one culture and not universal.

Judging from early reports, our retailers had a very good season. So far, the down turn in the economy has not had the same effects on real estate values, especially in commercial land, as some other sections of Los Angeles and the nation.

Give the council credit: On the William Morris project, they worked very hard to protect the public interest. Parking was increased and there could be adequate protection against building a structure for a talent agency we all want that might later be abandoned for a less valuable use. The city wants to be sure that if the property is zoned for an entertainment district that continued use is assured and protected.

If there is an agency that helps define us as a city, it is our police department. The sensitivity to good community relations by the men and women who serve and protect us has helped create a model for police-community understanding other cities could emulate. It is interactive. The police know they are supported and they respond to that support by encouraging concerns about police practices. It works. Show the police distrust and alienation, and that's what is most often returned. In metropolitan areas, our example is a good argument

for community policing.

Finally, a note on the national elections: When the first Iowa caucuses are finally held, the most important impact will be on the Romney campaign. For months, most of the other candidates were almost conceding him the state. Had he won, it would have had some but not too much significance

Now, should he beat out the surprising surge of former Arkansas governor Mike Huckabee, Mitt Romney will once again become a leading candidate.

Romney may not have wanted it that way, but it does make Iowa significant.

A KFWB reporter missed a cute response to a question by Cong. **Brad Sherman**. Asked about a recent EPA ruling that inhibited California from adopting more stringent rules, Sherman said that could all change if a Democrat won the White House. "Of course, we have no idea who SHE will be," Sherman said. The reporter missed it.



Unforced turnovers proved to be Beverly High's undoing in a 56-44 loss to Palisades in the championship game of the San Fernando Valley Tournament Friday night at Alemany School in Mission

"We turned the ball over too many times, especially in the first half, therefore, we didn't have enough rhythm," Norman coach Luis Turcios said.

Despite the turnovers, Beverly Hills (6-3) trailed by just three at halftime, 28-25. The Normans tied the score twice early in the third quarter, 28-28 and 30-30. The Dolphins (12-1) then went on a 9-2 run, taking a 39-32 lead they would never relinquish.

Council candidates spring toward finish line Campaign officials hope issues, not multilingual ballot or rumors, will define the election Issue 386, February 22

With City Council campaigns underway, candidates and their campaign teams hit the streets and staffed the phones with absentee voters in mind.

A total of 1,797 ballots were requested this year, in addition to the 2,899 ballots that were sent out to permanent absentee voters. With 129 ballots being returned each day on average, the projected number of absentee votes this year is on par with recent elections.

The widening of Santa Monica Boulevard was one of a few hot button issues that other campaigns, especially those of the two incumbent candidates, say have been misrepresented. Mayor

Steve Webb, ran for a second term, sending out a pre-recorded "robo-call" to thousands of residents, urging them to call him back and talk about issues such as Santa

The Beverly Hills North Homeowners' Association, which endorsed Nancy Krasne and Soleimani, has repeatedly attacked Webb and Jimmy Delshad, calling their approval of the MOU with the MTA the "misbegotten efforts of the incumbents" in an ad that appeared in the Weekly.

The new multilingual universal ballot, which drew over 300 complaints to the City Clerk's

Office was another unexpected – and perhaps widely misunderstood – election agitation.

It is uncertain how the Farsi ballot, or any other recent controversies, affected the election outcome.

Update: The final 2007 City Council election results had Nancy Krasne garnering 2710 votes, followed by Jimmy Delshad with 2579, and Steve Webb with 2408. Maggie Soleimani received 2299, Shahram Melamed, 1266 and Lizza Morales received 347 votes.



Beverly High to eliminate all pre Algebra

But some fear low performing students could be left behind

Issue 398, May 17

Beverly Hills Unified approved a reconfiguration of math courses at the middle and high school levels that eliminated any math courses below the algebra level at Beverly High.

The reconfiguration began during the 2007-2008 school year and is, in part, a response to the district's API scores. Current API calculations assign a minimum 200 point score to students who do not complete the state standard course at

the appropriate grade level. If a student has not com-

pleted Algebra 1 by grade 9, the 200 point score is assigned, which lowers scores for the entire district.

Beverly High offered three classes below the algebra level: Math A, Math Workshop, and Algebra A. The BHUSD proposed eliminated those courses altogeth-

In order to cope with the higher level math courses at the high school level, the middle schools will be forced to restructure their pre algebra courses. Beginning Algebra will become Algebra A and students who pass the class will then spend their ninth grade year in Algebra B, putting them at the college preparatory level once they arrive at the high school.

The district anticipates that there will be two reasons for students to struggle with the increased math requirement. They will either not grasp the math conceptually or they will struggle to complete the homework requirements and lack in classroom participation. For those students, Assistant Superintendent Ilene Straus believes that different math interventions for each different type of child will solve the problem.

Update: Graduating seniors must complete three years of math in order to be eligible to graduate. The new graduation math requirement did not affect students enrolled prior to the 2007-2008 school year. The incoming freshman class of 2011 and future classes will be subject to the new math initiative.



William Morris to move uptown

George Comfort & Sons proposes new headquarters for the William Morris Agency on North Beverly Issue 407, July 19

When the William Morris Agency decided to look for a new building location to accommodate their growing staff and needs, building owner George Comfort & Sons offered the agency a 210,000 square feet building on 231-265 North Beverly Drive, next to the Bank of America.

"William Morris very much wants to stay in Beverly Hills," said Mark Egerman, former Beverly Hills Mayor and the attorney represent-

ing the building owner George Comfort & Sons.

Efforts to retain William Morris in Beverly Hills heightened as the city began to lose several entertainment companies.

"One of the primary reasons William Morris and other talent agencies are important to Beverly Hills is that they are a cornerstone in the city's economic sustainability," said Mayor Jimmy Delshad.

The application for the project was filed by George Comfort & Sons last April. The Beverly Drive building's owners retained Gensler Architects, a firm based out of Santa Monica to design the building to the specification of the William Morris Agency, said

Egerman.

The proposed new headquarters of the William Morris Agency, if approved, would have to implement a new overlay zone that would apply new development standards for the site.

Update: On Tuesday, December 18 the Beverly Hills City Council approved two ordinances allowing the William Morris project to continue. The first ordinance granted William Morris the entertainment office planned development overlay zone (E-O-PD) and passed with 4-1 vote, with Councilmember Nancy Krasne voting against. The second ordinance was approved (3-2), with Krasne and Vice Mayor Barry Brucker voting against the development agreement that allows for the construction of William Morris with commercial and retail space.

Board of education race begins Millan unexpectedly withdraws from race Issue 411, August 16

The Beverly Hills Board of Education race took a slight turn when Board of Education President John Millan withdrew for re-election on Friday, August 10.

"It was a very difficult decision because I think I have accomplished a lot in the four years and I think there is always more to do," said Millan.

With new opportunities and existing responsibilities, Millan felt it was best to withdraw from the race

"I've got my regular full time job with some additional responsibilities, I'm on the Board of Education and

I'm also the President of the Board of Education at this time. The presidency has a lot more responsibilities and duties than even I expected. So there is a lot happening right now," said Millan.

The final candidates hoping for one of the three seats open on the Board were incumbents Myra Lurie, running for a second term and Alissa Roston, running for a third term with challengers, talent agent/manager Steven Fenton and political science professor Brian Goldberg.

Update: The Los Angeles County Registrar/County Clerk released a final vote count on Wednesday, November 21 for the Board of Education election that took place Tuesday, November 6. Challenger Steven Fenton garnered 2,718 votes, incumbent Myra Lurie 1,947, challenger Brian Goldberg 1,815 and incumbent Alissa Roston 1,795

The installation of the new Board of Education took place on Tuesday, December 11.



Smoke Out

Outdoor smoking ban leads to mixed emotions by local restaurants

Issue 418, October 4

The City of Beverly Hills passed a smoking ordinance that went into effect on Monday, October 1 prohibiting smoking in outdoor dining areas.

According to city officials the goal of the ordinance is to create a healthier atmosphere by helping to prevent the hazards of second-hand smoke.

"What this ordinance shows is that Beverly Hills is a self conscious city. It puts health reasons above everything else," said Beverly Hills Mayor Jimmy Delshad.

The ordinance will have a three month evaluation period. The City will analyze sales tax data during the months of October, November and December. The data will be presented at a public meeting no later than May 31, 2008. At this point the City Council will decide if the ordinance should be repealed or remain in effect.

According to Beverly Hills Chamber of Commerce Dan Walsh exactly how the ordinance will affect businesses is unclear.

"We don't know yet. But we did reach out to other cities that have the smoking ordinance in place. We heard [from these cities that they] have not experienced an adverse impact with their restaurant community," said Walsh.

Although there were mixed reviews on the ordinance, the City obtained the support of the Beverly Hills Chamber of Commerce.



Any person violating the ordinance will be fined \$100 for the first violation, \$200 for a second violation within one year, and \$500 for each additional violation within a year. All businesses affected by the ordinance are required to post "no smoking" signs.

Update: In January the Chamber along with the City will begin analyzing sales tax data for the months of October, November and December. The analysis will be presented to the City Council no later than May 31, 2008.

Ethics ordinance to be revisited by City Council "Revolving door" provisions could be extended to 30 months

Issue 419, October 11

An ethics ordinance that was originally brought up to establish restrictions on activities by former City Officials, elected officials and planning commissioners was brought to question at a formal City Council meeting on Tuesday, October 10. The Council discussed and voted on proposed amendments to the ordinance.

According to a staff report, the ordinance established a post-employment or "revolving door" restriction, which would limit a former public official or employee on what they can do after leaving the City's service.

Currently the ordinance prohibits former public officials and employees for a period of one year after leaving office from representing any person, for compensation, in any formal or informal appearance before the city. The prohibition is two years for city employees that exercise discretionary decision-making authority.

The rationale is that many development projects come before the Council and Planning Commission.

Councilmember Linda Briskman believes in a tough ethics ordinance, but disagrees with Brucker's recommendation of a 30 month prohibition.

"I think 30 months is probably too much. If they want to go to two years that makes more sense but as long as the Councilmembers that are running know the criteria and know what is expected of them, then I think it is fair," said Briskman.

Brucker says he has the support of Mayor Jimmy Delshad, who is part of the Ad Hoc Committee, and Councilmember Nancy Krasne.

Update: The City Council unanimously voted on all amendments made to the ethics ordinance on Tuesday, October 17 during the Council's formal meeting. Four amendments were made to the ordinance, one of which resulted in extending the "revolving door" provision to 30 months affecting future elected officials and planning commissioners.

"I am very pleased that we just passed the toughest and strongest ordinance in the state," said Brucker. "I put up a big fight for the two-and-a-half years and in the long run that is what was most important."

The amendment goes into effect immediately but will only affect new elected officials and planning commissioners, and officials running for re-elections who will hold office in 2009.



2-Hour free parking reinstated

Council reverses stand amidst resident complaints Issue 424, November 15

After a year and a half of implementing one-hour free parking rates the Beverly Hills City Council, despite recommendations from the public works and finance staff not to modify the current one-hour free parking rate, voted unanimously in favor of reinstating 2-hour free parking.

Based on the Staff Report presented to the City Council during the 2003-2004 budget planning process, the City experienced a large loss in sales tax and transient occupancy tax revenues due to post September 11 economic conditions.

As a result, in order to balance the General Fund budget, the City Council transferred \$2 million of parking meter revenue out of the Parking Enterprise Fund and into the General Fund to avoid a budget deficit. The Council intended to replace the Parking Enterprise Fund revenue by eliminating free parking, but postponed the action due to business opposition.

Originally Beverly Hills Mayor Jimmy Delshad and Vice Mayor Barry Brucker supported reinstating 2-hour free parking for residents only, but along with Councilmember Linda Briskman, who opposed reinstating 2-hour free parking for everyone, swayed their vote after heavy community outcry, voting to reinstate 2-hour free parking for residents and visitors.

Delshad explained his decision to support 2-hour free parking for everyone.

"Of the one-and-a-half billion dollar sales that go on in the golden triangle, \$500 million come from residents, \$400 million from counties outside Beverly Hills, and about \$500 million come from outside California. That means residents contribute to a third of the business, but two-thirds are non-residents," said Delshad.

The approved 2-hour free parking program will go into effect just in time for Thanksgiving and the Holiday season. The lots that will be affected are the 216 S. Beverly Dr., 345 N. Beverly Dr., 438 N. Beverly Dr., and 9510 Brighton Way retail parking lot structures.

Tuesday's decision to return parking facilities to 2-hours free parking to all users will result in a \$1.7 million reduction in revenues, a deficit of \$2.7 million in the current fiscal year and a total deficit of \$19.6 million over the next five years.

Currently the city of Beverly Hills operates 15 municipal parking structures.

Update: Delshad has asked the Ad Hoc committee to reconvene and find solutions on how to generate revenues sources to offset the financial shortfall from reinstating 2-hour free parking and how to eliminate the misuse of the parking facilities.
