"No agreement on Legacy permits" [Issue 4491

The controlling majority of the current BHUSD Board of Education continues to vote 3-2 against Mr. Steven Fenton and Dr. Brian Goldberg on every agenda matter endorsed by these two Board members elected on Nov. 6, 2007, by Beverly Hills voters. This "legislative gridlock" has successfully obstructed Fenton and Goldberg from changing the status quo policies of this Board, despite requests from residents speaking at Board meetings and writing letters endorsing ideas suggested by these two men who were clearly elected by voters to change BHUSD policies.

I find it pathetic that the current majority essentially ignored Beverly Hills voters at the last Board meeting and concurred with the positions stated by two former Board of Education members who probably had been invited by the majority to speak on the issue of Legacy permits. The majority wants to achieve an "ethical" solution. Where were the ethics when the same majority ignored the requests of voters and flushed [former Beverly Vista principal] Irene Stern's career down the toilet? Fenton and Goldberg may continue to see their ideas defeated by a 3-2 vote; however, voters will be able to express frustration with the "gridlock" at the next election.



Beverly grads team up to create "New" school

Danny Corwin, all Beverly High Class of 1990, have been friends since they spent their first year together at Beverly. Since then, they have gone their separate ways, getting married and taking jobs as a teacher and administrator, an attorney and a Los Angeles education reformer.

When Corwin took a job with the California Charter Schools Association, however, a plan started to take

shape. Albert, Yashari-Becher and Corwin's wife Zoë, who shares the group's passion for education, having been a teacher and reformer in her own right, had always talked about what it would be like to start their own school, and perhaps charter was the way to go.

"We were all pretty lucky to have a great public education at Beverly, and unfortunately the general public school experience is not the same for most L.A. students," said Albert, who worked as assistant principal at Milken Community High School.

Fast forward a couple of years, and the dream is about to become a reality with the New Los Angeles Charter Middle School,

sixth graders when it opens its doors in September, according to Zoë Corwin, who recently earned her Ph.D. in sociology with an emphasis on urban e d u c a t i o n . Coincidentally, one of the teacher candidates, Scherrie Britt James, also went to Beverly, graduating in 1994.

The group of friends used grants and private donations totaling to about \$400,000 to open their charter school.

During the school's first year and until it is able to expand, Albert, who is now executive director of New L.A., will also take on some of the responsibilities of principal.

New L.A. students, who will have had to submit an application and have been picked by a lottery process to attend, will be faced with a curriculum of "rigorous academics" meant to prepare them for a college-preparatory high school.

"Our educational philosophy in the classroom is going to be student-centered pedagogy," Albert said, "where students aren't passive learners and they're really engaged in the learning process through projects and group work and questioning."

As such, students will be able to learn about social justice, a strong focus area at

New L.A., first-hand on their weekly community service trips into nearby low-income communities, in which many of them live.

Since the 1970s – when Louis Pasteur Middle School closed and was replaced by the Los Angeles Center for Enrichment Studies (LACES), a city-wide magnet – there has been no middle school in the area, and students have had to bus to LAUSD middle schools like Emerson on the city's Westside.

"We thought this would be the perfect place to reach out to the community," Albert said. "We started this middle school because people need it."

The current location for the school is the Oasis Christian Church on Wilshire Blvd. and Mansfield Ave. While the group was "very excited" to lease the property in that many who receive charters in Los Angeles are unable to find a site for their school, this site is only temporary, until they can find a more permanent location in the area.

The thing that makes this charter school particularly unique, according to Yashari-Becher, is the fact that the school is not being started by parents unsatisfied with the local schools.

"We weren't doing this for ourselves," Yashari-Becher said. "We were doing this because we felt there was a community that was entitled to a good school, and we were positioned in a way that we could give it to them, due to our own experiences and professional backgrounds.

"We're a volunteer Board. I have two young kids. I work. I guess this is my third job, but it's really been a fulfilling process."

Board finalizes layoffs of 10 teachers, hardly any cuts in admin

In response to the threat of statewide budget cuts in education, the Board of Education unanimously agreed to fully or partially lay off 10 teachers

and only one part-time administrator who happens to be departing for maternity leave, out of the 35 employees originally noticed, at a closed-session meeting on May 9.

"If you look at the amount of teaching staff that's being cut [both voluntarily via

retirement and involuntarily via layoffs] versus the percentage of administrative staff that's being cut – It's like 2 percent of all administrators versus 10 percent of all teachers," Bushee said. "We believe there's an imbalance there and we don't believe that's best for students."

Human Resources Coordinator/ Credential Analyst Nora Roque's position was also in jeopardy of being downgraded to a non-management position, at a savings to the District of about \$30,000 per year. However, the change was rescinded at the May 6 Board meeting in a unanimous vote pursuant to a motion made by Board member Myra Lurie.

Pink slips were rescinded due to both the results of the April 15 administrative hear-

ing, which was held to determine the legality of the layoffs and the process by which they were distributed, and the District's Supplemental Employee Retirement Program (SERP).

Of the 35 people given layoff notices, the 8 most senior were placed on a "precautionary list," to be moved to the "primary list" only in case the judge in the administrative hearing ruled one or more of the other notices illegal. The judge ultimately ruled the primary list of layoffs to have been legally executed and as such the District cannot lay people off from the precautionary list.

Also, with 18 veteran faculty members opting for SERP, the District's early retirement benefits program, additional layoff notices were rescinded, provided that the teachers were appropriately credentialed to teach in the positions left open.

Gumina could not be reached for comment.

Why Did BH Lose A Top Official?

Also, three who make a difference By Rudy Cole

Beverly Hills has lost one its most able and creative staff members, **Vince Bertoni**, director of Community Development, to Los Angeles. [See brief on p. 4]

Bertoni succeeded **Mahdi Aluzri**. Who could take Bertoni's job. Aluzri!

However, city officials in Rancho Cucamonga, where Mahdi now works, have strongly denied these rumors and Aluzri was not available for comment.

Reports of the surprise resignation came as a shock to city hall. Bertoni has accepted a job as second in command of the Los Angeles Department of Planning, but it was a position he had turned down before city manager Rod Wood promoted him from planning director to head of Community Development, and "sweetened" his benefit package to keep him in Beverly Hills only last year.

Aluzri had resigned that job to become assistant city manager of the City of

Rancho Cucamonga. Before Planning and Building and Safety were combined, by Wood, Aluzri became the first director of the newly created agency. He had been both director of planning and director of Building and Safety.

Why did Bertoni take a job he could have had earlier? The most likely reason is that he may have been given assurances that he would be on a short list to become head of the Los Angeles Department of Planning when that position becomes available. Also, the challenges of being involved in some very high profile development projects now being considered in Los Angeles are important to the highly regarded professional planner.

Bertoni has just completed guiding his agency through some of the most difficult and contentious development projects in our city's history. His staff, as well as the planning commission and city council, have been on overload for months

wrestling with three enormous and complicated building applications: Robinsons-May (9900 Wilshire), William Morris and Hilton Revitalization.

The last, Hilton, received final approval Monday. Bertoni's resignation was announced the next day. During the months of processing all three, the city council held more meetings than ever in its history – often as many as three a week. This placed tremendous pressure on staff to complete the ever changing plans and concepts the council was debating on all three

Having survived those projects, Bertoni would now have led the final stages of the adoption of a new general plan for the city. That process has been in discussion and consideration for over five years.

Bertoni also had to carefully contend with a rare division at city hall. The Planning Commission, one of the three with whom Bertoni worked, had taken a very vocal and active role in a disagreement with the council on several development projects they had considered. However, **Noah Furie**, chair of the Planning Commission, said he and his colleagues all had the highest regard for Bertoni and "wished him well" in his now job in Los Angeles.

Clearly, Bertoni's people skills and political savvy worked well in Beverly Hills where he managed good relations with his commissions, city council, his own staff, the city manager and an often contentious community, split on the developments under consideration.

As for Aluzri, his possible return to Beverly Hills would mean the department could have a familiar and experienced director helping lead the general plan adoption process. There has been no official word on this from anyone at city hall, just rumors this column had heard yesterday.

What was apparently not true was that Bertoni left because his agency had come under attack by one councilmember, **Nancy Krasne**, for "papering" her with too much data just prior to council votes. There were constant and never ending changes in both 9900 and Hilton applications but these were mostly the result of negotiations with the developers and a split in the council on some aspects of the projects.

At the same time, the offices of the departments Bertoni led, Planning and Building and Safety, were being remodeled with both being temporarily housed on Third Street.

Bertoni also brought to his department a highly regarded planner, **John Lait**, who left a similar position in Santa Monica. Lait became director of planning when Bertoni replaced Aluzri as head of Community Development.

Before Bertoni, the heads of the department, **Ruth Nadel** and **Irwin Kaplan**, had more than 20 years each in city service.

Bertoni was here for three years.

A recent editorial in another newspaper about the role and responsibilities of the city commissions, although it probably had absolutely nothing to do with Bertoni's resignation, has prompted some anger by members of the planning commission.

The editorial, although obliquely praising the commission, seemed to attack them for taking a contrary view on some recent projects, insisting that commissions are "part of the team" and if you don't "want to play as part of the team, don't join the team."

However, that misses the whole point of commission independence and responsibilities. Unlike most other commissions, Planning has both state and city mandated rules it follows making them both independent and responsible to the elected officials. They have "legislative" and "quasijudicial" roles, described by state law.

The Planning Commission can not consider financial or "political" impacts of projects and there the process becomes difficult. When the Planning Commission does act, the council can, on its own motion, on appeal or by law review or consider every and all actions by the commission. Their perspective is broader and more loaded with community impacts.

What may well be true is that the Commission should not become activists in presenting its findings, but let the record speak for itself. No, they do not have to be "team players," that defeats the whole purpose of commissions, but they should also accept the very different perspectives considered by elected officials.

There has probably never been a more able planning commission, although there have been some stars such as **Jerry Magnin**, **Don DeWitt** and others who have served with great distinction. Furie, **Debra Judelson**, **Nan Cole**, **Kathy Reims** and **Lili Bosse** merit high praise for the incredible amount of time and energy they gave to the recent flood of decision making.

What about the referendum now being circulated that could possibly overturn the council approval of the Hilton Revitalization project? No question, referenda are part of the democratic process and an important right of citizens to challenge city government decision making.

However, there are very serious issues the referendum will not address. The final council action came after months of study and public hearings. What was approved gave the city enormous economic benefits NOT included in the original plan, and some the Hilton strongly opposed. The Council and the Commission, also made drastic changes in parking requirements, traffic mitigation and heights and density, all that could be lost if the referendum should succeed.

Also, some circulators may be tempted to tell those they solicit that their signing "will only help put this on the ballot." Actually, those who do sign the petition are giving their names as opposing the action of the city council.

A careful reading of the petition should

be important.

Former School Board president **Dana Tomarken** may have been the first to coin the phrase "the positive people of Beverly Hills," but it is an apt term to describe those who live and work here and give back to our community.

Nissenbaum has some very large moccasins to fill as the new managing director of the Peninsula Hotel. He was recently named to replace the highly regarded **Ali Kasicki** who left that hotel to head the soon to open Montage Beverly Hills.

A veteran hotel leader, who has had a distinguished and much honored career before coming to Beverly Hills, Offer also understands the Beverly Hills tradition of giving back and becoming involved. He told this column that he looks forward to taking an active role in civic affairs. Offer has a very different style than Ali, but he is very impressive and has very rapidly learned what it will take to be a civic leader as well as managing one of the world's great hotels. Offer is a very good fit for our community. There are also major improvements being made at the hotel that he is leading.

Create a Legacy program to complement the current "opportunity" permit program.

Financial benefits: The permit program brings in more (state) funding (ADA) than the cost to educate the permitted students. "Legacy" students will, likewise, increase much needed funding for the district.

Curricular benefits: More students per school, whether resident, legacy or opportunity, would allow for a more diverse elective offering, such as art, music and band, to mention just a few, and much needed librarians.

By adding a legacy program, the community would not be placing a priority on legacy students, nor "one that seeks to choose a select group of students to populate our schools, replacing an open process of opportunity," Demeter said" (BH Weekly).

Even with 900+ permit students, district enrollment is declining. Offer vacant seats to "legacy" families?

"District administration argues the program might increase expenses because more staffing would be needed to find proof of residency for grandparents. And, currently they don't have a computer system in place to verify attendance of alumni" (Courier). OK, let's accept that premise for the moment. Since permit students bring in more state funding than they cost, a Legacy program would easily pay for itself.

Regarding concerns about alumni data, [Pupil Services Director Amy] Lambert says, "...especially with regards to older, non-computerized records."

Three points in response to Lambert's concerns:

- 1. The BHHS Alumni Association could be of great assistance in locating alumni.
- 2. As I am a soon to be a retired (BHUSD) technology teacher, I will gladly volunteer to help with the implementation of gathering the necessary data required to allow the legacy program to move forward.
- 3. Where do we send our Beverly High diplomas as proof of our alumni status?!

"Hilton Referendum"

The May 6 City Council meeting was a staged play with some transparent City Hall bad actors. City Hall tried to explain why there were over 2,100 pages, weighing 15.5 pounds, in the Hilton Hotel General Plan Amendment Resolution. The Montage referendum book was only 196 pages and weighed a few ounces, which was easy to transport.

Unfortunately, the City Attorney took the heat for the City's decision to try to sabotage the signature gathering for the Hilton Referendum petition. [In addition,] I suspect that the Hilton lobbyists and attorneys also had a hand in this unfair strategy. The City Attorney said numerous exhibits that are referenced in the Hilton General Plan Amendment Resolution, including the Final Environmental Impact Report (EIR) and the Draft EIR are important documents that voters need to review before deciding whether to sign the Hilton Referendum Petition.

I made a plea to the Council to reduce the [number of] pages in the Hilton General Plan Amendment Resolution. To attempt to create an appearance of fairness, the Council then deleted the bulk of pages in a different ordinance, the Hilton Zone Change Ordinance, which is

not being attacked by the Hilton opposition.

When asked by Mayor [Barry] Brucker if the Council would consider also reducing the size of the Hilton General Plan Amendment Resolution, [Councilmember] Jimmy Delshad yelled out "no," which was then echoed by Mayor] Frank Fenton [Councilmember] Linda Briskman. Councilmembers Delshad, Fenton and Briskman are the majority who approved the Hilton expansion with three high-rise towers. Seven other public officials, including all five Planning Commissioners, Mayor Brucker, and Councilmember [Nancy] Krasne said "no" to having three new high-rise towers at the Hilton.

While our City Council refused to provide any relief to the Hilton legislation being put on the voter ballot, City Hall claimed to the media that they had reduced the size of the Hilton petition. After losing 10 days waiting for the printing of over 100,000 pages of petition documents, Referendum signature gatherers are now carrying 15.5 pounds of paper, house to house. We now have only 14 days to complete our task.

Few voters in the City have ever read coverto-cover an EIR, let alone a draft EIR. I doubt that any City Council members have ever read a complete EIR, which would take days to read. It is also unclear whether a court would find it legal for City Hall to force citizens to circulate a referendum petition weighing 15.5 pounds. It has never been done in Beverly Hills, or in any other California city.

It's our city, our voice and our choice. Call 323-944-0910 to sign the Hilton Referendum petition so you can decide in November.

Your two-page centerfold ad by "Supporters of the Beverly Hilton Revitalization Project...with major funding provided by the Beverly Hilton Hotel" was a wonderful boost to my spirits. After 34 years as a teacher and administrator, Rochelle Ginsburg is laying down her apple

How did you first get into teaching?

I got into teaching when I went to UCLA. I was getting a teaching credential, as almost every girl I knew was doing. One day, some people came from Beverly Hills -Superintendent [Ken Peters] and [the late Board of Education members Bernice Hutter and Elinor Nathan] - and they called me out of class and asked if I'd like to interview for a job there. And I said no, because I hadn't applied. And they said, it doesn't matter, they'd like to meet me. I graduated from UCLA on a Friday in January of 1961, and I started to work in Beverly Hills on Monday the following week. And I've been working ever since.

What spurred the change to go from a teacher to an administrator?

That was sort of an accident too. I actually got my administrative degree while just accumulating salary points. And I really was very committed to the classroom, so I wasn't thinking of [becoming] an administrator.

But one day I was in the [Beverly Vista] teachers' lounge, and a lot of teachers who were my age were talking about how things used to be. When I left the teachers' lounge, I thought, when you start talking about how things used to be more than talking about how things are or could be, then it's time to make a change. That conversation, that day in the Teachers' Lounge, made me think about it. There was nothing to do about it at the time, but when the opportunity came to apply for a position as an assistant principal [at Hawthorne], I did.

What prompted the move from Beverly Hills to Stephen Wise day school?

It was another accident. It was! I was very happy and I wasn't looking for a job, but I got a telephone call from a professor at UCLA who I know, who asked if I was interested in being a principal at a private school, and I said no.

He phoned me back about two weeks later and said I ought to think about this. And I said, well, let me know the information. At the time, there was a search committee in Princeton, New Jersey - they were running the search. I had never been to Stephen S. Wise. So I contacted them and then they started putting me through the hoops. I'd heard of head hunters and search committees, but I'd never been in anything like that. So I thought, this will be an interesting experi-

When I was offered the job, I didn't know what to do! I didn't plan to get there. But

then I really thought about working in a Jewish Day School, giving a personal contribution, a leadership contribution. Maybe leadership isn't the right word, but I could contribute in a different way. And so I accepted the job. And I said I would stay for three to five years, and they said that was OK. And it will have been nine at the end of the

Tell us about Stephen S. Wise.

We have approximately 480 children in grades K through 6. [But] it's almost like a school district. There's the preschool, the elementary school K-6, a seventh and eighth grade [Milken] middle school, and then there's Milken Community High School. In addition to that there's a one-day-a-week religious school. There's one Director of Education [Metuka Benjamin] for all five of the schools, and each of the schools has its own principal.

[At Stephen S. Wise,] there are 26 general studies teachers, about 14 Hebrew or Judaic studies teachers and about 16 or 18 speciala lot of paperwork and the kind of things that go on in public schools. In addition to that, we can go beyond that. Anything we say we want to do and is worthwhile doing and that we have the right people to do it, the resources to do it, we can do it. So that makes it pretty nice. In addition to that, because it is a religious school, we can incorporate the Judaic studies into the regular cur-

And then of course, the other thing is the learning of Hebrew. You know, it's funny when I first started teaching in Beverly Hills, the children had foreign language starting in kindergarten, five days a week. The children

ists. And there are about 20 assistants. It's a had that every single day, and they took either French or Spanish. We were very proud of that. And then they had to cut it out for a variety of reasons, one of them being funding. Here, the second language is Hebrew. Everybody takes Hebrew in the elementary school, and they do it just like we used to do in Beverly Hills, years ago. So at the end of sixth grade they are pretty fluent readers,

writers and speakers of Hebrew.

This is not my statement, but the statement of another head of school, not a Jewish school: "We all work on a one-year contract."

That means that you have to carry your own weight. You don't get to lean back on saying, "Pfft! I have tenure and I can slack off." The idea of union does not drive our policies in the school. That doesn't mean you don't have to be fair and care about people. We have a human resources department here as well, and we do adhere to certain terms of employment that are hopefully fair and humane, but it's not union-driven. Hopefully because we're a temple organization, our working environment is a reflection of the fact that we are a temple organization, and demonstrate respect for people.

What is Stephen S. Wise's equivalent to public schools' Boards of Education?

My director of education reports to the Board of Trustees of the temple, and the Board of Trustees of the temple is our governing board. When a family registers their child in this school, they also have to join the temple. So we're connected to the temple.

To a certain degree, when you're working in a district like Beverly Hills, the Board of Education gives direction, the superintendent gives direction, so you are more likely to be operating in a system where the district determines what you do.

In an independent school, it's more of a give and take, I think. I certainly take direction from my Director of Education, but I am equally free to suggest direction and act on it without too much encumbrance. The other thing is, though, there's also a certain responsibility in taking initiative. You can't just expect things to come to you and happen. You have to take the initiative to see what it is that's important and then make it happen.

While other schools around the state are dealing with budget cuts, Stephen S. Wise is able to hire teachers. That must be nice.

It is. We have some wonderful candidates, probably, because of that.

But hiring teachers is one of the most important things a principal does. Everything rests with the teacher and what goes on in the classroom. The principal has to run a good school, supervise teachers, hire good teachers, create and provide the environment, so people can do good work, and where they want to do good work, and that's the job of the principal - to create an environment where all of these good things can happen. But the most important work of the school goes on in the classroom, and that's with the teachers, and the principal has to respect that and create the environment where the teachers are happy and where the teachers feel supported and where the teachers feel honored and respected as professionals. If the teachers feel that way, they're going to give you

their best. So that's what I really hope that **Tell us a little about your family.** I've accomplished here. If I've done that, I've done a good job.

Do you feel like you're really involved with the teachers?

Very much so. The teachers know that. We imagine projects together, we problem-solve together. Hopefully I do some meaningful coaching, formally and informally. When you work with people every day, you get to know them personally, but in a different way, because you see them at their best and at their worst. As a Principal you really get to know the teachers and be friends with them in their lives when they need it.

It sounds like you really love your job.

You know for a while, [people] used to tease me, because sometimes I'd forget to cash my paycheck, because I would always be so surprised - this was way back when I was first teaching - and I thought, because I had never really gotten paid for anything and then I was doing something I loved, and I was so surprised when I got paid. I just never put the two together.

I'm glad I got paid. People should get paid - it's a lot of work. Teachers should get paid more than they get paid. But I never really connected my work with my pay. My pay was my pay and my work was my work. But my work really has defined my adult life. I'm really the luckiest person in the entire world. There's a saying - You can't have it all. But I think I do have it all. I couldn't ask for

Why retire now?

Because I really want to be more present, to be more available, more accessible. For a good many years, people have been waiting for me, and I feel like the people closest to me have had the longest wait, so I feel like this is the time to just be a little bit more accessible

Of course, they have a bet that I won't be, that I'm just going to switch and be equally as engaged. But I think I won't be working 70 hours a week.

What do you plan to do after retirement?

Right now, my real goal is not to fill in all the blanks, because my blanks have been completely filled in for the last 34 years without a break. So I'd kind of like to just experience life a little bit and be very selective about what I commit myself to. I do think I'd like to do something involved with teaching teachers, or coaching teachers, because I think now I get it. But I'm really not sure.

Other things, it was really to be more present to my kids. The whole decision about this was made to be more present in the life of my family. As a principal, I've kind of [worked] every day and many many many many nights. Long days that start early in the morning and end late at night. And when you're not working, you think you should be. So that means you tuck everything else into tight corners – Family, friends. As I said, I'm very lucky, I've been able to do everything. I still want to do it all. I just want to do it all in a slightly more graceful manner.

They're great. They're just the greatest family. I have two married daughters, two great sons-in-law.

My oldest daughter is Ellen Sugerman '81. She's a speech pathologist by profession. She's in cantorial school, and she works with her husband, Steve, in his communications business. She has two children: Michael, who is going to be 13, and Rebecca, who is

And then I have a second daughter, Carolyn Carlson '84. Carolyn was in the entertainment industry. She is currently a graduate student in psychology, and she is the mother of 7-year-old twins, almost 8, and their names are Robert and Rachel. And her husband Rob, is an agent at William Morris.

I better not leave out my husband. My husband is Eli, he's a physician who's been practicing in Beverly Hills for over 40 years, and continues to do so. So part of this plan is to spend a little bit of time together in a more relaxed way. He doesn't know that yet, though. Don't tell him.

Is it strange to be principal at Stephen S. Wise but to have such a strong connection to Wilshire Blvd. Temple?

No. It isn't. I'm actually very good friends with [former Beverly Vista Principal and current Wilshire Blvd. Temple Day School Principal] Nadine Breuer - We were administrators together, we both taught English in the Beverly Hills schools, we both were administrators in the Beverly Hills schools, we both left at the same time, we each became principals of Jewish day schools the same year. No, it's not weird at all. As I said, I'm just lucky because I have these communities where I know people well, and I can participate in each one of them very comfortably. It's just been very nice. I didn't abandon one for the other. I went to work at Stephen S. Wise, I have a job to do. It wasn't a question of that. It was a question of taking my skills and applying them where they were needed.

Do you miss Beverly Hills?

Well first of all, I don't miss it because [I live here]. But in terms of working in the district, when I worked in the [BHUSD], we had a great camaraderie. We really did. We liked each other, we had fun together, we worked hard, we played hard, it was a wonderful group of people in those years that I was in the District. You miss that because in working in a single school, you don't get that broad five-school community.

On the other hand, I guess I'm just one of those bloom where you are planted people. When I went to Stephen S. Wise, I said, This is just going to be a job, these are not going to be my friends. But it just doesn't work that way. It's become another community. I guess my biggest pleasure is that in this nineyear period, I haven't discarded one community for another, I've just added a whole new dimension to my life, a whole new community of people I didn't know before.

Do you still keep in touch with the people from Beverly Hills you worked with?

We have a little dinner group. Living in the community I do connect with people and, so, yes I do. And then there's a small dinner

group of people, very few of whom are still in the district, but, we get together. And actually I'm working with a few of the people at Stephen S. Wise. Tanis Harris – her office is right next door to mine. I think she's just finishing three years as the Director of Student

We just get together once every six weeks, and different people are doing different things - Rita Creagh, Angie Templer, Eloise Metcalfe, Lynn Rappaport (Steve Rappaport's wife, she was Lynn Richards when she was a math teacher at Beverly), Dick Douglas, and then other people come in

Who has been your inspiration?

The current person that I work with, [Stephen S. Wise Director of Education] Metuka Benjamin, I've been working with for nine years. The level of her vision, her energy and commitment, match my own. Working in that kind of environment is very energizing and motivating. You just want to do that work.

Prior to working with Metuka Benjamin, Dick Douglas – He was the principal with me for nine years at Hawthorne [in the 1990s]. I couldn't have done the work I do today without those nine years behind me. He was very ethical and clear-thinking and generous. Those are the words that come to my mind when I think of him. I think he's a great role model, and working with him really cleared the path for the work that [I've done] for Stephen Wise for the past nine years.

Prior to that, my first real mentor was a woman by the name of Lucille Wilson. She taught fourth grade at Beverly Vista. And every morning at recess time, she would put two pieces of cinnamon bread in the toaster, and from her I learned the beginnings of how to teach. I thought she was much older. She probably wasn't as much older as I thought.

And then when I started teaching middle school. I had a mentor by the name of Ben Shaver. And Ben was one of those legendary teachers in Beverly Hills, who all the kids loved. Now he's over 80 years old and his students still find him, even though he's no longer working.

I've had at every step along the way -Lucille Wilson, Ben Shaver, Dick Douglas, Metuka Benjamin - I feel very very lucky. Those are just four out of probably four hun-

What do you consider a legendary teacher?

A legendary teacher is like an artist. Artists perform or produce their art because they have to. They just have to. There's nothing else that they could do but be that writer, painter, dancer, singer, or composer. An artist does what he does because he's compelled to do it, and I think a legendary teacher has a lot of the same qualities of a real artist. An artist sees possibilities in ways that are different from other people, and I think a teacher can see possibilities in ways that are different from other people. So a legendary teacher is someone who not only has the ability to see the possibilities that might not be apparent to everybody else, but also to do something about it. And a real teacher is someone who is also a real learner. A real teacher never stops learning, never stops studying, never stops learning, never stops

trying new things.

Do you consider yourself a legendary teacher?

I consider that I would aspire to be a legendary teacher, even as a principal, even though you're not a teacher in the conventional sense of the word. You have the opportunity to be teaching every day and every minute. Whether as children, other teachers, parents. Some people think the principal doesn't teach. I see the job of the principal as just having a bigger classroom.

What would you title a book about your life?

When I first really thought about it, that I was going to retire— And I use the word "retire"—I'm trying to invent a different word, because I always think of this as making a change, and this time I don't know what the change is going to be. When I gave this up, I thought, I'm so used to operating with this adrenaline rush. You wake up in the morning with an adrenaline rush. And the first thing you do, you open your eyes and you think, "Oh my gosh! There's all this stuff today! [Maybe three events] and a crisis and a petition to be made and somebody you need and somebody sitting in a coffee shop waiting for you. So you wake up with this adrenaline rush, and I thought, I don't know what it's like to not to wake up with an adrenaline rush. So one day I thought, what do you do after the adrenaline rush? I thought, that's got to be the title of the book – "After the Adrenaline Rush." I don't know. I don't think that's as exciting as what comes during the adrenaline rush, so I'm just going to have to get a brand new adrenaline rush.

What do you think is your legacy, both at Stephen Wise and in Beverly Hills?

This is a tough one. I don't want to give some silly little answer because that's such a big question. I hope that you ask other people that. They can tell you!

I hope that my legacy has been to help create a vision and direction for the schools, to emphasize the value of each person, whether it's a child, parent or staff person. To be personally present and somehow model those values-

I was at a grandparents' day at Harvard Westlake the other day, and my husband was sort of taken aback because one of the boys that was a student there kind of flew across campus and gave me a hug, and my husband goes, What middle school boy is going to run off and give his ex-principal a hug, in public, in front of his friends?

You talk about a legacy, it's very personal. It's really... I hope that the families and children and staff feel that they can have, should have, they're entitled to have a personal connection with their leadership.


