"Hilton Referendum"

Max Salter, a former Beverly Hills mayor, sent out a mass mailing, telling residents that he doesn't want them to sign the Hilton referendum, voice their opinions, their thoughts, and their acts, about the proposed Hilton project.

This is my response.

A lot of people are signing the referendum. They don't accept as truth what they've been told about the project – because they don't believe some of our city officials. This referendum is not a vote for or against the Hilton Project. It is simply the means for the citizens of Beverly Hills to tell the Council to put this issue on the ballot and have the citizens of Beverly Hills vote on it.

The overkill and intensity of all of the negative mailers to thwart the Hilton referendum petition process is both appalling and saddening. Before this process even started mailers were sent out advising residents not to sign and saying that the petition was full of untruths. Max Salter's recent mailer letter states that "If you sign, your name will be used to stop the project. Your signature means you have decided to oppose the project." The reality is that at this stage, signatures ONLY signify a desire to place the project resolution on the ballot. Only upon voting will any positions of support or opposition be registered.

Why are the Hilton and their supporters so afraid of the constitutionally sanctioned right of the electorate to petition and vote? If sufficient signatures are not gathered, then so be it. But don't actively sabotage the process! These tactics are not why we live in America.

Interestingly, Hilton describes their project only as a "revitalization" of the original hotel and the addition of the Waldorf Astoria. 2008-2009 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

The City of Beverly Hills announces the availability of its draft "Statement of Community Development Objectives and Projected Use of Funds" for review in connection with the City's annual application to Los Angeles County for federal Community Development Block Grant (CDBG) funds. The City previously announced its program in January 2008, but is adding a new project, the Upward Bound Emergency Family Shelter in Culver City, that will serve homeless families in the region.

Proposed 2008-2009 CDBG Program

CDBG funds must be used for activities considered to primarily benefit persons of low and moderate income. The City's final allocation of 2008-2009 CDBG funds from the County is \$256,743. The City Council reviewed the application at the January 29, 2008, City Council meeting and approved the application and programs proposed except for the Upward Bound Emergency Family Shelter Project. That program was reviewed by the City Council in August, 2008 but must be added to the City's application to the County by formal action that will take place at the City Council meeting of June 3, 2008.

It is proposed that the 2008-2009 CDBG funding continue to support the City's ongoing programs in approximately the same amounts as the current 2007-2008 year. The proposed funding for 2008-2009 is as follows: Handyworker Services (\$190,000), public service programs for senior citizens (\$38,511), partial funding of planning activities and program management (\$25,674), and a contingency (\$2,558). In addition, the City proposes to use unallocated CDBG funds from previous years to fund the Upward Bound Emergency Family Shelter Project.

Upward Bound Emergency Family Shelter Project

The non-profit Upward Bound House is purchasing an existing motel located at 12841 W. Washington Boulevard in Culver City to operate as an Emergency Family Shelter for minor children and their families. The Culver City Council approved this change of use on January 14, 2008. Many local governments are contributing to this regional shelter and Beverly Hills is considering contributing \$200,000 in unallocated CDBG funds toward the purchase of the building. Unallocated CDBG funds are unspent CDBG funds the City has available from past years that must be spent on eligible construction projects benefiting low and moderate income people. By contributing these funds to the shelter, Beverly Hills would be able to refer homeless children and families to the shelter for services through other organizations that serve homeless persons. Many other government and private organizations such as the City of Los Angeles, County of Los Angeles and City of Santa Monica are contributing to the project.

Copies of the proposed CDBG programs are available from the Community Development Department in its temporary offices at 9357 West Third Street, Beverly Hills, California, 90210, or by contacting the Community Development Department at (310) 285-1135. The City is inviting comments on the proposed CDBG program through Monday, June 16, 2008. Comments can be submitted to the same address as above or at the June 3, 2008 City Council meeting.

"It was a historic night last night for our school district," Board member Steven Fenton, who initiated the discussion, said. "I am so pleased and thankful that [Board member] Myra Lurie and [Vice President] Nooshin Meshkaty voted for this landmark initiative."

The program as initially proposed was meant to give permit preference to the children of alumni and the grandchildren of residents, though not necessarily both.

However, concerns voiced by Lurie and Meshkaty led Fenton to propose amendments to his motion that would require that applicants fall into both categories rather than one or the other, their parents to have attended BHUSD schools for at least four years rather than simply to have graduated from one of the schools, and their grandparents to have lived in Beverly Hills for at least 10 years.

In addition, the new program will affect only a portion of new permits, and existing permits will not be affected.

Goldberg, who had shown strong support for the Legacy program in the past, said he could not support the program unless it completely replaces all future random "Opportunity" Permits, rather than only share equal priority.

"I support the passage and implementation of a Legacy Permit Program that provides priorities for Legacy Permits over Opportunity Permits," Goldberg said. "The amendment offered by Myra Lurie and accepted by the Board majority changed the proposal so fundamentally as to make the *city and schools cont. on page 7*

Summary of Ordinance

The Ordinance approves a development agreement between the City of Beverly Hills and Oasis West Realty, LLC, that would enable revitalization of the Beverly Hilton Hotel property for development of a mixed-use project including a multi-story luxury hotel building, multi-story residential condominium buildings, restaurant uses, ancillary commercial uses, and open space. The development agreement approved by this Ordinance is intended to eliminate uncertainty in planning and provides for orderly development of the Beverly Hilton Specific Plan in a manner consistent with the City's General Plan, Zoning Regulations, and other applicable rules. Among other provisions, the development agreement requires Oasis West Realty, LLC to pay to the City a hotel revitalization contribution and public benefit contribution part of which is set aside for use in promoting the provision of affordable housing in the City, establishment of an environmental mitigation and sustainability fee program applicable to the property, payment of a municipal surcharge in addition to the transient occupancy tax on gross room revenue generated by the new luxury hotel, provision of a gateway statement near the intersection of Santa Monica and Wilshire Boulevards, provision of bus turnouts, providing for City shuttle bus access to the project site, providing an easement for a potential future subway portal, and payment of a school benefit fee.

Vice Mayor Fenton, Councilmembers Briskman and Councilmember Delshad voted for the ordinance, and Mayor Brucker and Councilmember Krasne voted against the ordinance.

Faculty votes 229-3 against Straus extension

The Board of Education voted in support of extending Superintendent of Educational Services Ilene Straus' contract for the next three years, in a 4-0-1 vote, with Board member Brian Goldberg abstaining, at its May 20 meeting. Straus' had not yet expired.

Beverly Hills Education Association Vice President Mark Frenn spoke against the extension, pointing to a poll taken of all Association members, asking how they believe the Board should vote. Of the 232 members polled, 229 said the Board should vote

against the extension.

"BHEA is disappointed that the Board did not listen to the input from the staff, from the employees who have to work directly with Dr. Straus," BHEA President Chris Busheé said. "We also are disappointed that the Board chose to take action on this contract extension 14 months before the contract expired, where there has been so much pain inflicted on the non-management employees of the District – We had 11 layoffs in the certificated unit and five or six in the classified unit."

Straus could not be reached for comment.



Superdelegate Waxman endorses Obama

Congressmember Henry Waxman (D-Los Angeles), whose congressional district includes Beverly Hills and is one of about 800 "Superdelegates" who may make the deciding vote in the 2008 presidential election, officially endorsed Democratic Presidential candidate nominee Barack Obama on May 16, on the heels of a similar endorsement from former nominee John Edwards.

"Senator Obama has run an extraordinary campaign and he will be an extraordinary President," Waxman said in a prepared statement. "Senator Obama's vision for change has inspired tens

of millions of Americans."

Waxman's office would not comment further.

Beverly High gives students a taste of the perils of drunk driving



Beverly High's "Every 15 Minutes" program, a series of dramatizations intended to show students the dark realities of drunk driving, began May 21 and will conclude today with a "memorial service" assembly.

"It's very powerful, very impactful," said Beverly High Principal J Guidetti. "If we can save one life, we've done our job."

The first day of the program showed students the gruesome aftermath of a staged alcohol-related car accident. Beverly Hills Emergency Services were on the scene to extract students from the cars and to arrest the drunk driver, all while juniors and seniors watched

and a camera filmed the simulation. For the rest of the day, a student was taken from class every 15 minutes, the statistical frequency of alcohol-related traffic deaths in the U.S. at the national program's inception. The students were then sequestered for the night, during which time they wrote "goodbye letters" to their families.

The program culminates today with the "memorial service assembly" during which juniors and seniors will be given access to video footage of what happened after the accident, from the accident to the hospital to the jail to the trial. There will also be speakers at the assembly. Freshmen and sophomores will attend a separate assembly today, and parents were exposed to the program at their own assembly Wednesday night.

Guidetti said counselors and teachers are standing by to help debrief students after the program.

"Every 15 Minutes" is a collaborative effort of a Beverly High parent committee, the school's PTSA, administration, counseling staff, and other concerned community members, including former Mayor Les Bronte. Major event sponsors include the Vahagh Setian Foundation, Beverly Hills Rotary, the City of Beverly Hills (including the Police and Fire Departments), Cedars-Sinai Medical Center, Maple Counseling Center, and the Beverly Hilton Hotel.

El Rodeo students from all grade levels sang, danced, played instruments and displayed a variety of other talents at this year's Variety Show on April 24.



The performing arts center would involve the rehabilitation and reuse of the City's former main Post Office to house the classrooms, studio, ancillary activity space, administrative offices, and theater support areas. The project also involves the construction of a new 44?-foot high theater and sculpture gardens on the southern portion of the Post Office site.

A City subterranean parking structure proposed at 455 North Crescent Drive, under Crescent Drive between the former Post Office and City Hall. The facility is proposed to provide between 280 and 300 parking spaces in two levels with points of access at Santa Monica Boulevard South and through the parking lot along the north side of the former Post Office (proposed as a motor court). A three-level subterranean facility is also being considered as an alternative and could include alternative points of access.

An Environmental Impact Report (EIR) is being prepared for this project in accordance to the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The Draft EIR is expected to be released during mid-June. A public notice announcing its release will be provided at that time. No decision will be rendered on the project until the public has been provided at least 45 days to review the Draft EIR and written responses to any comments made on the EIR have been prepared.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

If you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

We Could Use Anger Management

Keep community issue discussions rational By Rudy Cole

Why all this anger? Our village is going to have a collective ulcer unless some of the hostility, loathing and emotions being spent on the Hilton project aren't, at the very least, brought under control.

For those of you not involved, and that is probably a large number of our residents, some background:

A majority of the city council voted to approve a plan that would bring a Waldorf Astoria and a condominium project to the Hilton property.

Now, some activists have launched a petition drive to challenge the council action, or at least one element of the proposal, that could lead to a referendum. If successful, the referendum would be placed on the ballot and the voters could overturn the city's approval. Or, to make this even more complicated, the council could rescind its vote and accept the intent of the referendum and there would not be an election.

The referenda process is an important right

of the people. But are they always wise and responsible? The Hilton project has been vetted more thoroughly than any project in our history. Countless studies on traffic, parking, economic benefits and neighborhood impacts have created a mountain of paper work few outside the council, staff or city commissions are ever likely to even scan much less study.

The Hilton wasn't thrilled with some of the demands they had to accept to gain council approval, but those conditions were in the public interest. The result of the legislative process is far more parking, traffic lanes to reduce traffic and considerably more revenues for our city. The referendum means losing all of that.

We received countless emails on both sides of the Hilton debate and next week we will publish a sampling. One of the most contentious questioned my view that the petition circulators were being somewhat disingenuous by arguing that signing "only" meant allowing the "people to decide" and "put this

issue on the ballot." Actually, by signing, voters, and they are the only ones legally allowed to give their name, are stating their opposition to the project.

There are some puzzling questions about why opponents of new developments decided only to challenge the Hilton. Some are very sincere - they view any change, any growth as harmful. But this negates the need to revitalize deteriorating areas through "smart, selective growth." They opposed the Montage Beverly Hills, and lost at the polls, despite the clear economic benefits and, equally important, the beautification of one of the ugliest, most neglected sections of the triangle.

What projects are most beneficial, most meet the test of "smart" growth? Hotels and housing. So, why were these same people so silent when the William Morris deal was pushed through the council? That development is smack in the middle of some of the most congested streets in our city. True, we have economic benefits from talent agencies remaining in our city, but the assurances that this structure, across from the Montage Beverly Hills, would continue as an entertainment use were far too weak and uncertain.

Why no outrage at this far more intrusive entity?

Waldorf =Astoria is far removed from any other commercial use - gone is the Robinsons-May being replaced by condos, a clear decline in traffic generation, that was next door. Incidentally, some opponents of the Hilton trotted out a discredited traffic study that claimed that Wilshire and Santa Monica was the most congested in Los Angeles. This was a seat of the pants report released many years ago by State Farm and immediately challenged by city traffic experts. A simple look at Wilshire and Westwood and dozens of intersections in downtown Los Angeles would make the insurance company claim ludicrous.

There is one more aspect of this dispute that needs to be told, and it has social implications. The Hilton owner, Beny Alagem, has been honored by one of the most militant, activist unions in the country for his "humanistic approach to labor relations." He gives back to our city and he lives here. He is not some outside investor looking to make a quick buck by enhancing the value of his property and then flipping it for profit. He is trying to create an exciting edifice that will be a cash cow for our city and he has had to accept all kinds of costly conditions to gain city approval.

Speaking of the Hilton, they are losing their hotel manager, Denny Fitzpatrick who has decided to return to his home in the northwest and a new hotel job. Denny too has shown civic responsibility with his service to the community, including a successful term as president of the Chamber. Denny will be missed.

Sometimes I wonder if the purveyors of



doom and gloom and I live in the same city. They vent their anger against the council, charging everything from mismanagement to insensitivity on change. But in the Beverly Hills I know this and past councils have helped provide one of the safest communities in the world. Amazingly, as one example of public safety, it took exactly 35 seconds for our police to respond to a murder report near the high school very recently. Aside from a more secure community, our alleys are cleaner, our parks better maintained, our library user friendly, our traffic management systems more effective, our city employees totally patron sensitive, as just some examples of what makes this such a great place to live, work and educate our children. And most residents fully understand the interdependence of an economically viable business sector and the preservation of residential values.

It may be painful for our "no sayers" to admit, but this is a well managed and led city and some of the credit must go to our elected officials.

We would all benefit from a lowering of voices; and a debate on the city's future needs without resorting to smears, innuendos and personal attacks. There is a place for rational opposition to any proposal, but within the confines of responsible debate.

Can a referendum be more emotional than rational? The state supreme court recently ruled that same sex marriages were constitutionally permitted.

They struck down a vote of the people banning gay marriages. Did the opposition to gay marriages really weigh the rights protected by the state constitution or were they reacting to the emotions of religious or personal biases? Of course, it is historically fascinating to find that the most militant gay bashers wind up putting their toes on undercover cops in airports. Demeter quoted a number of reasons for her vote, including the costs of increased staffing and possible lawsuits that could arise from the program, as well as the idea that the program is a form of "elitism" that will not add any "cultural or intellectual benefits" of changing the current program.

This sentiment was echoed by former Board members John Millan and Alissa Roston

On the other hand, about 40 residents spoke in support of the project, including former mayors Les Bronte and Joseph Tilem. Former Mayor Max Salter was disagreed with his views on the Middle East. The letter writer wasn't pleased with my support of Israel, that's fair, but to add words I never used was disturbing.

As for the Middle East, the most encouraging development is the start of serious talks with Syria. It is difficult for Israel to make a deal with the proposed Palestinian state because they can never know who will emerge as leaders – will it be the fairly responsible faction or the terrorists who will not even agree to recognition of Israel and who continue terrorist actions against vulnerable villages?

Final note on our police: A reader told me about a complaint he wanted to file against a member of the department he felt had been rude. I happened to know the officer involved and I tried to assure the reader that his record of service and his behavior in the line of duty had been without any blemish.

In any case, the resident met with Deputy Chief **Robert Curtis** and told me later that Curtis had been totally professional and had allayed his concerns.

A proposal to allow parking on both sides of the Two Hundred South Block on Reeves is not sensible. Parking is allowed on both the west and east side in the 300 south block and that makes passage of cars very difficult, but 200 south would be even worse. That narrow block is one block east of South Beverly Drive with its large number of restaurants and retailers that cause frequent trips around the street in search of parking spaces. The change would create major safety problems.

However, revenue projections are always exaggerated, and project costs to the City are rarely, if ever, factored in. Not to mention the increased traffic brought by greater height and density. Has anybody on the City Council ever considered cost reduction?

The Boards of the Municipal League of Beverly Hills, North Homeowner's Association, and the Southwest Homeowners' Association have all voted to support the Referendum Petition.

Let's do the right thing – sign the Referendum Petition and get the Hilton Expansion onto the ballot. We, the residents, will then vote and decide for ourselves whether it will be good or bad for our City. Beverly High advanced to a Southern Section boys' tennis final for the third time in four years and earned a measure of revenge with a 15-3 victory over Santa Monica Crossroads in a Division III semifinal Tuesday at Beverly Hills.

The Normans lost to the Roadrunners, 11-7, in a semifinal last season. Crossroads went on to win the championship.

Second-seeded Beverly Hills (20-4) is scheduled to play top-seeded Brentwood in Wednesday's final at The Claremont Club, set to begin at 11 a.m. The Normans lost to the Eagles, 10-8, April 16 in a nonleague match at Beverly Hills.

Beverly Hills' last two trips to the Southern Section finals both resulted in losses to Brentwood, 16-2, in 2006 and 10-8 in 2005, both in Division IV finals. The Normans' most recent Southern Section boys' tennis championship came in 2001 when they defeated Westlake Village Westlake, 14-4, in the Division III final.



Frank and Judie Fenton discuss their community involvement and being honored at the

BHEF Apple Ball on May 29

How did you first meet?

Judie Fenton: We met in a phone booth at Mount Sinai Hospital [now Cedars-Sinai]. Frank was a page and I was a volunteer.

Frank Fenton: I worked in the admitting office.

JF: And I was 15 ? and Frank was 18. **FF:** 19.

JF: 19. Yeah. And I was making a phone call in the phone booth, and Frank was waiting to make a phone call in the phone booth, and he was tapping on the window, and I was looking at him, giving him this just-a-minute look, and he was just- He had no patience whatsoever. Finally I finished, and in the old days the phone booths used to open up, you know, and we'd walk out, and he'd say, "Well it's about time!" and I'd say "Well you're just so rude!" And I went back to my floor and he made his phone call and then he went up to the volunteer office to find out who was the cute blonde who was in the phone booth in the volunteer office.

And then that night, my family took me to Las Vegas, and he happened to go to Las Vegas with some of his friends, and at about 11 o'clock or midnight I was walking through the casino and he was coming out of the—

FF: I was coming out of the Louis Prima thing.

JF: And we saw each other.

FF: And I saw her in this gorgeous blue dress, and that was it.

JF: We definitely were high school sweethearts.

Tell us about your family.

JF: We have four of the most unbelievable, individualized children.

FF: Fantastic.

JF: They're all such outstanding adults, and they all are very diverse, and they all graduated from Beverly.

FF: They all went to Horace Mann.

JF: Our oldest daughter graduated from UCLA, our youngest daughter graduated from UCLA. We're both alumni Bruins.

FF: Gary graduated from 'SC.

JF: But we won't hold that against him. And Steven graduated from Pitzer.

FF: But Gary then went to law school.

JF: [Now he] is an attorney. Steven

went on to be a politician like his father, and our oldest [Mindy] went on to give us two beautiful grandchildren, and our youngest child, Jennifer, is a first grade teacher at Brawerman Elementary [Wilshire Blvd. Temple] and has her masters from Pepperdine. She has a masters in—

FF: —in education.

JF: Right. And she works for Nadine

dren. And we met some of our nearest and dearest friends through our children.

Like we met Toni & Bruce Corwin, Linda & Mike Roberts, Stephanie & Sherman Gardner.

FF: Francine Silvera.

JF: Francine and the late Al Silvera. Just to mention a few.

And throughout Frank's political career and [now] crossing back and over to Steven's political career, these people who we knew then, are the people who have stood up and supported Frank's political endeavors and Steven's political endeavors. And it extends over 40 years of making acquaintances and lifelong friends.

How did Beverly Hills Sports Camp get founded?

JF: [In 1978,] Proposition 13 passed and there was no summer school that year. And we started the camp for children called the Beverly Hills Baseball and Sports Camp.

Breuer, who is the principal, who used to be the principal of Beverly Vista.

How did you first get involved in the City?

JF: We moved in 1971 and Frank became president of the American Little League.

FF: I was coaching Little League and the president [Larry Levy] had a heart attack.

JF: Right. And they asked Frank if he would step up and fill his shoes for a year. And then Larry decided he did not want to resume the presidency, and they elected Frank. And at around that time, I became president of Horace Mann PTA. I was president of Horace Mann PTA and Frank was president of Little League and we just got really involved in this community because of our chil**FF:** We did that two give two of our teachers at Horace Mann a job.

JF: There were two teachers who wouldn't have summer school jobs, and they were coaches for Little League – Mike Hochman and Steve Kessler. And Steve Kessler's still a teacher at Horace Mann. Mike was a football coach at the high school.

FF: We said, "If we can start a summer camp for kids, a day camp—

JF: —a baseball camp, because they were baseball coaches – would you be interested in doing something like that?" We opened it up at Rancho Park.

After several years, Steve Fisher from El Rodeo became our director, and Steve Fisher was our director for 14 years. And then it became Beverly Hills Sports Camp. It is still in operation. We founded it, we owned it for 14 or 15 years—

FF: Was it that long?

JF: —and it is now owned by Steve Taylor, who is a teacher at the high school, and his wife Robin.

There are not too many children who haven't gone through the Beverly Hills Sports Camp. When Steven was running for office, people would come up to him and say, "The best time I ever had was at your parents' camp." They remember their camp experience.

And one young man whose name is Scott Myers, he was one of my counselors and now he has a Joey's Gym in Manhattan Beach. He liked working with children.

FF: What about Mr. Waters?

JF: Oh, Richard Waters? Who [will be] recognized [May 29] as [a BHEF Apple Award] recipient?

FF: He was one of our counselors.

JF: There are a lot of people, a lot of stories about the camp. The camp was a good time.

How did you decide to run for a position on the Board of Education in 1983?

JF: It was all through meeting these people that Frank was encouraged to run for the Board of Education because there was never a candidate from Horace Mann who ever served on the Board of Education before.

We found out that children from various schools were not reading from the same text books, that Horace Mann was way behind, that Hawthorne was reading from newer text books, and we felt that there was not equality among the four schools. Frank was an advocate for equality among all schools and was the first elected official from the Horace Mann area to ever serve on the School Board. There were two others who followed him: Dana Tomarken and AJ Willmer.

I think we showed people it's possible not to be a candidate from the North who had a little bit more money or could raise money, that it can be done if you work hard and you walk and you knock on doors and people believe in you and even if they give you \$5 toward your campaign, you've got them committed.

How did you segue from the schools and get to be so involved in the City and City politics?

FF: I was on the Board of Education from 1983-1991.

JF: After '91, he took down a few years when he didn't run for any office, but they recruited him for BHEF to become the chairman. They drafted him. They literally drafted him!

FF: I got a call one day from the BHEF asking me if I would come onboard as chairman for a year or two to help them out. Which I did.

JF: [It was] because of Frank's occu-

pation and his expertise as a portfolio manager – his real love and interest is finance – that he was asked if he would be interested in running [for City treasurer].

A good friend of ours was Ray Gerson. He was the City treasurer for about 12 years [1972-1984]. And Ray worked for Frank at Sutro & Co. And he always said to Frank, "One day, I would like you to be the treasurer." It really stemmed from Ray Gerson.

FF: And Ernie Ach.

JF: But Ernie Ach was one of the people who encouraged Frank to run for Board of Education, because Ernie Ach was also a stock broker with Sutro & Co.

FF: He was actually one of my bosses.

JF: He's a community member. And he was a Board of Education member [from 1957-69]. He also talked to Frank about Board of Education. So he was one of the mentors in the Board of Education era. And when it came to the financial era, it was Ray Gerson who said, I'd like you, one day, to think about being treasurer.

He was loved and revered in this community. I think he was the longestserving treasurer in the community. And he convinced Frank, and Frank ran unopposed in his first term as treasurer. That's where he should have stayed, buried in City Hall as treasurer.

FF: It was great. I didn't have to go to any meetings.

JF: No meetings. No pot-shots. No vicious attacks!

FF: Just had to reinvest the City's cash-flow.

JF: And he did an unbelievable job. Frank did a lot for the City and I think saved the City or gained the City \$5 million in a transaction of a reinvestment. And then it was a natural progression possibly to think about going to City Council, which I rue the day I even thought to say—

FF: My boys said, "Dad, you've got to run for City Council. There's nobody ever in the history of the city who's ever been elected to all three offices, and we want you to be the one to do it." I said I really don't want to do that, but they convinced me I should do it.

JF: And that's how he got to City Council. But he should have stayed treasurer.

How do you feel about how a number of your old friends are coming forward, at Tuesday's Board meeting for example, in support of the Legacy permit program?

JF: Because they'd like to give their grandchildren the same experience their children had.

Not only that, but a lot of our friends do day care. They'll watch the children after school. Some of them are driving into the Valley to pick up their grandchild because the parents are working. They're doing it anyway, so it means a lot to these parents. They can send their grandchildren to a local school and they could be picking them up after school sometimes so their kids know where their kids are. It's for day care. There are a lot of them who want it for day care.

It's not like we invented the Legacy program. It's been going on for years and years and years and years.

FF: Everywhere else but here.

Tell us about FTA and how that got started.

In December of '91, one of our firefighters, Captain Stan Speth, called and said, "You've always done a tremendous amount of volunteering in all the schools, and our Fire Association wants to start raising money for a medical trust fund for the firefighters after they retire and after the City's insurance policy runs out. Would you and a group of people be interested in helping us put on an event that would raise us some dollars for our medical trust fund?"

Every few months, [Stan] would say "We're almost ready. We're almost ready." And by the time they got ready to do this, it was 1992, and my partner [former Board of Education President] Dana Tomarken and I had formed a company called Fenton Tomarken and Associates, DBA "FTA Events."

We told them we were already in business, but we would try to put this dinner on and we would try to charge as little as possible because it was our fire department. I think it was [Dana's] son Jason [Class of 1987] who gave us the idea of calling it the Backdraft Ball.

We were hired by the Fire Association to put on the Backdraft Ball in June of '93, and our very first job other than the fire department was we worked for NARAS, the National Academy of Recording Arts and Sciences, and they hired us to do their first pre-Grammy dinner.

FF: Which she's still doing.

JF: And 2009 will be our 15th year with the Grammy's.

But getting back to the Fire Association, when the police saw the Fire Dinner, they hired us. So we were hired by Fire in '92, we were hired by the Police in '93, and we've been with them ever since.

But this year, we started something new. A community member endowed a very major league gift to give the children of our firefighters scholarships. So [the scholarship committee is] giving their first three scholarships at the Backdraft Ball on June 4.

We have been involved in their lives in this community for well over 15 years.

It's been said that because of my affiliation with the Fire and the Police Association, that they went out to support a development project; and if the truth be known, and they will verify this, I was very much against them supporting any major development in Beverly Hills, because I did not ever want anything to jeopardize the fundraising ability out there.

FTA is an event company and we do community outreach. We are not lobbyists. We do not lobby. And since Frank has become a City Councilmember, we have not taken any projects. We have only done events. We have not done any Beverly Hills community outreach.

You've been very involved with the campaigns of a number of Board of Education and City Council candidates. Tell us about some you were particularly proud to work with.

FF: One of the things I want to tell you is she has gotten a lot of people elected, and she's never taken one penny to do it.

JF: We support candidates we really believe in. We're really very proud of the candidates we've helped get elected.

We were very very proud of Willie Brien on the Board of Education.

Very proud of a man who's since passed away, [the late Mayor] Ben Stansbury. He was so ahead of his time. He wanted to close alleys down like little Parisian streets. He wanted to put umbrellas out on the sidewalk and put benches so people could eat on the streets. And everybody went, "Ugh, that'll never fly," and look what's happening on Canon Drive today. He was so ahead of his time. He was a true visionary.

Very proud of Vicki Reynolds. Very proud of her commitment to public education and then moving on to the City.

FF: [Former Mayor] Annabelle Heiferman, who happens to be Dana Tomarken's mother.

JF: There have been some wonderful candidates who we've supported.

We're most proud of our son. From a political standpoint, from someone who does campaigns, he was the ideal candidate. You never had to tell him to walk – he was walking every day. The worst thing you can tell a candidate is you have to get out and walk, and they look at you like you're a monster with five eyes. It's very difficult.

I did Barry Brucker's campaign for Board of Education [in 2001]. I did Myra Lurie's campaign for Board of Education [in 2003].

I'm proud to say that when candidates are considering running for office, this office becomes the first stop. I have a great deal of pride in that. We can't run everybody's campaign, because, as I said, we only run candidates who we really know well, and we believe in. But they usually come here to ask for advice and see what they should be doing, and I feel very proud that somebody would ask for your advice. And Frank, too. The first name they want – Frank is always an honorary chair because he's got so much integrity and commitment.

This has been a very hard year.

What advice would you give to new families who move to Beverly Hills?


