"Are Hilton Opponents Really For a Vote" [Issue 459]

During the signature collecting phase your column was very critical of the Referendum process because you said it second-guessed our elected officials. Now you state that the process Hiram Johnson put into place was to "assure the right of the electorate to overturn almost any and all elected officials actions" and is "how the system is supposed to work." Well which is it, a good thing or a bad thing?

Also, in your column you stated, "the referendum once it qualified prevented any and all of the elements of the project from going forward without an election." This statement is FALSE!! Were the vote on the development rescinded by Council, a reduced project presented to the Council could have moved forward without the election. Your statement implies that a smaller project, (preferred by Mayor Brucker, Councilperson Krasne, and the Planning Commission) could not move forward without an election.

The petition asked for the project to be rescinded as passed OR for an election, so

this is NOT a reversal by those who collected signatures or those who signed.

Now you enter the arena with the "doom and gloom" argument that is always used to push oversized projects through, a cut in vital services. We heard the same scare tactics when Prop 13 was proposed. It is good for you to know that the electorate is far too smart to buy into this. The truth is:

Condominiums do not contribute to the TOT.

The Waldorf is expected to cannibalize room occupancy from the Hilton thus limiting the increase in TOT.

Condominiums and almost doubling of the Hilton's square footage result in COSTS to the city in fire, police, water, and other City services. How much cost? Just one item: The fire department needs additional equipment and training to deal with an 18 story high-rise fire, the size of one of the condos. Who pays for this?

The Hilton is across the street from El Rodeo School and a large residential community. What will 6-7 years of construction do to the air quality, traffic congestion, street safety, noise levels, ground vibration, and quality of life to the students, teachers, and residents just across the street from the project?

You stated that the construction impacts are "very temporary." Temporary for

Board Approves Most Expensive School Bond Ever

The proposed General Obligation Bond, which is at least three times more than any school bond in the history of BHUSD, aims to secure the "necessary funds" to make seismic and safety repairs at the five school sites. An independent consulting firm conducted a survey of Beverly Hills residents to gauge their support for the bond, with 60 percent saying they would support a bond if it didn't raise their taxes.

"I don't want the perception in the community that our schools aren't safe. Our schools are safe," said Goldberg about what he called "scare tactics" in the argument for the bond that the schools are in dire need of repairs. "But there is no question that a bond is needed. But [rushing this process] may come back to bite us in the tuckus."

After almost three hours of deliberations, the Board unanimously approved placing the

In a 4-0-1 vote, the bond as a Prop. 39 measure on the November BHUSD Board of ballot as a safety measure given the Aug. 8 deadline for submitting a measure for the bal-Education voted to put lot. But the Board directed Superintendent Kari McVeigh to investigate whether or not a March bond could qualify for Prop. 39, which requires a two-thirds approval of the board and 55 percent of the general election vote to pass, on the March 3 City Council election. A non-Prop. 39 measure would raise the general election approval requirement to 66.67 percent, but would not require two-thirds board approval.

> Should the findings indicate that March is viable for Prop. 39, the Board will hold a special meeting on the morning of Aug. 6 to discuss amending the decision and weigh the costs of each election. A March election would require a special ballot for the 24 voters in the BHUSD who are registered outside of the city of Beverly Hills, which would require the district also pay that city or county's election office.

The proposed General Obligation Bond would come from extending current property taxes of \$49.87 per \$100,000 assessed value of a home, in place from the last bond known as Measure K that passed with 78 percent support in the general election in March 2002.

Measure K was placed on the ballot to continue renovations after the conclusion of the Measure S bond, which passed with 70 percent support in 1993. At that time, bonds still needed 66.67 percent to pass.

"The safety and security of our schools is foremost and it cannot be postponed," said Board President Myra Demeter, who unlike all of her colleagues unwaveringly supported the November election.

Board members Steven Fenton and Goldberg were concerned about rushing the vote on a bond measure during the summer while many "stakeholders" were away for


vacation as well as the limited time in which they could wage a campaign.

"The [November] election is in 98 days. We haven't raised a penny and haven't hired a campaign committee. How do we rise above the noise of a major referendum that has fractured this city? I feel like I'm about to play the New England Patriots and just have to grab people and uniforms and get on the field," said Fenton about his concerns in voting for placing the bond measure on the same ballot as the presidential election.

Fenton and Goldberg are often on the other side of the fence from their Board peers. But after discussing their concerns, Board Vice President Nooshin Meshkaty supported Fenton in a short-lived motion to discuss the possibilities for a March vote, providing that the measure would still qualify for Prop. 39. The motion, however, failed in the initial vote.

"November is time-sensitive. El Rodeo parents who are concerned about the Hilton project will come out to vote and they will likely be pro-bond," said Lurie, who at the end of the meeting was open to discussing placing the bond on the March ballot if it would qualify for Prop. 39.

If the bond passes, the Board would legally need a bond counsel to go forward. At the meeting, the Board in a contentious 3-1 approved firms George K. Baum and Jones



"We put everything to a competitive bid," said Goldberg, who voted against approving either parties contract, in a phone interview. "But there was no competitive bid for this."

Jones Hall worked with Beverly Hills several times, including in 2007 via the Beverly Hills Public Financing Authority in connection with the 2007 water revenue bond for a over \$35 million bond.

If the bond is successful, Jones Hall's fee will include 0.5 percent of the first \$5 million principal amount of Bonds, with 0.25 percent on the next \$5 million, an eighth of the following \$10 million and a sixteenth of the remaining principal balance. The final total fee could be in the millions.

Confusion and frustration with a lack of options and lack time to digest the material pushed Lurie and Meshkaty to both want to table the last item on the bond agenda about renewing a contract with Strategic Concepts, LLC, which is BHUSD facilities director Karen Christensen's company. The issue will be discussed at the Aug. 6 meeting, according to Demeter.

"There will be a huge amount of money going to legal fees. I would have liked to have seen other options," said Fenton.

A 5.4 Earthquake Shakes Beverly Hills

People in Beverly Hills found themselves shaking on Tuesday from the rippling effects of a 5.4 magnitude earthquake that hit near Chino Hills, over 30 miles away.

At 11:42 a.m. on Tuesday, an earthquake that the U.S. Geological Survey originally estimated at a 5.8 but revised to a 5.4 magnitude originated two miles southwest of Chino Hills. Its effects have reportedly been felt as far south as San Diego and as far east as Las Vegas, Nev. No injuries or deaths were reported by press time.

The emergency earthquake plan was enacted at Beverly Hills' City Hall and by the local emergency services crews, according to city spokesperson Cheryl Burnett. Everyone inside the City Hall, including office workers, visitors, department heads and the mayor, were evacuated to a pre-determined place after the shaking stopped. Designated floor managers accounted for everyone's well-being.

The Fire and Police departments began the Windshield Survey, in which they survey the city for structural damage or human injuries, said Burnett. The Building and Safety Commission sent out inspectors to assess the schools and other important city facilities.

Based on the location of the epicenter, the earthquake most likely was caused by

the Whittier Fault or the Chino Fault, not the larger San Andreas Fault, which caused the destructive 1994 earthquake, according to the USGS Web site.

A series of after-shocks, as great as 3.8 magnitude, were felt in the surrounding communities for the rest of the afternoon.

Public Review Started for Hilton Referendum Ballot Statements

"It's just too big." That's how the argument against the Hilton revitalization plan, or Measure_, starts on the proposed official sample ballot booklet to be distributed for the November election.

The arguments for and against the Hilton referendum and the city attorney's impartial analysis were released for public review by the City Clerk's office on Friday. They are available at the City Clerk's office for public review and input for 10 days.

The 296-word argument in favor of the Hilton expansion plan argues that it "creates the biggest single economic benefit in Beverly Hills' history for our schools and city." It was signed exactly as follows: Joan Seidel, a former Beverly Hills City Treasurer; AJ Willmer, former BHUSD Board of Education president; Bruce C. Corwin; Parviz Nazarian; and Vicky Mense, chair of Beverly Hills' Chamber of Commerce.

The 298-word argument against the Hilton expansion was signed exactly as follows: Larry Larson, treasurer of Citizen's Right to Decide Committee, who wrote the referendum; Richard A. Stone, a

former mayor and board of education president; Ben Norton Jr., a former mayor; Edward I. Brown, a former mayor and Planning Commission chair; and Brian Goldberg, professor.

The impartial city attorney's analysis lends weight to the pro-Hilton argument, noting that the city would "generate approximately \$390 million more in revenue to the City than the continuation of the existing development." It also notes that the building footprint will decrease by 20 percent and allow new public garden space.

The Final Environmental Impact Report did recognize "significant impacts" on the aesthetics of the area as well as on cultural resources based on changes to the architecture.

One aspect of the ballot that may be confusing for voters is what a "yes" or "no" vote would mean. Given the rhetoric around the issue, it might seem that voting "yes" on the ballot means voting "yes" for the referendum, when in fact the opposite is true. A "yes" vote on Measure_ gives support to the Hilton expansion plan.

Larian Seeks Mistrial After An Alleged Ethnic Slur in Bratz Doll Case

The lawyer for Beverly Hills resident Issac Larian, creator of the Bratz dolls, asked for a mistrial on Friday in the copyright infringement case brought against his client by Mattel because of a racial slur allegedly used by a dismissed jury member.

The case involving Larian, CEO of MGA Entertainment, was in its first stage of the federal trial when a jury member

used a "disparaging" ethnic remark against Larian, who is Iranian, in jury deliberations, according to Larian's lawyer Thomas Nolan. Another juror alerted the court authorities to the derogatory remark, and the offending juror was dismissed from the case by presiding Judge Larson.

Jurors found that Larian conceived of the Bratz dolls idea while employed by Mattel on July 18, and were discussing possible damages to be paid Mattel by the defendant on July 23.

Nolan said that seventh amendment provides, in both federal and civil cases, that all defendants are entitled to fair and impartial deliberations by all jurors.

"Based on one juror's inappropriate statement, Mr. Larian and MGA were deprived [their seventh amendment rights] by a unanimous jury," said Nolan.

Nolan filed the briefs in the Riverside federal court on Monday morning. The trial has been suspended until Aug. 4 when a hearing will be held to determine whether or not to declare a mistrial.

Should the case not be declared a mistrial, there will be another two weeks of testimony, according to Nolan.

Audit Gives Chamber Good Marks Assorted other subjects

been completed and delivered to the city for study and evaluation (see cover story, page 9).

A very cursory look at this really outstanding report has some important findings: The city is getting its money worth and the Chamber is delivering the services the city supports financially.

On the critical issue of separation of the Chamber and the Convention and Visitor's Bureau, the report cautions a very deliberative and thoughtful approach, listing both advantages and disadvantages of a split.

Are staff salaries too high? Not according to the report. Are there improvements needed in both CVB and Chamber? Yes, but with more community and business interest involvement.

First, the City Council should not act on any issue including separation until the Chamber has had a full opportunity to study and respond to the audit.

We too need more time to evaluate the audit which was released yesterday.

Putting aside some private motives and personal issues some may have with the Chamber, the audit is a very healthy means of better understanding the Chamber's role in our community.

Wednesday the Los Angeles Times admitted the following errors: An affirmative action initiative pushed by **Ward Connerly** has not stalled in Nebraska, but in Oklahoma; **Cameron Silver** is the sole owner not co-owner of Decades; the federal deficit is not \$9.5 trillion, that is the overall federal debt, not a yearly deficit; a "home of the week" in La Jolla is not in Orange County, but San Diego County and a new James Brown DVD and an Elvis Presly CD due on "that day" but in reality would not be ready until August 5, 2008. How many mistakes did I make last week? Enough, but after all The Times has more space to err. First, I am sorry I was not able to reach **Myra Demeter** before reporting on rumors that she was going to resign (see letters, page 5). I probably should have tried harder.

Or I could have used the **Drew Pearson** ploy. In a radio show the famed political gossip columnist once said the following: "I predict that the While House will firmly deny that (a cabinet member) will shortly resign. The next day President **Harry Truman** attacked Pearson for not getting it right and denied there would be a resignation. How did Pearson react? "As I predicted correctly, the White House denied my story."

Certainly, whether or not the reports I had been hearing from many sources were accurate, Demeter would have denied she was leaving. But I will take her at her word that this was never her intent. She now told me that not only is she not leaving, she is considering running for a third term. Well, let's not go overboard here.

Other mistake: Last week two readers named Richard had varying degrees of anger regarding something I wrote. I asked if there was one more Richard who could find fault. There was, but he was gentle. When I said **Richard Rosenzweig**, who has probably been president of every major Beverly Hills organization except Camp Fire Girls, had not served on a commission – his wife **Judy Henning** holding that distinction, I was very wrong. Richard was indeed president and member of the City Fine Art's Commission and later Ms. Henning also served on the same commission.

Another reader again mistakes what I wrote re: Hilton referendum. I did not, and would not, deny the right of citizens to circulate a referendum that would overturn a council action. What I opposed was a demand that the council not vote but submit the proposal to an election. In other words, having the council initiate a vote instead of doing so by petition circulation.

The democratic process and a system of government by representation is our best protection against hysteria or bigoted mob rule. That's inherent in our constitution.

Theatre Forty is really a community gem and merits our support, but it is also a wonderful way to enjoy theatre. For those of you who have not had a Theatre Forty experience, this is not "community theatre" or amateur night at the civic center, this is a highly regarded, very professional group.

Not all of their productions are winners, but their ratio of critical acclaim to pans is very high. A recent mild disaster was a musical which probably was not appropriate for the theatre's venue. Mercifully, it was yanked after one performance. A great success has been the long-running "The Manor" at historic Greystone, and the scandals that monument to oil greed contained.

Now it is a pleasure to recommend the current offering at the Reuben Cardova Theatre, **Neil Simon**'s Pulitzer and Tony award winner "Lost in Yonker's." Directed by the talented **Howard Teichman**, it has an outstanding cast.

The play follows the relationships of a very dysfunctional family, is there a play about one that is functional?, and is set in Yonkers, of course, in 1942.

The young Neil Simon character, played by **Bridger Zadina**, and his older brother, portrayed by **Zav Herschfield** almost, but not quite, stole the show with their flawless performance. Not a missed line, none. Never a break in character, the two held their own with the more experienced cast members.

Their hapless widowed father, played by **Scott Facher** and their uncle Louie, by **Larry Ohlson**, were solid if slightly too stereotypical performances, especially the latter who was a gangster wannabe. Some slight subtleties would have helped.

On the other hand, the three female roles were even more stereotypical but incredibly brilliant nevertheless.

As the dominant, conniving mother and grandmother, **Nan Tepper** gives, not only a chilling interpretation of a matriarchal tyrant, she does it with such credibility that you know she must have been very real. Hardly ever sympathetic, ruthless and selfish at best, the grandmother is yet understandable. Credit Tepper for this wonderfully nuanced performance.

The lead character, Bella, has an even more challenging role: An emotionally challenged young woman striving to find some happiness in a world controlled by her mother and aware of her needs and limitations. A tough role, but one done with great sensitivity, flair and even humor by **Maria Spassoff.** Her need for love and affection which she transfers to her nephews is acted with great compassion and believability.

But there was a show stopper. Although only a minor character, another aunt, with her own mental limitations, played by **Amy Tolsky**, does a mid sentence voice change I can't begin to describe. A fantastic vocal trick, it brought the best laugh of the evening.

rudy cont. on from previous page and **Steven Fenton**, faulted the administration for not giving current staff a better opportunity to apply for the job while board members **Myra Lurie**, **Nooshin Meshkaty** and president **Myra Demeter** strongly defended the intense review process.

What was right about their differences was that, first, the methods used by the district to fill vacancies are laborious and aimed at finding the best possible administrators. In that process, it should consider assuring that our very able school superintendent, **Kari Mc Veigh**, has a team member with whom she can work. That has been a criteria for every selection for top jobs for several generations of school chiefs. It seems, from what we have been told, that the person selected has outstanding credentials and will be a great asset to the district.

However, and here's where the process needs to react to Fenton and Goldberg's position, the district should find methods of assuring that advancement opportunities are not denied to current staff. There needs to be some hope that one day a teaching job can mean better pay and more responsibilities and advancement.

True, other districts raid our schools and there is considerable movement among management level educators. It is also true that sometimes our schools need a new approach and new ideas – the outside argument does have merit. The school district is still wrestling with setting a date for the massive, largest in our history bond election and whether that should come this November or in conjunction with the city council election in March.

Although strongly supporting the bonds, member Steven Fenton said there is not sufficient time to organize a successful election drive. Fenton points out that "not one dollar" has been raised for the campaign and that "with the referendum (Hilton) and the presidential election "it will be very hard to get our message heard."

Fenton makes sense, but there are other considerations. A November vote would not cost the district anything and may, and this is critical, not require the same number of "Yes" votes – nearly 12 percent less than a March, 2009 election. If that is accurate, I think Fenton and Goldberg would agree and even knowing the time challenges, support a November vote.

As for election confusions, trust me, the next council race is going to be off the wall in distractions. I would not want the school bonds and education issues tossed into that mix.

The Beverly High football team concluded its summer play by winning all seven of its games in the Arroyo Grande Tournament July 18-19, winning the tournament.

The Normans defeated Lompoc, San Luis Obispo, Morro Bay and Atascadero July 18 and Arroyo Grande, Santa Maria St. Joseph and Paso Robles July 19 in seven-on-seven touch football games played in T-shirts and shorts.

"We played great," Beverly Hills coach Carter Paysinger said. "[Quarterbacks] Dex Lucci and Josh Newman did a real good job of reading their keys and making the right decisions. Our receivers ... understood better what their counters were to the defenses that they faced. Our kids have shown improvement in all the things we look for at the end of the summer."

Receiver Daniel Bradbury "has had a tremendous summer and finished it off well with this tournament," said Paysinger, who also praised the play of running back-receiver Kenny Bassett and receiver Harrison Hopp.

The Normans played "very, very well" defensively in the tournament, said Paysinger, who praised the play of safety Anthony Fortier and cornerback Willie Wood.

Entering the Arroyo Grande Tournament, "we felt like we were behind and not as far along as we should be, then this weekend showed maybe they were not as far as behind as we thought," Paysinger said.Beverly Hills ended its summer practices July 22, while the so-called dead period, where on-field instruction is prohibited, began July 23. During the dead period, players run and lift weight under supervision of coaches, who are not paid during the period.

The Normans are scheduled to begin fall practice Aug. 21 and play host to

Marshfield (Mass.) Sept. 6 at Nickoll Field in their season opener.

Girls' Basketball Beverly Hills Shootout

The Normans concluded the tournament by defeating Los Angeles Washington, 59-28, in Sunday's third-place game in what coach Charles Solomon called their "best win of summer," with sophomore forward Morgan Mason scoring 21 points and senior guard Sophie Payson 15.

Beverly Hills led 21-15 at halftime and 28-18 with 12 minutes to play, as it avenged a defeat in last month's semifinals of the Watts Summer Games and won its third consecutive game.

The Normans were "unbelievable" on defense, Solomon said.

Beverly Hills began the tournament by winning two of three games in pool play, losing to Brea Olinda, 42-40, Friday but defeating Chatsworth Sierra Canyon, 70-29, and Palos Verdes, 53-38, both Saturday.

The Normans had the lead and ball with 20 seconds to play against Brea Olinda, ninth in Max Preps.com's final 2007-2008 Southern Section rankings, but committed a turnover. Mason scored 22 points.

Mason scored 24, Payson 16 and senior forward Javonna Young 15 against Sierra Canyon in a game Beverly Hills broke out to a 28-6 lead.

Young was named to the all-tournament team.

The tournament was played at the Swim-Gym.

San Diego Classic

Beverly High lost five of seven games, including its last three by a total of 10 points, in the tournament which bills itself as the nation's largest high school girls' basketball tournament. "The overall effort over seven games was really strong," Normans coach Charles Solomon said. "I just thought the ball didn't bounce our way at the end of games."

The Normans concluded the tournament with a 47-44 loss to Mesquite (Ariz.) after leading for most of the game; a 51-46 loss to Laguna Hills in a game they led until the final minute, both July 19, and a 41-40 loss to Mission Hills Alemany July 20.

"It was heartbreaking how we ended a lot of close games," Solomon said. "We just couldn't finish. I don't know if we were tired."

Beverly Hills began the tournament with a 43-26 victory over Pomona Diamond Ranch July 17 in a game it led 43-26 at halftime.

The Normans lost to Santa Ana Mater Dei, 49-45, July 18 in what Solomon said was the team's "best game of the tournament."

Beverly Hills led for the first 36 minutes of the game, played with two 20-minute halves of running time. The Normans led 29-20 with 11 minutes to play. The Monarchs, who would finish third in the tournament's 3A Division, took a onepoint lead with 3 1/2 minutes to play 49-45. Sophomore guard Kaleena Mosqueda-Lewis, described by Solomon as the "best player I've ever seen," scored all of Mater Dei's final 12 points.

Beverly Hills "completely laid an egg" later on July 18 in a 47-33 loss to Arroyo Grande in "the worst game I've ever seer our kids play," Solomon said.

The Normans began play July 19 by defeating Corcoran, 48-29.

Payson was named to the all-tournament team, and made 38 3-point baskets, including a combined 17 in the games against Corcoran and Mesquite, Solomon said.

Mason was the Normans' leading scorer and best player, despite spraining her right ankle in the Corcoran game.

The Normans played their first three tournament games at RIMAC Arena at UC San Diego and final four at Aztec Recreation Center at San Diego State.

Results recommend more focus on day visitors to city **By Jacquelyn Ryan**





the recommendation that attention be drawn to day visitors is a good one," said the Chamber's CEO Dan Walsh. "It's a matter of funding. We need to have the funding to produce events that attract day visitors."

K&H president Gayla Hartsough noted that increased competition has made an impact on bringing day visitors and tourists to Beverly Hills and suggested that the Convention and Visitors Bureau (CVB) create an Advisory Group that would oversee the CVB's specific needs.

An advisory board for the CVB is "something worthy of consideration," according to Walsh, who said that the CVB currently has a dedicated board member overseeing it.

"This is being released at the same time that I am reviewing the Economic Impact Study, and actually we've seen tremendous growth in day visitors in the past three years according to the study," said CVB's Director Kathy Smits, who also said that there is currently an informal

advisory system in place for the CVB.

The audit results do not strongly suggest that the Convention and Visitor's Bureau, a division of the Chamber that was one of the central focuses of the audit, break off from the Chamber. Many of the improvements can be done while it continues to function in the Chamber, according to Hartsough.

However, Mayor Barry Brucker understood the results in a very different way.

"[The audit results showed that] virtually no other CVBs are run by their Chambers. And I believe that the underlying analysis suggests that we should have an independent CVB and board of directors," said Brucker, who was also on the ad hoc committee in connection with the audit. "The KH report kindly and in a very soft-shoed approach sent the message that things are not done per normal business standards."

Many local business owners said they are concerned with seeing the CVB step up its marketing and promotions of Beverly Hills and bring more tourists, visitors and their money to Beverly Hills, regardless of if it remains in the Chamber.

"I don't know if you make bureaucracy bigger that you make it better. I think the Visitor's Bureau could stay in the Chamber if [the city would work] to make it more effective," said owner of restaurant The Farm at Beverly Hills Fran Berger, who like many local business owners interviewed by the Weekly said she doesn't have much of a relationship with the CVB.

Berger's restaurant doesn't necessarily rely on tourists, but it does rely on locals and people in nearby cities coming to explore and dine in Beverly Hills. But both international tourists and residents of, say, Burbank could stand to see some better advertising of and accommodations in Beverly Hills, Berger believes.

"The [CVB] needs to do more to promote what's unique about Beverly Hills. There's no shopping here that you can't get elsewhere. You can go to Saks or Nordstroms anywhere. What we do have is unique restaurants and unique events," said Berger, who would also like to see more parking and more nightlife events in the city.

The results of the audit and other local business owners support Berger's sentiment.

"In a down economic time, in a city like Beverly Hills, they should advertise more," said Beverly Hills Diner owner Masood Moaven. With a restaurant that largely caters to the tourist crowd, he feels that the tourists, who do come into his restaurant, come in mostly by chance.

Steven Lococo, co-owner of Borrelli Salon on Burton Way, is a member of the Beverly Hills Chamber of Commerce and the West Hollywood Chamber of Commerce. Lococo said that in West Hollywood, the Convention and Visitors Bureau is a separate entity that he has worked with many times to bring in businesses from Atlanta, New York and other domestic locations.

"A Convention and Visitors Bureau is very important to any city structure. You need that PR machine to always reach out. In my experience in West Hollywood, the [Chamber and the CVB] are separated and it works incredibly well. [On the other hand,] I don't know the inner working of the [Chamber and CVB] in Beverly Hills, but I would think that it would be beneficial to all

be under one roof so you can stay in the loop about what's going on," said Lococo, who is an active member of the Beverly Hills Chamber.

By all accounts, Beverly Hills is a small town, but the council compares the city to bigger urban areas like New York, London, Chicago and Miami. And the consulting firm compared Beverly Hills to both larger cities, like Atlanta, and to smaller, upscale cities, like Catalina, Sedona and Palm Beach, said Hartsough. Of the 11 smaller cities included in the survey, nine of them had independent Convention and Visitors Bureaus.

For instance, even neighboring "small" city Santa Monica has a Convention and Visitors Bureau that is an independent non-profit organization, with and 11 member board of directors. It is fully funded by the city of Santa Monica.

It may be most cost-efficient to continue to house the CVB in the Chamber, said Hartsough. She estimated that it would cost the city \$120,000 to \$150,000 if it transitioned to an independent entity. She added, however, that it is important to weigh what the financial return might be to the city to have an independent CVB.

The audit results cautioned against making the CVB an entity of the city.

But even before the results of the audit were released, Mayor Barry Brucker felt that the CVB should an independent entity with its own board of directors devoted to marketing Beverly Hills. Brucker said he envisions a board of directors made up of hoteliers, restaurateurs, retailers and convention marketers who will use the city's multi-million dollar funding for the CVB alone.

"I'm not anti-Chamber. But I truly believe that with an independent CVB that the Chamber may become more motivated because they have such an exceptional chairperson in Vicky Mense and an executive board of very bright people, some who I consider personal friends. If the CVB were separated, than I believe that the Chamber would sustain themselves and that the Chamber would be stronger and have more members at the end of the day, because they'd reach out more to the business community," said Brucker, who said he would transition the separation between the CVB and Chamber slowly over a 12 to 18 month period.

The audit results stressed the need for a strategic plan across the board, no matter what the actual plan may be. While CVB Director Smits takes the suggestion in a constructive way, she felt that the audit didn't give enough "credence" to the large amounts of planning and collaboration that occur currently at the Chamber and CVB.

"[The audit results] provide an analysis of the pros and cons, and we are evaluating them thoughtfully," said Walsh. "The goal here is to make continuous improvements. We are going to take our time mindfully considering them. We are anxious to hear from the [City Council]," said Walsh.

The consulting firm and ad hoc committee made up of Mayor Barry Brucker, Councilmember Linda Briskman, City Manager Rod Wood, Assistant City Manager Katie Lichtig and Alison Maxwell, will make presentations to the City Council at the next council meeting on Aug. 5.

It is 5.7 Square Miles and it has about 100 miles of all paved streets. The daytime population increases to about 170,000 due to employment and business activities mostly concentrated within the business district and the commercial stretch of Wilshire Boulevard.

The City began its sign replacement program back in the year 2000. The first phase was to replace and upgrade all traffic regulatory, warning and guide signs. Scope of Work

The contractor will perform the following tasks to help achieve the project goal:

Activities:

The City Council of the City of Beverly Hills does resolve as follows:

Recently, the Governor has declared a drought in the State of California and the Metropolitan Water District has declared a Water Supply Alert. In light of this water emergency and for the reasons set forth in the agenda report presented to the City Council on July 15, 2008, the City Manager has determined that a five percent (5%) reduction in potable water use is required and that water conservation Stage "A" be declared and implemented by the City Council. Beverly Hills Municipal Code Section 9-4-301 provides that the City Manager or his designee is authorized to implement certain water conservation measures after holding a public hearing before the City Council.

On July 15, 2008, the City Council held a duly noticed public hearing to consider the recommendations of the Environmental Utilities Manager to implement water con-servation Stage "A." After receiving oral and written testimony, including the agenda report, the City Council hereby determines as follows:

(a)Water Conservation Stage "A" is hereby declared throughout the City of Beverly Hills and the City Council hereby directs that the Environmental Utilities Manager implement Water Conservation Stage "A" as set forth herein.

(b) The Environmental Utilities Manager and/or appropriate City Staff shall hereby communicate to residents, visitors and businesses of the following voluntary water con-servation measures for implementation: (i) restaurants shall serve water upon request only; (ii) all public restrooms in the city and private bathrooms in hotels shall notify patrons and employees of water conservation goals; (iii) plumbing and irrigation leaks shall be repaired as soon as possible; the city may issue notices to repair visible leaks; (iv) irrigation shall be reduced between dusk and dawn or 8pm to 8am; (v) no wash-down of paved areas shall occur except to alleviate immediate fire or sanitation hazards; (vi) operation of non-recycling fountains shall be reduced; and (vii) use of reclaimed water for construction purposes shall be encouraged. In addition to these elements, the City Council hereby authorizes the City Manager or his designee to imple ment other voluntary water conservation elements as determined by the City Manager as necessary in order to encourage behavioral changes in day to day life to achieve a five percent (5%) reduction in potable water In accordance with Beverly Hills Municipal Code Section 9-4-303.B, the City Council hereby directs the City Clerk to publish this Resolution at least once in a newspaper of general circulation within the city and to po Resolution in at least three (3) public places and continue to post this Resolution until such time as the restric-tions set forth herein are repealed by resolution of the Citv Council.


