

"Is the \$334 Million School Bond a Blank Check?" [Issue #464]

The \$334 million general obligation bond measure should be placed in perspective so that all prospective voters can understand the enormity of this "general obligation."

In rounded numbers, our city of 30,000 is approximately 10,000 times smaller than the 300 million people in our nation. Multiplying the \$334 million "general obligation" by 10,000 would amount to \$3.34 trillion on a national scale. Those of us who are horrified by the \$700 billion "national bailout" of Wall Street should be shocked-and-awed by an obligation for our city that is approximately 5-times that enormous number on a per capita basis for a city our size.

As a philosopher once said: "Where there is no vision, the people perish." It is difficult for any of us to claim vision into the nation's economic mess or our city's educational mess. In each case, the facts are relatively few and obfuscated, and the generalities and platitudes are numerous and not reassuring that anyone knows what they are doing.

# "Stone and Lawn Signs of the Times" [Issue #469]

[Rudy Cole's column last week] on the Hilton Revitalization Project was "right on the mark." After having carefully studied the Environmental Impact Report, and having the opportunity to observe from the sidelines the Planning Commission's hearings and deliberations on this matter, I am very much in favor of the Hilton Revitalization Project.

Remember the Four Seasons! I too have heard from several reliable sources that Mayor Villaraigosa wants the Waldorf=Astoria in Los Angeles and is anxiously awaiting the results of the November ballot initiative. Like many of my fellow citizens in Beverly Hills, I have great concern that this important redevelopment project may turn out like the Four Seasons Hotel at Beverly Hills which sits across the street from our Eastern border, greatly benefits from the use of our city's name and pays substantial transient occupancy taxes to our neighbor, the City of Los Angeles. I hope we have learned from past mistakes.

While traffic at the intersection of Wilshire and Santa Monica is certainly of concern, this traffic situation will exist with or without this project. Santa Monica and Wilshire is and has for many years been terribly congested, and if left alone, traffic will continue to be terrible and get worse. In fact, we could probably raze the entire Hilton property, construct a fence around it, and traffic at Wilshire and Santa Monica will still be terrible and continue to get worse and

worse. We are a "pass through" city, and Wilshire and Santa Monica Boulevards are major thoroughfares that without the Hilton Revitalization Project, have limited options for improvement. The Hilton Revitalization Plan, however, generously dedicates substantial portions of land and provides other improvements that will help traffic flow more efficiently around the property. While not a complete cure, the Hilton's plan provides some mitigation (at a significant cost to the developer) that will most certainly improve the flow of traffic along these main thoroughfares.

As you have eloquently pointed out, the benefits of the Hilton Revitalization Plan are clear and substantial. This project will vastly improve the Western gateway to our city along both Wilshire and Santa Monica Boulevards. The revitalization will most certainly spill over to surrounding areas, including along South Santa Monica Boulevard between Moreno Drive and Wilshire, a dilapidated string of commercial properties that if left alone, could someday appeal only to tarot card readers, collateral lenders, fast food restaurants and, in a worse case scenario, massage parlors.

One only needs to travel a couple of hours east of our city to Palm Springs to view first hand the implications of the anti-development mindset. Springs, a once vibrant community and substantial tax base of hotels and retail establishments, has after years of saying "no" to development lost these businesses

Robbers hit jewelry store on Beverly

While holding a man at gunpoint, armed male robbers wiped out a jewelry store on the 200 block of South Beverly Drive on Saturday night, police say.

The robbers entered the building and approached the victim from behind, then held him at gunpoint while he opened the jewelry store and its two safes containing jewelry and watch inventory, according to police. It was reported that the suspects stole all the items from the safe.

Beverly Hills police officers responded to a radio call of a "takeover" armed robbery within two minutes, but the suspects had fled the location before police arrival at approximately 12:30 a.m.

Although shaken from the incident, the victim suffered no physical injuries.

# Hilton drops BHEF's title from campaign

The Beverly Hilton has dropped mention of the Beverly Hills Education Foundation (BHEF) or the PTA from its Measure H campaign literature only weeks after the Hilton struck a \$3.24 million deal with BHEF that hinges on the measure passing.

"The Beverly Hills Education Foundation Board of Directors asked Oasis West Realty to no longer use the names Beverly Hills Education Foundation or PTA in their materials related to Measure H. The request was well received by Beny Alagem and Oasis West who immediately altered future publications to avoid any possible misperceptions," said BHEF president Jean

The deal faced a small controversy when it was announced two weeks ago. Some accused the BHEF, a non-profit organization, of sending a message of endorsing the Hilton by accepting the terms of the deal. Others accused the Hilton of trying to "buy

taining infrastructure and providing vital community services continue to increase at a rapid pace; projects like the Hilton Revitalization Plan become even more necessary to offset these rapidly rising costs. The deal would provide up to \$3.24 million over the course of 30 years to BHEF, a non-profit that supports Beverly Hills Unified schools, if Measure H passes on the November ballot. The agreement would be funded by at \$100-a-month fee attached to each of the 90 condominiums built as part of the Hilton Revitalization Plan, which would only go forward if Measure H is approved.

# **Finding Some Humor In Troubling Times, Hopefully**

Random thoughts from a columnist with far too much time and ink on his hands:

You can draw your own inferences, but it is fascinating, at least to me, that the most ultra conservative Republican office holders, very often gay bashers, are more often involved in allegations of homosexual misconduct while Democrats are caught in heterosexual scandals.

Which makes me wonder about the deeper psychological reasons for the enormous amounts of money and energy extreme right wing groups, many from outside our state, are spending in favor of Prop. 8.

If their arguments weren't so transparently ludicrous, it might be worth exploring their own sexual histories or, at least, hidden fears. The television spots insult our intelligence: "Would be mandatory" is just one. Gays would be forced to get married? Why, because of an unexpected pregnancy? "Would be taught in our schools" is another bit of hyperbole.

There is nothing in the state supreme court ruling on same sex marriages, which Prop. 8 hopes to overturn, that even remotely mandates any of the nonsense contained in these overblown, (no comment on puns here), television spots.

One married friend put it this way: Why shouldn't gays face the same agonies of marital bliss: property settlement litigation and conflicts of when to welcome the inlaws as the rest of us?

Another political paradox: There was a time when Democrats believed that "Wall Street" would manipulate the economy to benefit the Republicans. Sort of an "October surprise" with stocks and bonds. There was some history to substantiate the

When Grover Cleveland was seeking a second term, some major employers put signs in factories the day before the election with a simple warning: "This plant will be closed so don't bother to come to work if Cleveland (a Democrat) wins."

The conspiracy theorists believed that the economy would be manipulated to benefit any Republican president running for reelection or if termed out, his Republican successor.

Apparently not quite true this year. The economy slide may well be the deciding factor that elects Barack Obama. The only problem Obama faces is the father figure need – we turn for comfort to the more secure looking and sounding candidates in times of crisis. FDR provided that image as did, amazingly, Ronald Reagan. John McCain, the older, more mature contender, fits that look better, but no matter how he twists his record and runs from rather than with his own party's president, McCain can not avoid the blame being placed on Republicans for the failures of this administration. The dad figure need certainly applies to city government. We call councilmembers "city fathers," I'm not sure what name we use for members of congress.

When the best father figure we ever had, "Mayor Max" (Salter) first ran for council, and I had the pleasure of managing his campaigns, I had only known him as a major philanthropist and highly regarded civic leader. (He had made Nixon's enemies list, recommendation enough for me.)

But I was surprised by the name his large, and I mean big, family of children, grand children, uncles and aunts and cousins by the dozens, used when calling him. He was "Sonny."

Now managers are supposed to make the tough decisions so I called a family meeting to urge that "Sonny" not ever again be used in public. Simply did not fit the "city father" image that so easily fit Mayor Max.

The clan agreed, somewhat grudgingly, and we had our campaign kick-off. I had never seen such a turn out, before or since. No one violated my admonishment about the earlier sobriquet.

However, as Salter was concluding his remarks and thanking people for helping make the event such a success, wife Janet interrupted with: "Sonny, you forgot to introduce the rabbi's wife!" He won anyway. Lesson: Never listen to campaign managers. Well, maybe the one that told Dukakis to get on that tank for a photo op.



We have two **Ken Goldmans**. One, the long time leader of the Southwest Homeowner Association and veteran lawyer, and the other a new member of the bar, new husband and new city commissioner. Right, the first Goldman's wife, **Lori**, was also a commissioner.

Goldman is as popular a political name in Beverly Hills as **Kennedy** is in Boston. To mention a few: former Mayor **MeraLee** and the legendary **Sooky**.

There are two **Richard Stones**, really. Former mayor, former school board president and lawn sign vigilante Richard the first, and his son, Richard (Richie) Stone one of the brightest judges ever to serve in our Beverly Hills court.

We have had two **Tanenbaum** and **Tannebaum** mayors – notice the spelling difference because they are not related. **Robert K**,(1986 and 1992) best selling author, lawyer was preceded by **David** (1952 and 1956) who was actually our first Jewish mayor.

I never knew a Cheryl before, but now we have two working for the city's public relations office. **Cheryl Friedling**, the boss and **Cheryl Burnett**, her able assistant and press liaison.

If my email and phone calls are a good barometer of political thinking, Measure H should win comfortably. The "just too big" argument seems superfluous when you compare the Hilton condos with the massive high rises just west of us. The added traffic lanes on Wilshire – and a loss of land for the Hilton, and the increase in lanes on **Merv Griffin** Way – the street between the Hilton and the former Robinsons-May, and the gateway to Century City for much of the traffic from the north, are also resonating with voters.

However, the most compelling argument in favor of the Hilton is still economic: Using the most conservative figures provided by very objective financial experts who work for the city, our treasury will receive, every year, \$12 million dollars. Even in the best of times, that pays for a lot of police, fire, recreation and park, street improvements and other basic needs, not to mention helping schools through the Joint Powers Agreement.

Renters are also taking notice. The Hilton condominium addition could mean fewer conversions and demolition of housing stock in the city. Built on commercial, not residential, zones, it reduces the market need and could spare older more affordable housing.

Some of the angry steam seems to have left the No forces, and I must add many oppose the Hilton project who also care about our city. I just think they want to turn the clock back to an era that never really existed

What has been the best tool of the pro-H forces. Not their slick mailers or adds, but the personal campaigning of owner **Beny Alagem** and company president **Ted Kahan.** (The second A in the name is silent, but not the rest of him.)

Ted, taking a leaf from the political book of walking mastered by **Steven Fenton** and **Jimmy Delshad**, has been very convincing as he surprises voters by actually ringing their door bells. I have heard from dozens of locals that he changed their minds, including some hard to sell anti-growth loyalists.

Beny does it best in intimate small gatherings where his vision of bringing a world class Waldorf=Astoria to Beverly Hills is contagious and disarming.

For voters, and they are expected in

# BHHS Football Team Wins Second Game of Season

# Norman girls' tennis team defeats Palisades, Mira Costa By Steven Herbert

Beverly High's offensive game plan for Friday night's nonleague football game at Nickoll Field was to force the passing game, coach Carter Paysinger said, which resulted in a 41-31 victory over Valencia West Ranch.

"We wanted to get that part of our game together and I thought we did a good job of that," Paysinger said after the Normans evened their record at 2-2 following an 0-2 start.

Dex Lucci completed 15 of 20 passes for 185 yards, a week after spending the entire first half and part of the second on the bench after the coaching staff felt that he would be helped more by observing the game than playing.

"I thought he played a fantastic game," Paysinger said. "The performance is what we thought he could do all season."

Kenny Bassett proved that he is the team's most valuable player through four games, rushing for 188 yards on 26 carries and a touchdown on a 40-yard third-quarter run.

Beverly Hills has won every time Bassett has played a complete game, and lost every time has not. Bassett was sidelined by an ankle injury for the final drive of the 23-20 loss to Marshfield (Mass.) Sept. 6 and was

limited to one carry in a 28-13 loss to Long Beach Jordan Sept. 12.

"We've had backs in the past that are consistent and run hard, but are not necessarily game breakers," Paysinger said. "Kenny does both. He runs hard, has speed and elusiveness to break off the big run and break games open.

"Every year we've always had the one guy, whether it be a receiver, or a quarter-back or a running back and this year, who can score from anywhere on the field and this year that person is Kenny."

The Normans trailed only once, as the Wildcats (1-2) opened the scoring on Colin Amsler's 41-yard field goal.

Beverly Hills scored the next 20 points, as David Saedi ran for the first two of his four touchdowns on four- and 15-yard runs in the first quarter and Brandon Bank ran one yard for a touchdown in the second quarter.

West Ranch cut the deficit to 20-9 at halftime on Jake Bernards' 30-yard touchdown pass to Frankie Madero.

The Normans sandwiched touchdown runs by Bassett (40 yards) and Saedi (two yards) around Ross Bacon's 22-yard touchdown run for the Wildcats in the third quarter, as Beverly Hills led 34-16 entering the

fourth quarter.

Sadei ran 17 yards in the fourth quarter for his fourth touchdown.

"I thought our team played very well on both sides of the ball," Paysinger said.

The Normans' offensive line of center Jordan Adams, guards Noah Phillips and Resse Wynton and tackles Caylin Hauptmann and Jon Jun "did an excellent job of pass blocking and run blocking," Paysinger said.

Paysinger also praised the play of Lucci, who would have had even more glittering statistics if two of his passes were not dropped, receiver Erik Munzer and Bassett.

Bank and Saedi played well at both running back and linebacker, while the Beverly Hills' kickoff return and kickoff coverage teams are "doing better than any in recent memory," Paysinger said.

# The Weekly's interview with Beverly Hills Residents Association president Alan Kaye

Tell us how the Beverly Hills Residents Association works?

The BHRA was organized to represent the interests of the residents and homeowners living in the Flats north of Santa Monica Boulevard. It was specifically designed to be an unbiased organization. We wanted to make sure it was a transparent organization that would establish a forum for our members to share information on issues affecting them in our city and to create an open dialogue. Much of the information that everyone receives is with a particular bias for or against the project. We have many members of our board and of our assoc who are for or against everything that's going on right now. But it was important to us for there to be an organization where regardless if you're for or against a particular topic there was a place where you could obtain all of the information so that you can make a reasonable decision.

[BHRA started] a year and a half ago. I don't know whose idea it was originally and I'm sure what we've become is not what the original idea was but I was invited with about seven or eight other people, feeling there was a need to create something like this. And the seven or eight of us invited people we knew and thought would be leaders. As we kept reaching out, we ended up with 17 or 18 people who said, 'You know what, I'd really like to do this and I'll be a board member and put up a little bit of money to help start this thing and will contact all my friends and try to create an organization.' And that's what we did. [Kaye is currently serving as president of the BHRA.1

# What's an example of what BHRA does in the community?

The most recent thing we did was to send out a summary of the most important things we think were happening and that includes the Hilton project and Measure E and the status of Santa Monica Boulevard and the entertainment district. We announced specifically with Measure H, the arguments that the 'Yes on H' people are making and the argument that the Citizens Right to Decide Committee [the 'No on H' people] are making. We included a link to both Web sites and to help further clarify it we are holding a virtual debate. We invited people to ask questions of both the 'yes' and the 'no' people that we are going to submit to [each side], let them respond in writing and give the other side an opportunity to rebut in writing and then share that with our members, on [bhresidents.org], and local news organizations so that people really have a chance to see all sides of the

From what I understand, there has not been any debate scheduled between the two. We

invited them both to a live debate. The Hilton agreed to participate. The 'No on H' steering committee declined, so we decided to put it in writing.

You're involved in several other community and professional organizations, like Beverly Hills' Solicitations Advisory Commission, the Mass Transit Committee and Beverly Hills Rotary Club. What would you say is the most interesting organization you work with and why?

I think they are all interesting. That's why I'm involved with them. One of the nice things about what I do is that I can pick and choose things that are really interesting to me. The Rotary Club I was introduced to when I ran for office [on the Board of Education in 2001]. I was shocked because I never thought I'd want to be a member of a service organization like that. I remembered when I was a kid going to speak before the Lions Club and the Optimist Club and thinking, 'What a bunch of funny old guys.' And I went [to the Rotary Club] and was really surprised at the caliber and quality of the people who were the members. These were people who were really involved in the community and kinda made things happen. I've been thrilled. I've made wonderful friends. They do really good things. They give to local charities. We give away tens of thousands of dollars both at home here and internationally and I was embraced by these people and made good friends.

And the Mass Transit [Committee], I thought that was a fascinating thing to be involved with. I was shocked. I mean here was a group of, I forget how many people served, but there were people who came in thinking, 'We don't want a subway' or 'We definitely think it ought to go this direction or that direction.' In the end, everyone with all these different points of view ended up really on the same page. There was no minority opinion in the group; it was unanimous and painfully obvious that a subway would be tremendously beneficial to the city and there was a specific route that it ought to follow. So again,  $\bar{I}$  like all the things I get involved with. There are a lot of things that I don't get involved with because they just don't hold an

Your professional career revolves around your insurance company, and work at your father's insurance company (Barry Kaye Associates) with your father—how'd you get started in this line of work?

My father is, forget life insurance sales, he is just one of the most tremendous and innovative salespeople in the country and built a very large business representing one particu-

Even though I've been a part of Barry Kaye Associates and its marketing, it still was essentially my sales, my brother's sales and my father's sales. Then we all sold our companies about 10 years ago to what is now a New York Stock Exchange firm called National Financial Partners and I operate now under the name Alan Kaye Insurance Agency.

I have over 35 years experience consulting with individuals and families and their insurance and estate planning. I'm part of the Beverly Hills Estate Planning council. I've been a member of the California Senate Advisory Commission on Life and Health Insurance in the past and was president of what was at the time the West Los Angeles Association of Life Underwriters.

I work hard. There are a few men in America who do the volume of business that my father does so I've been exposed to just some very exciting people over my lifetime that are inspiring and have a lot to share.

# Why did you choose to raise your family in Beverly Hills?

Beverly Hills is just a very unique and wonderful community. I love the fact it's a small town and you get to know everyone on the school board and the City Council. You can be involved to the extent you want to be involved and have an impact and to the extent that you just want to live your life, you can do that too. But I really like the fact that I can pick up the phone and call people who are active and have an impact in this community. I think that's wonderful.

I decided to raise my family here because it's a wonderful community.

I have two daughters. [Gillian] is a second year student at [University of California, Santa Barbara, majoring in communications] and [Danielle] is a sophomore at Beverly High.

# What's it like having your daughter at your old school?

It's fun. I mean it's a neat thought. My wife and I both graduated the same year [1973] from Beverly High. But that's really not such a big issue; the big issue is that she is extremely happy at the school and made lots of friends and is involved with the sports. The fact that [my wife] Michelle and I went there — it's a different place today than it was back then.

[Danielle] went to Windward School.

# Did you and your wife meet in high school?

We knew each other from high school. Our families have been friends but we didn't start dating until right before we got engaged, after college, way later. I went both to [University of Southern California] and [University of California, Los Angeles], spent about a year and a half at each. But I'm a Bruin fan.

My wife went to UC Irvine. Michelle was a professional dancer. She's a terribly creative individual and works hard for a lot of non-profits groups in the city as well. She's also on the board of [SLE Lupus Foundation], on the board of Beverly Hills Education Foundation (BHEF) and was the dinner chair last year and I think this year also for Temple Emmanuel's ball and has chaired the BHEF Apple Ball in the past. She's done a lot.

# How did you get involved with the SLE Lupus Foundation?

My older daughter was diagnosed with lupus about three years ago now so we wanted to do everything we could to not just help her but to help on a more global basis. We're both on the board of the local Lupus L.A. and I'm also on the national board for Lupus.



# What is in the future for you?

Again, I pick and chose the things that interest me. Obviously, the lupus has affected our family individually and there's about a million and half people nationally who are affected by lupus. So my time is well spent both on the work we do for lupus and the community activities that I've been involved with — and trying to get people to call me about consulting on their life insurance.


