

Considering the magnitude of the Measure H campaign, it is astonishing that neither the Weekly nor Courier offered any analysis. It would have been useful to see the claims of both sides, for example whether the Hilton would offer employees parking, fact-checked by one of our papers. Instead here is a sampling of what our

local papers proffered.

The Courier published pro-Hilton editorials and was reduced to printing front-page advocacy masquerading as news articles, but it found no space for objective inquiry. And the Weekly's belated coverage was no better. Its unhelpful ringing endorsement consisted

# Five Beverly Hills precincts favor McCain

# Trousdale narrowly favors Prop 8 By Jacquelyn Ryan

The initial election results for 20 Beverly Hills precincts were returned on Thursday, showing five precincts that favored Sen. John McCain, one precinct that approved the controversial same-sex marriage ban Prop. 8, and that more than half of the voters in the precinct surrounding El Rodeo voted against Beverly Hilton's Measure H.



RITA NAZIRI Senior Planner Obama. Precinct four, which encompasses the Trousdale area, gave 252 votes to McCain over 177 votes for Obama. Precinct six, which covers the area northwest of the Beverly Hills Hotel, voted 216 to 154 in favor of McCain. Precinct eight, which includes Hawthorne School, voted 256 to 191. Precinct 10, which includes El Rodeo School bounded on the south by Wilshire Boulevard, gave McCain 235 votes to 186. Precinct 16, the Burton Way area including the Sunrise Senior Center, voted for McCain with 245 to 211.

In 2004, seven precincts largely in the north (3, 4, 6, 8, 10, 16, 46) voted for President George W. Bush in the presidential election over Democratic nominee Sen. John Kerry.


This year, citywide, Obama won with 7,987 votes to McCain's 5,278. Obama won by the largest margin in precinct 39, bounded by Whitworth, Beverwil,

Olympic and Maple, with a tally of 409 to 161.

Precinct four, the Trousdale area, was the only Beverly Hills precinct to vote in favor of Prop 9, which gives crime victims more power in the justice system, and Proposition 8, which would amend California's state constitution to restrict marriage as only between a man and a woman. The vote for Prop 8 was 217 to 212; for Prop 9 was 186 to 156.

The overall vote count for Measure H, which would bring a Waldorf=Astoria hotel and two condo buildings to the Beverly Hilton lot, is still too close to call. The L.A. County Registrar-Recorder has been counting late absentee and provisional ballots since Friday. The total as of Tuesday evening showed the Yes on H side winning by 16 votes with a total of 7,017 to 7,001 votes.

## Hilton winning by 16 votes in latest count

Initially behind by 68 votes on election night, the Beverly Hilton's Revitalization Plan has taken a lead of 16 votes in the latest Measure H ballot tally by the Los Angeles County Registrar-Recorder/County Clerk's Office.

As of Tuesday evening, the Measure H tally showed 7,017 votes (50.06 percent) in favor of Measure H and 7,001 votes (49.94 percent) opposed.

The L.A. County Registrar has been counting since Friday thousands of late absentee and provisional ballots that were not included in the initial results from the Nov. 4 election.

While Measure H is still close, the divide is widening from the Registrar's first absentee and provisional ballot tally that occurred Friday afternoon. That tally showed the Hilton losing by only nine votes. The Measure H vote total from precinct ballots on Election Day put the Hilton behind by 68 points.

Both The Beverly Hilton and The Citizens Right to Decide Committee, which gathered the signatures the force the issue to a vote and led the unofficial No on H campaign, has sent a team to the L.A. County Registrar's Norwalk office to oversee the absentee and provisional vote counting.

"We've been able to examine the vote-bymails," said CRDC treasurer Larry Larson. "We wrote down the business addresses



[where some voters had registered] and will investigate those voters" to verify whether or not they could legally vote in Beverly Hills.

While voters can use a business for a mailing address, a business address cannot be used to register to vote. Larson suspects several non-residents and non-citizens "were sent" to vote Yes on Measure H in the Nov. 4 election.

Larson says that if the Hilton wins in the final certified vote, the CRDC is prepared to file a lawsuit "based on voter fraud to set aside the election."

"The election for Measure H is not over until every vote is counted. There are still a large number of absentee ballots and provisional ballots to be counted. We will not have the final results until the County processes all the ballots," said spokesperson for The Beverly Hilton Marie Garvey, who noted that the Hilton will not further comment until the results are finalized.

The L.A. County Registrar will continue counting votes every Tuesday and Friday until

all votes are counted and the election results can be certified. The process could take until Nov. 28, according to the L.A. County Registrar's Canvass Update Schedule.



# **Time To Lower Our Voices**

And remember our common goals By Rudy Cole

It would take a small army of social psychologists to sort out all the emotions involved in our latest installment of angst and hysteria over a development plan, this time Measure H for Hilton.

Listening to the appeals of the combatants, you could easily be convinced that life as we know it in Beverly Hills was threatened. Vote against H and there would be no money for police, fire and schools. Vote for and Beverly Hills would immediately become a Century City or, dare we even use the word, Westwood.

What is even more puzzling is the anger directed at the Beverly Hilton owner, **Beny** Alagem.

Do we cannibalize our own? No opponents of development launched a referendum challenging a massive condo project just west of the Hilton. The owners of 9900 Wilshire are young, eager entrepreneurial brothers from England, the **Candys**. Now the fate of their American dream may become a nightmare. But Alagem is very much a part of our community; his sister in- law is even a teacher in our public schools.

What about past Hilton owners? Would **Merv Griffin**'s star status have cooled any referendum? Just possibly.

As for the original owner, **Conrad Hilton**, he didn't exactly endear himself to our denizens when he presided at the opening of the Hilton in Cairo, calling **Gamal Nasser** the "George Washington of the Middle East," yes, the same tyrant who wanted to eradicate Israel. Interesting, since Alagem is Israeli.

Built in 1955, no successive owner spent as much as Alagem to restore its original luster and bring the Hilton out of the commercial traveler category to a more Beverly Hills like hotel.

Not Griffin, and certainly not Conrad Hilton, ever gave as much back in support of community charities as Alagem. And none had his vision of revitalization that includes bringing a Waldorf Astoria to our gateway at Wilshire and Santa Monica.

If the Hilton wins in the referendum, and it

appears likely it will, Alagem needs to make a very concerted effort to turn back the anger of his immediate neighbors, the homeowners in the El Rodeo neighborhood. They were fed some fearful consequences of a Hilton approval: Employee parking on their streets; industrial pollution during construction and a high rise condo with views of their swimming pools. These were legitimate concerns and they could and should have been addressed far more realistically. Instead, the Hilton campaign became as distorted and sensational as that of some of their opponents.

However, it might be interesting to examine our two other hotel referenda, one very recent, the Montage, and the other in 1984, the Four Seasons. The Montage won, the Four Seasons lost big.

What made the Montage campaign so different? It too had a condo element and obtained entitlements on height and density beyond our codes. But unlike the Hilton, the Montage owners were total strangers to Beverly Hills.

The Montage had a unanimous council vote, the Hilton won with three. The Hilton was not able to win Planning Commission approval for its condos, although the appointed members did favor part of the condo project and all of the hotel improvements, as did the dissenting members of the council.

What the Montage also had was a very credible advocate in then Mayor **Mark Egerman.** Not quite as glamorous since he too became a land use lawyer representing

clients before the council soon after leaving office, Mark was a very trusted councilmember, mayor, and, before that, member of the school board. I remember one north homeowner telling me that it was "only because I trust Egerman that I voted for the Montage."

Another difference in the two referenda: The Montage could explain away some of the opposition as being economically and competitively motivated. The massive funding of the anti-Montage referendum came from the owners of the Peninsula Hotel. True, they had a very legitimate complaint: The Montage was receiving zoning exceptions they were denied. However, it diminished the purity of the stop the Montage drive.

Why did the Four Seasons lose? In part, because it refused to even consider any compromise and, unlike the Hilton, which argued their hotel could not be financed or created without the condo elements, the Four Seasons simply wanted more banquet, public assembly areas and more rooms than their across the street neighbor, **Hernando Courtright's** Beverly Wilshire. The Four Seasons was placed on the ballot by the city council, and not by petitions circulated by opponents.

The reason: Some then members of the council and the Four Seasons convinced themselves it would have voter approval and win more rooms, banquet facilities and height than the council could politically approve! It was clobbered at the polls and now gives all its tax dollars to Los Angeles.

(Historical note: Mark Egerman, before he was elected to the council, was one of those opposed to the Four Seasons.)

Some numbers are interesting. Although leading by only a handful of votes, as of now the Hilton yes vote is 7,017 compared to the Montage approval vote of 4,482. Of course, part of the reason for the larger vote is that

more people voted in the general election than in the council race in 2005. Still, a very impressive number of residents supporting any development in any election.

I fully understand the concerns of some of the Hilton neighbors, and the appeal of "just too big" did resonate. Unfortunately, the rational arguments the Hilton had made in response were lost in the last minute frenzy of ads and mailers diverting attention from reason and logic and relying on not credible fears and dire warnings of fiscal ruin if the Hilton failed.

Frankly, the overblown front page news coverage in another newspaper, totally diverted attention from the more positive arguments the Hilton had been making. No rational person was prepared to believe that the city would go bust if the Hilton lost. Loss of revenue? Needed tax dollars? Yes, but not quite up to pushing the editorial panic button.

Also, their last minute too cute ads and mailers quoting a hapless Hilton opponent, Councilmember Nancy Krasne's, strange note to a Hilton executive, an effort at conciliation, that "all my (Krasne's) friends are voting Yes" just doesn't work in this sophisticated city. The H campaign ads said join Nancy's friends in voting yes but the voters knew Krasne did not support a yes vote and the ads bombed.

Frankly, all this junk could have cost the Hilton the election. Conversely, the Los Angeles Times story about Councilmember Krasne's bizarre claim that she had been threatened by Alagem and had filed a police report, and which she first made semi-public in emails to friends and the press, also stretched reality and, at best, can be attributed to Krasne's reaction to attacks on her by the other paper.

The campaign nonsense wasn't limited just to the Hilton. As we said before, the nastiness began with wild charges against some councilmembers by some anti-Hilton activists.

A far more temperate campaign message came from the Richard Stone-Robert K. Tanenbaum open letters. The two former mayors did not engage in personal attacks or smears even though some of their arguments were very answerable.

What was partially amusing was the sudden and probably only temporary political falling out of Mayor Barry Brucker and that other newspaper in town. It has only been weeks since Brucker led the battle to separate the Chamber of Commerce from the Conference and Visitor's agency, a major goal of our big sister publication. And how things change. At one point, the other paper, I simply can't remember their name, was crying for the head of our city manager. Now, the paper is a strong supporter even though they may have exacerbated Rod Wood's problems with Brucker and Krasne by overstating Wood's concerns about a Hilton loss effect on city finances.

Frankly, we have too much going for us as a community for all this overly emotional involvement in the Hilton referendum. Mayor Brucker and Councilmember Krasne need to pull back their anger at those with whom they disagree, including their three colleagues on the council. The Hilton must do some major outreach. Both sides need to stop talking about retribution for straying from the gospel, because there is no purity on either side.

As for the other paper, we have heard some troubling reports at reprisals and boycotts of advertisers, and even though I question their judgment and fairness of reporting, press intimidation is not something we should ever condone. Don't read the paper if its editorials and news coverage are too biased for your tastes and that alone will send a message to advertisers, but stifling a free press is not what democracy is really all about and isn't that what the Hilton opponents demanded with a referendum?

It is interesting: The same paper can carry on a one sided attack on the business community's organization, the Chamber of Commerce, and no cry for a boycott. The paper can attack one of our most respected city agencies, our police department and their retirement benefits, and no appeal for retribution, just being pro-Hilton unleashed the furies.

Some final thoughts: Our community needs some political tranquilizers, now. This election, so historic for our nation, was an overly charged plunge into raw emotion and anger in our own village. We have too many shared values, too many reasons to be grateful for being able to live, work, educate our children and enjoy the finest in city services to allow ourselves to be so torn apart by any one issue. It simply makes no sense. We look to our elected officials to lead the healing, not divide us further.

As for Alagem, he too deserves better,

even from those most upset with some elements of the Hilton development. The council, and candidates in the next election, should not even try to divert attention from the real problems of the campaign by blaming the city manager: it will not work, and could cost those who try a defeat at the polls. Wood may not be Mr. Warmth, but he is probably the most able city manager in the state, and other cities know that all too well. And so does his very supportive city staff. It is time to remind all those involved that we have a city manager form of government and what that really means.

I just looked outside my window. Beverly Hills is still here.

As for the painfully slow count of the Hilton vote by the County Registrar of Voters, there needs to be some investigation of that office by the Board of Supervisors, determining why the Registrar implodes at every election and why it takes days and even weeks to obtain results in close elections. With so much at stake, it is intolerable that the Registrar can't complete its count more quickly. Another reason for mentioning this? The election procedures are controlled by the County and not our very able city clerk and his deputies.

# Strong Second Half Gives BHHS Football Team Victory Over Morningside

Normans to play at Culver City Friday night in regularseason finale.

Instead of a comeback from a double-digit deficit as it has done three times this season, the Beverly High football team turned a dominant second half into its most recent triumph, a 56-21 homecoming victory over Inglewood Morningside Friday night at Nickoll Field, which assured it of at least a share of the Ocean League championship.

The Normans (7-2, 4-0 in league play) led 21-14 after a first half that coach Carter Paysinger said his team didn't play "particularly well" and didn't "match Morningside's intensity level."

It was a different story in the second half, as Beverly Hills scored the first 35 points to wrap up their seventh consecutive victory.

The onslaught started with David Saedi running for two four-yard touchdowns in the third quarter, his second and third of the game.

Instead of a comeback from a double-digit Marcus Silbiger recovered a fumble in the end zone on a Monarchs' kickoff return for the Normans' third touchdown in the quarter.

In the fourth quarter, Beverly Hills got a seven-yard touchdown run from Kenny Bassett and a 34-yard interception return by Silbiger for another score.

"In the second half, we were able to focus and play to our capabilities," Paysinger said.

The Normans' improved play in the second half was a result of the score being closer than the players thought it would be, Paysinger said.

Beverly Hills took a 7-0 lead on Dex Lucci's 24-yard touchdown pass to Erik Munzer in the first quarter. It increased the lead to 14-0 on Saedi's four-yard touchdown run. Morningside (3-6, 1-3) cut the deficit to 14-7 on Isaac Charles' 64-yard touchdown



The Normans regained a 14-point lead on Lucci's 40-yard touchdown pass to Bassett. The Monarchs scored the final touchdown of the first half on Charles' 23-yard pass to Antonio Wilson.

Wilson scored the game's final touchdown on a 31-yard fourth-quarter run.

Bassett, lineman Caylin Hauptmann and Munzer drew praise from Paysinger for their play on offense, while lineman Daniel Kim "played well on the offensive and defensive lines," Paysinger said.

Despite the victory, Beverly Hills remained ranked 10th in the Southern Section Western Division poll.

# What's Next?

The Normans are scheduled to play at Culver City (6-3, 3-1) Friday at 7 p.m. in the regular-season finale for both teams.

A victory or tie would assure Beverly Hills of the undisputed Ocean League championship and the designation as the league's No. 1 team for the Southern Section Western Division playoffs, and accompanying firstround home game, most likely against a No. 3 team.

If the Centaurs win, they would be cochampions with the Normans, but would be designated as the league's No. 1 team on the basis of the victory.

"Culver's interesting because they have the ability to run and pass the ball," Paysinger said. "They have a lot of athletes, just as many as other teams we've played in our league. From our standpoint, we've got to stop the run [and] make them as one-dimensional as best we can."

Beverly Hills is 0-3-2 in its last five games against the Centaurs, including a 31-21 loss in 2007. Paysinger said fourth-quarter fumbles cost the Normans victories in 2006 and 2007.

Rosen had 11 service aces while Skootsky and Mallory Smith each had seven kills.


"We had a little letdown in the second game, gave up too many points, but overall, it was a win," Weiss said.

# Beverly Hills begins 'Sister City' relationship with Pudong, despite some resident concerns

A recent trip to China by a delegation of Beverly Hills major players has resurfaced the debate over Beverly Hills' Sister City program.

Beverly Hills currently has three Sister Cities: Cannes, France; Acapulco, Mexico; and Herzliya, Israel. Cannes was the first city to partner with Beverly Hills, in November 1986 via the international non-profit organization Sister City International.

The Beverly Hills Global Partners (BHGP), a year-old non-profit umbrella group overseeing all Beverly Hills' Sister Cities activities, recently began orchestrating a sisterhood relationship with Pudong, China, a suburb of Shanghai.

The delegation of Beverly Hills residents, all members of BHGP, traveled to China from Oct. 30 to Nov. 4 to meet with approximately 70 Chinese officials and begin solidifying the "Sister City" relationship.

In the delegation were BHGP cochair Bruce Cole, Cole's Public Works Commissioner Nanette Cole, Mayor Barry and Sue Brucker, PTSA president Alissa and Warren Roston, Conference and Visitors Bureau director Kathy Smits, Rotary Club president Robbie Anderson, Paula Kent Meehan, Chamber of Commerce chair Vicky Mense, and the *Beverly Hills Courier* publisher Clif Smith Jr.'s wife Candace and daughter Mary Evelyn Smith.

Brucker said he didn't know who selected the members of BHGP.

BHGP co-chair Cole has spearheaded the campaign to enter into a relationship with Pudong. His intentions behind that campaign, however, have been met with skepticism.

Cole has been involved with businesses in China since 1985. He currently holds several executive roles in banks and investment companies in China, including his role as chairman of Mamtek International, a Hong Kongbased sucralose manufacturing company, as well as vice chair of China Consolidated Investments, a diversified investment company. He is also vice chair of Morgan Stern Merchant Bank in Beijing and Hong Kong, as well as Morgan Stern Realty in Beverly Hills.

His close business relationship with the owner of the Grand Hyatt Shanghai in China's second tallest building, the Jin Mao Tower, ensured the delegation's accommodations in the hotel. Cole, who could not be reached for comment by press time, told the City Council at the Sept. 23 study session that his desire to 'sister' with Pudong had no connection to his business dealings in China.

• Before the delegation's trip, the Beverly Hills City Council approved a \$35,000 grant from the City's general fund to BHGP to begin to establish a Beverly Hills tourism office and to hire one full-time employee to staff the office, per BHGP and Cole's request. The BHGP's original request was for \$100,000, with a line-by-line itemized breakdown of costs for office space, supplies, miscellaneous items, and a full-time employee at \$45,000 a year.

This was the first time that the Beverly Hills City Council has granted any money to a Beverly Hills Sister City Committee, with the exception of a few grants to Beverly High students taking part in the student-exchange program, according to President of Beverly Hills/Cannes Sister City Committee Paul Kuperstein.

The Cannes/Beverly Hills committee "has never received any funding from the Council. No Sister City committee does," said Kuperstein, adding again the exception of money for financially strapped students in the exchange program.

The Beverly Hills/Cannes Sister City Committee is comprised only of volunteers and all members pay their own expenses. There are 20 volunteer members in the Cannes-based Sister committee and between 10 and 15 volunteer members in the Beverly Hills-based committee. Kuperstein says they communicate weekly.

The members of the delegation to Pudong all paid their own personal expenses, according to Brucker.

• While in Pudong, the BHGP hired one full time employee, named Woo Pai. Pai is the daughter of Cole's business associate. According to the financial records submitted by BHGP when requesting \$100,000 for the Pudong office, the full-time employee would be paid \$45,000 a year. The BHGP anticipates the office earning the capital to pay the employee through merchandising and other business dealings.

The BHGP's mission in Pudong appeared to be based more on tourism than cultural exchange, according to Councilmember Linda Briskman at the Sept. 23 Council study session when Cole presented the Pudong plan.

A large business component and merchandising plan is included in the BHGP statement submitted to the Council.

Brucker told the Weekly that the Smith family, though not residents, simply wanted to come along on the trip in "good faith." However, the Courier is included in the 'Business Membership' facet of the BHGP's proposal to promote relationships with Chinese businesses. For a \$20,000 annual fee, a business can purchase a golden membership that would include "free advertorials on major partnered local media; Discount media package on major sister city local media such as the Beverly Hills Courier," according to the materials presented by Cole at the Sept. 23 study session. No other local media is mentioned in the materials.

Clif Smith Jr. is also a member of BHGP.

• Based on this business and tourism emphasis, Briskman was concerned with this project doesn't fall within the definition of a Sister City—which is aimed at promoting cultural understanding—but rather a project for the Conference and Visitor's Bureau (CVB).

In fact, at one point Briskman suggested that perhaps the money for the Pudong project should come from CVB.

CVB director Kathy Smits says that the CVB already has a full-time employee in China, based in Beijing.

"Her scope is very broad-based," said Smits. "She covers the whole country." The CVB's latest tourism report shows that their outreach has brought in a higher percentage more tourists

Beverly Hills residents though are concerned that city money is being funneled to China. Beverly Hills Ruth Kraft addressed the Council at the study session explaining that she doesn't think city money should leave the city.

"I have to tell you that anyone in China who has the money to come to Beverly Hills has either been here of will be here. We don't need to send them money to publicize. We are known all over the world," said Kraft.

But Brucker says that Beverly Hills is not as well-known as residents might believe and that the "small" investment in Pudong's office will yield extraordinary returns to Beverly Hills in tourist and retail dollars.

• Others residents have concerns about China's questionable humans rights record.

"Is this the same Beverly Hills that at [then-] Mayor [Jimmy] Delshad's urging was moving to divest all holdings in companies that do business with Iran because of alleged human rights violations?" asked John Mirisch, who edits BlogBeverlyHills.org.

"While moving to divest from Iran is certainly the right thing to do, if the City is really concerned about human rights, picking China as the next country to partner up with seems extremely hypocritical. While China is undeniably a major economic force whose international influence is only bound to grow, China is also one of Iran's biggest international allies and can hardly be said to be the best global role model of respect for human rights. Yes, doing business with China seems to be inevitable these days, but it hardly should top the list of countries with which Beverly Hills should develop a sibling city relationship," Mirisch wrote in his blog.

The City Council's decision to divest from Iran in mid-2007 came on the heels of California's Assembly Bill 221, which required the state to divest its investments and pension funds from foreign companies with ties to Iran.

Beverly Hills held around \$482 million in public employee pension funds in 2007, though officials did not know what percentage of the money was in companies with ties to Iran.

According to Amnesty International's 2008 report on human rights violations, China's role in the human rights abuses in its own country as well as in Tibet and Darfur place it as one of the top countries in human rights violations. "Truthfully, I still have big issues with the human rights issues in China and I don't know that I want to be funding an effort there until I know more about it," said Briskman.

The council will discuss finalizing the relationship at a future council meeting.

According to Brucker, a delegation of Chinese officials will be traveling to Los Angeles on Dec. 14 and will be staying in Beverly Hills hotels for the duration of their stay.

Cole did not return phone calls by press time.
