


I deplore that.

# What does 'Basic Aid' mean for the BHUSD?

### Increased funding, fewer permits mean prosperity ahead By Jacquelyn Ryan

The Beverly Hills Board of Education learned that it could become a Basic Aid district, which is funded by property taxes as opposed to state aid, as early as this year, at last Thursday's study session with consultant Dr. Mike Winters.

In a two-hour presentation, Winters described at length how the BHUSD will become a Basic Aid district by approximately 2010 if not sooner. Becoming Basic Aid is not voluntary; it only happens when a district's local property taxes exceed the amount of funding the district would receive from the state, and Beverly Hills is "rapidly" approaching that scenario. When that happens, the state stops supplying monies to the district and allows the district to fund itself with the property taxes and pocket whatever extra revenue those taxes generate.

The BHUSD, currently a revenue-limit district funded by the state of California, now receives state funding based on the actual daily attendance (ADA) of students. For the 2008-2009 school year, the BHUSD received \$6,770 per pupil for its over 5,200 student population.

Compare that number though with the approximately \$13,300 per student that Basic Aid district Laguna Beach Unified receives from its local property taxes alone for its almost 3,000 students.

That's why the Board of Education is looking forward excitedly to becoming Basic Aid—the district, classrooms and students could all have more money available to them. It could open up possibilities for new extracurricular activities, new equipment and eventually even provide bonuses or better wages to faculty and staff. What's more, Basic Aid districts like Laguna Beach Unified won't be affected by mid-year state budget cuts, since they don't rely on state funding.

To become a Basic Aid district, a district's local revenues from the 1 percent portion of property tax levies must exceed state revenue limit funding (or minimum funding requirement) or the district's per pupil property tax revenue must exceed its per pupil revenue limit, according to Winters. That scenario usually results from rapid increases in local assessed valuations coupled with static or declining school district enrollment, as is happening in Beverly Hills and the BHUSD.

If that sounds abstract, picture the minimum funding requirement like a full cup. For revenue-limit districts, that cup is filled first with proceeds from the local property taxes. When the property taxes don't fill the cup to the top, the state pours in the rest of the funding. For Basic Aid districts, the local property taxes fill the cup to the top and often overflows, which the district also gets to keep.

The flip-side, Winters said, is that "in a Basic Aid district, enrollment doesn't matter—you get what[ever funding] you get."

The BHUSD's operating budget is approximately \$55 million, which includes \$10 million a year from the City through the JPA. The BHUSD receives from the state of California only about \$32,737,392 a year based on the ADA (5,200+ students x \$6,770 from the state per student= \$32,737,392). In Basic Aid, Winters estimates that the BHUSD would initially receive somewhere around \$34 million from property tax funding, regardless of the number of students. In revenue-limit structure, when a district loses a student, it loses money. In Basic Aid structure, if the district loses a student, it has more money to spend on the remaining students.

The BHUSD has more than 850 interdistrict permit students, which means 850 students whose parents aren't paying property taxes in the city. When the district's funding is no longer based on the enrollment number, those 850 students could pose a financial problem.

"We will definitely have to reevaluate our permit policy," said Board member Brian Goldberg, who suggested an immediate moratorium on new opportunity permits and beginning to develop a process to wane down the number of permits the district currently has. All five Board members made it clear that they would not favor cutting permits for City or District employees.

By reducing the number of students in the district (like opportunity permit students) the district will have a significant amount more money to spend per remaining student. Controlling the number of students in the district allows the Board to loosely control how quickly BHUSD enters Basic Aid, but it also could ensure that BHUSD stays in Basic Aid.

"If we budget and prioritize correctly, we can do very creative things... almost like private schools," said Goldberg. "What I'm afraid of is we're going to miss this opportunity by getting bogged down in a debate about permit levels and how high a reserve is prudent and necessary."

Winters projected that the BHUSD's resident enrollment would steadily increase over the next 15 years, especial-



ly if students who are now on permits move into the district in order continue their education. But only last school year, the district hired a demographic consultant who predicted that the district's enrollment would decline in the coming years.

The Board made no decisions at the informational meeting. They will discuss plans for Basic Aid at a future meeting.

#### Waxman wins chairmanship in House Energy and Commerce Committee



Rep. Henry Waxman (D-Los Angeles) narrowly beat out incumbent Rep. John Dingell (D-Michigan) to become the chairman of the House Energy and Commerce Committee last Wednesday.

Democratic Caucus voted 137-122 to grant Waxman, 69, the chairmanship. The 82-yearold Dingell, the longest-serving member of the House currently seated, had chaired the committee off and on since 1981 and was most recently instated in 2006. Waxman and Dingell have worked together for 34 years.

"I am honored by the vote of the Democratic Caucus. We are at a unique moment and have an opportunity that comes only once in a generation. I will work with all parts of our Caucus and across the aisle to deliver the change that the American public expects us to deliver," said Rep. Waxman, in a prepared statement.

Waxman called Dingell a "true legislative champion" and said he "will always admire and respect [Dingell] and his many legislative accomplishments."

Waxman, who was elected to office in 1974, currently leads the Oversight and Government Reform Committee, the principal House investigative committee on federal programs and policies. Waxman was elected chairman in 2007 but has been a ranking member of the committee since 1997.

The Energy and Commerce Committee, which is one of five exclusive committees in the House, has a broad scope and oversees energy, telecommunications and health care.

Waxman chaired the Commerce Committee's Subcommittee on Health and the Environment from 1979 to 1994 and served as a ranking member from 1995 to 1996. He has also sat on the Subcommittee on Health, on Energy and Air Quality and on Oversight and Investigations.

Waxman will speak about "Priorities for the 111th Congress" at the National Council of Jewish Women (NCJW) Los Angeles Council House on Dec. 1 from 11:30 a.m. to 1:30 p.m. as part of the NCJW's Lunchtime Speakers Series. For more information, call (323) 852-8503.

## Hilton winning by 80 votes in Measure H race

Measure H was winning by 80 votes on Wednesday afternoon, after the Los Angeles Registrar-Recorder/County Clerk's Office completed another round of late absentee and provisional ballot counting. The Beverly Hilton is currently leading with 7,787 votes (50.26 percent) versus 7,707 votes (49.74 percent).

The County Clerk's Office says there were between 5,000 and 10,000 vote-by-mail and remake ballots and roughly 70,000 provisional ballots left to be counted as of Wednesday morning. Some of those ballots are likely are from Beverly Hills voters. Another round of ballot counting is scheduled on Saturday to count the remaining approximately 20,000 provisional ballots.

The Hilton has steadily held the lead since late ballots began being included in the count. However, the margin of difference continues to fluctuate, with the Hilton at one point only ahead by nine votes. The County Clerk's

Office anticipates all outstanding ballots to be counted by Saturday evening and hopes to certify the election results on Dec. 1. Even with a finalized vote, Measure H, which would allow the

Beverly Hilton to build a Waldorf=Astoria and two condo buildings on its lot at the intersection of Wilshire and Santa Monica boulevards, may very well be decided by the courts.

Citizens Right to Decide Committee, which led the unofficial No on H campaign and gathered the signatures to force the issue on the ballot, has said that it will file a lawsuit to set aside the vote if the Hilton wins. CRDC treasurer Larry Larson believes that there were several cases of voter fraud on Nov. 4 and says he is aware some non-residents and noncitizens who voted in Beverly Hills.

Representatives of the Beverly Hilton have said they will wait to comment on the race until all the ballots are counted. But after a \$3 million campaign to pass Measure H, it seems unlikely that the Hilton would sit silently should the win slip out of their hands.

#### Beverly High takes second place at unofficial Academic Decathlon

Competing against eight other high schools in Los Angeles County, Beverly High's Academic Decathlon team earned second place in the L.A. County Decathlon practice competition on Saturday.

Despite taking second, the Beverly team won the most individual awards including a first, second, and third place sweep in the mathematics test. First place was Cindy Xu with a score of 971/1000; second place was Josh Sun with 943/1000; and third place was Michelle Mah with 857/1000.

The teams competed in the fields of math, English, music, art, social science, economics and a 'superquiz' about evolutionary biology. At the official competition, the teams will compete in these categories as well as in speech, interview and essay writing.



teachers. At this point, the union president stomped around the room and in front of the camera in a very distracting manner and some members of the almost-all-teacher audience made catcalls. Perhaps because of adrenalin when feeling attacked, they did not hear my next comment. I said, "Are these comments fair? Probably not, they are most likely rantings from unsuccessful and unmotivated students." I just said these comments were morally equivalent, but they are not: I repudiated the comments by the disgruntled students immediately and the union leadership stands behind and continues to report on their equally personal attacks. My point is that neither type of attack is fair or appropriate (there is a reason why the district does not survey student opinion of individual teachers and use that as feedback in their performance reviews). This was my attempt to get the union leadership to empathize with the district administrators that they constantly attack.

I spoke to a union member a couple of days afterward who agreed that the tone of communications had deteriorated, but that you don't get someone to stop hitting you in the face by hitting them in the face. I think that person is correct, but we seem to be well beyond that point even before my comments were heard.

So now the union leadership is running around the campuses as the injured party,

# About Anger And Board Views

### Some shockers in council race By Rudy Cole

If the "soaps" are really heading for ether land, where will we turn for angst and raw emotion? Try watching a meeting of our own school board or city council: Enough drama to sell a whole warehouse full of detergents.

Actually, considering some recent council tiffs over Measure H and the mayor's trip to China, by comparison the school board has been almost collegial, but not quite.

This week, some school issues, some reasons for continuing disputes and some responses to interviews with all five board members. Some of their answers and recent comments may even surprise you.

First, and probably the most contentious event was former school board president **John Millan**'s comments at the last board meeting. Millan, who served with real distinction and was an often moderating voice during his one board term, has become far more confrontational and even strident in his frequent board appearances since opting not to run for a second term.

Last week, Millan went after the teacher's union leadership. But was it fair?

Not that the union has always spoken with a temperate or conciliatory voice, they haven't, but Millan may well have gone over the line of acceptable debate.

What surprised many was Millan's taking of information about two teacher – union leaders that students posted on "ratemyteacher.com." The two, BHEA vice president **Mark Frenn** and president **Chris Bushee**, were subjects of some typical student gripe venting. Giving this public airing as if it truly represented an honest evaluation of their work as teachers was neither fair nor a step toward bringing the education community together, something that will require far more dialogue with teachers.

Could the board have intervened when Millan appeared during the public comment period? Was it a violation of the education code, as the union has charged, this raising of employee performance issues in a public



forum?

Here's what board members told us on this and other school matters:

According to Dr. **Myra Demeter**, board president, Millan could not have been silenced. She cites Baca v. Morena Valley: "a legislative body can not censor in advance public speech that includes criticism about a specific employee or require such discussion not take place in public."

Board member **Steven Fenton** would try to intervene and prevent personal attacks on anyone. **Nooshin Meshkaty** said the administration had advised her that it would violate the Brown Act to stop attacks, agreeing with Demeter, but she added: "I think we need to start off the meetings by asking everyone to be more respectful when addressing the board."

**Myra Lurie**, a lawyer, took a more legalistic and more analytical approach:

"I think the distinction to be made is whether the speech that is critical is legally defamatory or whether it constitutes specific charges or complaints against certain employees." She says that the complaint filed by Bushee omits sections of the codes that protected Millan's comments.


**Brian David Goldberg** says the board should carefully follow its own rules insisting that any employee issue be considered in closed session as required by the education code.

Which brought up another issue: Unlike the city council, the school board does not now have a legal advisor, although for many years it did. Budget restraints are the most often cited reason, but how to handle public attacks on teachers is only one example of why the board might well need a lawyer to advise them on many public policy legal matters, including interpretations of the Brown Act.

Goldberg says rather than waste district resources on an attorney, "we should halt the activity and call for a recess to calm the situation (apparently a dispute on process) and confer on how best to proceed." Demeter points out that the board can request legal advice "when needed." Lurie thought it would be helpful to have an attorney at meetings, but "I don't think it's a luxury we can afford." She cited the value to the city council of having city attorney Larry Wiener at all council meetings. Meshkasty thought an attorney would be helpful but also cited costs. How much it would cost since the services are provided by the county counsel is something Meshkaty wanted to explore. Fenton said he would support having a legal advisor at meetings.

All five members agreed it would be advisable to hold board meetings that did not conflict with city council meetings. But there are differences on whether the board should have roll calls.

Demeter said "roll call votes are always used when there appears to be a vote that is not unanimous." This would mean keeping



present policy of not having a roll call on each vote, something routinely done by the city council and most other school boards. Fenton favors calling the roll as do Goldberg and Lurie who pointed out it has been done when there was any doubt on a unanimous vote.

A considerable amount of time is used during each board meeting by the reading of letters to the board. Should people who don't want to speak or who are not able to attend meetings have their views read publicly or should the letters simply be acknowledged and made part of the record?

Goldberg favors a policy adopted by the council: accepting telephone calls during public input. "If we went with that option then the need for letters to be read would be diminished" but "without that option I would support having letters read."

Fenton says he has "no problems with letters being read as long as there are no personal attacks." Meshkaty has mixed feelings about letters being read, but agreed with Goldberg on the exploring phone messages. Lurie wanted the board to review letter reading and Demeter had no comment.

More board responses to the interview next week.

At the last board meeting it was Goldberg who urged more civility in dealing with issues by all those involved in the education community. Goldberg, who gave considerable effort to helping the bond campaign after first questioning the date set for the election, has often been very temperate even praising board members with whom he sometimes disagrees. So, I was somewhat surprised by his direct attack on Karen Christiansen, who is a district consultant on facilities and construction.

Goldberg had some reason for his annoyance. There have been too many mixed messages and uneven explanations of first steps in the construction process, but there are very good reasons for using architects with current experience and involvement that were simply not adequately explained or understood. The issue: Inviting an open selection of architects. Yes, for later work, but not in preliminary stages where past involvement and experience are critical. Again, a matter of failing to communicate and/or not taking more time to consider.

In any case, Goldberg and other board members should give Christiansen far more credit for some very remarkable achievements, especially in identifying and bringing to the district enormous amounts of grants we would never have obtained without her expertise. In the last few years, since Christiansen came to the district, she isolated and brought to the district nearly \$10 million, including \$350,000 from FEMA because of flood damage. Her construction and facilities technical skills, and that of her staff, are critical needs to the district. What Karen needs is some keener understanding of how to communicate with the board and the public. She does good work, just not chores that even her bosses often understand. She and Goldberg need to talk, and Christiansen needs to be more detailed in her board presentations.

Back to the other contentious problems in the district: I think our last departing school superintendent Kari McVeigh served the district well under very difficult circumstances. Whatever the reasons, there was a deep split between school administrators and the teacher's union although many individual teachers had very good relations with McVeigh.

Whether McVeigh was caught in the middle of disputes some members of the board had with the union and whether she reflected board attitudes, is now moot. Both the interim and next superintendent and the whole board needs to find far better means of reuniting the education community and that urgently means working with the teaching staff and its union.

The BHEA has an able leader in Chris Bushee. The union must now, however, help take the lead in ending the misunderstandings and contentious disputes of the past. It is a new beginning: a new leadership team of administrators is coming, the community has given strong support to public education by passing the school bond and this community wants to be teacher supportive. The Union now needs to become the adult in the room.

Incidentally, although we are still focusing on Measure H and an upcoming city council election, it is not too early to start thinking about possible board candidates for 2009. Some names being mentioned next week, but some who merit early consideration are Jake Manister, Jennifer Terrell-Schwartz, Bruce Horowitz, Cathy Baker, Nadine Nieman, Franny Rennie, Marc Saleh and our own Josh Gross, head of the alumni association.

This is going to be one fascinating city council race. What began as a walk in the park for Mayor Brucker and two new contenders, is turning into a very hard election to predict. Although the election is not until March, the battle lines are forming with some more surprises yet to come.

First jolt was the decision of former mayor and Councilmember Linda Briskman to seek a third term. That assured a real contest. Second is the entry of a real wild card. John Mirisch. Mirisch. if he does mobilize the anti-council vote, could be viable, but his often over-the-top blog might be a problem for him to defend. No question he is bright and his family has deep roots here, but can he define himself as able to work as a team player and not just as a harsh critic of every council or school board action.

Ready for a real shocker: Rumored seriously considering running with Mirisch is former mayor and former school board president Richard Stone!

It has been many years since a slate has even entered a city election, but this possibility would combine a young anti-council activist with a recent opponent of major hotel developments - Stone fought both the Montage and the Hilton.

Brucker has problems. In recent council elections, incumbent mayors have not had easy rides, two even losing bids for reelection. However, everyone concedes Brucker is a very tough campaigner, will walk every street and knock on every door. On the other hand, he has been the lightening rod on many, many issues from fighting the Chamber of Commerce to disputes with the North Homeowner's Association. If that portion of the population that actually votes is unhappy with city government, fair or not, the mayor suffers in the election.

Brucker's work as mayor and councilmember merit more space than this and I will give it that soon.

I have no idea where Virginia Maas stands on most issues, she was a contentious member of the school board and, interestingly, Richard Stone's most consistent ally when both served. She has a strong base of support, including those with whom she worked at Temple Beth Am, but she now faces an even tougher challenge.

The most likely beneficiary of this plethora of contenders is Dr. Willie Brien, who will probably emerge as the consensus candidate. Dr. Brien has the ability to work with a broad spectrum of public policy advocates and effectively moderate differences, even those with very strong, emotional views on issues. He is exactly the kind of public servant we want but are seldom able to convince to seek public office.

Briskman has a strong message: The city faces real, serious challenges if it hopes to continue providing the best in city services. The economic down turn will impact city revenues and leadership that has the experience to meet the new financial realities is something she can help provide. However, the two incumbents will NOT be running as a team.

The Beverly High football team appeared headed for another painful narrow first-round playoff loss late in the fourth quarter Friday night.

West Hills Chaminade had scored touchdowns on back-to-back possessions to tie the score after trailing by 14 points in the fourth quarter and seemed headed for another score.

Defensive back Erik Munzer preserved the Normans' chances for a victory by intercepting a pass by Eagle quarterback Anthony Vitto on the Beverly Hills 13yard line with 33.4 seconds remaining in regulation.

Beverly Hills ran out the clock to force overtime. Both teams scored touchdowns in the first overtime segment.

Munzer caught an eight-yard pass from Dex Lucci for a touchdown on the first drive of the second overtime. The Norman defense stopped Chaminade on downs on the ensuing possession, with Greg Townsend sacking Vitto on the final play, to secure the 42-35 victory in a Southern Section first-round playoff game at Nickoll Field.

The victory was Beverly Hills' first in a Southern Section football playoff game since 2005. The Normans had suffered one-point losses in first-round games in both 2006 and 2007.

Beverly Hills entered the game with a 1-6 record in the Southern Section football playoffs since 2001. However, its playoff futility appeared to be about to end when Munzer caught a 52-yard touchdown pass from Lucci with 11 minutes, 49 seconds to play, giving the Normans a 28-14 lead.

The Eagles (2-9), which hadn't scored since the second quarter, responded with a six-play, 65-yard drive that lasted 1:08, culminating with Vitto's 21-yard touch-down pass to Ronald McCrory.

Chaminade's defense forced Beverly Hills (8-3) to punt after three plays on the ensuing possession. The Eagles then drove 63 yards on five plays, with Vitto's 24-yard pass to Brando Tessar and Matt Goudis' extra point kick tying the score, 28-28 with 6:06 remaining.

The tie score sent the game into overtime, where each team is given the ball at the opponent's 25-yard line. Beverly Hills won the coin toss and chose to go on defense. Chaminade needed seven plays to score on Nick Grodotzke's four-yard run. Kenny Bassett ran eight yards for a touchdown on the Normans' third play, re-tying the score.

The Eagles had the choice to start the

David Saedi ran five yards for the third quarter's only touchdown, three plays after Martin Cadres recovered a fumble by Tessar on a punt return at Chaminade's 26-yard line.

#### What's Next?

The Normans are scheduled to play at top-seeded Palmdale (10-1) in a secondround Southern Section Western Division playoff game beginning at 7:30 p.m. Friday.

The Falcons operate a spread offense that "looks a lot like Culver City's," Paysinger said.

"The quarterback [Brandon Mims] is a really good runner and a better than-average-passer," Paysinger said. "They have two running backs [Marquell Jefferson and Corey Washington] that are strong and fast."

Having played Culver City gives the Normans an idea "of how to defend that offense," Paysinger said.

Paysinger said the Normans will benefit from the presence of linebacker David Saedi, who he described as the team's "No. 1 run stopper." Saedi missed the Culver City game, serving a mandatory one-game suspension from his ejection a week earlier.

Paysinger credited Palmdale's success to having "a lot of talent," and players who are big, fast and strong.

"They pose a lot of problems for opposing teams because they have so much talent spread all over the field," Paysinger said.

Review of tapes of five Falcon games led Paysinger to believe that Beverly Hills "has a better passing game and as good a running game."

"We think we can pose a problem because we have the dual threat" of running and passing, Paysinger said.

The Normans have not won a second-round football playoff game since 1997.

If Beverly Hills wins, it would play the winner of the Downey Warren-Manhattan Beach Mira Costa game in a semifinal Dec. 5.

The Normans would play at Warren, because it lost a coin flip, while it would play host to Mira Costa under the Southern Section rule calling for the team with the fewer home playoff games to host the next game.

Beverly Hills' first home game is set for Dec. 17 against Oak Park in the second annual BHHS Girls Varsity and JV Winter Basketball Classic.

#### **Boys' Basketball**

Beverly High is scheduled to open what first-year coach Derek Boldon described as a rebuilding season Monday when it plays at Newhall Hart in a nonleague game beginning at 7 p.m.

In addition to the customary losses from graduation from last year's team which was 11-15, failing to qualify for the Southern Section playoffs and finishing last in the Ocean League with a 2-8 record in league play, the Normans had their leading scorer, guard Julian Wheeler, transfer to Lawndale Leuzinger, and starting center Justin Cooper move to Texas, Boldon said.

The Normans will try to play an "up tempo game" in an attempt to compensate for their lack of size, said Boldon, a former assistant at Pasadena City College who replaces Luis Turcios, who resigned to coach the Mexican professional team Lechugueros De Leon.

Defensively, "we're looking to be a stronger rebounding team, based on positioning," Boldon said.

"We're not going to out-jump anybody or be a shot-blocking team, so we've got to play defense from a position standpoint and make sure we're staying in front of the opposing player," Boldon said.

Beverly Hills will be "pretty shallow on the bench, so as soon as my big fellows get in [foul] trouble, we're going to get real small real fast," Boldon said.

## Past honorees tell us why they are thankful this holiday season

Thanksgiving is one time during the year that we slow down from our hurried lives to give thanks for some obvious good fortunes and for some of the things that we may take for granted. Every Thanksgiving for the past several years, The Weekly has profiled some Beverly Hills residents who have something to be uniquely thankful for: a second chance at life. This year, we checked in with our past featured residents to see how they're feeling and how they'll be giving thanks this year.

#### JANET LAMBERT



Janet Lambert, Hawthorne School eighthgrade teacher who was first profiled in "Giving Thanks" Issue 269, has "had a year that gives me much to be thankful for this Thanksgiving."

Lambert was in remission from non-Hodgkins Lymphoma after a successful bone marrow transplant in May 2004. After being in remission

for more than three years, her cancer returned in the spring of 2007. Lambert was treated by oncologist Dr. Philomena McAndrew at Tower Hemotology and Oncology while working a full year at Hawthorne in 2007-2008, both as teacher and as interim assistant principal in the spring.

"I've been at this for quite a while. I was disappointed [that my cancer came back] but was very thankful that they were able to treat me," said Lambert, who is again considered in remission.

For her most recent battle with cancer, Lambert received a stem cell transplant at City of Hope under the care of Dr. Stephen Forman in August, forcing her to take a medical leave from Hawthorne School. She hopes to resume her work in spring.

When the Weekly caught up with her in 2005, Lambert said that she hoped to be able to thank her first donor one day. Given the donor was from an international donor bank, Lambert waited the requisite year and then mailed her donor a thank-you letter.

"It felt great. You are really thanking someone for your life," said Lambert.

Lambert is also grateful for some of life's simpler things.

"When you have a transplant, you have to eat a lowbacteria diet and wear a mask," said Lambert. "When I got to go on a normal diet, I really appreciated fresh food. And to be able to walk outside and feel the air without a mask on."

A highlight for Lambert this year was seeing her husband, Mike, honored as the Apple Award recipient from Hawthorne at the Beverly Hills Education Foundation's annual Apple Ball.

"I have had tremendous love and support from not only my family and friends, but from the Beverly Hills community as well. I am truly thankful for all my doctors and nurses who have cared for me, and, my Beverly Hills family, of whom I will always remember as an extended family," said Lambert.

Lambert will be spending Thanksgiving at her mother's house with her family.

#### **JAMES BRUBAKER**



James Brubaker, featured in Issue 373, is continuing to do "extremely well." Brubaker, a former

South Doheny Drive resident, had esophageal verices, which is a rupture of the veins in the esophagus when the body is suffering from liver disease. After a series of complications including an irregularity of his heart beat

(Atrail Fibulation), Brubaker received open heart surgery regulate his heart beat and remove a large blood clot, which allowed him to grow healthy enough to receive a much-needed liver and kidney transplant at Cedars-Sinai Hospital in 2005. He was in the Intensive Care Unit at Cedars-Sinai for several days after his operation before he eventually "pulled through."

"The motivation came from my wife and grandson, the reason I did this in the first place, is because I could not conceive leaving them alone to deal with the world," said Brubaker in 2006.

On the anniversary of his liver/kidney transplant in August, Brubaker says he e-mailed his doctors, chief of surgerical team Dr. Andy Klein and chief hepatologist Dr. Fred Poordad at Cedars "with my annual acknowledgement of their saving my life. I thank them in my prayers nightly."

Brubaker is currently living on the Chesapeake Bay in Havre de Grace, Md., a place that Brubaker described as "a charming, unspoiled town of about 12,000."

"Life on the Chesapeake Bay is beautiful and living in a small town has done wonders for my wife Joyce, our teenage grandson Brian and me," said Brubaker, who admits to missing parts of Beverly Hills.

Brubaker is being "well cared for" by doctors at Johns Hopkins Hospital who are former associates of both Dr. Klein and Dr. Poordad.

"I have tons to be thankful for" on Thanksgiving, said Brubaker about his second chance at life. He'll be spending the holiday with his wife and grandson.

Brubaker says his dedication to recovery and living a long, healthy life have been in part inspired by former North Carolina State basketball coach Jimmy Valvano, who said "Never, never, give up!"

#### **ELAINE LERNER SCHREIBER**



Elaine Lerner Schreiber, who was first profiled in Issue 217, says physically she is still "doing fine" after going into remission from stage 3C ovarian cancer.

Schreiber was diagnosed with the disease in October 2001 and told that her cancer had spread to her intestinal areas and other organs in her body. "I had unusual stomach

pain, cramps and bloating and it's not something you typically run to the doctor when you have, but my pain wasn't something that went away," said Schreiber in Issue 217. "It's difficult to detect ovarian cancer and nothing originally showed up after I had a visit to my gynecologist and I also had a colonoscopy."

Six days after her diagnosis, Schreiber went into surgery to have the cancer removed and began six months on chemotherapy. After her successful treatment, Schreiber said she was incredibly thankful to her doctor, gynecological oncologist Dr. Beth Karlan at Cedars-Sinai.

"Not one time did I ever think that I wouldn't make it," Schreiber told the Weekly in 2003. "That woman [Karlan] is the most loving and amazing person I have ever met. When she talks to you she makes you believe you're the most important person in the world."

But tragically in the spring of this year, Schreiber's husband, Arthur Schreiber, and mother both passed away within seven weeks of each other.

"I had 14 years with [Arthur]. I'm grateful for that," said Schreiber, a Spalding Drive resident. "I'm just glad I'm here. I'm always grateful for that."

Arthur, a more than 30-year resident of Beverly Hills, got a respiratory infection which was complicated by his asthma and chronic lung disease. He was in the Intensive Care Unit at Cedars-Sinai for a month before he passed away in April.

"Thanksgiving was always very special [to my husband]," said Schreiber, who with one of her children has traveled to Arizona to be near her family for Thanksgiving. "I didn't want to have to stay home or cook."

Schreiber says she doesn't anticipate this year to be a "wonderful" Thanksgiving like she's had in previous years. But she is glad to be near family and she said, "as they say, life goes on."

These definitions shall read as follows: "CANDIDATE: An individual who is listed on the ballot or who has qualified to have write in votes on his or her behalf counted by election officials for nomination or election to the city council or the office of city treasurer, or who receives a contribution or makes an expenditure or gives his or her consent for any other person to receive a contribution or make an expenditure with a view to bringing about his or her nomination or election to the city council or to the office of city treasurer. whether or not the specific city office for which he or she will seek nomination or election is known at the time the contribution is received or the expenditure is made and whether or not he or she has announced his or her can-didacy or filed a declaration of candidacy at such time. Notwithstanding the above, "candidate" does not include a replacement candidate or a target officer. An individual who becomes a candidate shall retain his or her status as a candidate until such time as that status is terminat-ed pursuant to section 84214 of the California Government Code. "Candidate" does not include any person within the meaning of section 301(b) of the feder-al election campaign act of 1971.

RECALL ELECTION: is an election conducted pursuant to Division 11 of the Elections Code. For purposes of this Chapter, a recall election begins when a member of the city council or the city treasurer is served with a notice of intention to circulate a recall petition pursuant to section 11021 of the Elections Code and a recall election ends when any of the following occurs: (1) the city clerk finds that the notice of intention to circulate a recall petition for the target officer fails to meet the requirements of sec-tions 11020-24 of the Elections Code; (2) the proponents of the recall of the target officer fail to file a valid recall petition within the deadlines required by section 11042 of the Elections Code; (3) the city clerk refuses to accept for filing the recall petition for the target officer pursuant to section 11222 of the Elections Code; (4) the city clerk certifies the recall petition for the target officer to be insufficient pursuant to sections 11224 or 11225 of the Elections Code; or (5) the recall election is held. Additionally, no candidate or candidate's controlled committee shall solicit or accept any contribution that will cause the amount contributed by the contributor to the candidate or the candidate's controlled committee to exceed one hundred and twenty-five dollars (\$125.00) for any single election at which the candidate is attempt

ing to be, or is, on the ballot. 2. Notwithstanding subsection A1 of this section, if a candidate accepts the voluntary expenditure ceiling established by section 1-8-4 of this chapter, no person or committee shall make to any such candidate, including the controlled committee of such candidate, a contribu-tion in excess of three hundred dollars (\$300.00) for any single election at which the candidate is attempting to be or is, on the ballot. Additionally, no candidate or candi-date's controlled committee shall solicit or accept any contribution that will cause the amount contributed by the contributor to the candidate or the candidate's contributor committee to exceed three hundred dollars (\$300.00) for any single election at which the candidate is attempting to be, or is, on the ballot.

3. No person shall make to any committee which supports or opposes any candidate or candidates, other than a candidate's controlled committee subject to subsections A1 or A2 of this section and no such committee shall solicit or accept from any such person a contribution or contributions totaling more than three hundred dollars (\$300.00) for any single election. 4. The city council may, by resolution, adjust the contri-

bution limit established in this subsection A in October of every even numbered year to reflect any increase or decrease in the California consumer price index since the last such adjustment of the contribution limit. Such adjustments shall be rounded to the nearest ten-dollar (\$10.00) amount.

5. The limitations of this subsection A shall not apply to contributions of a candidate's personal funds to his or her controlled campaign committee on behalf of his or her own candidacy, and shall apply to contributions from the candidate's spouse.

Subsection D of Section 1-8-3 of Chapter 8 Title 1 of the Beverly Hills Municipal Code is hereby amended to allow spouses to make their separate contributions on one check if accompanied by a letter indicating the contribu-tion is from both spouses and to read as follows:

"D. Family Contributions: Contributions by a husband and wife shall be treated as separate contributions and shall not be aggregated. Nothing in this chapter shall prevent a husband and wife from making such separate contributions through the use of one check if (1) the check is from a joint checking account with the names of both spouses printed on the check, or (2) the check is accompanied by a letter from either spouse indicating that the check is from both spouses. Contributions by children under eighteen (18) years of age shall be treat-ed as contributions by their parents and attributed onehalf (1/2) to each parent or the total amount to a single custodial parent


