NOTICE OF PUBLIC HEARING

The City Council of Beverly Hills, at its regular meeting to be held on Tuesday, December 16, 2008, at 7:00 p.m., in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210; will hold a public hearing to consider:

> A time extension through June 30, 2009 for the Interim Ordinance regarding parking and loading standards of commercial buildings along in the Commercial-Transition Zone (C-3T-2) on Olympic Boulevard between Rexford Drive and Robertson Boulevard, first adopted by the City Council on November 5, 2008.

The Interim Ordinance requires new businesses occupying a major commercial space (greater than 12,000 square feet) in the area along Olympic Boulevard between Rexford Drive and Robertson Boulevard to conform to the City's current parking and loading standards. In the event that it would not be feasible to meet the current standards, accommodation may be granted through a public hearing before the Planning Commission. The Interim Ordinance would expire on December 20, 2008, unless extended.

This project has been reviewed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. Staff has determined that the proposed project qualifies for a Class 8 Categorical Exemption under the authority provided by the CEQA Guidelines Section 15308 because the Interim Ordinance is an action taken to protect the environmental conditions in the project area from traffic and parking intrusion into residential areas resulting from new commercial uses that otherwise could operate without adequate parking and loading facilities. Further, the project is exempt from CEQA pursuant to CEQA Guidelines Section 15061 (b)(3) because it can be seen with certainty that it will not have a significant impact on the environment.

Any interested person may attend the meeting and be heard or present written comments to the City Council. If you challenge the City's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

The City of Beverly Hills is preparing an Environmental Impact Report (EIR) for the proposed 9936 Durant Drive Project as more fully described below. The public is invited to attend a preliminary "scoping" meeting on December 15, 2008 at 6:30 p.m. to comment on environmental issues which should be addressed in the EIR.

Project Location: The project site is located on an 11,991 square foot site comprised of Lots 788 and 789 of Tract No. 7710 (Map Book 83, Pages 94 and 95). The project site is located on the south side of Durant Drive, between S. Moreno Drive to the west and Lasky Drive to the east. An alley runs along the southern edge of the project site.

Project Description: The project site is currently developed with a two-story, 28 foot tall, 12,145 square foot apartment building with five dwelling units. The existing Colonial Revival-style apartment building was constructed in 1935 and is the work of architect Robert V. Derrah. Under the proposed project, the existing apartment building would be demolished and replaced by a single four-story, 45 foot high, 24,906 square foot building containing 13 units, with two levels of subterranean parking containing 41 parking spaces. Access to the subterranean parking would be from the alley. Two of the 13 units would be set aside as moderate income affordable units.

Purpose of the Scoping Meeting: The purpose of the scoping meeting is to present the project in a public setting and provide an opportunity for a full airing of the environmental issues that are important to the community. The meeting will include a presentation of the proposal and the environmental issues and alternatives to be analyzed in the EIR will be described. Following the presentation, interested agencies, organizations, and members of the public will be encouraged to present views concerning what environmental issues should be included in the EIR. The oral and written comments made during the scoping meeting will provide an inventory of potential environmental effects of the project to be addressed by the EIR, such as cultural resources, geology and soils, hazards and Hazardous Materials.

The City also invites all interested members of the public to attend the public scoping meeting. The City also invites written comments on issues related to potential environmental impacts. Written comments should be addressed to:

To ensure that the Environmental Impact Report addresses any specific concerns that the public may have comments should be submitted as early as possible, and no later than January 8, 2009, which is 31 days from the date of this notice.

Once the comment period closes, the City will prepare a Draft Environmental Impact Report (DEIR). Once the DEIR is prepared, it will be released for public review and comment. After this comment period, the Planning Commission will hold a public hearing on the EIR and on the Plan. A Notice of availability for the DEIR and for public hearings before the Planning Commission will be released at later dates.

The case file on this project, which includes the plans and applications, is available for public review at the Planning Division, 455 N. Rexford Drive, Beverly Hills, CA 90210. Copies of the checklist of initial environmental issues (initial study) to be addressed by the EIR are also available in the Planning Division at City Hall. ated high school student. This year, he stepped back onto the court as Beverly High's newest walk-on coach for the Normans' junior varsity basketball team.

"Being able to come back and coach at the school I went to is a special feeling," said Abdi, who had been working as an assistant coach for the freshman basketball team for the last two years. Abdi, a recent graduate from USC ,spends his days working at his brother's real estate development company.

This year, he is coaching a group of 12 juniors and sophomores, most of whom he'd coached on the freshman basketball team last year. The team had their first game last Monday night, narrowly losing.

Montage A Smash



To describe the Montage Beverly Hills as "different" would be an abuse of the English language. It defies comparison, but we'll try.

First, a word about our hotel, hospitality "industry." With the opening of the Montage Beverly Hills and voter approval of a new Waldorf Astoria at the Beverly Hilton, Beverly Hills has become the most prestigious venue for luxury hotels in all of Southern California. No Southern California city can compare with what we can now offer.

Hotels do help define cities, but usually that means one or two leading ones, not the five we will soon have. Think the old Fairmont in San Francisco, the original Biltmore in Santa Barbara or the Del in Coronado.

Our first luxury hotel was the Beverly Hills Hotel, the legendary home of the early movie colony leaders that helped make it world famous.

Conrad Hilton entered the market in 1955 when the Hilton brand was still a leader in luxury hotels. Later in that decade, **Hernando Courtright** took control of the Beverly Wilshire, won approval for a new tower addition and reshaped a hotel known previously as a commercial stop over for business travelers into a world class hotel.

The Zarnegin family continued the march to excellence when, after a seven year struggle with the city, it finally won approval of a scaled down Peninsula. However, that world famous name was not in the original scheme and only became the operator after the hotel construction was nearly completed. Its first operating name was the Belvedere, now its fine dining restaurant.

However, what is most significant about all our hotels is the continuing movement to upgrading and improvements. From **Beny Alagem's** vision of a new Waldorf Astoria to the Beverly Wilshire becoming a Four Season and adding a **Wolfgang Puck** restaurant, "Cut," to the remodeling of the Beverly Hills in both public assembly areas and rooms, all our leading hotels have spent enormous sums on upgrades.

What is also difficult is to make any comparison of our leading hotels. They are all very unique with different appeals. Now, enter the Montage Beverly Hills, and some entry it was. Finding the right words to fit the hotel, as we said, isn't easy, nor is a review of the opening night party.

When the Montage first proposed coming to Beverly Hills, it was a very unknown name. But **Alan Fuerstman**, founder and CEO of Montage Hotels and Resorts and **Kim Richards**, president and CEO of the Athens Group, had an exciting vision of what they wanted to bring to our city and they convinced the council they were exactly the right operators for a property that included city owned land. They could point to the magnificent Montage in Laguna Beach as testament to their dedication to excellence.

You know the political history: the hotel plan had to survive a hotly fought opposition referendum, as did the Hilton's condo and Waldorf Astoria proposal, and it too had condominiums. The delays were extremely costly as were the costs of the election.

A major step to fulfilling Fuerstman's and Richard's promises for Beverly Hills was bringing **Ali Kasikci** in as managing director. Clearly, one of the most highly regarded hoteliers in America, Kasikci was exactly the right fit for the Montage Beverly Hills. (See cover interview on page 9).

But last Friday the Montage Beverly Hills finally had its grand, official opening although it had a "soft" unveiling one week earlier.

Now, normally "grand openings" are taken over for prestigious charity fund raisers that absorb much of the costs and assure an "A" guest list. Not the Montage, it presented the party of the decade inviting all those who had something to do with making it possible and were most likely to be part of its continuing appeal for patrons. This meant a "party" for a guest list of 1,000.

It was, to coin a phrase, classy. Avoiding a static, sit down traditional event, it was a movable fiesta with food stations everywhere as guests moved around and through the hotel, culminating in brief comments by its organizers and a beautiful fireworks display. I should mention the outstanding wine selections: BV 2005 Tapestry and 2006 Chalone Estate Chardonay.

The Montage is everything and even more than the developers promised. The exciting public entry areas, the grandly designed restaurants and two smaller private dining areas, the ballroom and many cocktail lounges, the very marvelous roof top pool with a great view of Beverly Hills, and the ultra modern spa, and even the muted colors and art work make it instantly one America's best.

One element of a Kasikci managed hotel is the service level. Staff, and the hotel has a very high ratio of rooms to staff, all reflect his enthusiasm for making visiting and dining world class. From the parking lot attendants to the wait staff, you feel the sense of pride they reflect in their relationship to their patrons and their desire to be friendly, helpful and totally professional. I have visited the hotel four times before and after the opening and could not find anything but marvelous service, and I was looking for problem areas.

In fairness, all of our major hotels have first rate employee services and outstanding general managers including **Offer Nissenbaum** who replaced Ali at the Peninsula. However, there is something very special about the Montage.

The party was black tie except for Wolfgang Puck who arrived in his traditional chef's uniform, coming directly from Spago's just across the street. When Puck spotted us leaving he asked: "Why don't you dress like that when you come to my place?"

Just before the grand opening, the Montage was the site for a very small birthday party for **Betty** (**Mrs. Fred**) **Hayman** with **Lee Iacocoa** as one of the guests and the night after, a family dinner for the 66th wedding anniversary of **Sooky** and **Sam Goldman**.

It was also wonderful to see my predecessor president of the Greystone Foundation and my mentor **Fred Nicholas** at the opening along with the publishers of our community newspapers. In his remarks, Fuerstman acknowledged the work of Athens group's **Jay Newman** in helping win city approval for the project.

I really do hate to rip any new restaurant, the effort to start one is never easy, but two new arrivals in our village need some fine tuning.

Anxious to experience the Luau on Bedford, the successor to some successful and some failed efforts at the same location, I arrived on a very busy Friday night. Now, some restaurants actually think that the success of their first weeks allows them to be somewhat arrogant to patrons you should be happy we can find you a table syndrome - and the Luau was no exception. First, the pirating of the name was hard to swallow, as was the service. We expected at least a nod toward the historic Luau with some token efforts to offer their unique Polynesian fare. Not even close. The menu was clearly upscale, expensive Chinese, dare I use the word, chow.

(Pun intended) Two, not one, hostess at the front desk, were only mildly helpful, but mostly disinterested. As for the server, she delivered a most fascinating rule. We were having cocktails awaiting the arrival of another guest when I asked if we could order some appetizers first.

"No," the wait person said, "you have to

order your main dish at the same time."

As for the cocktail lounge at the new Thompson, the redesigned and upgraded successor to a Best Western and once Holiday Inn on Wilshire, it is, at least in the dining and bar areas, somewhat disappointing. During a recent visit, we asked the hostess if the second level bar area was open. The yes response wasn't exactly true. The bar had been taken over by a film crew, so we had to climb back down the stair case. The bartender, an officious type, demanded a credit card before serving us. There were exactly two other people in the bar making a departure without paying very unlikely and I really don't appreciate having my one, very low limit card floating around. Understandable in a busy club or bar scene, but in a BH restaurant? Not server friendly. My complaint to the same hostess who said the upstairs was functioning was met with a pleasant nod.

Speaking of slightly chaotic openings, the installation of the new president of the Beverly Hills Board of Education Tuesday night, Nooshin Meshkaty, followed a tradition - insult a fellow board member. Last year, when Myra Demeter took over the gavel, her first words were a put down of newly elected board member Steven Fenton. A highly emotional Steven asked that he not be called by his last name, since that could only mean his father, Frank, whom Steven idolizes. Yes, not practical, but not deserving of the immediate response of Demeter who proclaimed that she would be called Dr. Demeter, and that all board members would be called by their last names. A more gentle response was in order.

Now, this year, as the induction wound down with considerable confusion on how to adopt some final year beginning, mandatory resolutions, and Meshkaty proclaiming she did not have an agenda, a stab at colleague Dr. **Brian David Goldberg**.

Goldberg had just completed a very conciliatory speech on board issues when Meshkaty greeted him with: "And I thought my speech was long."

A surprised Goldberg did not respond. Fenton, incidentally, was out of town in Hawaii on business, but the class act, as always, was **Myra Lurie** who graciously shared credit for the success of Measure E although she was clearly the worker bee that made it happen. Demeter did make mention of Lurie, but gave no credit to Goldberg who also gave time and energy to the campaign.

More on this later, but it was historic to have Meshkaty take the gavel. Not only the first Persian woman to hold a leadership position on an elected body in Beverly Hills, but the first Muslim-American, too.

How has the economic downturn impacted the opening of the Montage?

We have little control over the macroeconomic conditions. However, Montage Beverly Hills is a brand new product, in a great location, in the heart of one of the most desirable cities
