

Three City Council candidate forums set

The 11 City Council candidates will have a chance to prove their merits at three candidate forums thrown by Beverly Hills organizations at City Hall this month.

The Southwest Homeowners' Association (SHA) will direct the first forum on Jan. 15. The second forum, thrown by the Beverly Hills Chamber of Commerce, will be held on Jan. 28. The third forum will be on Jan. 29, hosted by the Beverly Hills Municipal League and North Homeowners' Association,

All 11 candidates have confirmed their attendance to the Jan. 15 forum, according to SHA president Ken Goldman.

The SHA will pose questions to the candidates that will frame the debate at the forum. All questions and topics will remain confidential until the debate, according to Goldman. Residents will be allowed to ask questions of the candidates, if time permits.

The SHA, which has held candidate forums for over 25 years, represents 400 homes in the Southwest part of the city. Over half of those homeowners are members of the Association, according to Goldman.

As the Council race continues to heat up, several candidates will hold their respective campaign kick-off parties on Jan. 11 at various spots throughout the city. The times and locations of each reception are listed below, in alphabetical order.

Former Board of Education member Dr. Willie Brien will hold his kick-off reception at 807 N. Linden Dr. from 11 a.m. to 1 p.m.

Councilmember Linda Briskman will hold her kick-off reception between 11:30 a.m. and 1:30 p.m. at 511 N. Sierra Dr.

Mayor Barry Brucker's kick-off reception will be from 12:30 to 2:30 p.m. at 805 N. Roxbury.

Architectural Commission Chair Fran Cohen will hold her kick-off party on Jan. 11 from 1 to 3 p.m. at 519 N. Linden Dr.

IMAX film executive John Mirisch will hold his reception from 2 to 4 p.m. at 622 N. Trenton.

Former Councilmember Richard Stone holds his kick-off party from 1 to 3 p.m. at 805 N. Linden Dr.

Christiansen contractor's license reinstated; Stone's CPA license lapsed

BHUSD's contracted facilities director Karen Christiansen recently renewed her California General Contractor's license, which had been expired since 2005 [See "BHUSD's Christiansen contractor's license expired in 2005" Issue 472].

Christiansen, who oversees the district's construction and management of Measure E bond projects, renewed her individual license on Dec. 10, 2008. It will now expire on Dec. 31, 2010. Christiansen says she passed the licensing exam in 1999.

The BHUSD has charged Christiansen

with heading the construction aspects of the Measure E projects, which will include revamping six school sites as well as creating a 'marquee' project on the Beverly High's lawn.

"My expired licenses were corporate licenses; [I] switched from my individual license years ago. I have been in the process of getting my individual license up and running for months," said Christiansen. "The corporate licenses are still expired and I now hold my individual license again. [My company] Strategic Concepts is an LLC and cannot hold a contractor's license."

The contractor's license permits Christiansen to do general contracting work as an individual.

"It doesn't do anything to change what I do for BHUSD. I only hold the license to show construction knowledge," said Christiansen.

Meanwhile, 2009 City Council candidate Richard A. Stone identifies himself as a Certified Public Accountant (CPA), but Stone's license was cancelled in 1997, according to state records.

Stone was licensed as a CPA in 1952 and held a license until April 30, 1997.

"It doesn't mean I'm not a CPA. It just means that I can't practice right now," said Stone, when asked why he promoted himself as CPA despite his expired license.

But the California Board of Accountancy disagrees.

"If you have a cancelled license, you can no longer call yourself a CPA," said Hilary Barboza, a representative for the California Board of Accountancy, which regulates CPA licenses.

Stone noted that to maintain one's CPA license, one must take continuing education courses and there "just isn't enough time as an attorney, my primary career."

To renew his license, Stone would have to complete 120 hours of continuing education courses, be re-finger-printed and complete an ethics exam. He would not have to repeat the CPA licensing exam again, Barboza said.

BHUSD could benefit from new cyberbullying law

As BHUSD faces charges claiming it unlawfully punished a student who was allegedly "cyber-bullying" a classmate, a bill authorizing school districts for the first time to discipline cyber-bullying between their students successfully passed recently.

Sponsored by Assemblyman Ted Lieu (D-Torrance), Assembly Bill 86 effectively adds cyber-bullying, which includes bullying via electronic means like the Internet or text messaging, to the list of disciplinary codes a school can punish, with suspension or expulsion.

At the BHUSD last year, Beverly Vista principal Erik Warren, vice principal Cherryne Lue-Sang and counselor Janice Hart reportedly disciplined a middle-school girl for posting a video of classmates verbal bashing another student on YouTube. The district and the three staff members now find themselves named in a lawsuit alleging the student's right to free speech was violated. A request for an amendment to an existing Conditional Use Permit (CUP) to allow an increase in the maximum permitted square footage for retail uses within an existing hotel located at **9882 South Santa Monica Drive.**

The existing CUP limits retail uses within the hotel to a maximum of 300 square feet. The hotel proposes to expand its retail uses to approximately 700 square feet, and amend the existing CUP to allow retail uses to be controlled by existing regulations within the Beverly Hills Municipal Code.

law firm representing the plaintiff.

The question at the center of the lawsuit is whether or not the district overstepped its boundaries in disciplining the student for actions that took place off-campus and on the Internet.

At the time, cyber-bullying was not among the list of actions that the school had authority to penalize. The new bill would provide staff with the ability to take action in these scenarios.

Board of Education member Brian Goldberg has requested that the issue be included on the next Board meeting agenda. He said he hopes that the Board will be able to review the bill and draft new policy in accordance with it.





What Makes Nili Run?

And bored about billboards?

Ever wonder what makes people run for our city council? Considering all the abuse we heap on elected officials, why would anyone actually want to serve?

There are eleven candidates, including two incumbents. Three of these I had never met: **Brent C. Lilley, Nili Nathan** and **Abraham C. Ross**. I decided to ask one of them why they were running. It was a very random choice. I actually drew names from an envelope and the unlucky, probably, winner was Nili Nathan.

Ms. Nathan is all over the internet. There are countless references to her on everything from advice on "start up companies" to preparing menus with organic foods. But nothing political, except her new campaign web site.

Along with her campaign manager, Lauren Pizer Mains, we had a fairly far ranging interview this week. Did I get any incisive answer as to what made her

decide to run for city council? Not exactly, her reasons would probably not be very different from those of any of the candidates. She felt she could make a difference.

Nathan did express concern about the political process and what she described as a deterioration of ethics in both the private and public sector.

"Our national economic crisis can be directly attributed to the decline in morality in the financial community and the government leaders we expected to protect the public interest," she said.

How does this relate to Beverly Hills? "I want to make sure that our wonderful city is protected and do my part in my own community to provide honest government services," she said.

I asked if she had any private reasons for running such as obtaining more name recognition or in promoting her various business interests. As expected, her answer was "no, my only interest is in serving the people of Beverly Hills."

So, we moved on to issues. Nathan said she favored the hotel elements but not the height of the condominiums in the Hilton project. If the proposed general plan increases heights anywhere in the city, she would vote to keep present height limits and not agree to any increases "in sizes of new buildings." This puts her at odds with the Planning Commission which has supported some height increases in some areas of the community.

Nathan also expressed concern over the loss of businesses, including automobile dealers. "We need to do more to encourage businesses to remain in our city," she said.

On the other hand, Nathan had high praise for City Manager **Roderick Wood** and "the wonderful people who work at city hall." She did not give the incumbent candidates for city council the same high marks, although none failing grades.

Of all her opponents, she thought Dr. Willie Brien was the most qualified and the best "consensus builder." On a scale of one to five, she rated both Councilmember Linda Briskman and Mayor Brucker as threes, with John Mirisch and Virginia Maas "between two and one." She said she did not know enough about Richard Stone to make a rating.

Nathan had done some good homework on city revenues, but is obviously not a political junkie. She thought 10,000 people had voted in the last election – about seven thousand short, and she felt it would take "around 2,600 votes" for her to win. Maybe, in a very low turnout, but most successful council candidates need 4,000 plus.

A single parent with a child at Beverly Vista, Nathan said she had lived in Beverly Hills for many years, but had only recently moved back. "Mostly because of our schools and outstanding city services, including police and fire," she said. (Nathan has lived outside Beverly Hills for the past six years.)

Nathan came to America when she was only months old, her parents were Israeli, both serving in the army. "My mother actually outranked my father," she said. Nathan has considerable professional experience in finance and held key posts with major banking and other financial institutions.

"I feel my business experience will be very helpful in protecting the city's investments," she explained.

So much for the polite niceties; time for some reality checks.

With no planned kick-off, no fund raising apparatus and no major endorsers, how did she expect to win? "Do you really think you have a chance," I asked. "Even with the best issues and the highest qualifications, you need to explain that to the voters. How are you going to do that

without a reasonable campaign budget?"

Her answer was the same each time I asked the same question in different words: "I will win."

Nathan said she had begun by walking her own neighborhood, where she felt she was receiving "strong support" and she knew the right terminology for targeting residents by acquiring lists of "high propensity voters," those most likely to actually vote.

What the candidate does have is a very savvy campaign consultant who not only knows the community and civic leaders, but has considerable experience in political campaigning. Ms. Mains has worked in many Democratic campaigns, including that of former Governor **Gray Davis** when he first won election. Belying her very youthful appearance, she has also has considerable knowledge about past political community icons such as former state senator **Alan Sieroty** and former Cong. **Anthony Beilenson.**

Serving on the council is not just voting on high profile issues such as the Hilton, but working your way through complicated agendas that are seldom all that interesting, controversial or even attention grabbing. Last Tuesday, as one example, the council plowed through changes in rules permitting elevators in single family residential areas. The council also has to consider expenditures for everything from new fire trucks to landscape consultants. Not the stuff that excites too many political "activists."

We have been very lucky to have some excellent people serve on our city council. Most have given unselfishly of their time and energies. The current concern about councilmember lawyers leaving the council and quickly returning as land use lobbyists is not all that black and white in the morality judgment arena.

First, while they served, they gave up a good part of their lives to city work. Not only losing billable hours, but time away from family. Resuming their legal practices after leaving the council is their right. There is even some city benefit in this. Often, these experienced former councilmembers can and do make land use clients more amenable to realities and not bring to the city projects that are too obviously unacceptable.

While I do favor some of the elements of the recently amended ethics ordinance, there is a negative side effect: Lawyers with very special skills in land use are less likely to want to serve.

Public service and holding political office is not one of highest winners of approval ratings. But there are interesting contradictions. Although opinion polls on members of congress, as one example, were in the low 30 percent before the last election, an overwhelming majority easily won reelection.

As I told Nathan, I respect anyone who is willing to serve and subject themselves to the agonies of an election campaign and the lack of appreciation for those who win and hold office.

However, think of the outstanding community leaders who have never served



and who would have been remarkable members of the council. My short list would include Richard Rosenzweig, Fred Hayman, Sooky Goldman and Bram Goldsmith.

Time for my favorite story about the quality of elected representatives:

In the 1930s, an Indian Nation appealed to Congress for greater control over their own interests, then administered in a somewhat paternalistic and insulting manner by the Department of the Interior's Bureau of Indian Affairs.

The Indians sent a delegation to appear before the appropriate House committee with some mixed results.

At one point the chair of the committee, a Mississippi Congressman and segregationist, told the primary spokesperson for the delegation that although the Indian's made a good argument, and that their representative appeared to be very competent, he was not convinced the "tribe" had the ability or experience needed to "self

govern."

"I am sure your tribe sent a representative who is very smart and a good talker," the Congressman said. "But you are certainly not typical of the rest of your tribe."

"No, you are wrong," the Indian responded. "We never send our best people to Congress"

Trying to actually sort through the city's sign rules and ordinances has proved to be a very formidable task. In fact, after a protest regarding bus stop signage, the city council agreed to take up the sign issue at their next study session.

One of the problems is understanding the language: As defined in Los Angeles, billboards are considerably larger than the signs we now permit at bus stops/shelters. The advertising industry, when it "buys' boards, also defines them as large, outdoor framed installations. Those boards are totally banned in Beverly Hills.

Now, I am not going to spend too much energy defending signs at bus stops.

But classifying them as "billboards" is not logical. The old saw: Oranges and Apples.

As a newspaper person I should hate all forms of outdoor advertising and the reasons are obvious. My first newspaper boss, Telford Work, the first owner of the Los Angeles Daily (Law) Journal once instructed me: "Print any story attacking the legality and worth of billboards," he

A naive me asked why. "Those ugly billboards take dollars away from newsadvertising," he explained. Just maybe that is why there has been so much recent coverage of a court test on the legality of banning boards in various cities and states.

Up or down, the bus sign issue is worth exploring, but keep the arguments rational and don't call those babies billboards.

People notes: On the amend, following surgery for a broken ankle, David Goldman a Beverly High Athletic Alumni Hall of Famer.

Had lunch recently with one our best liked former city officials, Fred Cunningham, who had many titles in city government, including Deputy City Manager. FACES OF LEGACY

BHUSD's new Legacy permit families share their stories

Twelve students entered the BHUSD in September through the new "Legacy" permit program.

Legacy permits allow out-of-district children to attend the BHUSD if the children's grandparents have lived within the city limits for at least 10 years and if at least one parent attended a BHUSD school for at least four years.

When introduced last year, legacy permits were drafted to match newly distributed opportunity permits one-for-one. The BHUSD currently has approximately 1,000 students on permit, over 80 percent of which are 'opportunity' permits given to students who were randomly selected from other districts, mostly LAUSD.

Supporters of the legacy permit program, introduced by Board of Education member Steven Fenton, believe that if the BHUSD needs to supplement enrollment with permits, a number of those permits should go to students who have family living in the city and parental ties to the district.

Legacy permit opponents, including former Board members John Millan and Alissa Roston, believe that favoring a group of students whose parents attended the district is "elitist" and contrary to the mission of public school.

The two most vocal staff opponents, superintendent Kari McVeigh and director of pupil services Dr. Amy Lambert, both left the district earlier this year.

It was property-owning grandparents in Beverly Hills who spoke most passionately in favor of the Legacy permits at the Board meetings. They argued that their property taxes, which the school receives, entitled their grandchildren to the same benefits as children whose parents live in the city limits.

"The intrinsic value we get from having legacy kids here in the district is immeasurable," said Fenton, who believes more grandparents are becoming involved with the district as a result. "We want people here in the district who want to be here."

Since the BHUSD may become a Basic Aid district as soon as this year, it's possible that permits, especially new permits, be drastically reduced or even eliminated

Basic Aid districts, which are funded by local property taxes alone, have very few, if any, permits since the districts receive a lump-sum of funding coming from local property taxes as opposed to per-pupil funding from the state. State-funded schools primarily use permits to generate income for the district.

But legacy permits could soon face the chopping block.

The Board narrowly approved the program by a vote of 3-2, with dissent coming from Board members Dr. Myra Demeter and Brian Goldberg. Goldberg supports the concept but opposed based on last minute changes to the plan by Myra Lurie. Demeter opposes the program entirely. The Board will revisit the topic of Legacy permits at a study session on Jan. 12 to decide whether to continue the program or bring it to an end.

The Dveirins

When Nina Kleinert Dveirin (class of '83) began thinking about her daughters' academic future in Los Angeles Unified School District, she became increasingly nervous with each passing year. Her daughters, fourth-grader Jillian and third-grader Natasha, were attending Westwood Charter School, which offers classes through fifth grade.

"There was nothing wrong at Westwood Charter but I was worried about [my children] having continuity academically and socially. And I wanted them to be challenged in junior high and high school," said Dveirin.

So when Dveirin got notice about the new Legacy permits available, she immediately filled out the paper work for her two girls. Dveirin declined to apply for a permit for her youngest, kindergartener Aidan, because of concerns that he may have to change schools mid-year.

One week into the school year, Jillian got into El Rodeo. A week after that, Natasha was accepted as well.

"Legacy permits are a wonderful program. I've been living in the city [on Swall Drive] since 1969. I've paid my taxes to support the city for a longtime. Before the school district takes any [out-of-district students], we are entitled to send [our grand-kids] to the district," said Simone Kleinert, Dveirin's mother and Jillan, Natasha and Aidan's grandmother.

Simone said she believes that the district should give priority to residents and family of residents who are paying their property taxes before those who do not live in the city. Further, Simone argued, the district should put weight on the applications of families that have a history in the BHUSD.

"Home prices have gone crazy. I don't think it's fair [to penalize] the children. I'm very proud of the system but we should get a dividend to allow our grandchildren to attend the BHUSD," said Simone.

Since Jillian and Natasha started El Rodeo, Nina said that her parents have become active in the school district again.

"They're involved in education issues, including voting and bonds, which maybe they wouldn't [care about] if their grandchildren weren't here," said Dveirin.

Dveirin understands that the permits are a privilege and could be in danger if the district becomes Basic Aid. But even though Dveirin isn't paying property taxes to the district, she feels her mother's property taxes and her involvement in the school count outweigh the fiscal burden.

"I'm incredibly grateful for the [Legacy permits] and I do feel like I contribute," said Dveirin, who was school president as a BHUSD student and is currently on the PTA and involved with other school projects. "The modular schedule at Beverly High, where we got out at 1 [p.m.] prepared me for college. The friends I made in elementary school are still my friends today. I want my kids to have that."

The Brooks

The Brooks live on Maybrook only three houses away from El Rodeo School. In fact, they can even see it from their front yard.

Parents Sara Furie Brooks and Ivan Brooks both grew up in Beverly Hills. Ivan (class of '84) and his five siblings attended Hawthorne School and Beverly High. Sara, who attended Westlake School (now Harvard-Westlake), had

six family members graduate from Beverly High: her five brothers and mother.

"We're a family that has deep ties to the [BHUSD]," said Sara.

So when their first daughter Amanda was preparing to enter kindergarten two years ago, the couple applied for and received an 'opportunity' permit for her to

attend El Rodeo.

This school year, their second daughter Elizabeth entered kindergarten. Since the girls' grandparents live in Beverly Hills city limits and Ivan had attended the BHUSD, Elizabeth's application for a Legacy permit was granted 10 days into the beginning of her kindergarten year.

"I'm so grateful [for the Legacy permits]. It's important for sisters to go to the same school. When [Elizabeth] got in, it was great," said Sara.

Now that her granddaughters attend the BHUSD, grandmother Rochelle Brooks, like the Kleinerts, has taken a renewed interest in the school district. She says she has been attending El Rodeo events and taking a close look at district voting issues, like the Measure E bond.

"I put six kids through the Beverly Hills schools. I pay property taxes. Two of my kids live in Beverly Hills, and pay taxes, but their kids are in private [parochial] schools. So I think kids [like my granddaughters] deserve to attend," said Rochelle.

The advantage that Legacy permits provide to the school district, Sara and Rochelle both explained, is that the ties those children and families feel to Beverly Hills provide an emotional connection.

For Sara, the schools represent a family tradition and a bridge between the generations. For others who have no family history with the BHUSD, the schools might simply just be schools.

Ivan is on the Board of Directors for the Athletic Alumni Association at Beverly High. Sara said that if a teacher or administrator asks her for help or to buy supplies, she immediately says yes. Sara's been able to collect dozens of donations from local businesses and families for the school based on her deep roots in the city.

"It's so hard to split your kids up at public schools because public schools need so much from parents. I'd rather have both my kids at one school so I can give my time

and money to one place," said Sara, who was worried about not being able to make it both of her children's events at different schools

The Brooks have a 3 year old son, Brandon, who will enter Kindergarten in 2010. They hope that he too will have the opportunity to help carry on the family legacy.

The Gellers

Longtime Walden Drive

resident Anne Geller attended El Rodeo before graduating from Beverly High in 1955. Her sons, Jordan (class of '87) and Bruce (class of '83), attended El Rodeo and Beverly High.

This year, Jordan and Bruce have had the chance to see their very own children walk through the doors of a BHUSD school. It's happened thanks to the Legacy permits

Bruce's son kindergartener Tommy Geller was the first student chosen in the Legacy permit program. He entered Horace Mann this year. Bruce's other son, fourth-grader Zachary, also received a Legacy permit to attend Hawthorne this year.

Jordan and his wife Brandi Williams (class of '91) met in the late 1980s. Both

Jordan and his wife Brandi Williams (class of '91) met in the late 1980s. Both grew up in Beverly Hills.

"We wanted our kids to have the same education and experiences as we did," said Brandi Geller, who recalled the close friendship she built during her years at BHUSD that she still holds today. "We could send them to private school, but we believe in this school district."

Brandi's oldest daughter, 5-year-old Caroline, started kindergarten at El Rodeo in September with a Legacy permit. One of Brandi's biggest draws to the BHUSD is the feeling of community it provides. Most of the students in Caroline's class at El Rodeo live nearby and eventually Caroline may even be able to ride her bike to school.

Brandi said the family spends most of their time in Beverly Hills; Jordan has his office in Beverly Hills. The couple has put their Beverlywood house on the market and are looking for a home in Beverly Hills.

"But in this economy, it's not the best time to be selling your home and then trying to buy one in Beverly Hills," said Brandi.

Brandi said she worries about finding a home in Beverly Hills quickly in case the permits won't be renewed or she won't be able to obtain a permit for her other daughter, 2-year-old Amanda, when she enters kindergarten.

But Brandi and the children's grandparents are pleased with Legacy permit program

"The fact that we are paying [property] taxes like everybody else, it certainly feels better to know [my grandchildren will] benefit from it. Now, voting for the [school] bond felt good," said Dr. Paul Geller, grandfather of the three Geller children on Legacy permits in the BHUSD. "These days, the grandparents are the only ones who can help people out. Young people can't afford these homes [in Beverly Hills] now. We can help out emotionally and financially."

The Legacy permit program has allowed the Geller children to begin their educational careers in the school district that their parents hope they will graduate from.

"We have three grandchildren at three different schools [in the BHUSD]. So we know the permits depend on how many spots are available in the district [after residents enroll],"said Anne Geller, who had hoped all the grandchildren could attend the same school. "I'm still 1,000 percent enthusiastic."

"I'm hoping I didn't discourage my team," Rappaport said. "I think I gave them a schedule that wasn't fair. I gave them too many Division I teams, given we're a Division IV school.

"I just put us over our heads a lot. I'm hoping that it turned out to be a great education experience, rather than discouraging them now that we're going to start playing teams in our own division."
