Farewells and new beginnings for the City Council

Distinguished professionals, residents, family and friends filled the Samuel Goldwyn Theater of the Academy of Motion Picture Arts and Sciences Tuesday night at the City Council and City Treasurer community installation ceremony (see photo page 2).

Beginning with a rendition of "God Bless America" by City Clerk Byron Pope, the night was filled with laughter, some tears, and hope.

Former California Governor Gray Davis (1998-2003) was also in attendance.

Retiring councilmembers Frank Fenton and Linda Briskman were honored for their years of work on the council. Fenton presented his farewell speech in a short comedic video.

Briskman spoke of the "tabloids of a cross-town bully," and said, "My work in Sacramento, Washington D.C. and this community has spoken for itself."

Briskman also thanked former Mayor Vicki Reynolds, her mentor.

Re-elected councilmember Barry Brucker "improv-ed" through technical difficulties and reflected his year as Mayor with a film of significant achievements of the city over the past year.

John Mirisch emphasized the importance of the voice of residents, and how he himself, was "Joe Beverly Hills." He then added a monologue in his best Jimmy Stewart impression, from the well known movie, Mr. Smith Goes to Washington.

Mirisch, who became a citizen of Sweden during the 20 years he was in Europe, acknowledged Consul General Ersman in Swedish.

"Yes, it's true: I'm the first American-Swedish Councilmember in the history of our City. I'm also the first City Councilmember to live East of Wetherly, the first fourth generation Beverly Hills resident to serve on the Council and the first councilmember whose parents also graduated from BHUSD schools," said Mirisch.

He added, "I'm also the only registered Republican on the council. I'm the only member who lives South of Santa Monica, and while I look forward to representing the entire City, I'll make sure that the South's voice is not forgotten. I'm the only councilmember with a small child."

Mirisch promised to represent and speak for the people of Beverly Hills and passionately closed his speech by saying, "This is our town, and nobody better ever forget it. This is our town, and we have

no intention of giving it back or giving it away. And this is your City Council, and we, the residents of BH, are going to be the ones to decide about our own City, and to do our best together to protect, preserve and improve our home, no matter what problems or challenges we face. We are the solution.

Dr. Willie Brien also took the stage and spoke of his vision for city improvements. He stated his plans to improve traffic, create health seminars for Beverly

Hills residents, and enhance inner city transportation for seniors.

"I pledge to work to review and assess the budget and make sure that the money of tax payers is being allocated and spent responsibly," said Brien.

Brien also stressed the need to work on the General Plan, and his intention to create a summer internship program, in which students learn the fundamentals of working for City Government.

Maccabi event raises \$10,000 for Jewish athletes

New data shows opportunity permits are overwhelmingly Caucasian

Permit demographic data for the current BHUSD students shows 72 percent of opportunity permit students are White (non-Hispanic).

The Board of Education received the information from the district administration last week.

Although the long and heated debate over permit students has come to an end for now, new information contradicts a key argument from the permit-supporting side.

Guidelines for the inter-district policy also include meeting BHUSD's four behavior criteria and clearly state that the permit may be revoked at any time.

State Education code requires the school district to have information such as this demographic data available.

The controversial issue came to a decision made by the school board March 11, to continue approving permits on a yearto-year basis, along with other terms and conditions.

"This data would have been helpful months ago when I originally requested it. It shouldn't have taken so long to receive this information. It would have been more useful during the discussion on reducing the number of opportunity permits" said Board of Education member Dr. Brian Goldberg. "It is useful now so people can see that racism isn't the issue, but the damage to our City's reputation has already been done."

Supporters of permits argued that those opposed to keeping opportunity permit students were taking part in a discriminatory and potentially racist act. However the data contradicts this opinion.

Of the 579 students enrolled with an opportunity permit, 418 are White (non-Hispanic). African American opportunity students are the second highest ethnicity enrolled at ten percent. The next category of students are Hispanic/Latin, which make up 7 seven percent.

117 Diversity permit students include 40 Korean, 24 African American, and 14 Hispanic/Latino students for the majority.

Although District and City permits were not a part of the debate, demographic data shows approximately half of the 89 district employee permits are ethnic. Of the 19 City employee permits, seven are White (non-Hispanic) students.

This data suggests that eliminating opportunity permits would actually increase diversity, rather than against discriminate students.

Since permits are on a year-to-year basis, this topic will rise again. School board members will continue to have discussions on permits in the future.

"My hope is that this data will put to rest once and for all that lowering opportunity permits is not racist," said Goldberg.

Comment from school board member Myra Lurie was not received by press time.

Museum of Tolerance expansion approved

The Los Angeles Planning Commission is moving forward with an expansion, creating a new banquet and reception venue at the Museum of Tolerance.

The expansion could affect neighboring Beverly Hills homes.

Steve Dahlerbruch, president of Beverly-Roxbury Homeowners Association, believes the expansion would create more traffic in addition to the bus staging and employee parking.

According to Dahlerbruch, the Beverly-Roxbury Homeowners association and the Beverly Hills planning department teamed up to address traffic issues that would arise in the area, especially on Beverwil and Roxbury.

"The questions were addressed to the point where they were asked to work with the office of [LA] councilman Jack Weiss to resolve those questions. Although they were addressed by the commission, they were not included in the commission hearing," said Dahlerbruch.

The museum was approved to hold 18 "third-party" events each month until 10 PM, with a maximum of 500 guests at each event.

"I am disappointed by the Los Angeles planning commission. They are allowing too many events per month. There will be much more traffic in our area and heavy usage from third parties will impact Beverly Hills," said Dahlerbruch. Susan Gans, a Los Angeles resident,

Beverly High Alumni Association inducts 2009 Hall of Fame members

The Alumni Association ceremony inducted four individuals for 2009: Loretta Isaacs Weinberg, Herbert Katz, Don Davies, and Lynn Stalmaster.

New Jersey state senator Loretta Isaacs Weinberg graduated from Beverly in 1952. Since elected in 2005, Weinberg has served on the Senate Health Committee and Senate State Government Committee. From 1975 to 1985, Loretta served as the Assistant Administrator to the County of Bergen, and was a member of the Teaneck City Council from 1990 to 1994. She was elected to the New Jersey General Assembly in 1992. Her award was accepted by her brother Carl Issacs, Beverly Class of '49.

Former Santa Monica Mayor Herbert Katz, served on several commissions in the City of Santa Monica, and was one of the co-founders of the Third St. Promenade. Katz, who passed away this January, served on Santa Monica City Council from 1984-1992, and 2000-2007. Katz served one term as Mayor from 2007-2008, and was re-elected to City Council 2008. He graduated from Beverly in 1948. Katz's award was accepted by his daughter Dana Wood.

Prominent educator Don Davies, Class of '44, is an international teacher and has received numerous awards in the field of education. He also served as Executive Secretary of the National Commission on Teacher Education and Professional Ethics. Prior to receiving his PhD from Columbia University, Davies taught journalism for four years at Beverly and was faculty advisor to the Highlights. Davies' classmate Stewart Tinsman accepted his award.

Lynn Stalmaster, Class of '45, is a veteran casting director who has over 50 years of experience working with the top of the entertainment industry. After college, Stalmaster opened an independent motion picture and TV casting office, and worked with many directors, including John Huston, Stanley Kramer, and Robert Wise. His casting credits include over 400 productions such as Fiddler on the Roof, Superman, Deliverance, Jeremiah Johnson, and Roots, for which he received a special award from the Academy of Television Arts and Science.

BHHS Girls' Basketball, Soccer Players Receive All-Southern Section Honors

Top-ranked Normans boys' tennis team defeats thirdranked Santa Monica.

Beverly High sophomore power forward Morgan Mason was a first-team selection for the Southern Section girls' basketball All-Division II-A team, while teammates Miranda Abdul-Mansour and Javonna Young were named to the second team and John Braddell shared coach of the year honors.

Mason averaged 16 points and 6.6 rebounds per game, Abdul-Mansour, a junior forward, 10.2 points and 6.2 rebounds, and Young, a senior center, 9.7 points, 9.8 rebounds and 2 blocked shots helping the Normans to a 24-10 record and the team's first berth in a Southern Section championship game.

Braddell shared the coach of the year award with Kevin Kiernan, who guided Santa Ana Mater Dei to the division championship.

Girls' Soccer

Beverly High senior forward Emily Litvak was a first-team selection to the Southern All-Division III team, while Norman goalkeeper Rebecca Gold, also a senior, was a third-team selection.

Litvak had 26 goals and 11 assists. Gold had a 0.88 goals against average and 10 shutouts, helping to the Normans to a 12-8-2 record and a second-place finish in the Ocean League.

Change Of The Guard

Fun and games at city induction By Rudy Cole

Usually, one meeting is sufficient to induct torium three times a year. Krasne chose the a new mayor, vice mayor and newly elected councilmembers, but this year it took two council sessions to make the transition with a first ever ceremonial event outside a government facility.

Talk about change! Well, maybe not all that significant, but it was interesting. For the record, the actual, legal oath taking by Mayor Nancy Krasne, Vice Mayor Jimmy Delshad and just elected members Dr. Willie Brien and John Mirisch and reelected Barry Brucker took place last week at a brief formal meeting at the usual venue: city council chambers at city hall. (This "legal" meeting was necessary to comply with datelines for taking office.)

Tuesday the act moved to the Samuel Goldwyn Theatre at the Academy of Motion Picture Arts and Sciences with the same cast of elected officials, but with a far different oath giving crew.

According to Mayor Krasne, the city was able to take advantage of an agreement with the Academy permitting city use of the audivenue because she felt it would save the city money: No costly tent to house the usually large attendance and no street closings that inconvenienced both residents and businesses.

For the record, the agreement with the Academy to provide free use of their auditorium was because the Oscar organization received exceptions to providing code required parking when their structure won council approval.

Not the best deal for neighbors, despite some permit parking restrictions. Tuesday's event also found countless parking enforcement officers all over adjoining streets advising those attending events that they should use neighboring free parking.

The theatre setting did seem appropriate. There was high drama, some unintentional humor and one or two good one liners by your elected officials.

As for those watching at home, the audio of some of the speeches had glitches. No comment on whether this was good or bad.

Historically, how the change of mayor council meetings has evolved into major events is hard to trace. Until the 1970s, new mayors, if they did anything, invited a few friends to their homes for very private receptions, most simply took the oath. The next step was an invitation only event outside the council chambers, but when Dr. Charles Aronberg was inducted he opened the party to the whole city. Unlike current practices, Dr. Aronberg's post swearing in party was not at tax payers expense.

So, what does all this mean for the city? Will there be drastic changes in city government? Generally, this new council has two members who have been opposed to major new developments, Krasne and John Mirisch, one with a mixed voting record, Brucker – he opposed the Hilton and backed the Montage, Jimmy Delshad who supported both and Dr. Brien who has no absolute position on development issues.

Mirisch and Dr. Brien replaced Councilmembers and former mayors Linda Briskman and Frank Fenton, both of whom voted for the Hilton and the Montage. In this sense, this is a very important change in city government.

However, it is very unlikely this council will have any decisions to make on projects as large or significant as either the Hilton and the Montage, or 9900 Wilshire and William Morris, in the next few years. They will, hopefully, complete work on a new general plan, but the more pressing challenges will be continuing first rate city services in the face of declining tax revenues.

Mayor Krasne made a special point of wanting to "return" to two hour free parking at all city lots and not just some of those that were approved last year. Certainly, a very popular move with both residents and merchants, but it does mean less money for making very necessary repairs in our parking structures and have any buildings had worse designs?

Krasne got off one of the best lines of the evening: "I want to thank the Academy, what every young woman hoped to say once in her life." Mirisch did point out his history making moment. Because he spent much of his adult life in Sweden, he became a citizen of that

country, now holding dual citizenship. He clearly has the honor of being the first Swedish citizen to serve on our council and he gave a Swedish greeting to his Consul General who attended the event.

Do the new councilmembers and mayor really have a clear mandate from the voters to make drastic changes in policies and programs? Yes and no. Clearly, there is an attitude in the community, even among those who backed the Hilton and the Montage, that the city needs a breather from more massive development projects; at least the process should permit the completion of the general plan to be in place first. However, there are developments not nearly as large in scope that are in the pipeline that should not be side tracked but judged on their own merits. We have too many ugly sections in the business district not to encourage rational and responsible improvements.

But back to the voter mandate question. Several speakers said "we have to listen to the voters." Well, if they spoke about the candidates, it was with a whisper and not a roar. Seventy percent of eligible voters didn't bother to cast a ballot in the last election. This could mean they are not that unhappy with the incumbents or so turned off they refused to even vote. But winning with about 10 percent of the total possible vote does not exactly reach the level of "mandate."

Also, proclaiming that the voters have expressed their opposition to major developments and "sent a message to the council" is not borne out by the numbers. Although it was not a landslide in either case, the voters did approve both the Hilton and the Montage. Some 7,972 electors marked their ballots for the Hilton and 2,272 voted for Mirisch this time and 2,710 for Krasne when she won in 2007. Yes, the larger votes came during a national not local election, but they were real just the same. Incidentally, although Linda Briskman lost this time, she too almost doubled the votes received by Dr. Brien and Mirisch when she ran for a second term in 2005.

Voter revolts? Strong mandates for drastic change? Not quite, but the winners in any election, including Beverly Hills, have a right and even an obligation to be both responsive but also responsible. Reality and not revolutions are what most voters expect and they know all too well that change for the sake of keeping the more zealous backers of their campaigns happy, should not mean disrupting

a city government of highly skilled professionals that make this one of the safest, best managed cities in the world.

We know Dr. Brien well. He has lived here all his life, served with distinction on our school board, is chief of staff of our leading hospital, Cedars-Sinai. We also know Mayor Krasne very well. She had been a member of two city commissions, a strong supporter of local educational and other city cultural and charitable needs and, although at times very volatile, tries to do what is right and fair. Councilmembers, and both former mayors Barry Brucker and Jimmy Delshad, are also very familiar public servants even though they take different approaches to issue solving. Both will be stabilizing influences for the new council.

The far less known of the five is Mirisch. He does have strong family ties to our community, but has only returned to Beverly Hills since 2007 with a 20 year absence in Europe, mostly in Sweden where he worked in the entertainment industry – something his family did here with great success.

"It may well depend on how that intervention period is utilized. If it's a fullfledged class with consequences for the students not doing what they're supposed to, that's a whole other set of duties," said Bushee.

"I have learned that by providing my students with the additional support of the Reading Plus class, while they continue to participate in the regular English class is a highly effective form of intervention," wrote Bauer.

Nancy Krasne discusses her vision for the city By Diana Vu

Mayor Nancy Krasne was installed Tuesday at The Academy of Motion Picture Arts and Sciences. With a new year ahead of her, Krasne talks with the Weekly about her family and what she sees for the future of Beverly Hills.

What is it like to mayor of Beverly Hills?

Very busy. I never realized the demand that would be put on me. There are five things to do every minute. I go from one thing to the next with phone calls and important things to take care of.

I work for the people of this community, I'm their employee and there's always something to be resolved. I take it seriously, and I don't want to be a bad employee. I'm going to be the best employee I can be for this community.

Whether I'm a Mayor or councilmember, I'm going to do the best job that I can. Therefore, getting problems resolved and helping people find solutions is my goal.

What are your priorities for this year?

First, I really want to bring back free parking. I think it's critical to stay competitive with neighboring cities and have people rediscover Beverly Hills. There are so many things going on in the city.

For instance, you can see millions of dollars worth of art in Neiman Marcus without paying a museum fee. When you first walk in there is the Mariposa sculpture. Most people just walk by without even noticing it. There is fabulous first-class artwork throughout the store.

What I would like for people to do is take advantage of this. Economic times are bad, and if you don't have the money, you can do all of these things. I want people to see these things, and enjoy the city. It's a great environment for the family. We need our two-hour free parking to do that.

The second thing I want is our infrastructure fixed. That means the water pipes, our electrical lines, and our sidewalks. It has to be repaired. We need to renovate and have everything state of the art.

Before we start building new buildings, before we're getting carried away, we need to fix what we have first. We have to be on top of what we have. I think that it's critical and important. And while were doing that, it'll work. We'll have a new water system up with Coldwater Canon Reservoir; I think all of these things will make for a fabulous environment and a great residential and business community. A safe place for people to live.

Another thing is, I'd like to see our General Plan finished. I want to see an achievable traffic mitigation plan. I'd like to see the General Plan worked on this year. We've been working on it since 2000, enough already. It's time to finish it, get it done, and put this one to rest.

I think all of these things are achievable.

When will the council start to look at revising the General Plan?

Immediately. There shouldn't be any new proposals going on until the General Plan is addressed. You can't plan for something and work around the General Plan. I don't like zoning around. So, if you put the plan in place, then everything falls into place in an orderly fashion. Otherwise, you're always "making-do," "making it work" kind of thing. I like an orderly process.

Once a school teacher, always a school teacher. You can't teach multiplication before you teach addition. Because multiplication is really a success of addition. That's how I work.

Speaking of being a teacher, in what other ways has being a teacher influenced your position as Mayor?

Even though I do not tread over school territory, I watch over the schools like a mother watches over her children. Even though I do not say anything to the schools, I am there to protect the schools and this community.

It's my responsibility to ensure that the schools stay vibrant and healthy. It's my responsibility to make sure any funding we can give to them, they get. I will do whatever I can to be supportive of the school district without interfering.

What responsibilities does the mayor have that other councilmembers don't have?

Speaking on behalf of the council, the city, and all its constituents is different now. I represent the community, I must be poised and gracious and watch what I'm doing. I certainly do not want to offend anyone or omit anyone.

In other words, I don't want to say ladies and gentlemen, and forget to say children if they're

in the audience. You have to be conscious of everyone there and know who you're speaking to so that you don't forget or neglect someone. As a councilmember, you're speaking and representing the whole city at functions and special events, on a day-to-day basis. Even though your job description is the same, it's not quite the same.

What responsibilities does the mayor have that the city manager doesn't have?

The entire council basically sets the policy for the city. The City Manager runs the city. We [City Council] set the policy, the City Manager implements it. And the city staff works for the City Manager, not the City Council.

Tell us about your new plan for spotlighting Beverly Hills' businesses.

I'm not going to spotlight just businesses. I look at Beverly Hills as where the world meets. I would like to implement a plan called "The Heart of Beverly Hills," and this program will highlight outstanding residents, professionals, public service employees, and businesses. All of those components make it unique. Without any one of those parts, it doesn't cut it.

Each week I'd like to point someone out, for instance, Dr. [Emanuel] Wasserman, the orthodontist, finds people throughout the world, and he helps reconstruct their jaws. An oral surgeon will come in and reconstruct them physically, and he donates his time and reconstructs their teeth. He is just phenomenal.

That's the thing about this city, it happens everyday. There will be no spotlight on them, but they just give. People look at Beverly Hills and they think that we just take – we don't. We are a very caring and giving city. Look at the [Police] Department's Black and White Ball, or the Backdraft Ball, our merchants just give and give and give.

My feeling is I support the merchants who support the city.

How exactly will you highlight these individuals as part of your "Heart of Beverly Hills" program?

I'd like to have them come in and talk to us about what they do. What better way to support them than by giving them the recognition that they so rightly deserve by the council? I can see giving them lunch or a gift basket, and just special recognition.

These people have supported us through this time of a recession and economic meltdown. What better way can we help them, by supporting them? This is time to live, play, shop, enjoy your life, and stay in Beverly Hills.

That's my philosophy on that topic and that's what I intend to do.

Should the Montage Lot be two hour free parking?

I think the community felt it was going to be free parking. When it was the "T" Lot, it was always free. And when the Montage [Hotel] came into existence, I think the community still thought it would be free. And it didn't. Councilmember [Linda] Briskman said it was always meant to be a paid lot.

In fact, I was down there yesterday, and the Montage lot sits empty. There are maybe 40-50 cars in the paid area. The entire lot is basically empty. It costs the city the same whether it's empty or full. Therefore, why not open it up to free parking? Why should the city have it that way? I want to put that in light instantly, and bring back parking to Beverly Hills and encourage shoppers to come.

I'd also like to see some parking moved from the South Beverly lot up to the Montage lot, as far as the monthly parking. So we can free up the South Beverly lot for residents who want to go shopping. That happens to be my personal opinion; I don't know how the rest of the council feels.

Tell us about the two new councilmembers John Mirisch and Willie Brien.

I know it sounds funny, but I stay out of the council race. I don't endorse other people that are running. I don't believe in endorsing. I support everyone and try to keep the playing field level. I think everyone should have an equal shot of being elected. It's up to the people of the community to decide who will serve the best.

As for John [Mirisch] and Willie [Brien], I think that they will serve incredibly well, and Councilmember [Barry] Brucker has been a great colleague. I really enjoy serving with all of them.

I think it's a well balanced council, but like I said, I'm one of five. We're probably going to have heated discussions, differing discussions, because reasonable people will differ. On the other hand, I don't know what the outcome would be, because if we did, we wouldn't need a council.

It remains to be seen. That's what makes this country great, and that's what makes this city great.

The true test will be when I start looking at the voter fraud issue. It's a real touchy one. I think it's time to look at the way we're voting. It's time to say, we have a problem, and we need to look at this.

In a city where you only have 21,000 or so voters, and a few votes can change the entire outcome of an election, it's appropriate. It's ok to say "enough". We need identification for municipality elections. Or at least test the law. I don't know what will happen, but I'd like to see where it goes.

Under the Patriot Act, you need an ID to get on an airplane, why shouldn't you need for one of your most important rights? To vote.

How does your husband Jim feel about you serving on the Council?

He's really proud. And his parents were long time residents. They lived here in Beverly Hills, they were in their late nineties when they passed. They would be so thrilled. What's funny is Jim just calls himself "Mr. Nancy," because all these years I've been "Mrs. James". We've been married like 45 years, he just laughs and thinks it's amusing, but he's so proud.

Tell us about your children

I have two boys. Kevin Allan is 38, he graduated from Beverly High ['89], and he's actually moving to Pittsburgh. My other son, David Joseph is at Columbia getting his MBA.

What lessons have you learned from previ-

ous mayors that you will use for your term? There are so many. Every previous mayor has taught me something. There isn't a day that goes by that I don't learn something new.

[Former Mayor] Tom Levyn taught me the best thing of all. He taught me one word, and I think it's one that will carry me through my year and my entire life. And that word is respect. He said always be respectful. No matter who you're talking to, be respectful. It's true. Be respectful, and it always works out.
