Goldberg launches flyer to recruit BHUSD families

Board of Education member Brian Goldberg launched a 10,000 flyer distribution campaign in an effort to attract and retain Beverly Hills student enrollment

earlier this month, which has gained support from Beverly Hills residents.

Beverly Hills resident Lee Lewis, parent of three children attending Beverly Vista, said he supports Goldberg's proposal.

"It's really great, and I really wish it would have come a lot sooner," said Lewis. "I'm glad he's fighting. It was voted on, the board members are behind it, and he paid for it himself. He did what they were supporting, so there is no issue."

Bob Sternsheim, who has two daughters attending Horace Mann, also thinks the flyers should have been released earlier.

"We need to be more proactive and make our schools more community based again. We should do more flyers and maybe even mailers," said Sternsheim. "Whether [Goldberg] did it himself or not is not the issue, he's looking at the big picture. He's getting out there and making things happen. We need to get the community and more businesses involved."

The flyer, distributed by "The Committee to Attract and Retain Resident Students", highlights the Beverly Hills Education Foundation's Ambassador Parent Program and the June 30 deadline for placement at a home school.

Board of Education member Myra Lurie said she received a number of calls and comments from residents who assumed the flyer was distributed at the discretion of the dis-

trict.

"While I completely agree with its message encouraging residents to enroll in our schools, this flyer was put out under the name of an unknown organization which failed to contact either the BHUSD or BHEF before using their names and contact information," said Lurie. "As a board member, I believe that our work is most effective and well respected when conducted in an open, transparent, and thoughtful manner that reflects teamwork and the pursuit of our joint goals."

Goldberg said he has not received a negative email or phone call in regards to this issue.

"BHUSD and the Board were repeatedly asked by me about any plans to market the Ambassador Parent Program and inform the community about early resident enrollment and our new deadline for guaranteeing resident enrollment at their home school. I was told repeatedly by the district that there was no money. It is one thing to say you support a policy and another to actually support it. Actions will always speak louder than words," said Goldberg. "I pushed to have this as part of our district goals, I was not going to let it fail. I also feel strongly that this is the perfect opportunity for us to market ourselves to residents who have chosen to send their kids to private schools to take another look at our public schools and come back to BHUSD."

Santa Monica-Malibu Unified School District adopts their own version of Legacy Permit Program

The Santa Monica-Malibu school board unanimously approved a permit policy giving priority to children of alumni last Thursday.

The policy, which will go into effect in the upcoming school year, will not increase the number of permits, but will give priority to

students whose parents graduated from the district.

Unlike the Beverly Hills Legacy permit, the SM-MUSD policy does not include grandparents. In Beverly Hills, Legacy permits are available for students who will attend grades K-8 and have both a parent who attended the Beverly Hills Unified School District for a minimum of four years and a grandparent who currently resides within the district boundaries for a minimum period of ten years.

Santa Monica-Malibu school board member Ben Allen said the additional requirement might create more difficulty in their district.

"It would have added a whole other layer of complication in terms of proof. And there were some concerns of staff that it might add a bureaucratic burden. Since there was a willingness to just do alumni, we figured it would be easier to keep it that way," said Allen. "We could have been more restrictive, but this way, all we need to do is verify the transcripts. That being said, I am very interested in the grandparent component of this, I'm going to look into it for next year."

Board of Education member Steven Fenton said he is glad other districts are adopting the Legacy Permit.

"I hope that they will include a grandparent component in the future as well," said Fenton. "I'm excited they have established it, and it's definitely a foot in the door."

According to Allen, the SM-MUSD school board understood the need for the policy as soon as he presented it. Allen said the economy was a major factor in the board's determination.

"The fact that a lot of younger people are getting priced out, but still have a tangible connection with the city, and their parents are still in the city was an issue. All that made a lot of sense to my board members, so

it didn't end up being as controversial," said Allen.

While not controversial in Santa Monica-Malibu, the issue was debated in Beverly Hills for several months until the school board came to an agreement.

"I'm still trying to understand why the issue is so controversial in Beverly Hills. For us in Santa Monica, it was really a question of logistics. It didn't become a big drawn out battle with people screaming at the school board," said Allen. "We took a look at the legacy permits, and we looked at what made sense for us and we moved forward with it."

Allen also said there is a big difference between the school districts: basic aid.

"At the end of the day, the majority of our money comes from our ADA funds from the state. At some point, the district had a policy where we recruited inter-district permit kids to Santa Monica schools, but we realized that was a mistake," said Allen.

"If Beverly Hills does go into Basic Aid, there comes a financial incentive to cut inter-district permits that we don't quite have. I can understand in that, where there was tension with the board. I can understand pulling back a little bit."

Mirisch raises issue of overtime at City Council Budget Study Session

The Beverly Hills City Council met Tuesday to discuss and review the city budget, financial projections, and possible cuts for various departments. Recreation & Parks, Information Technologies, and Community Development were a few of the departments who presented information and recommendations for the council to consider.

In addition to department cuts, Councilmember John Mirisch raised the issue of reducing overtime.

“One of the major issues that were discussed, and I certainly brought it up, was the issue of getting rid of overtime. Overtime is a tremendous expense and if we can eliminate that, it’s a good thing,” said Mirisch. “In looking at cuts, we addressed the issue, and hopefully we’ll be getting a schedule of what is spent year by year in overtime. I expect we’ll save a significant amount.”

The study session is part of several scheduled sessions through the month of May. City Manager Rod Wood said the City projects a budget shortfall of approximately \$18 million due to recessionary impacts compared to last year at Tuesday’s meeting.

“The community will surely feel a shift in service level as a result of the impact of the cuts,” said Wood. “Public safety and other core departments will not be affected, but many attentions to detail, and always having people available, will be affected by the changes.”

Animal control policy unclear

Upon finding a dead cat on the street of her Spalding Drive home, Barbara Cohen is unhappy with the “confusing and unorganized treatment” she received.

According to Cohen, she immediately called the Beverly Hills police department non-emergency line and found out she needed to call Los Angeles County Animal Control. Cohen said she was told numerous times by LA County that the process could take up to 72 hours.

The City of Beverly Hills recently announced a contract with the City of Los Angeles Animal Services Department in February 2009.

The partnership provides animal licensing, shelter and care services, but does not remove dead animals or trap wildlife.

George Chavez, City Building Official who oversees the code enforcement division which handles animal related inquiries, said Beverly Hills will be working with an outside company to help with removal of dead animals in the next month. Currently, Beverly Hills is working with the county of Los Angeles for the removal of dead animals.

“The reason we are transitioning at this time is to improve and change the level of service,” said Chavez.

Chavez did not provide an exact time frame, and said each situation is different.

“The situation depends on the time of the day for example, but our goal is to take care of the animals immediately,” said Chavez.

Stacy Mungo, liason of administrative services at LA County said the time frame depends on the priority level.

“A deceased animal is a level three, where an attack in progress is a one. Our target average is 24 hours, but it also depends on other factors such as location, number of officers, and priority level,” said Mungo.

Cohen said the animal was left overnight and was concerned about health and safety hazards.

“Someone was walking their dog outside, and almost got hit when a car swirved to get

around the dead cat,” Cohen said. “This is Beverly Hills, the fact that there was a dead animal on the street overnight and no one was here to help for so long is disappointing.”

Trousdale neighbors feud over trees

A view protection ordinance is in the works after several Trousdale residents brought recent concerns to the City Council’s attention.

After attempts to negotiate with neighbors, members of the Trousdale Homeowner’s Association said it was time for the City to step in and mediate the problem of blocked scenic views of Trousdale residents and appeared before council at last Tuesday’s meeting.

Mayor Nancy Krasne said the recommendation has been sent to the Planning Commission with the direction to examine the issue and incorporate it into the General Plan.

“Originally, lots in Trousdale were priced based on the view. This is a pending problem and this isn’t the first time the issue has come up,” said Krasne.

Frieda Berlin, liason agent of the Trousdale Homeowners Association said the homes were originally built to have a view and said the problem escalated after the expiration of the Covenants, Conditions and Restrictions (CC & R’s).

“Our view is gone, which in these economic times, lowers the value of our home,” said Berlin.

The document that accompanied the sale of property in Trousdale, stated along with other restrictions, prohibited hedge rows, which block the view of neighbors. Since the expiration of the CC & R’s in 2004, Trousdale has had a city ordinance in effect with restriction on decks and height of homes, but does not include tree restrictions.

According to Berlin, homeowners have tried to mediate the situation themselves, but have been unsuccessful. She said the neighbors might be more willing to cooperate if provided written documents and regulations from the City. She said some opponents do not want to disrupt nature, some want extra privacy, and others simply do not care.

Trousdale resident Alan Iezman said views were being threatened in two ways at Tuesday’s meeting.

“A sizable number of residents are letting their trees grow into view blocking messes, and when asked to trim them back to sustain

the views, they either decline completely, or insist the offended homeowner pay. This is not the spirit of community that we wish to encourage in Beverly Hills,” said Iezman. “The city trees on Loma Vista are acknowledged even by the city as the wrong trees in the wrong place.”

Berlin said residents have responded by saying, “I don’t have a view, why should you?” She said this is part of the viscous circle of the homeowners.

“People who don’t have views don’t care,” said Krasne. “But people pay accordingly based on their location and views in the hillside and I think that entitles them to being able to enjoy it.”

Richard Kahn, a resident of North Hillcrest Road in Trousdale, is troubled by his neighbors’ refusal to cooperate and hopes the City will create a view protection ordinance similar to those of Malibu and Rancho Palos Verdes.

The ordinance known as “Malibu Country Estates View Restoration and Preservation,” was a result of problems similar to one faced in Trousdale.

“We moved in 30 years ago and enjoyed our view for 28 years because of good neighbors. Unfortunately, we ran out of good neighbors a current resident on [North] Hillcrest Road said he has no intention of topping off his trees. We’ve pleaded with him and sent him letters for years and now he just refuses to meet with us. Something needs to happen,” said Kahn.

In an information packet given to the city as evidence, photos showed homes with trees blocking views.

Joani Rome, a resident in one of the homes identified in the packet, declined comment.


According to Berlin, the ordinance is still in its first stages, but is happy the plan is moving forward and being included in the Planning Commission meeting in May.

Beverly Hills and Los Angeles have different views on Olympic/Pico plan

The Traffic and Parking commission need more information before the city will support changes on Olympic and Pico Boulevards that may affect the Beverly Hills area.

Currently, Beverly Hills does not want to re-strip or add additional lanes until Los Angeles provides information to support the need for these changes, which has not been provided as of April 2. The City has not taken a formal position on the proposal.

Want To Serve On The City Council?

Are you ready for a prime time budget

So, you think one day it might be interesting and amusing to become a member of the Beverly Hills City Council and even take your turn as mayor?

Before forming your campaign committee you might just want to watch one of the study sessions now considering adoption of the city's annual budget.

The first reality check is how little interest there is in this spending and revenue process. Give the people a hearing on hotel development or even some contentious permit parking plan, and the council chambers will be packed.

Budget deliberations? Who cares? The city will always make sure we have the best in police, fire and other emergency services. Not that simple or easy, this year.

But the buck, if there is an extra one available in these troubling and confusing economic times, does actually stop at the city council's dais.

You have to steel yourself to endless, interminable but very critical reports from city staff professionals on highly complicated fiscal issues.

First, if you are a councilmember, you will be wise to follow the lead of your fellow councilmembers and make the politically correct and forceful disclaimer: not one cent will be taken from any protective services. Or, as one current councilmember put it: "When you dial 911, someone will always answer."

No question, we have the best possible first responders anywhere. And public safety is and should be the first responsibility of our elected officials. As a councilmember with some hope of reelection, you will not want to even suggest cuts in safety departments.

Now, you will also find that there is an almost equally strong constituency for public education. Not smart to consider reductions in the Joint Powers Agreement

that helps maintain quality educational services. Trust me, you don't want the PTAers to march on city hall.

However, cut you must, although there are some other risky possibilities. You could dip into reserves. If that does happen, most city services could remain as they are, and they are indeed excellent, but you would risk losing our very high bond ratings. Spend now and prevent losses in services and worry about fiscal impacts later? Not very responsible.

Enforcing sign ordinances, repairing alleys and streets, replacing aging recreational service structures, giving financial assistance to cultural and community service organizations may not be community priorities, but all of these and more, if funding is not available, will impact our quality of life.

You will also learn that many departments and city divisions, although not fully staffed even now, are major sources of revenue including planning and building and safety. Tampering with their budgets could actually mean losses of earnings.

Being new to the council, you will also be very pleasantly surprised by the extremely high level of professionalism on the city staff. From the city manager and his immediate assistants to the staffers who actually work in finance, the competence level is extraordinary.

Back to the process and the challenge: the city faces an \$18 million dollar "short fall" in this fiscal year. Why? Obviously because tax revenues, even the highly important cash cow of the hotel bed tax, has plummeted as have retail sales. From car dealers to art galleries, their declines in revenue are our losses too.

Between now and the end of June, the city council will have six public hearings on the budget crisis, and if you think that's fun you can take my place at my next root canal drilling.

Some thoughts: First, the constituent organizations in the city really should have representatives at these hearings: The Chamber of Commerce, the Rodeo Drive Committee, all the Homeowner Associations and Municipal League, the organization representing seniors, the education community, our service clubs – any organization or group that could and should have an impact on civic life, should be involved and informed, as should our residents and businesses.

Second, let's make tough but also smart decisions. Just one example: The aging and dysfunctional community center building at Roxbury that serves many needs, mostly that of our senior adult community, is in desperate need of replacement. What we don't need is a cost cutting approach that gives us an inferior structure with which we will have to live for several generations.

Today's exigencies should not mean

too many contractions in Beverly Hills standards of excellence. Remember, past generations bit some tough fiscal bullets to build our outstanding parks and five schools.

Finally, a word about this council. Not bad. Although they may represent very divergent positions on other issues, they have, so far, shown real care and involvement. We may have strong differences with each of them on some issues, but they are, as a council, very well qualified to face the fiscal challenges. **Jimmy Delshad** is at his best when it comes to money matters. **Barry Brucker** does his homework and runs his own business. **Nancy Krasne** is a business and investment activist, **Dr. Willie Brien** has mammoth fiscal responsibilities as chief of staff of Cedars-Sinai and **John Mirisch** has run some highly successful entertainment industry companies. They all know how to read a balance sheet and actually understand all the information coming from the city's professionals.

If, after all of this, you still think serving on the council might be fun, call me. They need volunteers at the Domestic the Sharks Committee.



In other words, the other side was not notified, and that wasn't required, for a public input appearance, but no action could be taken without notice and full participation by both sides at a noticed, public meeting.

LOCAL HEROES: Not easy balanc-

ing the responsibilities of making sure the city functions efficiently and in the public interest and driving the budget process through the city council, the ultimate decision makers, but City Manager **Rod Wood** and Chief Financial Officer **Scott Miller** have been truly outstanding in keeping our financial crisis in perspective.

Their professionalism has made the city council's job both easier and more open. Budget deliberations don't have much political interest, but the impacts will and do. We are lucky to have Wood and Miller working the complicated process when we and the council most needed their involvement. Of course, they didn't do it alone and we should be appreciative of all their staff's assistance too.



According to the initiative described on the Los Angeles City website, the proposed project would include re-stripping roadways to provide continuous curb lanes on both sides of Olympic and Pico between Fairfax and Centinela Avenues during peak periods.

The project also proposes modifying traffic signals to encourage westbound travel on Olympic Boulevard and eastbound travel on Pico Boulevard. New left turn signals will also be added to facilitate movement from Olympic to Pico.

"Essentially, LA will be catching up with what Beverly Hills did 2 years ago: extend peak hour parking restrictions. Beverly Hills has had synchronized signals for a long time," said Ken Goldman, Vice Chair of the Traffic & Parking Commission.

Neighborhood Watch meetings begin this month

Every Tuesday, the Beverly Hills neighborhood watch will be holding meetings at the city library auditorium at 7 PM.

The meetings are held according to zones, however all residents are welcome at every meeting to address concerns.

"Most people don't even know what zones they live in. But, residents shouldn't worry about coming to the meeting for their specific zone. The meetings are always open any

citizen," said David Seidel, Health and Safety Commission chair.

The meetings will also provide information and familiarize the residents with the Community Emergency Response Team (CERT), and Disaster Communication Department (DCS).

According to Seidel, in conjunction with Earthquake Preparedness Month, one of the main focuses of the April meetings will be to prepare families.

Seidel said that residents should have an adequate supply of water and food. Residents can also visit the city website at www.beverlyhills.org to sign a pledge of preparedness. "There is always a chance that a natural disaster might occur because we live in California," said Seidel. "The city of Beverly Hills is prepared to provide support, but in the case of a natural disaster, if you are prepared, your quality of life will be much higher in an emergency situation."

Automated License Plate Recognition not only for Police

The ALPR system could be used by parking enforcement to monitor parked vehicles throughout Beverly Hills.

The new system, which has been used by the BHPD in the past weeks, recognizes vehicle information by a simple and quick scan while driving. The technology has already helped the police department recover stolen vehicles and arrest suspects.

Parking enforcement officials will soon be using License Plate Recognition GPS (LPR GPS).

According to Chad Lynn, Director of Parking Operations, the City currently testing vendors and is in its final negotiation phase. Lynn estimates the installation of approximately three units within the next few months.

Currently, one unit is deployed and results show that one unit is as efficient as 2 officers.

In regards to parking, the LPR GPS sys-

tem would be able to track expired time on vehicles at meters and 2-hour time zones, and monitor the circulation of cars over the course of the day.

City Ordinance requires vehicles to move at least 500 feet from the previous parking spot.

"There has always been a call from residents to monitor parked vehicles. There are impacts everyday that spillover from commercial to residential areas," said Lynn.

City offers assistance in event of an emergency

The Beverly Hills Human Relations and Health and Safety commissions have created a volunteer program to assist residents in the

event of an emergency evacuation.

The Emergency Evacuation Assistance Registry is specifically targeted towards residents who are frail, disabled, elderly, or have other needs that require special attention.

City emergency managers will be able to better prepare for emergency evacuation, transportation, and sheltering of community members based on the results of the Registry.

Currently, there is no screening process for the City of Beverly Hills Registry program. The City will accept all those who feel they will need assistance in the case of an emergency evacuation.

However, the Registry is not a promise or guarantee of assistance from the City. Assistance will depend on factors including the nature of the emergency, available resources, and the ability to assist at the time of emergency. In addition, the program is only used when an evacuation has been ordered.

Completed registry forms are valid for two-years. The Office of Emergency Management also accepts referrals of any citizens who may need this service. For more information or to register, contact Pamela Mottice Muller at (310) 285-1025.

NO FLAME TOO HIGH

Ray Navarro looks back at 28 years with the Beverly Hills Fire Department

Tell us about how you got to the Beverly Hills Fire Department.

It's really interesting actually. Back in 1979 I was doing my paramedic internship. That's the part where you go to a fire department or provider agency that already has paramedics, and they check your skills.

With my background being a flight medic in Vietnam on a helicopter, I had a lot of training and experience. So I took the county's test and passed all of the written material and was sent out to be evaluated by certified paramedics. Then I was sent to Beverly Hills.

That was my first experience with a fire department. Up to that point was I was a pre-med student at UC Riverside and I was thinking I was going into medical school.

I got to Beverly Hills and the guys were very cordial. And I remember everyone being so supportive. It is one of the few places, in my experience, even in my prior service career, that people really thanked you and congratulated you every time they saw you for the job you did.

Tell us about Vietnam.

I was one of the lucky few, part of the last part of the draft. It was the last draft that they had assigned numbers to, and my draft number was 22 in the lottery. So, I got the notice, got into the military, and packed up and went to Fort Oregon.

You don't really get selection of assignments, it's just based on what you qualify for. I happened to test high enough for medical, and they assigned me to the 25th aviation battalion. I was there right towards the end of the war, so I didn't spend much time there.

We got re-deployed back to the states and I was flying missions for the state of Hawaii. I spent about 16 months there, and then I was honorably discharged.

What inspired you to become a firefighter?

When I first rode along with the paramedics, they knew that I had some experience with trauma. They put you

through different challenges and my first one was putting an I-V into a patient while in route to the hospital. I told them I could do it and they said "We'll see." Then I said, "If I can do it in a helicopter, I can do it in a moving ambulance."

They tried to give me the biggest challenge they could, which was to cook dinner. And I love cooking, and

my mom has showed me how to cook meals. So, I made them the best Mexican meal they've ever had. And they said, "Do you want a job?"

So they knew I had the skill to be a paramedic, and then they asked me if I wanted to be a firefighter. Nobody in my family had ever been a firefighter, and I didn't really know at the time, but it seemed really interesting. So I passed all of the physical tests, and I had to do an oral interview. I didn't get a high enough score for the first go-around, but I was on their list.

About a year later, I got a phone call from HR asking me if I was still interested in working with the Beverly Hills Fire Department, and I immediately responded with a yes.

I was working as a paramedic for the Pasadena Fire Department when

Beverly Hills called. I probably would have stayed with Pasadena, but my battalion chief at the time said, "You should go to Beverly Hills. They're a great department, and you'll do a real good job out there. It's a great community and these opportunities don't come too often."

I didn't know then what he meant, but it really turned around for me. So that launched my career that I have to say, has just been exceptional. I started April 20, 1981, with a group of six of us total. We were one of the few stations that had paramedics at the time since it was still new.

It was a natural fit. The excitement, being in life and death situations, dealing with trauma and combat. Firefighters are story changers. We get to help with how the story ends. People go through trauma and emergencies and they may be huge. When we arrive, we try to help and in almost all cases, alleviate the situation.

What chiefs did you work for?

It started with Bill Daley. I have to say that Bill was a forward-thinking guy

that I get more involved in the county, and the next thing you know I was nominated and selected as chairman for the California Firefighters Association as the Emergency Medical Services chairman, representing 27,000 firefighters in California.

I lobbied and helped introduce four bills and got them passed and signed by the governor during my time as chairman of the committee. And all of this stemmed from Beverly Hills as the dominant voice in EMS (emergency medical services) in California, if not the nation.

In my tenure, I was asked to be the first representative of the state commission on EMS representing all of fire service. Governor George Deukmejian appointed me as the first fire representative to that commission. Then I was re-appointed under Governor Pete Wilson. So for 8 years I sat on the state commission overseeing the development of all emergency medical services.

Jerry Hayes is another chief that sticks out in my mind. He was a battalion chief who had a similar background. He was a team-coach, and he had a lot of sports background, so he coached us into being a really organized team and work on a high level.

Two chiefs that also come to mind and I keep in contact with are Dennis Andrews, who is a fireman's fireman. He's so good at everything that he does and I'm happy to say he's currently president of the Fireman's Association. Another captain is Steve Zance, who is the funniest guy, someone who I've always relied on for critical evaluation.

Even now, I contact those people. Even when you're not there, they help you to center yourself.

Tell us about the legislation that you passed?

One of the important ones was the exposure to pre-hospital care personnel/public safety. Specifically for the exposure to communicable diseases including blood products, HIV, etc. Back in 1987, there was no reporting mechanism for first response if you got exposed, and or to test patients who have these exposures.

There was no way to inform someone if they have been exposed to a communicable disease, there was no mechanism in place. Both Jim Page and I worked on this and I carried the legislation through the state legislature which got passed and signed into law.

Tell us about some of the friends you made over the years in Beverly Hills?

Your classmates, the guys you started with, you bond to your entire career. Like Jerry Koyama. He's one of the engineers, and he was a paramedic with me. We came on together.

Sadly, Chief Ed La Fougere recently passed away due to complications with

and a very community-oriented fire chief. One of the best Beverly Hills has ever had. The reason I say that is he was in tune politically to what the community wanted and needed. But he was also focused on the expansion of the role of fire service in its role as community protectors.

Chief Daley was actually the one that propelled me. Because of my background he pushed me to help establish the EMT and Paramedics program into what we call a state recognized pre-hospital program.

My attempt in 1983 was to develop, direct, and put a program together so that every fire fighter in the department was trained to emergency medical technician level, which was unheard of at the time.

Then the chief [Daley] recommended

leukemia. We came on together and he served as battalion chief before I left. James Doersam, was another one who came on with me, and we were paramedic partners. He's probably one of the best bedside manners of patient care you've ever had.

Do you still keep in touch with any friends from Beverly Hills?

Oh yeah, all the time. Most of them. In fact yesterday I was talking to JR Berardinelli, and Kurt Beeson, he's a paramedic there. I still talk to the office staff, they're wonderful. I talk to Chief [John] Karns who's a deputy chief there. And Chief Dwight Simpson, he just made battalion chief. Just wonderful people.

What's the hardest part about being a firefighter?

The hardest part about being a firefighter is your time away from family. Because of the dedication and the number of hours. There are times when you're serving and doing the job that you're called to do, and I really believe it's a calling. Not everyone can do this. You have to sacrifice a lot.

You miss birthdays, holidays, and other important things that you just can't attend. You miss them, and you never get them back. It's pretty hard, nothing becomes a sacred day. This is the first time in my fire career, after

almost 30 years, that I am home every night.

It's also really hard on your body. It's a young person's job. After 25-30 years you've got a good career. Sadly to say, our life expectancy isn't like other jobs. We know that going in, and we know time is precious.

Have you ever had to save someone you knew personally?

A couple times. Especially with celebrities in Beverly Hills. I remember the actor Danny Thomas, when he was going into cardiac arrest. You see someone who you've grown up with on television and they're laying there unconscious and not breathing and you have to be there right in the moment, and not think about anything else.

The outcome didn't change, unfortunately he passed away. We did all we could to resuscitate him and you just kind of wonder if there was something else you could have done. Sometimes you second guess yourself in this field.

You make the mental and the relational connections like, "I know this person, and they shouldn't be like this. That's one of the more difficult parts.

What is the craziest call you have received during your career?

The call that is always the funniest to me is the time we got called in to rescue a pony out of a pool. We get dispatched

and at the time I'm a captain on the engine. It was on Hillcrest [Road] just by Santa Monica [Boulevard].

They called and said, "A pony in the pool!" I thought they were kidding. But we got there, and it was a children's birthday party. There was a clown and pony rides, and apparently the pony got spooked and jumped into the pool. So we had to empty water out of the pool and design a ramp so we could help pull it out of the pool because we couldn't carry it out.

What your most memorable experience as a firefighter in Beverly Hills?

One of my fondest memories was being around President [Ronald] Reagan. Having one-on-one time with him and Nancy during their time in Beverly Hills was really special. Because we have to travel with him. It really is world-class. You are treating the elite of elite and world-class decision makers.

What was the biggest fire you encountered during your career?

Within the city, there has definitely been big fires in homes. I remember a few fires in different structures on Beverly [Drive]. Also, there was a building on Wilshire Boulevard called Abbey Rentals. It was a big warehouse with a fire that started in the evening, and we didn't put it out until seven

hours later. The 8383 building [Wilshire Boulevard] during my career had a high rise fire that took the whole seventh floor and burned all night.

Tell us about your family.

My wife [Paula] and I have been together about 30 years and we have three beautiful children. She's definitely strong and capable, and like all fire wives, they learn that sometimes Dad's not there and they have to learn to do things on their own. My daughter Kendra is a high school teacher and coach, and my sons Matthew and Michael are studying here at Santa Barbara City College.

What advice would you give to a new firefighter?

First of all, get the training. And second, give as much as you can. Being a firefighter is not a job, it's a career. It's definitely a calling and a lot of hard work. You have to sacrifice a lot, but it will come back to you ten-fold.

Also, it's like buying a house: location, location, location. Because you'll end up working there for years, I really lucked out with Beverly Hills. Beverly Hills just has that uniqueness and closeness with the community that you don't think you'd ever find in a big city like Los Angeles. I've grown so much, and things that I never thought would happen and expect, did.


