

“Courier Editorial”

[The Courier Editorial] recently expressed opposition to all of the propositions on the May 19 statewide special election ballot. I offer an alternative point of view.

Blood, sweat, and tears are not sufficient resources for California to provide high quality education to our residents. We also need money. California ranks 47th out of 50 states in terms of per-pupil funding. This is dismal and it's shortchanging generations of children.

I belong to the California Teachers Association and we support all six propositions, 1A through 1F, as a way to close our state's multi-billion dollar budget gap. Propositions 1A and 1B are the most impactful.

Proposition 1A stabilizes future state spending and creates a long-term reserve fund to help prevent further cuts to schools, health care, and public safety. 1A also extends the temporary statewide tax increases by one to two years to prevent California from running out of money as we suffer the largest economic downturn since the Great Depression of the 1930s.

Proposition 1B ensures that California public schools are repaid the \$9.3 billion they are owed under the minimum school funding law,

a proposal so uncontroversial that the Secretary of State's official voter information guide does not even include an argument against 1B.

However, 1A generates the money necessary for 1B to be implemented. If 1A fails, then 1B automatically fails and \$16 billion will be cut from schools, health care, and public safety. This would be on top of the \$11 billion in cuts that schools have already suffered over the last two years.

A “cuts-only” approach to schools is shortsighted. Rather, we must maintain and grow our investment in children's education and keep our state fiscally solvent by voting “YES” on 1A through 1F on May 19.



Ethics Seminar course may be added after students register incorrectly

The Ethics Seminar, formally known as the Beverly Seminar is one of the most sought after courses this summer, with another course currently in the works after four sections reached maximum capacity hours after opening up for students.

Beverly students were eligible to register for summer courses on April 29 at 9 AM. However, since students can take courses at any site, some Beverly students found a loophole: Register early through Burbank prior to open registration for Beverly.

The summer enrichment program offered by Marymount College includes other high schools such as St. Bernard Catholic High School in Playa Del Rey and John Burroughs High School from the Burbank Unified School District.

Students can take courses at any school site. John Burroughs began registration approximately two weeks before Beverly.

The online system allows students to register at any time. To register, a student creates an account using their name, address, and email. There is no verification process of what school the student is from, which allowed students to register for the class through the John Burroughs portal.

By the morning of the 29th, all ethics sections were closed.

Beverly English teacher and principal

of the Summer Enrichment program at Beverly Christiane Elhabr said approximately 15 students registered for the class through the back-door before the registration date.

Elhabr said in the past, classes have reached capacity in as little as two hours, which contributes to the students trying to get a head start on registration.

"It's a new requirement and everyone's nervous," said Elhabr. "It's ironic that some of the students registered for the Ethics Seminar in an unethical way."

Elhabr also said some students may have registered without malicious intent.

"The webpage can be confusing since there are other schools involved. A student could have easily pressed the wrong link," said Elhabr.

Elhabr said all registration is time-stamped, and Marymount is going through all of the files to determine all students who registered before the allowed date. Elhabr said they will try to accommodate everyone, especially those who registered ethically.

"We are in the process of opening one more health and one more Ethics Seminar class," said Elhabr. "Those who signed up before the registration date will be put at the end of the list."

She did not confirm how soon classes would be added. Elhabr said they might know in the next week.

"There were a lot of people who wanted the class and couldn't get in," said Marymount College Community Education Director Lisa Francis. "We continued to take applications even after classes were full so it is fair to those who want the course."

Francis said she could not determine exactly when classes reached capacity.

Elhabr said she has not received the roster, but anyone who has registered in the course that is not an incoming Beverly freshman, will be taken out of the class.

Elhabr said Marymount is going through the applications one by one to log everything in order received.

"It's going to take some time because we're trying to meet everyone's needs,

The majority of the fees and charges would be increased by 1.1% based on the Consumer Price Index (CPI) for November 2008. In some cases, the fees were adjusted to reflect a change in service level, more equitable distribution of costs, or to obtain full-cost recovery, rather than by the CPI. The new fees would become effective on July 1, 2009. Fees for development applications, per State law, become effective 60 days after adoption of the adjusted fee schedule, which is July 13, 2009.

but it will all work out," said Elhabr. "Marymount is personally making calls to each student who is registered, which has helped with the panic in the past week."

The Ethics Seminar is a new graduation requirement which focuses on life skills, ethical behavior, and judgment. Students have until their junior year to complete the Ethics Seminar. The program was approved by the Board of Education last year, and recent changes to the program were presented at the last Board of Education meeting.

Koretz, Vahedi Face Off in Runoff Election

Former West Hollywood City councilmember Paul Koretz and David T. Vahedi will face off for a seat on the Los Angeles City Council later this month.

The race to replace Councilmember Jack Weiss in the 5th district is extremely close, with poll results from recent months showing as little as a 0.2 percent according to the LA Times.

Weiss will face former Deputy District Attorney Carmen Trutanich to succeed termed-out City Attorney Rocky Delgadillo.

LA council's 5th district surrounds Beverly Hills, and includes the communities of Westwood, Century City, Bel Air, Holmby Hills, Cheviot Hills, Encino, Beverly Wilshire, Carthay Circle, and Sherman Oaks. The District has approximately 258,000 residents, with one of the highest voter registrations in the city at

approximately 62 percent.

Vahedi, who is a lifelong resident of the 5th district, worked as an auditor for the State Board of Equalization. He is supported by Mayor of Beverly Hills Nancy Krasne, the Los Angeles Airport Police Officers Association, and the Century Park East and Westwood Gardens Homeowners Associations.

Koretz is endorsed by Beverly Hills City Councilmember Jimmy Delshad and Public Works Commissioner Joe Shooshani. He is also supported by Weiss' predecessor, Assemblymember Mike Feuer as well as the Los Angeles County Federation of Labor. Koretz served on the West Hollywood City Council from 1988-2000.

"Paul [Koretz] wants to help people, he's an excellent politician, he's the only Jewish candidate in the race, and if he does half of what he did in West Hollywood, Los Angeles will be a happy place," said Shooshani. "He means well and he does right."

Bel Air-Beverly Crest Neighborhood Council boardmember G.G. Verone disagrees. The association includes hillside communities stretching from Laurel Canyon to Sepulveda Boulevard and Sunset Boulevard to Mulholland Drive.

"Paul Koretz will be disastrous," said Verone. "He's jumping from one community to another, and didn't do anything great in West Hollywood in my opinion."

Verone said the biggest concern of homeowners associations in the 5th district is overdevelopment, and traffic and

safety are key issues as well.

"We want homeowners to be considered, and that's not happening on any level right now," said Verone.

She believes Vahedi will be a better advocate for the residents in the 5th district.

"Vahedi is better, and he's not taking money from big developers," said Verone.

Voters in the 5th district have a history of picking younger candidates and less established names.

In 1953, they elected 22-year-old Rosalind Wiener, later known as Rosalind Wyman, and in 1975, the district chose 26-year-old Zev Yaroslavsky, now a veteran county supervisor.

If elected, Vahedi will become the first Iranian American elected to serve on the City Council of Los Angeles.

In a debate at UCLA on April 20, both candidates were asked for their top three priorities for spending stimulus funds. Vahedi said sufficient hospitals, mass

transit and schools, as well as funding additional scholarship programs. Koretz said transportation, infrastructure and affordable housing.

Annenberg Center parking plan presented to Architectural Commission

The City owned and operated three-level subterranean parking structure conceptual landscaping plan was presented at the last Architectural Commission meeting.

The 470-car parking garage was approved by the City Council in January 2009 in conjunction with the approved Wallis Annenberg Center for the Performing Arts.

Architectural commission chair Allen Rennett said the project is still in its beginning stages and it is too early to tell what will be affected.


Rennett said the underground lot will go towards City Hall, which may affect

People making news

Even though we may not always hold them in high regard, newspapers really need public relations types, lovingly called flacks. Some are incredibly skilled, knowledgeable and highly professional, but some unfortunately have the same limitations as the rest of us in the information biz: clueless.

An example of the latter: The late publisher of the Los Angeles Times, **Norman Chandler**, once showed me a press release he had received for a play soon to open at the old Biltmore Theatre, one of our few stage venues before his wife Buffy shamed our big spenders into funding the Music Center.

Chandler, the scion of a newspaper dynasty, asked if I knew the PR person who had sent him the following: "Attached is press release announcing the opening of Tea and Sympathy at the Biltmore Theatre" (followed by show times, cast, synopsis of play etc.) and the following: "If you will bring a 'tear sheet' (clipping) of the story

you print to the box office, we will be pleased to give you two passes to any matinee."

The play was not reviewed.

Columnists emails are overloaded with clever attempts by publicists to by-pass the advertising departments. Why not try to promote your product in the news section instead of paying for ads? The PR departments will argue that it is important news, information your readers must have: that a new face cream will actually reduce the need for cosmetic surgery or that a pet grooming service merits page one placement.

Often, the press releases are so outlandish that I am simply unable to resist not sending a response. A recent communication from a PR firm touted the importance of an "exciting" new product: an electronic cigarette. This incredible contribution to scientific advancement assures us that we could "satisfy our nicotine cravings without the flame, tobacco, tar or carbon monoxide

found in real cigarettes." There are also cigars and they come complete with a "stainless steel battery, nicotine cartridge and atomizer."

So, I sent the following, admittedly not Benchley or Cerf quality, but at least a mild attempt at sardonic humor: "Electric Smokes? This comes as a big SHOCK to me, but I'm sure users will get an enormous CHARGE from the experience. However, since I am a pipe smoker, could you recommend something that would not become BATTERY of another person because of second hand CURRENTS."

Trust me, this is a verbatim answer to my email: "Thank you for your response. I'm not quite sure I understand your question. Would you be interested in interviewing 'SmokeaCali.'" (Names of PR person omitted to avoid pain for the very innocent.)

Good to have some top leadership come to instead of depart from our city government. Planning and Building and Safety, combined into one department during the **Rod Wood** reorganization structuring, will have a new boss: **Susan Healy Keene**, who has, despite her very youthful appearance, over 25 years experience in municipal government.

Most recently in West Hollywood, Ms. Healy-Keene also served in Santa Monica with our director of planning, **John Lait**. Lait had very high praise for Susan's talents and leadership skills.

Healy-Keene will assume her responsibilities next month.

Some notable events: **Fred Hayman** hosted a reception last week for the unveiling of a re-creation of his world famous Giorgio Beverly Hills storefront on his building on Canon Drive, complete with faux entrance.

After the viewing, the guests made the short trip to Hayman's favorite watering venue, Spago.

It is certain to be a tourist attraction on a street, Canon, that itself is going through positive change. Giorgio's, the fragrance name and not the store, was sold to Avon and then Hayman kept the store giving it his own name.



IS BEVERLY HILLS PUSHING OUT DEALERSHIPS?

BMW leaves the City, could Lexus be next?

With one closure of an auto dealership as a result of expansion problems, and another in the process of expansion approval, the City could be losing significant sales tax revenue.

City budget study sessions in recent months have included discussions about numerous cuts in departments throughout the City including information technology, community development, fire, and police to make up for the shortfall. In past meetings, City Council members have discussed all the possible ways to make up for the deficit, including reducing overtime and utilizing the City's reserves.

With car sales in the hundred millions, the City can receive \$1 million plus a year from a single dealership. With a budget deficit of \$18 million, does every cent count? A revenue generator like BMW, Mercedes, or Ferrari is important—or is it?

According to Chief Financial Officer Scott Miller, car dealerships contribute mainly through sales taxes. The City receives 1 percent of the 9.25 state sales tax. The city also receives a business tax, based on a gross percentage of sales outside of the sales tax. The City receives \$1.25 per \$1,000 of gross receipts in business tax.

For example, BMW generated approximately \$140 million in gross sales last year; a little over \$1 million went to the City.

“Car sales are an important element of the City's overall sales tax revenue. In 2008, the transportation sector, which includes auto parts/repair, auto sales, and misc. Vehicle sales accounted for 13.9 percent of the City's sales tax revenue,” said Director of Economic Development and Marketing Alison Maxwell. “New sales alone accounted for 12.1 percent.”

Last year's total sales tax revenue was \$26.5 million, which is approximately 16 percent of the \$167 million general fund budget. Of that \$26.5 million the automobile industry contributed \$3 million to the City, which is approximately 2 percent of the total budget.

Maxwell also said overall sales were down for the year ending December 2008 by 18.6 percent compared to the

year ending December 2007. In terms of dollars this is a drop of approximately \$700,000.

Unlike other cities that rely heavily or solely on sales tax, Beverly Hills does not. According to Chamber of Commerce Vice President of Economic Development & Government Affairs Anita Zusman Eddy, the main source of tax revenue comes from tourism and retail.

In addition to sales and business taxes, the Transient Occupancy Tax (TOT) included with hotel room rates also contributes a percentage to tourism and retail sales tax revenue.

In the last quarter, through the months of October 2008-December 2008, car dealerships contributed to 12 percent of the City's total sales tax revenue. Miller said the percentage fluctuates every quarter.

“Twelve percent is not as big of an impact, but losing the dealership is going to hurt,” said Miller. “We only have 4, but it's too soon to tell how much impact it is going to have.”

The auto dealership industry is changing in Beverly Hills, with Lexus seeking City assistance in expansion, what BMW could not accomplish.

Zusman Eddy said auto dealerships are critical; however they are other outlets for the City.

“We are sorry to see them leave, but there are other sources and it's not going to negatively overwhelm the ability to supply services to Beverly Hills,” said Zusman Eddy.

BMW is leaving Beverly Hills for two buildings on La Brea and Wilshire Boulevard, as a result of the issues with the City in expanding the dealership as ordered by the corporation. The company needed to expand their service area.

The buildings are under construction, and the dealership will keep the Beverly Hills name. Murray Fischer, attorney for BMW said the company wanted to stay, but City gave them no

other choice but to leave.

“We tried to find other locations to expand within the city, unfortunately we didn't accomplish our goal,” said Fischer. “We found a location outside of Beverly Hills and LA graciously accepted us.”

Construction will be completed in the next year.

A scoping session was held April 23 and an initial study was presented for the Beverly Hills Lexus Expansion project. The City is currently preparing an Environmental Impact Review (EIR).

The scoping meeting allowed citizens of the community to comment on the potential environmental impacts that should be addressed in the EIR.

Eight individuals attended the meeting according to official meeting minutes.

Included in the minutes, is a written comment from Beverly residents Leslie and Phil Katz, who manage a 60+ unit building on South Maple Drive. Both addressed the issues of increased traffic, horns, and the frequency of backups interfering with the residential area.

Lexus currently has a service center on Robertson Boulevard and storage facilities in the 9900 Wilshire building in addition to the Jim Falk Lexus on Wilshire Boulevard.

If approved, the current building on Wilshire Boulevard would be torn down, and rebuilt to a new proposed 150,000 square foot, five-story facility.

The proposed expansion is 65 feet 4 inches in height, including a showroom, two levels of service, 201 parking spaces, and room for office and lounge areas.

According to the public notice of the scoping meeting, the City Council would need to approve, “a general plan amendment to extend the commercial land use designation onto the South Maple Drive parcel [currently residential], increase the allowed height to 66 feet, an amendment to the City of

Beverly Hills Streets and Highway Master Plan to vacate the alley between South Maple and Wilshire Boulevard, the creation of an Overlay Zone to increase height, and allow tandem parking.”

Calls to Jim Falk Lexus General Manager Kevin Wuepper were not returned by press time.

The proposed project will also be subject to Development Plan Review by the Planning Commission and the project will require Architectural Commission Review.

Although the City and BMW could not come to an agreement, Mercedes continues to maintain a good relationship with the City.

The City leased space to Jardine California Motors DBA (doing business as) Beverly Hills Mercedes Benz located at 400 Foothill Road. The 49,500 square feet property was used for the servicing of cars. The City leased this space to Beverly Hills Mercedes from 1997 to 2007.

Although the City rarely sells property, in 2007 the City sold that property to Jardine California Motors Limited. The City also leased the eastern half of the City owned property at 348 Foothill Road to Beverly Hills Mercedes Benz for auto storage. This lease is still in effect.

This week the dealership donated a second car to the Beverly Hills Police Department, a DARE SmartCar. Calls to Mercedes General Manager Bruce Schulman were not returned by press time.

For years the old Ford dealership on Rexford and Olympic remains empty, with no major complaints from the City or residents. In other cities, most would not hesitate to add another dealership.

City Planner Jonathan Lait said the City will try to work with Lexus' needs.

“City staff will continue working with Lexus to balance a shared interest in their continued investment in Beverly Hills with the need to ensure that future development is consistent and compatible with surrounding neighborhoods,” said Lait.


