Teachers dodge salary cuts at the board

3-2 vote А at Tuesday's Board of Education meeting tabled the agenda issue of certificated teachers layoffs for the 2009-10 school year.

The Salter Family Theater was filled with more than 70 BHEA members, Chris Bushée said.

"Our members came together to impress upon the board the

necessity of keeping moral high in our district and that begins by not putting a dark cloud over the upcoming school year with the prospect of salary cuts," Bushée said.

Board President Nooshin Meshkaty tabled the agenda item, which said the state estimates a \$24 million budget shortfall for the 2009-10 school year, to the top of the agenda and made a motion to table it another year.

Boardmember Myra Demeter said the budget crisis was unpredictable and that the proposed resolution was there to provide options, but passing it did not ensure it would be put to use.

"We have to be conscious of the possibili-

ty of future cuts mid year," Demeter said. "What this resolution does is gives us the ability to negotiate with our staff if we choose to go to 175 days."

Demeter's comment referred to Gov. Arnold Schwarzenegger's proposal to cut five days off of the 2009-10 school year, saving the state \$1.1 billion.

Boardmember Myra Lurie concurred with Demeter.

"This is not a resolution to reduce salaries," Lurie said. "It only allows us to have that conversation if necessary.'

While boardmember Brian Goldberg said he would normally not want to table an agenda item, but this was an exception.

"At this point we've been advised by our staff that this is not necessary this year," Goldberg said.

Bushée said BHEA feels good about the board's decision.

"We're happy the board took the action it did and we can come into the next school year and not have to worry if our personal wages are going to be cut," Bushée said. "We feel ultimately that is the right decision for the students that we serve."

gathered during the weekend and into the week, showing their support for Iranians, who faced the frustration of a rigged election and are now fighting for their basic human rights in Iran.

"The question is now beyond the election," Vice Mayor Jimmy Delshad said. "Now that they have cheated their own people, the people in Iran finally woke up, they saw how the government was lying and cheating, even their own people."

Vice Chair and Senior Analyst Said D. Gabbari of the Center for the Promotion of Democracy and Human Rights in Iran, which is located in Beverly Hills, said while he agrees with Delshad, the people of Iran have known their government is not on their side.

"This is a natural involvement of events because of the nature of the regime in Iran and its people," Gabbari said. "The people saw an opening to express their frustrations and they have; now the regime is closing that opening and you have people resisting.'

Gabbari said with the purchase of software that allows Iranian authorities to monitor Internet usage, citizens are having their strongest defense, technology, taken away.

"That is why they have been able to control the demonstrations in Iran much better and control and suppress their communications much better," Gabbari said.

Delshad and Gabbari both said aside from showing solidarity and support for Iranians, the best way to show support for them is by vocalizing.

"The most important thing is to write to your senators, congressmember, the white house, send emails," Gabbari said. "We are at an age where it should no longer be a big deal to sit down and write a few words of support."



The Beverly Hills budget cut and 10 percent of business hours

Monday through Wednesday the library will close at 8 p.m. instead of 9 p.m. and Thursdays it will close

at 6 p.m. as opposed to 9 p.m. City librarian Nancy Hunt-Coffey said cuts that impacted customer service least were

made. "We did try very hard to look at our usage patterns," Hunt-Coffey said. "What we found looking at the patterns is that last hour of the day, while we do have patrons using the library; it was the slowest hour of the day."

As well as weekly cuts in hours, the library will be closed on the weekends of 4th of July and Labor Day, not just the day the holidays fall on, as well as the weekends closest to Christmas and New Years Eve.

Although its hours are being cut, it is working to provide more online services such as: databases, research tools and e-books.

Hunt-Coffey said fulltime staff's schedules were being moved around and they would not be affected by the cut in hours.

"The people it will affect most are the hourly employees - the part time employees because they just wouldn't be working those days or those hours," she said.

The city is watching the library's and city's budget closely, Hunt-Coffey said, and if the economy changes the library's schedule might change too.

"If things get better they'll look at restoring things, if things get worse we'll have to look at cuts again," Hunt-Coffey said.

Architect Richard Best donates \$100,000 to help end world hunger



Architect Richard Best, who competed on and won the reality TV show "The Hydra Executive," donated \$100,000 of his share of the \$1 million prize to the United Nation's Intergovernmental Institution for Microalgae Spirulina Against Malnutrition.

The apprentice-style, real-estate reality show took place in the United Arab Emirates.

Eight contestants from the United States and eight contestants from the United Kingdom competed against each other to prove who had the best business mind and plan to win. The show took place in UAE's capital Abu Dhabi and was a way to introduce international entrepreneurs to the rapid growing real estate market in UAE.

Best learned about IIMSAM while working on the show.

"Once I learned about it, I couldn't help but feel there had to be some way I could contribute, and I had just won this huge cash prize," Best said. "It was a natural next step to make a donation to IIMSAM."

IIMSAM promotes the use of Spirulina, a type of algae, to combat severe malnutrition. Best was part of Charles W. Moore's design team for the Beverly Hills Civic Center Competition in 1983.

Andrew Lee Named Top Scholar from BHHS' Class of 2009

Andrew Lee was named as the recipient of the Faculty Cup, emblematic of being the top student in Beverly High's 2009 graduating class.

Lee, who will attend Harvard University, had a 4.75 grade point average, based on a 4.0 scale with an extra point being given for honors and advanced placement classes, Principal J. Guidetti said at Senior Awards Night June 17.

The Faculty Cup was first presented in 1932 and is the school's oldest award and the equivalent of a valedictorian award. It is traditionally based on seven semesters of work and presented to the student or students ranking first in the senior class. A variety of factors are taken into consideration in determining the recipients, Guidetti said.

Faculty Scholarship Cup recipients have their names added to a trophy displayed at the school.

The recipients also receive a financial award known as the Corwin Family Scholarship Award, established in 1990 by friends and associates of Beverly Hills resident Bruce Corwin to honor him for his support of the school and his commitment to community projects and charities, Guidetti said.

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, July 23, 2009, will hold a public hearing beginning at 1:30 p.m.* to consider:

An amendment to the Beverly Hills General Plan to adding a policy that would prohibit the subdivision of property into common interest developments in the City's commercial areas. The amendment would make new commercial condominiums and stock cooperatives inconsistent with the General Plan and, therefore, unlawful.

On June 16, 2009, the Beverly Hills City Council initiated the subject **General Plan amendment.**

The proposed General Plan amendment has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. Staff has determined that the proposed ordinance qualifies for a Categorical Exemption (Section 15305 of the CEQA Guidelines), Class 5, "minor alterations in land use limitations" because the ordinance would not result in any changes in land use or density. Further, as the proposed policy neither proposes nor enables development or physical changes to the environment, the amendment is exempt from CEQA pursuant to CEQA Guidelines Section 15061 (b)(3) because it can be seen with certainty that it will not have a significant impact on the environment.

Any interested person may attend the meeting and be heard or present written comments to the Commission. Comments may be submitted in writing to the Planning Office of the Community Development Department prior to the meeting date and written or oral comments will be accepted at the Planning Commission meeting at the date and time noted above.

If you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

Insider Election News

Power brokers take sides

IThe candidates should make the next gavel for the final weeks of his term, that has school board election very interesting, but what is likely to be even more intriguing is the back story: who and why the contenders will have as supporters.

Official filing begins on July 13 and ends on August 7 unless an incumbent does not file and then it remains open for five more business days. Two seats will be up for grabs Nov. 3.

As of now, we were able to confirm that Board President Nooshin Meshkaty will seek a second term and that she will face at least two strong challengers: Beverly Vista PTA copresidents Jennifer Terrell Schwartz and Jake Manaster, co-chair of the district's Facilities Advisory Committee. Manaster has been the most active in preparing for the campaign.

Still undecided is two- term board member Dr. Myra Demeter and several other possible candidates including Jonathan Prince, whose father, Martin, once served on the board and who has been an education activist.

As for their supporters, some early alignments, while not exactly surprising, will dominate discussions about this election. Board Member Steve Fenton has told this column that he will endorse and strongly work for the election of both Manaster and Schwartz and will not back Meshkaty, or Demeter if she files.

As for Meshkaty, she too will have a most powerful political ally. Councilmember Barry Brucker, a former school board president, has told us that he and his very politically savvy wife Sue will be co-chairs of Meshkaty's campaign.

Manaster will not only have board member Fenton's backing, he has signed Judie Fenton's FTA to handle his campaign.

The Fenton - Brucker relationship is very complicated. Although Barry Brucker very graciously made it possible for retiring councilmember Frank Fenton to complete his city service as mayor by officially turning over the not translated into any great affection for son Steve. It might take a highly skilled team of political psychologists to sort that all out, but it has more to do with personalities than issues. In any case, this election inevitably pits the two families against each other even though they may yet agree on one of the challengers.

As for Schwartz, she will very likely have campaign help from Linda Brown. Linda and her former mayor husband Ed burst back into the political arena after years of hibernation when they became heavily involved in John Mirisch's successful council race.

Wait, there's more big news: Dr. Brian David Goldberg, frequently allied with Fenton on board issues, including their joint effort to fight out of district student permits, has told us he will not "officially" endorse any candidate. This has more to do with Goldberg's feeling that elected city officials should not make endorsements. Some thoughts on that later.

Finally, Myra Lurie, who often cuts across battle lines in the education community and who is a very powerful and independent influence maker, has told us she has yet to decide on any endorsements, but would back her colleague Demeter if she decides to run.

Lurie is a member of a very powerful political family. Husband David, a Beverly High graduate and star athlete, has strong connections to school alumni and mother Sooky is a legendary civic leader.

The two Myra 's styles are very different. Demeter is far more confrontational while Lurie is often a mediator. They too have had differences, but not as frequently as those they have with Goldberg, and in a lesser way, with Fenton.

But Lurie said of Demeter: "She is probably one of the most educationally informed and knowledgeable people ever to serve on our board."

Although the board often seems to line up

on issues by gender: "The boys versus the girls," that has nothing to do with feminist matters. The permit issue was an example -Fenton and Goldberg mostly opposed, the three female members generally in support, although even here the differences were not always so sharp. Whether Lurie does back Meshkaty could make the difference in her election.

Back to Goldberg, although withholding endorsement, he is certainly more likely to give advice and help to Schwartz and even Manaster than Meshkaty or Demeter.

Why not endorse? I respect Goldberg's position on the propriety of endorsing colleagues or other public officials. However, I think the community has a right to know from those with the most intimate knowledge of the work of their colleagues, how they judge them. The one exception on which I would agree is board members endorsing members of the city council. This presents an obvious conflict since the council votes on providing funding through the Joint Powers Agreement. Not quite the same issue as councilmembers supporting school board candidates.

Generally, the more we learn about their endorsers and supporters, the more able we are to evaluate candidate's strengths and positions on issues.

Aside from the powerful Brucker clan, Meshkaty will also have the backing of the highly regarded Bosse family. Brucker told us that Jon and Lili Bosse will be co-chairs of Nooshin's campaign.

Even though we don't have slates, this election would take on a more definitive coloration if Demeter decides to run. It would be a more clear vote on present board majority policies. Although that isn't entirely true since Demeter and Meshkaty sometimes do go separate ways and even Fenton and Goldberg disagree on process, although mostly vote together.

Sometimes, in our elections, being the lone incumbent hurts, not helps the campaign. Best example was the campaign when Maxwell Salter and Robert K. Tanenbaum both won. They took very opposite positions on issues and it was thought that incumbent mayor Annabelle Heiferman would win and only one of them would be elected. They both won and Heiferman, despite the strong support of the Fenton's and their allies, trailed badly. (Side note: former mayor Tanenbaum has another best seller out: "Capture" Salter will have time to read the book when he has a minor procedure at Cedars Sinai today. Janet says nothing serious, very routine and Max will be out and greeting the next day.)

One of the most bitter school board elections some 30 years ago had a similar ending. Ruth Bard and Elinor Nathan were competing against a very popular male contender, with only one expected to succeed. They both won.

As for other endorsements, it will come as no surprise that the Teacher's Union will not endorse any incumbent and give their backing to Manaster and Schwartz. If Demeter does not run, and despite the Steve Fenton-Barry Brucker divide, Brucker could wind up giving his endorsement to Jake. However, his heart will be with Meshkaty.

I think we should be grateful that we even have qualified candidates running for school board. It is not a job that has many perks, draws limited interest during the election and is loaded with financial, union and future administration issues.

How deep is the disparity in voter interest? When Frank Fenton ran for Council in 2005 he received 4,568 votes. Son Steve, running for school board, led the field in 2007 in a very competitive and issue loaded election gathered only 2,718 votes.

Speaking of the teacher's union, their president Chris Bushee and his associates, made comparisons on district salaries that were surprising. They cited salaries of dozens of school districts that have higher levels of pay than our own. A 32-year teacher pointed out that his buying power has actually decreased through the years compared to teachers in neighboring school districts.

This assumption that people who work for our city and our schools are at the top of the pay scale has not been true for years. Our police and fire fighters too are now paid less than in many other departments. When things do return to some fiscal normality, those are problems the council and the board need to reexamine.

When Paul Koretz takes over as councilmember for the Fifth District, the Los Angeles political district that surrounds Beverly Hills, look for a far more cooperative relationship than we had with termed out Jack Weiss.

Koretz, a former mayor and councilmember in West Hollywood who most recently represented us in the state assembly, knows our community and had the support of many of our residents. This relationship will be most critical as Los Angeles considers massive development proposals on our borders.

And speaking of former legislators who had our respect, we lost one of our finest this week with the passing of former State Senator Herschel Rosenthal. Hersch was a true product of the Democratic reform movement and a strong ally of Congressmen Henry Waxman and Howard Berman. He and wife Pat were an incredible, inseparable team. He will be missed. Our condolences to his family. I was honored to have been his friend for over 30 years. We will miss his great good will and humor and his marvelous letters from his trips to Israel.

I can't begin to express my appreciation to that other newspaper for correcting an error in my column last week, and with a headline on page one yet. We goofed when we reported that the William Morris new home office building on North Beverly Drive, which we never liked, would become commercial condos. No, that possible plan is for their other properties on South El Camino and South Rodeo.

Not my first journalistic error. Years ago, when I worked at the Los Angeles Daily

(Law) Journal I failed to catch a mistake in a page one photo captions. We were running two pictures. One was of newly installed state bar president **Joe Ball** and the other of about to be executed **Caryl Chessman**, whose death penalty had become an international cause. So, under Chessman we ran: "Takes Over State Bar" and under Ball: "Dies Tonight."

Ball forgave me, but the House of Morris will probably not.

Another was my headline, based on some insider information from the Fox property owners, "Century City Will Never Get Off Ground." **Tom Korey**, one of those who emailed my mistake on Morris, but who was not yet able to use the internet when that headline hit the streets, does seem to enjoy his role as an unofficial editor of these works. But where was he when the "other paper" had this great headline: "Maple Counseling Center Helps Slaughter Victims." True, mine was an error in fact, theirs in grammar.

Final thought: If we really are as involved a community as we claim, just maybe the school board election will create enough interest to find a majority of our voters actually visiting the polls. Even better, why not become involved. Everything considered, we should be very thankful that some qualified and caring candidates are willing to serve. More later on issues and why some incum-





BHHS Girls' Basketball Team Wins Tournament

Forward Morgan Mason named as most valuable player.

The Beverly High girls' team won the Desert Resorts Boys and Girls Summer Basketball Classic, defeating Inglewood, 61-48 in Sunday's final, as forward Morgan Mason scored 36 points and was named as the tournament's most valuable player.

"I thought we played really well," said Norman assistant coach Charles Solomon, who guided the team during the absence of John Braddell, who had a football commitment.

"It was a matchup of size versus speed and I thought we did a great job getting up and down the court and forcing their bigs to run the floor and make it a fast-paced game. We dictated the pace."

The victory was Beverly Hills' second in 16 days over the Sentinels, the Southern Section Division III-A runner-up.

The Normans defeated Inglewood, 43-32, in the final of the Beverly Hills Regional of the Southern California Interscholastic Basketball Association Classic June 6 at the Swim-Gym. The Sentinels played without standout guard Hazel Ramirez in both games.

Beverly Hills center Chelsea Austin was named to the all-tournament team.

Point guard Natalie Moy also drew praise from Solomon.

"Probably half to three-quarters of Morgan's points in transition were because of Natalie Moy throwing over the top or running our fast break," Solomon said. "I think she did a very good job."

The Normans advanced to the final by defeating Chino Hills Ayala, 65-38, in a championship semifinal Saturday "in probably our best performance of the summer," Solomon said.

"We really ran very well," said Solomon, whose team had lost to the Bulldogs, 62-49, in the third-place game of the Southern California Interscholastic Basketball Association Classic in a game Austin did not play. "We saw what they did and we took it away."

Beverly Hills defeated Huntington Beach Marina, 43-28, Saturday in a championship quarterfinal, overcoming a 14-6 deficit early in the second quarter.

"We looked good the rest of the way," Solomon said. "We pretty much clamped down defensively the rest of the game."

The Normans began the tournament Friday with a 58-22 victory over a San Diego Mission Bay team that Solomon described as "way overmatched."

Beverly Hills played without starting forward Miranda Abdul-Mansour, who could be sidelined up to six weeks because of a broken bridge in her left foot, Solomon said.

"This year, we have a really special team," Solomon said. "They really have fun out there. They bond.

"Winning is nice, but it's important for the girls to have a good time. That combination of fun and winning carries us through the whole summer and gives us momentum."

The tournament was played at Marywood-Palm Valley High School in Rancho Mirage.

COVERSTORY IN SEARCH OF KURT HABER'S MILLIONS FILL Kurt Haber died with an estate worth more than \$8 million... but the story doesn't end there

Kurt Haber died with an estate worth more than \$8 million... but the story doesn't end there By Amanda Renner



Five years after his death, Kurt Haber's millions have yet to be laid to rest. Notorious for voicing his contrary opinions to the City Council, the 2001 Beverly Hills City

Council candidate legacy of stirring things up unintentionally lived on through the trust he left for his two closest friends: Dick Shapiro and Ismael "Mike" Soto.

The Weekly first reported on the controversy surrounding Haber's \$8 million trust in April 2005 (issue #287).

Since then, Soto received his share of the trust: 60 percent of Haber's money and bonds, a multi-family building in Cudahy, Calif. and Haber's Beverly Hills Swall Drive residence.

Shapiro, however, has not had such luck.

Since Haber's death Shapiro has been involved in three disputes: the White, Weinstein and Fields lawsuits.

Thomas White, chairman of the Beverly Hills Municipal League, claimed Haber made an oral agreement with him to leave White his Swall Drive residence. White was not named a beneficiary of the trust and later sued.

Despite having no interest in the property, Shapiro was still named a defendant in the lawsuit by First Bank and Trust, the bank handling Haber's estate. Because of this he said he had to pay \$25,000 of his share of Haber's trust in the settlement, as well as legal fees and costs Federal Bank and Trust incurred, and the separate counsel he hired to represent himself in the lawsuit. According to Shapiro, it cost him more than \$80,000.

Soto said White's case was not a strong one.

"[White] only had a very thin case according to his lawyer and the lawyer of the trust," Soto said. "He had no chance of getting it."

White declined to comment.

When Haber's original attorney of his trust Stanley Weinstien died, Shapiro said he failed to leave behind any filed documents, electronically or on paper, of the trust, which made it harder for the trust to defend itself against the White lawsuit.

According to Shapiro, the bank filed legal malpractice lawsuit against Weinstien because of this and settled for \$140,000 without Shapiro's knowledge.

Shapiro said this settlement was too low to cover losses of Haber's client files, settlement money from the White lawsuit and legal fees and costs that the trust and Shapiro accumulated in the process. Ultimately, Shapiro alleged the settlement "cost" him more than \$80,000 as a beneficiary.

"If I handled my business the way they handled this trust, I wouldn't be in business today," Shapiro said.

Similar to the White lawsuit, the Fields case involved Haber's Swall Drive residence, which Shapiro said he was still uninterested in.

Ira Fields, a tenant at the Swall Drive residence at the time, filed a lawsuit claiming per-

sonal injury due to mold exposure caused by a ruptured sewer line. Early on in the lawsuit, Fields had agreed to escrow the rent; however the

bank still

attempted to evict Fields, and again, named Shapiro as a defendant in their lawsuit, which racked up more lawyer fees for his defense.

"I've gotten involved in two lawsuits over a house I have no interest in," Shapiro said. "The longer they keep this thing going the more they're going to suck out of the trust, it's that simple."

Shapiro is still battling for the 40 percent of money and bonds Haber named to him and his never-ending court battles still continue.

Shapiro's newest court date is today, June 25, at 8:30 a.m. He is petitioning for removal of the trustee. Soto received his share of the trust, Shapiro said, and he said in his petition once his share is distributed the Haber Trust can laid to rest.

Eli Blumenfeld, a Beverly Hills tax attorney, said if there is no question as to if he is a beneficiary or not, there is no reason for the bank not to distribute his money.

"Normally a trustee would withhold

some property back in the event there are other claims," Blumenfeld said. "But why they would distribute it to the other fellow and not Shapiro, I don't know. You think you'd want to withhold from both."

Soto did not return calls by press time.

"I'm more than prepared to take them to trial and however long it will take that's how long I'm prepared to go," Shapiro said. "I figure it will take maybe another three or four years."

First Bank and Trust had fiduciary responsibilities that went unfilled, Shapiro said.

These duties, which Shapiro stated in his petition for removal of trustee, include:

Administering the Haber Trust solely in the interest of the beneficiaries

Fully disclosing any facts or information surrounding the trust

Superior Court in 1992. The court ruled in favor of the plaintiff, who accused Wells Fargo of breach of trust and fiduciary duties, as well as statutory fraud against the beneficiaries of Robert L. Gump's trust.

Haber, originally from Germany, fled the country with his brother Alfred during the Holocaust.

Unable to cross Argentina's borders, where their father's family was, Haber and his brother moved from country to country until they were able to bribe an Argentinean official into letting them into the country.

When Haber and his brother came to the United States, they were each others only living family members. Alfred committed suicide about a year and a half before Haber's death.

Haber met Mike Soto in 1971, a year after he started his steel fabrication company. What started as a working relationship morphed into a bond that stayed strong long after Haber retired 21 years after he and Soto started working together.

In issue 287, Soto told the Weekly he and Haber were more like family than coworkers.

"I was taking the rent to [Haber] every month, and we used to go to have breakfast the first of the month," Soto said. "It was a tradition every month, or sometimes we got together for dinner, or for his birthday we used to go out. That's how we kept in touch for so many years."

When Haber died May 8, 2004, it was Soto who paid for and made his funeral arrangements. He was buried in the Soto family plot next to the space reserved for Soto.

The Oct. before Haber passed, Soto signed the Kurt Haber Living Trust.

Shapiro met Haber at a Beverly Hills social event in the 1960s and, despite their opposing political views, the two remained close. He was unaware he was a beneficiary to Haber's trust until after Haber's death.

Shapiro's voice hardened as he talked about how his anti-tax and often financially frugal friend would respond if he knew how his trust had played out after his death.

"He would be rolling in his grave," Shapiro said. "Heck, he'd be so angry; he'd probably be doing cartwheels."

Section 2. On May 13, 2009, the City Council held a duly noticed public hearing to consider the recommendations of the Environmental Utilities Manager to implement ceiving water conservation Stage "B." After receiving oral and written testimony, including the agenda report, the City Council hereby determines as follows:

Water Conservation Stage "B" is hereby (a) declared throughout the City of Beverly Hills and the City Council hereby directs that the Environmental Utilities Manager implement Water Conservation Stage "B" as set forth herein.

The Environmental Utilities Manager and/or (b) appropriate City Staff shall hereby communicate to residents, visitors and businesses the following mandatory water conservation measures for implementation: restaurants shall serve water upon request only; (ii) all public restrooms in the city and private bathrooms in hotels shall notify patrons and employees of water con-servation goals; (iii) plumbing and irrigation leaks shall be repaired within seven days notification to the property owner by the City; and (iv) water usage shall be reduced to ninety percent (90%) of the baseline year amount as determined by the City Manager; and the watering of lawns and other landscape shall occur in accordance to a watering schedule promulgated by the Environmental Utilities Manager. In addition to these elements, the City Council hereby authorizes the City Manager or his designee to implement other mandatory water conservation elements as determined necessary by the City Manager in order to achieve a ten percent (10%) reduction in potable water use.

(c) A water penalty surcharge of up to two (2) times the basic water rate shall be charged for water usage in excess of ninety percent (90%) of the baseline year amount as determined by the City Manager.

(d) Violation by any person of the stage "B" mandatory requirements described in subsection (b) shall constitute an infraction and, upon conviction, shall be punished by a fine not to exceed one hundred dollars (\$100.00). The violation of each element described in subsection (b), and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly.

Section 3. In accordance with Beverly Hills Municipal Code Section 94303.B, the City Council her by directs the City Clerk to publish this Resolution at least once in vspaper of general circulation within the city and to a ne post this Resolution in at least three (3) public places and continue to post this Resolution until such time as the restrictions set forth herein are repealed by resolution of the City Council.
