

I read Rudy Cole’s piece last week and found it quite interesting, especially the idea that there is real value in having more attorneys involved in our city government. Among some, this may seem counter productive and perhaps even sacrilegious, what with the historic attitude and endless jokes about lawyers. And while I may be guilty of having told my share, Rudy’s suggestion actually makes perfect sense to me.

None of us need be reminded that we are living in an increasingly complex legal climate. There can be no doubt that Beverly Hills will be faced with more than its share of challenges as the city works to maintain the quality of its historically renowned services, and navigating that maze is something at which lawyers excel.

I remember hearing Lou Milkowski, an attorney, who at the time was the head of traffic and parking, discuss issues relevant to an item before his commission. I was struck at the clarity of his questioning, and his grasp of the fine points of current and future issues. Against a background of ever-evolving tests, I have to agree that Beverly Hills can clearly benefit from its large legal population and that there are a number who will be willing to participate in city government and, as they say, step up to the plate and be counted. I would like to encourage Lou Milkowski to consider running for city council and continue to offer his educational training and background to our City.



Beverly High grad who went missing on Ecuadorian hike, found

Jocelyn Karlan, a 2008 Beverly High graduate, and two peers were found in

Ecuador Monday night by a police helicopter, according to reports from the Associated Press and other news outlets.

"I think it's any parent's worst day of their life," Beth Karlan, Jocelyn's mother said. "All we did was rally every resource we could even dream of and get everyone on the mountain to find them."

Jocelyn was reported missing Sunday morning after her and two others were separated from a group of about a dozen who were hiking up Imbabura, a more than 15,000 foot inactive volcano in the northern Andes Mountains.

Beth Karlan said after seeing the community pull together to find her, Jocelyn has a new appreciation for community efforts.

"I did always believe in my heart that she was going to be found and return safely to the school," Beth Karlan said. "She is going to stay for the rest of her committed time to continue her teacher responsibilities."

Jocelyn, who will be a sophomore at Harvard University, has been in Ecuador for the summer working with the Village Education Project, which helps tutor children who do not have the means for sound educations.

Jocelyn was featured in the 2008 graduation issue "All Grown Up" (issue #455).

The Weekly recently interviewed Jocelyn's brother, Matt, in issue #510 "From Beverly Hills to the south side of Chicago."

City Council supports Iranian civil liberties

Following the U.S. House of Representatives, U.S. Senate and City of Los Angeles, Beverly Hills City Council

voted 5-0 at its Tuesday City Council meeting to support Iranian civil liberties.

The resolution provides "a strong statement in support of fair and democratic elections, freedom, and human rights in Iran," according to the staff report. It also condemns violence and "the oppression of independent reporting and communications from Iran."

Councilmember John Mirisch said

while he is happy the resolution passed, he would have liked for it to take a stronger stance.

"I think we need to emphasize that we're in favor of a separation of church and state in Iran," Mirisch said. "That we oppose their denial of the holocaust, that we oppose their oppression of Jews, their totalitarian society in general and also their attempt to get nuclear weapons. If there is a way to include all of this I think we need to be as strong as possible to support something which has so negatively impacted our residents on a personal level."

Vice Mayor Jimmy Delshad, who

said at the council's study session he was invited to meet with the general secretary of the UN, said while he was trying to follow in the steps of what the government passed, he would not have minded going into more detail.

"If I have this in my hand [when meeting the general secretary of the UN] it would significantly improve my chances of telling them what our city stands for," Delshad said.

Delshad said he was "impressed with the degree at which the City Council supported the resolution."

Robbins Drive shooting victim dies

A Caucasian male in his 50s who was treated on the scene for a single gunshot wound Thurs. July 16, later died, Lieutenant Tony Lee said.

Lee said the Beverly Hills Detective Bureau is "aggressively investigating" the shooting that occurred shortly after midnight on July 16 in the 9000 block of Robbins Drive.

"It's a mystery right now," Lee said. "Whether it's a suicide, an accidental shooting or a homicide, it's still a mystery."

The area, which is between Moreno and Lasky Drives, is a little more than 350 feet from Beverly High.

"It's considered mostly an apartment area," Lee said. "About 90 percent are all apartments in that area."

The last shooting in Beverly Hills occurred Dec. 1, 2008, resulting in the death of Scott Ruffalo.

Bomb threat was not made in Beverly Hills

Despite reports of a bomb threat made at a Beverly Hills Hotel, Lieutenant. Tony Lee said the Four Seasons where the incident occurred is located just outside of the city, on Doheny Drive.

"LAPD responded to it, but I had at least four news media outlets calling me this morning asking about," Lee said.

He said bomb threats are becoming more common.



new information until September," Manaster said.

He said they reviewed proposed budgets for each school, but the committee is not close to finalizing anything.

"Hopefully the board will be getting a presentation of schematics and associated costs and timelines [in Sept.]," Manaster said.

Karen Christiansen, facilities program manager for BHUSD, said they are in the schematic design process for Building M.

"They're going through possibilities of what the building will look like," Christiansen said.

Last month, the Board of Education voted down a proposal for a new administrative building at the high school, with one board member claiming "it's too big."

Most of the work being done at each school, with the exception of Horace Mann and Beverly High, is inside the building and deals with seismic and safety issues he said.

Most of the work is slated to start late 2010 and be completed by 2014, Manaster said.

The annex building at Horace Mann was demolished and is now in the process of being cleaned up, Christiansen said.

She said the last wall of the building took a little extra work because they found a higher level of asbestos in it.

"It's mandated by law and there is a special contractor that does that on call," Christiansen said. "Whenever we hit anything like that, that is unforeseen we call

them and then they go through their containment area to handle it."

After the site is cleaning up, Christiansen said it will be paved over for additional play space.

Norman Girls' Basketball Star Injured

BHHS seeking new boys' lacrosse coach.

Morgan Mason, Beverly High's first-team All-Southern Section Division II-A forward, sustained a knee injury Saturday that could cause her to miss the 2009-2010 season, assistant coach Charles Solomon said.

Mason was scheduled to undergo a magnetic resonance imagery examination Wednesday, with results expected Friday, Solomon said.

The examination was delayed until the swelling in the knee was reduced, Solomon said.

Mason sustained the injury in the first minute of the second game of a San Diego Classic game against Chino Hills Ayala.

"It was just one of those things where it was completely a freak accident," Solomon said. "We threw a ball long to her, she was on a breakaway layup and she just landed wrong. No contact, no nothing."

The game was delayed for 20 minutes and Mason was taken by ambulance to Scripps Memorial Hospital La Jolla, Solomon said.

Mason may have injured her posterior cruciate ligament because the injury was on the side of her knee, Solomon said.

The Normans won four of six games in the tournament, opening play with a 44-20 victory over Coronado last Thursday at Alliant International University.

Beverly Hills led 18-15 at halftime against a team Solomon said "probably shouldn't have been in our division," and was winless in the tournament.

"We were absolutely flat," Solomon said. "The girls responded at halftime. It took them a half to get going."

Playing with just six players for the second consecutive game, the Normans lost to state Division V champion Burbank Bellarmine-Jefferson, 53-42, Friday at RIMAC Arena at UC San Diego.

Beverly Hills led 33-31 with about 10 minutes to play.

"Their speed and tempo they play at... just wore us down," Solomon said. "I was very pleased with our effort."

The Normans scored the first 14 points in a 47-21 victory over Anaheim Esperanza Friday at RIMAC Arena in a game Solomon said he "was nervous going into" after seeing the Aztecs "give La Jolla Country Day," a San Diego Section Division IV semifinalist "a really tough battle."

"They're a very slow and deliberate team that runs a lot of screen and has good shooters," Solomon said of Esperanza, which lost in the second round of the Southern Section Division I-A playoffs in February.

Beverly Hills played what Solomon called its best game of the tournament in a 60-44 victory over Phoenix Pinnacle, the Arizona Interscholastic Association 5A Division II state runner-up, Saturday at RIMAC Arena.

"They're a very, very smart and they shoot the ball extremely well," Solomon said.

The Normans trailed 19-11, then "Morgan took over the game," going on to score 37 points, Solomon said.

The scored was tied 40-40, then Beverly Hills outscored the Pioneers, 20-4, to close the game.

The Normans lost to Ayala, 41-30, Saturday at RIMAC Arena, giving up 15 unanswered points after Mason's injury. Beverly Hills led 23-19 when Mason was injured.

Following the injury, the Beverly Hills players "were worried about Morgan, understandably so, and couldn't focus on the game," Solomon said.

The Normans concluded the tournament with a 33-28 victory over Santee West

Hills, the San Diego Section Division II champion, Sunday at RIMAC Arena.

"I was really proud of the girls," Solomon said. "I didn't think we would win the game. Our defense was solid. Natalie Moy came up big with 14 points. The girls really responded."

Mason gave a speech to the team before the game in an attempt to motivate it.

"She could have gone home and she didn't," Solomon said. "It shows the character and type of person she is."

Lisa Kliman "had a nice tournament," averaging two 3-point baskets per game and giving the team an outside shooting threat, Solomon said.

Boys' Lacrosse

Beverly High has not renewed the contract of coach Tim Ray, which "was not a reflection on him," Principal J. Guidetti said.

"Tim did a great job," Guidetti said. "He's a very good coach. He knows the game inside and out."

Guidetti is seeking to have a faculty member coach the team. Ray was a walk-on coach who is an environmental consultant.

"Coaches have to be more than coaches," Guidetti said. "They have to do fundraising, they've got to do PR, they've got to be administrators. It's a thankless job. That's why if you have someone on campus it's much more beneficial for the program. It's easier for the coach."

Ray had coached the team for eight seasons, the first five when it was a club

team, the last three as an official varsity sport.

Ray said he received an e-mail at the end of May from Gary Greenbaum, who handled various administrative functions for the team, saying he would no longer be the coach.

"Carter said that wasn't true, that they were actually just looking to get rid of Gary and the JV coach and that I was more than welcome to stay there," Ray said, referring to then-athletic director Carter Paysinger, now an assistant principal whose responsibilities include overseeing athletics.

"We're trying to set up a meeting where we could both sit down and talk and discuss what's going on and that's kind of where it was kind of left."

Ray said he is moving to New York, but plans to spend one week a month in Southern California "and I was looking to help out."

"I wanted to sit down and talk to them what politics were involved and how I got caught up in it and make sure I'm not involved with that," Ray said. "If I have the option of helping out, that's more or less what I'm looking for."

Greenbaum said he "has nothing to do with" with the school's lacrosse program anymore, but will remain involved with the Beverly Hills Lacrosse Club's middle school and post-collegiate men's programs.

Greenbaum said he "was fired two days" after encouraging "parents to con-



Hotels Need Help

Mayor needs calming

Although our hotels are probably doing better than those in other tourist destination areas, they too are hurting. If they are impaired, we will all feel the pain in losses of city revenue.

The decline in occupancy is probably across the board, but less so at the Beverly Hilton and the Peninsula. The Montage Beverly Hills, probably one of the most exciting new hotels to open in California in decades, and under the highly able management of **Ali Kasikci**, could not have picked a less productive time to enter the market.

The more you see of the Montage, the more you appreciate its appeal. From service to design, it is remarkable. Aside from the pure beauty of the hotel, the staff is universally excellent and highly professional.

The Beverly Hilton continues to reinvent itself. Under the direction of their new general manager, **Sandy Murphy**, you can feel and see the upbeat ethic at every hotel level, including a zealously friendly wait staff in Circa 55 and Trader Vic's.

Defying the economic gloom, the pool area has become the new Luau as a bustling coming together venue for young professionals, although I did spot some gray hairs among the yuppies. The hotel will soon be showing classic films on a mammoth screen near the Olympic size pool. The most recent was Casablanca.

Despite all the inevitable rumors, the Hilton has no plans to abandon creation of the Waldorf Astoria. Incidentally, sources have also told us that 9900 Wilshire may soon be refinanced and restructured although earlier talk about a possible hotel at the site are not now even being considered. This project too will add to the economic sustainability of the city and finally beautify our most important gateway. We all have an interest in wanting it to become reality.

Old sermon, but more valid than ever: Become boosters for our hotels, restaurants and shops. We need the money. If you have friends coming to town, don't let them stay at the airport, Century City or other environs that send tax dollars to Los Angeles – keep them here and help our own economy and our city services.

Speaking of tax dollars, and the Gilbert and Sullivan topsy-turvy world called Sacramento, the state will be raiding our treasury for some \$3.5 million, through a grabbed loan impacting cities and counties throughout the state.

City financial officers are suggesting that we borrow that amount from our reserves to help ease the pain caused by the city's own financial revenue losses.

That we even have such an important safety valve as a comfortable reserve is something we accept without appreciation for the leader-

ship of this and past city treasurers and city councils. Wise and prudent city management of resources by city staff and city councils, and investment programs by elected city treasurers including **Joan Seidel**, **Frank Fenton** and incumbent **Eliot Finkel** have made this happen.

Last Tuesday's council meeting dragged on until past 2 a.m. despite an earlier plea by Mayor **Nancy Krasne** to require adjournments at a set, earlier hour – I think she proposed midnight.

Not the first time a councilmember balked at a late night show. Then Mayor Dr. **Charles Aronberg** made similar arguments against fatigue loaded meetings in 1979, suggesting an ordinance forcing shutting down at 11 p.m.

The rule was adopted, but to Dr. Aronberg's displeasure, seldom followed when his term as mayor ended.

Now, I want to discuss a problem that I have hesitated to write about: the acrimony and lack of collegiality on the council, and especially the role of the mayor, **Nancy Krasne**, and her treatment of colleagues, city staff and people appearing at meetings.

First, some positive reports: Mayor aside, this council has come together in many ways that would have been hard to predict. Our two newest members, **John Mirisch** and Dr. **Willie Brien**, are very creative additions to the council.

Mirisch is not the sardonic, blistering blogger who managed to anger a small army of targets; he is now both rational and reasoned in his role as a team player. What is also positive is John's good working relationship with Councilmember **Barry Brucker**, who was a frequent target of a Mirisch blog.

Dr. Brien is clearly the voice of reason and restraint on the council. His clear thinking, his careful approach to issues is invaluable. As one example, as the council seemed prepared to immediately support a state initiative requiring voter identification, Dr. Brien issued a responsible warning note assuring a calmer look at the proposal. Being pushed by a conservative Republican senator, **George Runner**, there are many complicated civil liberties issues involved, all needing vetting before Beverly Hills adds its name to the effort to place the matter on the state ballot.

Speaking of Brucker, one of his best talents is as a presiding officer. As president of the Board of Education and mayor, Brucker kept his calm even when some hostile, even irrational people attacked him or some other colleague.

Brucker's courtesy and even handed gavel handling is something Mayor Krasne could emulate. In fact, the mayor needs to remember her own more reasonable handling of staff and citizens when she was a commissioner.

The **Nancy Krasne** we are observing as mayor is not the same person I used to see when she served on the architectural and planning commissions. Yes, she was often unpredictable, unwilling to conform to rules of procedure, but she was always courteous to colleagues, had a good working relationship with most staff members and polite to people who appeared at public meetings.

Something is very wrong. This **Nancy Krasne** has problems and issues, and it is impacting her relationship with her fellow councilmembers and many, but not all, staff members. More important, it has hurt her own wish list for the city.

How bad is it? Tuesday night a resident not known for being a community activist identified with some of our more volatile battles was watching the council meeting on her TV. She was so offended by how the mayor spoke to our city attorney, that she quickly dressed and rushed to city hall to be heard.

"Mayor Krasne," said resident **Debbie Supnik**, "I am very offended by the rude and insulting way you treated our city attorney, whom I have never met. But he deserves to be given courtesy and respect."

How did Krasne respond? "I am sorry I was bad, I will wash out my mouth," she said and, turning to an embarrassed and obviously uncomfortable city attorney. Asked if he would accept her apology, **Larry Wiener** nodded his acceptance.

But she has also been confrontational with many of her colleagues, has publicly made it clear she has issues with Brucker, tried to cut off Mirisch and diminish his position on a medical office use moratorium, and entered into a total war with our departing city manager.

Last night, many speakers on agenda items felt her wrath. I don't know what happened in the chambers because I was watching at home, but at one point she ordered the police to throw someone out of the council meeting. Now, people can be loud, and even out of order, but a warning usually does it, not police action.

At least Krasne was an equal opportunity confronter. One of her strongest supporters, **Judy Okun**, felt her annoyance when she asked for more time to finish her arguments on an agenda item. There's a way to cut people off without being angry and insulting.

Understandably, with a long agenda, Krasne wanted to move quickly through two important public hearings. First, she cut speaker's time from three to two minutes and then she told those appearing that they should not repeat what others had said!

Nothing wrong with suggesting that speakers simply say they agree with what someone else already said, but to demand that they not echo someone else's words is probably a violation of the Brown Act, and even if it isn't, we treat people with more tolerance in our city.

The other side of Nancy is the knowledgeable public servant who does her homework, and really understands land use matters. I did try to discuss this with Nancy, but did not hear back before my deadline.

The two issues that drew most attention at

Tuesday's meeting involved parking on the street next to church row and a design dispute on South Rodeo Drive. Both were finally resolved and probably not to everyone's satisfaction. However, there does seem to be a serious problem on Parkway, the strange, short street north of the churches. Residents have reasonable concerns about parking; youth hang outs, food and tourist trucks and other activities that have become a police problem. More on this later.

On another city issue, don't give up your law license to become a city park trash collector at \$50 an hour. That salary reported in another publication, is a stretch of reality.

In an editorial and news story, the claim was made that park maintenance workers were paid nearly \$50 per hour to "tidy up our parks."

Yes, newspapers just love to "expose" these kinds of governmental gaffes. Who can forget the disclosure that the Defense Department paid \$600 for each toilet seat?

However, the facts are not quite as reported. The \$50 is the cumulative cost of trash collection, not the actual pay for any city worker. Included are not only the obvious side benefits, but more important, the costs of support from many others. As an example, since this is an assigned task, the supervisor who monitors the collection, the supplier of tools and more all figure in the hourly cost, not just the pay of one trash collector.

Sort of like saying the President's salary should include money paid for secret service protection. Yes, costs of operations, but not take home dough.

Time for a break? When we reviewed some night time resources in our business area, we hadn't yet heard about the fine fare being offered by, yes, a restaurant called "A Cow Jumped over the Moon."

The eatery once occupied a carved out area in the bottom floor of the Rodeo Collection and found an appreciative audience for its healthy, kosher offerings.

Now it has moved into the more luxurious digs once occupied by a very formal, kosher steak house one floor up. Every Tuesday, Wednesday, Thursday and Saturday evenings there are presentations of big bands or gypsy guitars or a Sinatra sound and look alike. Sunday brunch includes good jazz with Levytan. (Rodeo Collection, 421 North Rodeo Drive.)

Seen at the Montage Parq: **Vicki Reynolds** and **Murray Pepper**, **Steven Fenton** and **Fred Hayman** and at the Peninsula, the Brucker's. Although Murray and Vicki have a great marriage as do **Pepper Salter** and **Joe Edmiston**, us pundits often thought it would have made great copy if somehow the Salter family sibling had married Murray. How we would have loved to write; Mrs. Pepper Salter Pepper. Yes, obviously time to close the column.

MAKING BEVERLY HILLS BEAUTIFUL

The Weekly's exclusive interview with Design Review Commission chair Hamid Gabbay

Hamid Gabbay is serving as chair for the design review commission for the second time since the commission's beginning. Gabbay talked with the Weekly to discuss the ins and outs of his job as chair.

Tell us about the Design Review Commission.

The Design Review Commission basically reviews the exterior of the projects that in the so-called "flat" area of the city are proposed to be built. We look at it from a point of being harmonious with the neighborhood, being pure architectural style and from the point of view of proportions, landscaping, interesting features, etc.

How does the Design Review Commission differ from the Architectural Commission?

It's actually just the type of projects that distinguish the two commissions. We do houses only. The architectural commission does the commercial and condominium projects. They do apartments and condos; we do single family residential only. Also, the Design Review Commission is formed of five commissioners, Architectural Commission has seven commissioners. But these are the only differences.

What is the prevailing style of house in Beverly Hills right now?

First of all, I wouldn't necessarily call it style; it's more than anything else an expression of the architects or the designers that design it. If you'd like to call it a style, it would be what most of the time is called Italianate. But we are seeing other projects. We are seeing a lot more contemporary design projects.

What do you mean by contemporary designs?

The quality of design for the contemporary houses is far superior than other projects that come to us. They are usually done by rather famous architects or at least well known architects. The other styles are a more common approach to houses.

You said some were done by famous architects. Who are some examples of those architects?

Just off the top of my head, we

What is the commission is working on now?

Lately, our work load has been little lighter than usual. Because of that we came up with a program to have famous architects come to our commission and make presentations to the community of their work. It has been very, very successful. For example, our next architect who will be presenting his work to us is Marc Appleton. He will be coming on Aug. 6. He is most famous for what he has done with what is called the "Santa Barbara" style, which is really a gorgeous style of architecture.

What is your goal with this program?

We don't want residents to feel limited to a certain way of architecture. We would like them to know and see the work that is being done by other architects and how [houses can] look. That it's not only doors and windows with molding around it and a roof on top of it.

How did you get involved with the commission?

About six years ago the city was researching to come up with a solution to have more control over the development and the exterior design of houses. At the time the City Council appointed a few residents and commissioners from the Architectural Commission, the Planning Commission and the Fine Arts Commission to come up with solutions of what to do. The result of that research was that we should form a Design Review Commission and not just regulate and review by numbers. That design is more than numbers. So that is how this commission was created. Susan Strauss and I were part of that group, and I was the first chairman of this commission. Now after a few years I am the chair again and Susan Strauss is the vice chair of our commission.

What commission were you apart of when you were appointed to the research group?

I started with what is very similar to what we have now, it was called R1 commission. Then I went to the Planning Commission. From the Planning Commission I went to the Fine Arts Commission and finally I am on the Design Review Commission – I guess I like to be involved.

What are the challenges of working on the Design Review Commission?

That is a very good question. It is a very difficult task to be honest with you. Dealing with people's houses it is always very emotional. Usually, since I'm an architect myself, I understand that clients spend a lot of time with their architects. They work out the floor plans and they look at it and love it. Then they come to our commission and there are times where we necessarily don't see it from that point of view. So sometimes it can be emotionally difficult.

reviewed a project last month designed by Mexican architect [Ricardo] Legorreta. The house was designed apparently by his son [Victor Legorreta]. They are partners in an international firm.

In the history of the city we have had buildings and houses designed by very world renowned architects. If you look at Santa Monica Boulevard, or what is called "Little Santa Monica," it's an architectural promenade starting with Paul Williams and Allen Greenberg. There are several architects in just that small piece of street going from City Hall to west of Wilshire who have their own imprint there.

Where did you get the idea for this program?

When I became chair of the commission. I decided that we should be seeing and presenting to the public what really good architecture is, as far as home designs go. Not only for us as commissions, but the public should see what is being done. So we started this public presentation series. The first speaker was Michael Palladino. He is an associate with Richard Meier, they have done the Museum of Television and Radio. He presented houses that he designed, which were really unbelievable. And we had a lot of public in attendance and everybody was very impressed.

cult to deal with. We have learned to respect the wishes and tastes of the residents who have realized their dream of having their own castle. It is difficult from that point of view, but after a few years and being on a few commissions we have been able to reach that [equilibrium].

What do you like about working on the commission?

In my opinion, being apart of any commission in the city should be considered a privilege. I've always felt privileged that the City of Beverly Hills has picked me to look into these projects. I always felt honored because of that. For me, more than anything else, it's seeing these houses and achieving a balance between the desire of the homeowner and the goals of the city. For me that challenge is very interesting and I like it. Especially when we arrive at a solution that is acceptable to both us as the commission and the residents. That is a very pleasant feeling.

Is there a project that you work on that you're particularly proud of?

I can tell you about the projects that we've rejected and are more proud of. There have been times when we have been presented with projects that were horrible and I knew that if they went up it would have been an eye-sore. And we were able to spend time and work with the client and the architects or designer, and we stood firm and didn't accept some compromises. The final results are better sometimes when we make it clear to the designer that their solutions are unacceptable and that they should come back with better ideas. Those are the ones that are more important in my opinion.

What would qualify something as unacceptable?

We are open-minded about everything that is being presented to us. We are not prejudice about anybody or anything or any style. I always thought that bad architecture is like pornography. When you see it, you know what it is. I can't define what is good or what is bad, but I know what it is when I see it.

How do you feel that you and the other commissioners work together as a team?

We work very well together. There is a harmony and understanding of each other. Not that we always agree with each other, after all, this is a matter of taste and interpretation of criteria. But we are a harmonious commission.

What is your professional background?

I have had my own firm with my brother and partner, Yassi Gabbay, for more than 20 years in the city. Our firm has always been in Beverly Hills. We are one of the few architectural firms left in the city.

What is it like working with your brother?

It's pretty good. We have been partners since 1988, so it must be good. We have created a pretty good balance. We enjoy each others' point of view, knowledge, criticism and differences.

Tell us about your family.

My wife's name is Nahid. We have

been married 37 years. I used to go to school with her brother and because of that I used to see her. Then she went to school in New Jersey and I went to school in Florence, Italy and we didn't see each other. But when I got back to Iran, she was back from New Jersey also. And that was it; the rest was history as they say.

We have two children, Joubin [class of '92], our son who is a surgeon, and who is engaged to Tiffany Ganjian. My daughter, Nilou [class of '93], is married to David Noruzi. They live in Little Holmby, just next door to Beverly Hills. And they have two children, my grandchildren, and their names are Sophia and Benjamin. They are twins who are almost seven.

What are your plans after your term as Design Review Commission chair ends?

That is about two years away and it will be depending on where I am and what I would like to do. I don't mind staying in the city, I enjoy that. So I will see how it goes.


