## Beverly Hills High School media center

In 2000 all the analogue video equipment and studio in the Beverly Hills High School Media center was upgraded and rewired at considerable expense. The Media Directors' plan was to preserve the analog studio as an additional training facility to complement the recently purchased digital equipment studio that was to be installed in an available and separate section of the Media Center.

Despite TV's digital conversion, analog procedures and equipment continues in video editing and production today and is a valuable asset for the Media Center and the BHUSD.

The plan to utilize this studio and equipment in conjunction with the newer digital studio, was circumvented by [assistant superintendent] Cheryl Plotkin. She was obviously unaware or misguided about the practical value of what was already in place and was so valuable. This analog studio, with a value of \$150,000 to \$200,000 was removed by an outside contractor and locked in a storage bin where it is of no use to anyone. The cost of the equipment upgrading, outside labor required, and that of converting all the Media Centers archival videotapes for digital application, must be added to this unnecessary expense and waste.

This action was taken by an outside contractor under the direction of Ms. Plotkin without the knowledge or consent of the Media Director or the school principal! The Media Director was hired because of his experience and knowledge in such matters and should have been consulted about this change of plan. Instead it was done surreptitiously while he was not present.

This needless expense by the school district's representative has to be viewed in light of the BHUSD's \$1.3 million dollar deficit, the probable \$1.3 million cut from the upcoming school year's budget and the proposed cut in teacher's salaries. The high school has a valuable asset that should be put back into service and not allowed to turn into chemical waste.

## Council denies 90210 zip code boundary clarification proposed by Mirisch

The City Council snuffed out further discussion in the near future of gaining exclusive rights to the Beverly Hills

90210 zip code at its study session meeting Tuesday.

Councilmember John Mirisch requested information on starting the U.S. Postal Service's zip code boundary review process, according to a staff report.

"I think the time has come for us, Beverly Hills, to become one city under one zip code," Mirisch said.

The other members of the Council opposed Mirisch's stance.

"I'm sure we would be having a different discussion here today if our neighbors to the north were applying to the U.S. Postal Service to have their area north of us solely inclusive of 90210 and asking us to have a different zip code," Councilmember Willie Brien said.

Part of Beverly Hills most famed zip code, 90210, is in the Beverly Hills Post Office or BHPO, which, despite its name, is in the City of Los Angeles.

Those residents vote in City of Los

Angeles elections and attend schools in the Los Angeles Unified School District. However, because they live in Los Angeles and have a Beverly Hills zip code, confusion is created when it comes to municipal services, the staff report said.

Mirisch said two of his reasons for wanting to start the review process were to create a better sense of community in the city and to address the issue of safety in the area that wears the Beverly Hills zip code, but is not part of the city.

"It [90210] is one of few zip codes that is known through out the U.S, perhaps the world and it is also so closely identified with the city, [unifying zip codes] would allow residents in 90212 and 90211 to feel like they're part of the club," Mirisch said. "More than that there is the issue of safety. We don't want to have the police and fire not come to someone's aid because they have a Beverly Hills zip code or Beverly Hills address but live in Los Angeles."

One example of this confusion was reported in "City Considers Angelo Drive Annexation" [issue #507]. Although the property was not annexed into the city, the owners experienced frustration when one of their security cameras was stolen. They initially called the Los Angeles Police Department, who told them they did not live in Los Angeles and it was a matter for the Beverly Hills Police Department. However, upon calling BHPD, they were informed that they did live in Los Angeles and it was a matter for LAPD.

Mirisch said this isn't an uncommon problem.

"The fact that we are getting letters and there are things that have come up to the Council that indicate confusion among people who live in L.A., either when it comes to services or other aspects, certainly leads to another reason to do this," Mirisch said.

Barbara Nichols, vice president of the Benedict Canyon Homeowners Association, which represents 6,000 to 7,000 residents in the BHPO, said as a real-estate broker, the confusion described isn't that big of problem.

"We have not had in the 23 years I have lived here the degree of confusion in city services that has been pointed out," Nichols said. "Real-estate agents are very careful to let people know that they are not within the boundaries of the City of Beverly Hills and therefore do not have the services of the public schools, the police department or the fire department."

Brien said while he understands the desire to unify Beverly Hills under one zip code, he doesn't want to jeopardize the city's relationship with its neighbors.

"This will create very unfriendly relations with our neighbors to the north and other areas," Brien said. "This is not an item I want to engage in right now or anytime in the future."

## City Council supports subway extension

In a 5-0 vote Tuesday, the City Council voted in support of the planning, development and construction of a west side subway extension through Beverly Hills by the Los Angeles Metropolitan

Transportation Authority.

The City of Beverly Hills Mass Transit Committee recommended the line follow Wilshire Boulevard with a west side stop near Wilshire Boulevard and Beverly Drive, and a east side stop at Wilshire and La Cienega Boulevards.

"I'm particularly happy that there is a La Cienega/Wilshire station because I think that fits in very nicely with the possibility to develop east Beverly Hills and to look into the idea of having an arts and theatre district there," Councilmember John Mirisch said.

## Friends of the Library's membership down, bookstore up

First Vice President of the Friends of the Beverly Hills Public Library, Barbara Linder, said while the economy has hurt the Friends' membership for the fiscal 2008-2009 year, it has helped sales at their used bookstore.

"We had to lower our expectations for this coming year in terms of what we think we're going to be able to turn over to the library for them to use," Linder said. "However, the bookstore is doing really well. I think that could be a reflection of the economy. People are more interested in buying used books at a lower price."

Linder said all membership donations are turned over to the library to help support programs and services the library offers. According to the friends' Web site <http://www.friendsofbhpl.org> memberships range from \$25 for seniors and students to \$1,000 for "circle of friends."

**The search for a new city manager begins**

As one of the first steps in the recruitment process of finding a new city manager, a town hall meeting will be held Monday from 7 to 9 p.m. in the city hall council chambers.

Residents will be able to share their input on what qualities they think makes a good city manager.

It was announced at Tuesday's council meeting that the city is searching nationwide for Rod Wood's replacement. The search's tentative schedule appoints someone by the end of the year, with that candidate taking over in early 2010.

**Fifth candidate files for Board of Education election**

Richard Groper, a political science professor at California State University, Los Angeles, filed Tuesday to run in the Nov. 3 Board of Education election.

Groper, a soon-to-be BHUSD parent,

said although he lived in the general area most of his life, he moved to the district last year.

The filing period, which opened July 13 and is supposed to close Friday, will remain open an extra five days, until Aug. 12., assuming incumbent Myra Demeter does not file.

Demeter announced she will not run again.

Marcia Ventura, spokesperson for the L.A. County Registrar said this only happens when there is an incumbent who has not filed by the closing date.

"This doesn't happen in elections with no incumbents or elections where all incumbents have re-filed," Ventura said.

This year's other candidates include: Craig Davis, Lisa Fisch Korbatov, Jake Manaster and Nooshin Meshkaty.

## Donald Paysinger Expected To Be Named BHHS Football Coach

**Norman girls' basketball team ends summer play by winning three of four games.**

Longtime assistant coach Donald Paysinger is expected to be named as Beverly High's football coach, according to a school district source who requested anonymity because he was not authorized to speak publicly.

Principal J. Guidetti said in a July 29 interview that a coach had been selected, but his name could not be announced until the appointment is approved by the Beverly Hills Unified School District's Human Resources Department, Superintendent Jerry Gross and Board of Education.

Alex Cherniss, the district's director of human resources was on vacation and could not be reached for comment, as was Guidetti and Paysinger.

Beverly High has been seeking a successor to Carter Paysinger, the team's coach since 1990, who was named as an assistant principal in the spring. Carter Paysinger has said he will continue to help call plays during games and develop game plans on weekends.

Donald Paysinger, an older brother of Carter Paysinger, is a 1977 Beverly High graduate. He was Santa Monica High School's football coach from 1998 to 1999, guiding the Vikings to 2-8 records each season.

Donald Paysinger was also a graduate assistant coach at San Jose State and coached with the San Francisco 49ers during training camp in 2004 in connection with the National Football League's Minority Coaching Fellowship Program.

The Normans are scheduled to begin fall practice Aug. 24 and play their first game Sept. 11 by playing host to Long Beach Jordan at Nickoll Field.

### Girls' Basketball Beverly Hills End of the Summer Tournament

Beverly High concluded its summer play by winning three of four games in games played at the school's upstairs gyms.

"I was very satisfied," Norman assistant coach Charles Solomon said. "I didn't think we'd do as well as we did considering our injuries."

Playing without the injured Morgan Mason and Miranda Abdul-Mansour, Beverly Hills opened the tournament with a 46-26 first-round victory over Palisades Friday.

"We were in control the whole game," Solomon said. "I was really pleased with the girls playing without Morgan and Miranda. We like playing at home, especially in the upstairs gym. We don't really lose too many

games there.

"I think the girls stepped up and played really hard. Coach [John] Braddell and I were really pleased with our effort. We controlled the glass."

The Normans defeated Santa Monica St. Monica, 45-40, in a quarterfinal later Friday in what Solomon called "an odd game."

Beverly Hills led 28-10 late in the first half. "There was one point when I thought they were done and we were in control," Solomon said. "All of a sudden they cut [the lead] to about 10 at half time."

Norman point guard Natalie Moy had to leave in the second half to play in a club game and the Mariners pulled to within two.

"At that point I thought we were dead, but the girls were resilient and we ended up winning," Solomon said.

The Normans lost to an Olympic Girls Development League team, 44-38, in overtime in a semifinal Saturday Solomon called "a phenomenal game."

The team, comprised of players from a variety of high schools, was a late entrant in the tournament, replacing Inglewood Morningside, which had withdrawn two days before the tournament started, Solomon said.

Beverly Hills never trailed in regulation and led by seven points with two minutes to play when "we really chocked down the stretch," Solomon said.

"We had a lot of costly turnovers," Solomon said. "We went one for eight from the free throw line, including 0 for six on the double bonus, which really opened up a window, then they took control in overtime."

The Normans concluded the tournament with a 57-40 victory over West Hollywood Pacific Hills in a consolation game they trailed 29-26 at halftime before Moy's arrival after playing in a club team game.

Beverly Hills guard Jaina Abdul-Mansour was named to the all-tournament team averaging 15 points per game, while Norman guard Lisa Kliman drew praise from Solomon for making 12 3-point baskets in the tournament.

The Normans had their "best summer by far" in Solomon's four years as an assistant coach, he said.

"If we are full strength [this season], I don't know how we're going to lose too many games," Solomon said. "I think we're a favorite to win [a Southern Section] title if Mater Dei is not there."

"We have a lot of weapons and the girls really believe in themselves and each other and most of all, they like each other. They're

all friendly and they're all nice and there are no attitudes or egos.

"We are very anxious for season to start. We should do the city and school proud."

June Beverly High graduate Mario Clemens and partner Tiffany Lua of Rowland Heights were 1-up winners over Evan Beck of Virginia Beach, Va. and Doris Chen of Bradenton, Fla. in a mixed four-ball match July 29 on the Canyon Course at Forest Highlands Golf Club in Flagstaff, Ariz.

The Clemens-Lua team closed out the match by halving the final hole with a birdie. Clemens and Lua took the lead for good by parring the par-4 ninth hole while the Beck-Chen team had a bogey.

The Clemens-Lua team increased its lead to 2-up with a par on the 10th hole while its opponents had a bogey. Clemens and Lua saw their lead reduced to 1-up when their opponents birdied the par-4 16th hole which they bogeyed.

## Zip Wars Avoided

### And Notes About Our Village

Some six thousand of our neighbors in Los Angeles can now stop fretting: they are not in any immediate danger of losing their 90210 zip code despite an abortive move by a member of the Beverly Hills City Council to make that postal designation even more exclusive.

Ever since the postal service began modernizing delivery by creating geographic zip codes, the mountain areas north of Beverly Hills to Mullholand Drive in Los Angeles have shared the 90210 zip with their north of Wilshire neighbors in Beverly Hills.

But newly elected Councilmember **John Mirisch** wanted to make certain that the zip most identified with Beverly Hills, 90210, was actually a Beverly Hills only "property." It didn't work.

At Tuesday study session, Mirisch was not able to convince even one colleague to support putting the issue on the formal agenda for a full hearing. (Any councilmember can have a hearing at informal

meetings on matters they want considered, but unless the mayor or two other colleagues agree, no formal votes are even considered.)

The council had a small sampling of the uproar this might have created when a very unhappy and forceful leader of Benedict Canyon Homeowners Association appeared Tuesday to strongly protest the zip code change.

Not surprisingly, this "resident leader" was also a real estate broker and one can only imagine the fears felt by brokers with listings in Beverly Hills "adjacent" or the more common and even more confusing, "Beverly Hills Post Office."

So, some reality checks. First, "90210" was never that esoteric until that zip became the name of a television series about a very fictional high school in our school district. As for the characterizations of our village and our kids, the show was about as realistic as a **Sarah Palin** explanatory speech. In fact, the exterior of

the high school shown in the show was actually filmed in Torrance!

Since "Beverly Hills 90210" there have been other moves to capitalize on the commercial value of the zip. There are television reality shows about a cosmetic surgeon who dubs himself the 90210 doc, or something akin to that tab, and a newspaper with the name, although it is published in Brentwood.

When a magazine format newspaper was launched in Beverly Hills, the owners obviously thought our then area code, 213, was more identifiable with our community than the 90210 zip.

In **Leonard Maltin's** movie guide, there are nearly twice as many film titles with the name Beverly Hills as Paris, France. Aside from the Beverly Hills Cop series, in which I starred – well, if you look carefully you can see the back of my head in the opening scene of the original as I walk to city hall – there have been such image enhancing films as "Beverly Hills Madam", "Beverly Hills Vamp" and the never to be forgotten, "Beverly Hills Cowgirl Blues."

"Beverly Hills 90210" was not the first television series that distorted life in our village. "Beverly Hillbillies" had that honor. I remember getting a call from **Marian Dern**, then the west coast editor of TV Guide, asking what the people of Beverly Hills thought about the program – a spoof of some mountain stereotypes who strike it rich when they discover oil on their property and move to Beverly Hills.

"Frankly, I don't think the people who live here even think about it," I responded. As for our high school students, they would probably find it difficult to identify with any of the characters in "Beverly Hills 90210."

Back to the Mirisch proposal. The four councilmembers who lined up to quickly shoot down his recommendation all made sense: It would be offensive to our neighbors, place additional costs on the postal service and residents, create deep political problems with Los Angeles elected officials and make us appear even more elitist than we are.

However, was the Mirisch proposal without any merit? He probably began giving this serious thought when Dr. **Harold Karpman**, who lives just out of Beverly Hills, filed an appeal to have his property annexed to Beverly Hills.

The famed cardiologist, who has long practiced in our city, argued that his family frequently had difficulty in obtaining emergency and other services from Los Angeles because he was considered in Beverly Hills, but he isn't.

Underlying the Mirisch proposal was the explicit argument that the Beverly Hills 90210 residents outside our city limits pay no taxes to Beverly Hills but have enhanced property values because of the confusing nature of their address. Although the primary argument was to end

delivery and public services confusion, economic factors can not be avoided even though the postal service can not use property value impacts as criteria for zip code realignments.

Another element of the Mirisch idea was to bring all of Beverly Hills into the 90210 zip.

We could have used the Mirisch passion when the then telephone provider separated our city very slightly with area codes. Just east of La Cienega, businesses and residences were kept in the 323 zone and not changed to 310.

The telephone company maps boundary for Beverly Hills was La Cienega!

One of our largest office buildings, 8383 Wilshire Boulevard, has a 323 prefix, and the professionals in that structure are not amused.

Credit Mirisch for some creative thinking and giving public airing to a problem many of us have silently pondered for years. The city could also reform some its own geographic skills. When a mailing service was first hired to send out city hall information, they included all of 90210. No wonder those residents north of our city thought they were part of our community, being invited to town hall meetings on how to find the best possible city manager!

On the other hand, maybe I should lead a movement for secession. As a resident of 90212, we are being taxed without representation. Should we form our own city? Four of the present council lives in 90210 and one, Mirisch, in 90211, and yet 90212 has a larger resident voter population, especially if you include all those folks who vote out of their postal boxes.

We have no real hills, so our city could be called "Beverly."

The north Los Angeles folks probably have nothing to fear despite a mildly encouraging staff report prepared for Mirisch. Although there is a postal committee that considers realignments, I found the staff person who prepares the studies, **Edwin Johnson**, manager of address management, as redundant as that title sounds.

Johnson told us "it will not happen" and that in recent years, despite appeals from "top" political leaders, community efforts to realign zip codes have been consistently denied. He cited costs to residents and the heavy expenses this would bring to the postal services. A mammoth effort by Cong. **Brad Sherman** did succeed in the late 1990s but it involved a zip code in two different counties. The postal service managed to give Dodger Stadium their own zip (90090), and some years back, a building owner on North Robertson managed a zip change that was inventive and almost made **Ed Kushner**, then a resident of the south-east and a long-time community leader, almost go postal. The owner had two joined properties, one in Beverly Hills and the other with a Los Angeles address and zip code, but the LA property had a larger height than our codes. Somehow, despite Kushner's efforts, the Los Angeles building managed a change of address and zip giving it a Beverly Hills identification. A medical building, the doctors pay their taxes to Los Angeles, of course. Kushner now lives near Solvang.

My own view? If you don't live in Beverly Hills and don't pay taxes here or vote for our councilmembers, why use our name? Keep the zip, but use Los Angeles as your address. The mail will arrive. Of course, I will now drive very carefully on Benedict Canyon and probably never run for state assembly.

\*\*\*

The seniors, now dubbed "active adults" and the youth of our city took a hit from the council majority Tuesday which once again put brakes on improvements at Roxbury Park. Frankly, the condition of the Roxbury Community Center and the park grounds, are a civic disgrace.

For years, park users, city staff and the Recreation and Parks Commission have worked on improvement plans, frequently modified to meet neighbors concerns. The money is there for the improvements and has been long before the current city fiscal problems.

The user community and all those who understand the value of open space and first rate park services need to be there when this comes up for another review this fall.

Congratulations to Councilmembers **Barry Brucker** and Dr. **Willie Brien** for their courageous defense of the park community.

Great news for the Montage and all our Beverly Hills hotels, but not so good for Los Angeles. The Bel Air Hotel announced this week that it will close for two years to renovate and remodel.

Some hotel workers think the closing, instead of working while remaining open, is a ploy to drive out the hotel union, something they claim happened when the same owners shut down the venerable Beverly Hills Hotel. No such problems during the Beverly Hilton renovation – they kept operating, but that hotel has a strong and good working relationship with all their unions.

Mayor **Nancy Krasne** has urged her colleagues to avoid overtime meetings that make rational decision making difficult. She is especially concerned that council sessions that begin in the afternoon and continue with a short break until after midnight make closed session deliberations difficult.

Long meetings are not conducive to constructive deliberations, but the council could also benefit from moving through agendas and general discussions more expeditiously.

\*\*\*

Great new addition to Rodeo Drive, the major expansion of Mont Blanc is good for our famed street and our tax dollars. This showing of optimism about our economy was very welcome, and they are a class act.

Mayor **Nancy Krasne** cut the large ribbon for the unveiling last Monday.

\*\*\*

Speaking of streets, which street signs are most often stolen from their installations? Not Rodeo, as you would expect, but the two at Gregory and Peck. But not

quite as often since the passing of that legendary actor and long time resident.

\*\*\*

And while on the subject of zip codes and city identifications, one of the great rip offs in our history was the annexation of Trousdale to Beverly Hills.

Certainly, we have a large number of fine citizens living in that now much improved section of our city, but when the Beverly Hills City Council approved the annexation and the County of Los Angeles gave its permission, some very barren land quickly became extremely valuable. Engineered by real estate legend **Paul Trousdale**, fortunes were made. Paul also arranged for the sale of Greystone to short time owner **Henry Crown** who wanted to demolish the mansion and sub-divide the property.

**Josh Gross** has a fair and responsible letter publishing policy: unless it is libelous or totally tasteless, it deserves to be printed, even when he may strongly disagree with the opinions expressed.

Two weeks ago, The Weekly published a very excellent review of the life, work and times architect **Hamid Gabbay**, but following the paper's policies, last week we ran a letter from a reader highly critical of the article and of Gabbay personally.

The writer blames Gabbay for the mammoth homes now found in our village and there was an undercurrent and hint of ethnic bias in the letter, although not overtly, and in fairness to the writer, not explicitly.

What is ironic is that some developers

and architects, including those in the Persian community, feel that Gabbay too often, as a commissioner in both Design Review and Planning, stood in the way of mansionization.

We have larger homes than we may have wanted because previous councils refused to set limits on bulk and design in residential areas as they had in commercial zones, arguing that private homes were the purview of the owners and codes should not be altered to prevent uses that did not meet family needs. All of this long before Gabbay became a city official and before the in-migration of the newer Iranian community.

Few people in our history have given as much back to our community as Hamid Gabbay. We are fortunate to have his public service and his leadership.



## TAKING IT TO THE STREETS

The Weekly's exclusive interview with Traffic and Parking Commission chair Joyce Braun.

**Tell us about the traffic and parking commission.**

Traffic and Parking is a seven-member commission. The commission serves as advisors to the City Council. All of the commissioners on our commission are very, very diligent, take it very seriously, are hard working and in all the times I've worked with them, about five years, they've displayed very good judgment and insight. And even if they don't all agree, there is a mutual respect for the other person's opinion. That in my mind is why the commission has been able to accomplish so much.

Also, the commission advises staff on many of the issues that they hear, just interacting with other residents that staff might not hear. The staff in turn provides the commission with the information and the background and the studies that are needed to help us understand and study the issue. This commission has a great advantage because we have a great staff; all of the people in Traffic and Parking are equally concerned about making things work, making things safe and doing a better job. It's like a hand in a glove, the relationship between staff and the commission. We provide the information or study the issues that City Council wants us to work on.

We work with the transportation and the engineering and the police on ways to improve the parking and traffic conditions in the city. In addition the Commission meeting acts as a forum for people to come and have their problems heard.

**What are typical concerns that residents present to the Commission?**

A lot of the issues are asking for parking permits, or asking for a change in restrictions on their block. If you'll notice some blocks are two hour restrictions and some blocks are permit parking only. And they want to change the time or days. That typically has been the focus of the Parking Commission, in making their lives a little bit more livable. Parking is tight in this city.

**How long have you been involved with the city?**

Before this I was on the Public Works Commission for six years. That was after I graduated Team Beverly Hills. I was in the second graduating class of Team Beverly Hills. [City treasurer] Eliot Finkel was in my graduating class and served with me on the Public Works Commission. Bobbe Joy Dawson was on the same Team Beverly Hills too, but now she is involved in the South Beverly Merchants Association.

That was a good training ground and it gave you very good insight.

Before that I did PTA, my biggest involvement with it was as a member of the board at Beverly High.

**How long have you lived in Beverly Hills?**

I have lived here 23 years. My children went to the high school and one of them went to Beverly Vista. I'm very lucky. Both chil-

dren had fabulous experiences. We moved here from Philadelphia. As you can imagine, it's a little bit different culture. I am originally from New York.

**What brought you here from Philadelphia?**

My husband always wanted to live in California. There was a company then, who wanted him [to work for them], so he came out here for a change in career. And I wanted to be with him.

**Tell us about your family.**

I am married. My husband, Jerry, is principal in Braun and Associates, it's a retail executive search company. My daughter, Beth [class of 1988], still lives in Beverly Hills, she is a therapist who deals with overweight, chronically ill children. My son Alan [class of 1992] is a senior agent with CAA and he and his wife, Lora, live about three miles away in Westwood. She is originally from Dallas. They have two daughters, Madalyn, 3, and Sarina, 1. I'm very lucky, I have all of my family right here.

**Last year [in issue #447] former chair Julian Gold said the possibility of turning Olympic and Pico Boulevards into one way streets had died down. Has anything changed since then?**

Nothing has changed. The project from Los Angeles hasn't been resurrected and we can't do anything alone. But what has happened on Olympic though, and where Beverly Hills leads L.A. on this, was the timing of westbound parking on Olympic. It used to be 9 a.m., and now it is 10 a.m., so the City Council approved it way before Los Angeles approved it.

I would say the [changing Olympic and

n't impact income. We're working very diligently on this problem.

There are 500 new parking meters that are going to be installed, if all is well the project will start on Friday. The first installation will be around the parks, like around Roxbury and La Cienega. They will be solar and credit card parking meters, much like the test meters we have on Canyon Drive.

We just started looking into the condition and need bus shelters and bus stops because mass transit is becoming more and more important in our city.

Our goal is to work with the Planning Commission and develop a parking master plan. That will be good. We will know where all our parking is when someone comes with a project that they want, the Planning Commission will know about all the parking.

**Who influenced you in to getting involved with the city?**

Well, I had heard about Team Beverly Hills and it sounded like such a great idea that I thought "I would like to know this." So I applied and loved every one of the 10 sessions.

**How did you get involved with the PTSA at the high school?**

I wanted to learn about what was going on with the schools. Certainly this was different than the schools I was involved with in Philadelphia. I met Gail Silver, Evy Rappaport, but she is no longer with us. I made lots of friends and it was fun. The principal was Sol Levine at the time.

**You said you met Eliot Finkel on Team Beverly Hills. Did you meet any commissioners the same way?**

Dick Seff, who worked with me on the General Plan in 2000, on circulation and mobility, we are serving together.

You meet great people. I met a lot of the councilmembers at the time while on Team Beverly Hills too; MeraLee Goldman and Vicki Reynolds and Tom Levyn and Mark Egerman.

There are two new commissioners joining the commission in October, Brian Rosenstien and Alan Grushcow, and both of them are Team Beverly Hills graduates.

**What do you do aside from the Commission?**

I am also a docent at LACMA. I give tours to children at the museum. I like art, and I thought it would be fun for me and for the kids, because I like interacting with the kids. This gives them an opportunity to come and spend an hour and a half and maybe they'll see the world and art in a different way. So many of the art programs today are gone in the schools, then they never get the opportunity to get art. It is a really wonderful thing, aside from being a commissioner.

**What is next on your agenda once your term is finished?**

Well, I still have another whole year, so I am just concentrating on doing the most that I can for this commission and I haven't really thought about the future at this point because there is so much more to be done here. But I've enjoyed everything I've done with the commissions, I think it is all really great.




